(57) CLAIM


The ornamental design for a rechargeable battery pack, as shown and described.


#### DESCRIPTION

- FIG. 1 shows a first top view of the rechargeable battery pack in accordance with the invention in a closed state;
- FIG. 2 shows a first perspective end view of the rechargeable battery pack in accordance with the invention in the closed state;
- FIG. 3 shows a second perspective end view of the rechargeable battery pack in accordance with the invention in the closed state;
- FIG. 4 shows a second substantially top view of the rechargeable battery pack in accordance with the invention in a partially opened state;
- FIG. 5 shows a third top view of the rechargeable battery pack in accordance with the invention in an opened state;
- FIG. 6 shows a first side view of the rechargeable battery pack in accordance with the invention in the opened state; and,
- FIG. 7 shows a third perspective end view of the rechargeable battery pack in accordance with the invention in the opened state.












