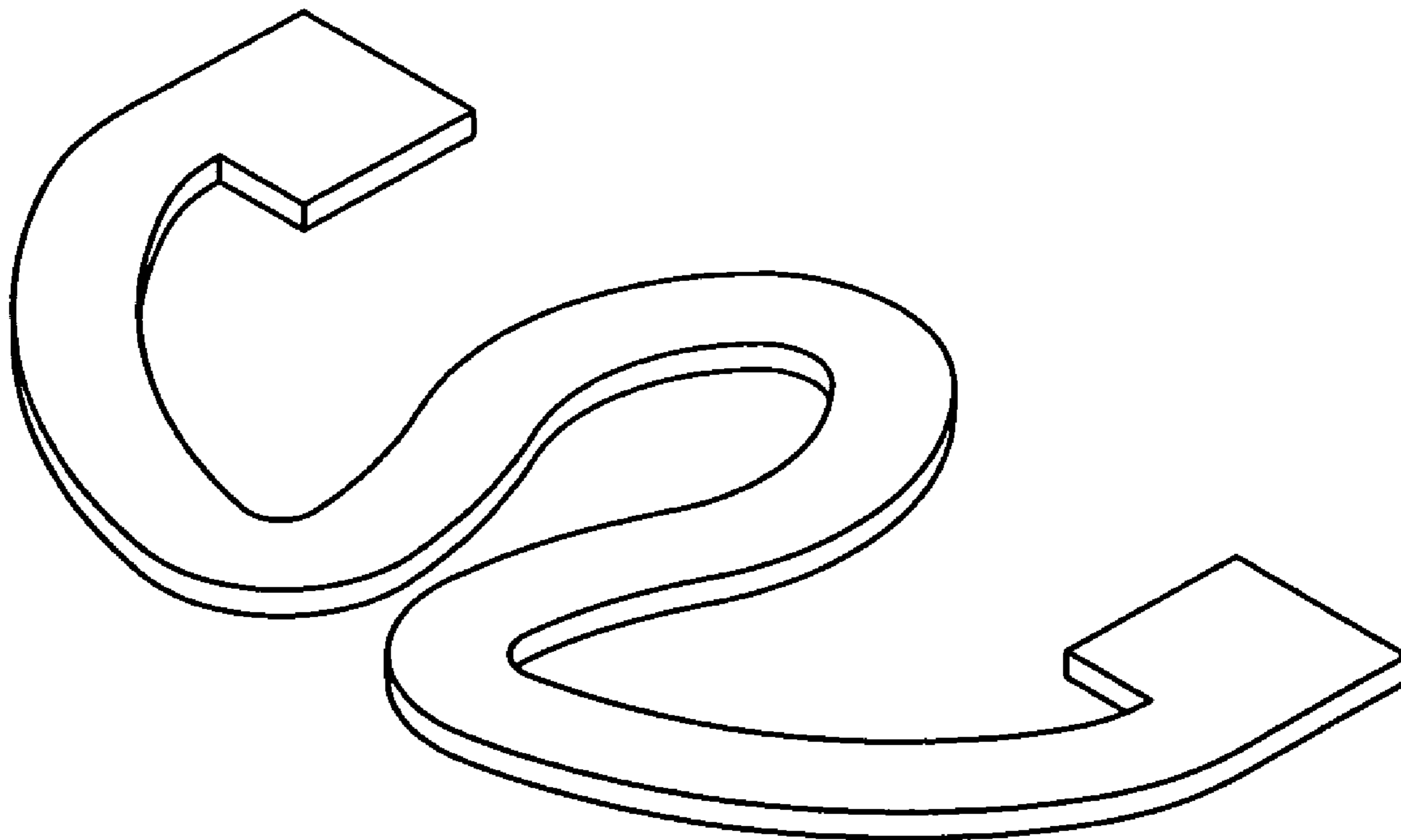
The ornamental design for an omega-connector, shown and described.

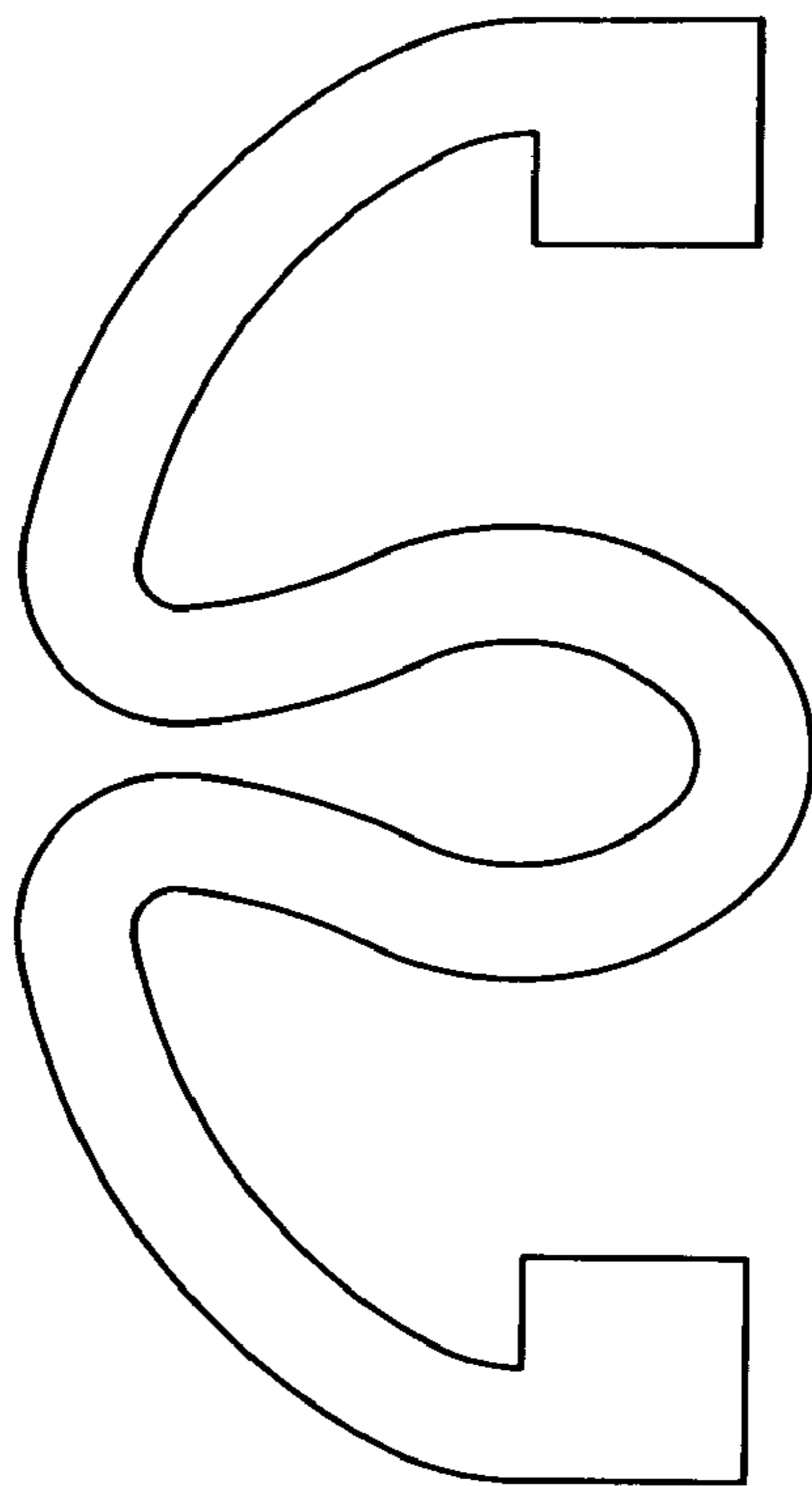

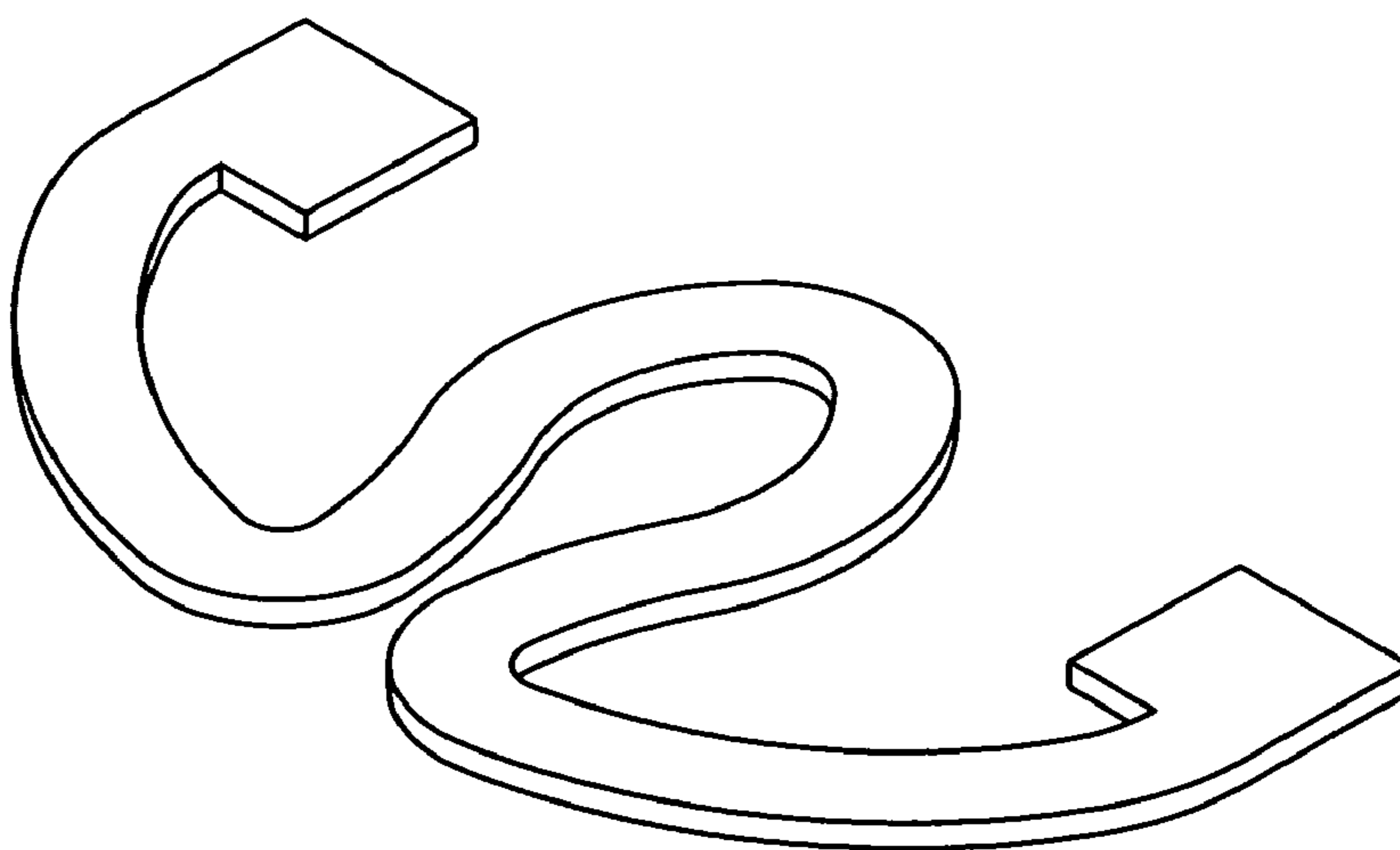
