(57) **CLAIM**

The ornamental design for a video image display for portable phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a video image display for portable phone showing our design;

FIG. 2 is a front view of the video image display for portable phone of FIG. 1;

FIG. 3 is a front view of an alternative embodiment of the video image display for portable phone of FIG. 1; and,

FIG. 4 is enlarged front view of the video image display for portable phone of FIG. 1.

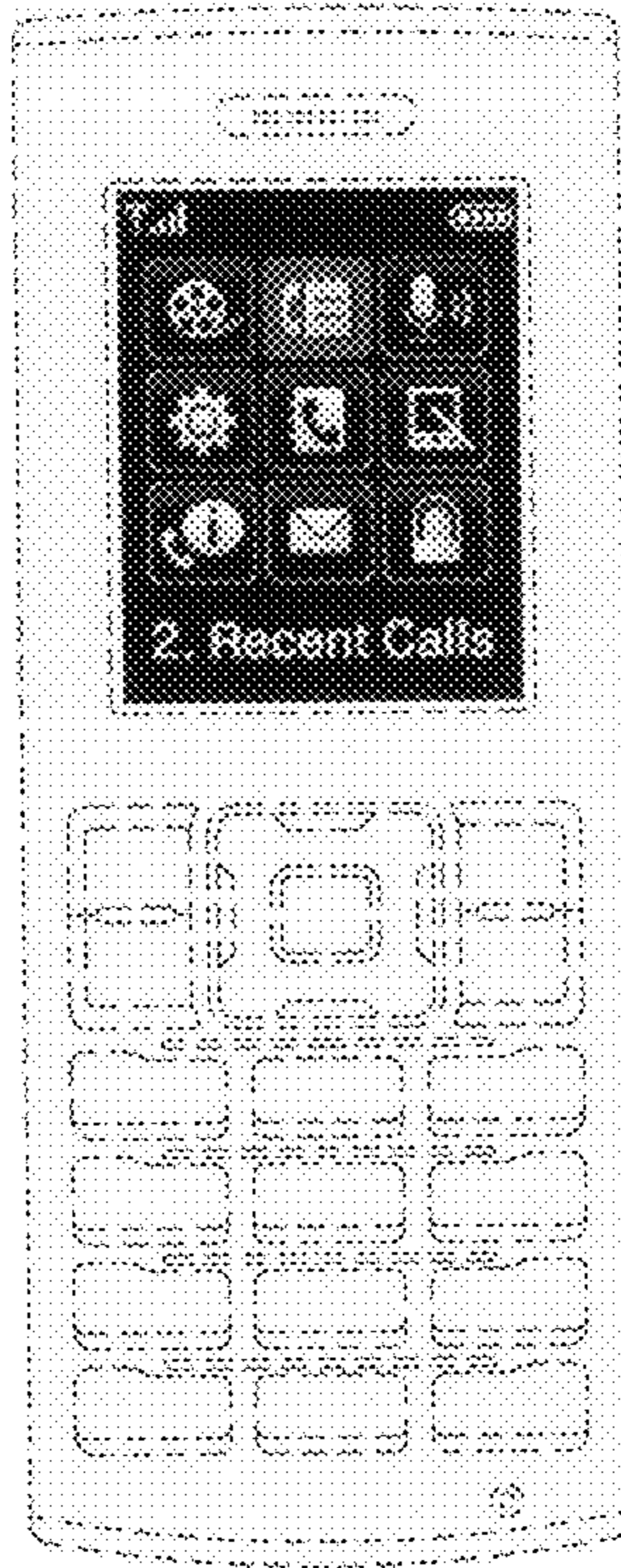
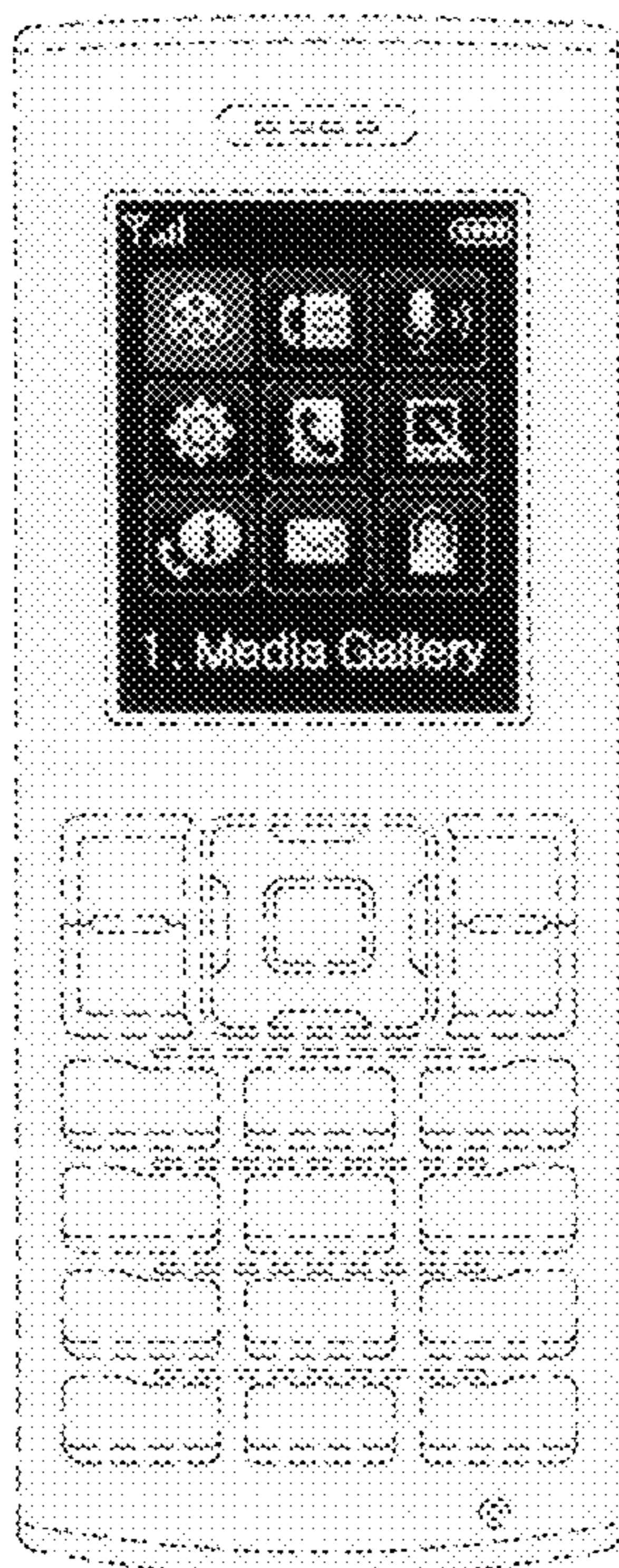

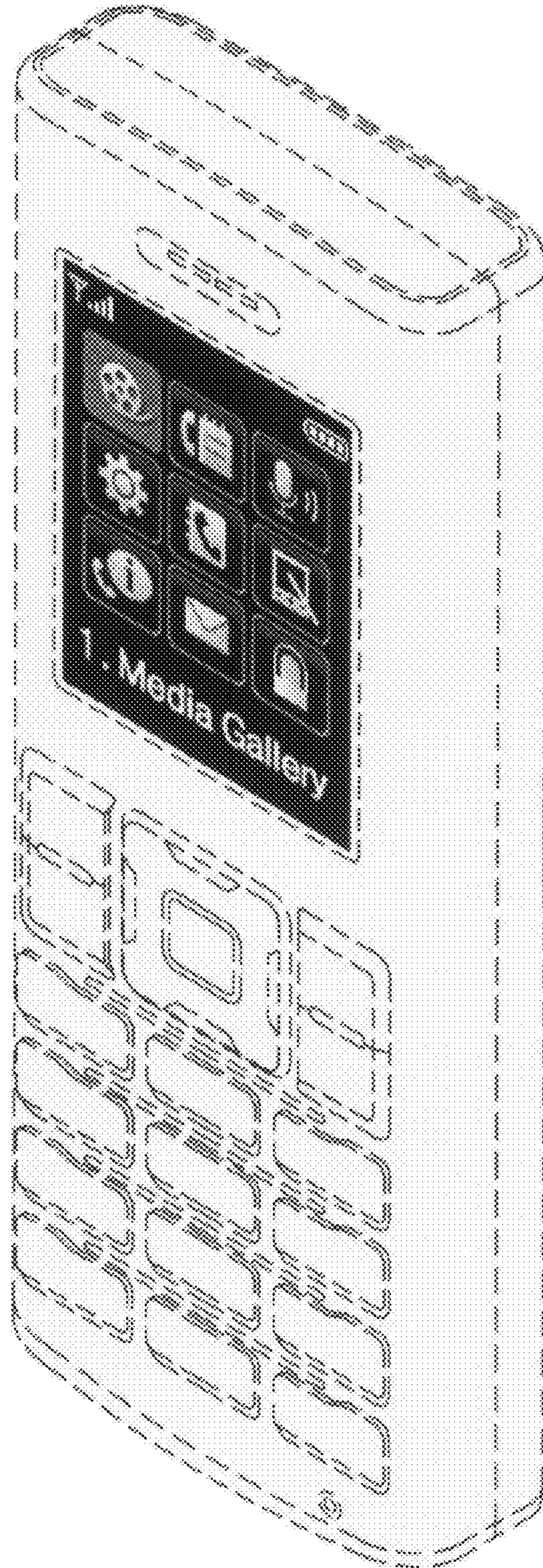

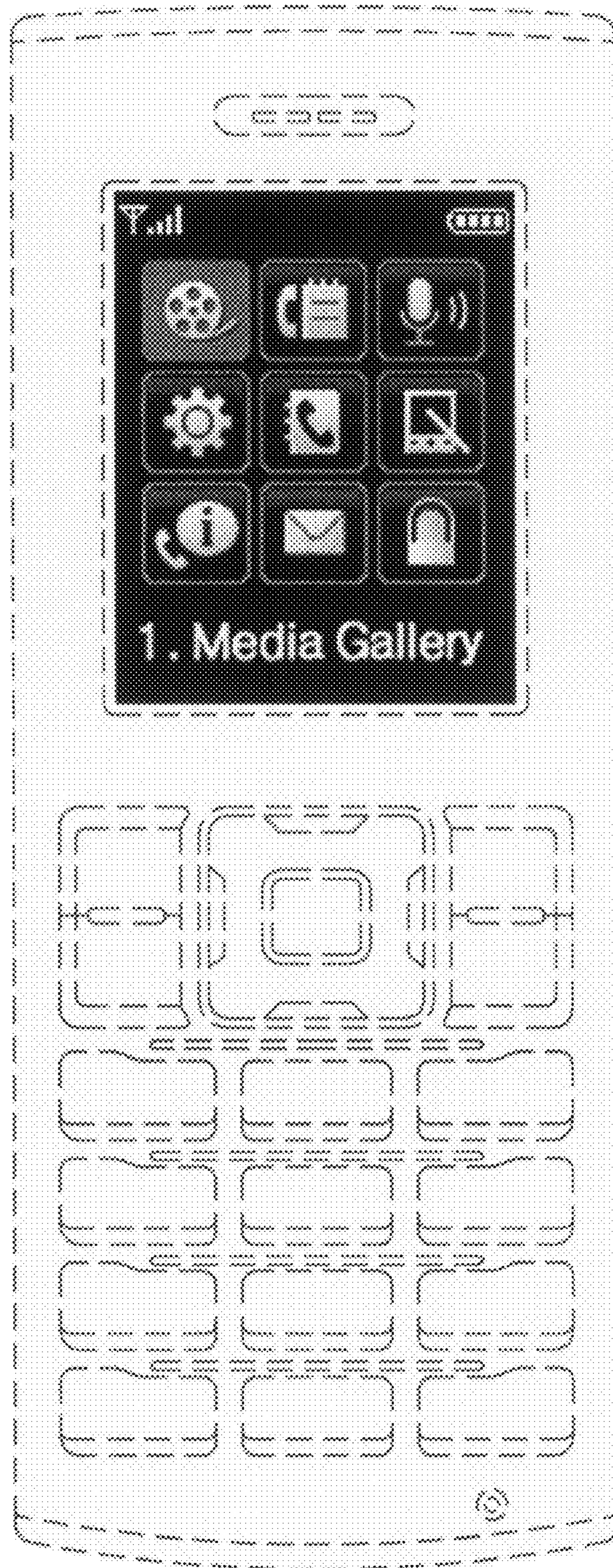

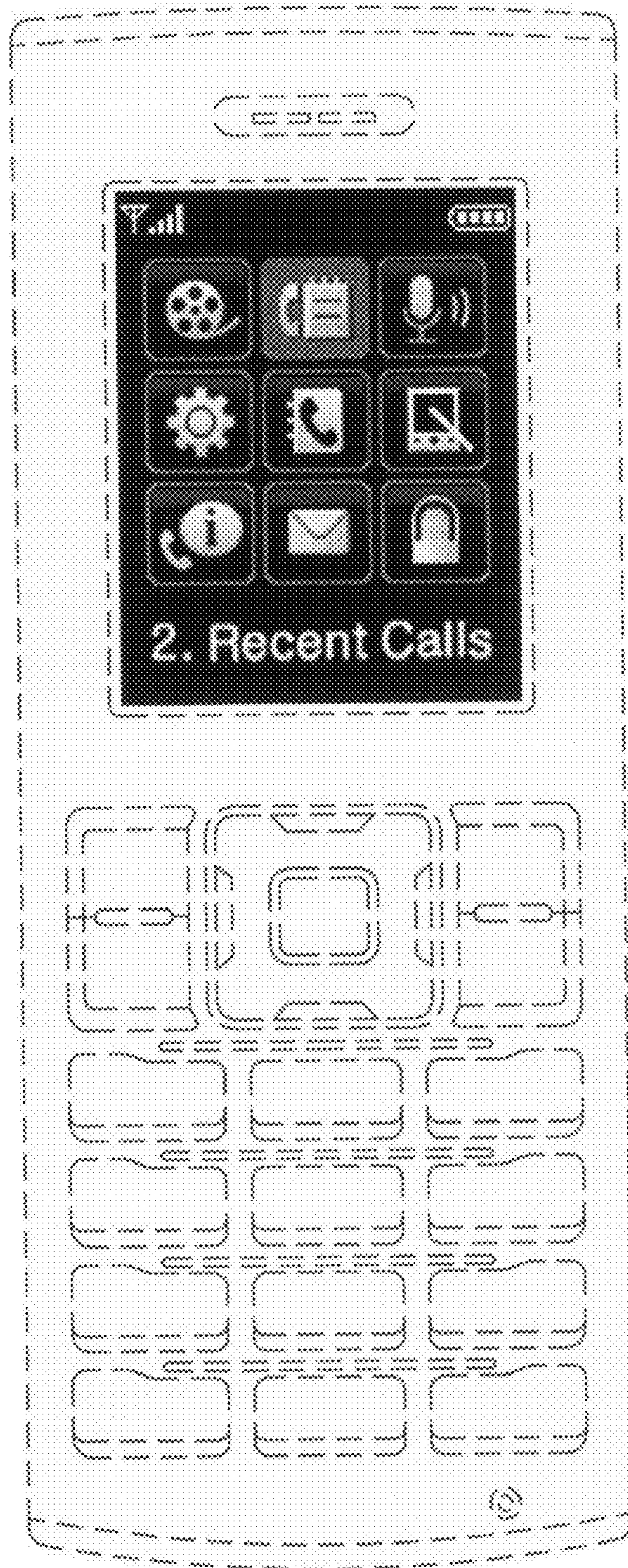
