compressor apparatus of the present invention;

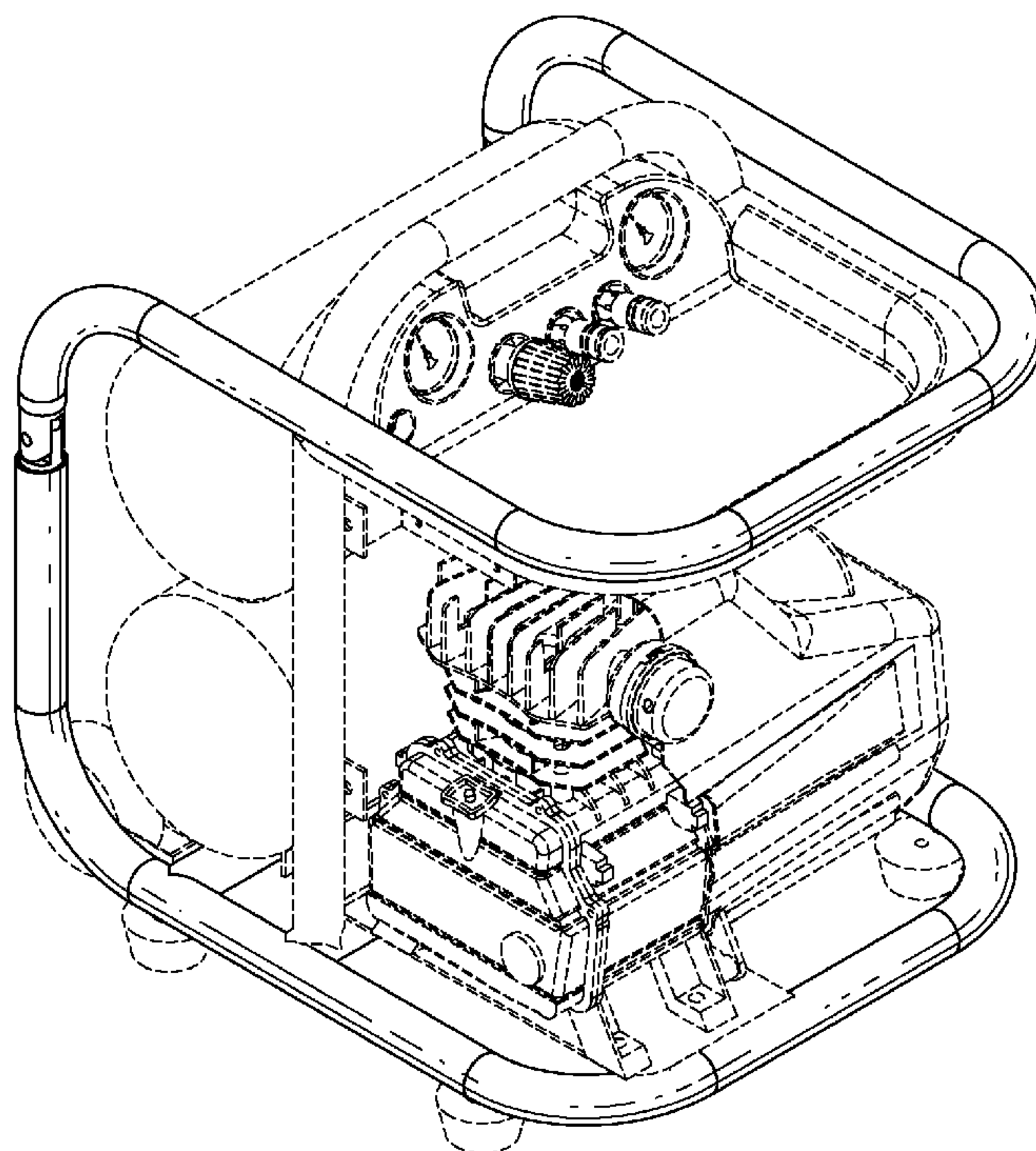
FIG. 4 is an elevational view, depicting a left side view of the

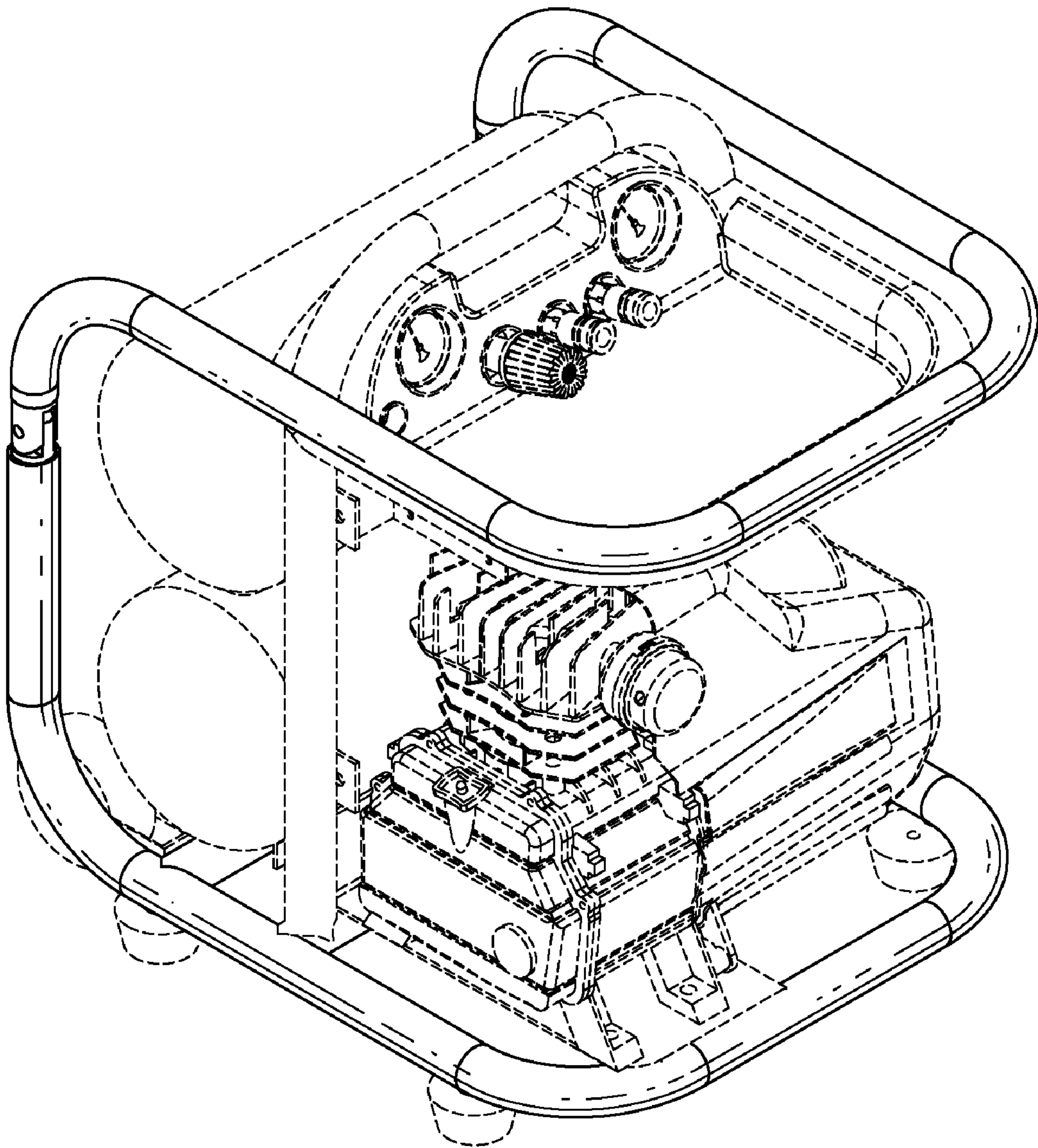

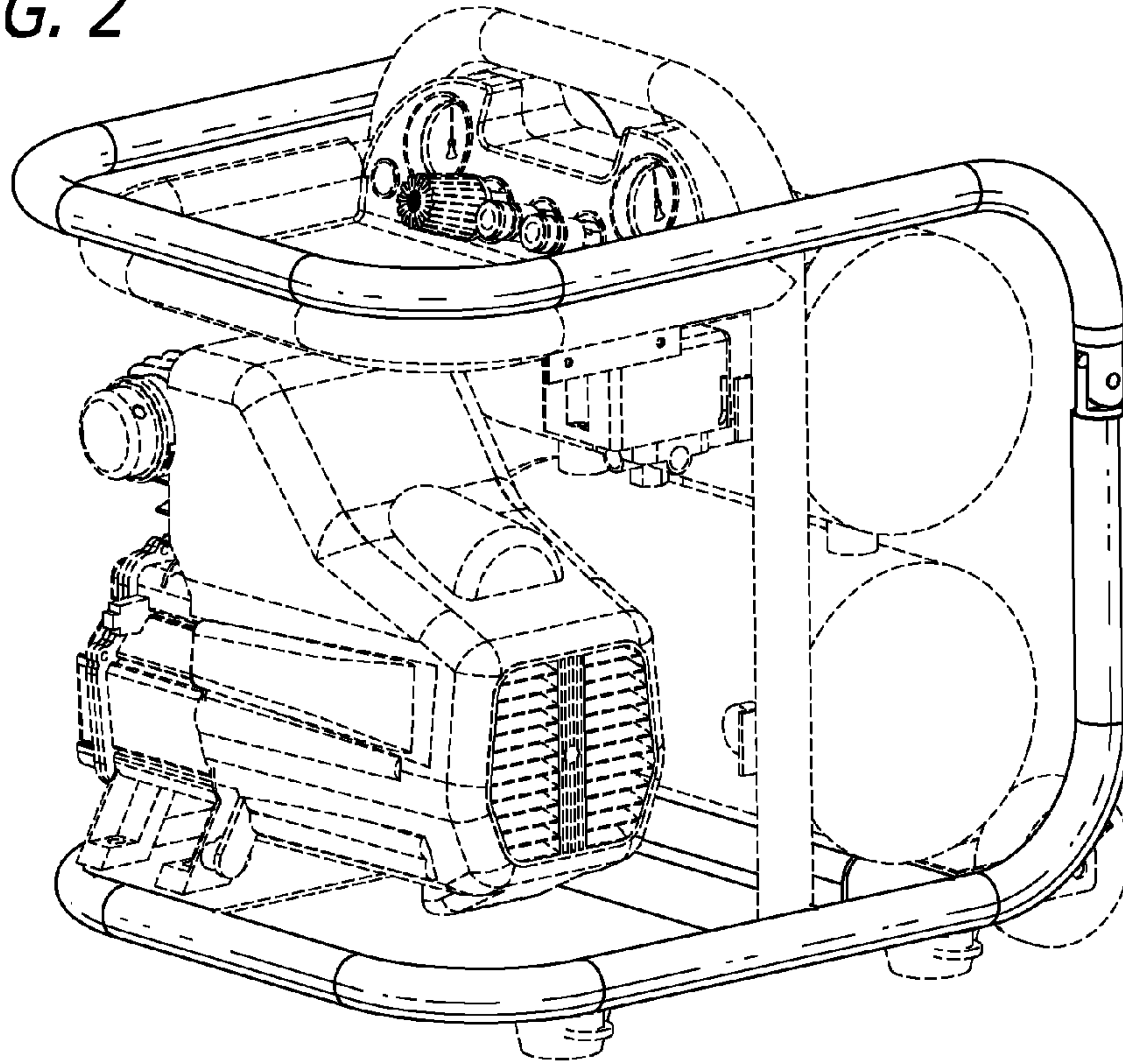

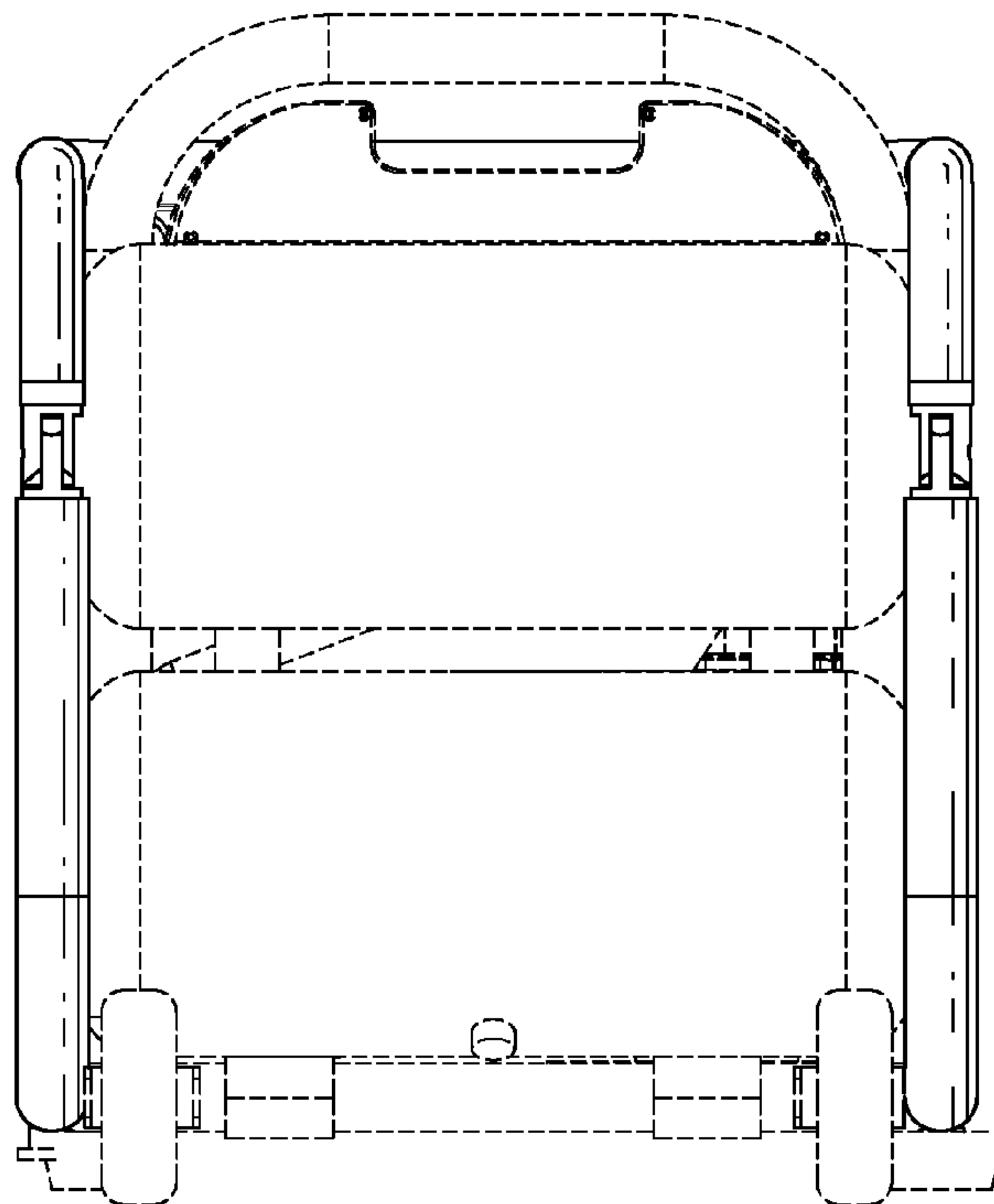

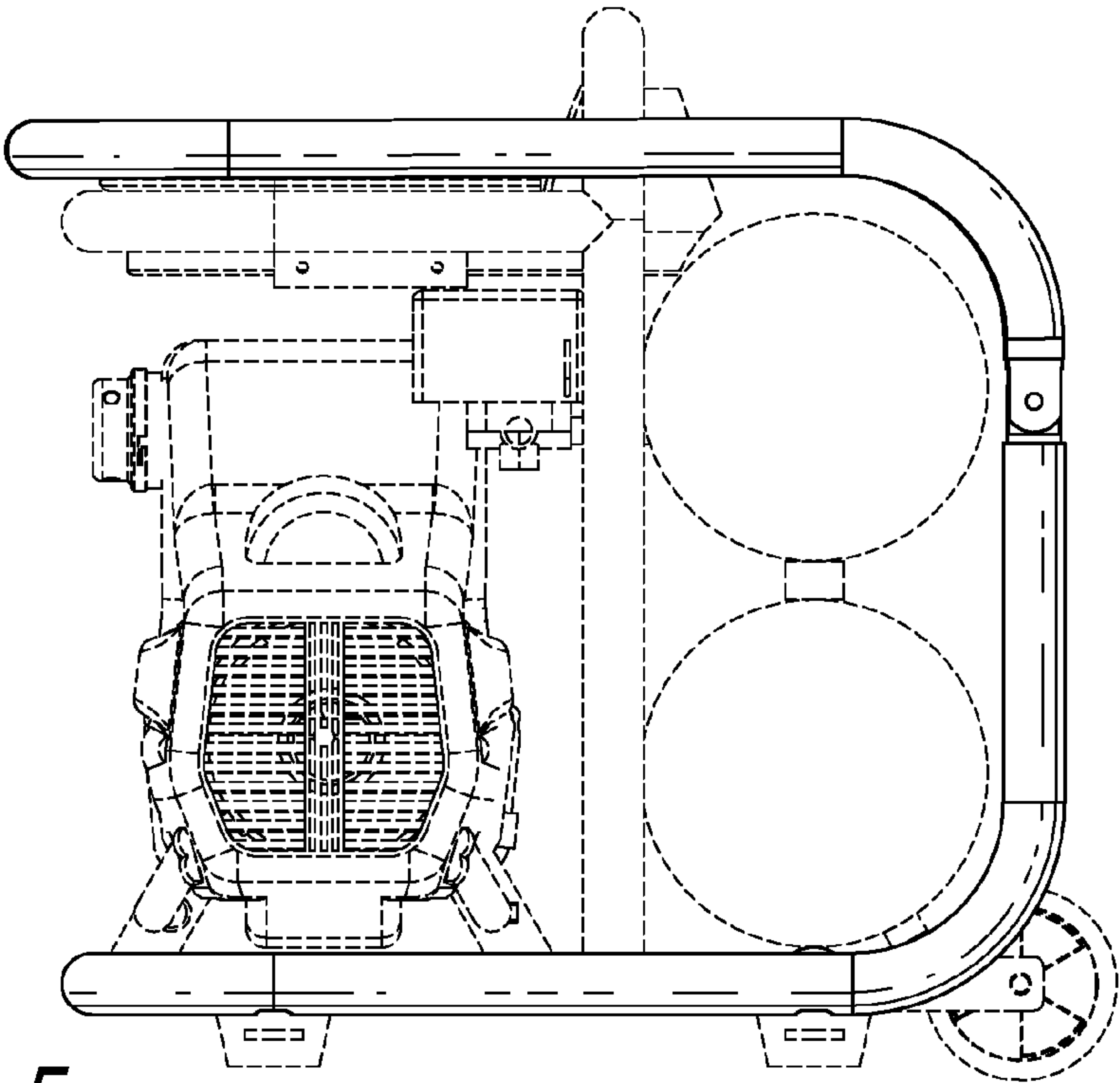
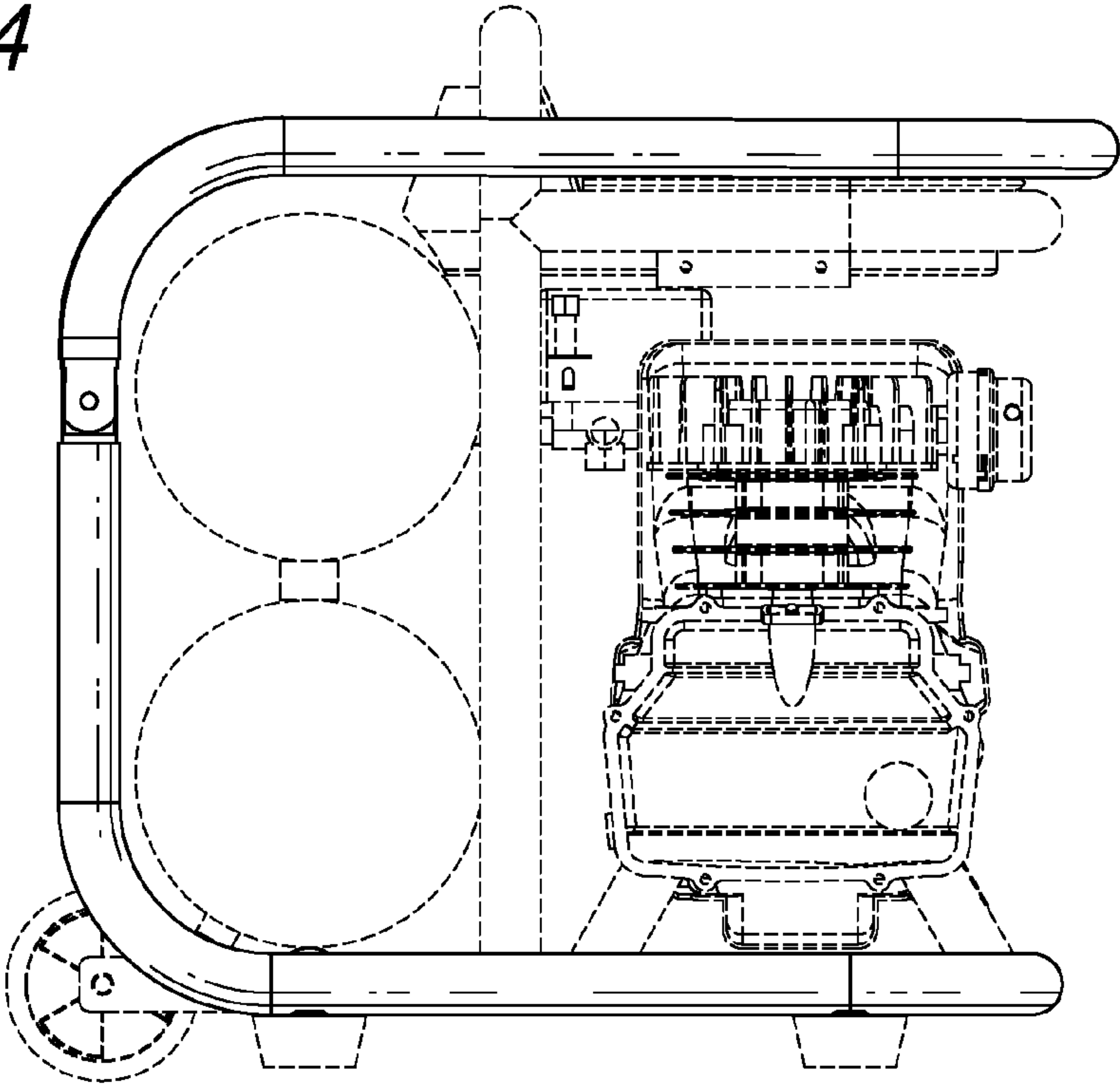

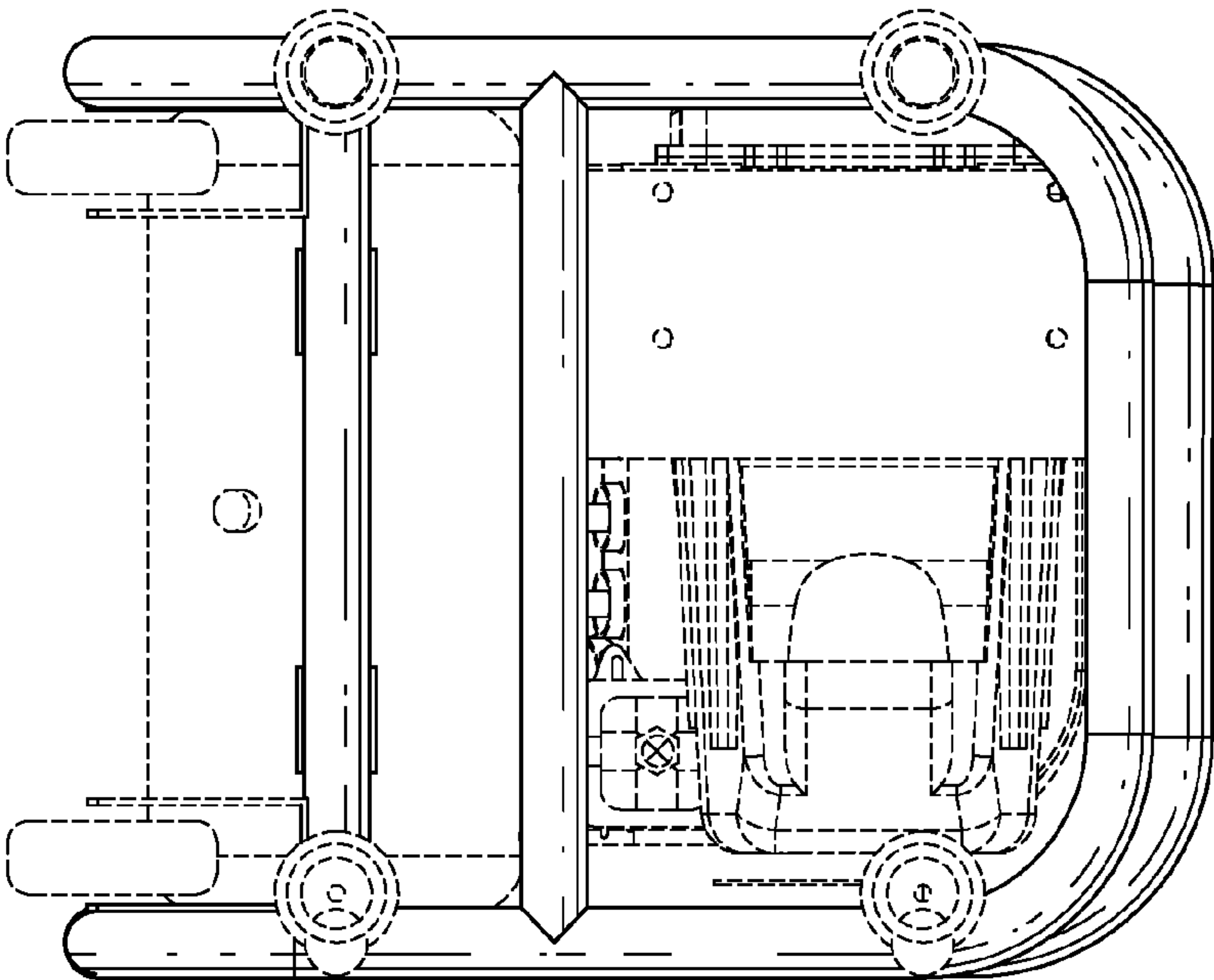
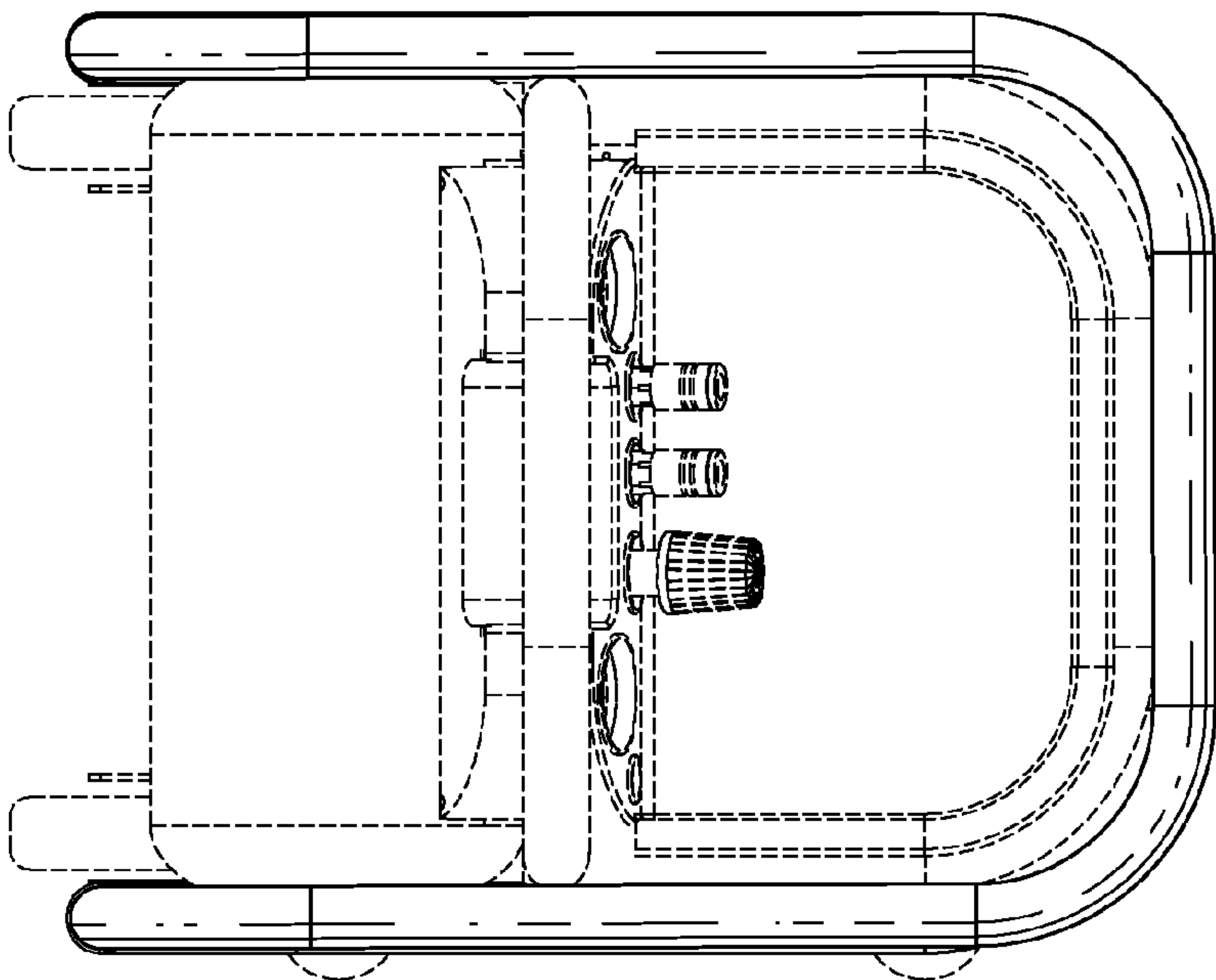
