FIG. 6 is a rear view thereof;

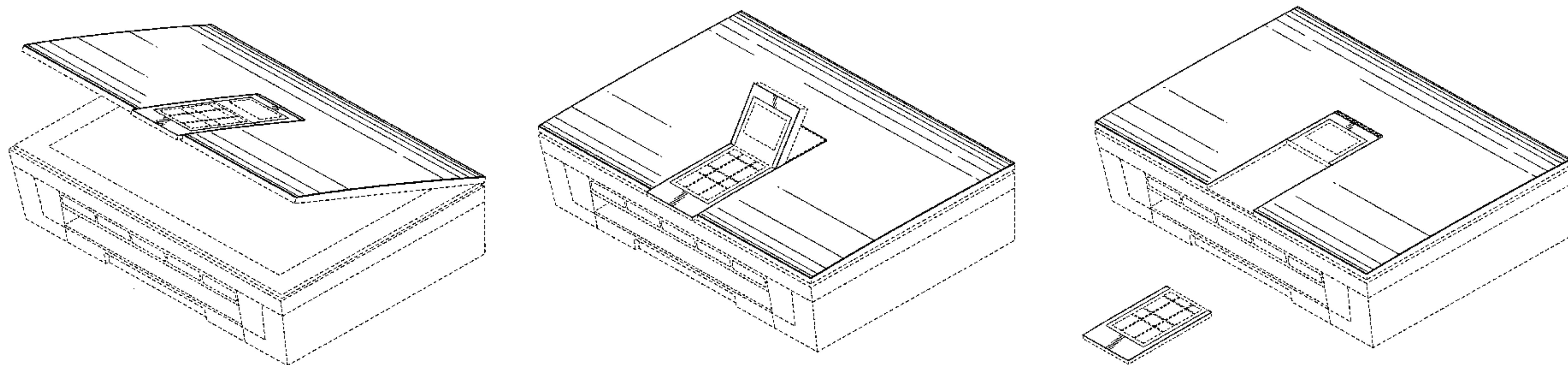
FIG. 7 is a perspective view thereof with a scanner cover in an open position;

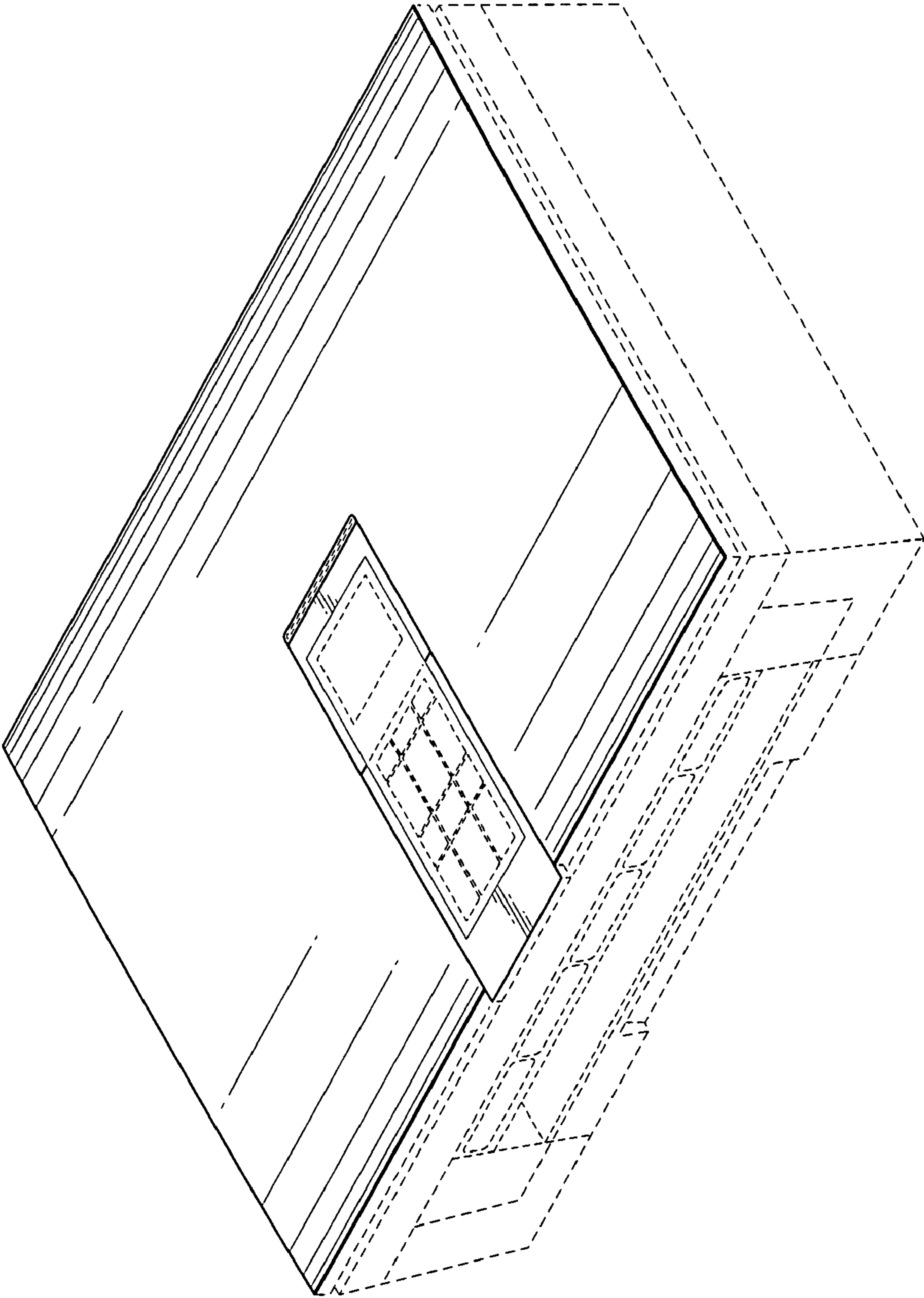

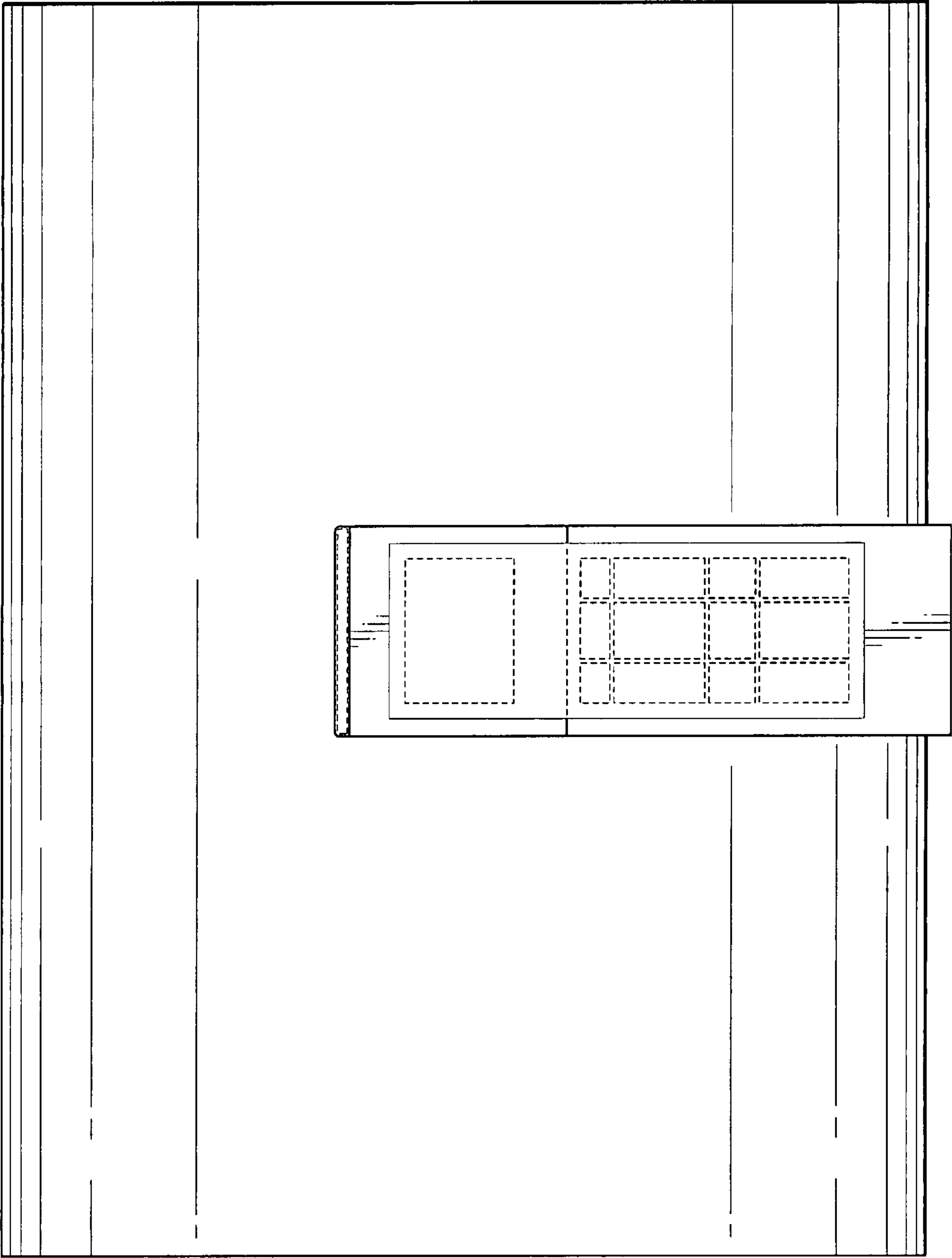

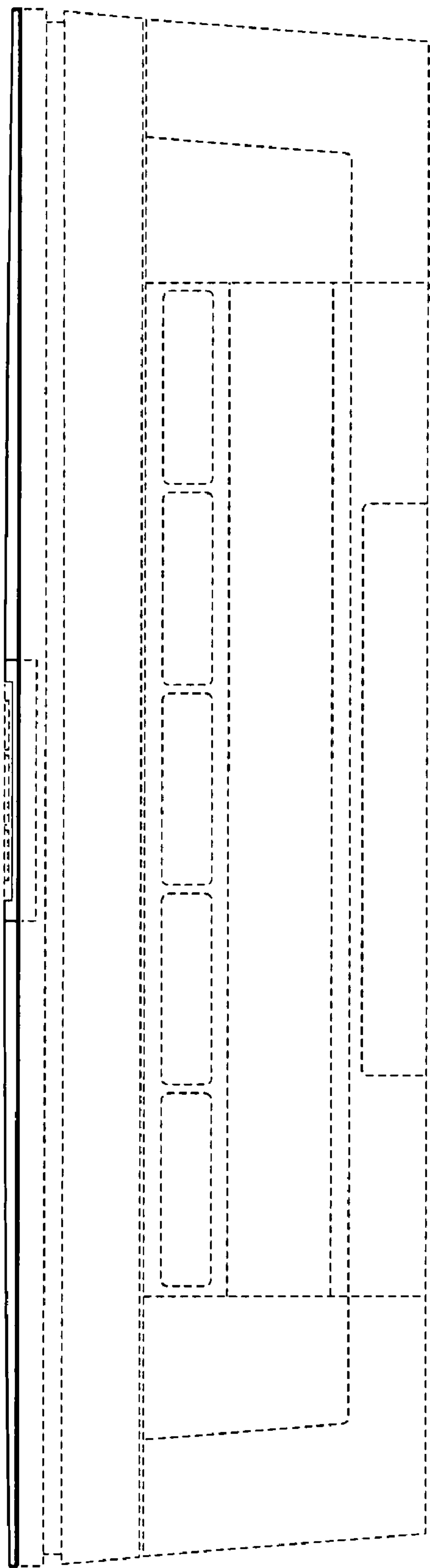

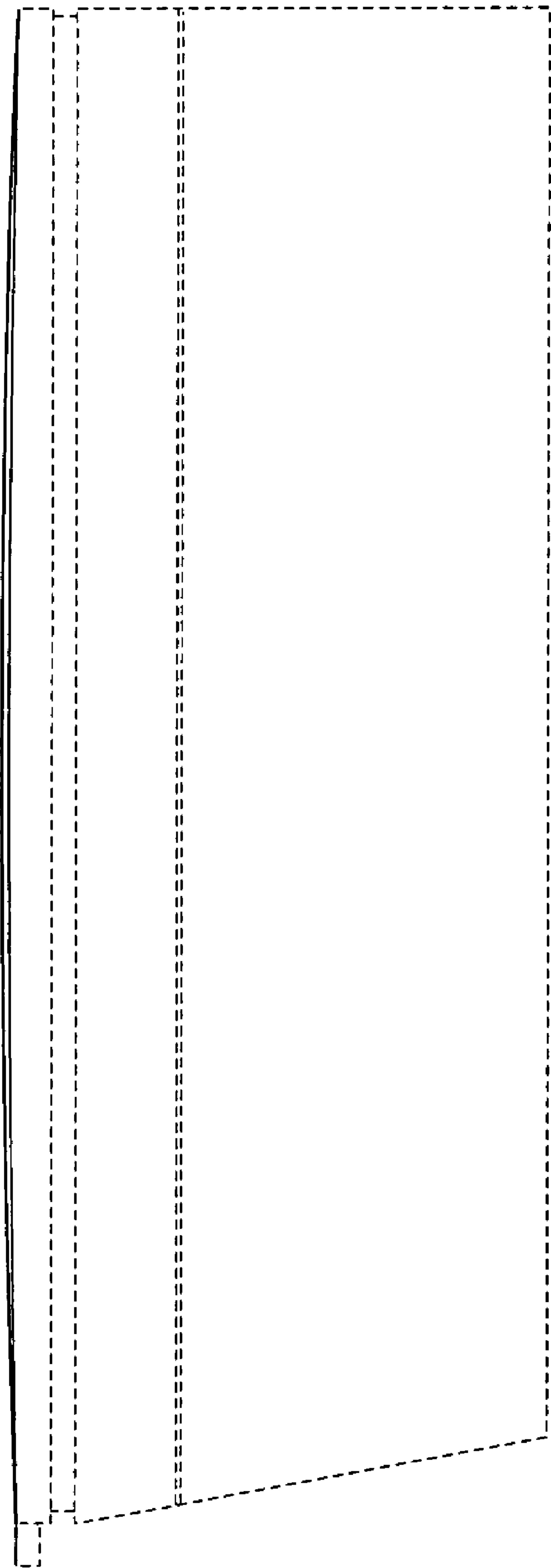

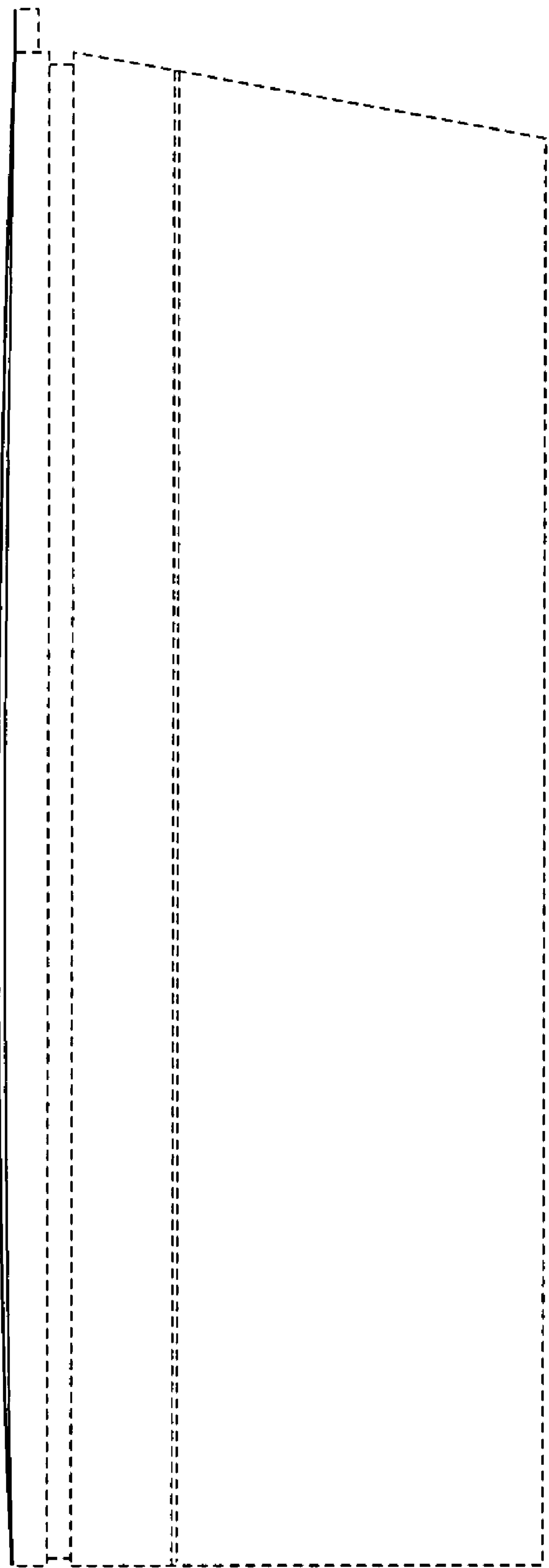

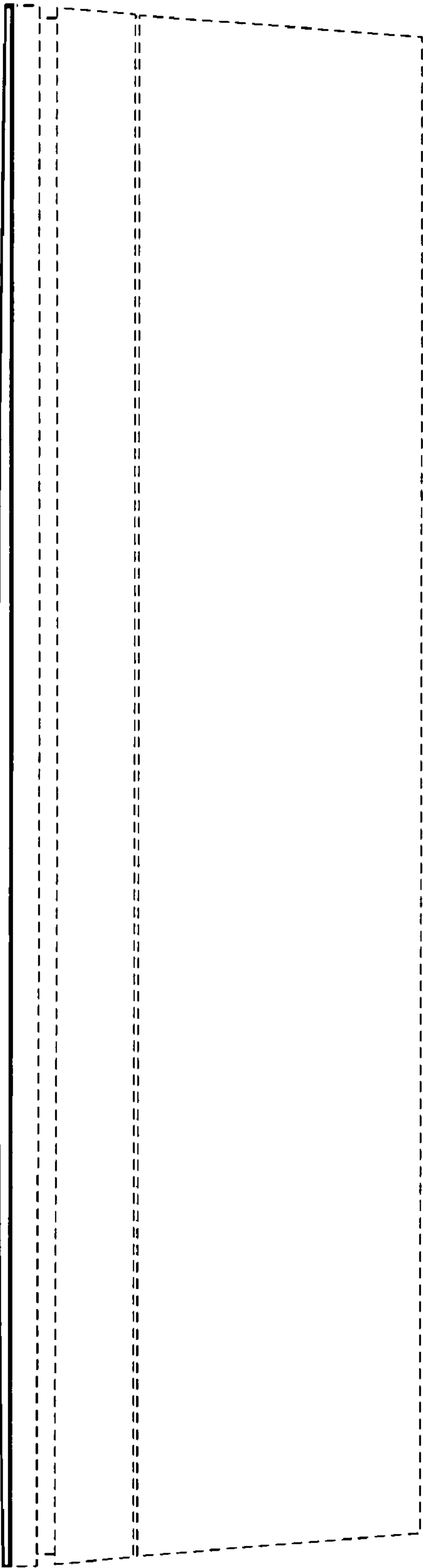

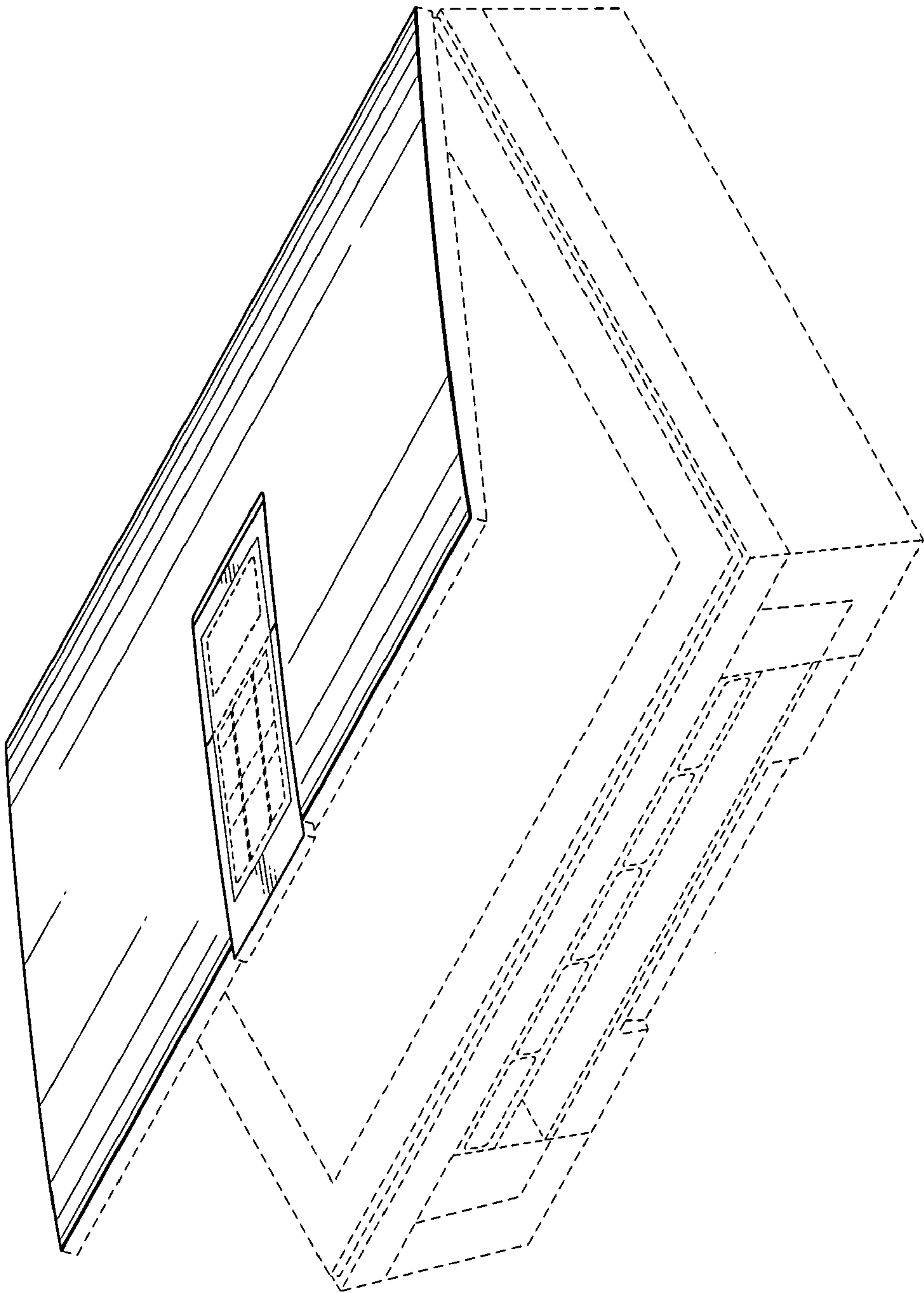

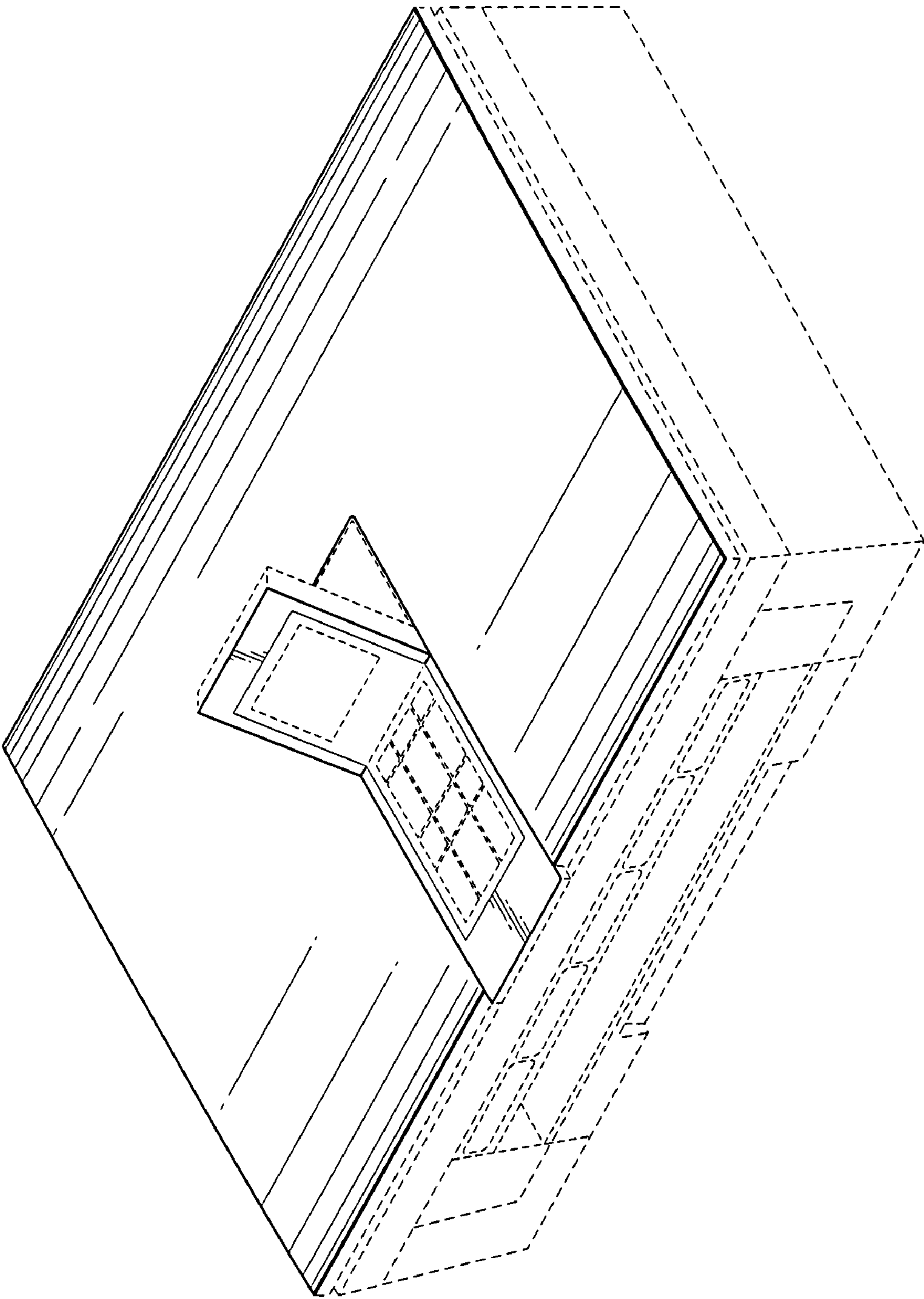

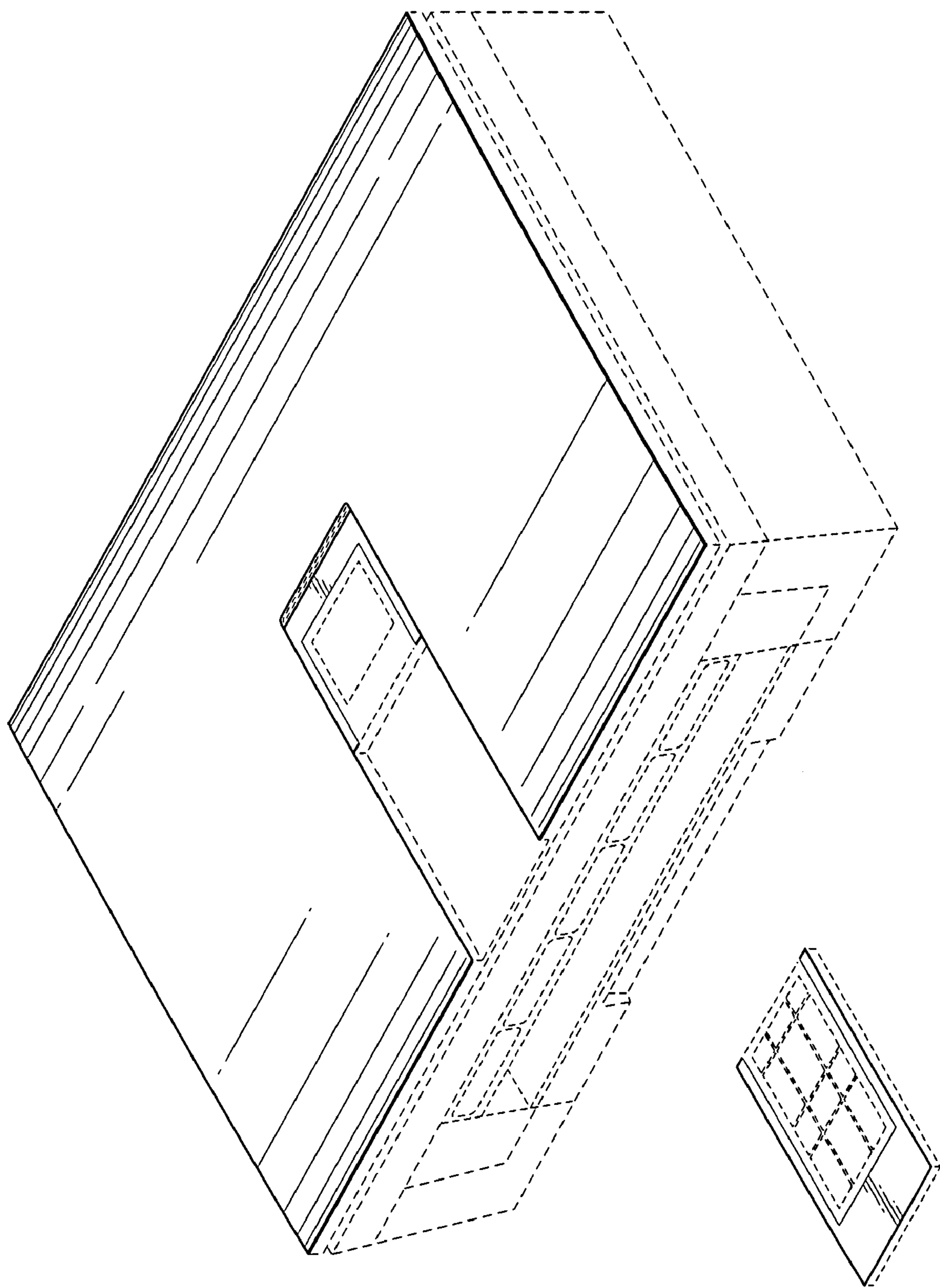
