**DESCRIPTION**

FIG. 1 is a perspective view of a doll with a spacesuit having a square symbol on middle right front and a 5-pointed star on back;

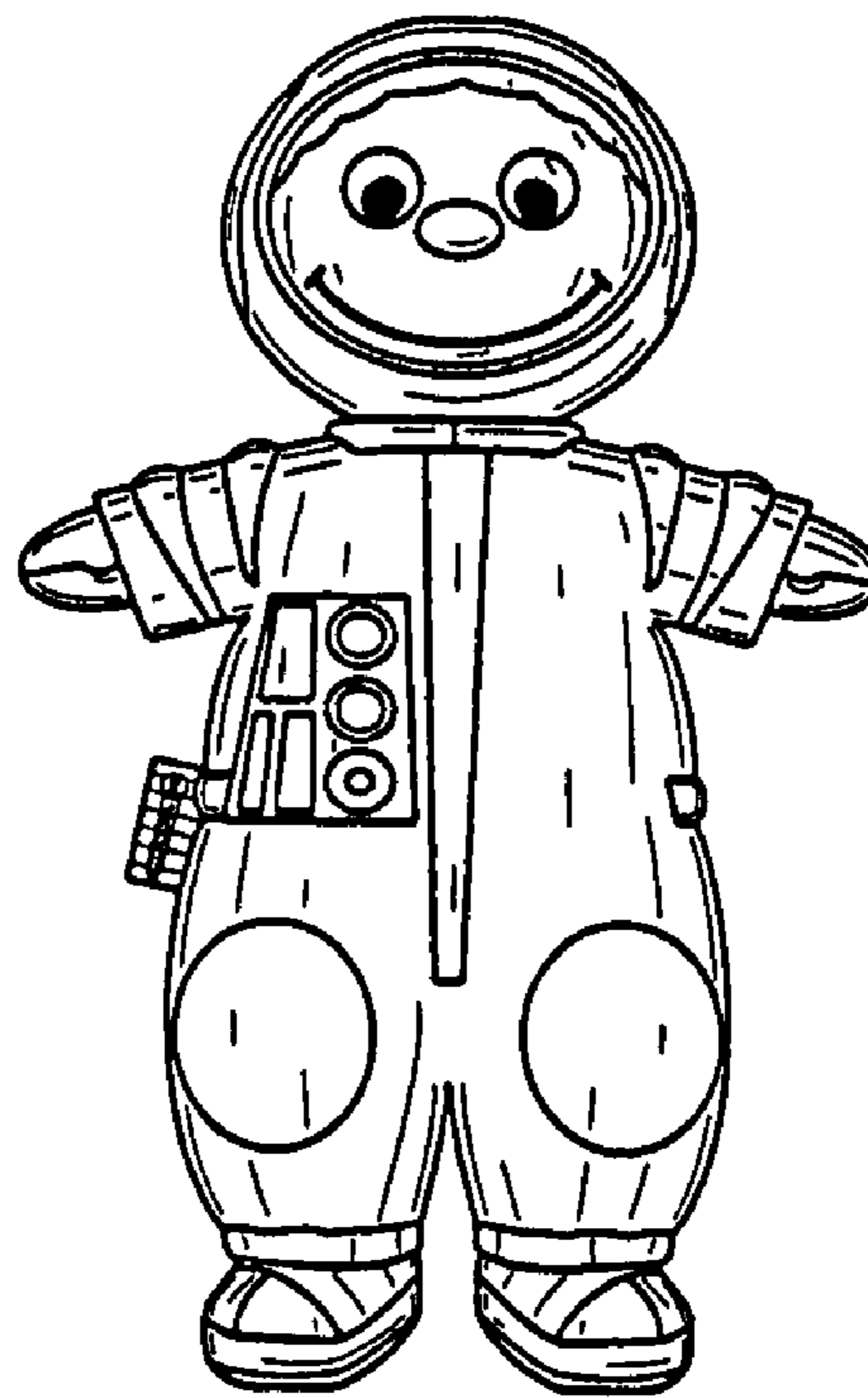
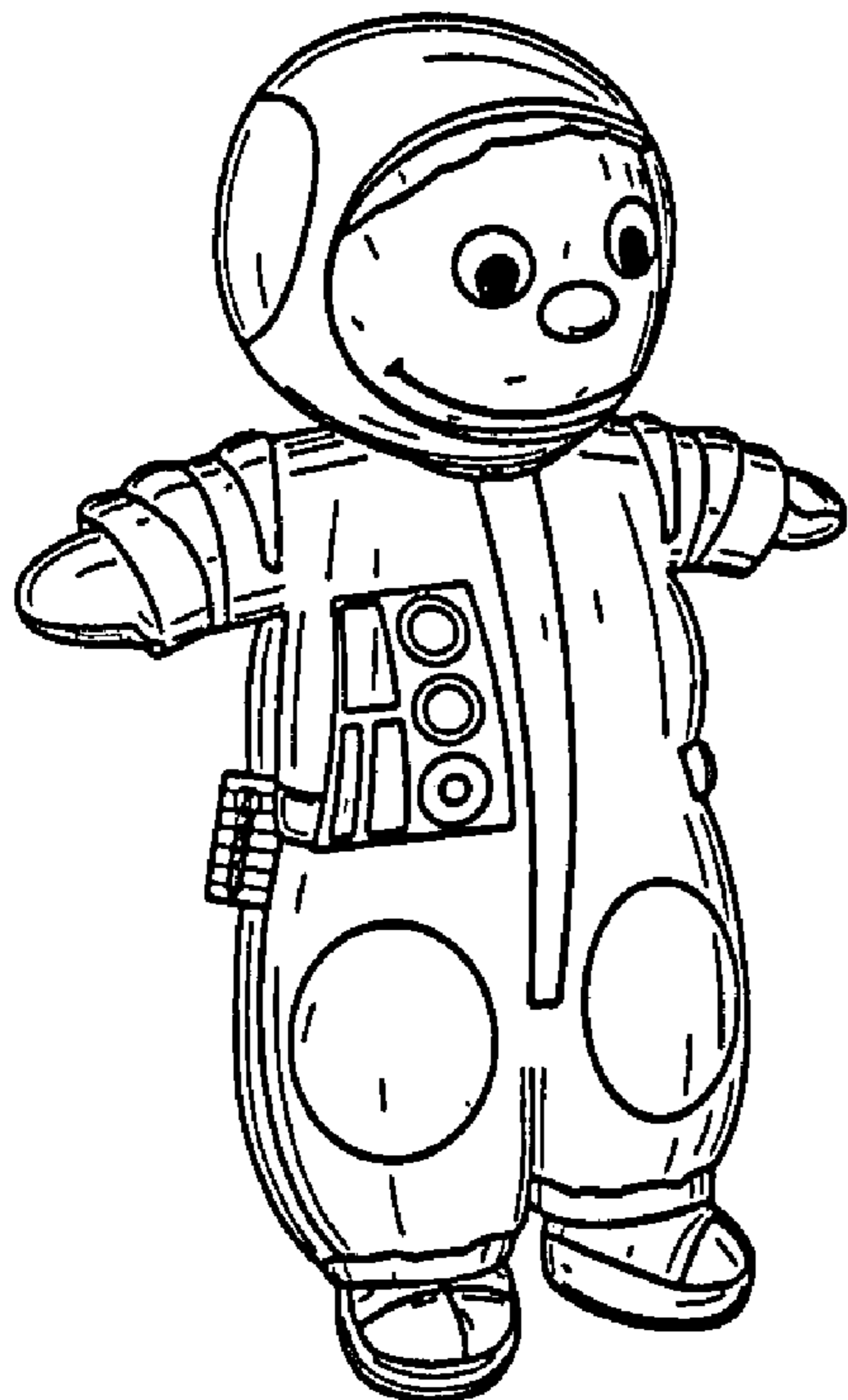
FIG. 2 is a right side elevational view thereof;

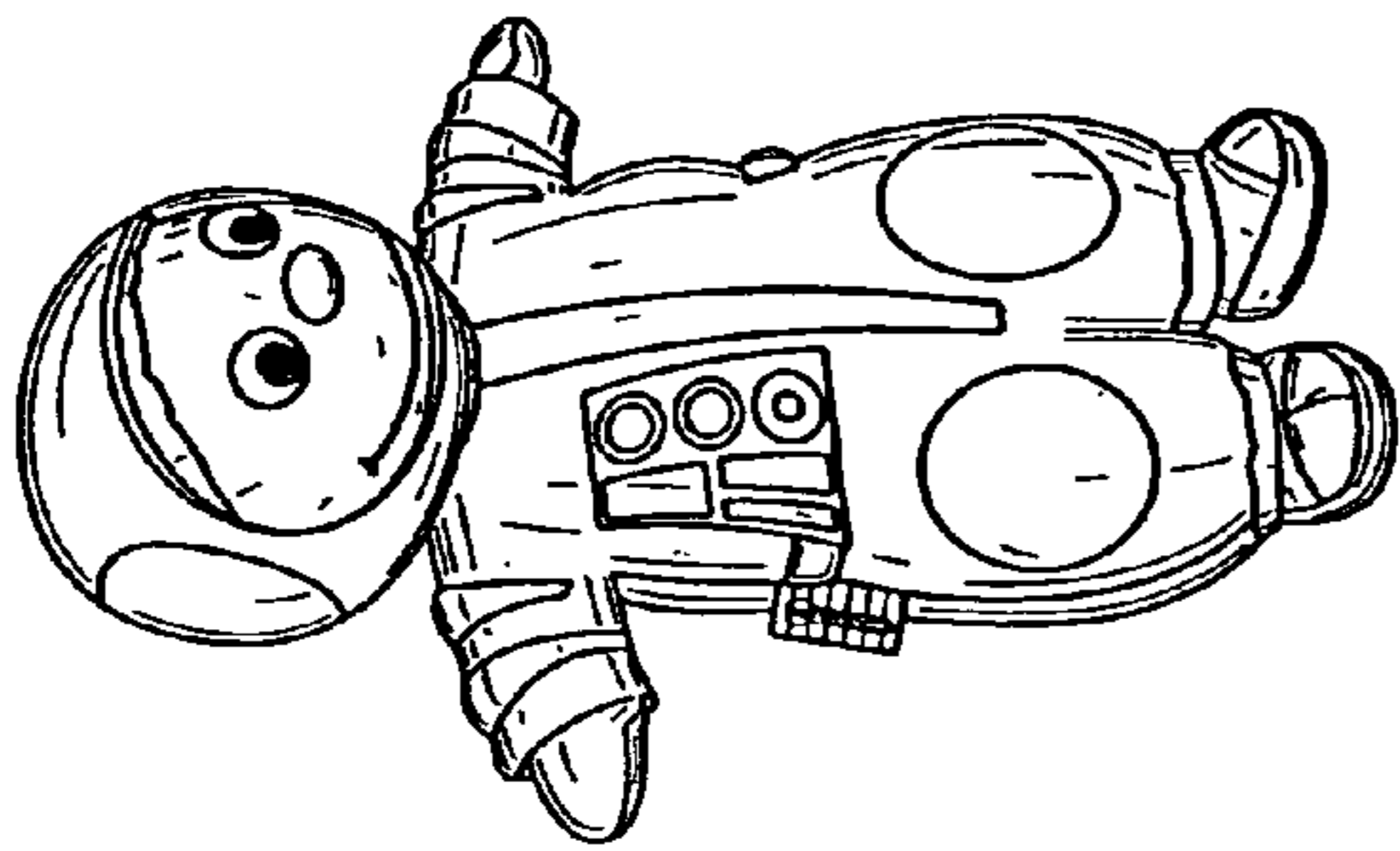

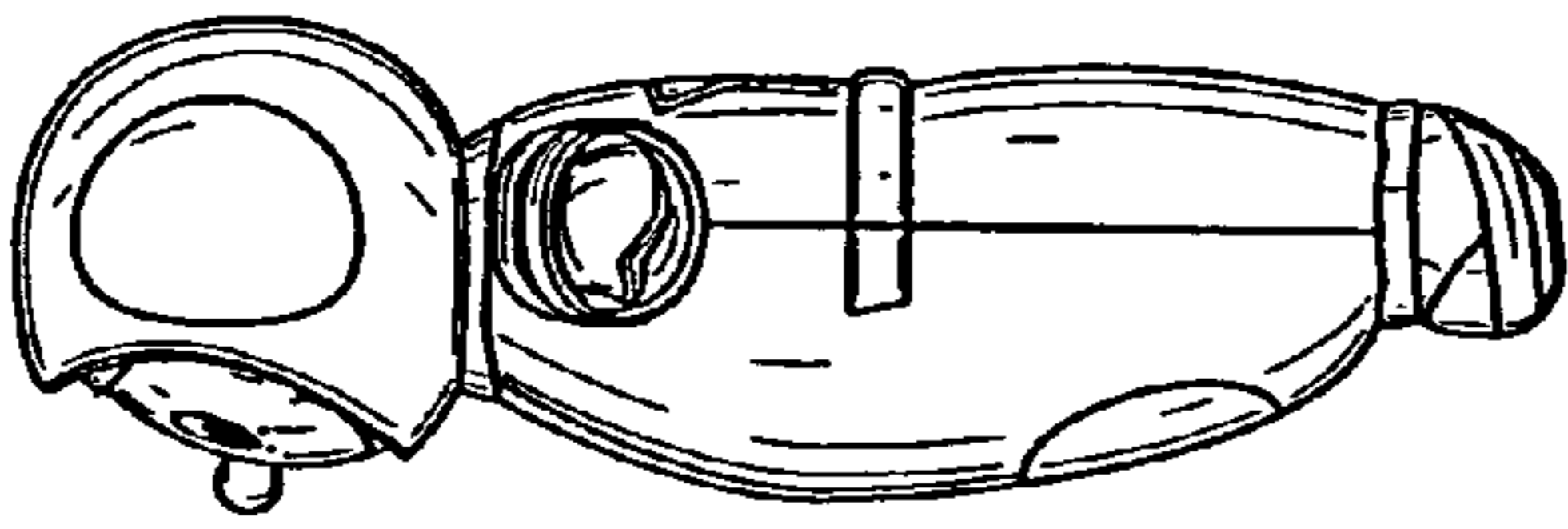

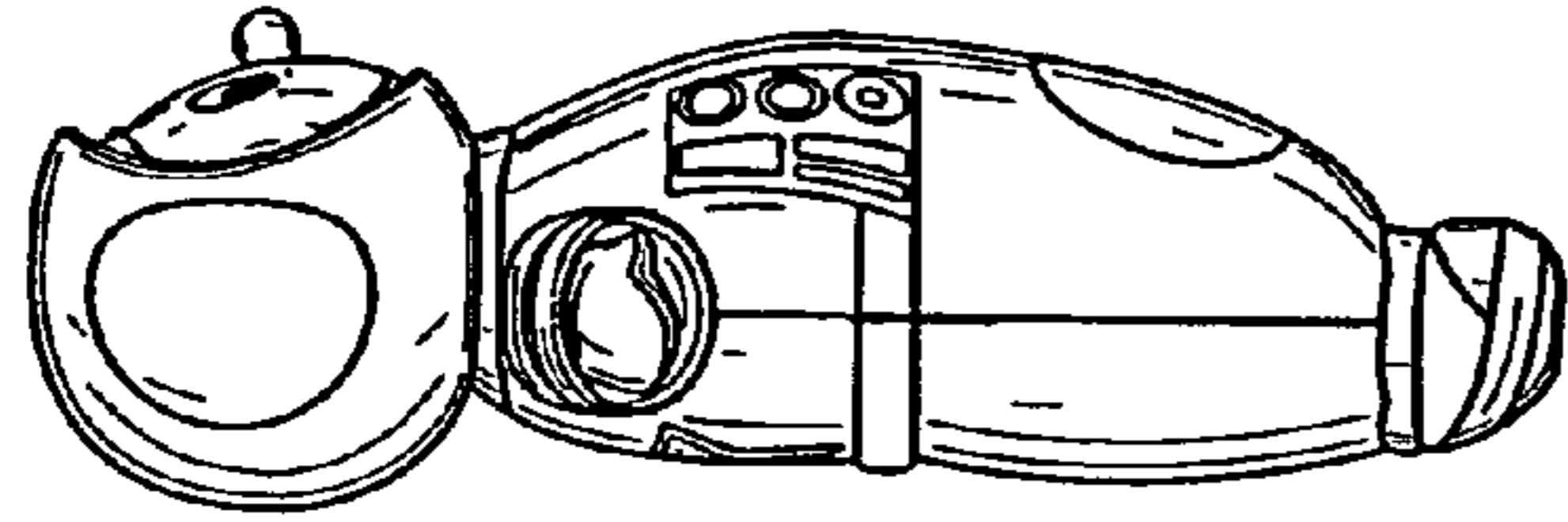

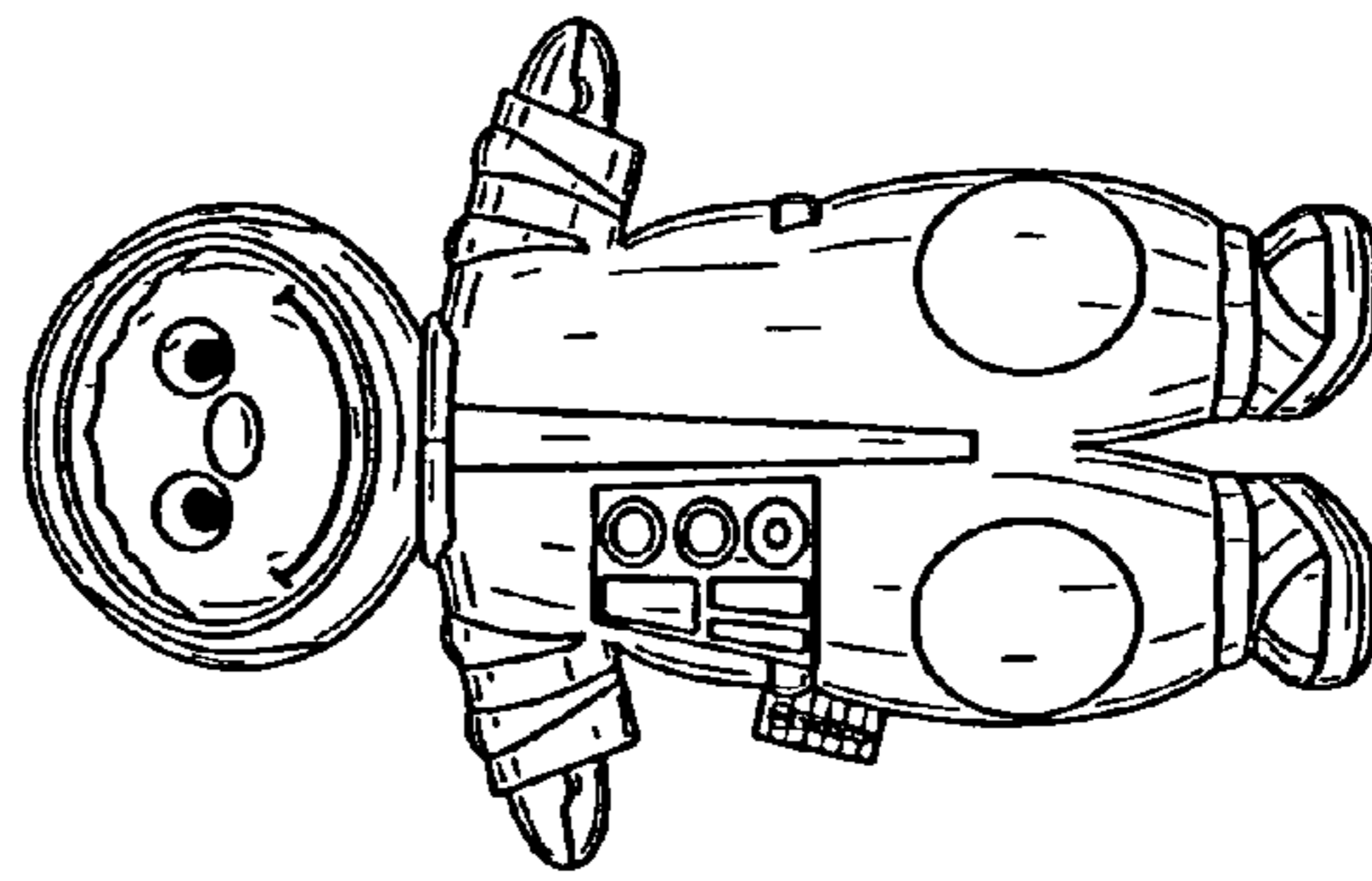

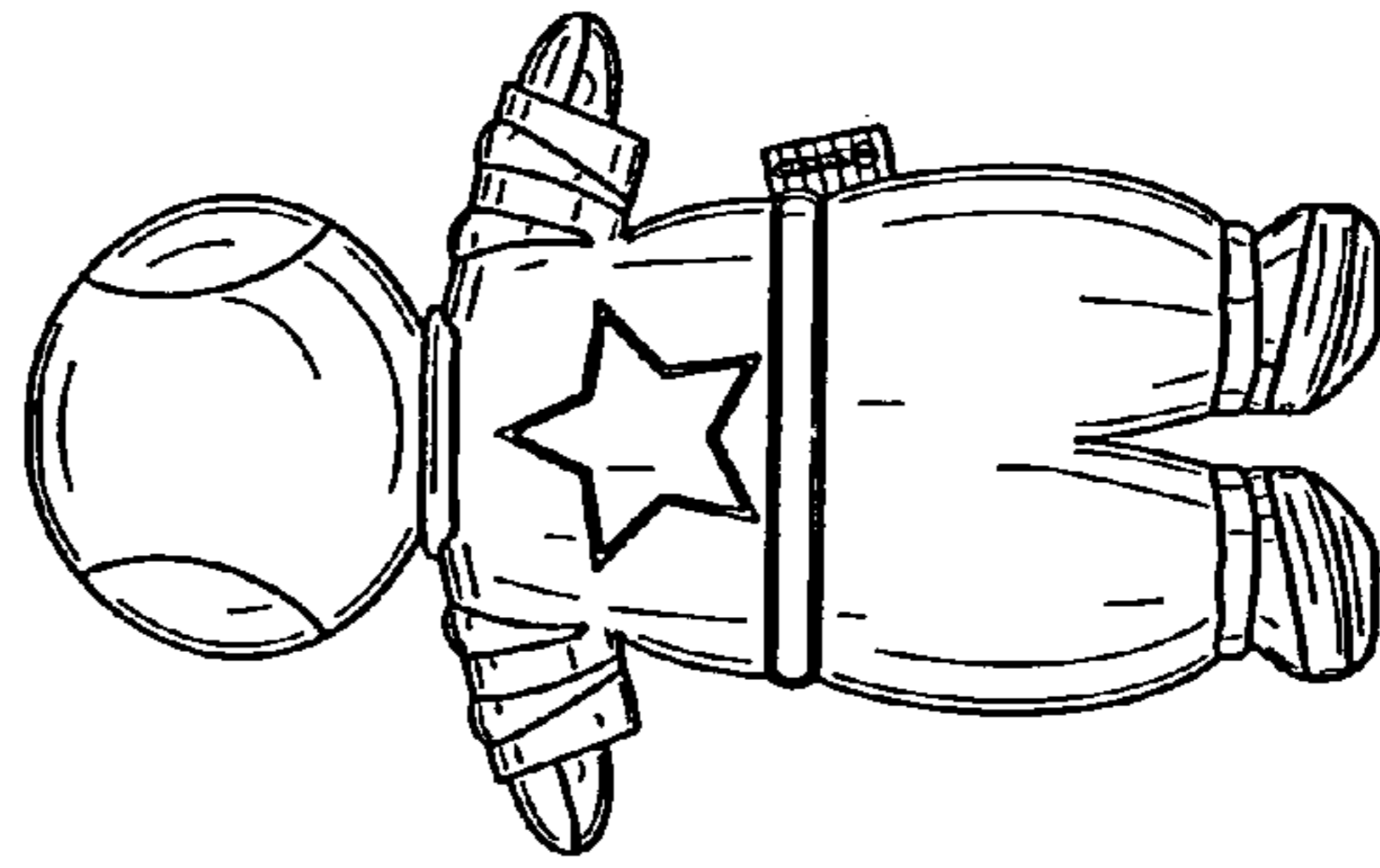
