FIG. 1 is a front view showing a first embodiment of my new design;

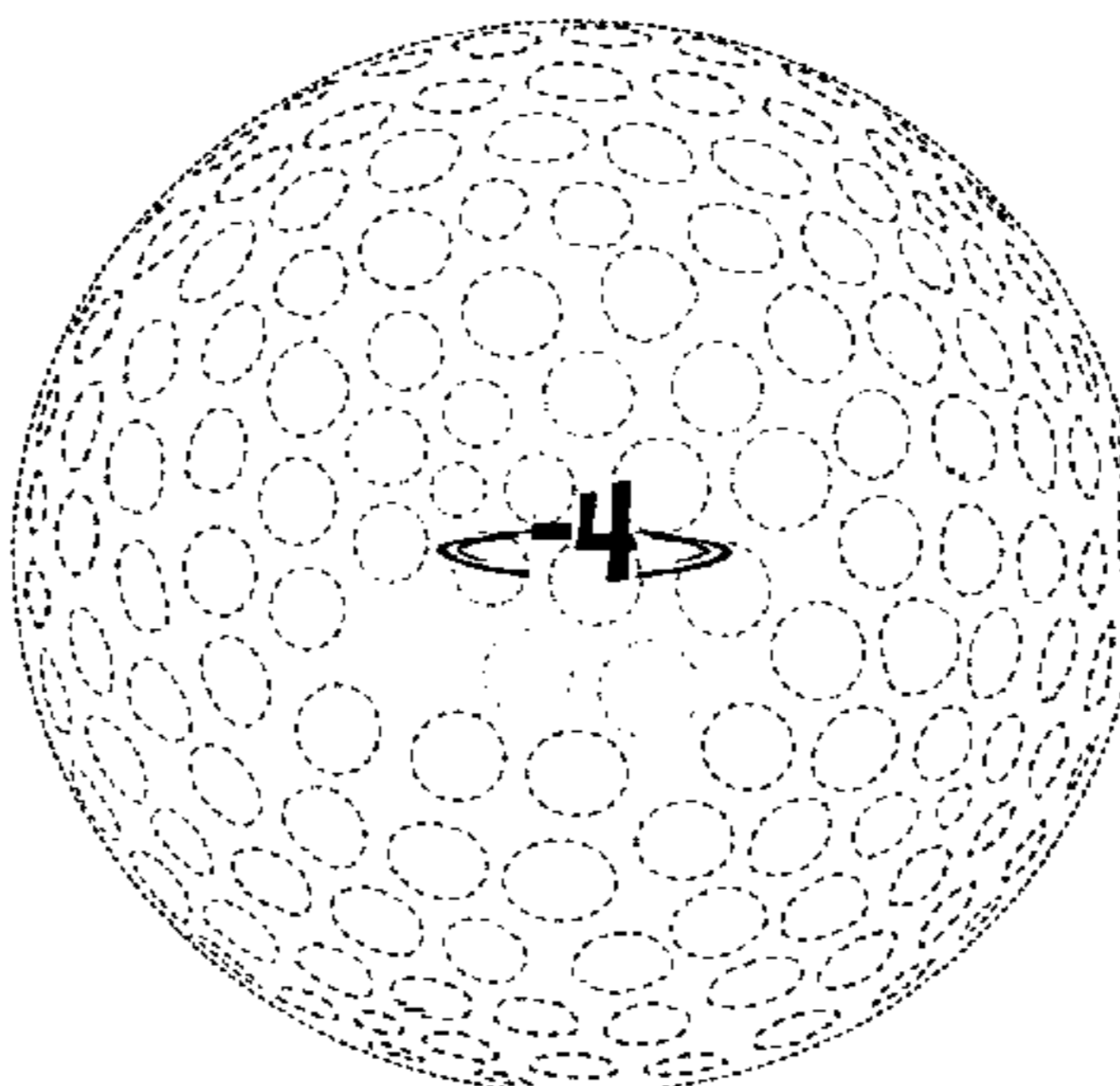
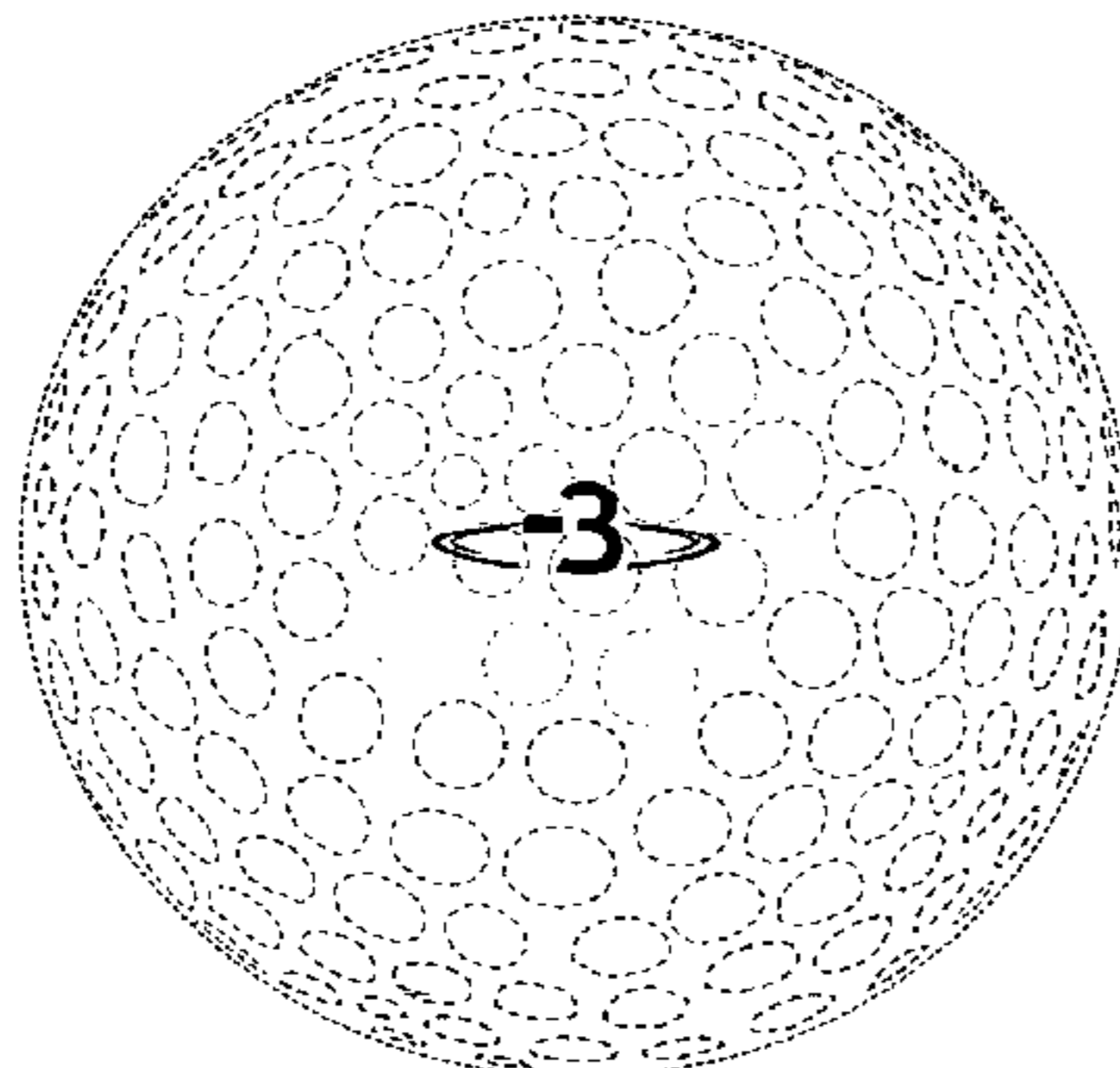
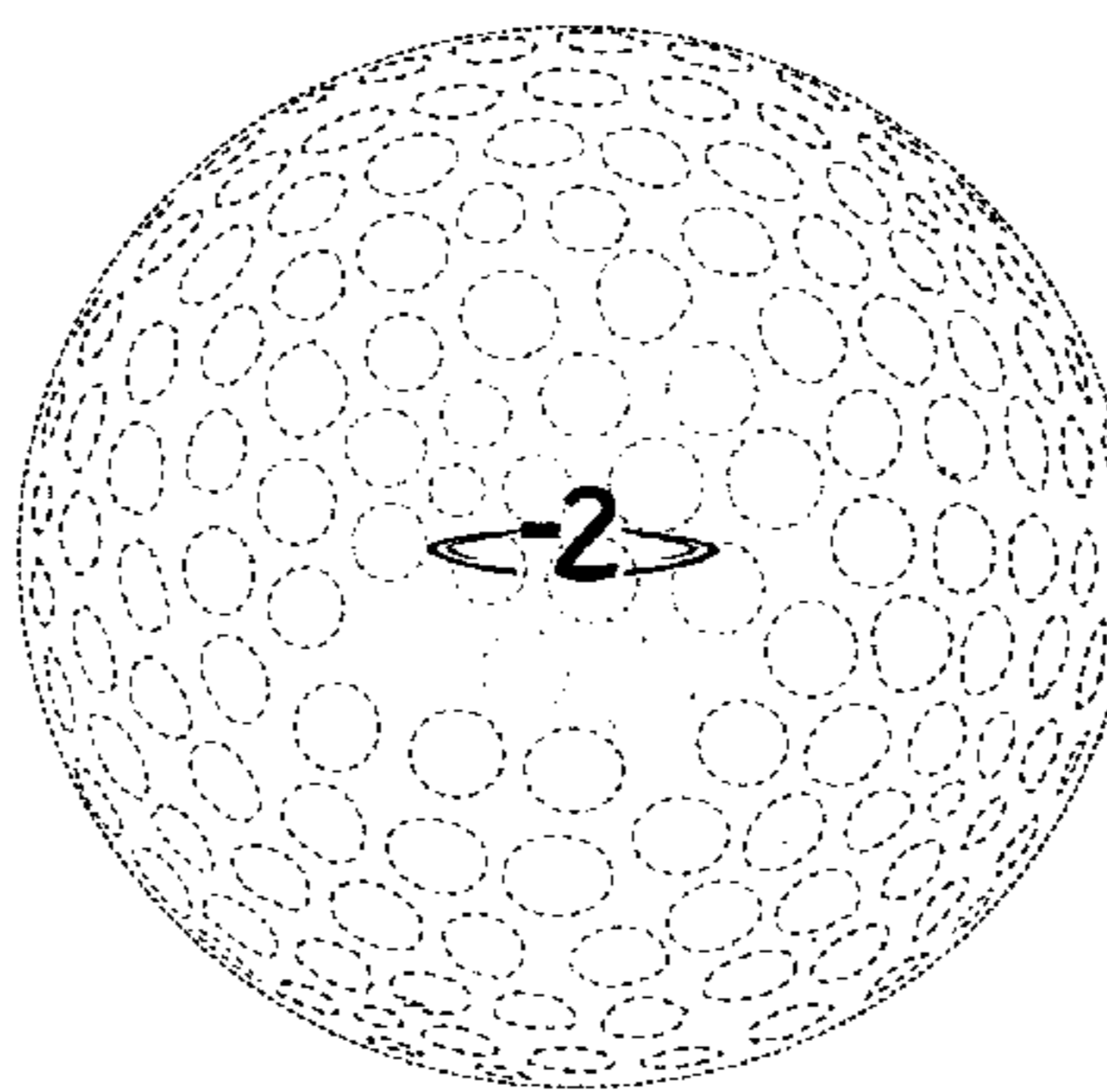
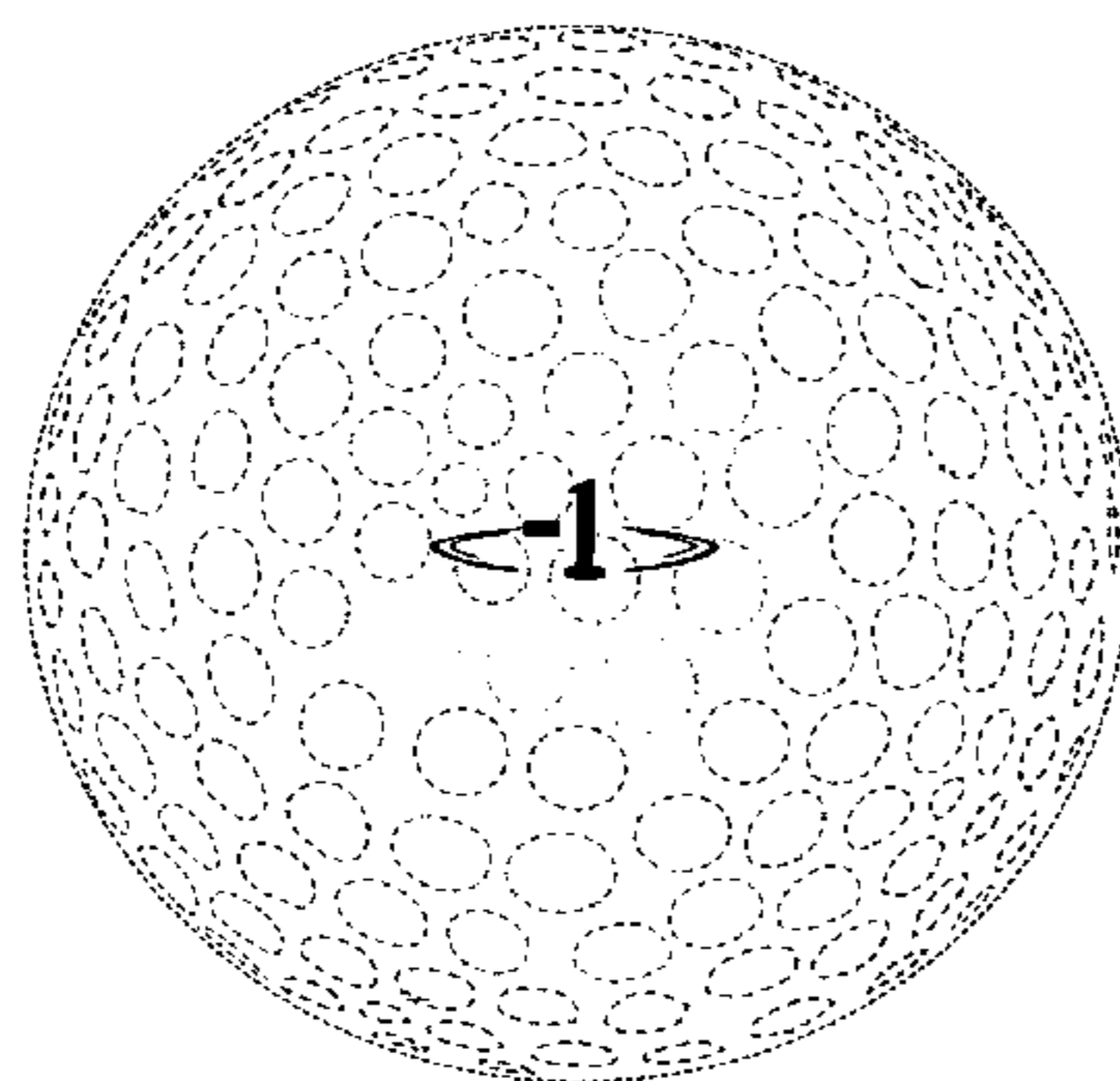
FIG. 2 is a front view showing a second embodiment of the design;

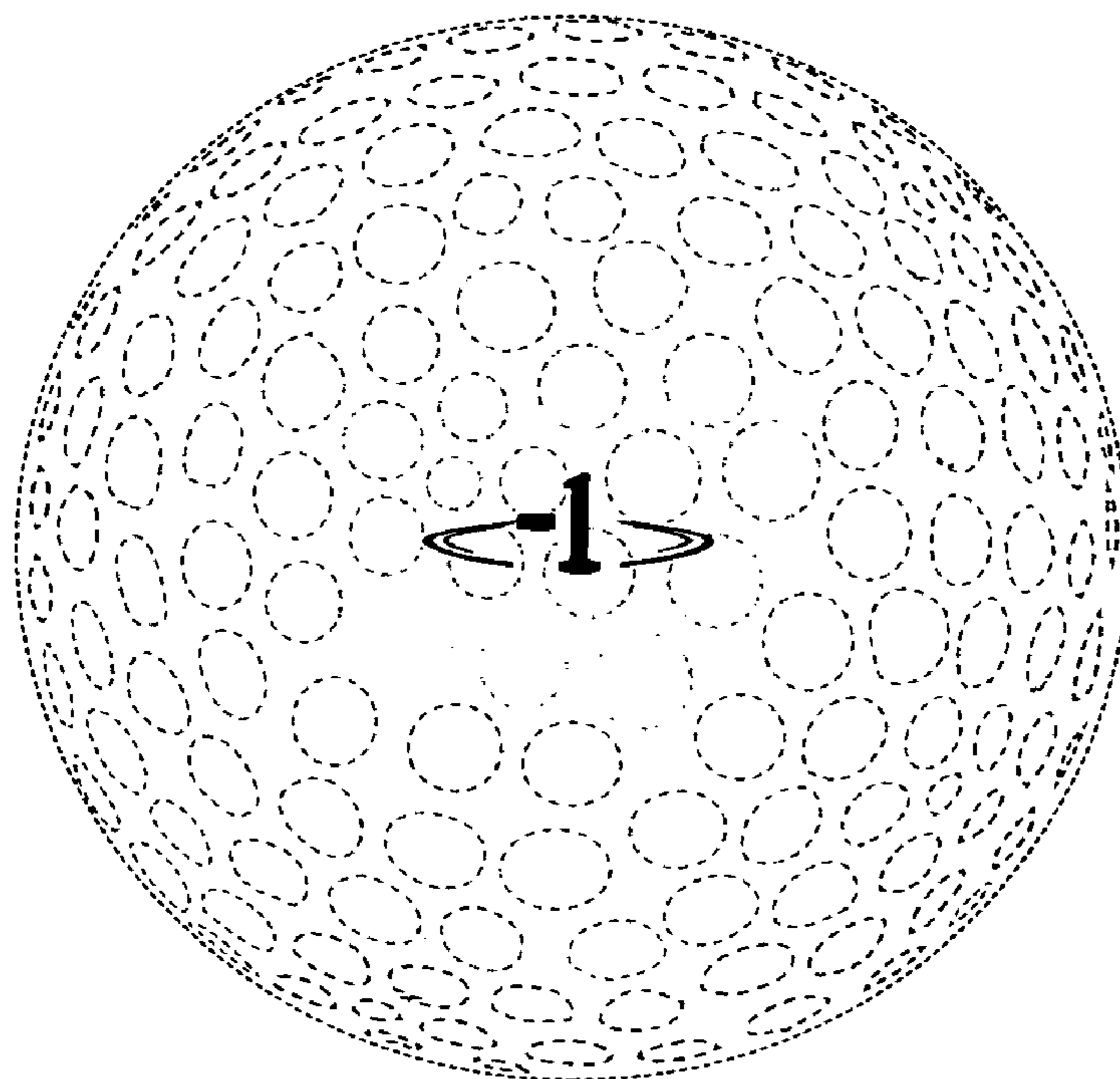

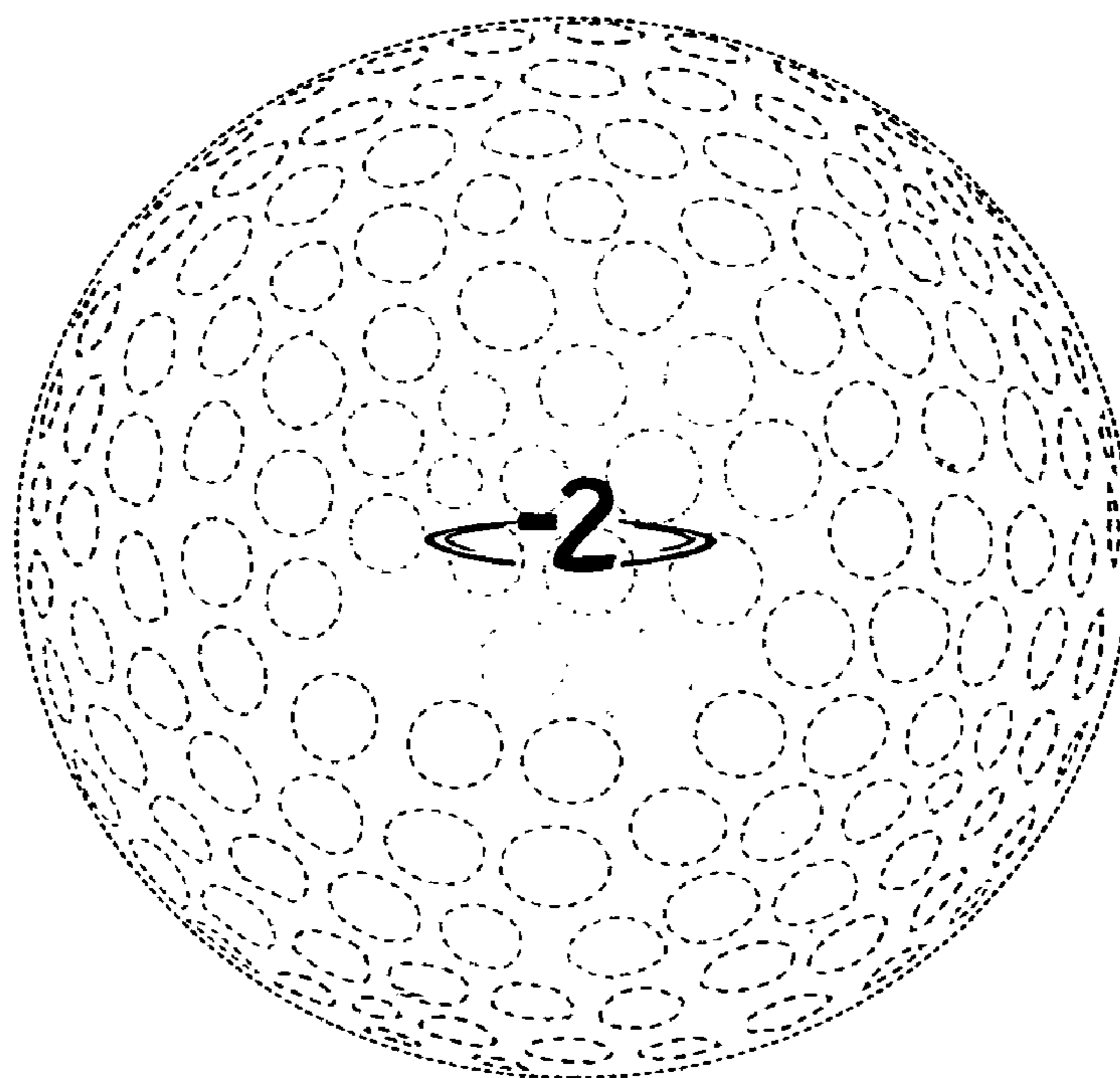

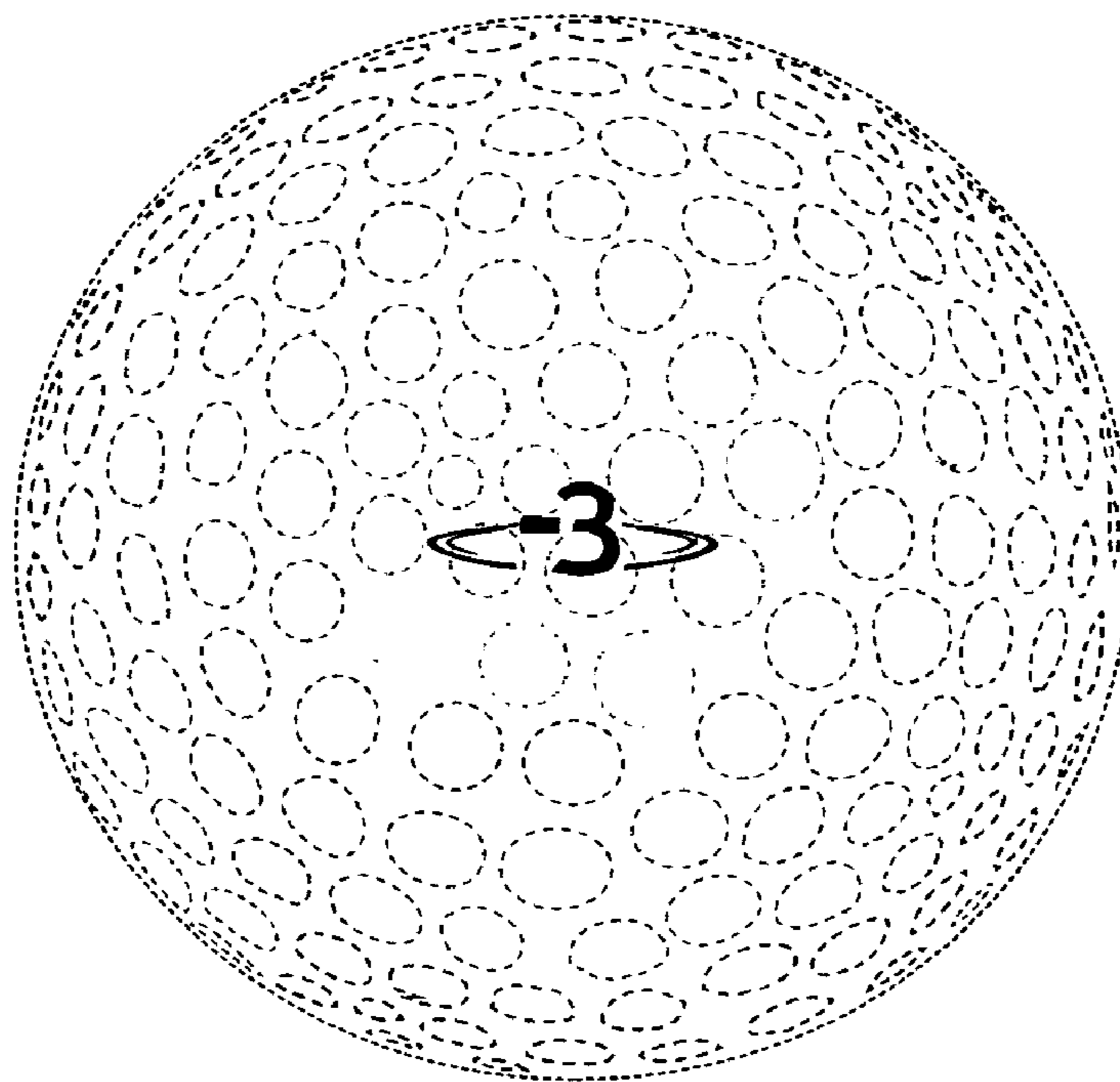

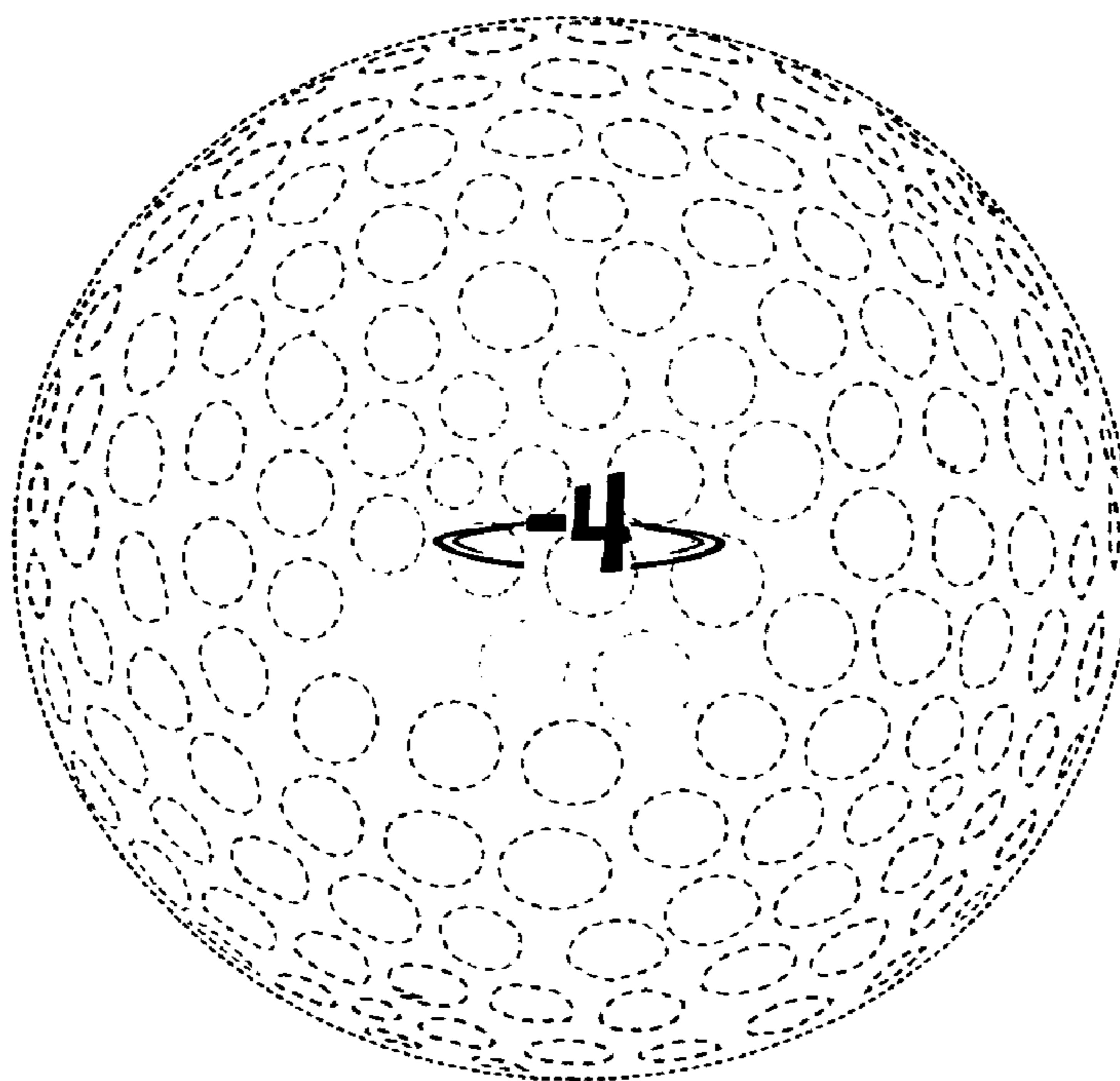
