(57) **CLAIM**

The ornamental design for an outdoor refuse container, as shown and described.

DESCRIPTION

FIG. 1 is an upper, front, right perspective view of an outdoor refuse container showing my new design, with the lid shown separated;

FIG. 2 is another upper, front, right perspective view thereof, with the lid in a closed position;

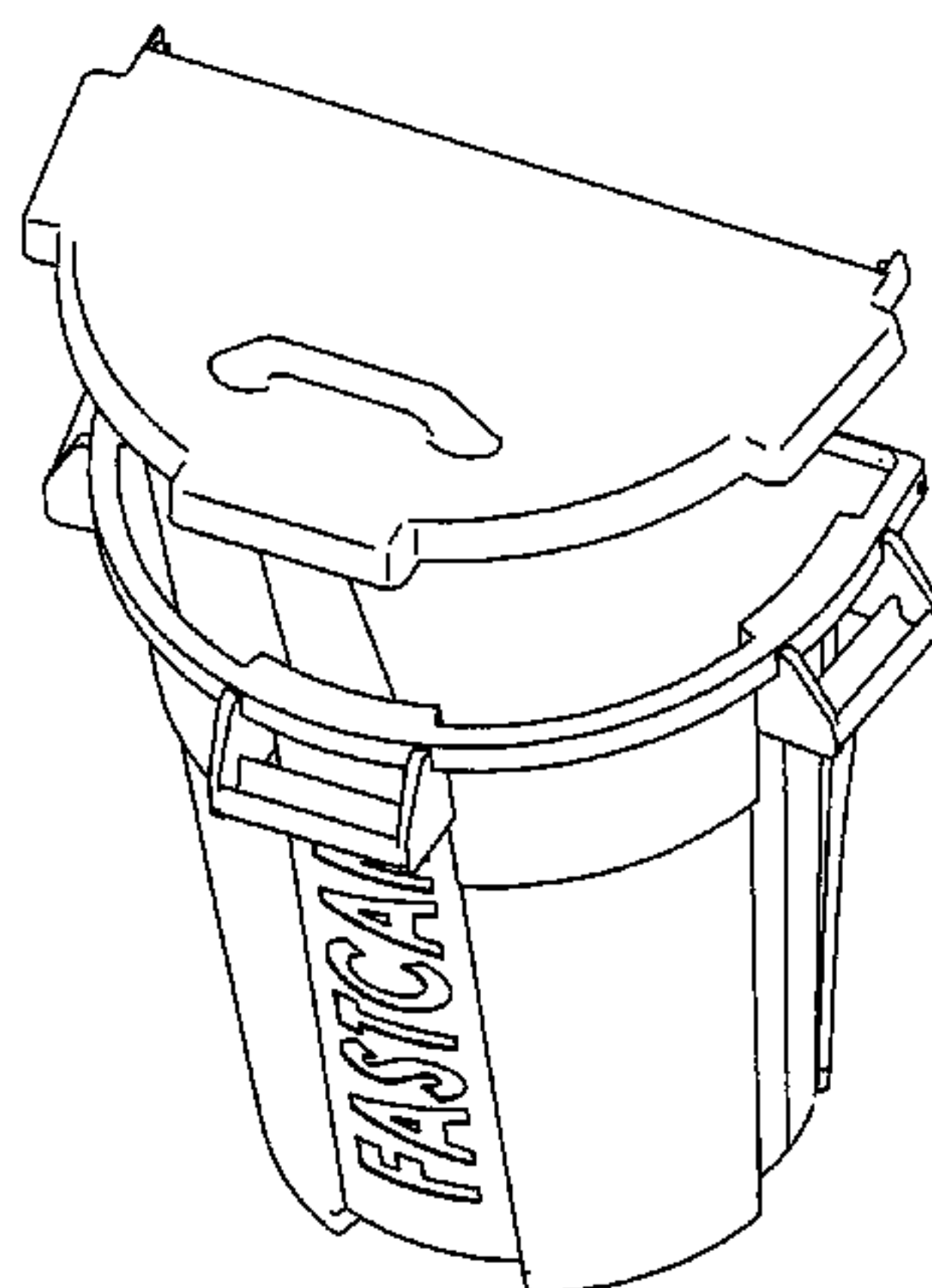
FIG. 3 is a left side view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a front view thereof; and,

FIG. 6 is an upper, front, right perspective view thereof with the lid in the raised position.

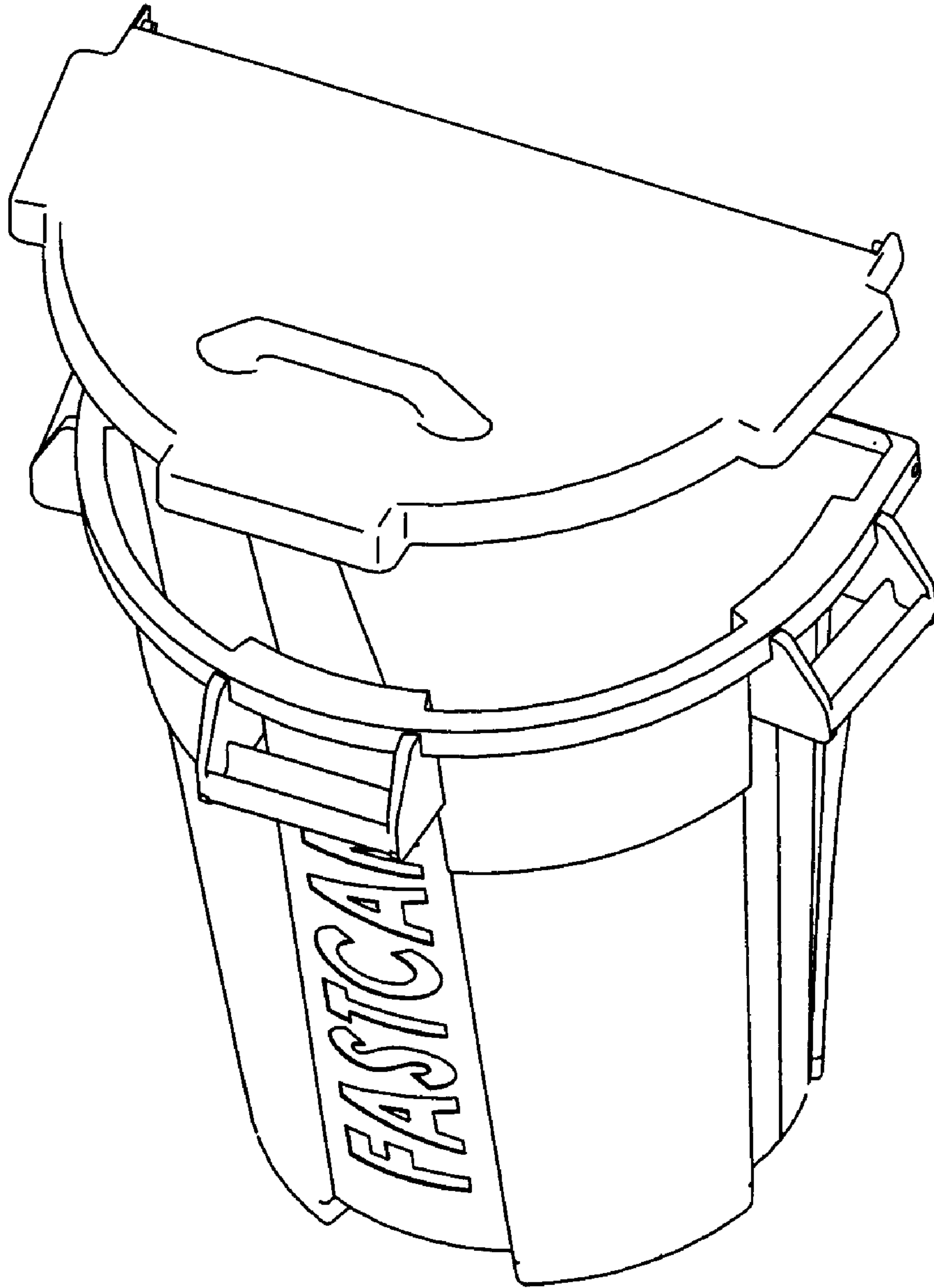

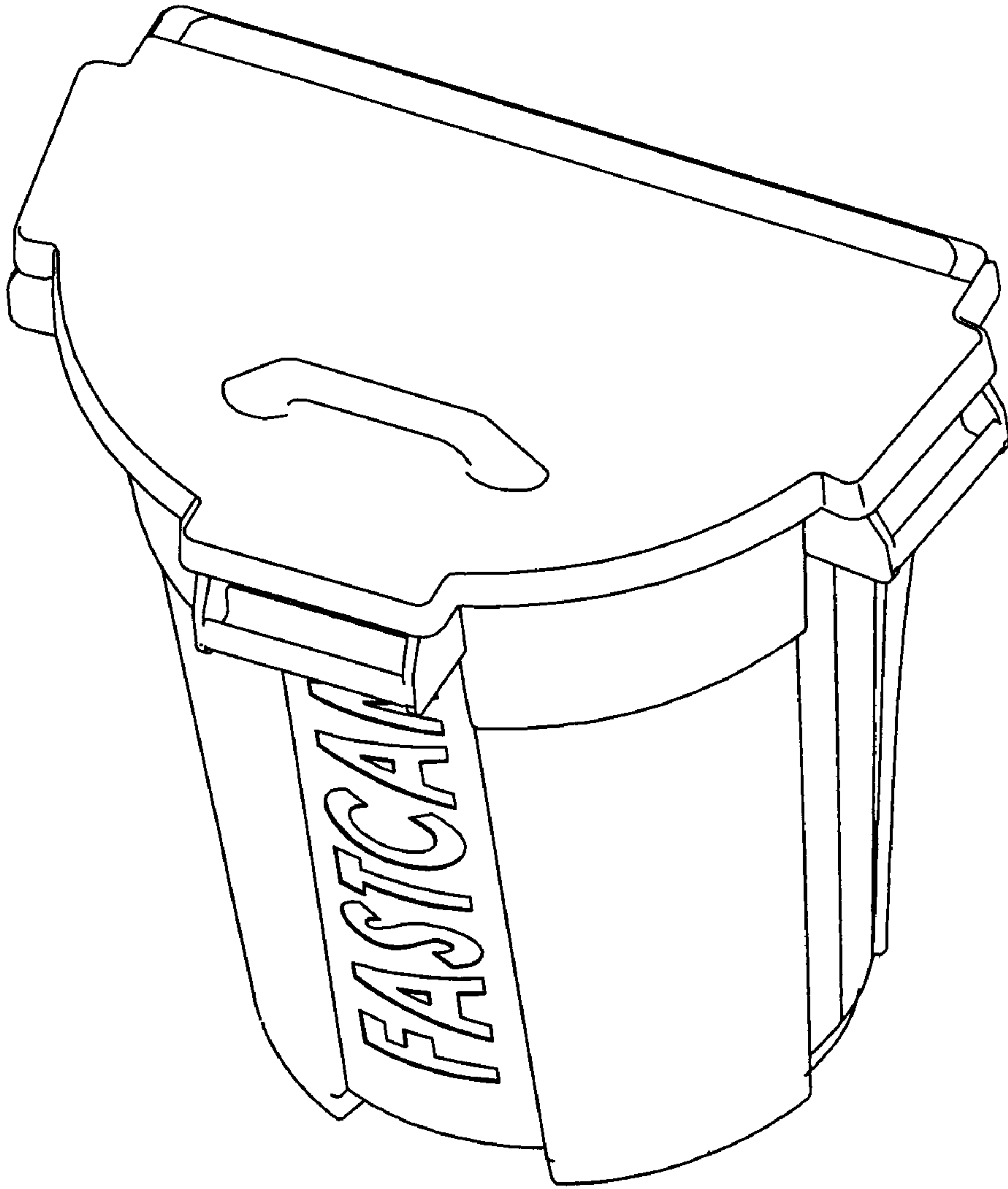

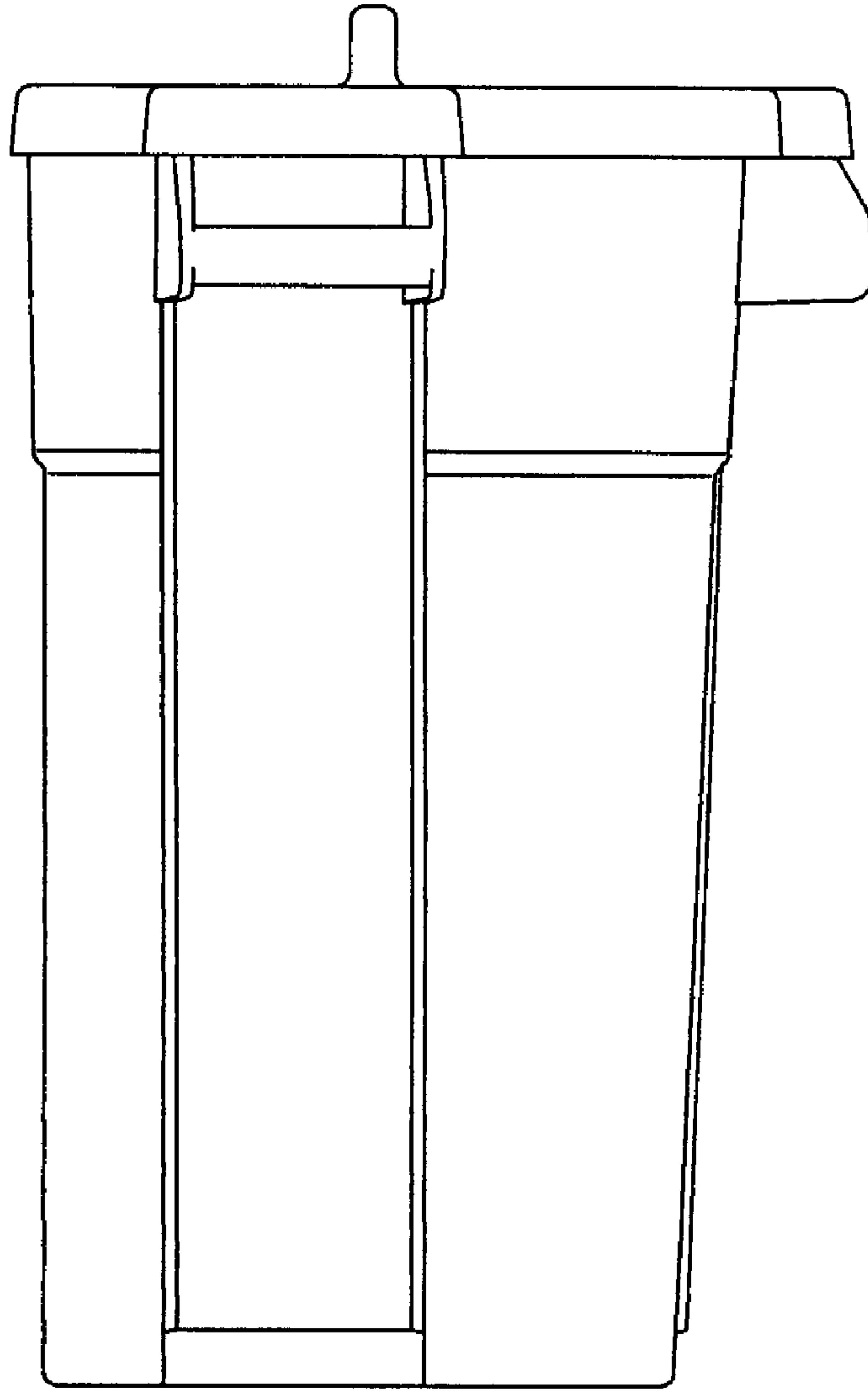

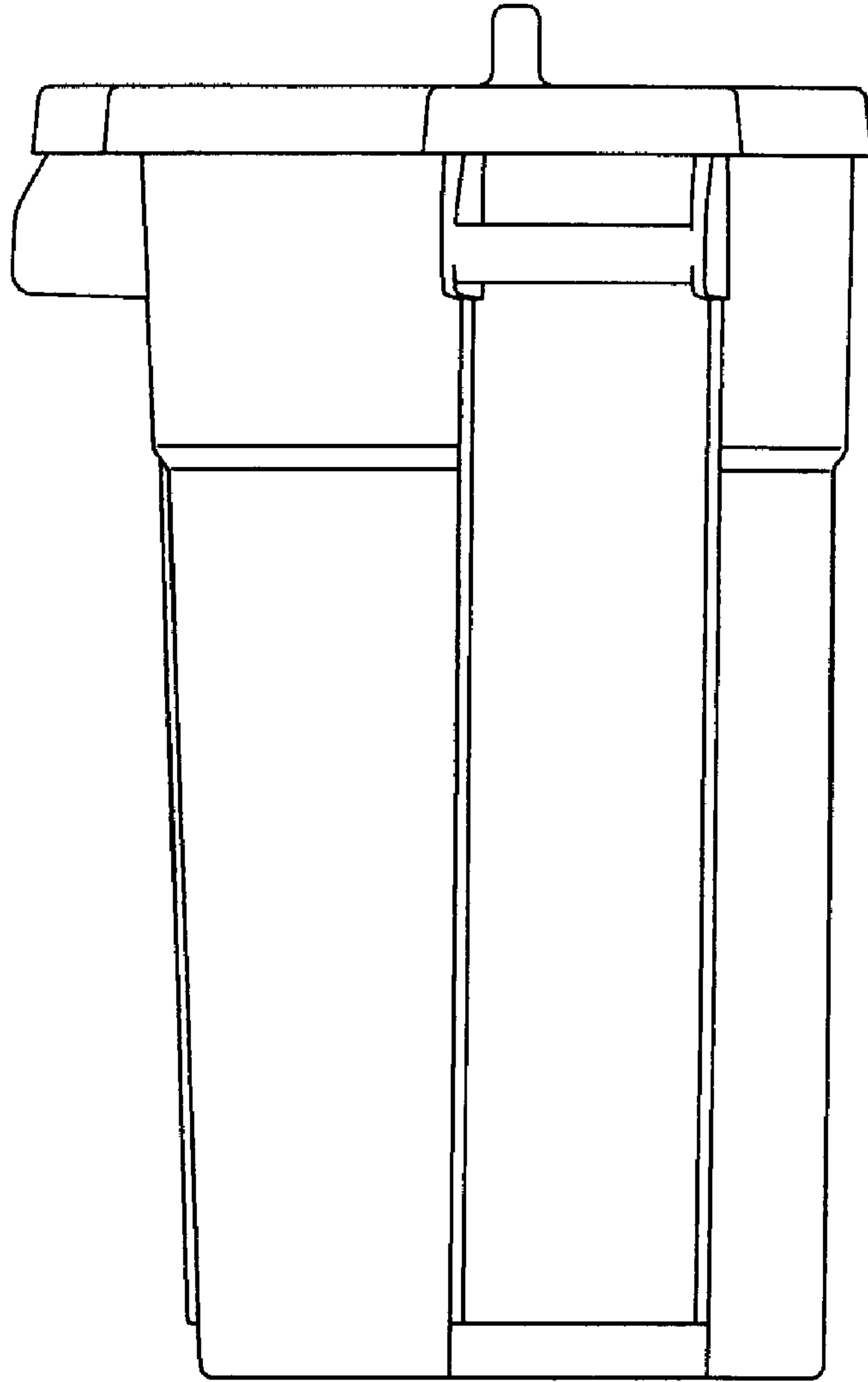

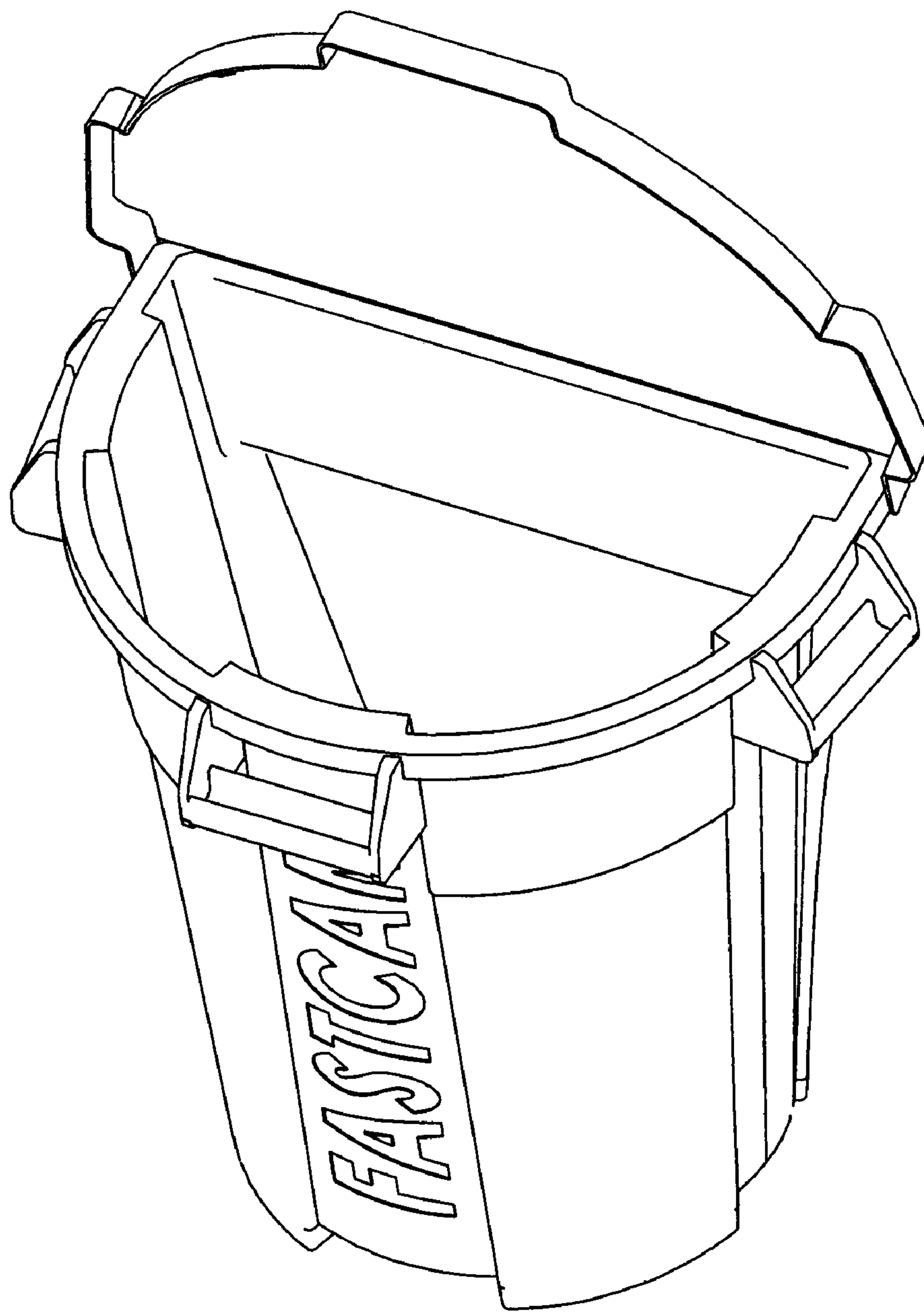
