I claim the ornamental design for a sole for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a sole for footwear showing my new design;

FIG. 2 is a top perspective view thereof;

FIG. 4 is a right side elevational view thereof;

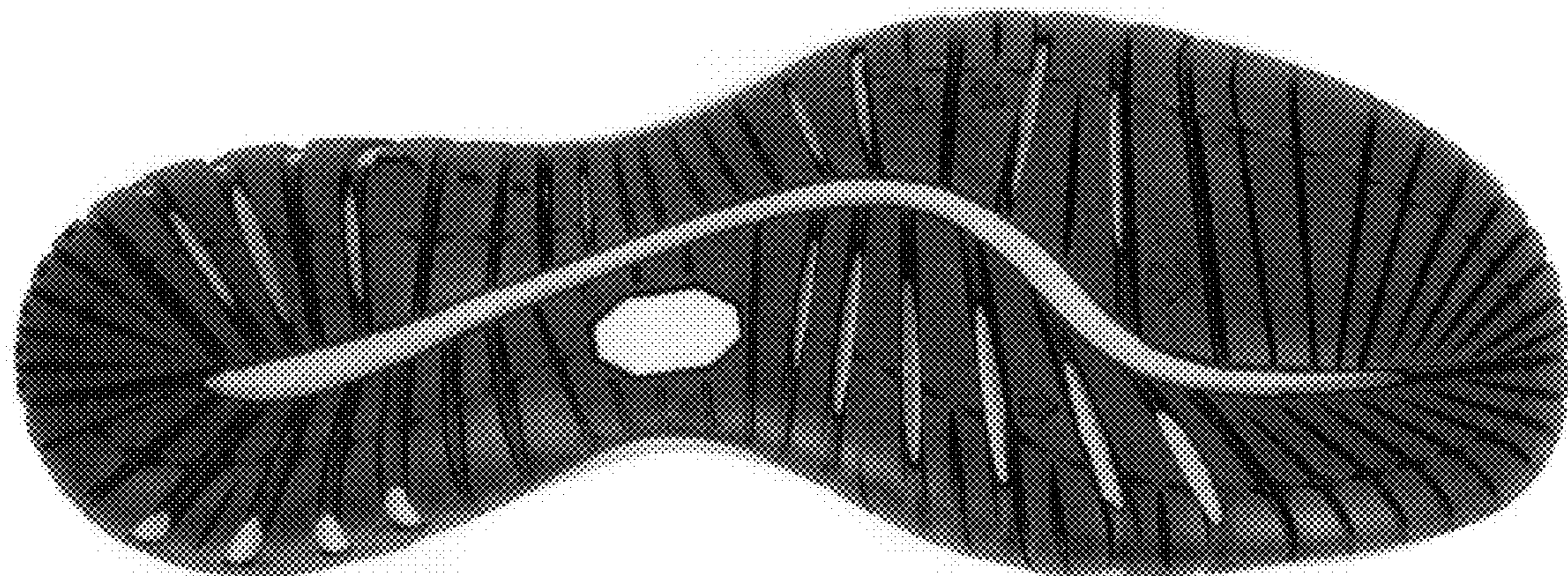

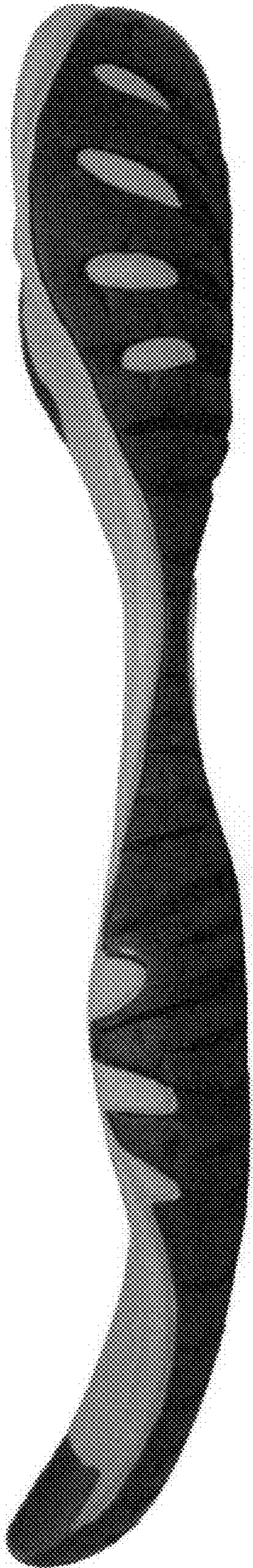

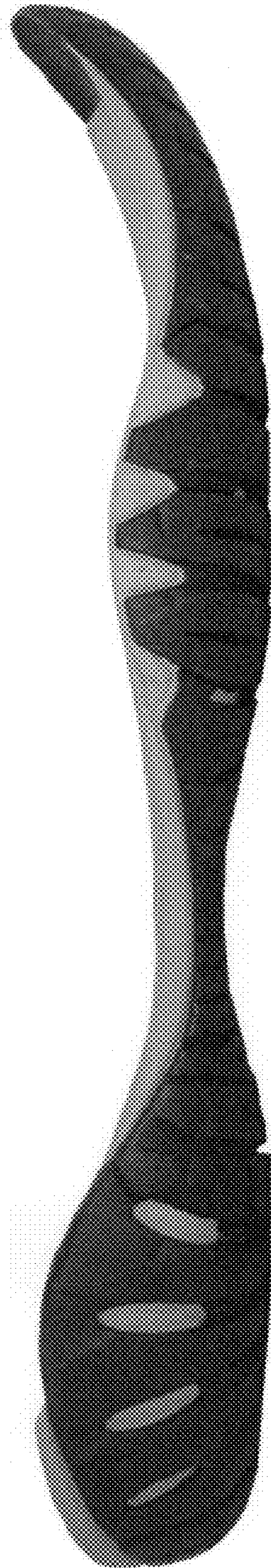

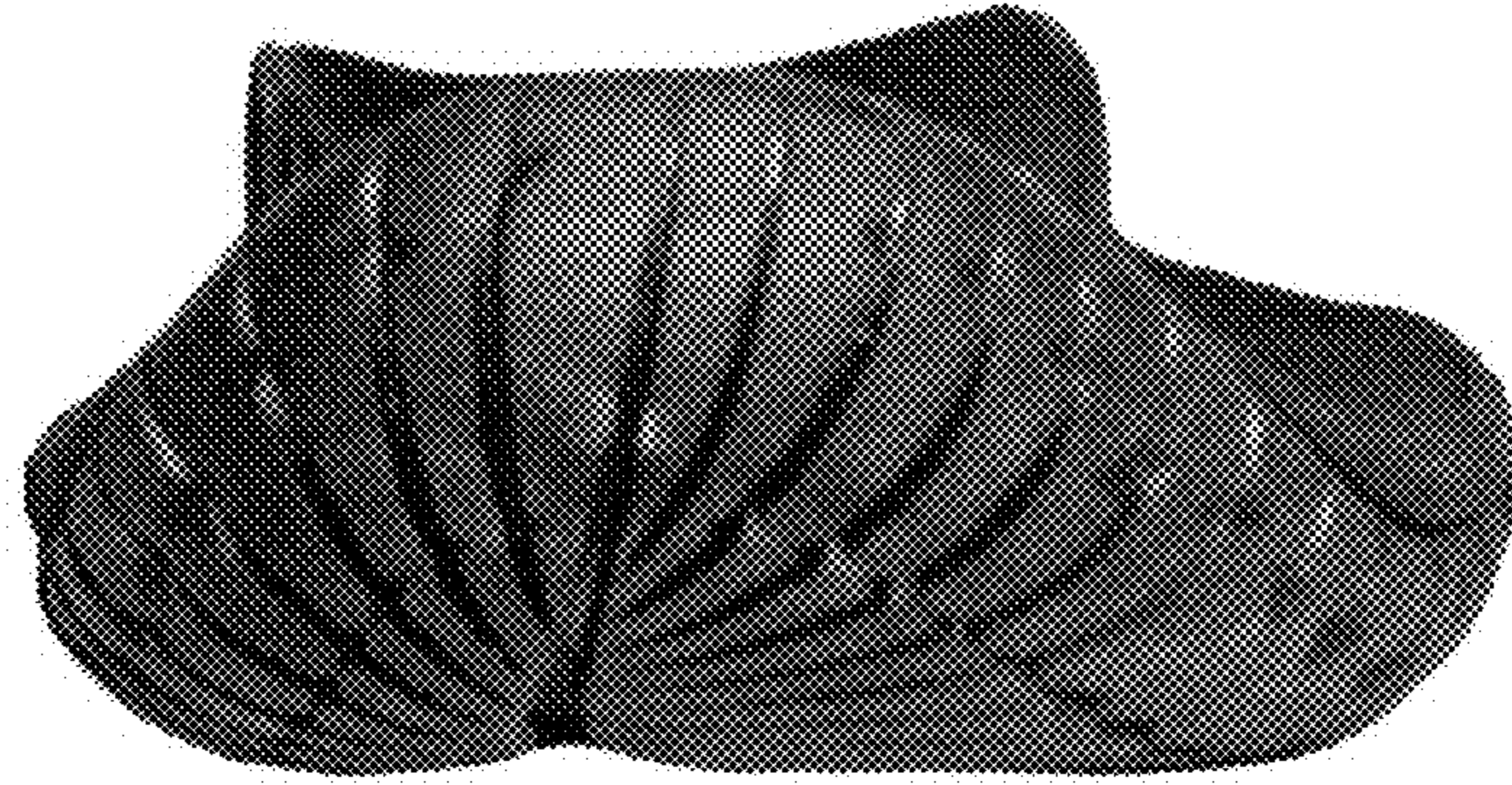
