The ornamental design for a tackle box, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a tackle box showing my new design;

FIG. 2 is a rear elevational view thereof;

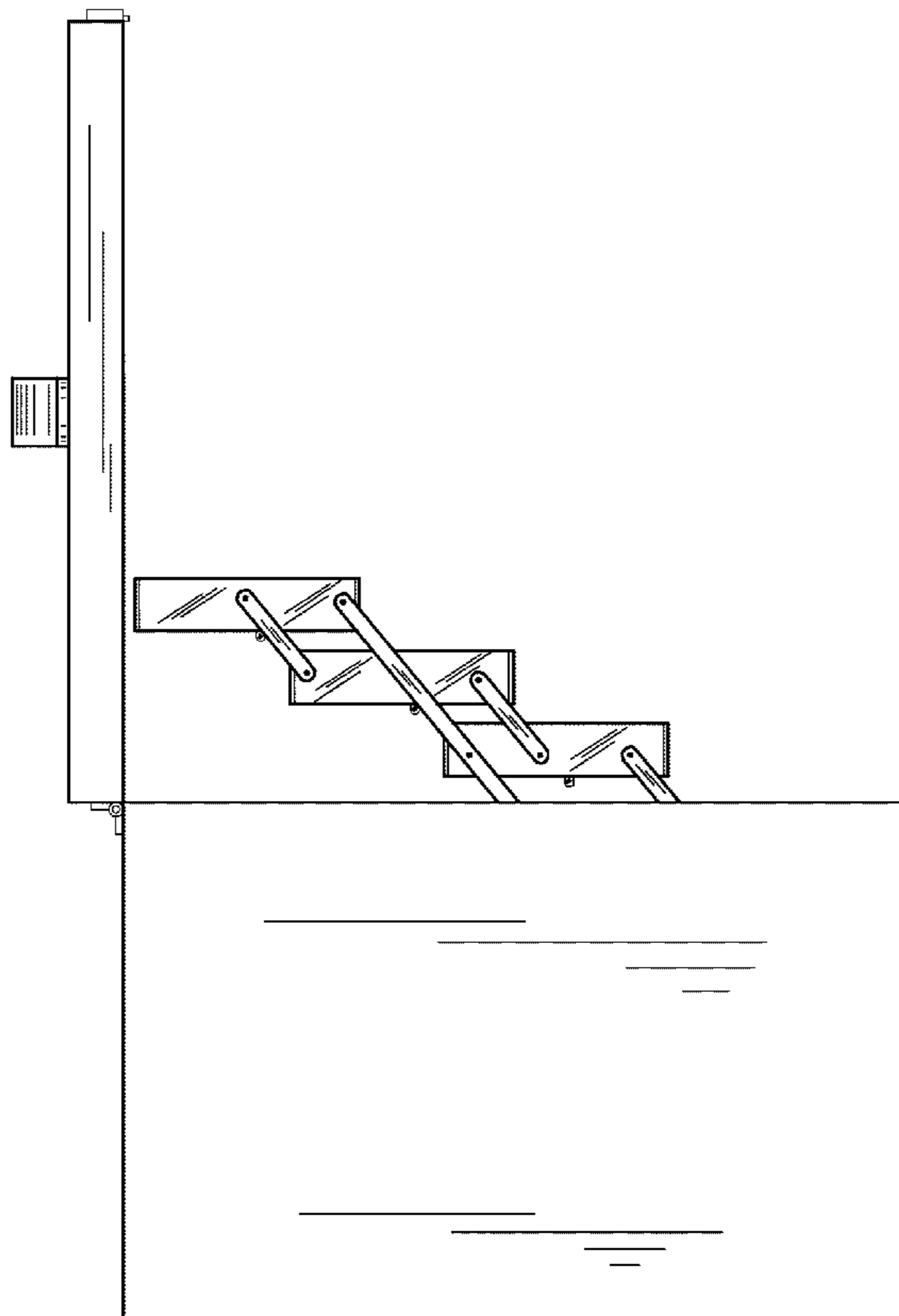
FIG. 3 is a side view, taken from the left side of FIG. 1, the right side view being a mirror image thereof;

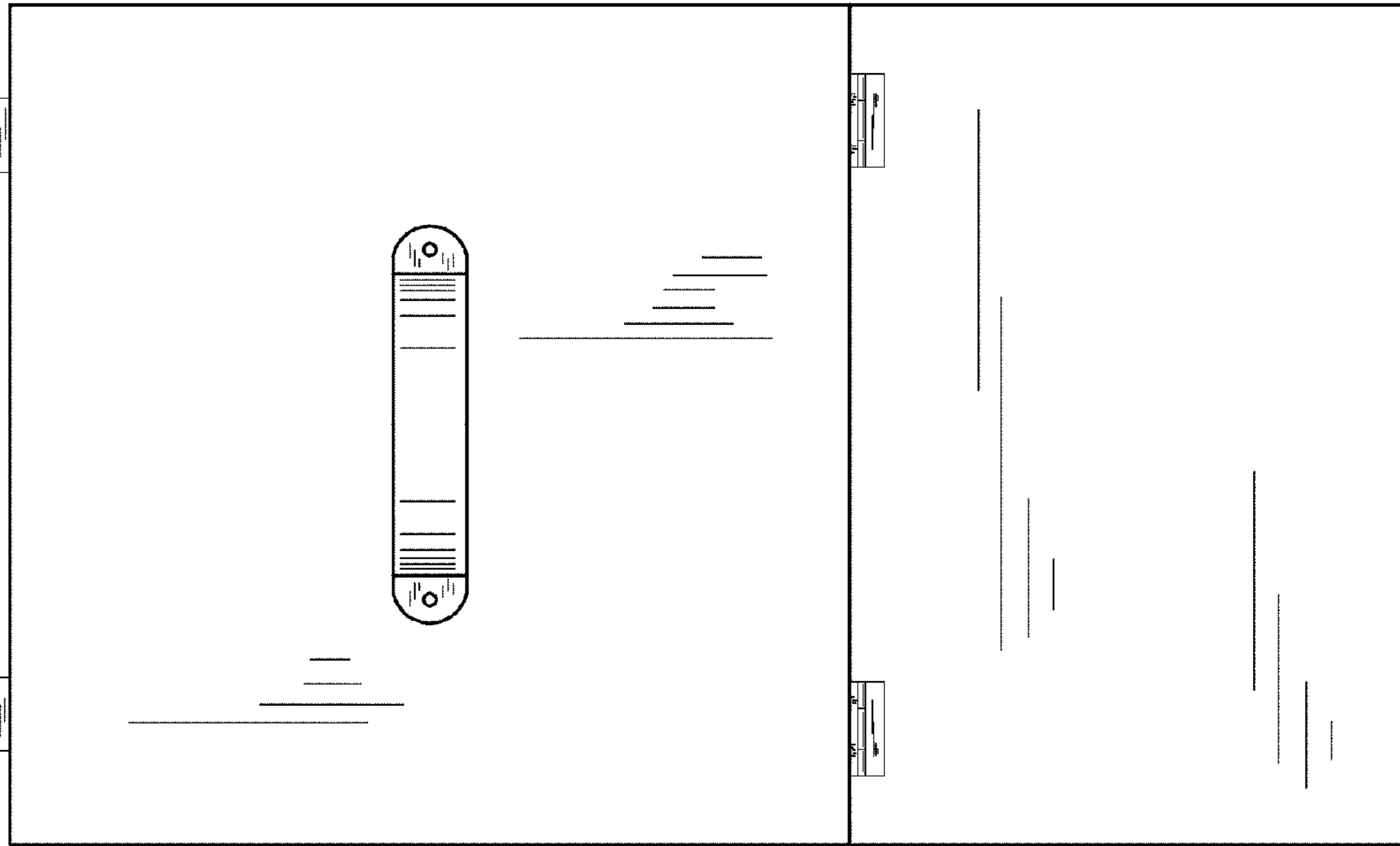

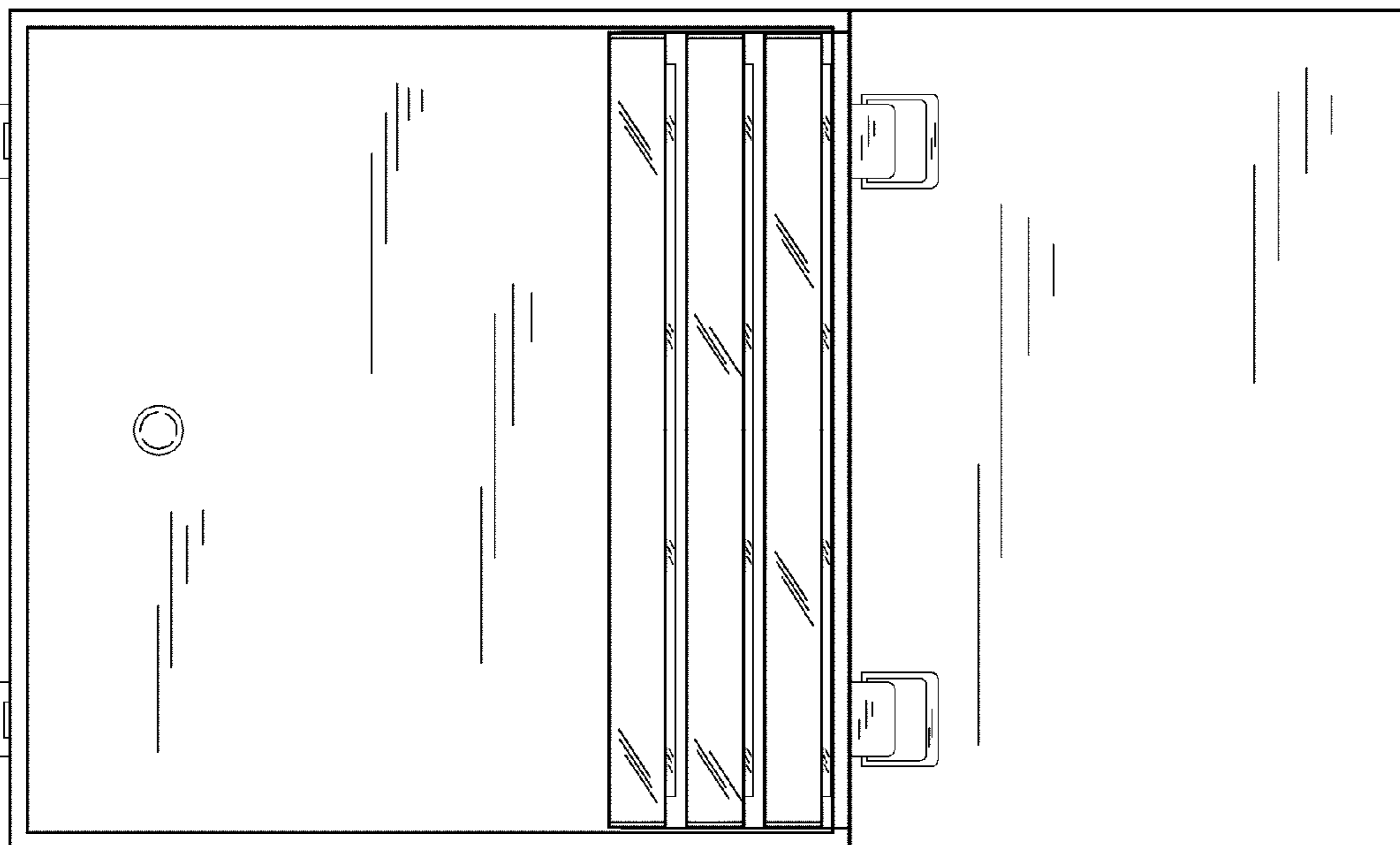

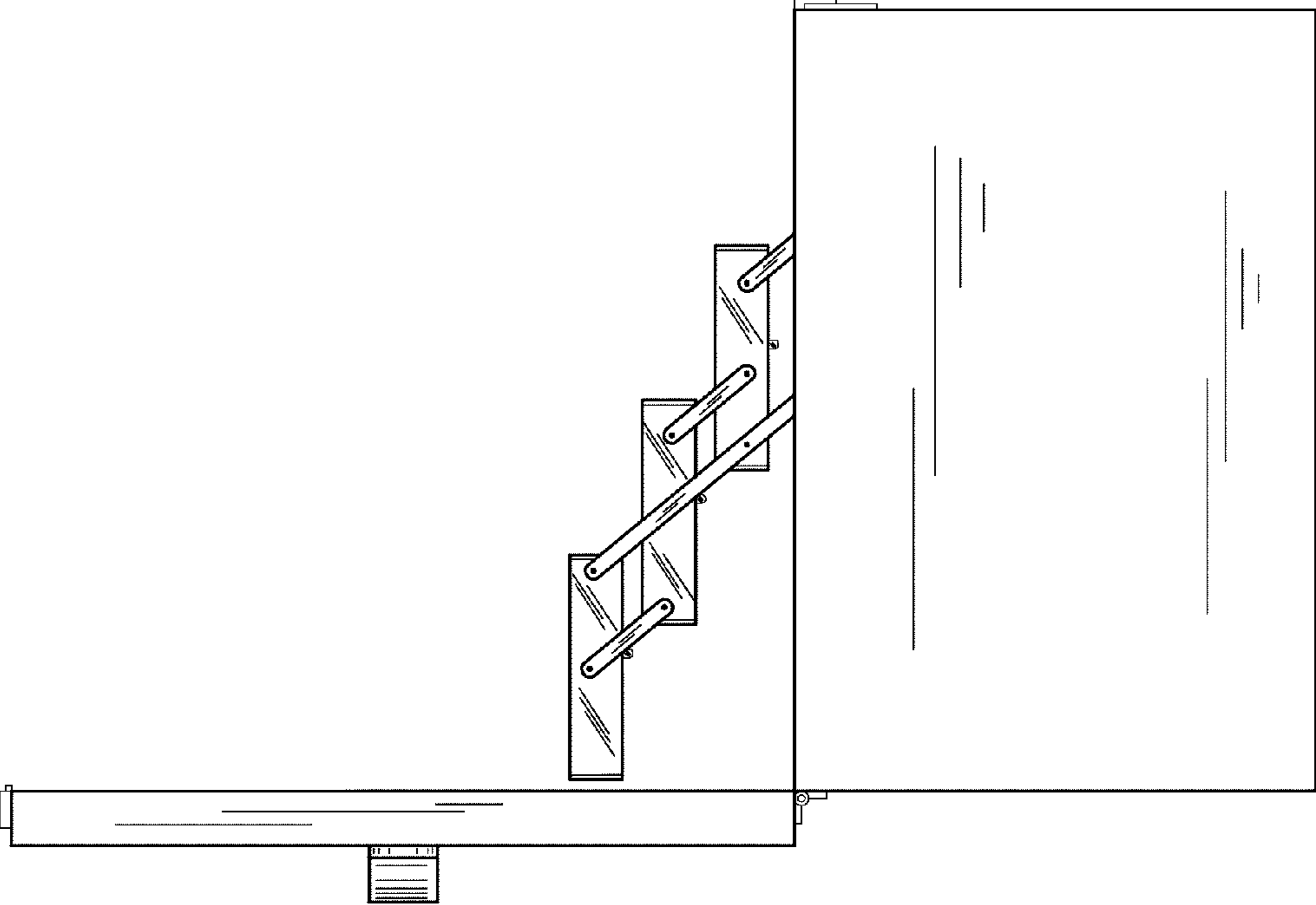

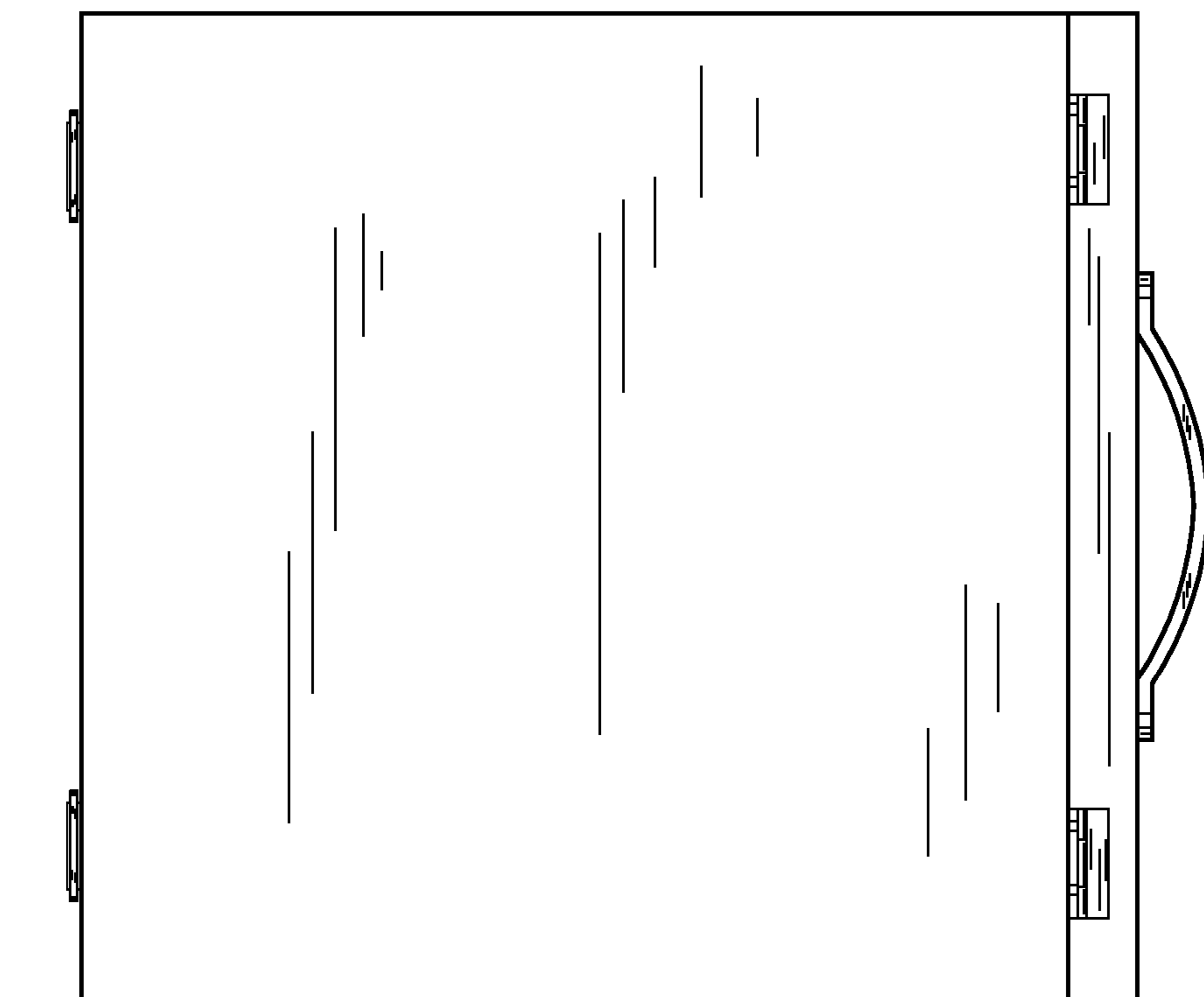

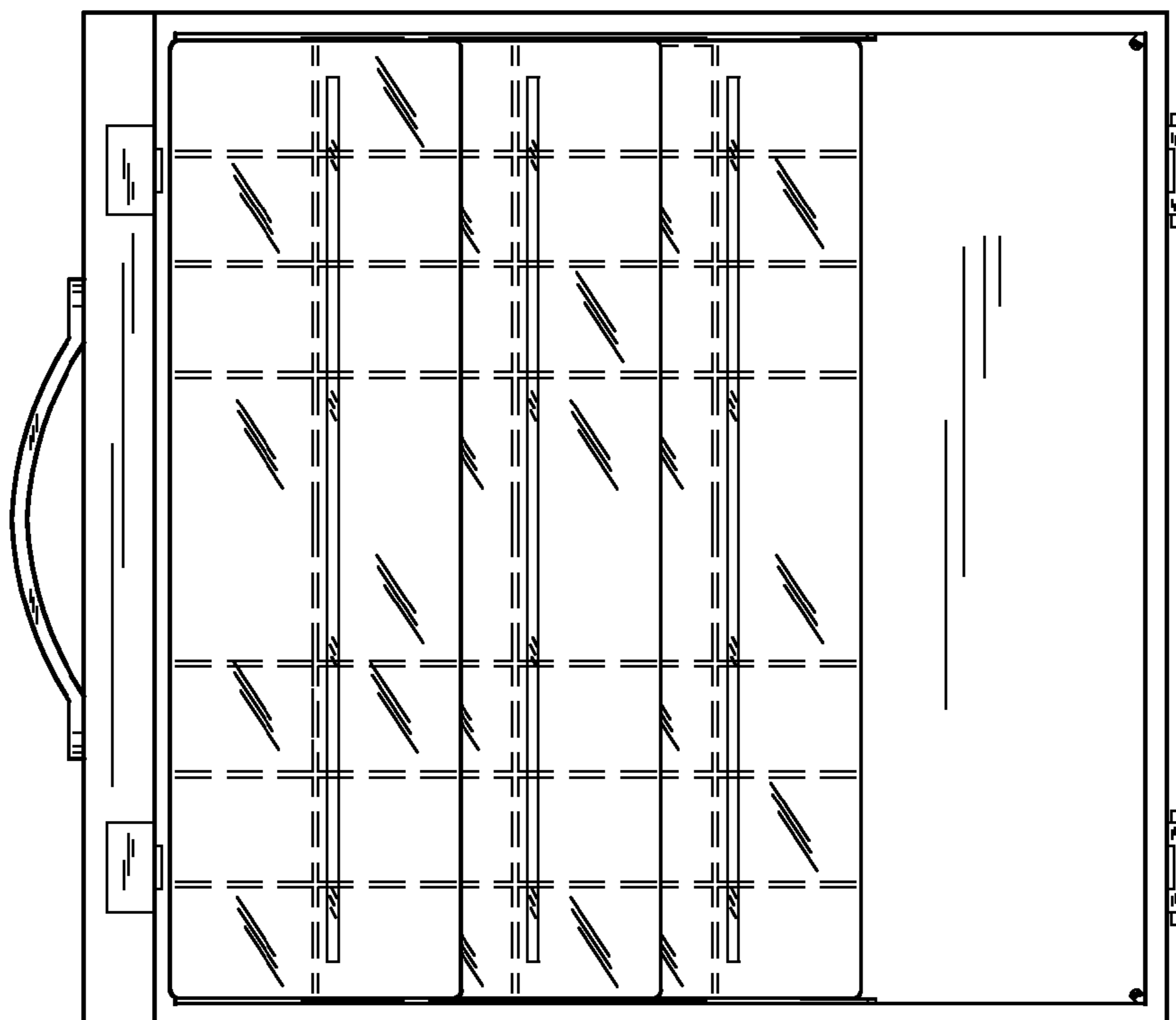
