I claim the ornamental design for a beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a beverage container;

FIG. 2 is a front view of the beverage container of FIG. 1;

FIG. 3 is a plan view of the beverage container of FIG. 1;

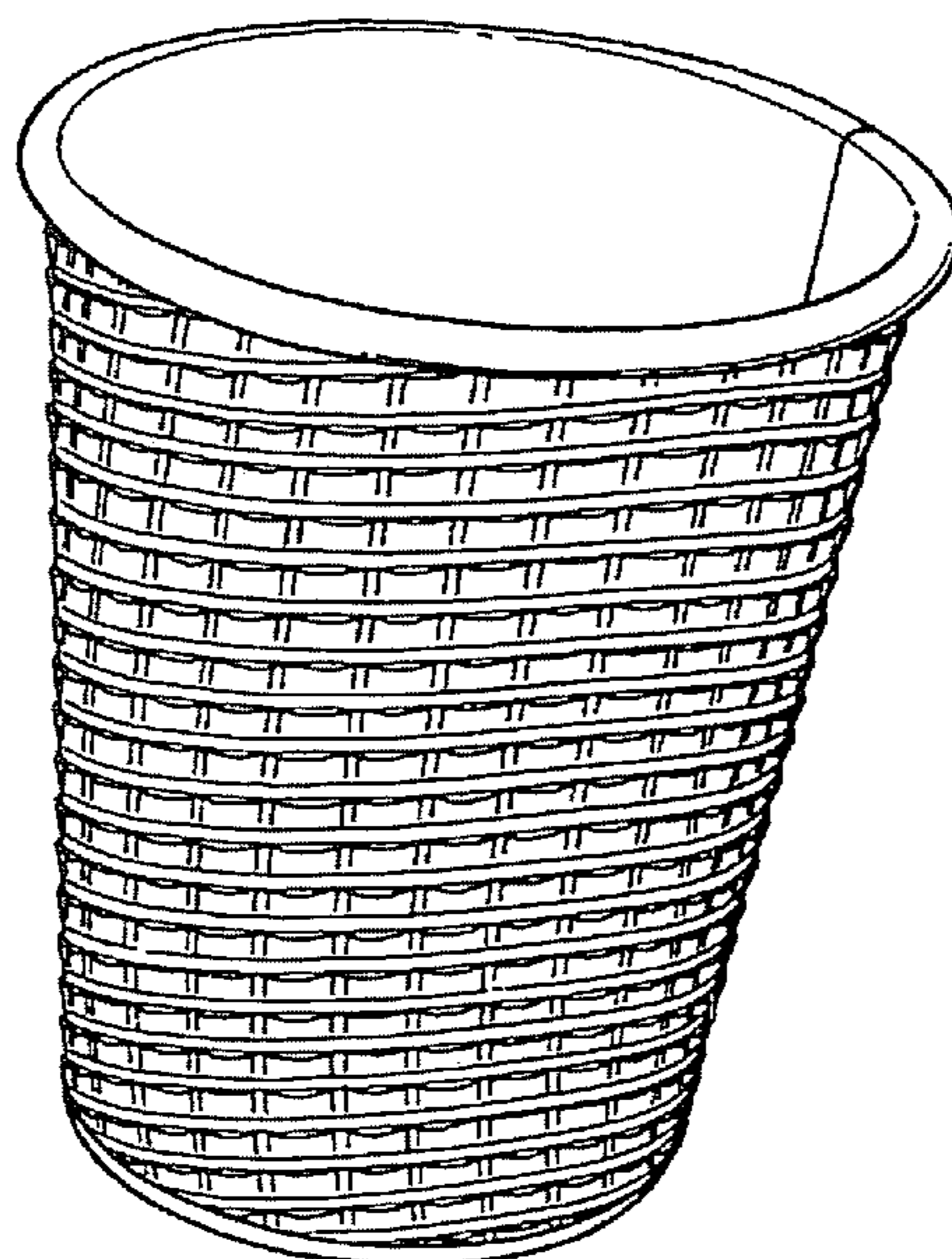
FIG. 4 is a right-hand side view of the beverage container of FIG. 1;

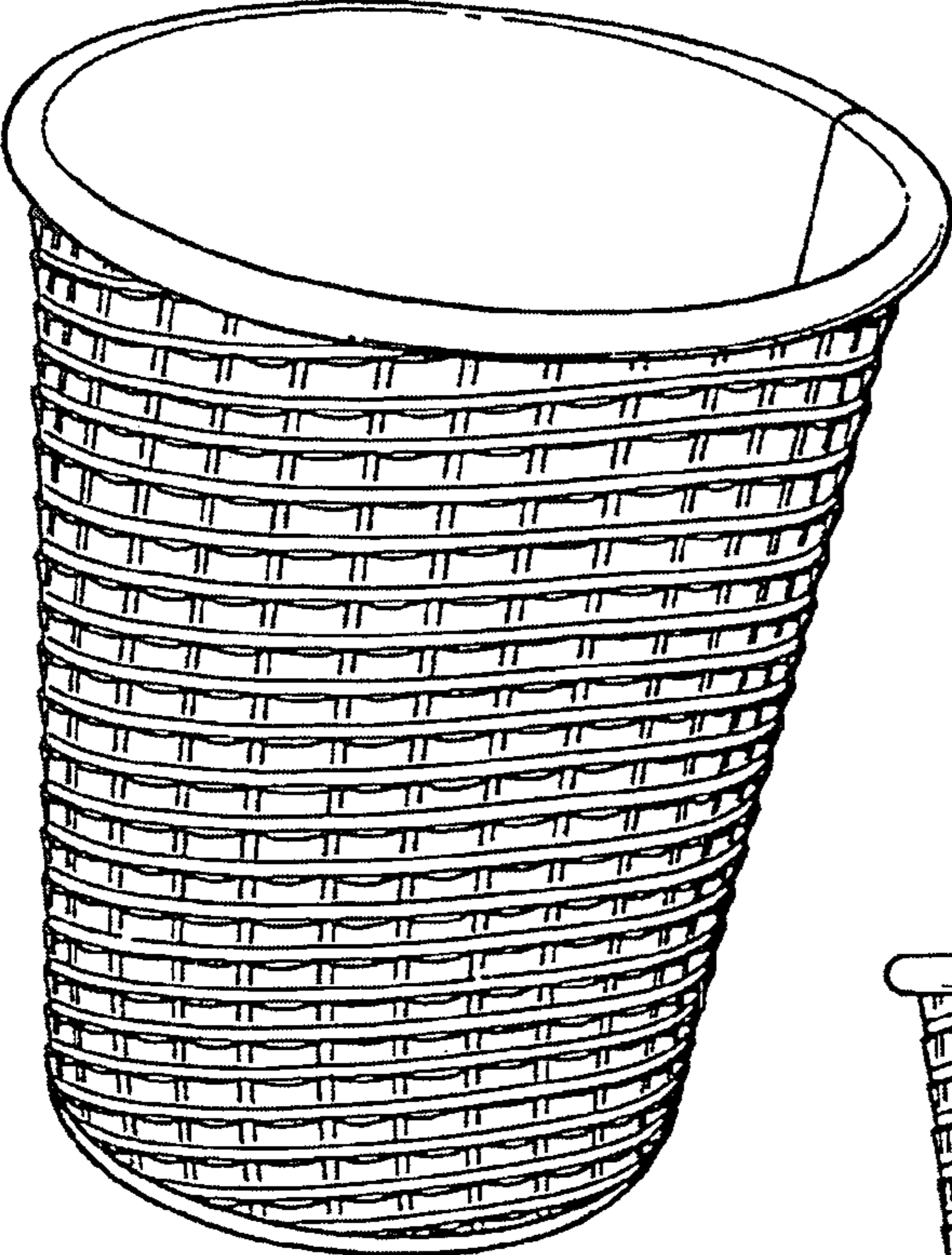

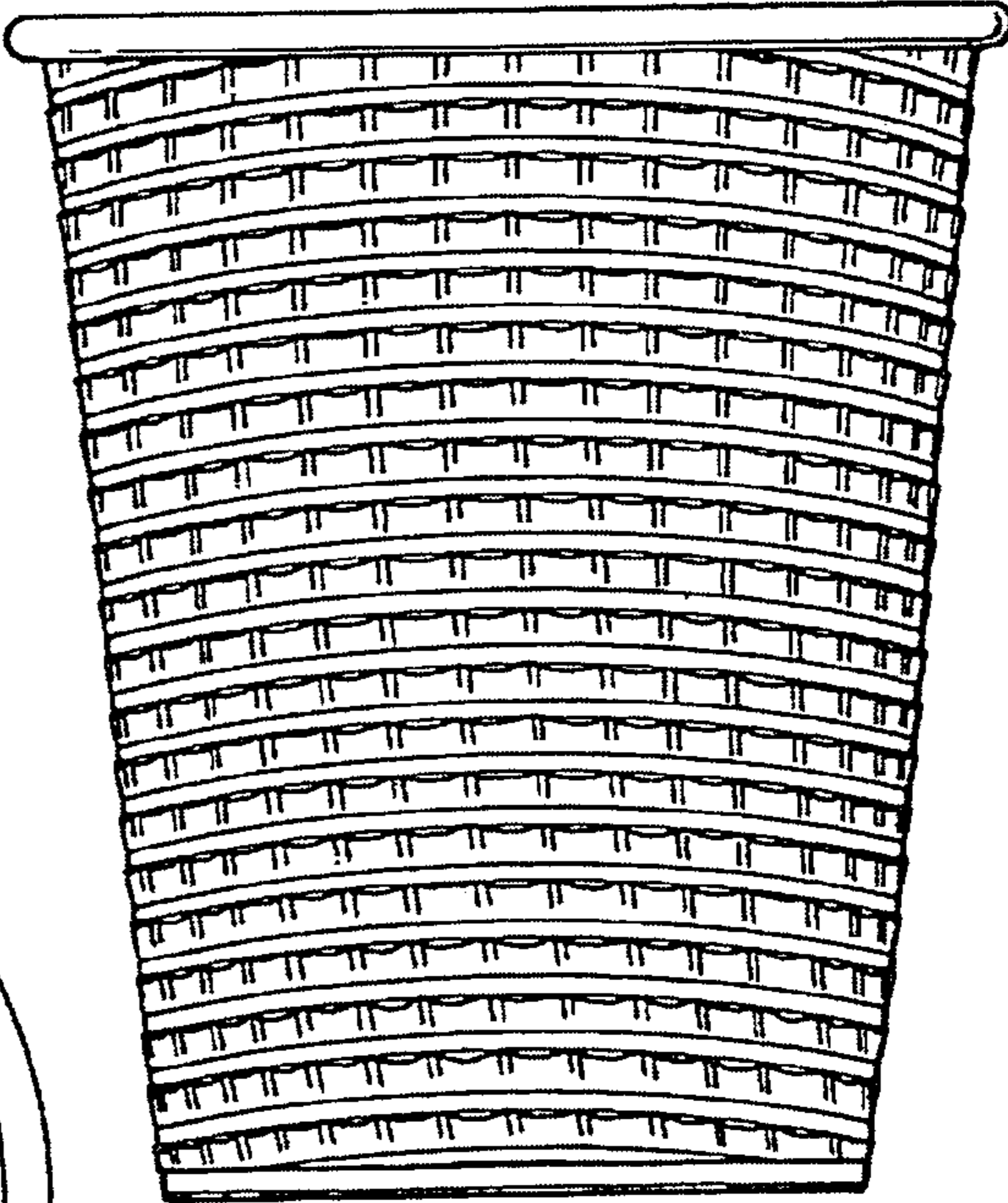

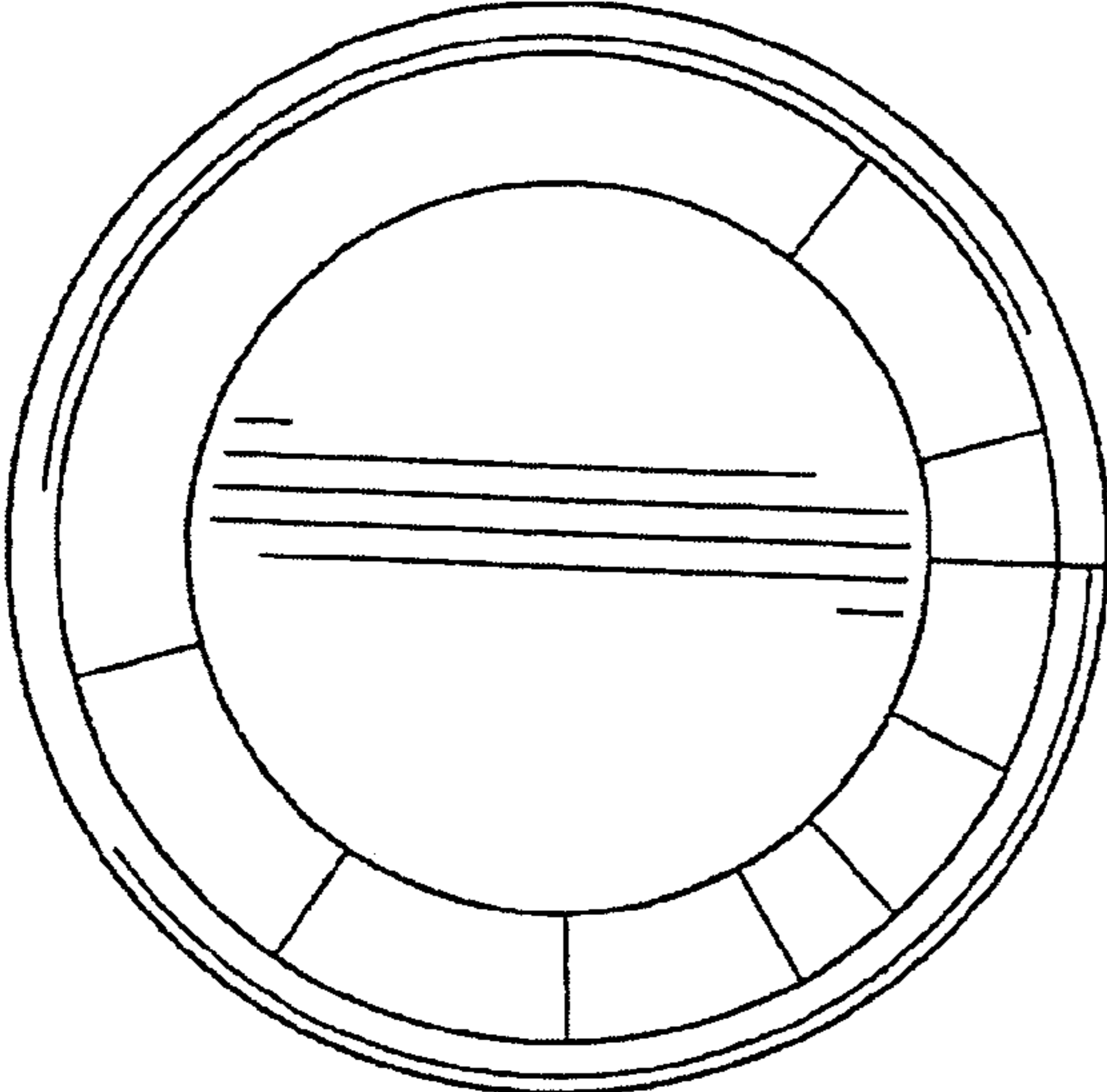

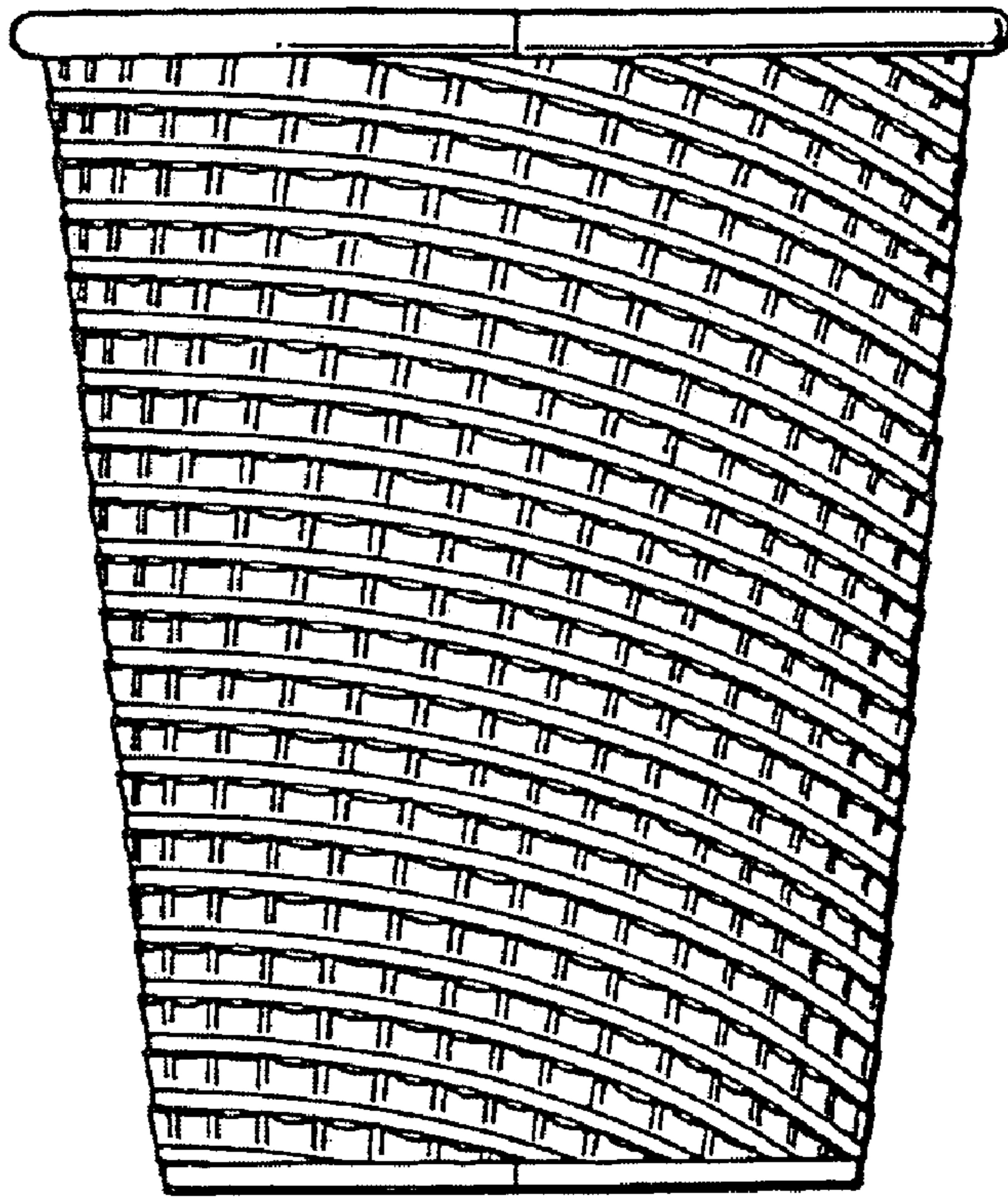

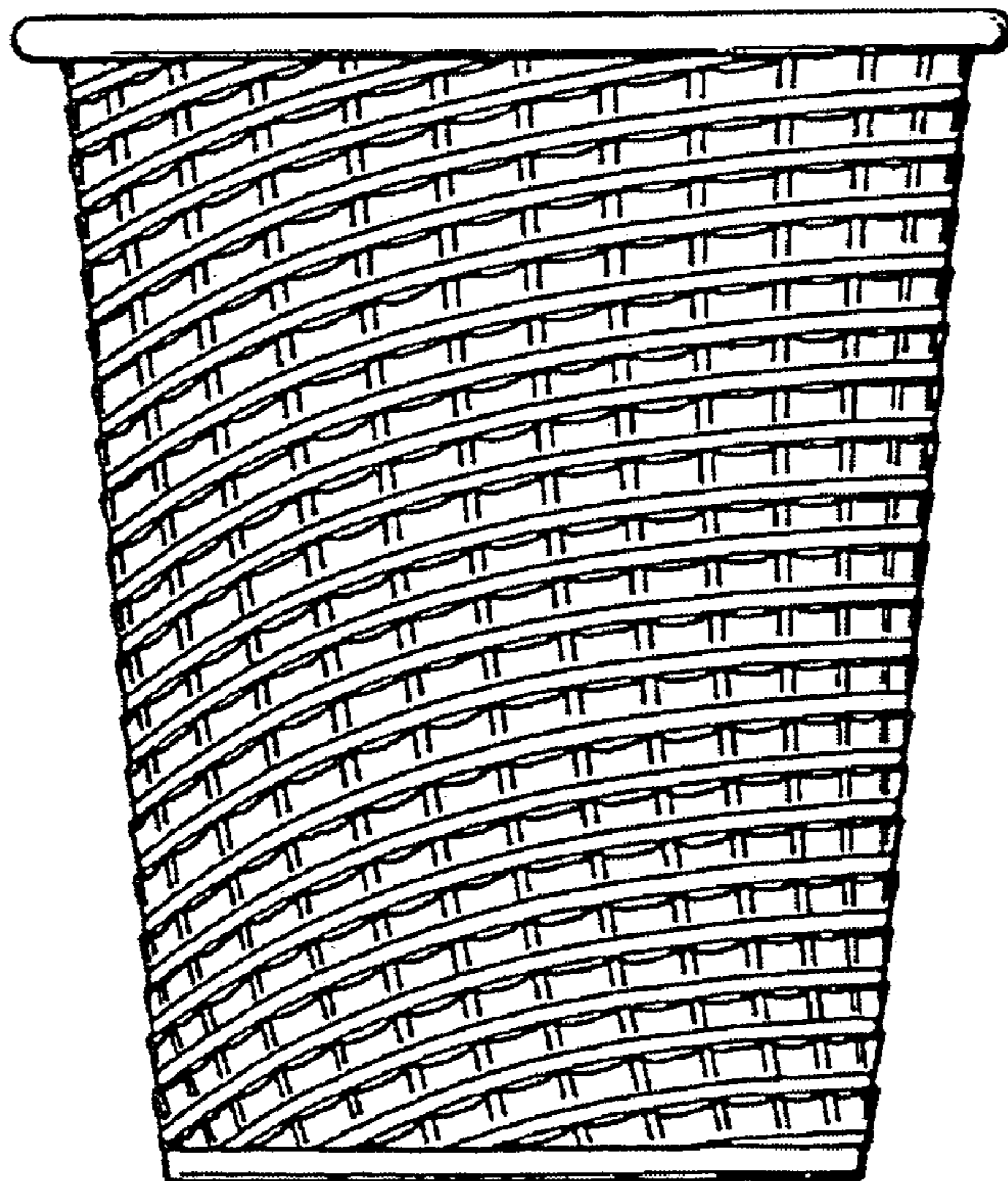

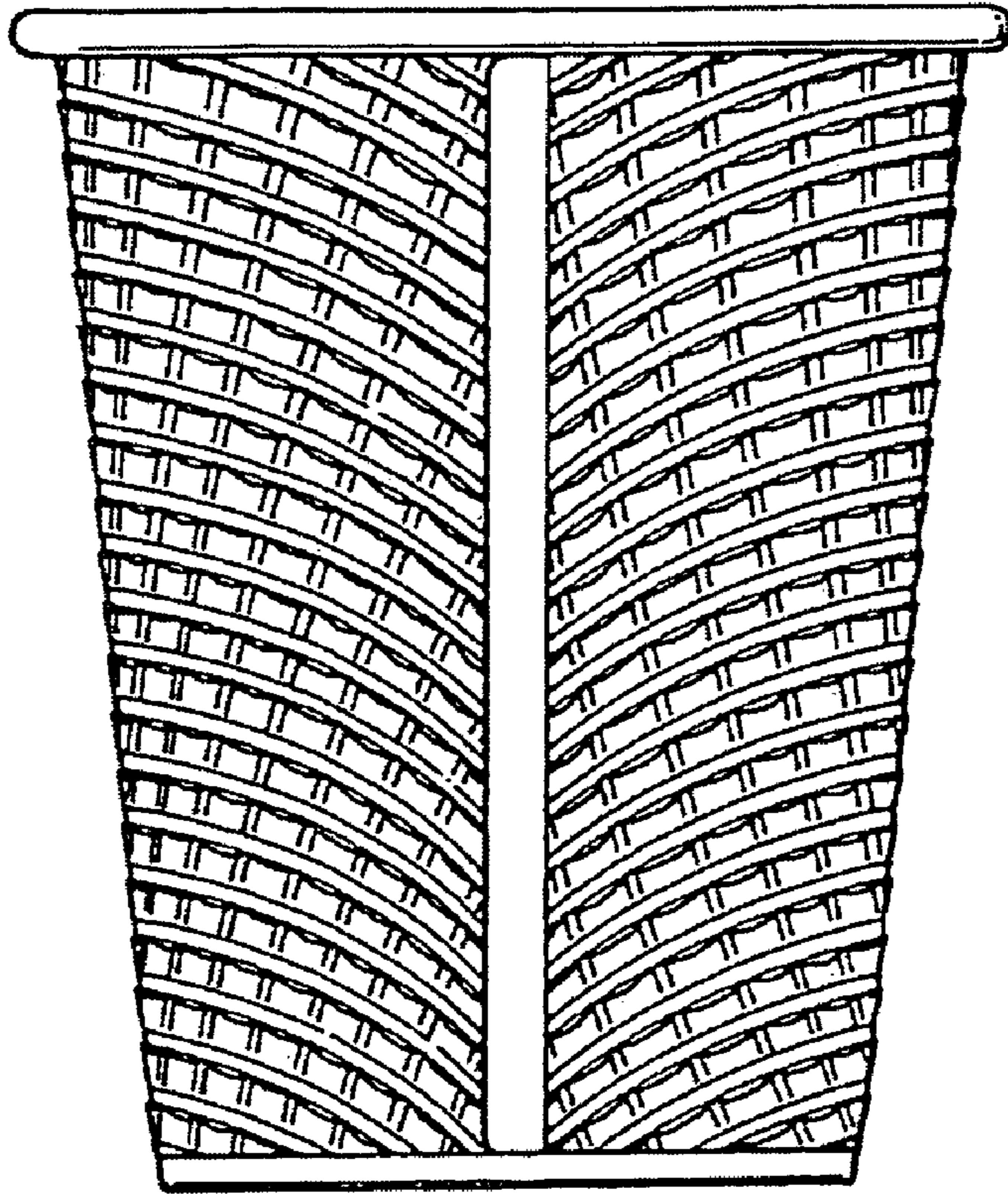

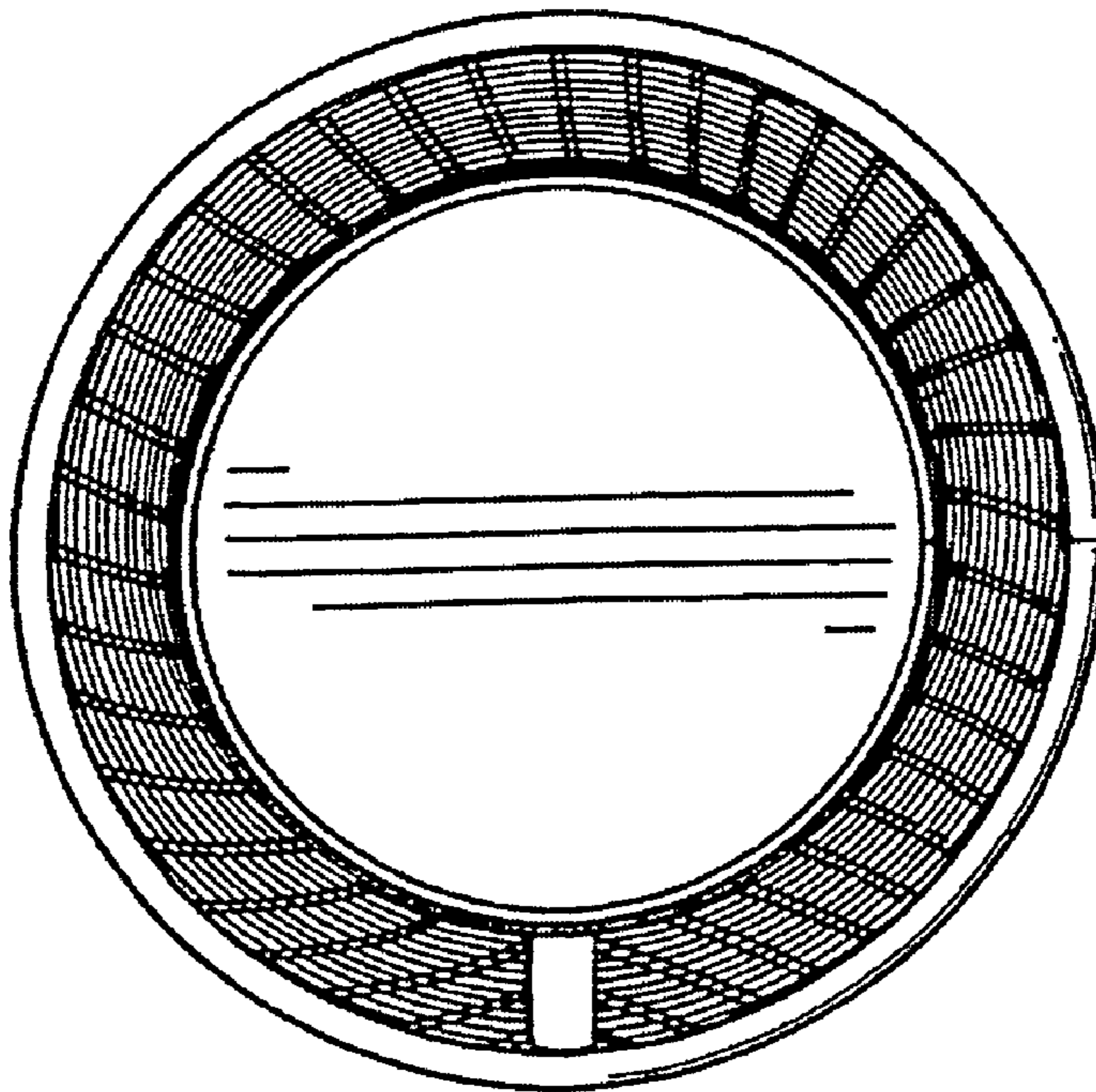
