FIG. 12 is a top plan view of the third embodiment of the present invention.

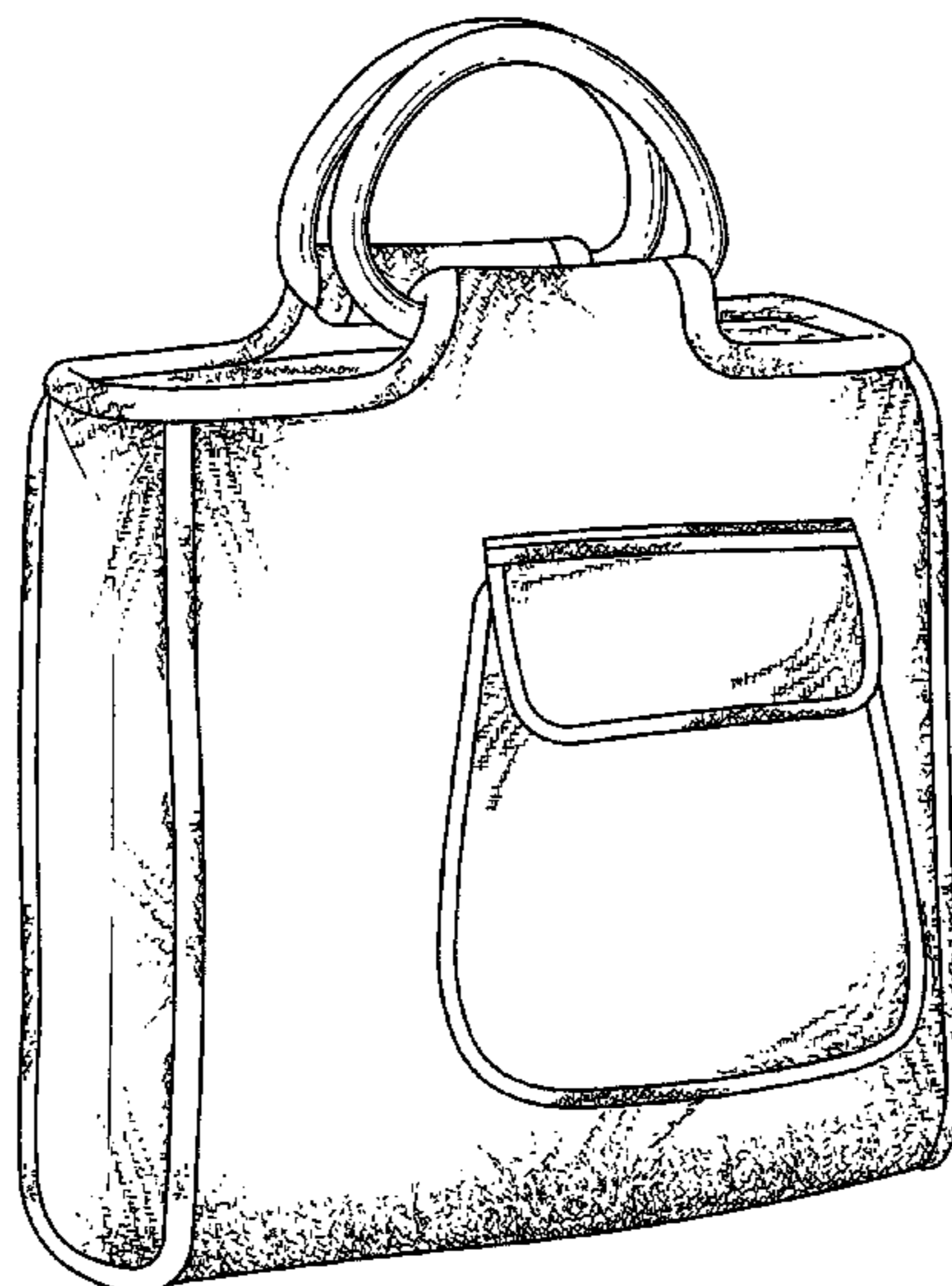

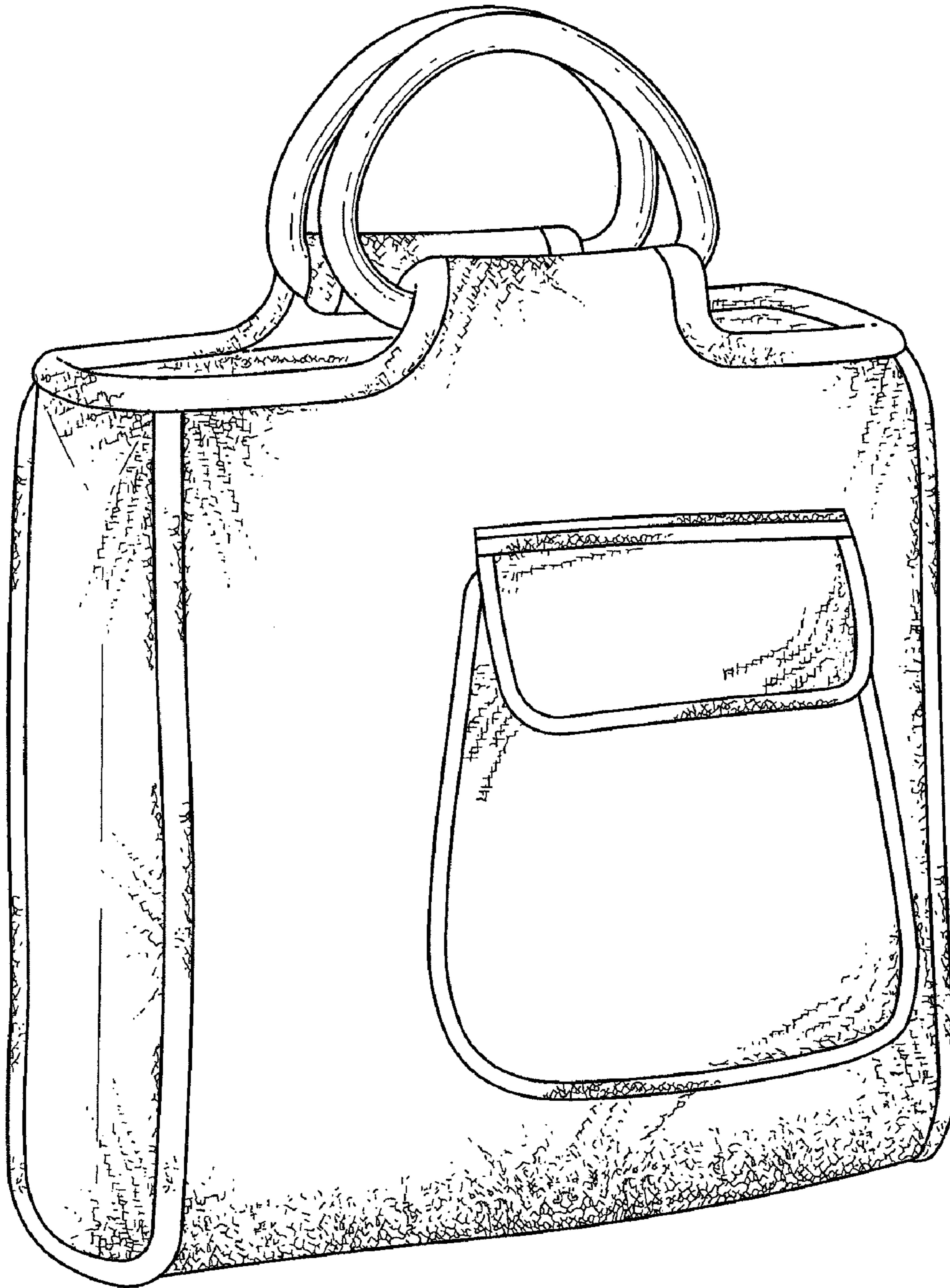

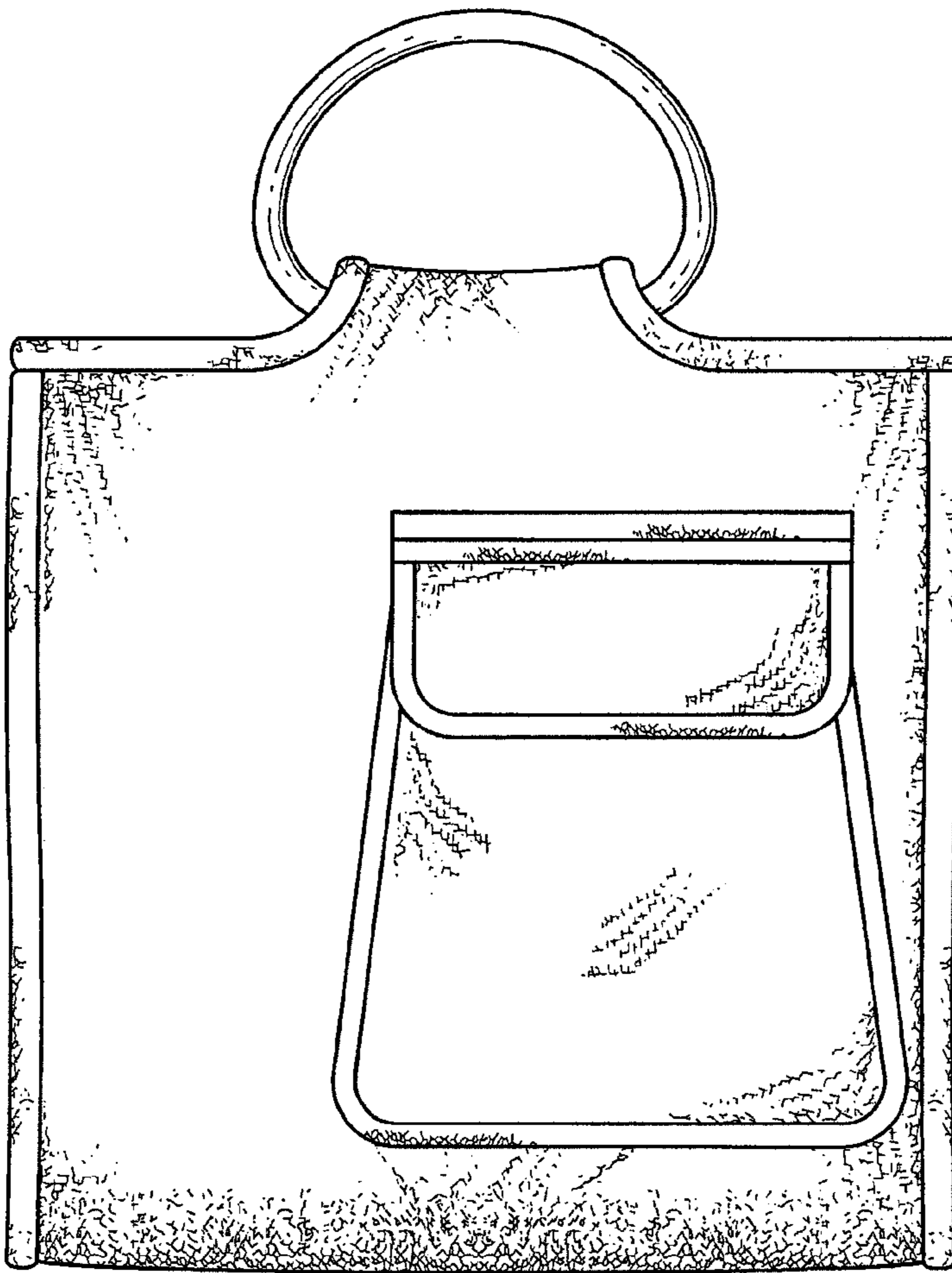

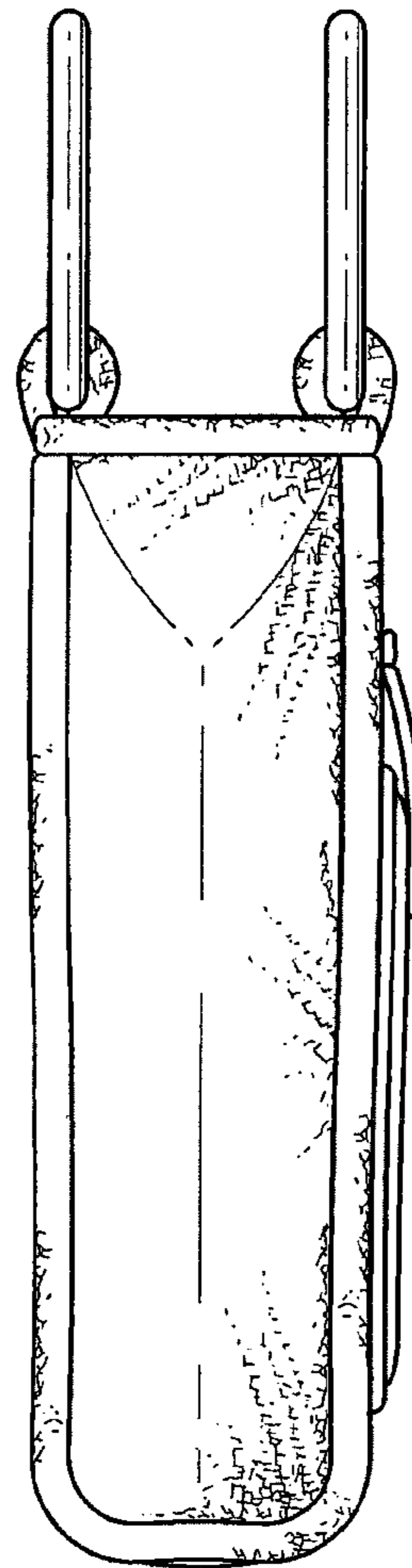

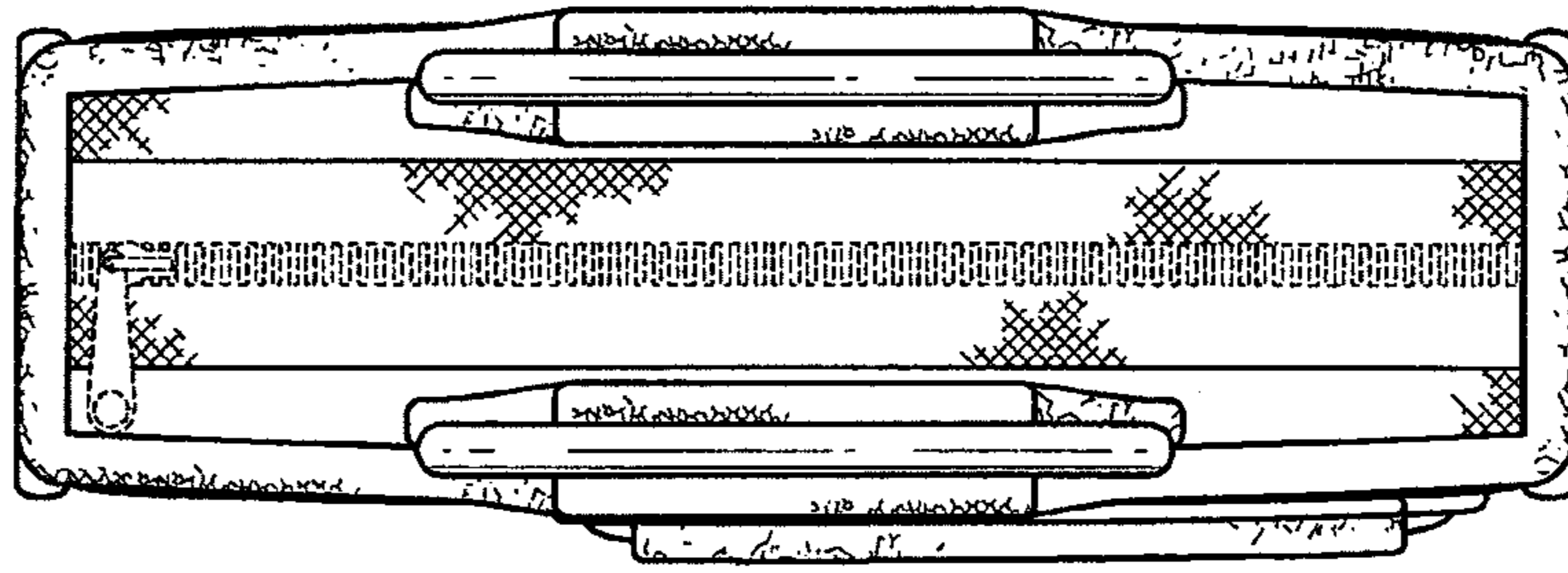

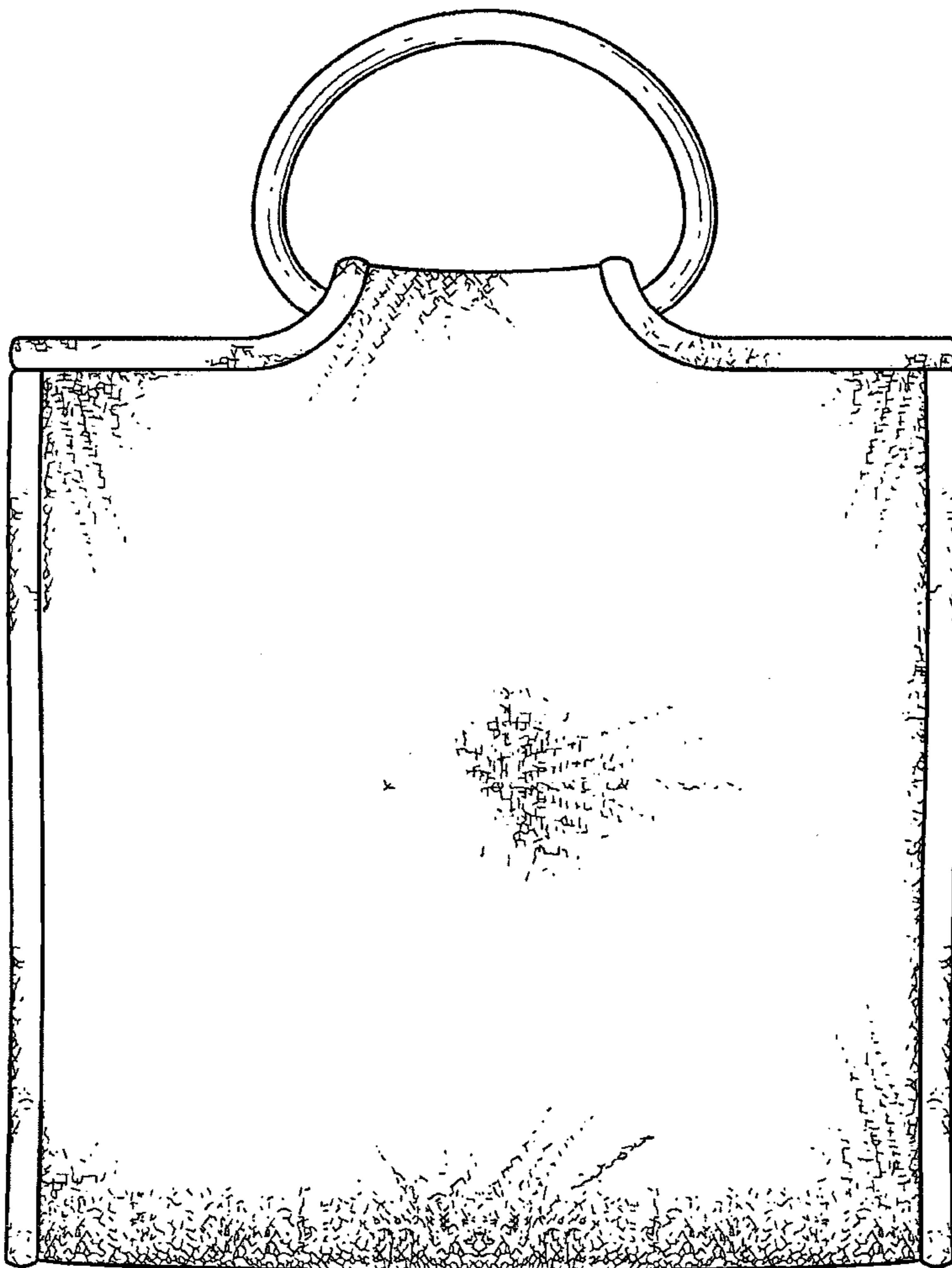

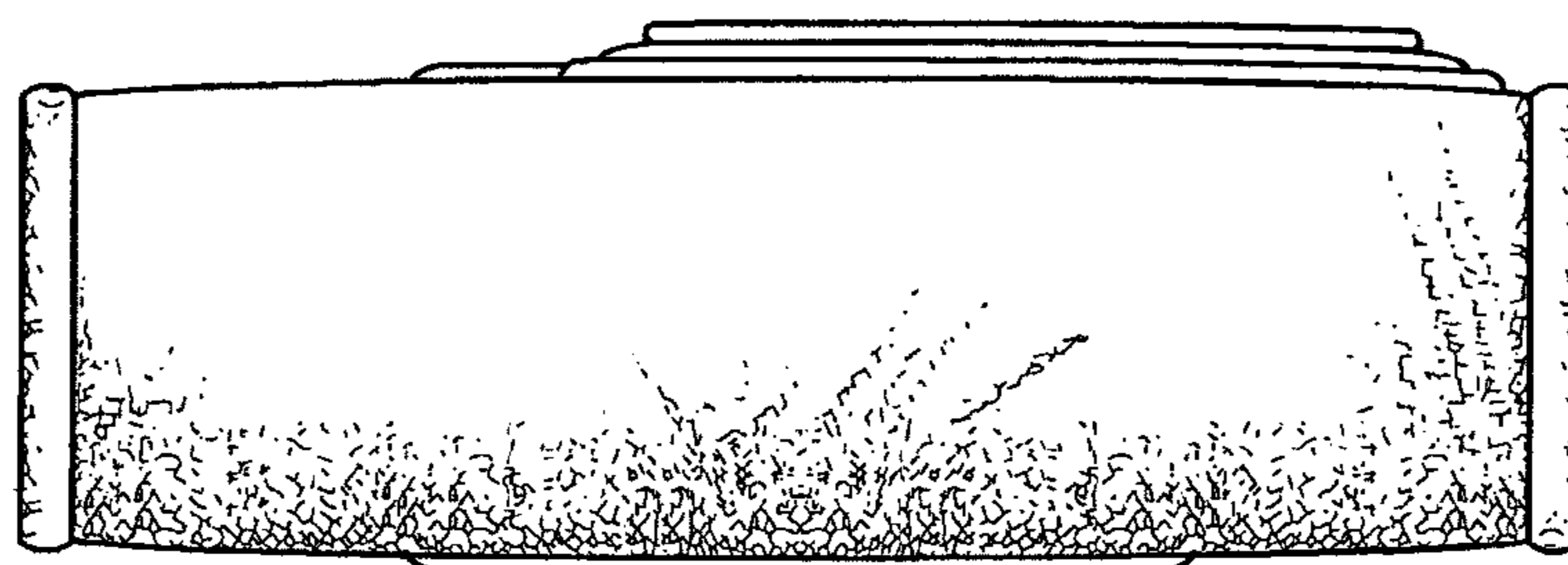

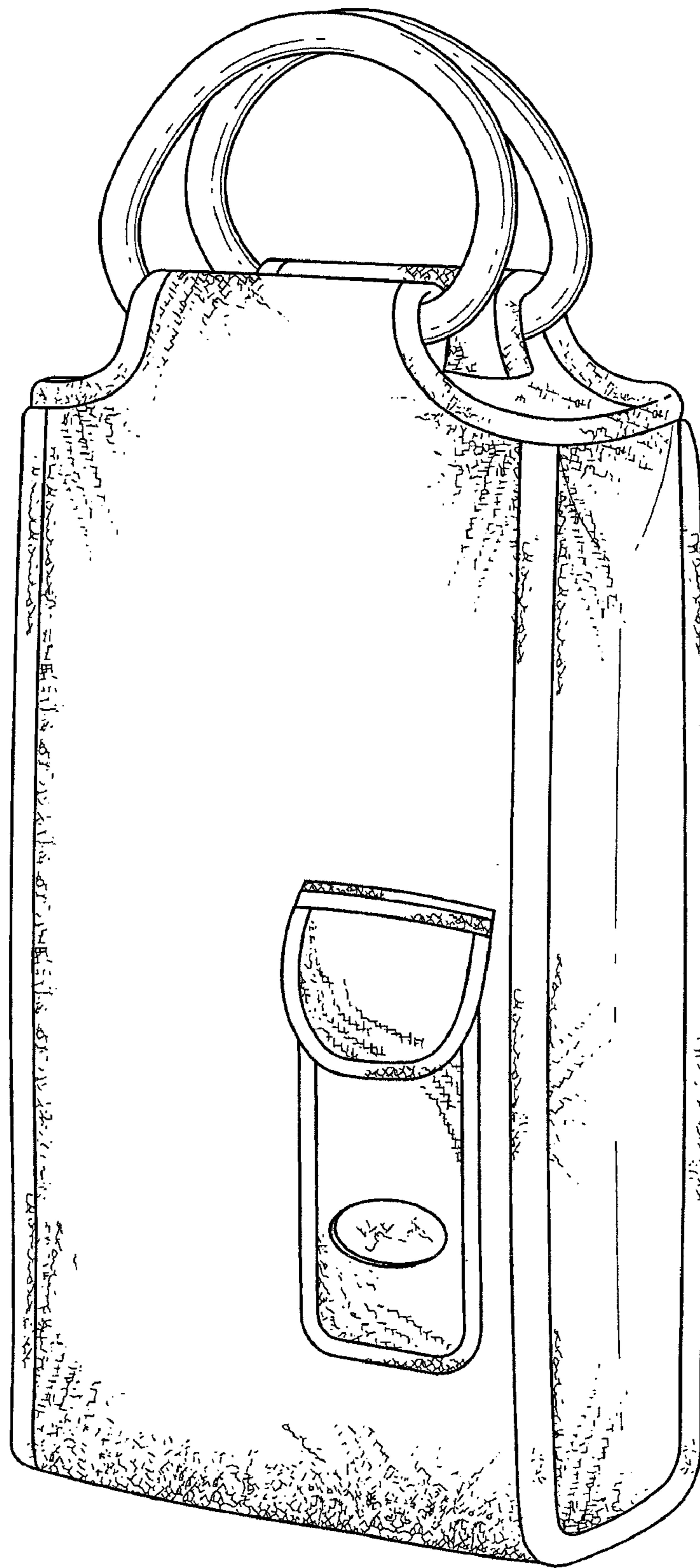

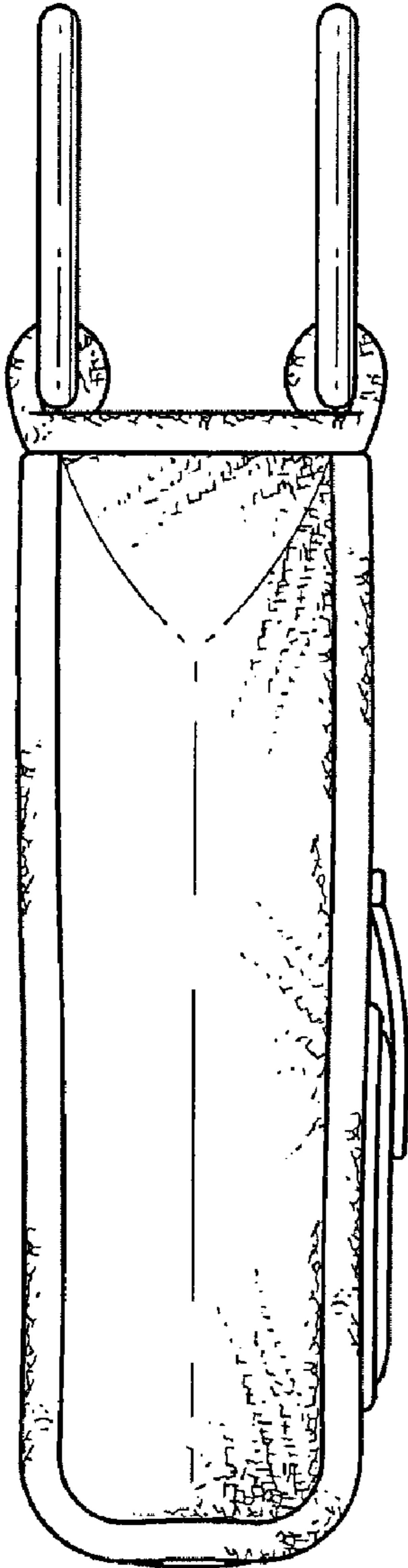

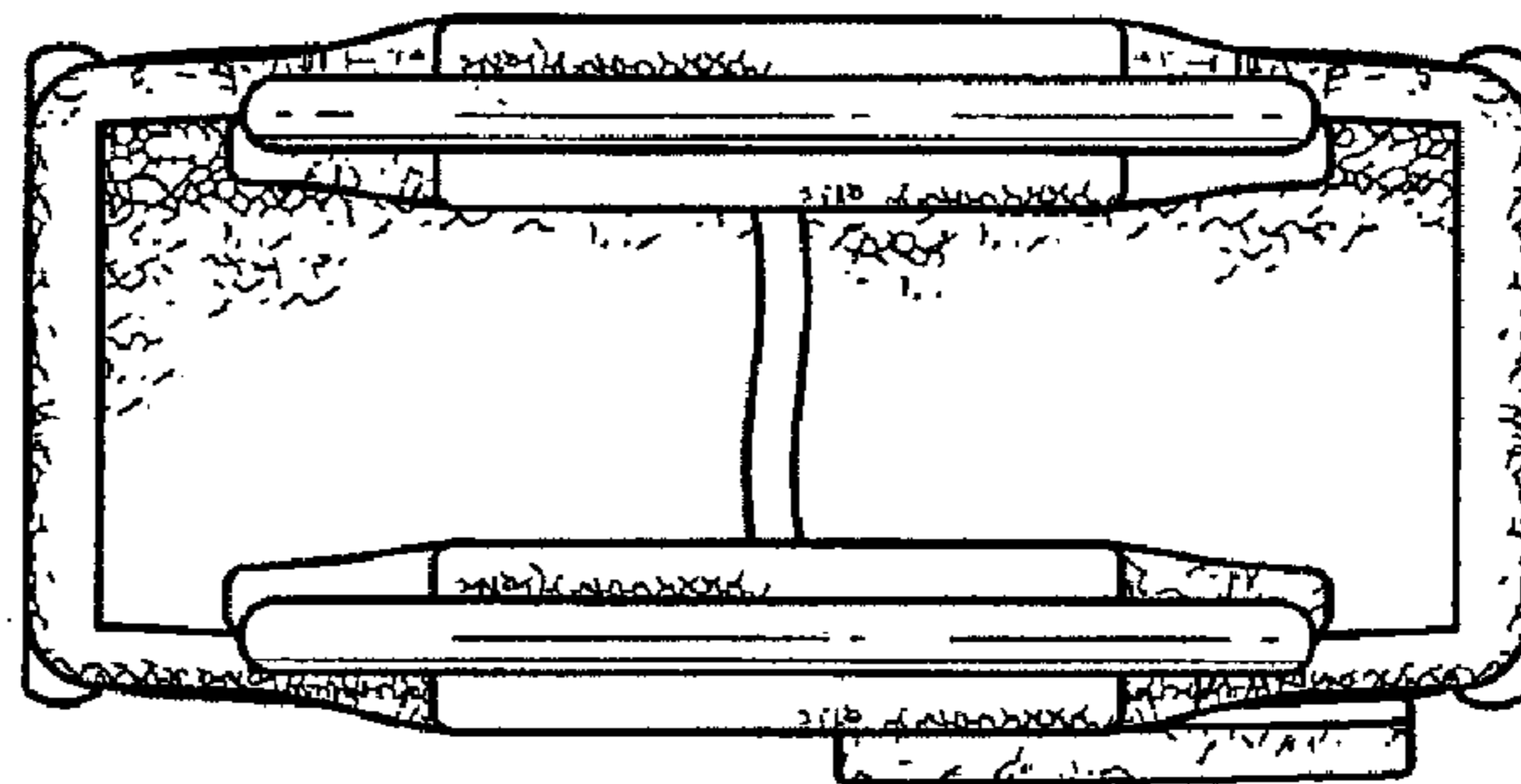

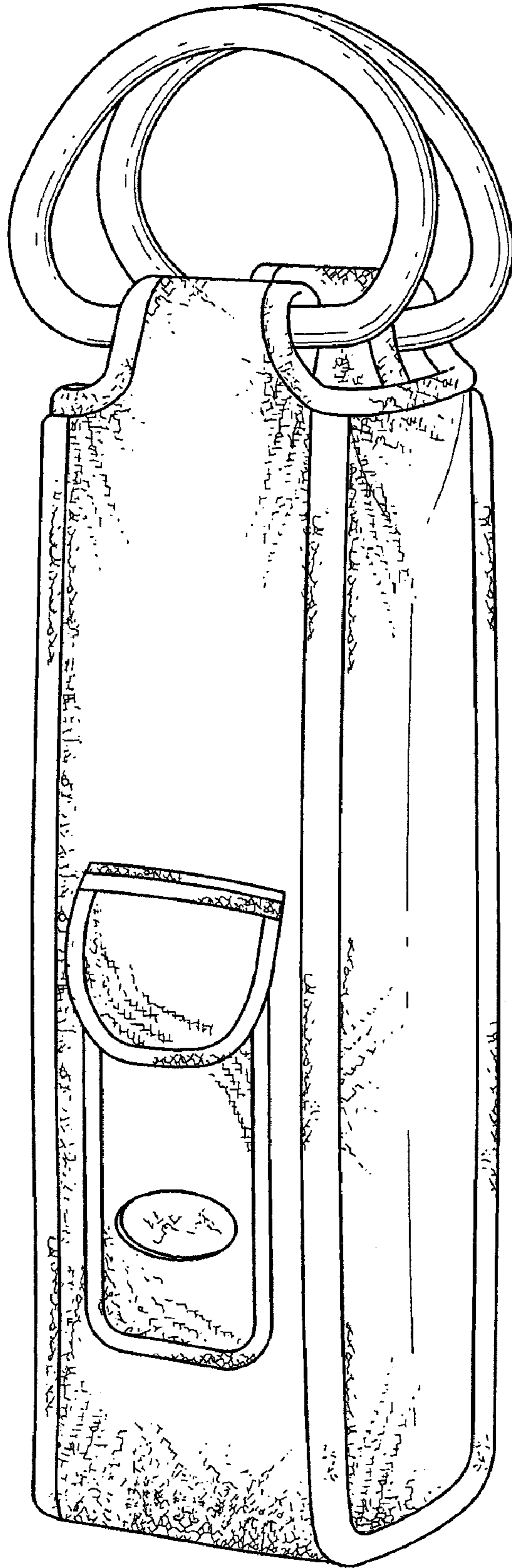

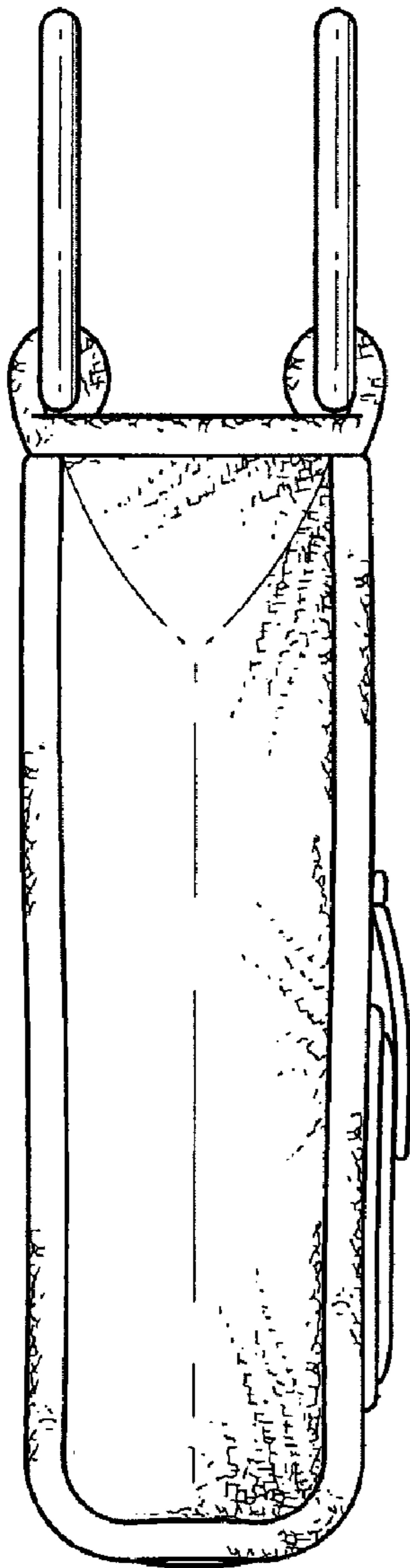

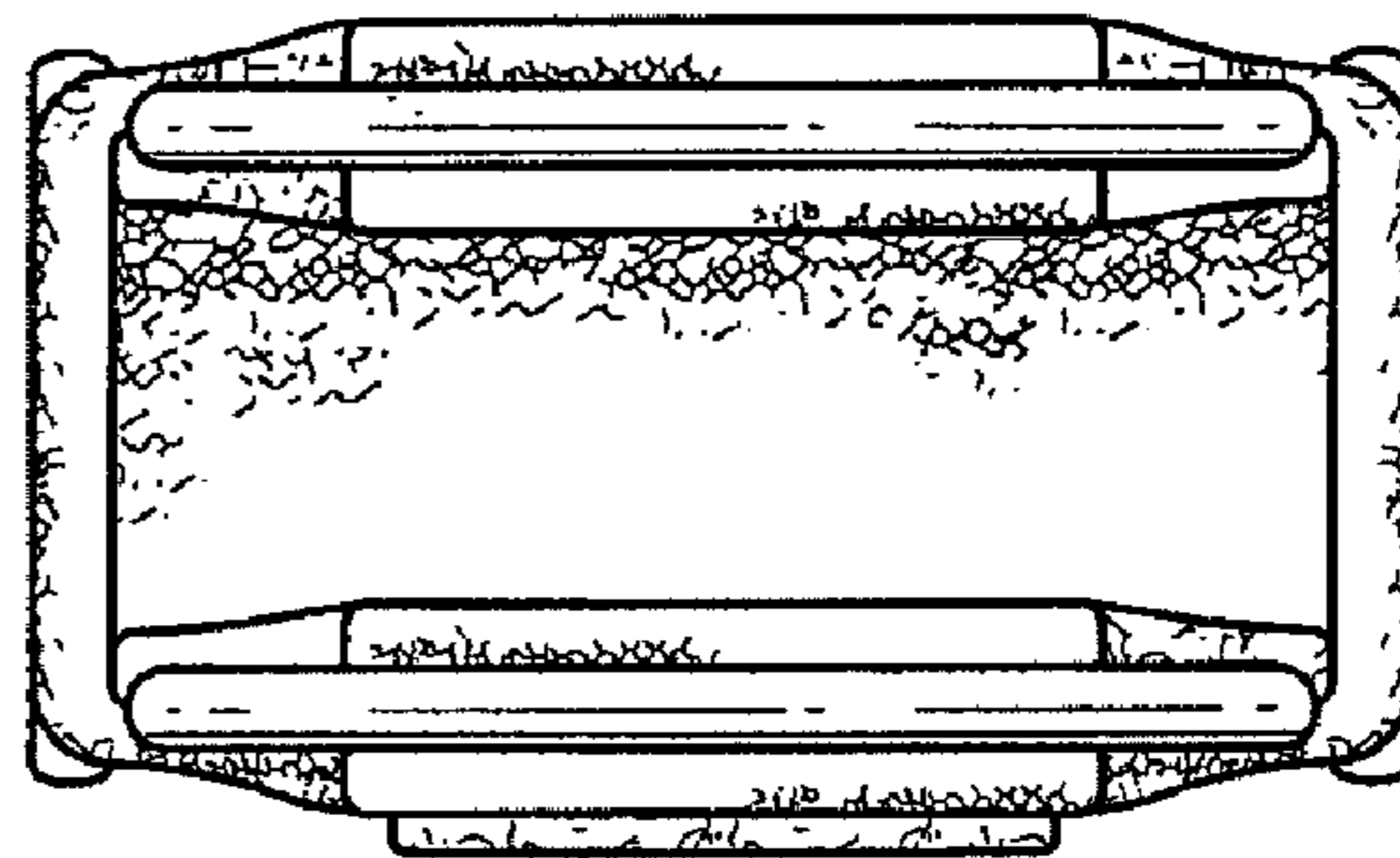
