FIG. 1 is a front elevational view of a hook showing our new design;

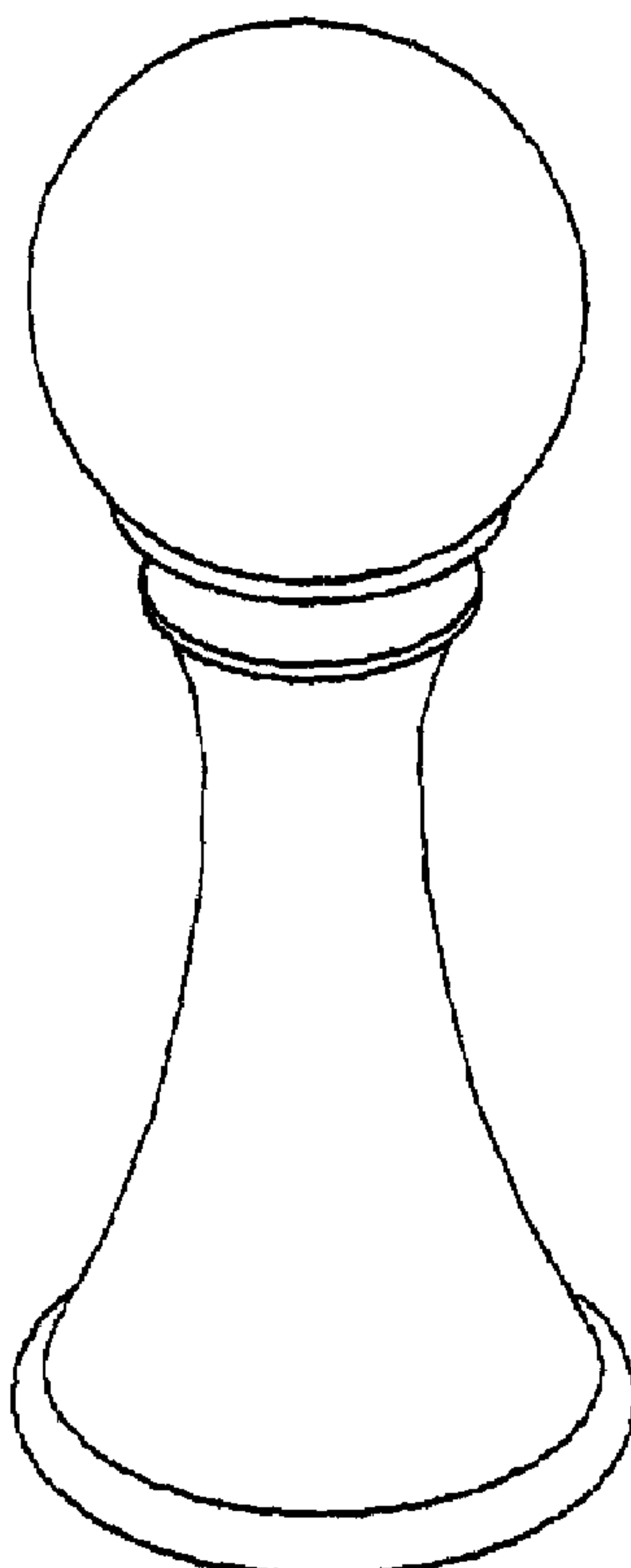
FIG. 2 is a bottom plan view thereof;

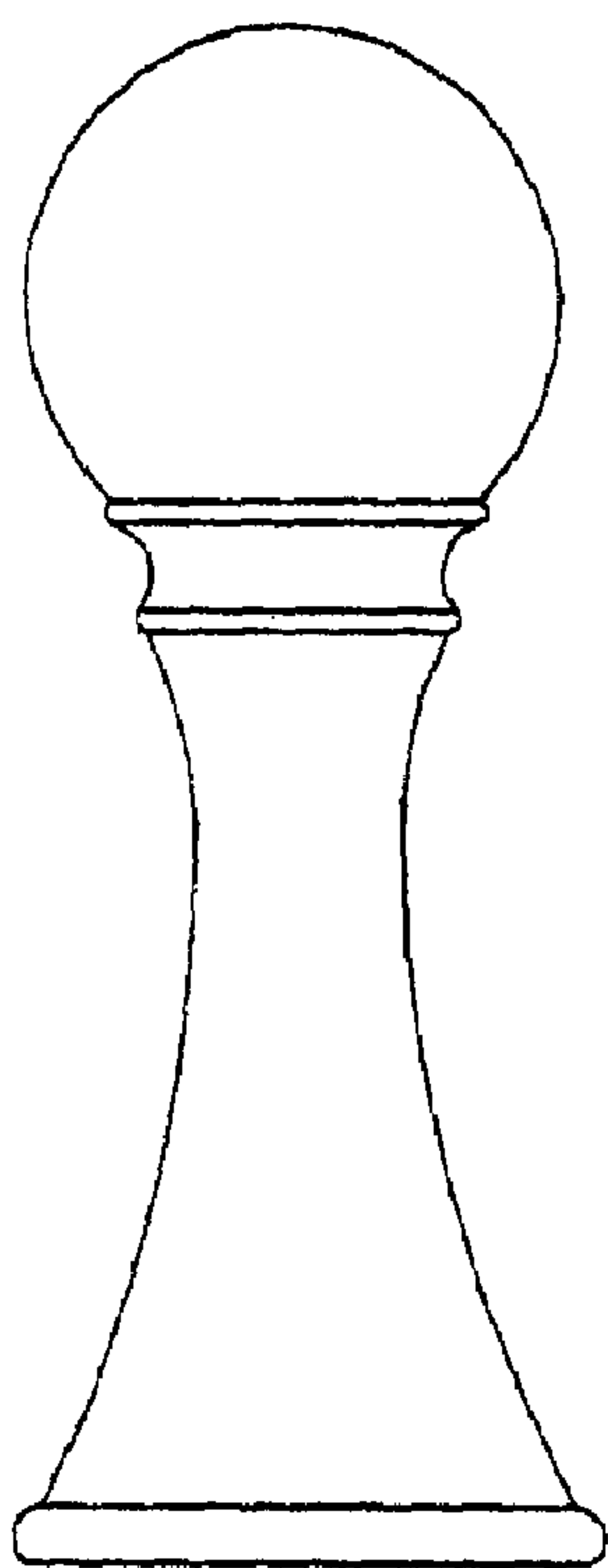
FIG. 3 is a top plan view thereof; and,

FIG. 4 is a perspective view thereof.

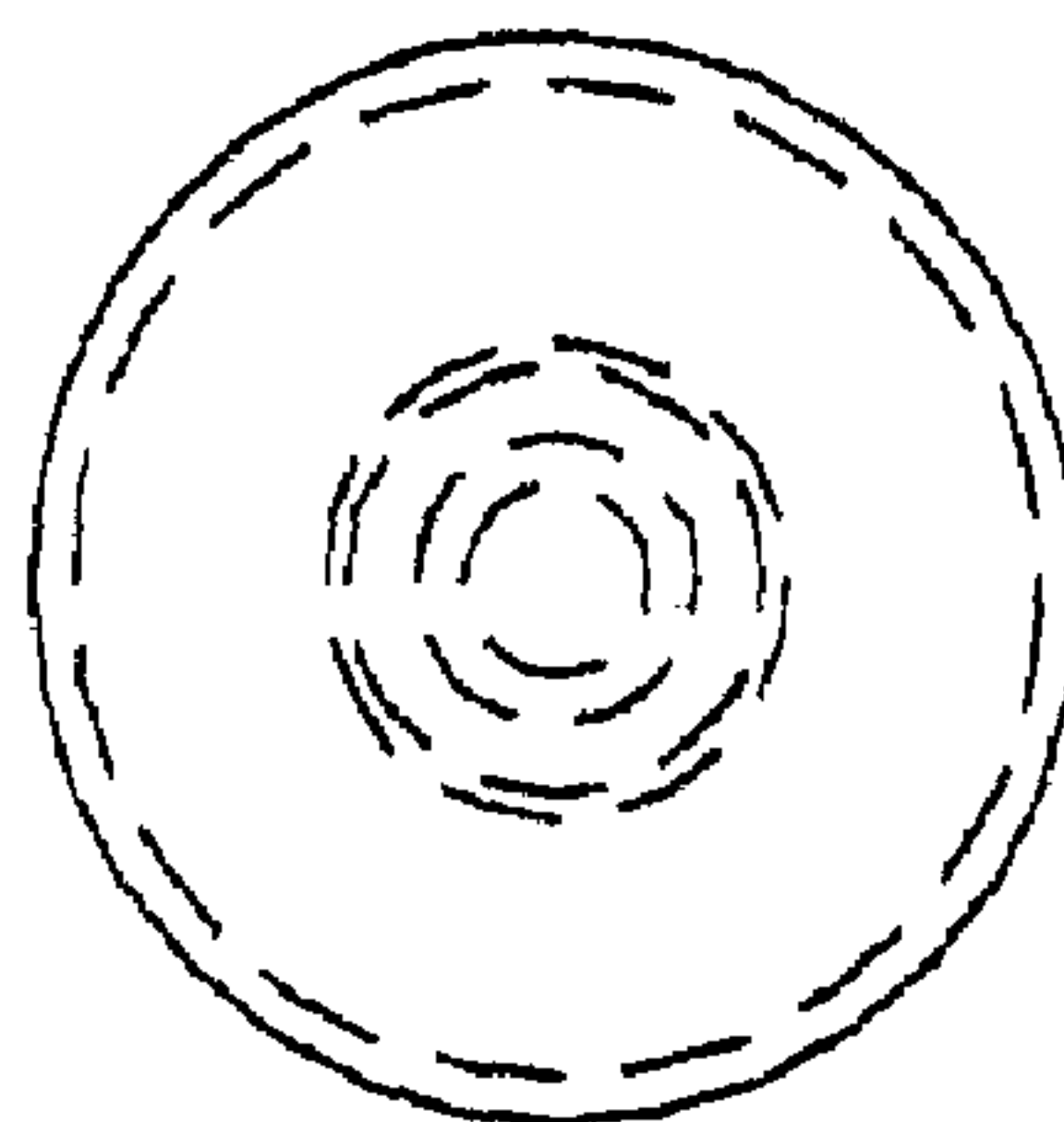

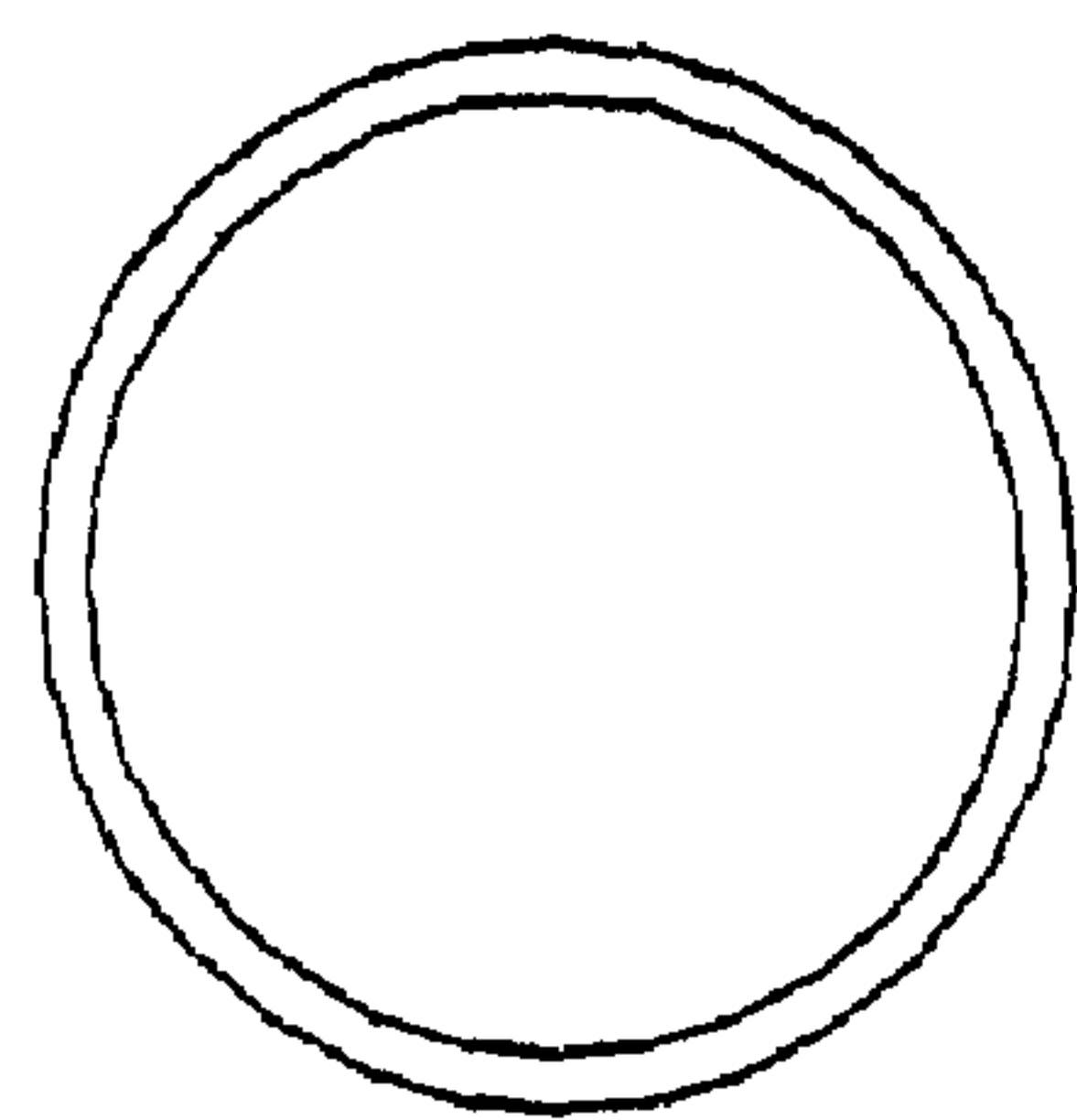




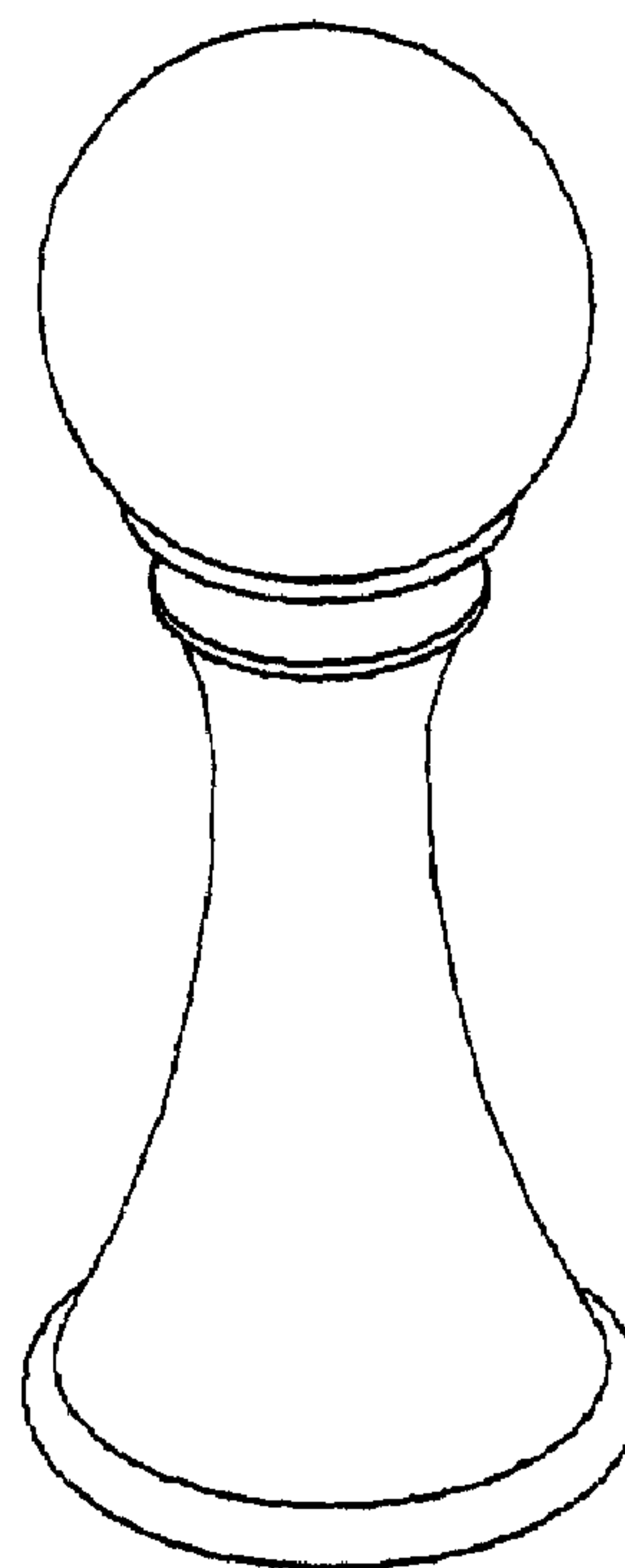
