DESCRIPTION

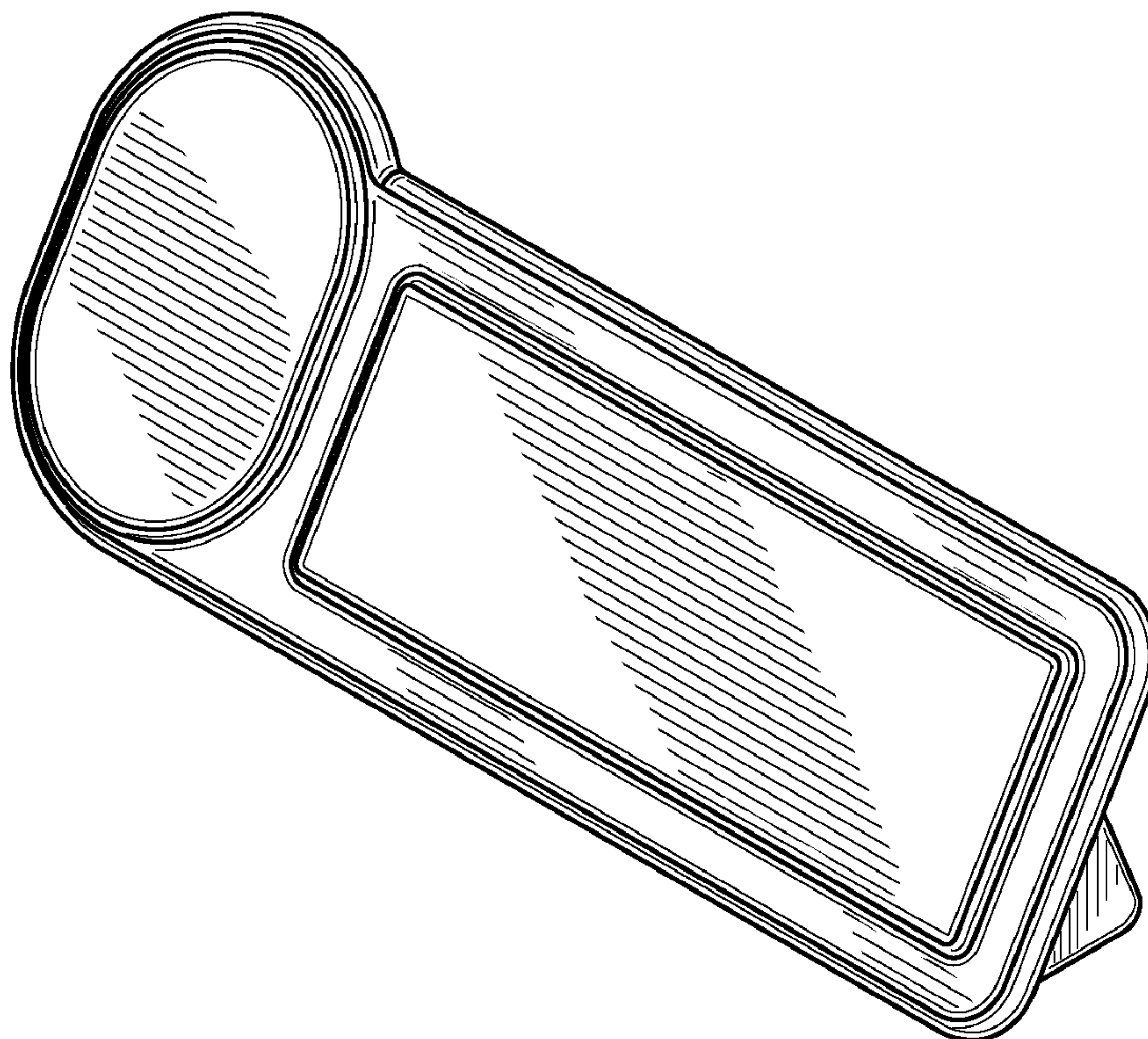

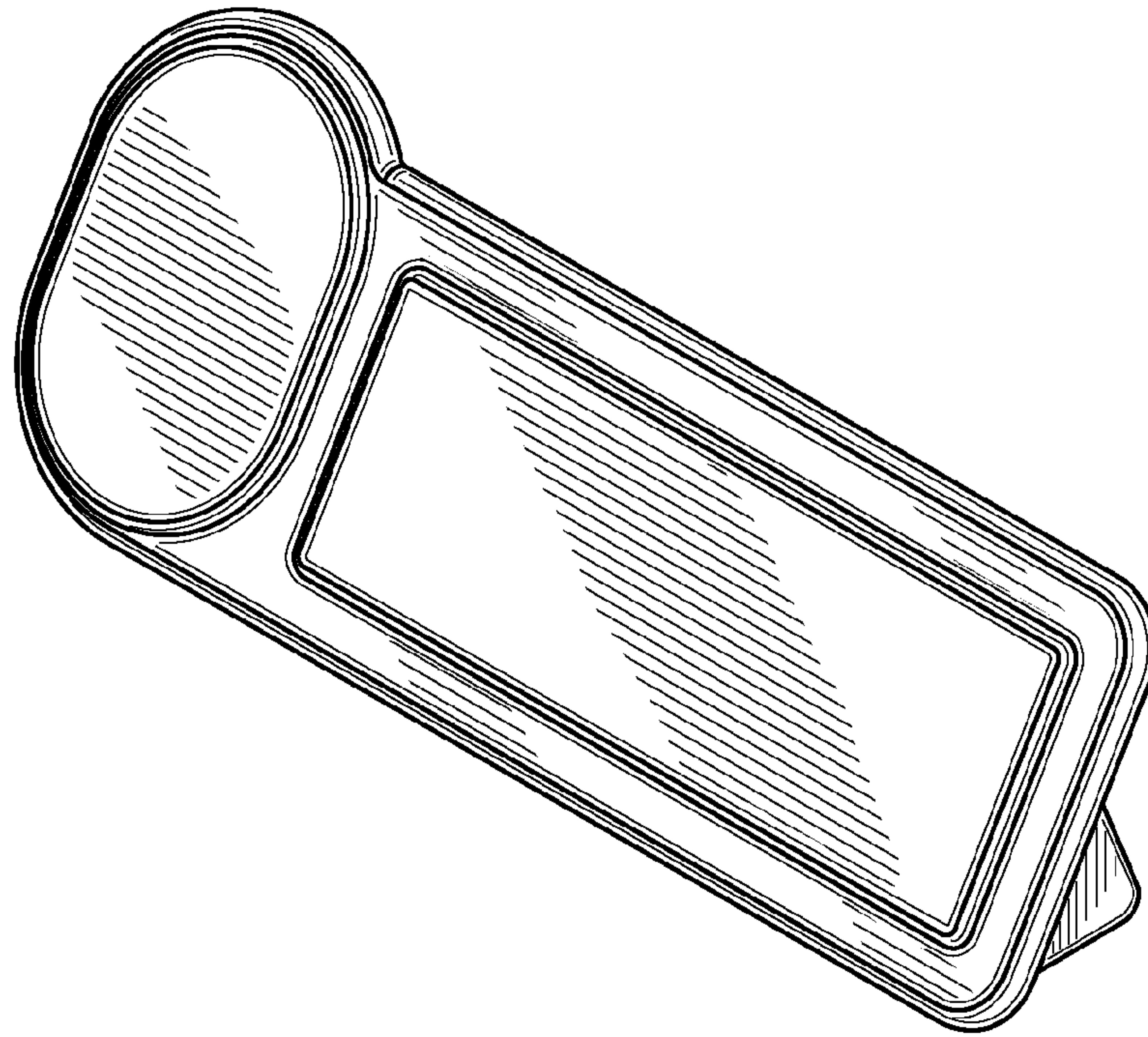

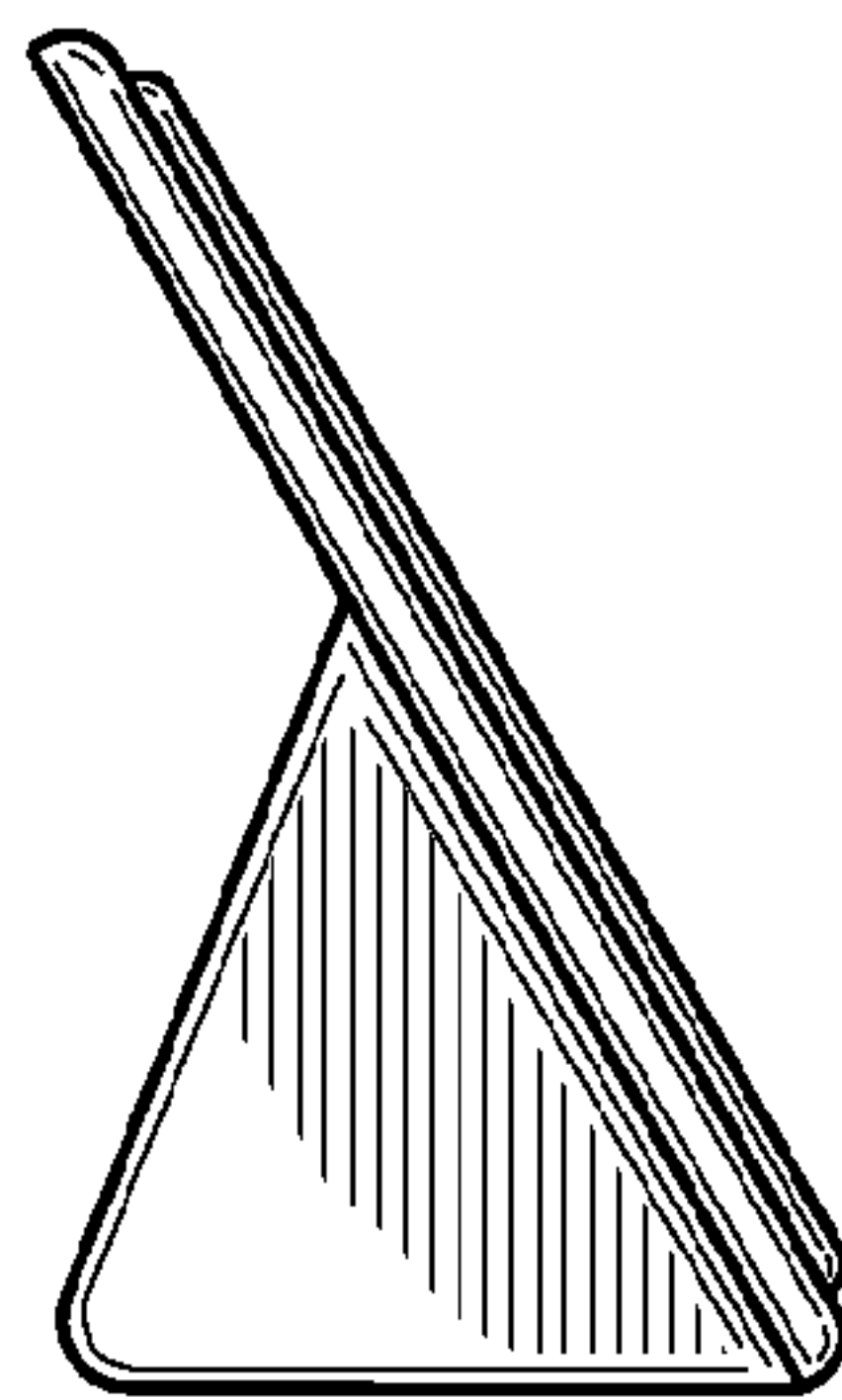

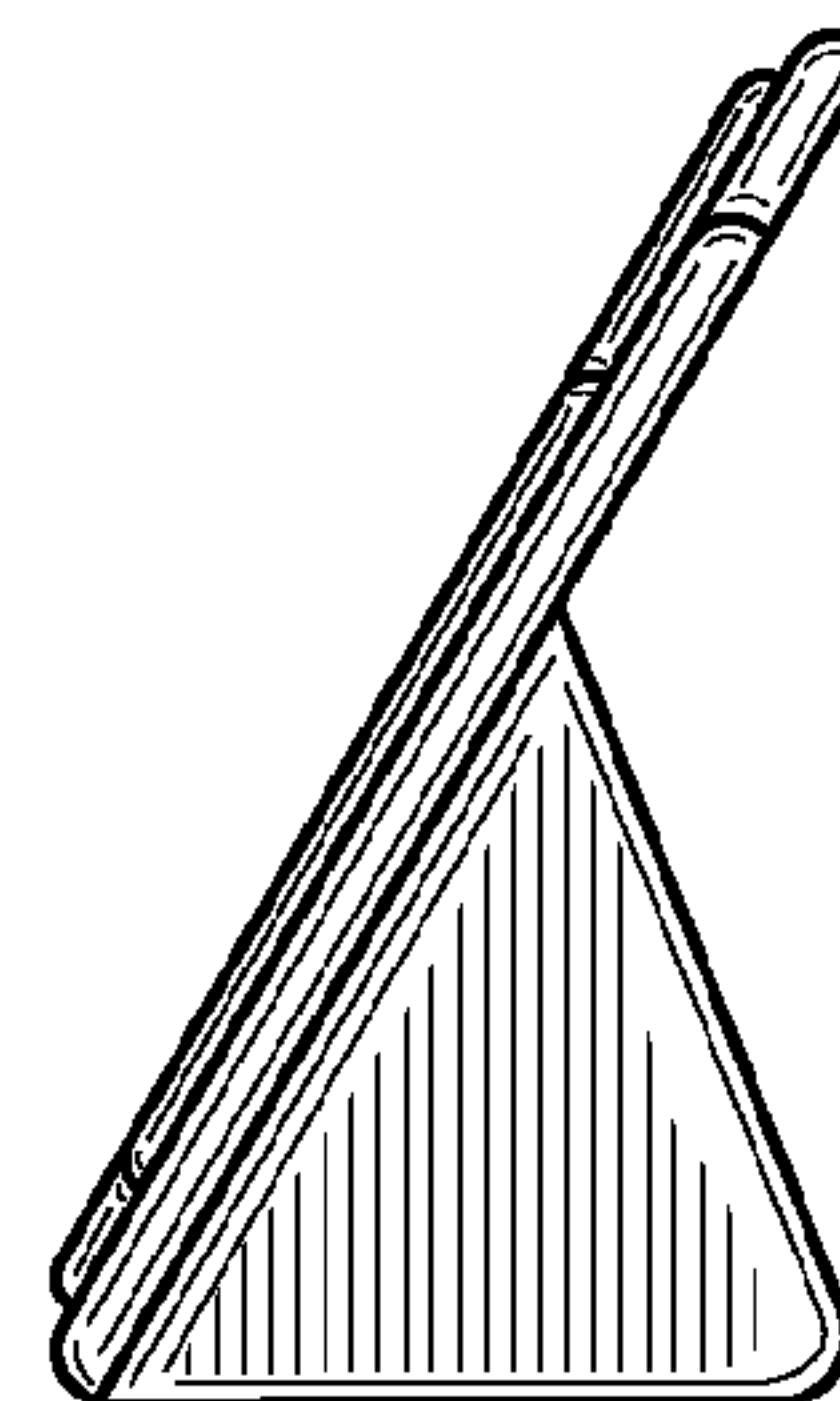

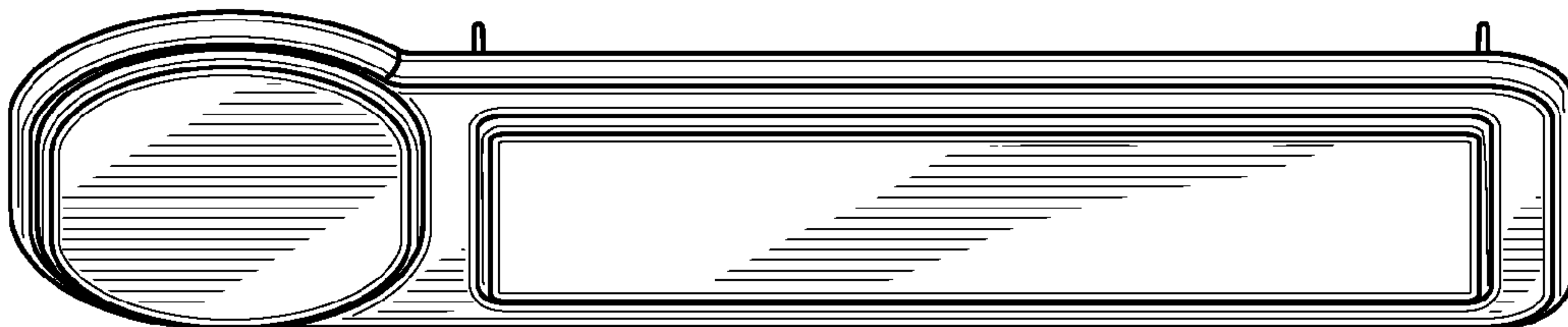

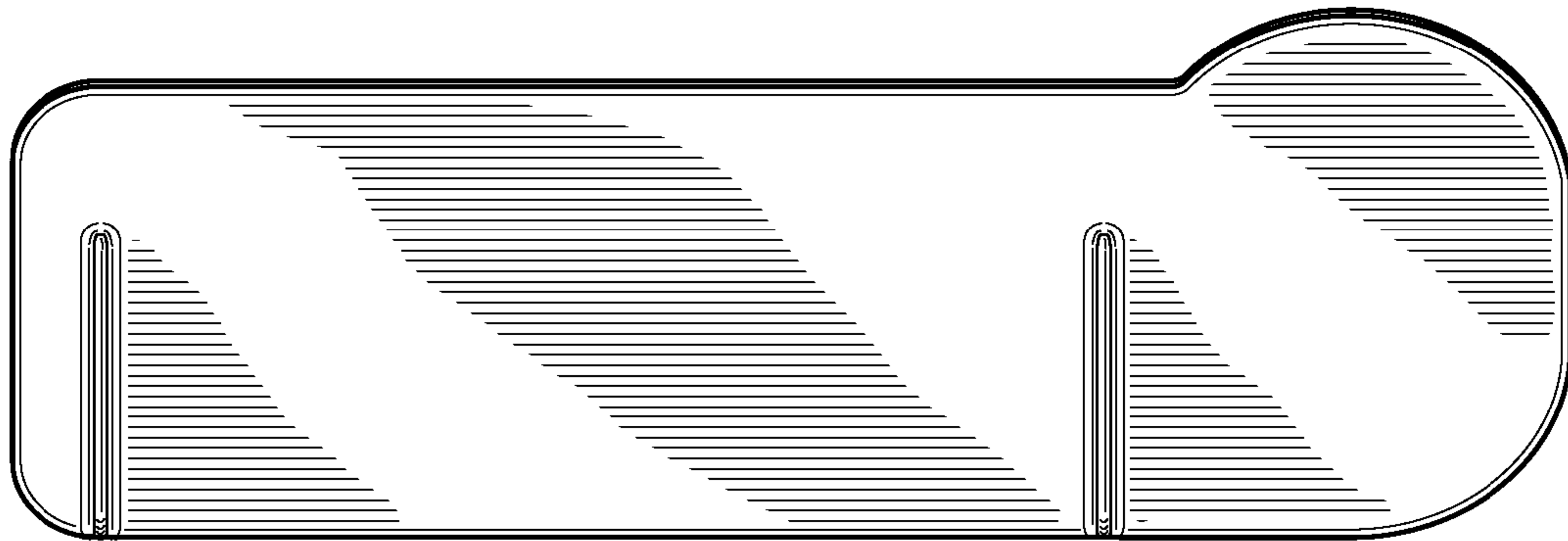
