(57) **CLAIM**

The ornamental design for an absorbent pad for breast milk, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation of an absorbent pad for breast milk showing our new design;

FIG. 2 is a rear elevation thereof;

FIG. 3 is a right side elevation thereof;

FIG. 4 is a left side elevation thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a cross-sectional view thereof taken along line A—A in FIG. 1;

FIG. 8 is a cross-sectional view thereof taken along line B—B in FIG. 1;

FIG. 9 is a cross-sectional view thereof taken along line C—C in FIG. 7 and shown on an enlarged scale; and,

FIG. 10 is a rear perspective view thereof.

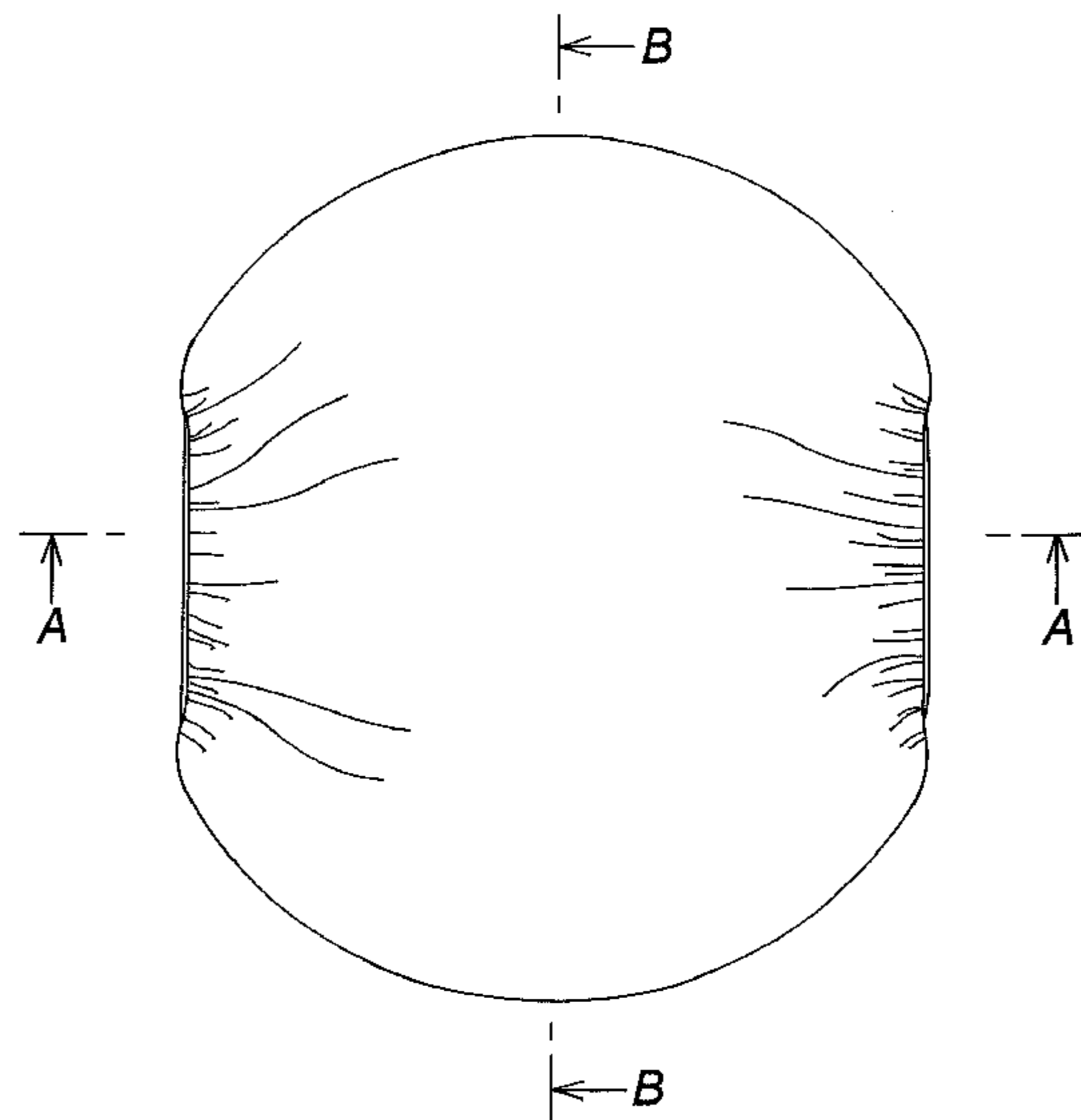

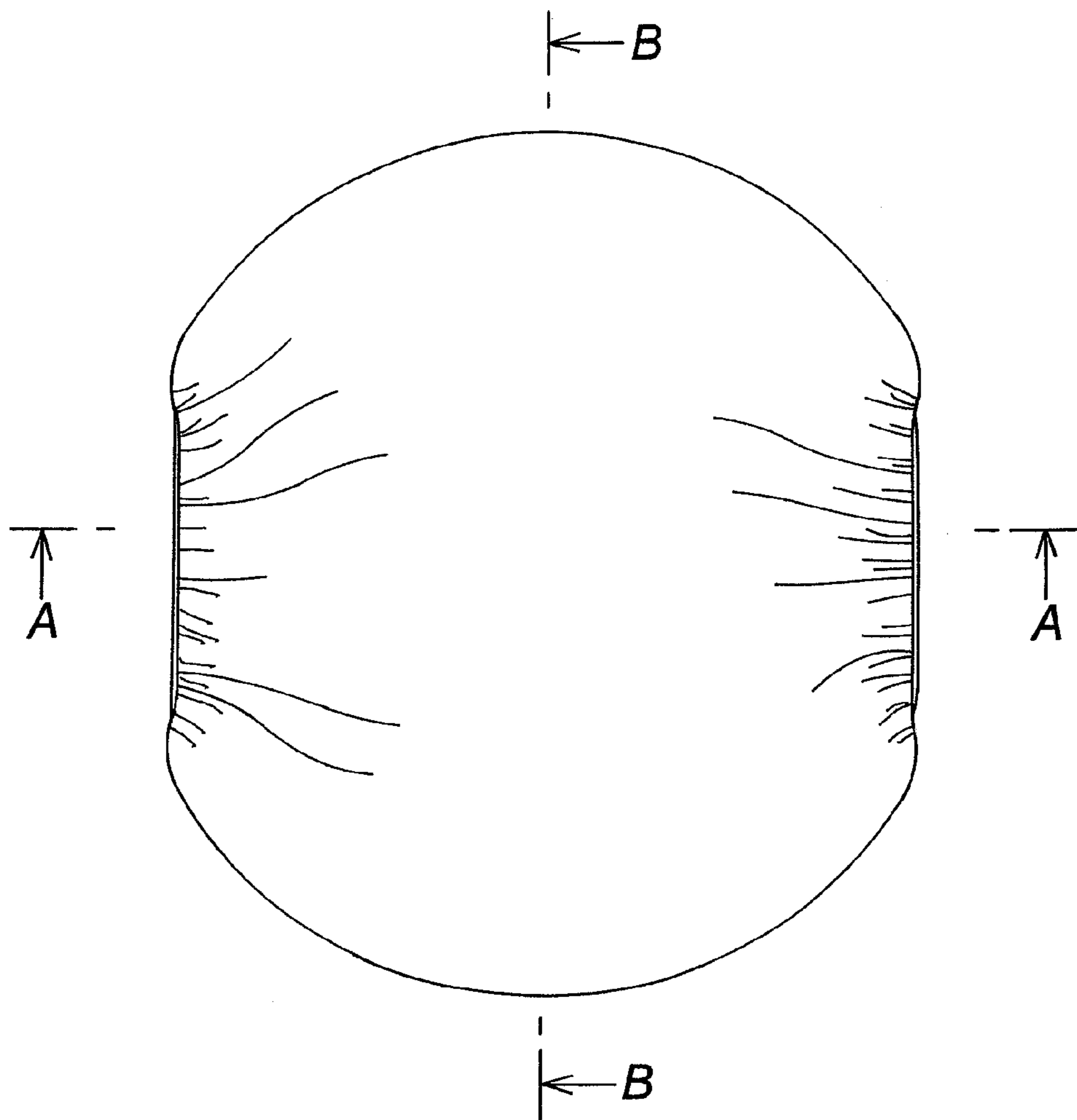

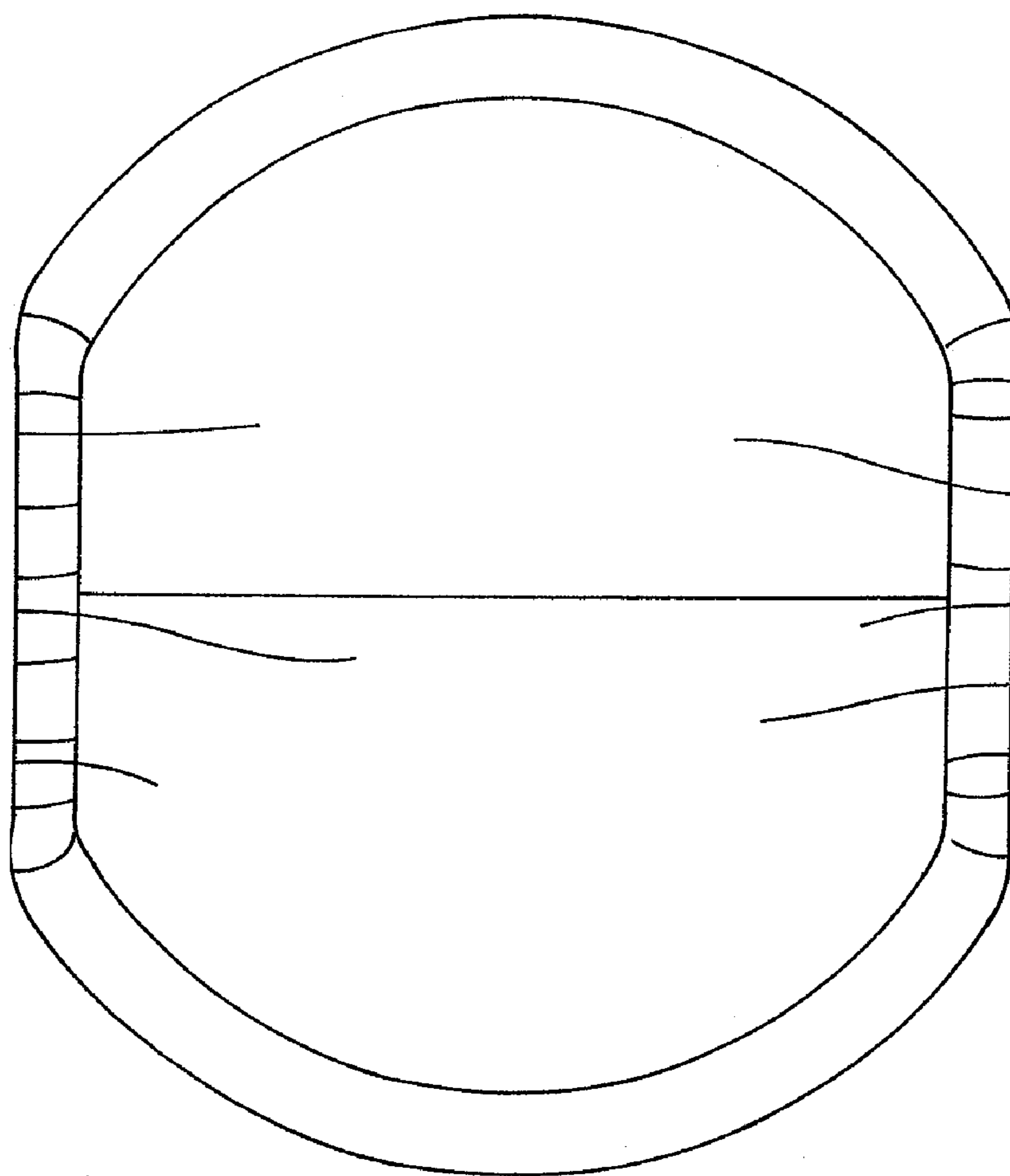

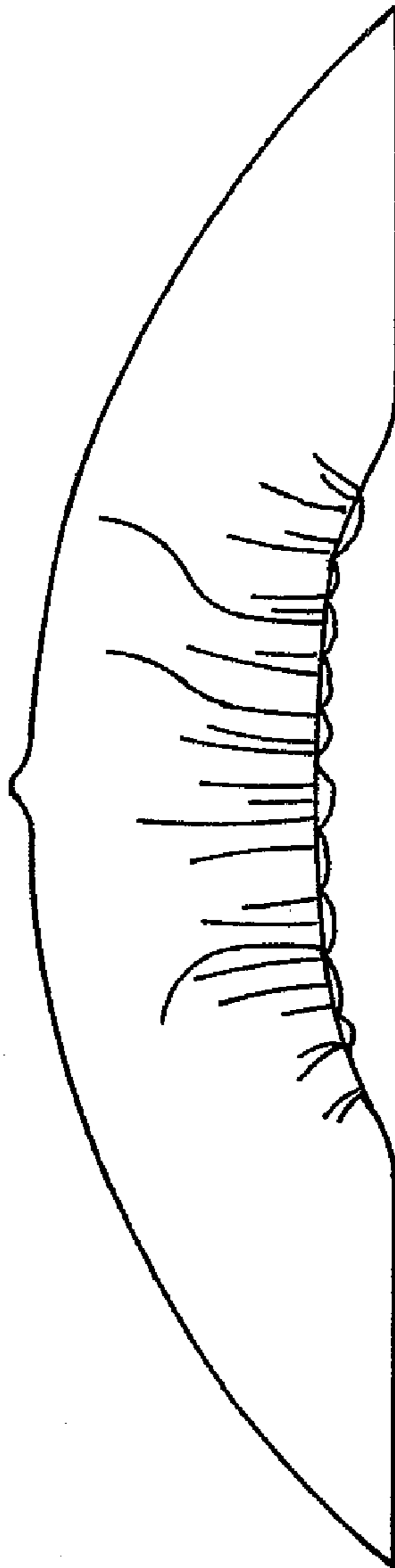

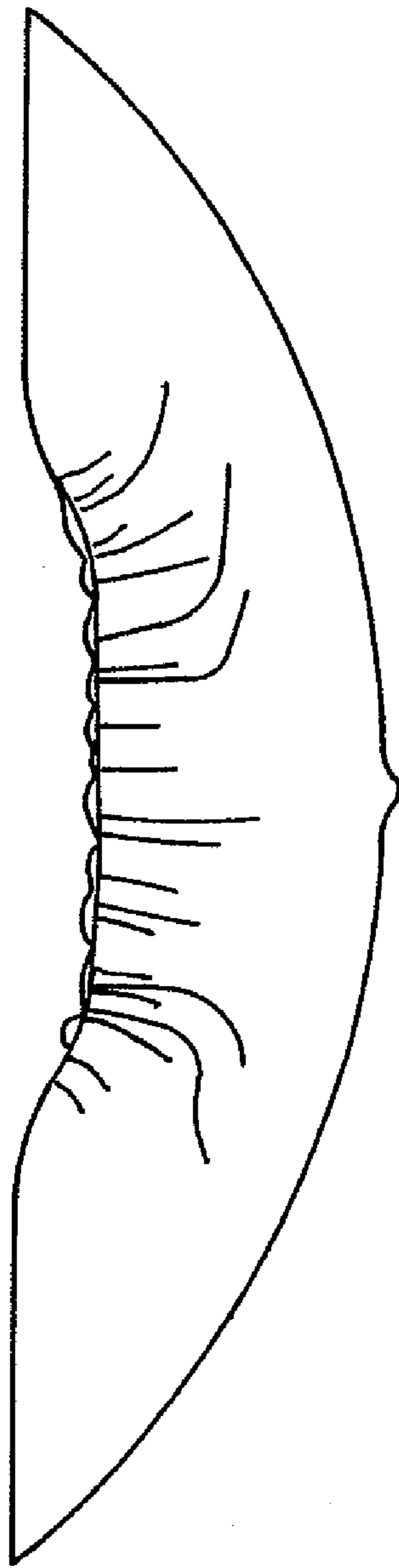

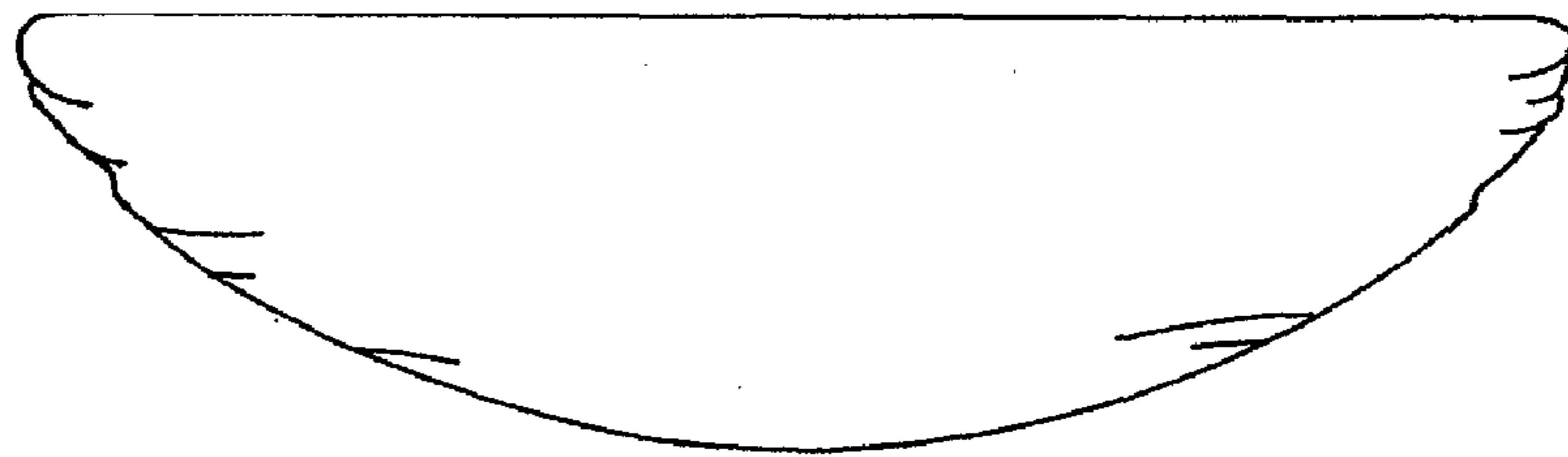

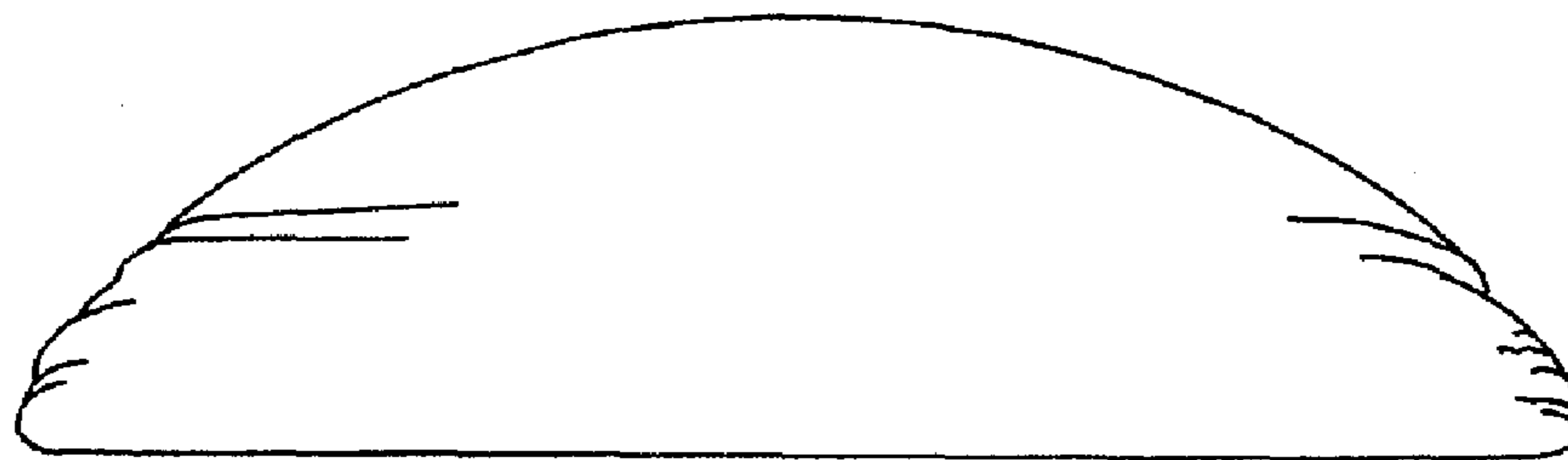

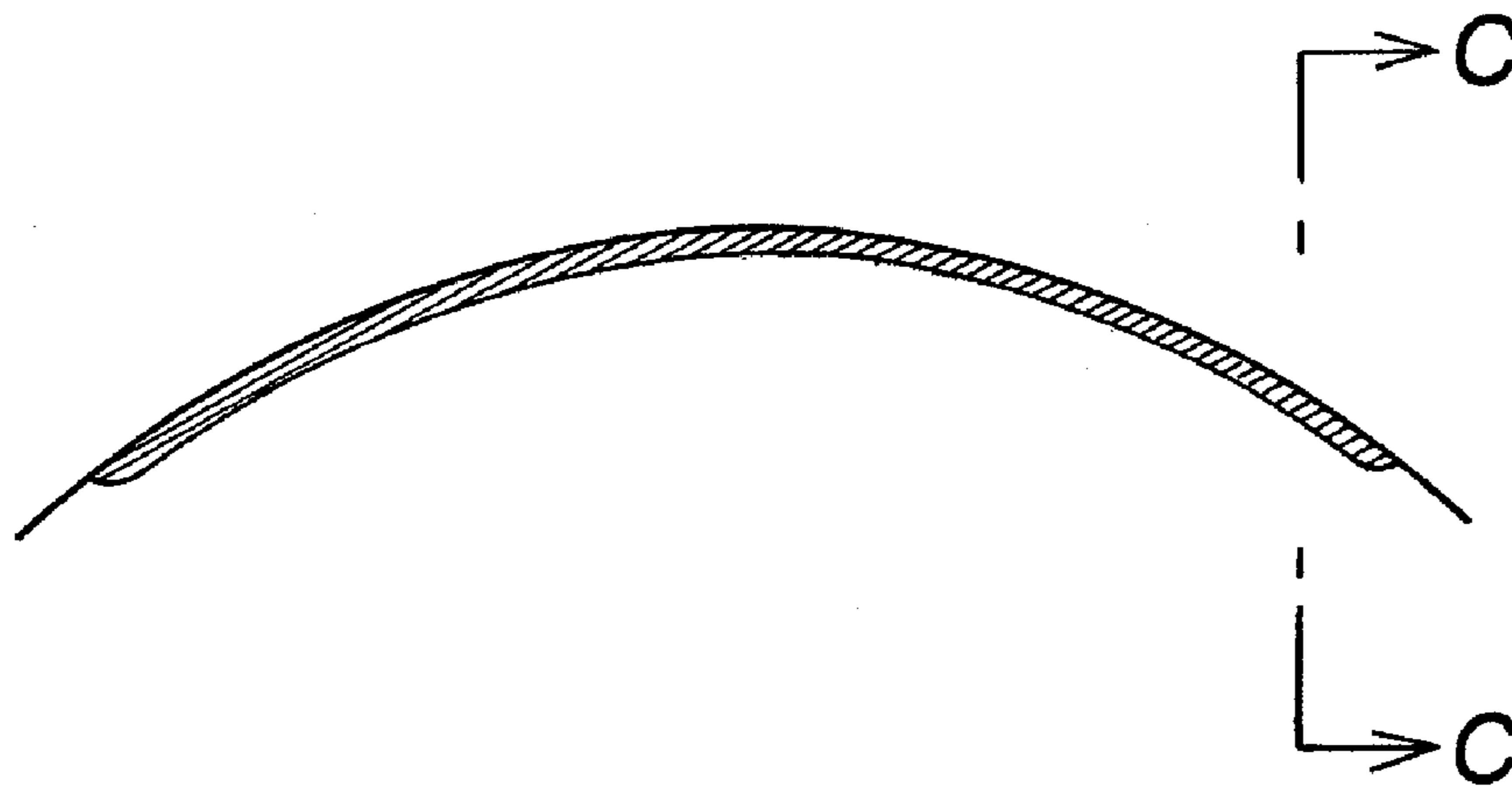

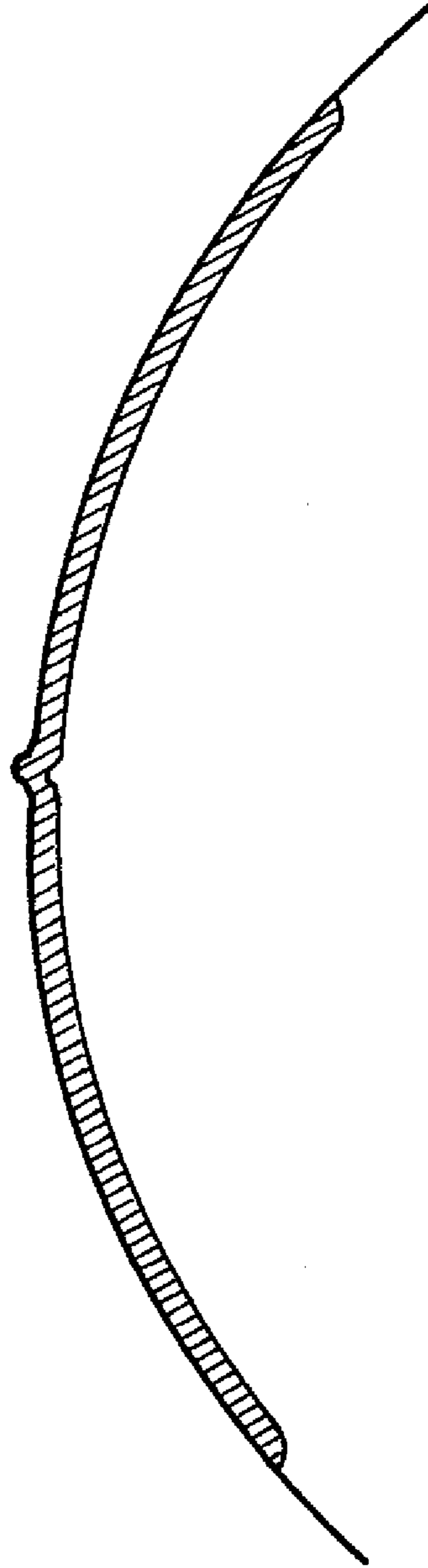
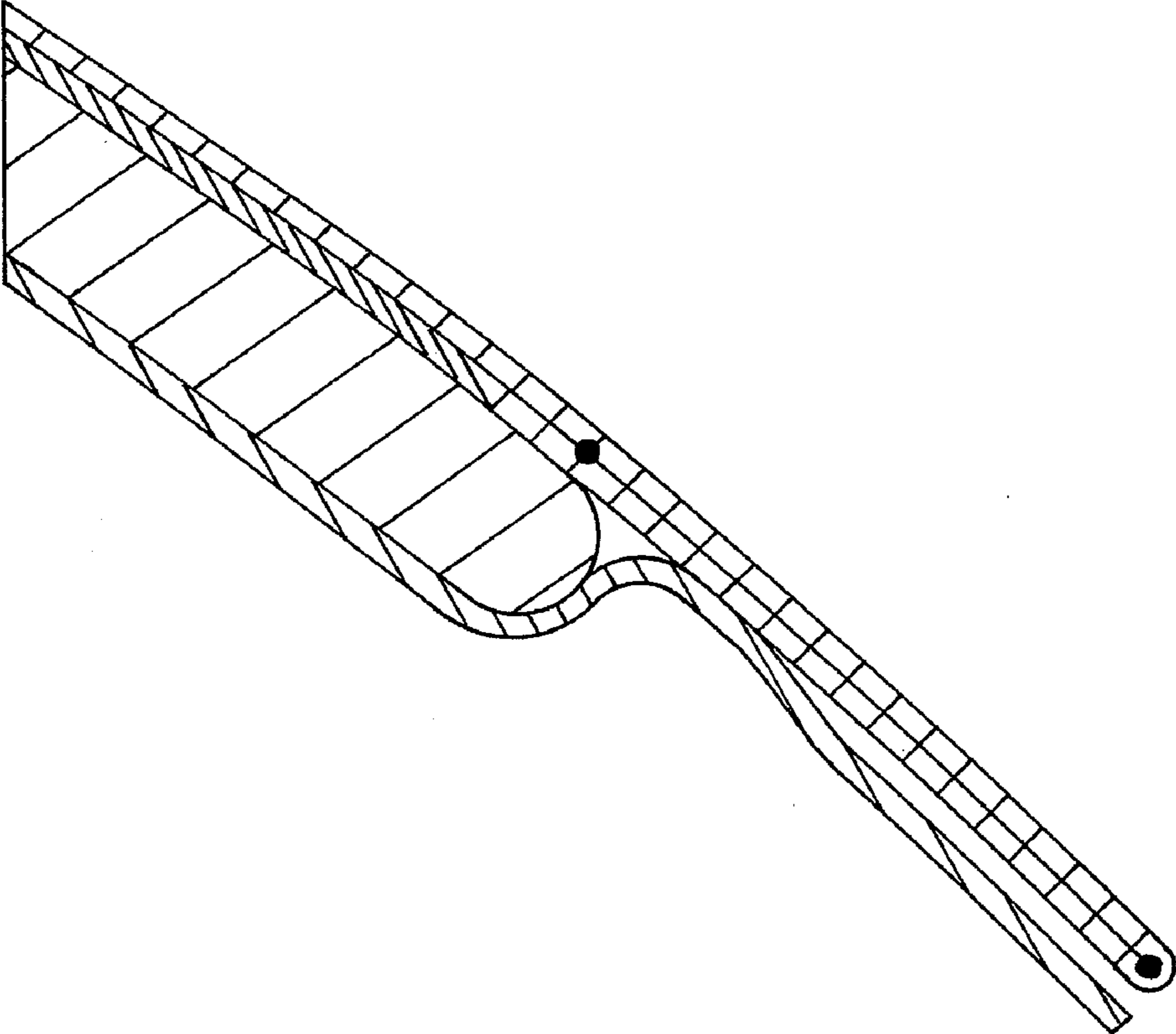

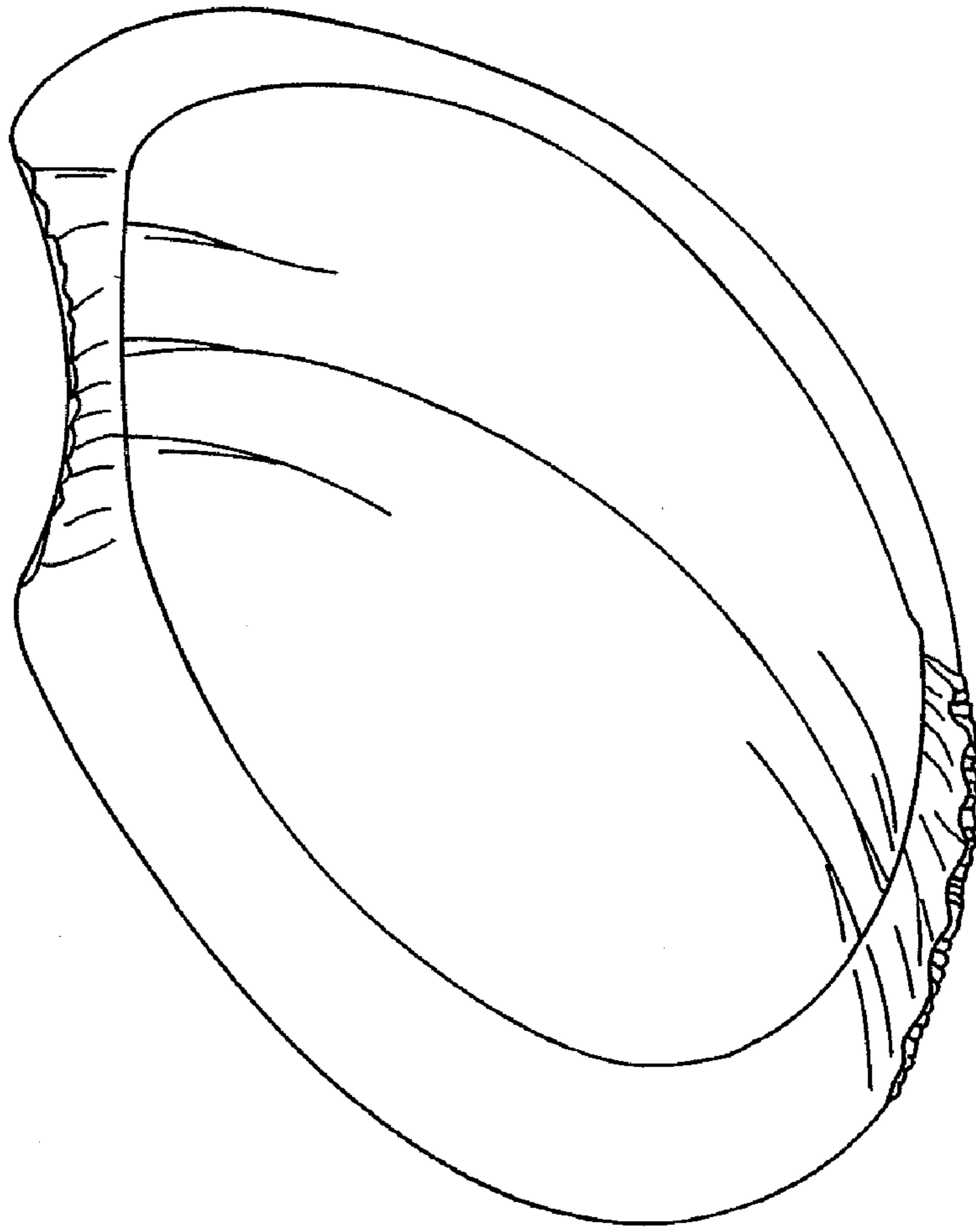
