showing our new design;

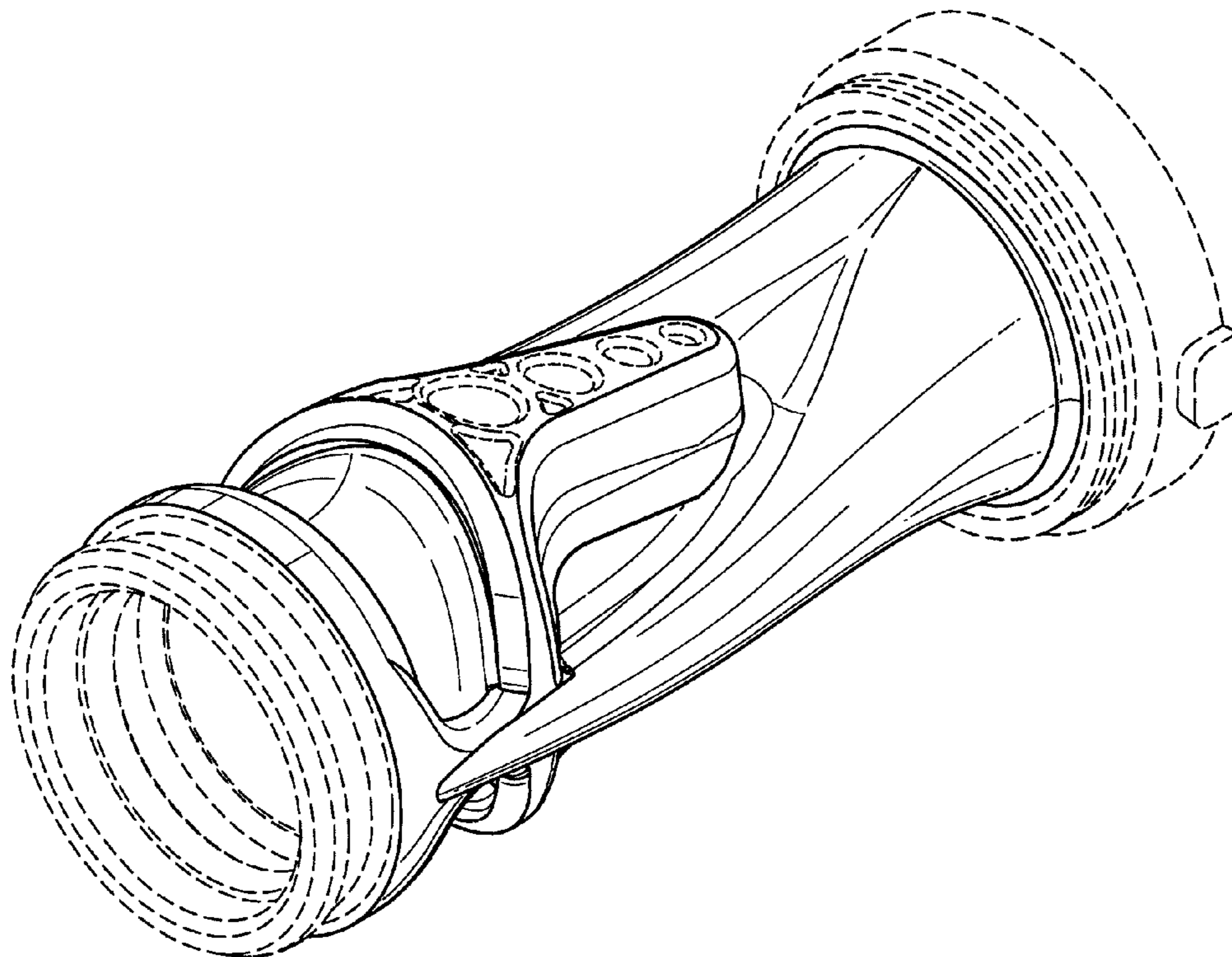
FIG. 2 is a second perspective view thereof;

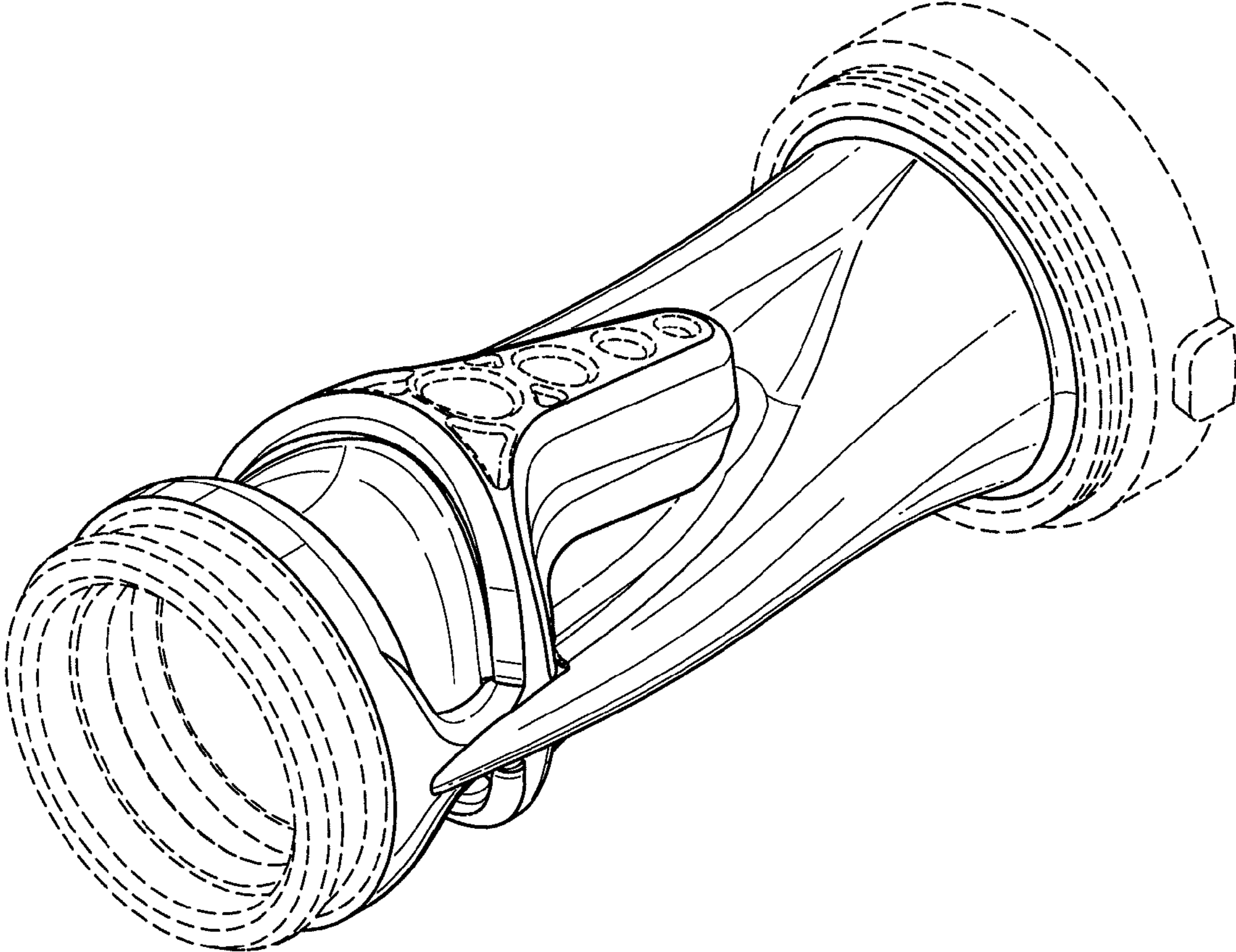

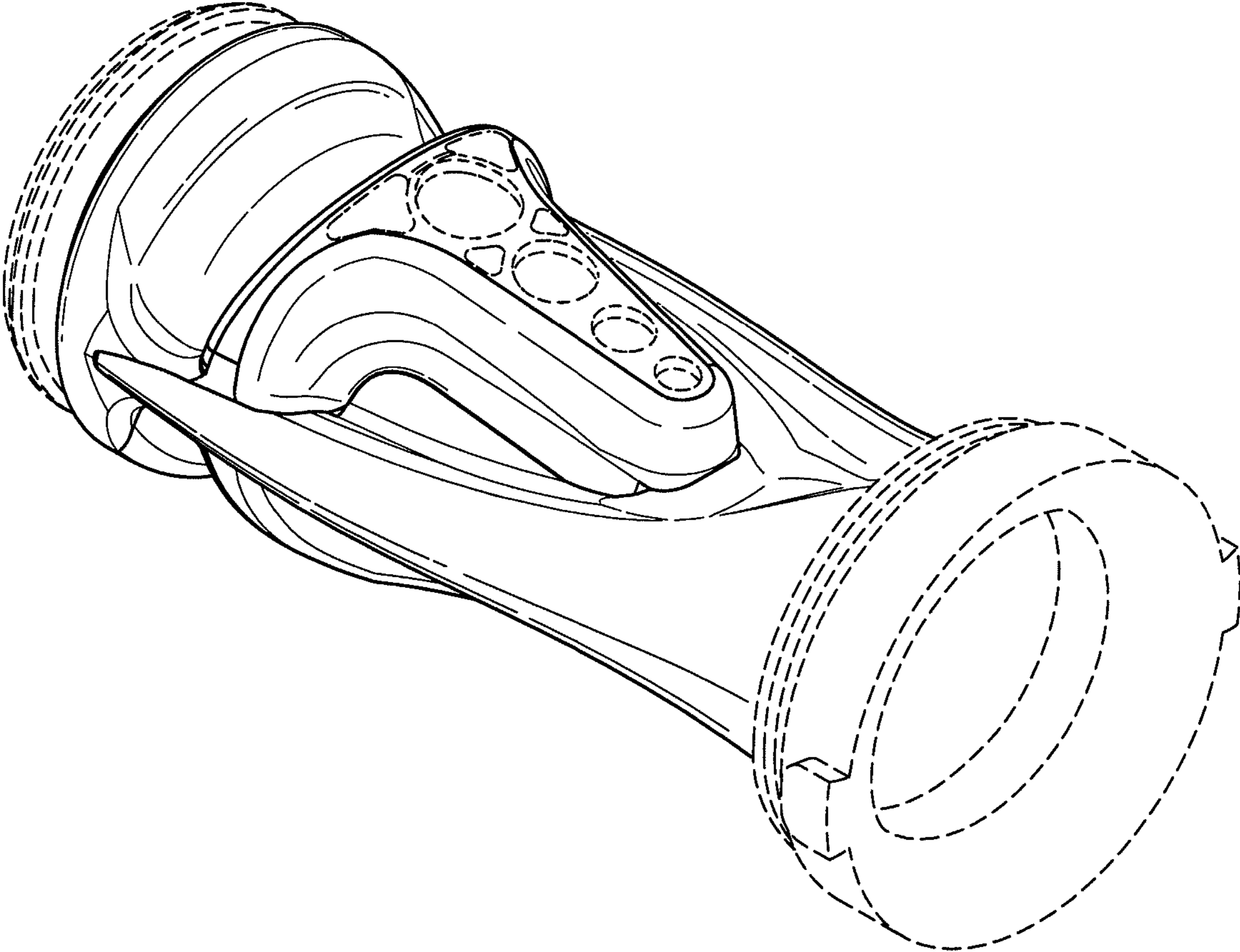

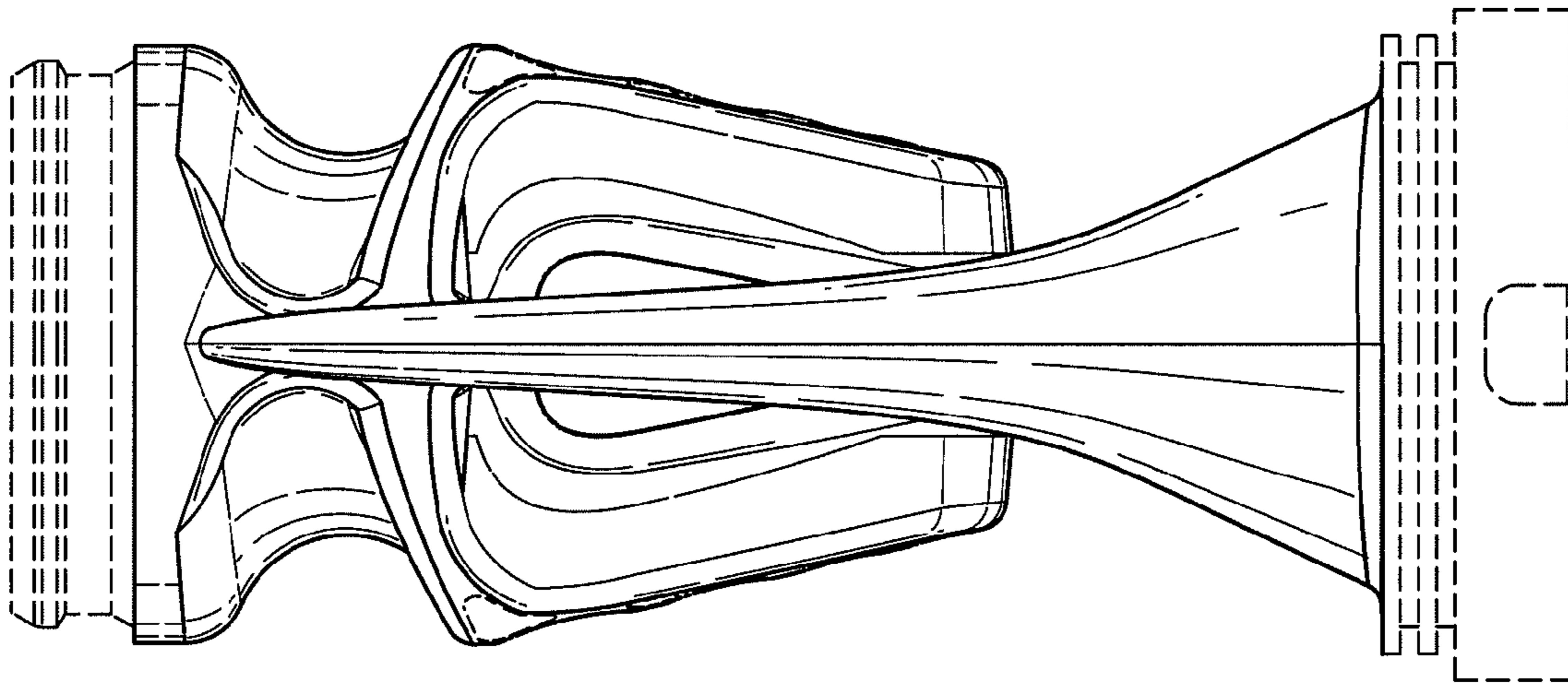

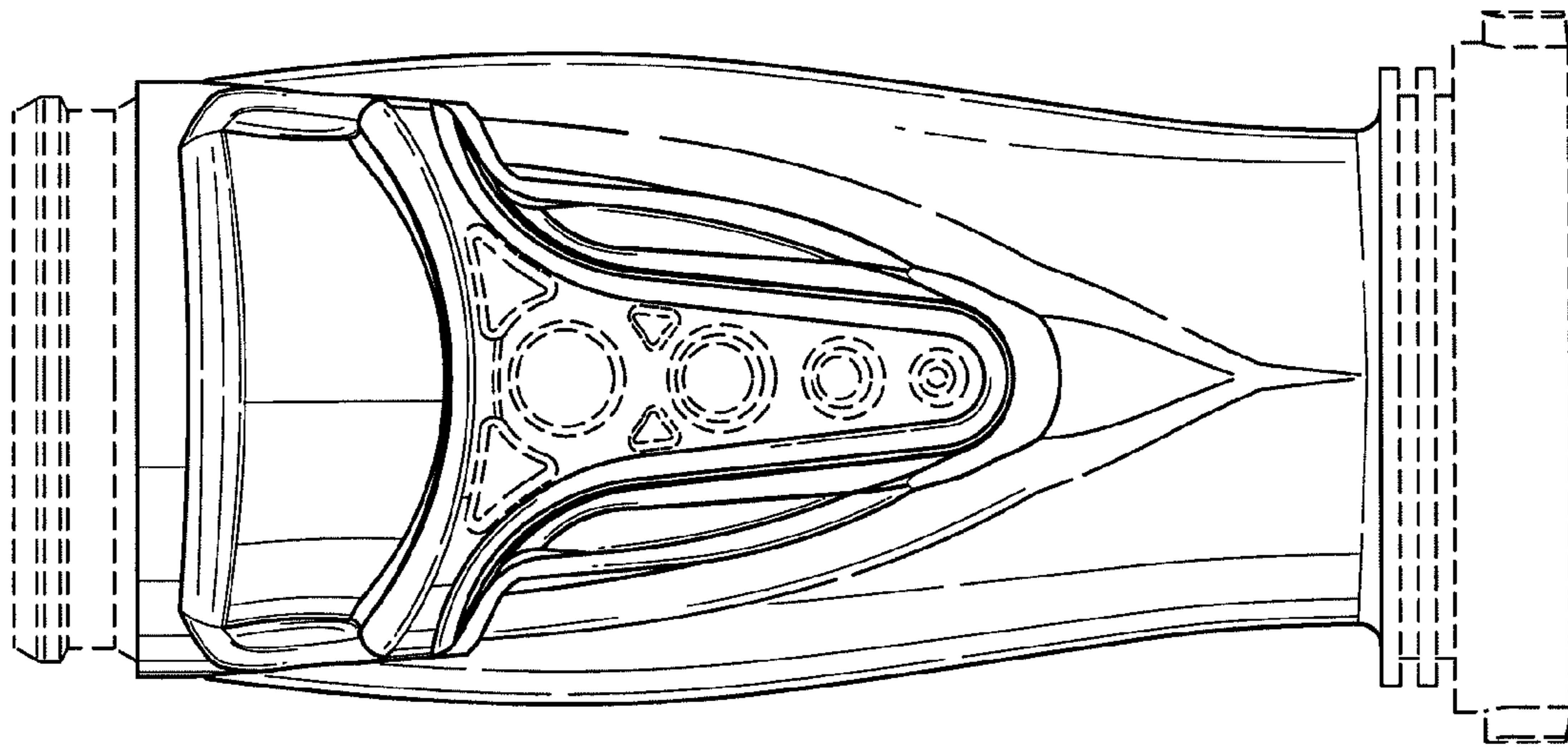
