**DESCRIPTION**

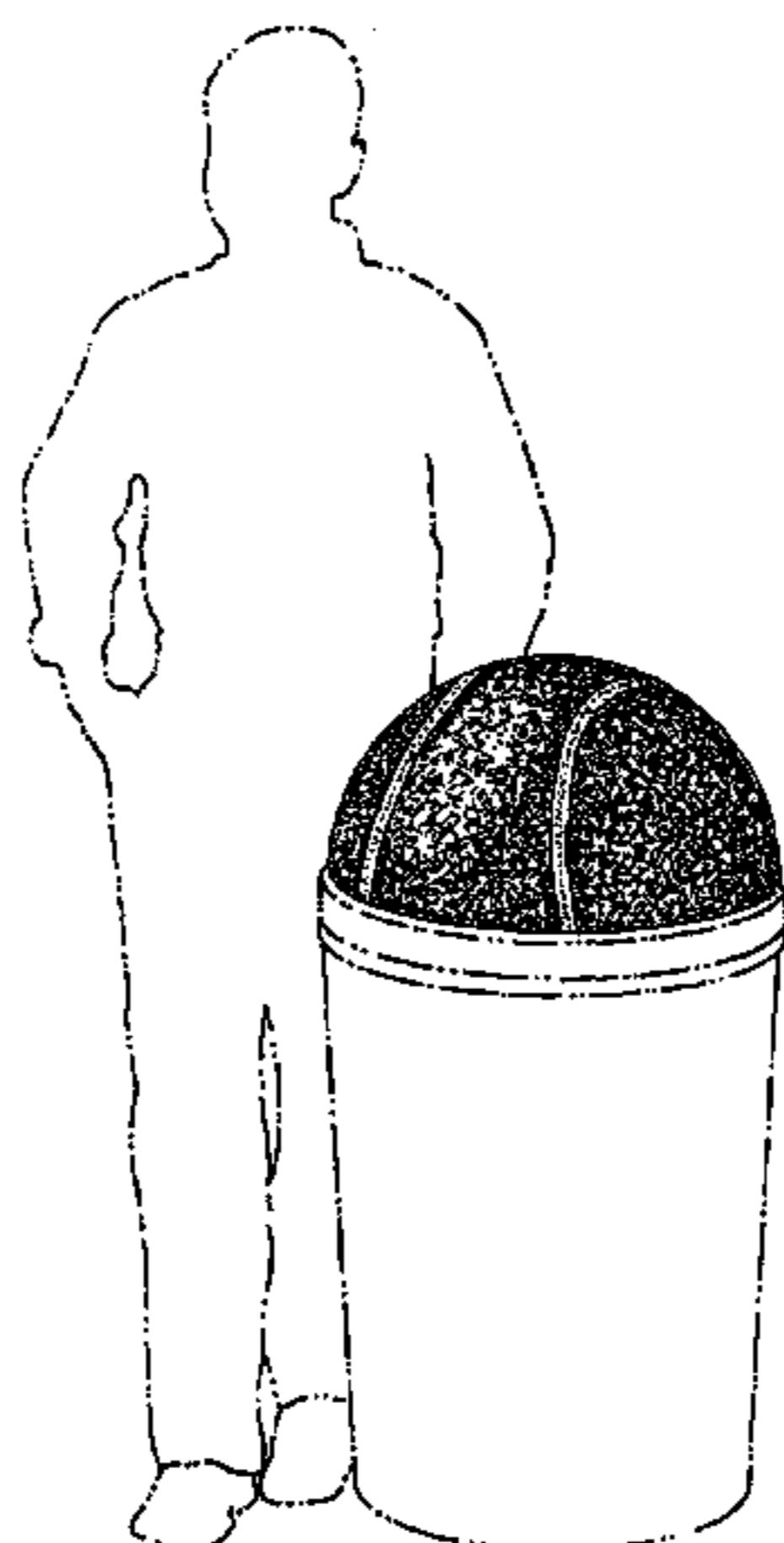
FIG. 1 is a front perspective view of a container for household waste materials showing our new design, the rear perspective being a mirror image thereof;

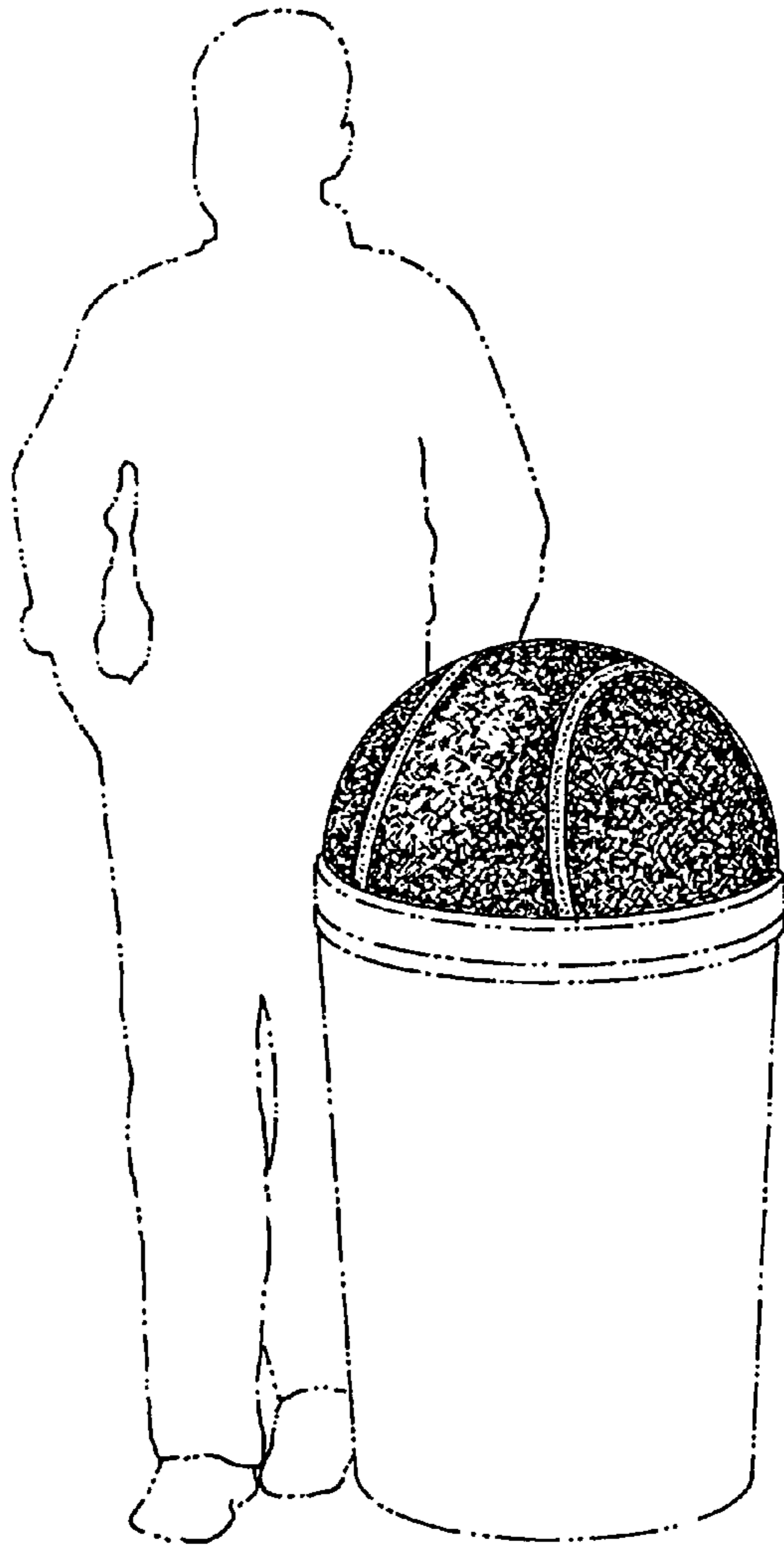

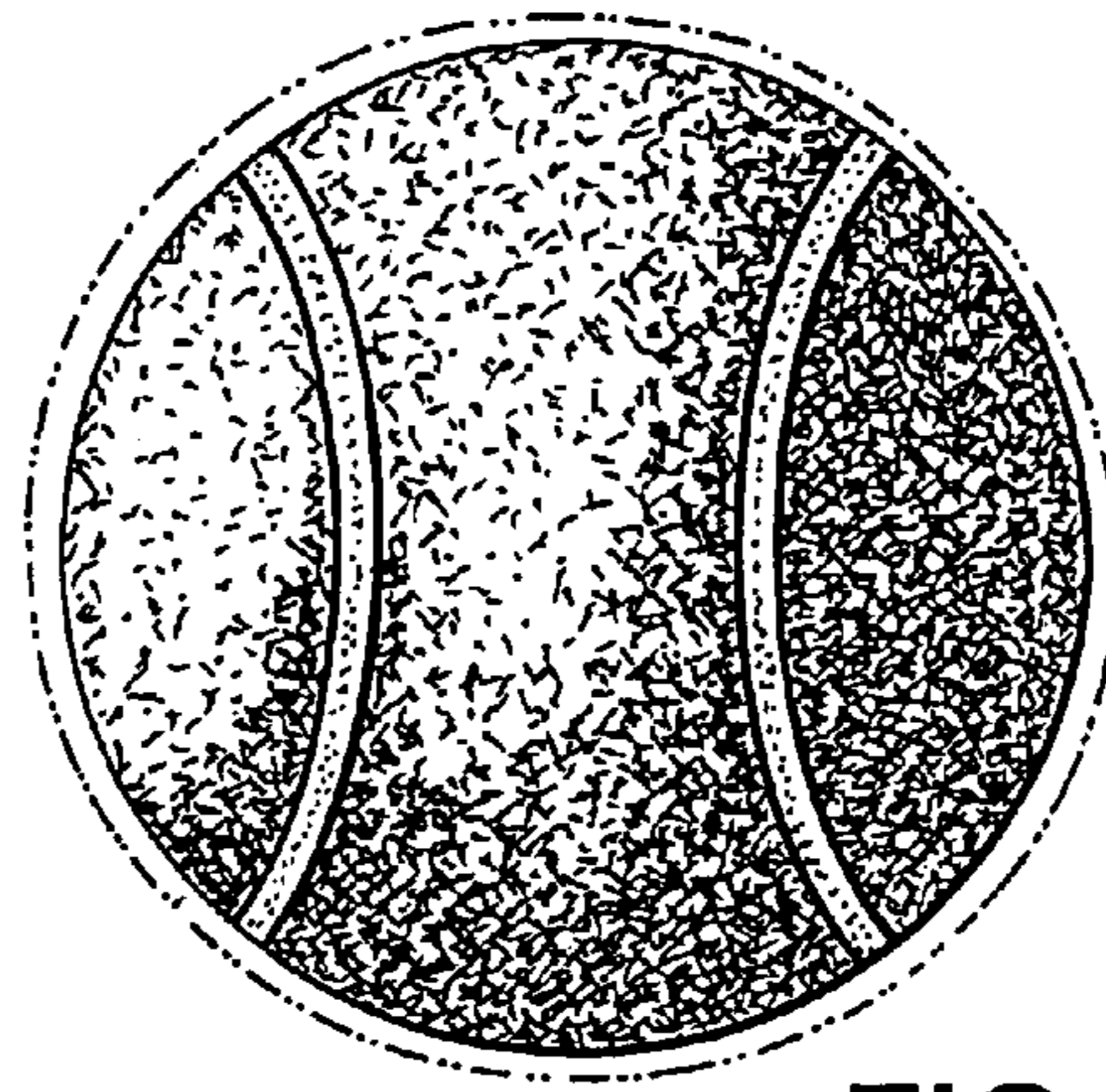

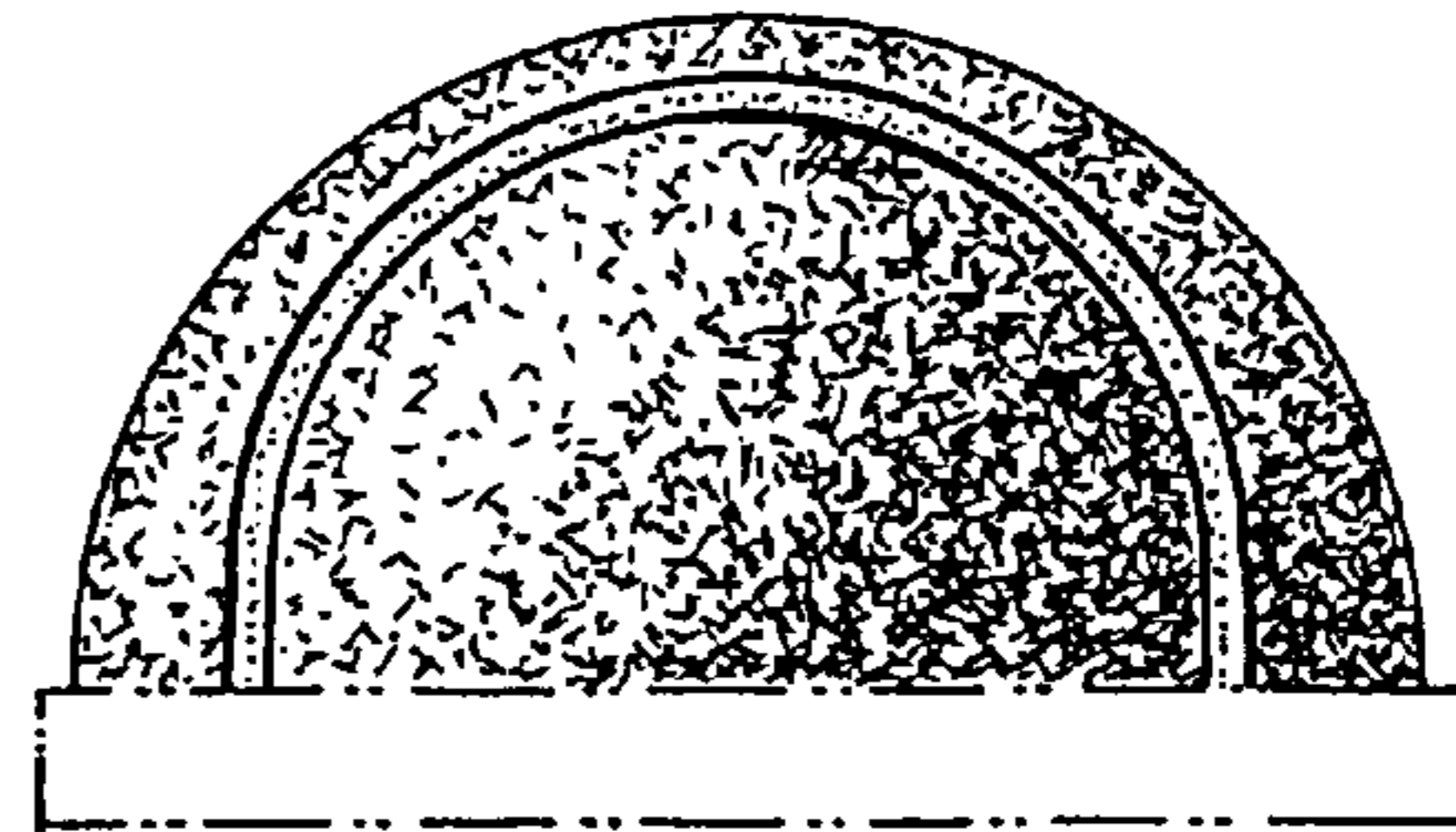

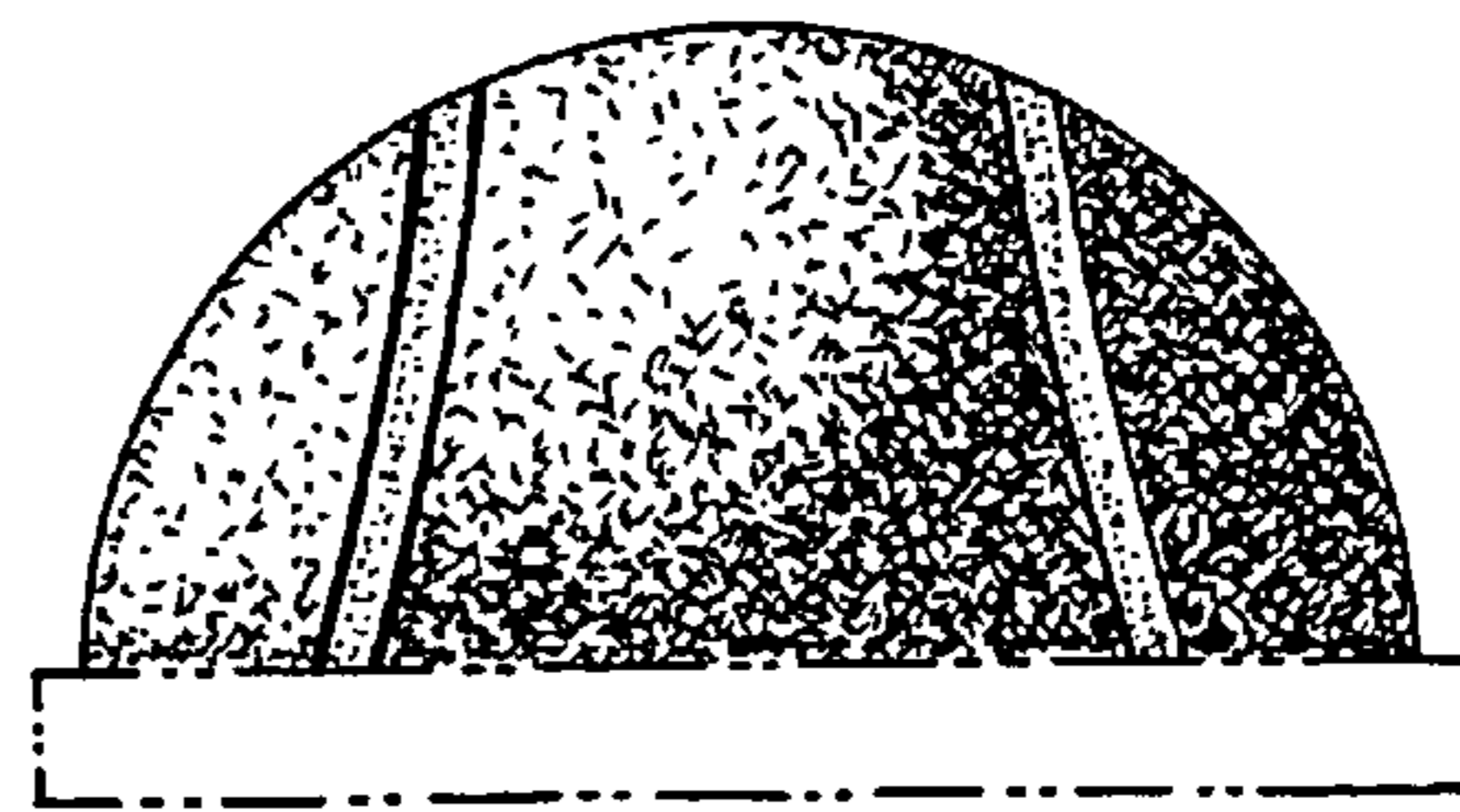
