FIG. 3 is a rear elevation view;

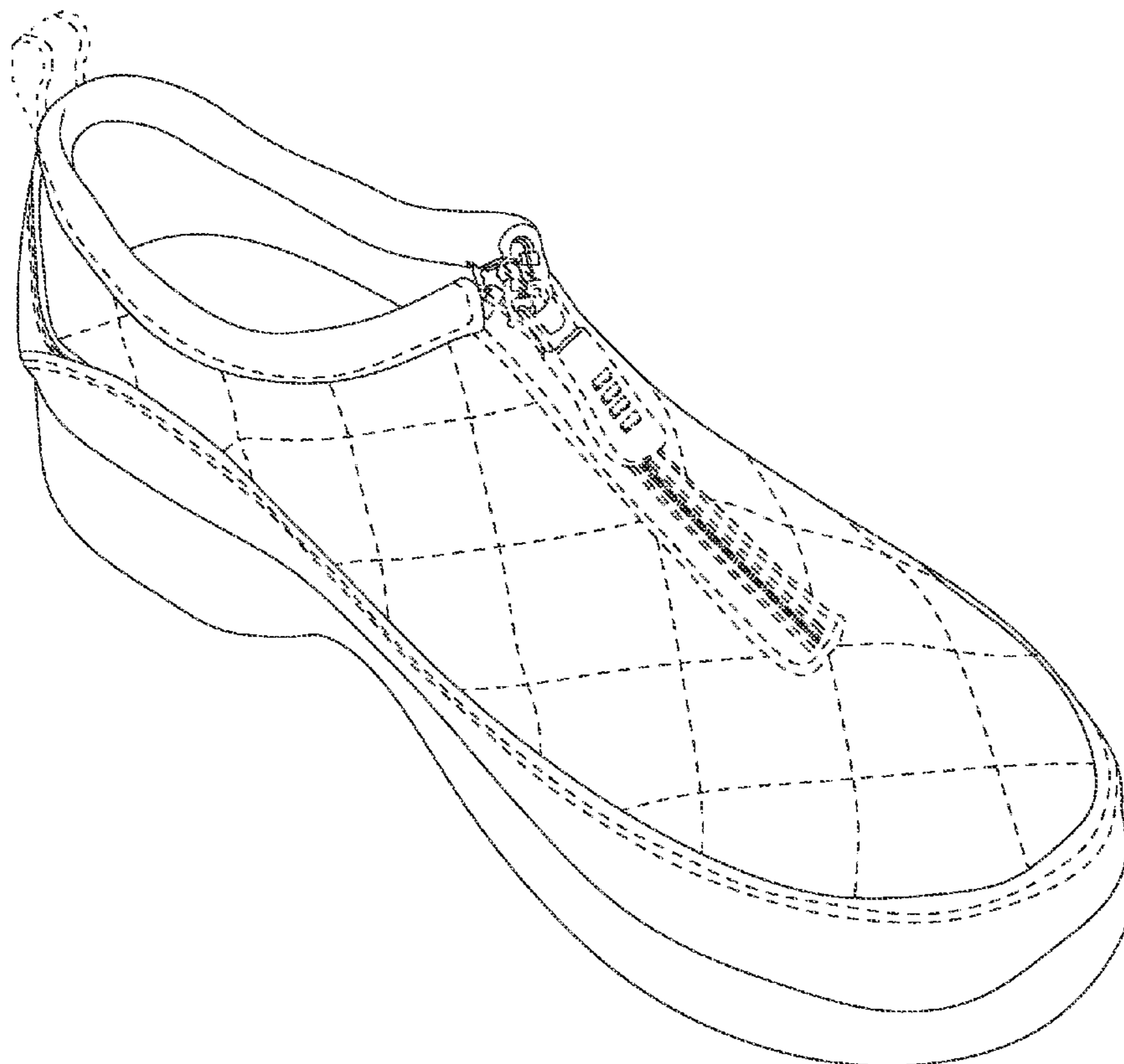
FIG. 4 is a left side elevation view;

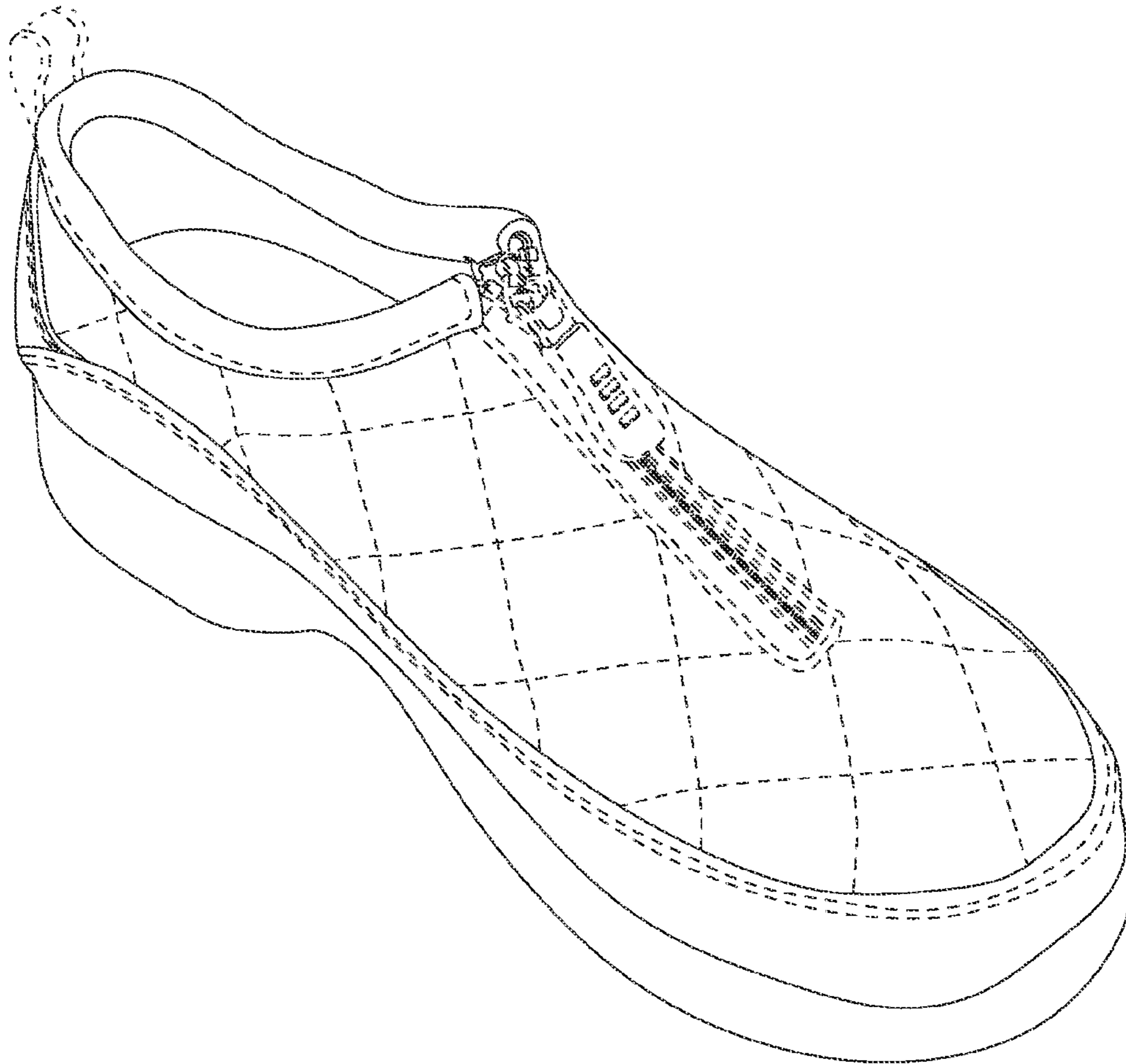
FIG. 5 is a right side elevation view; and,

FIG. 6 is a top plan view.

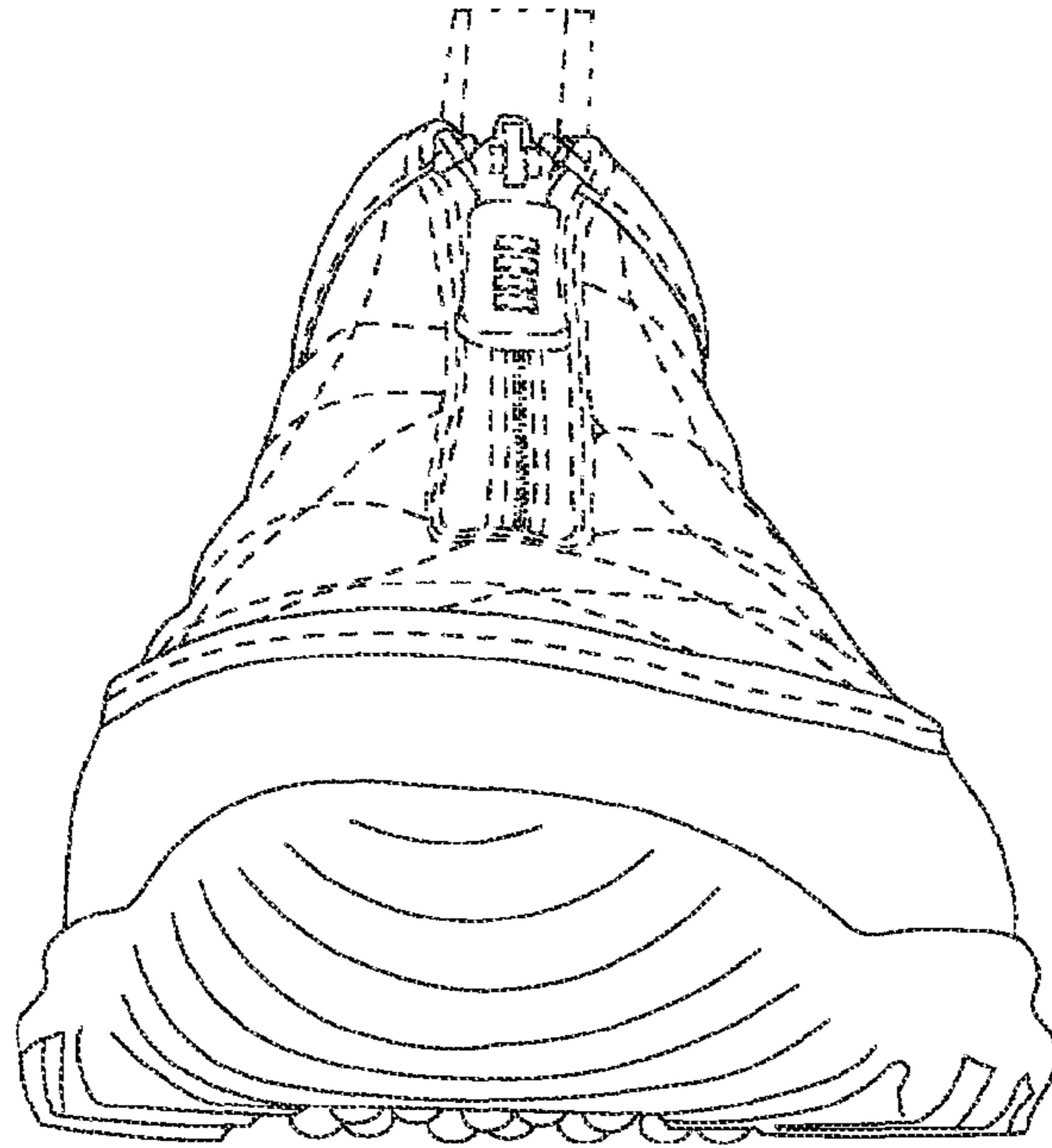
The dotted lines showing the shoe back heel loop are provided for illustrative purposes only and form no part of the design claimed.

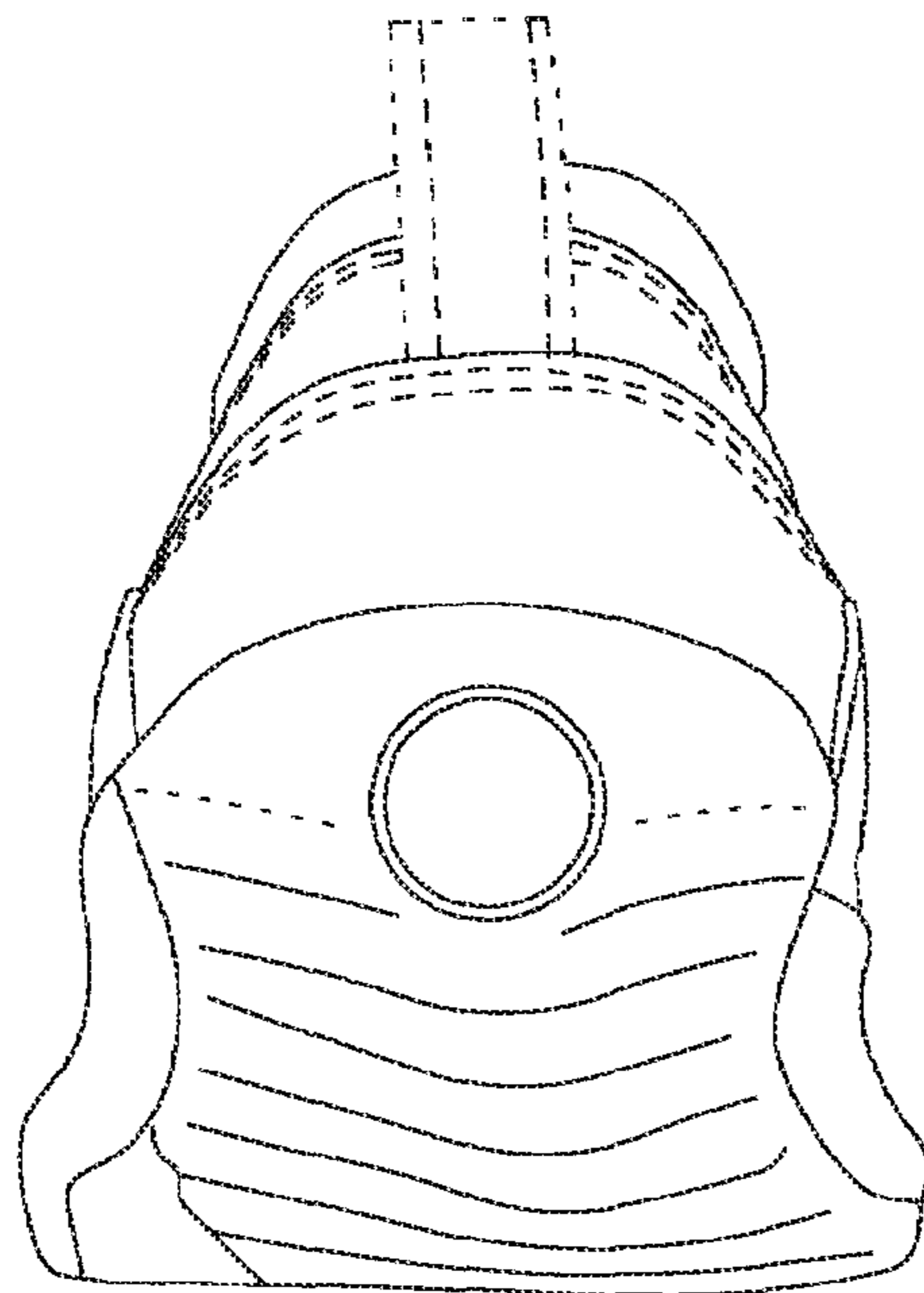




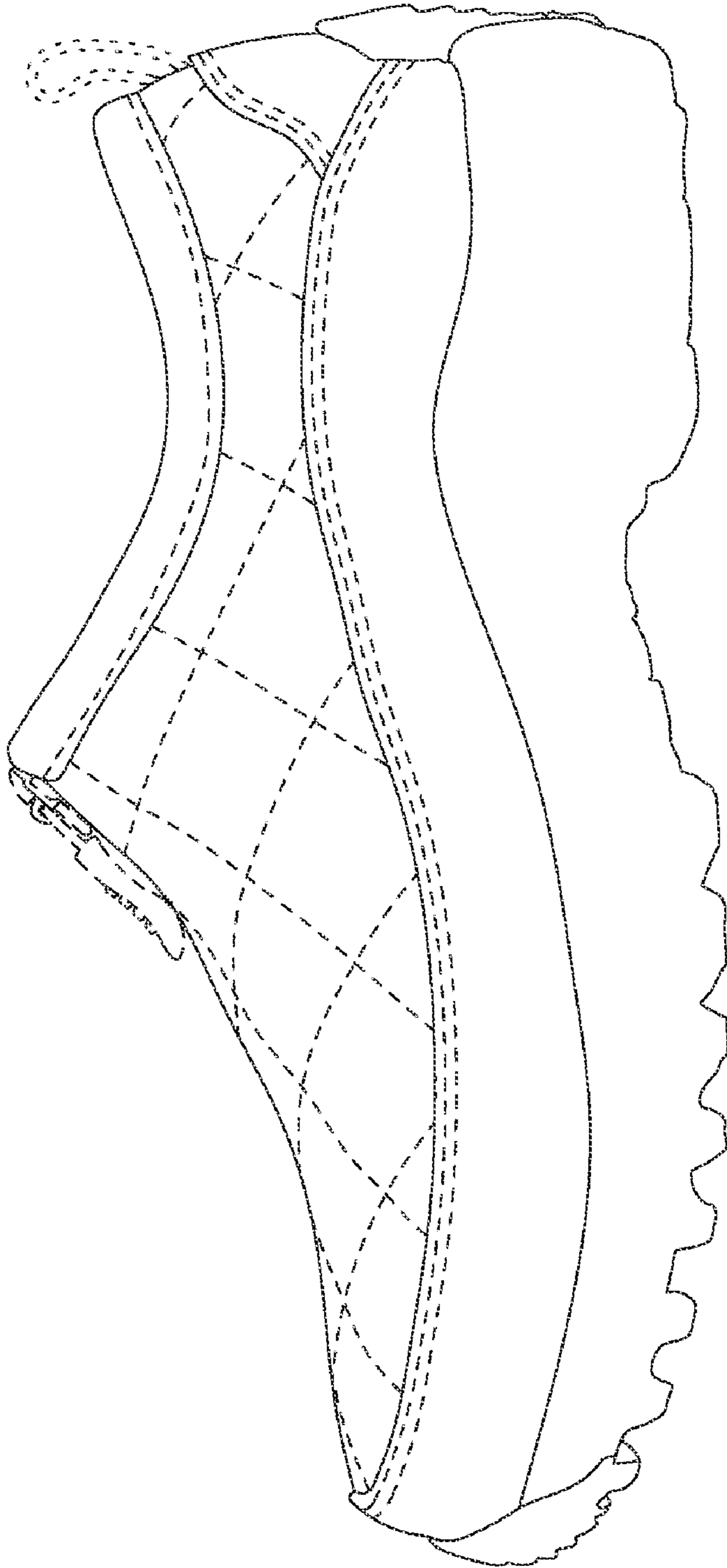

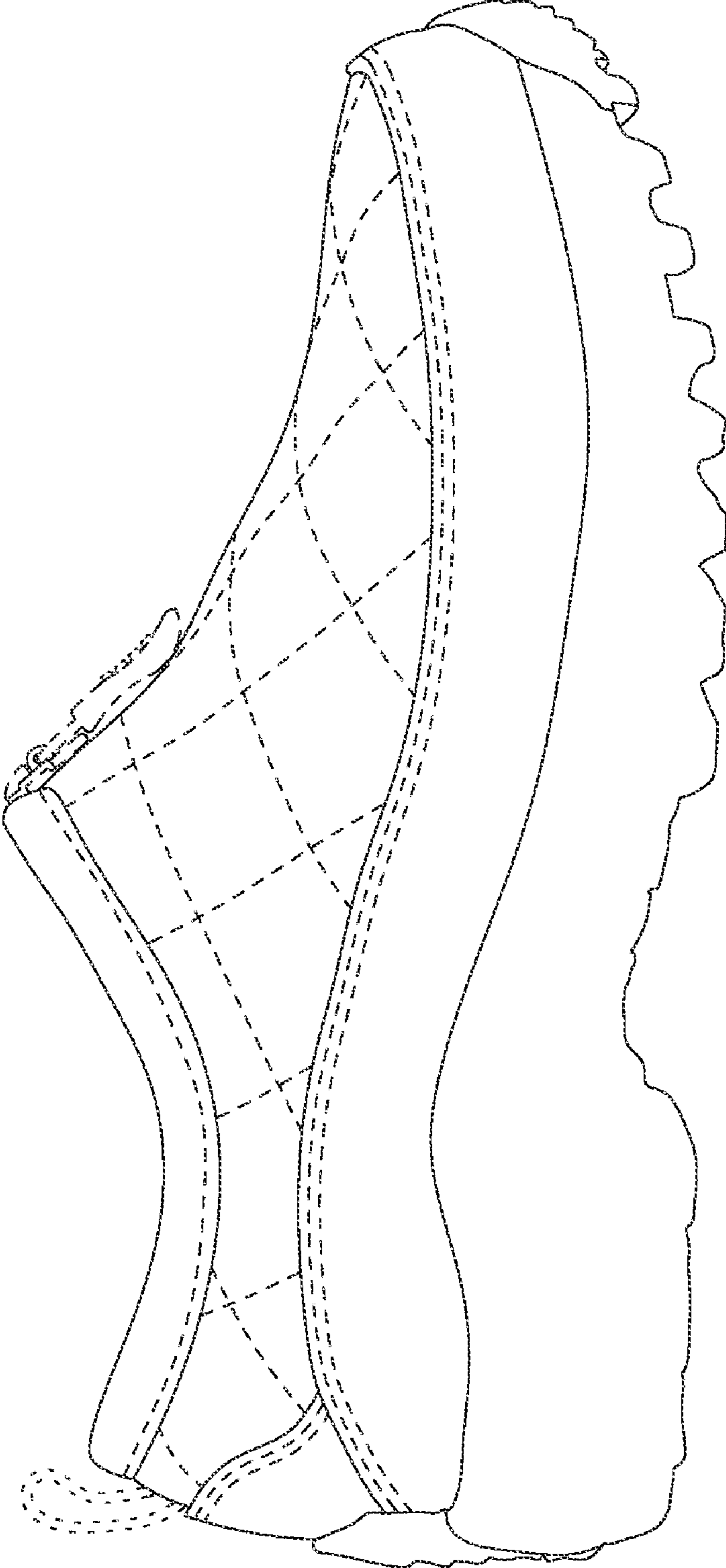

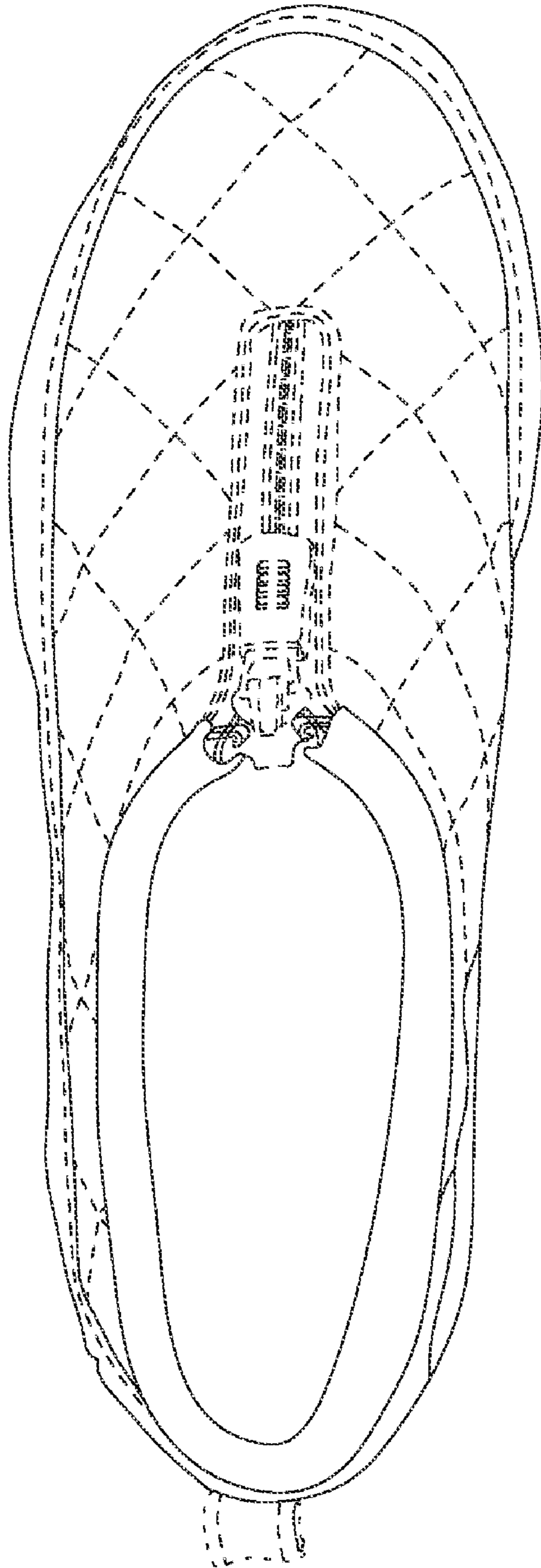
