FIG. 9 is showing a rear elevation view of a headrest in a position of use.

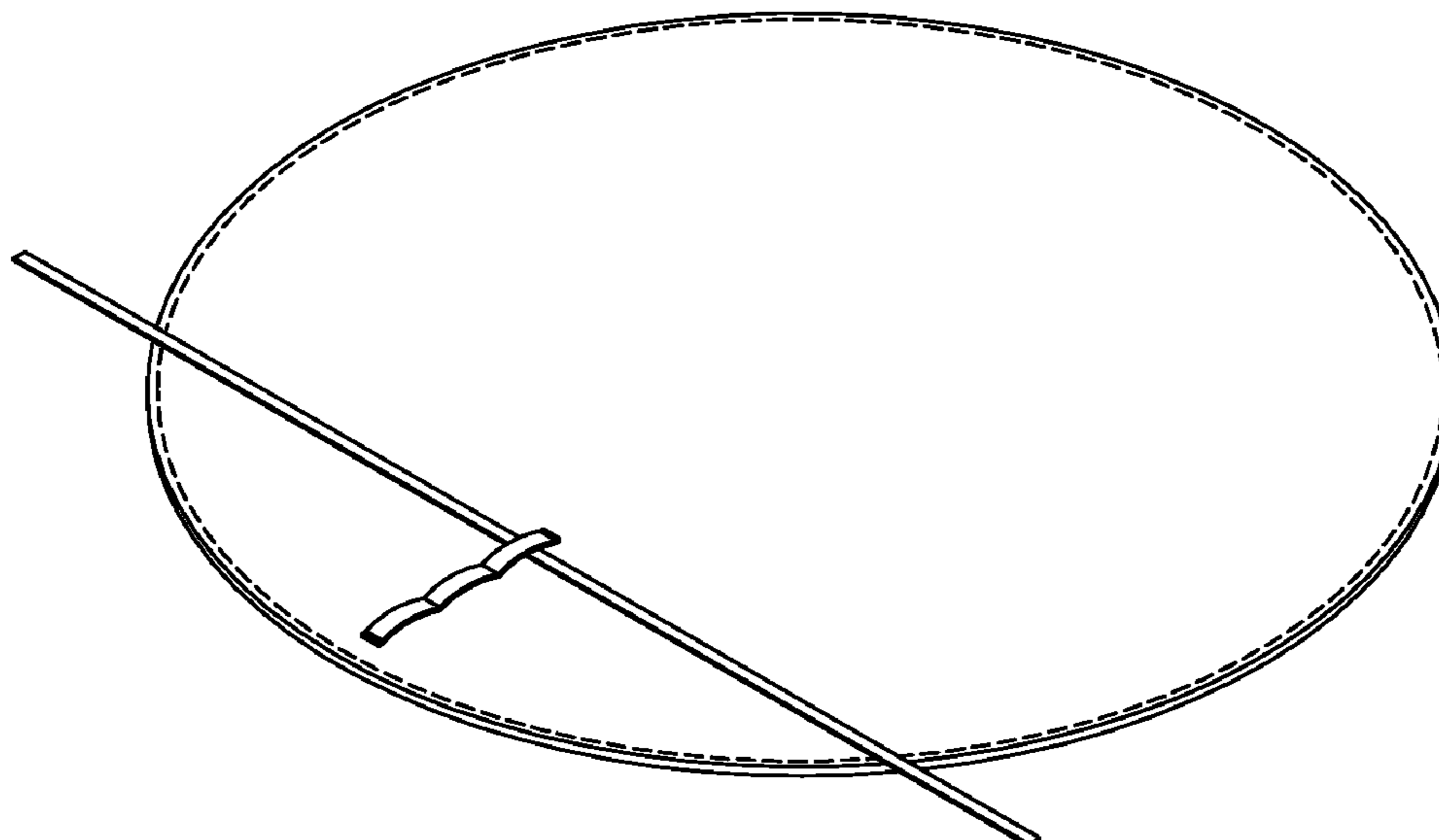

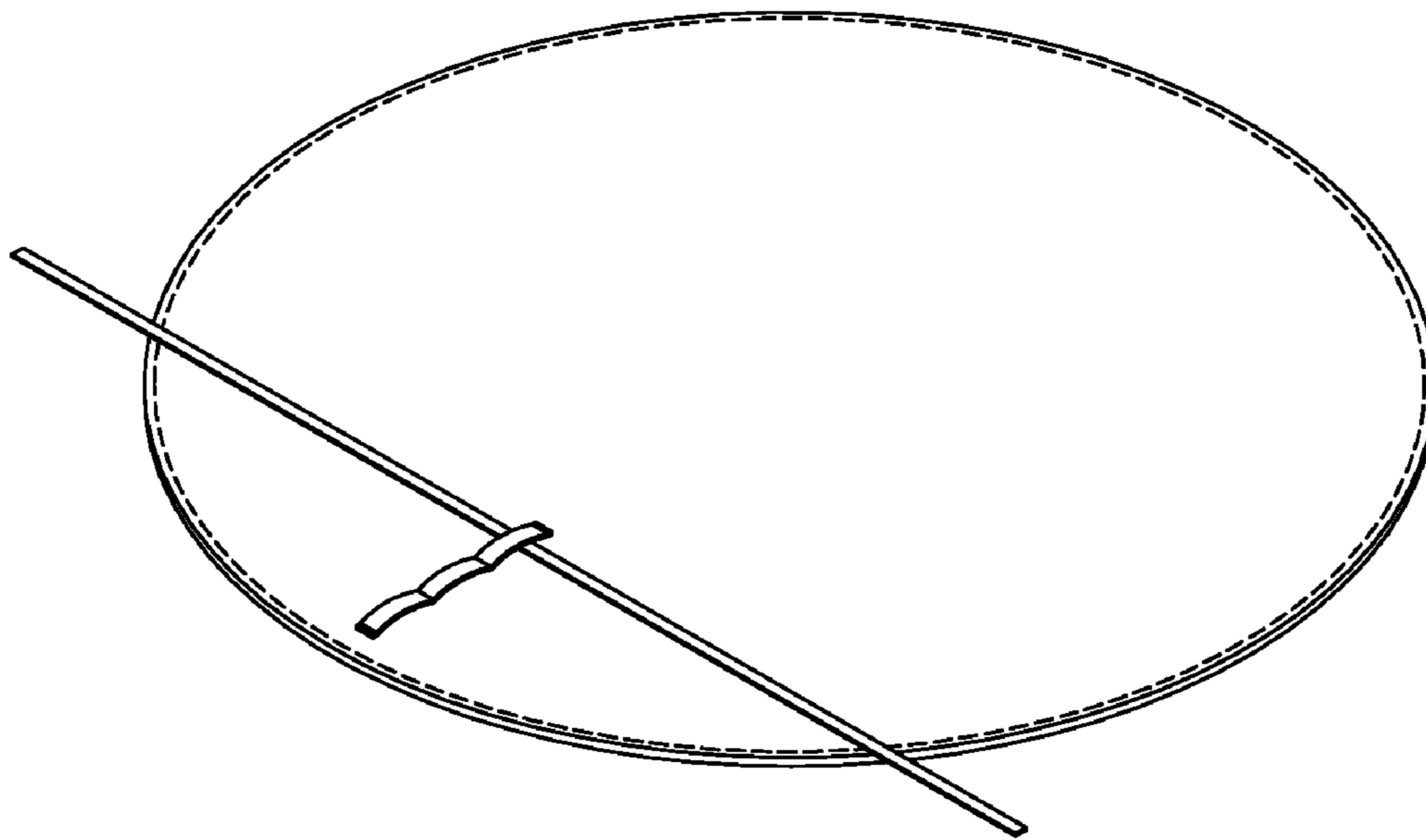

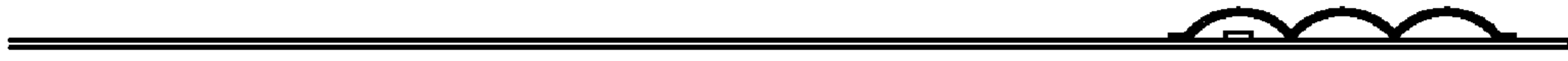

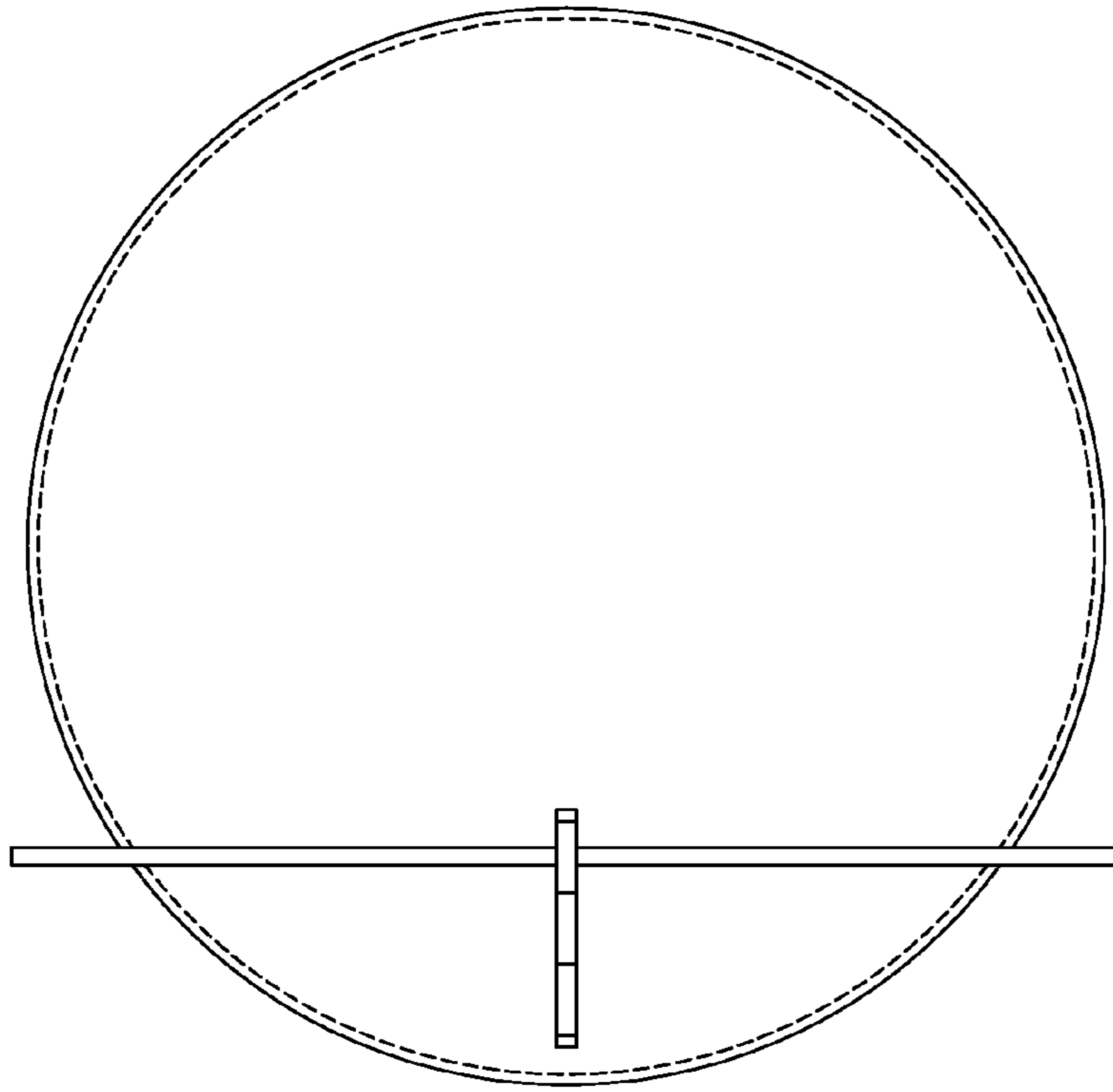

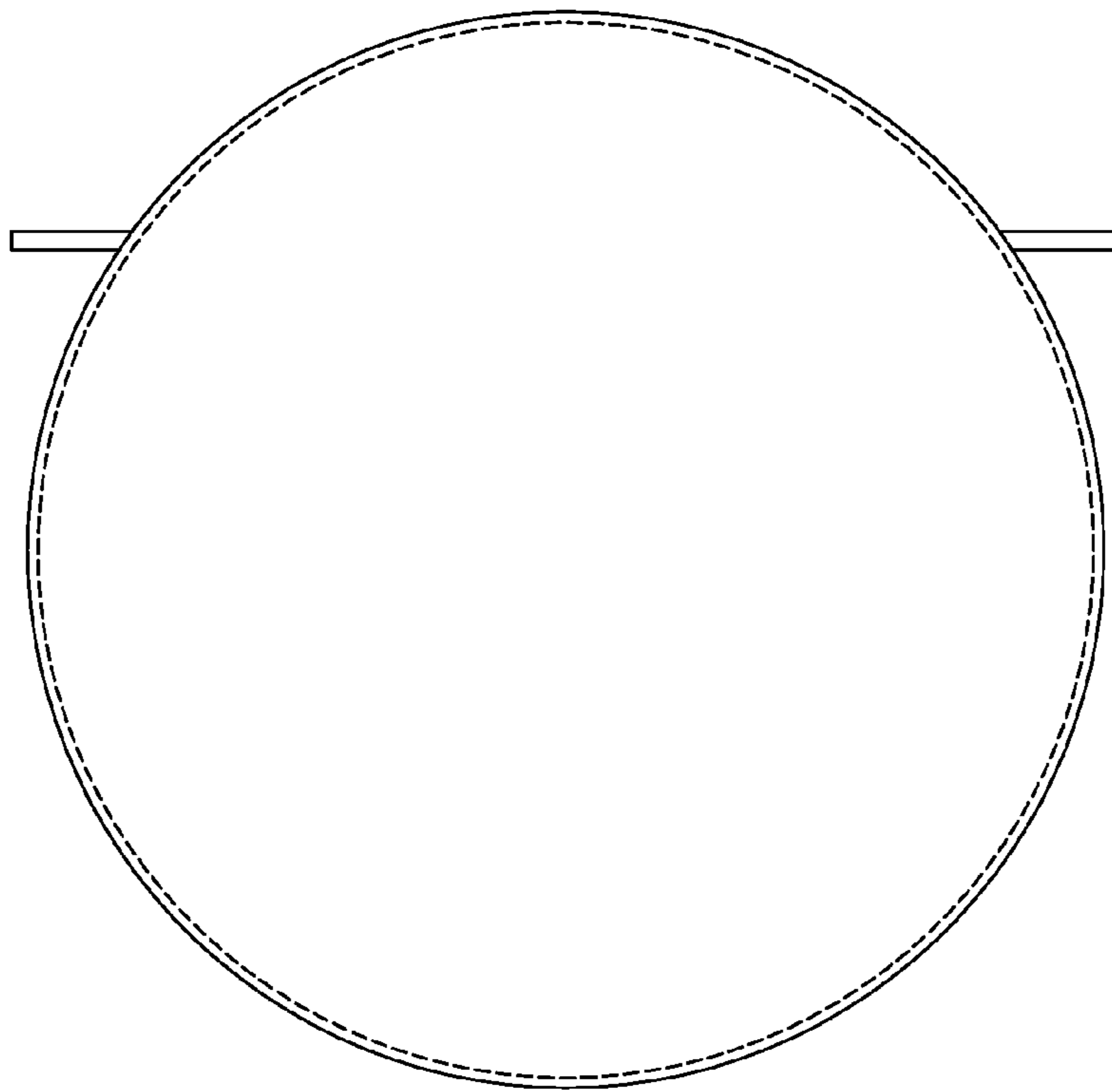

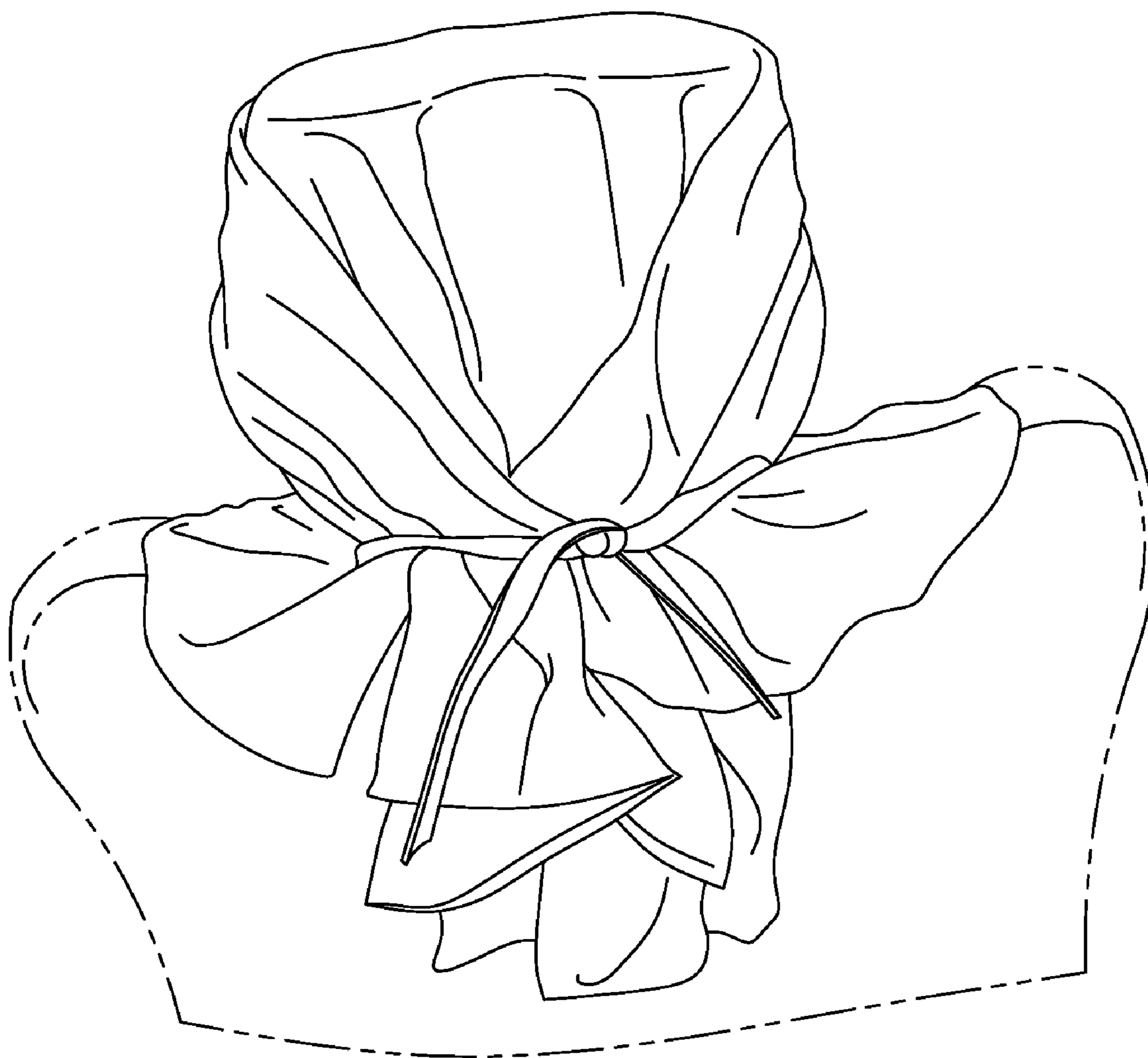
