(57) **CLAIM**

I claim the ornamental design for a drink bottle with revolving door, as shown and described.

**DESCRIPTION**

FIG. 8 is a front view of the drink bottle with revolving door in an open position showing my new design;

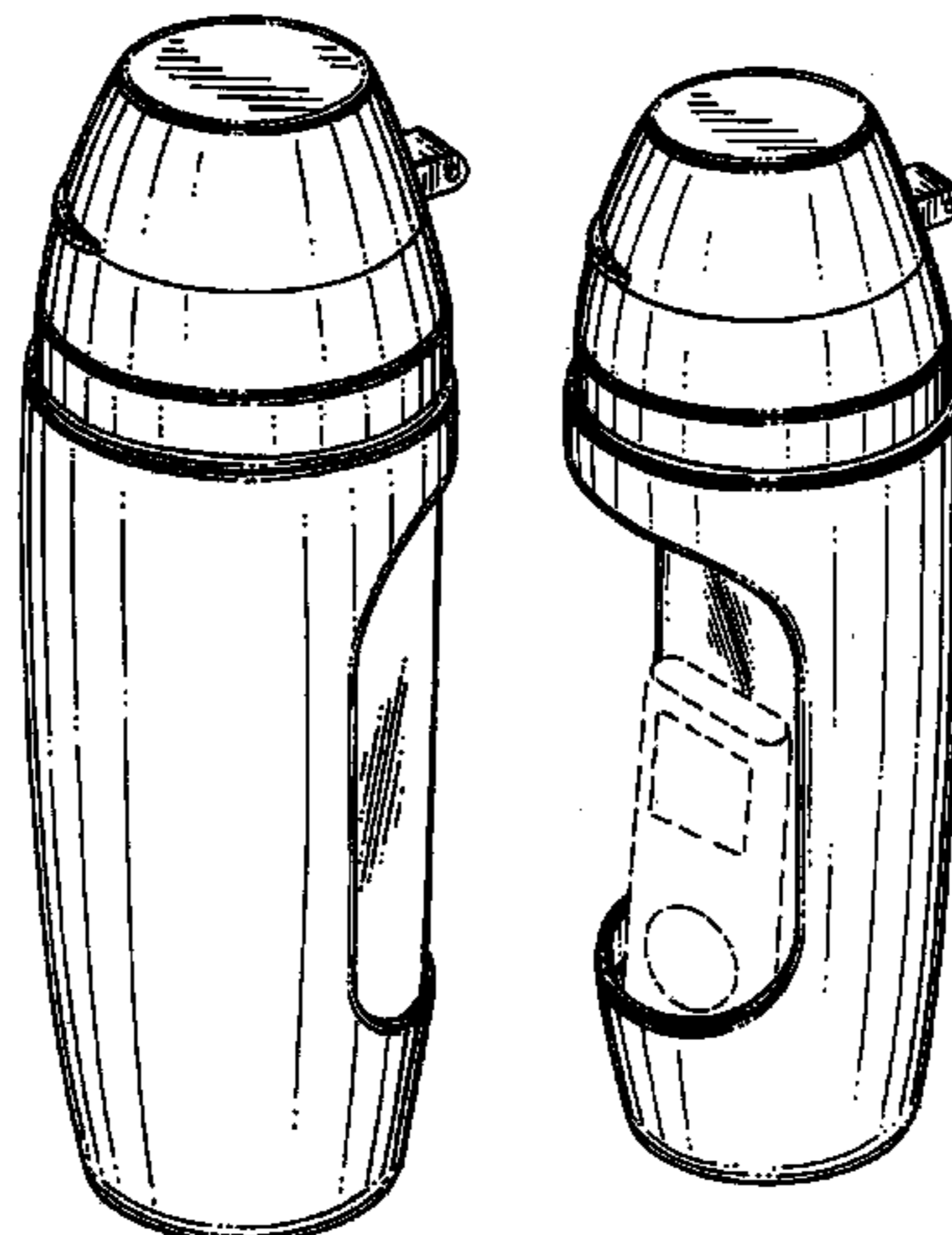
FIG. 9 is a side view of the drink bottle with revolving door in an open position showing my new design;

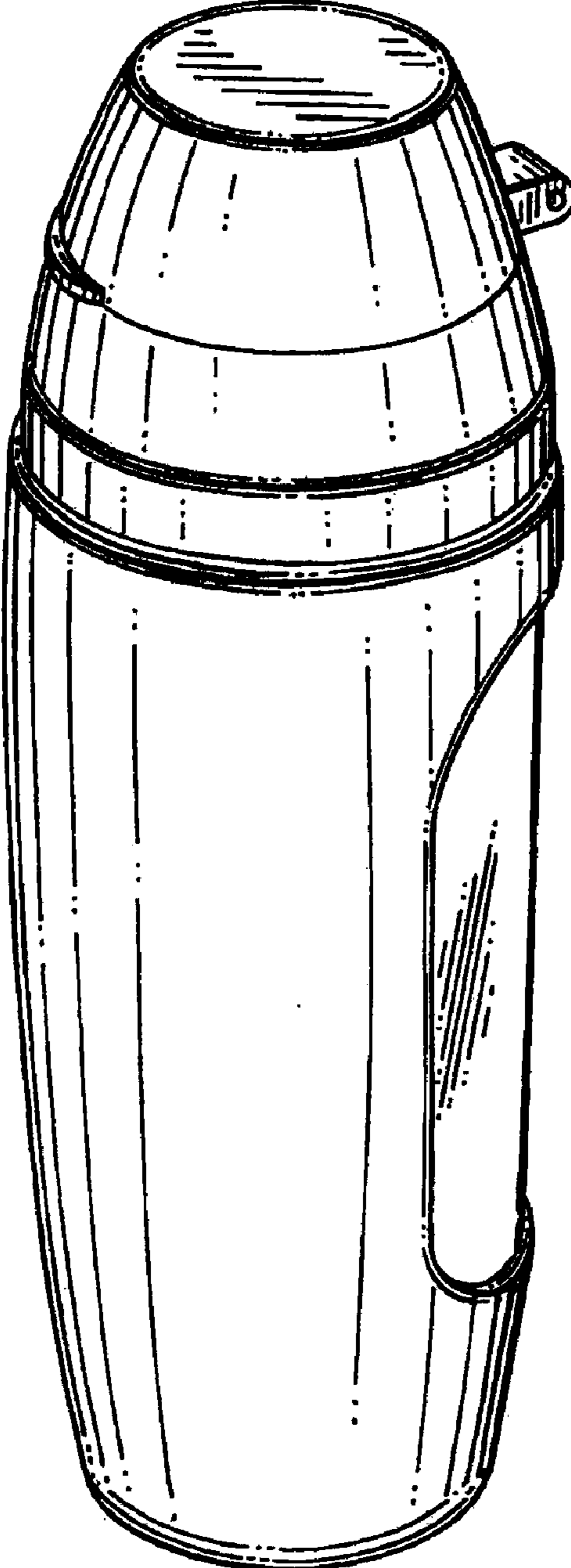

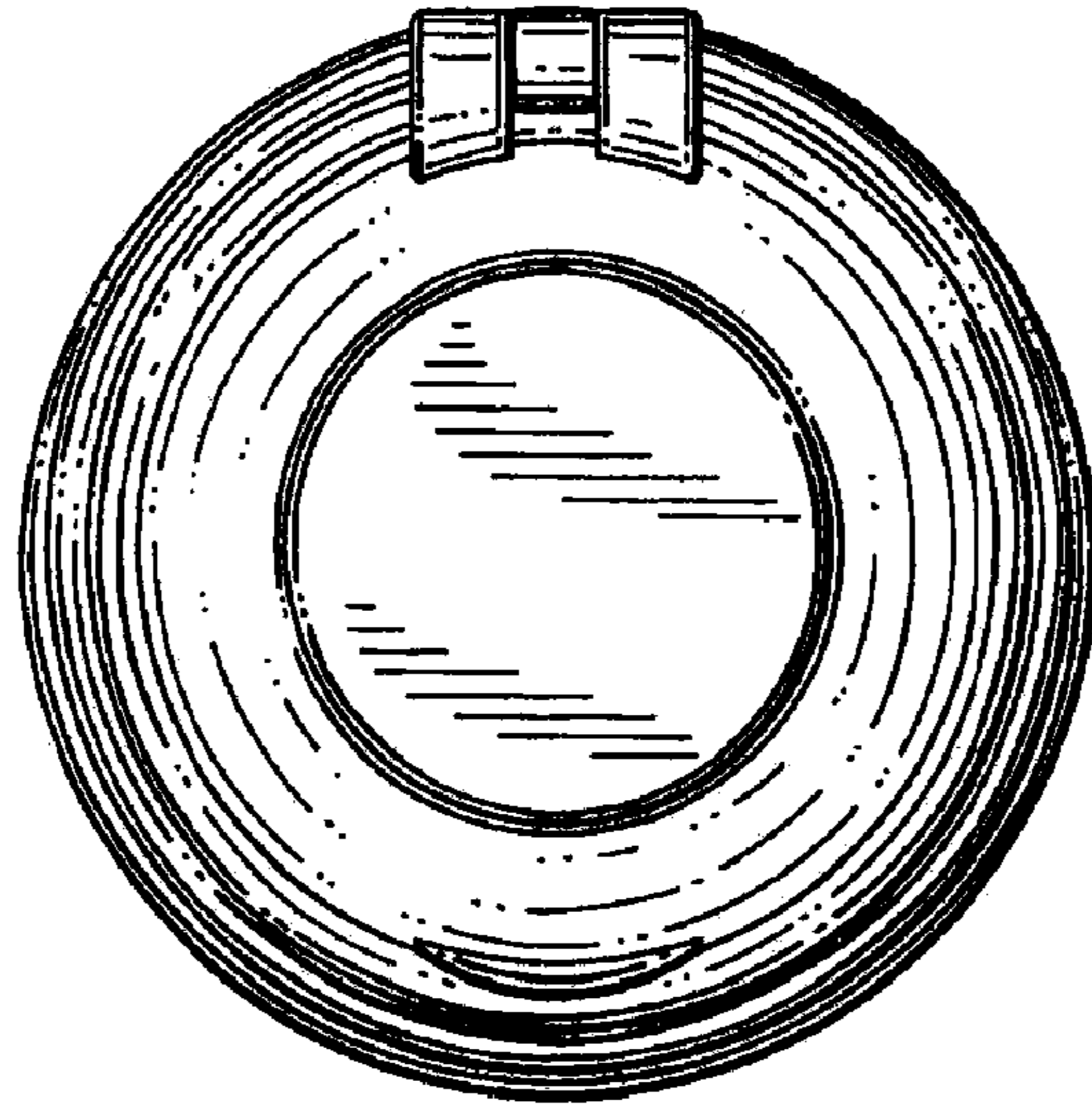

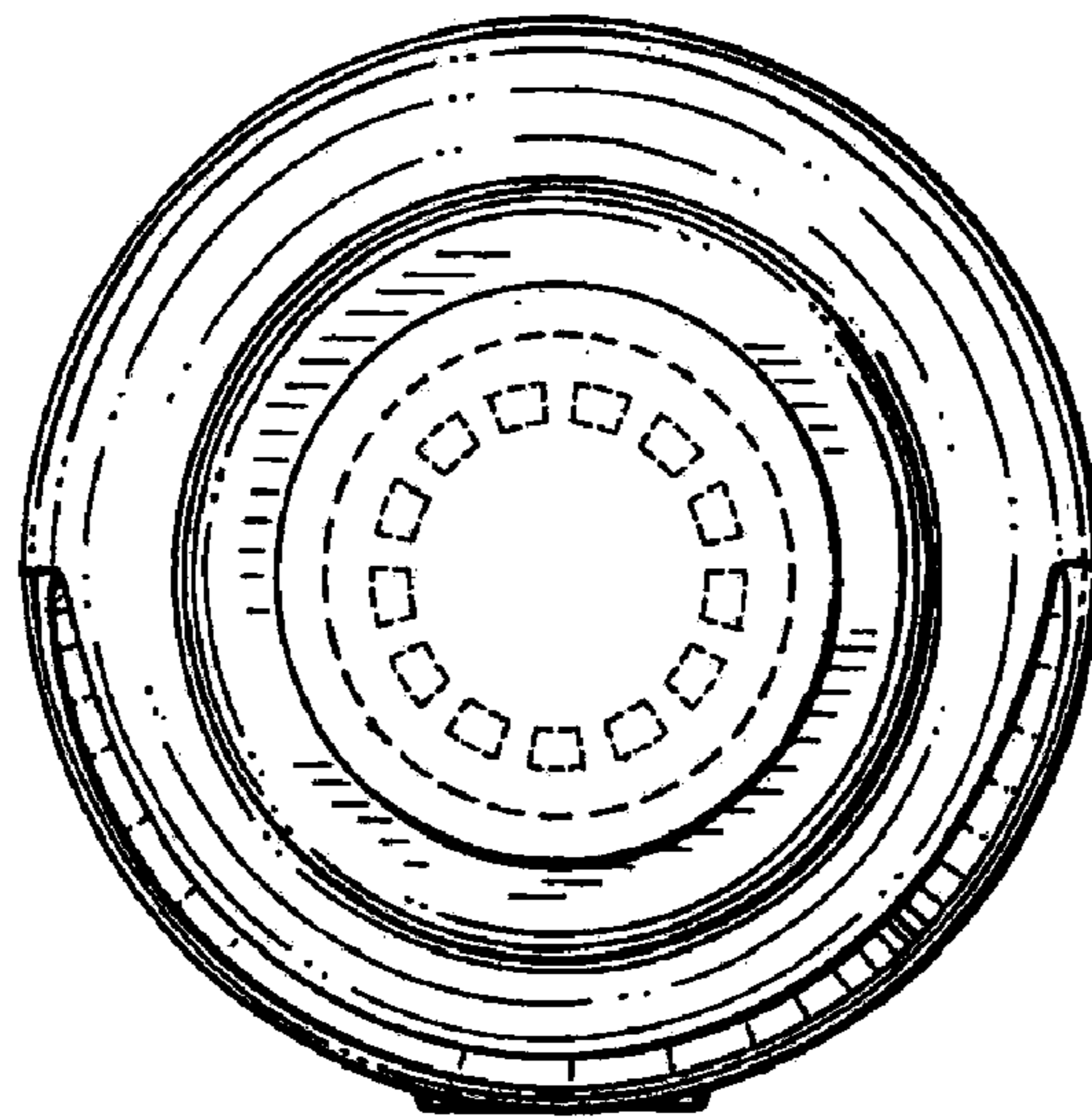

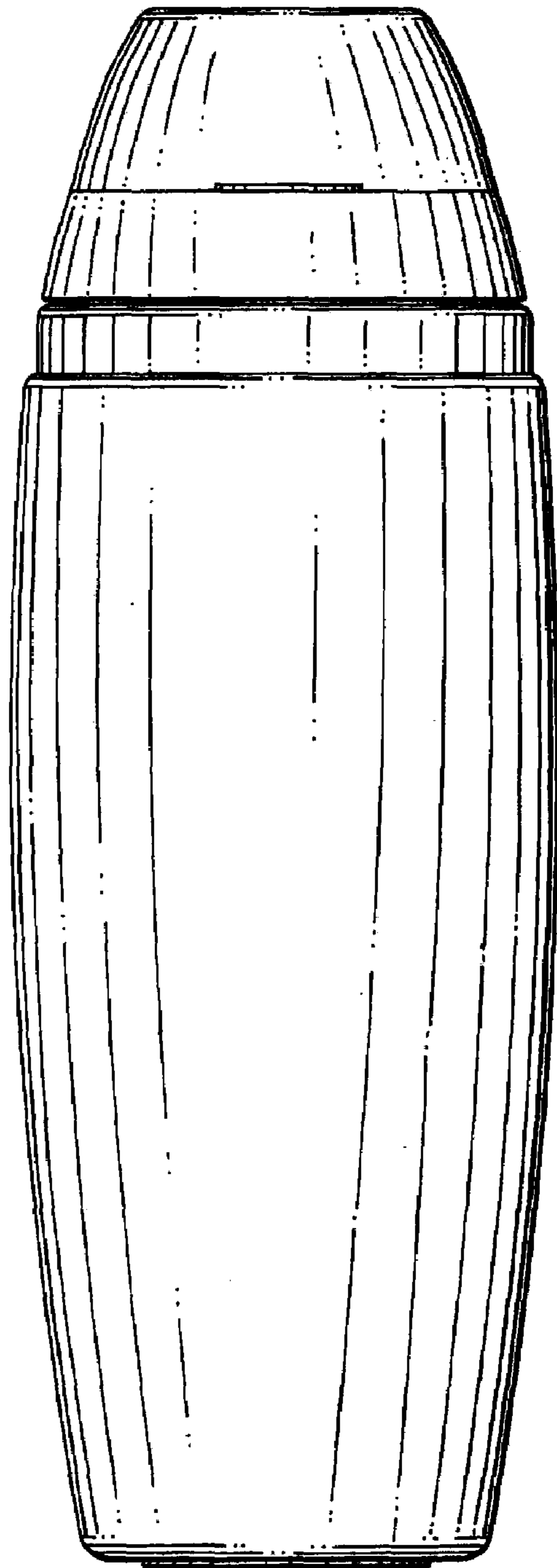

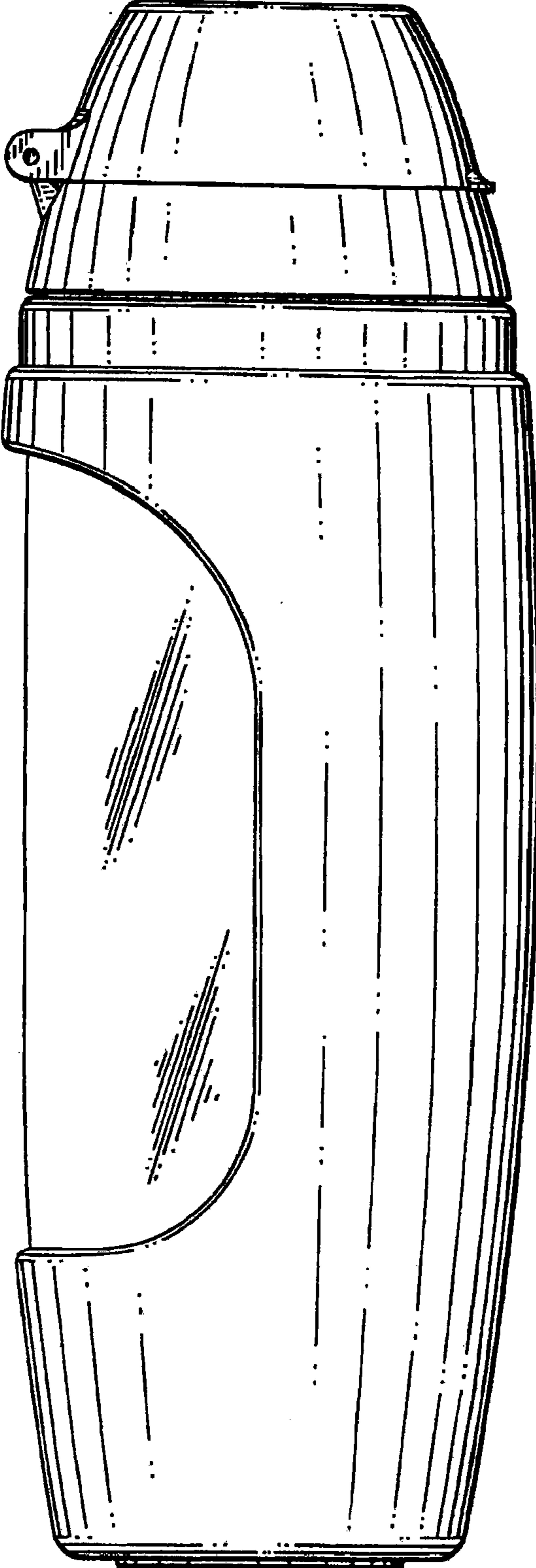

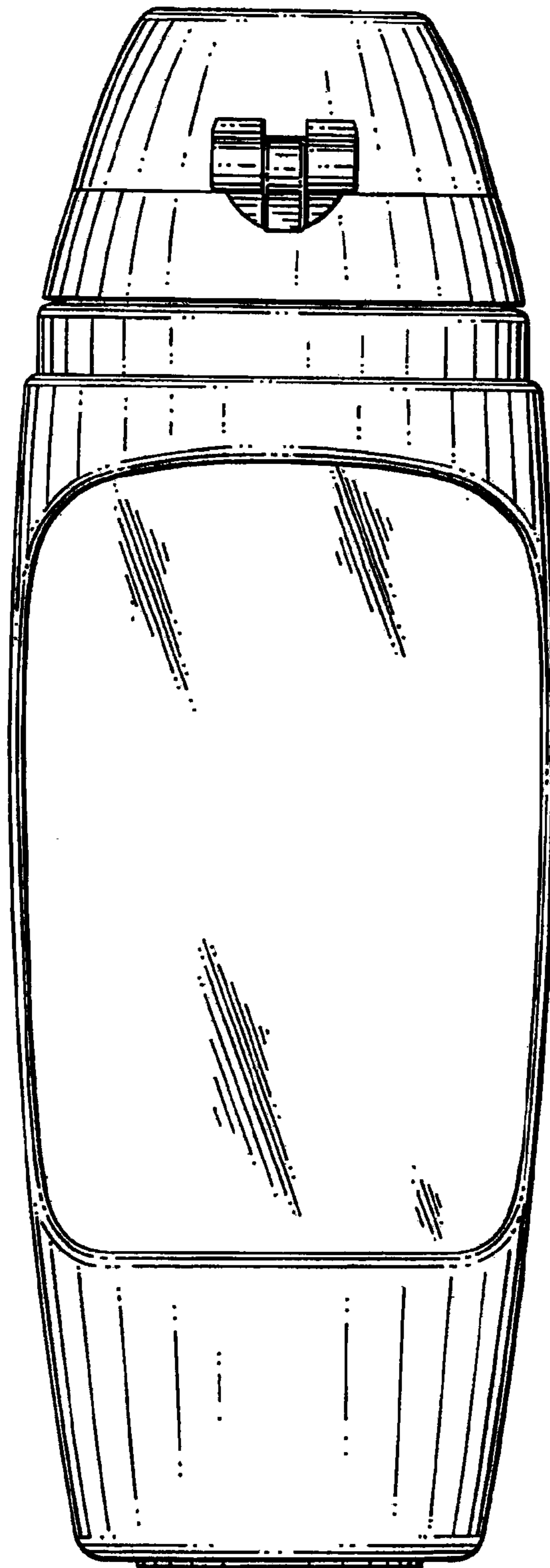

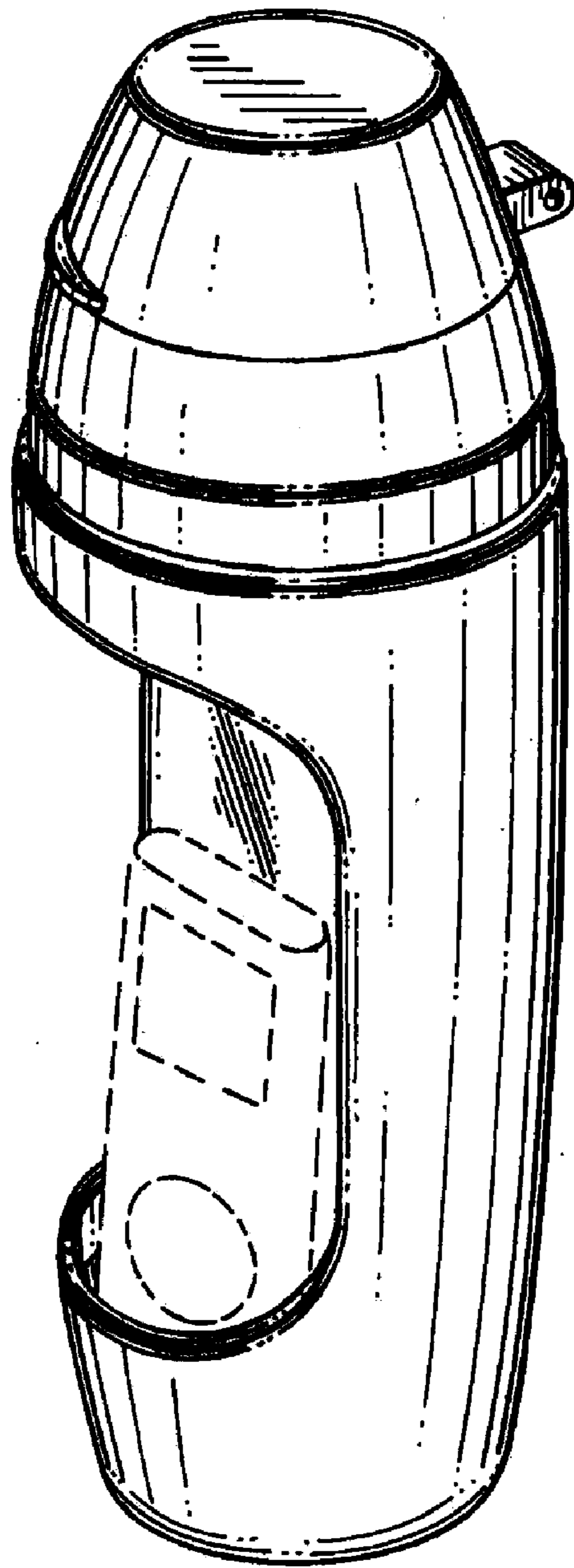

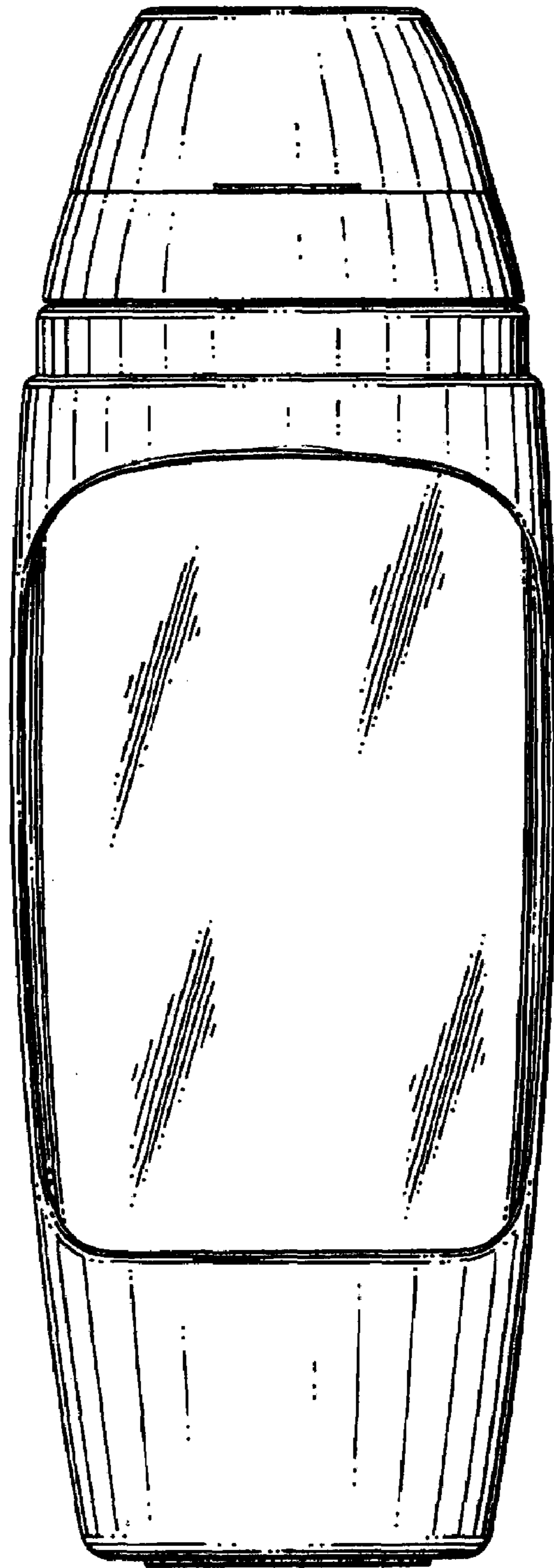

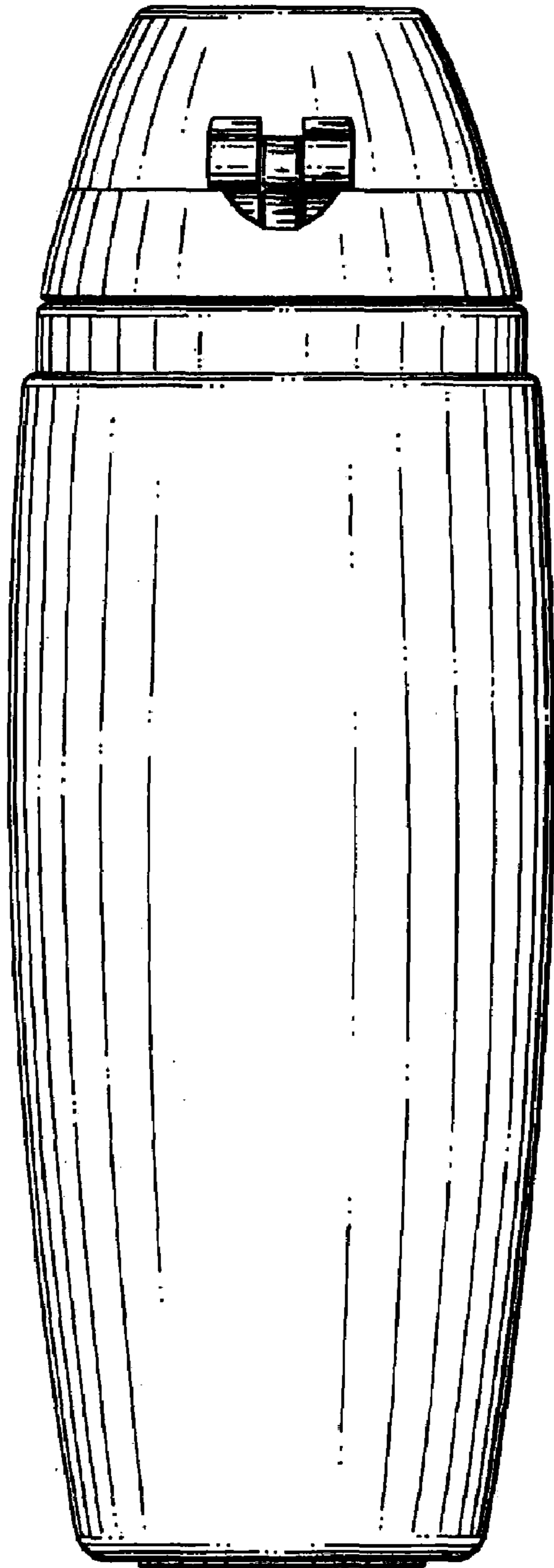

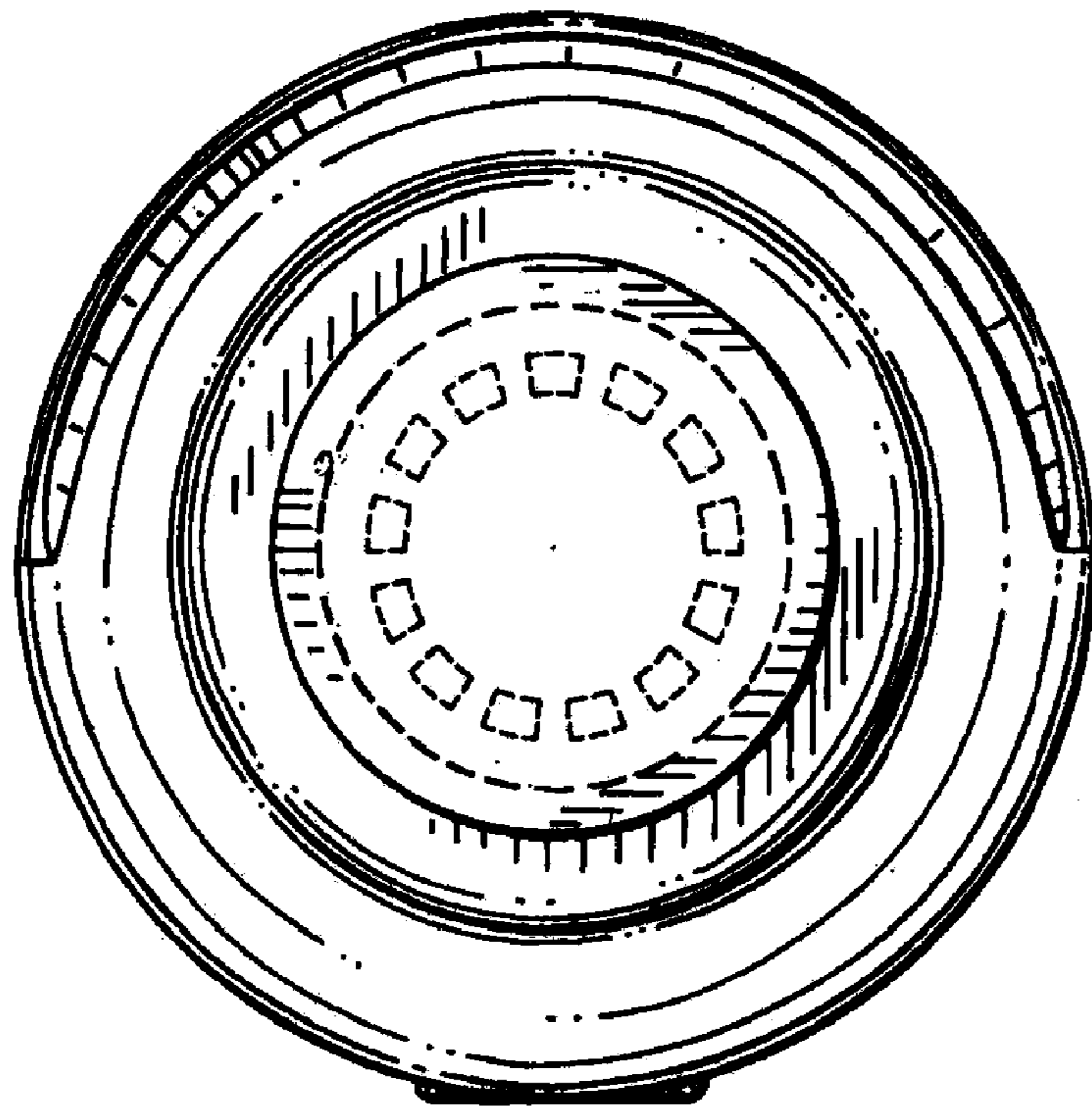
