(57) **CLAIM**

The ornamental design for a food and drink container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a food and drink container showing my new design;

FIG. 2 is a front elevational view of the food and drink container shown in FIG. 1;

FIG. 3 is a left side elevational view of the food and drink container shown in FIG. 1, the right side being a mirror image;

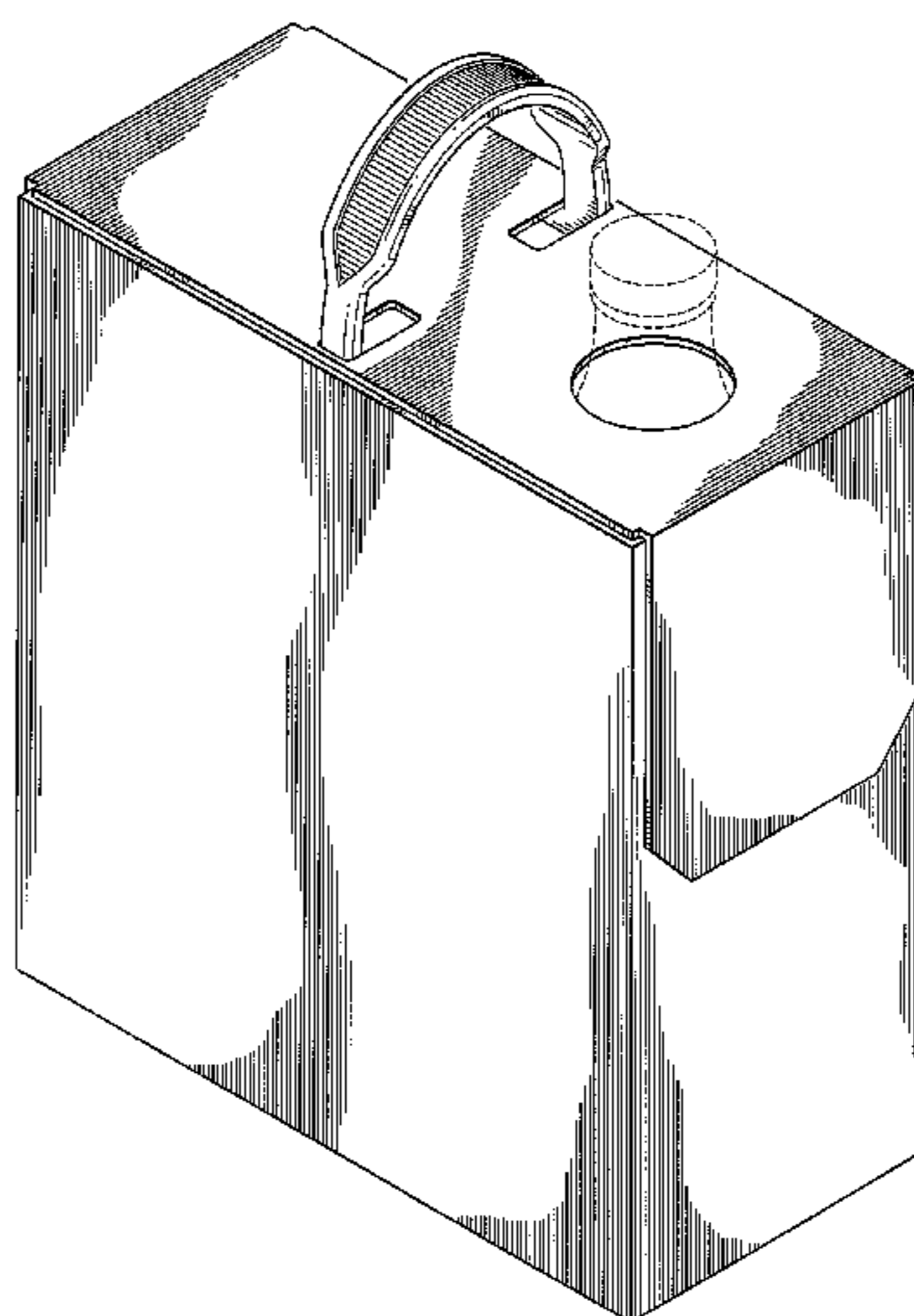
FIG. 4 is a rear elevational view of the food and drink container shown in FIG. 1; and,

FIG. 5 is a top plan view of the food and drink container shown in FIG. 1.

The portions of FIG. 1 shown in broken lines are for illustrative purposes only and form no part of the claimed design.

The bottom of the food and drink container is flat, unornamented, and forms no part of the claimed design.

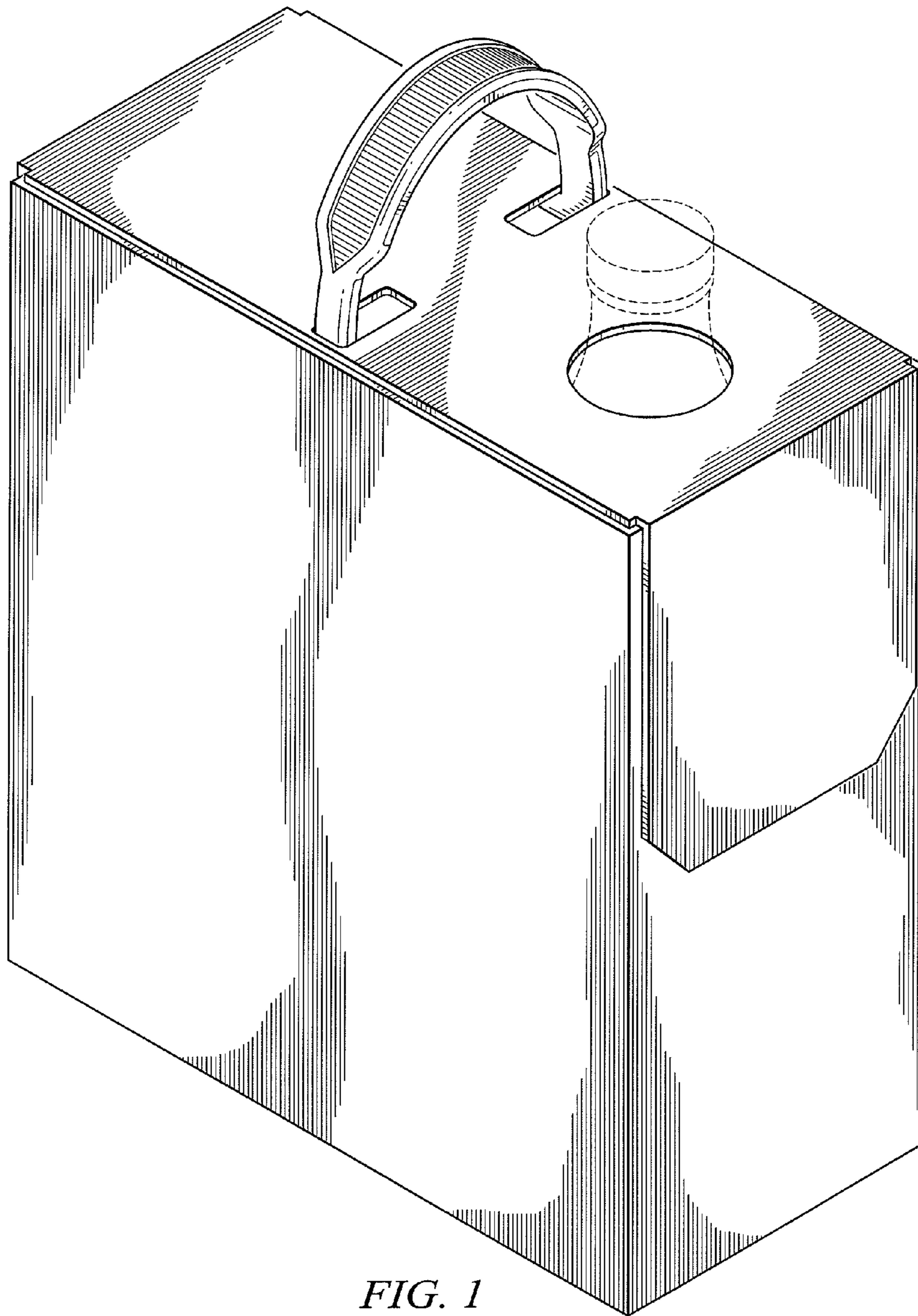
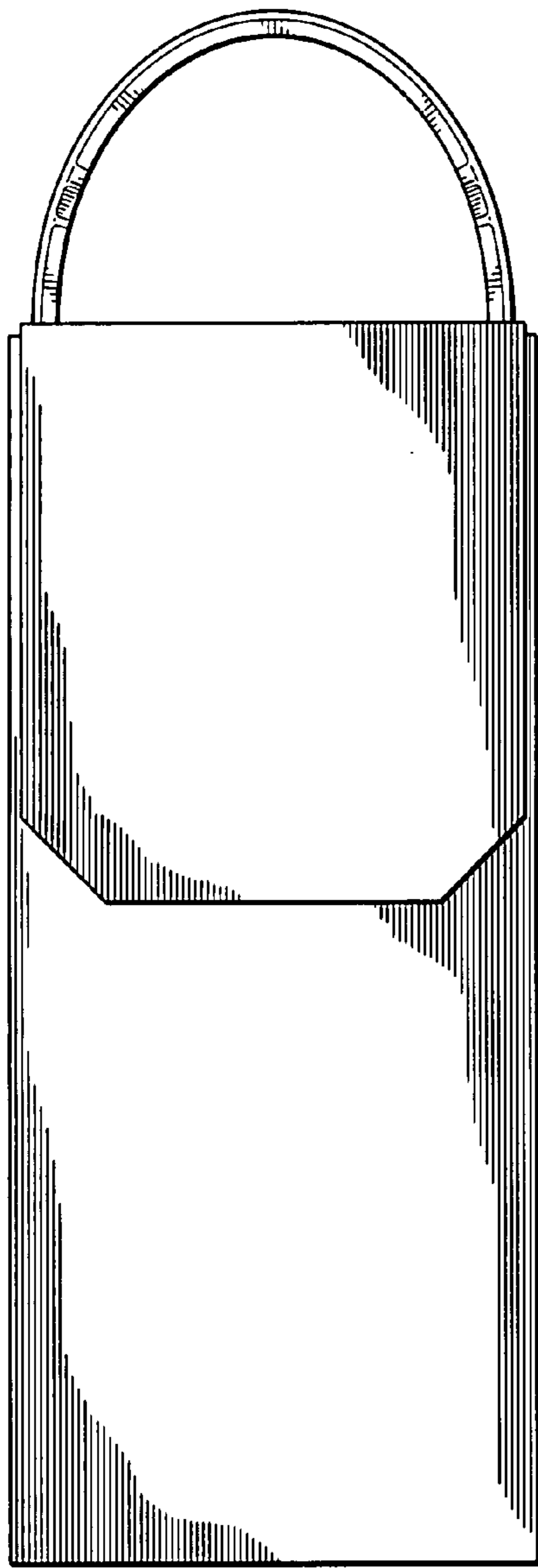
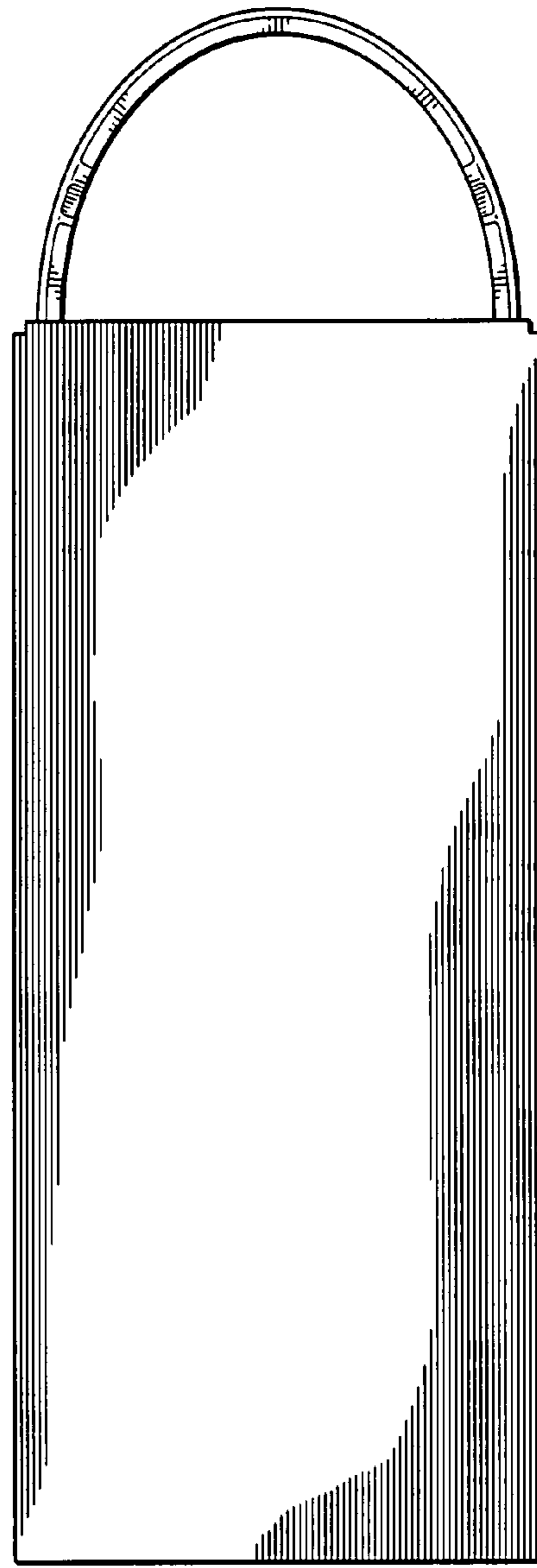

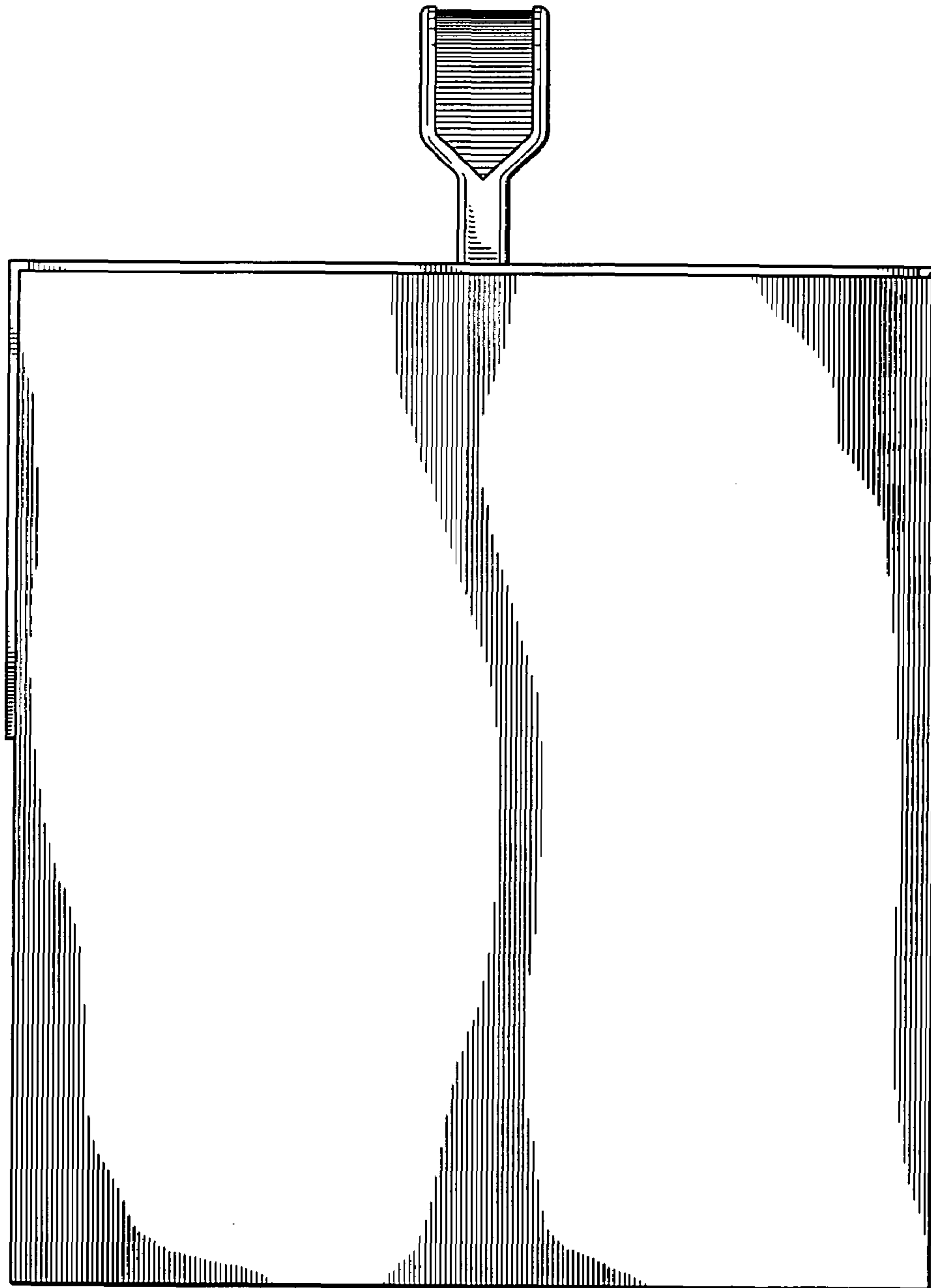
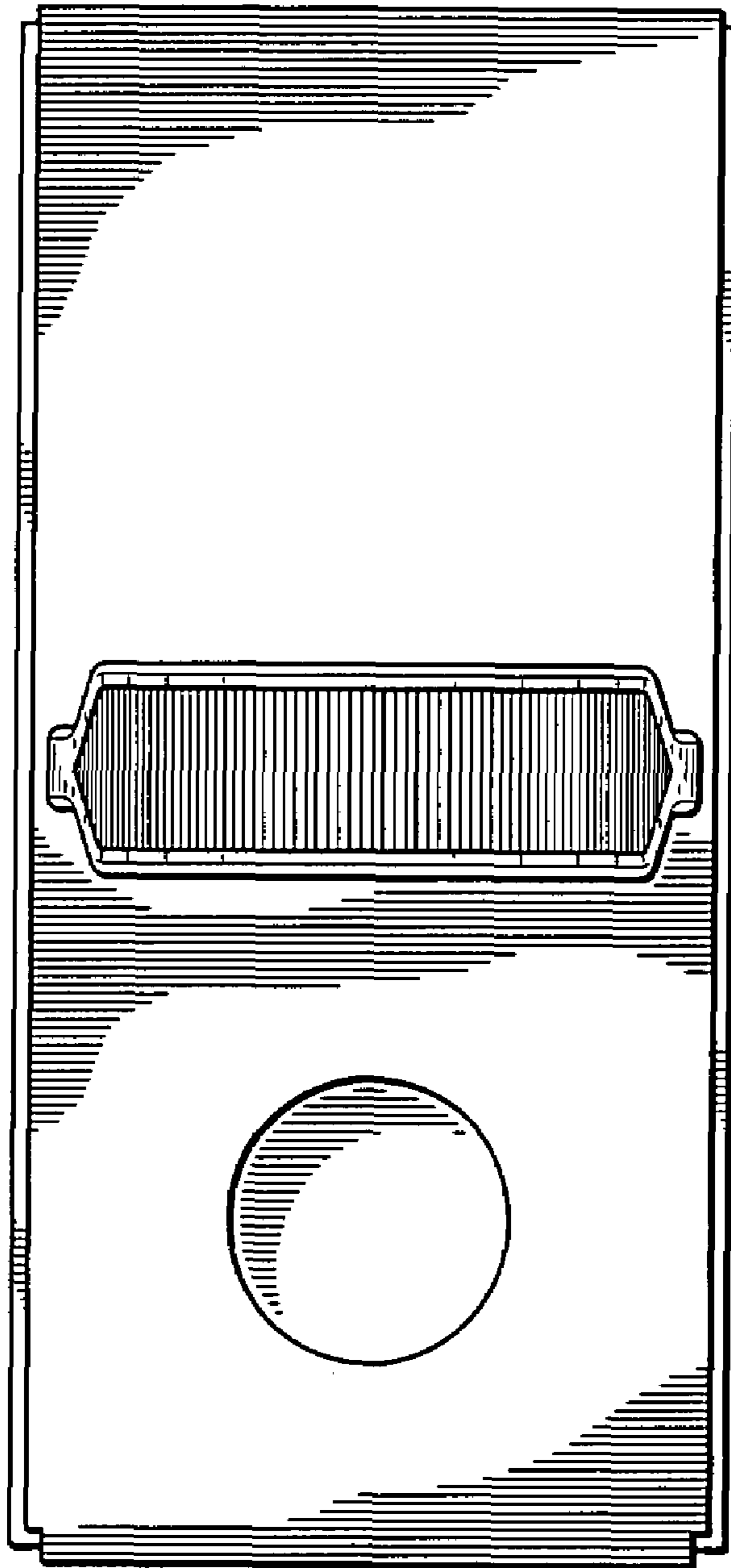
