(57) **CLAIM**

I hereby claim the ornamental design for a collapsible bottle,
as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view showing my new design for
a collapsible bottle in its fully erected position;

FIG. 2 is a top perspective view of FIG. 1;

FIG. 3 is a bottom perspective view of FIG. 1;

FIG. 4 is a side perspective view showing the design in a first
partially collapsed position;

FIG. 5 is a side perspective view showing the design in a fully
collapsed position; and,

FIG. 6 is a side perspective view showing the design in a
second partially collapsed position.
