FIG. 7 is a front view of the insert only, shown without the pendant for ease of illustration;

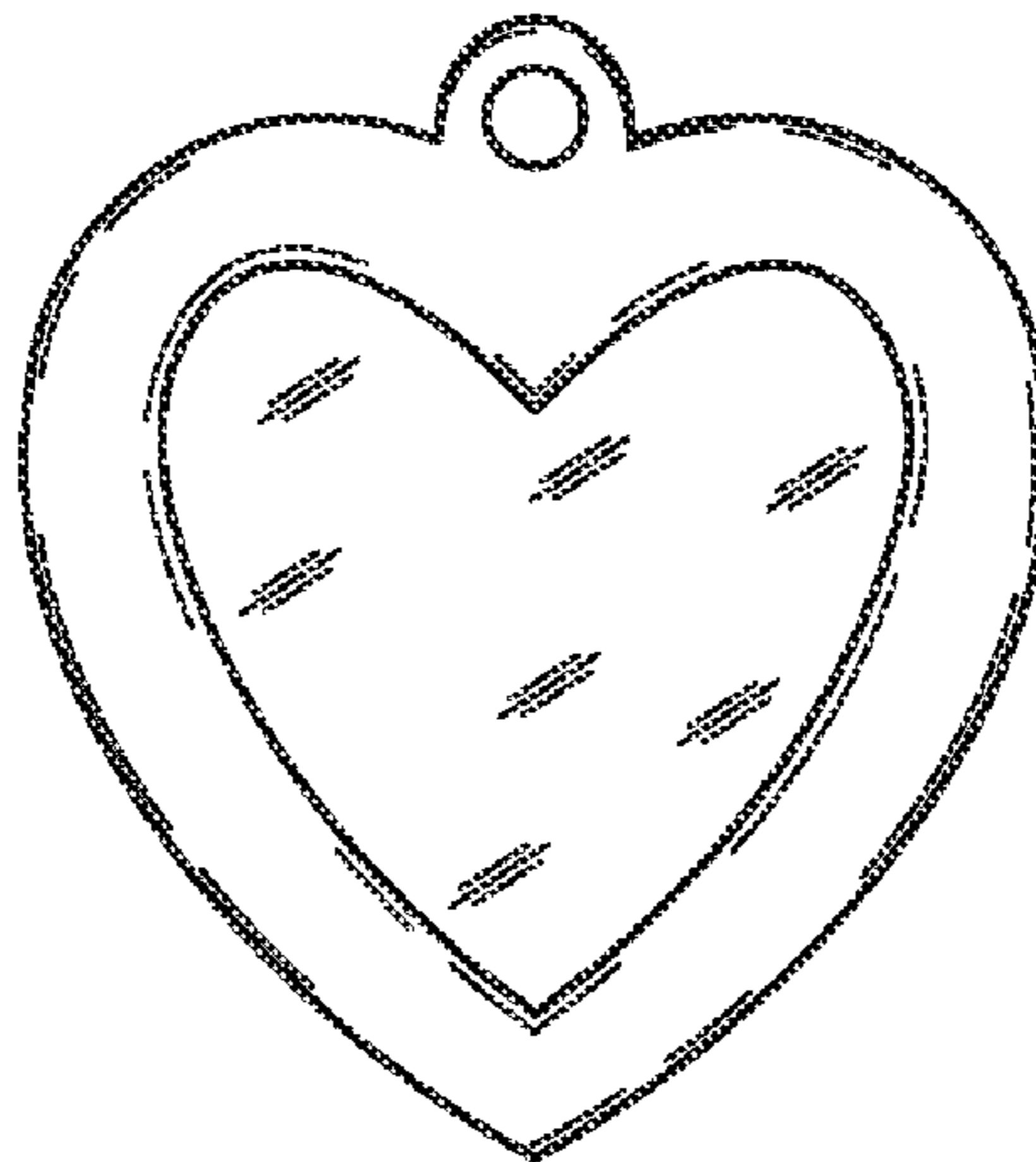
FIG. 8 is a top view of FIG. 7;

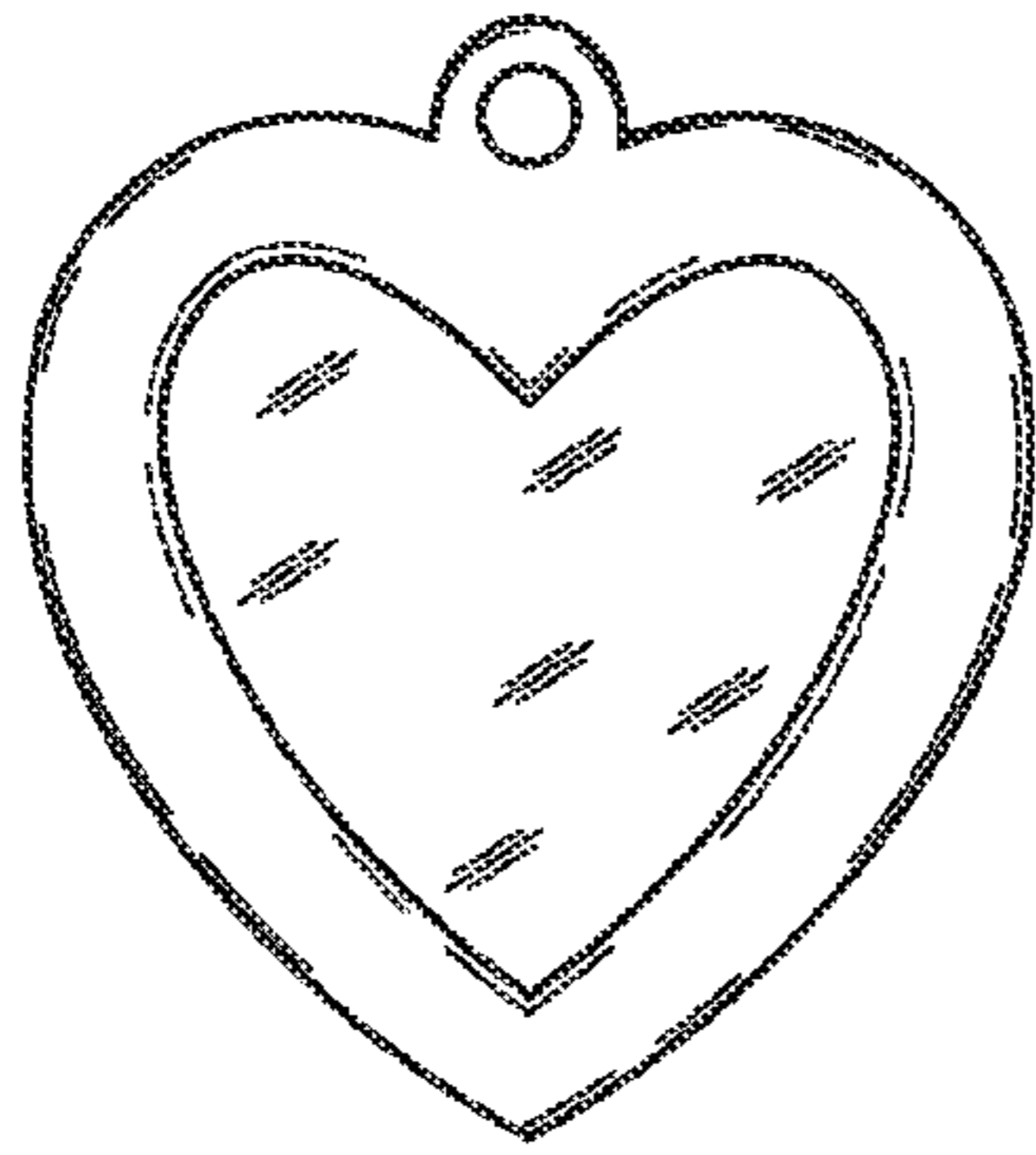

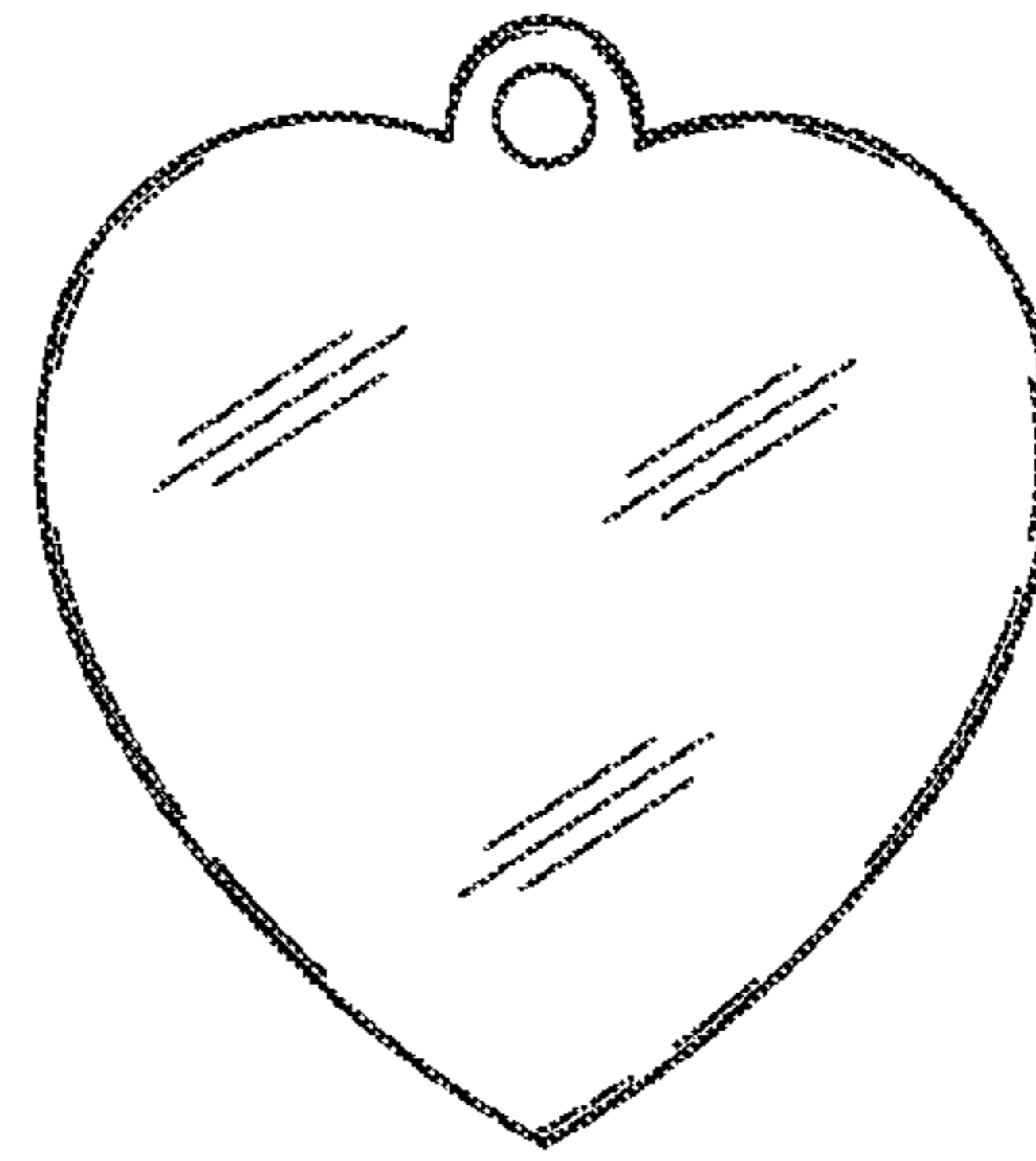

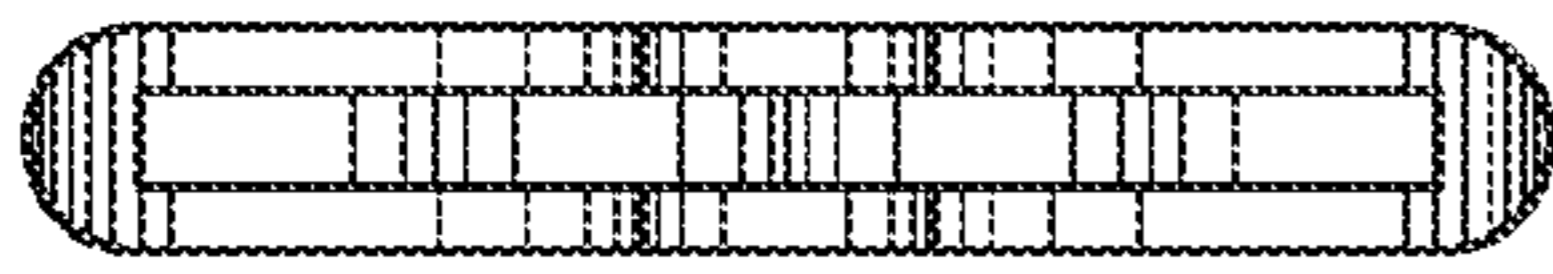

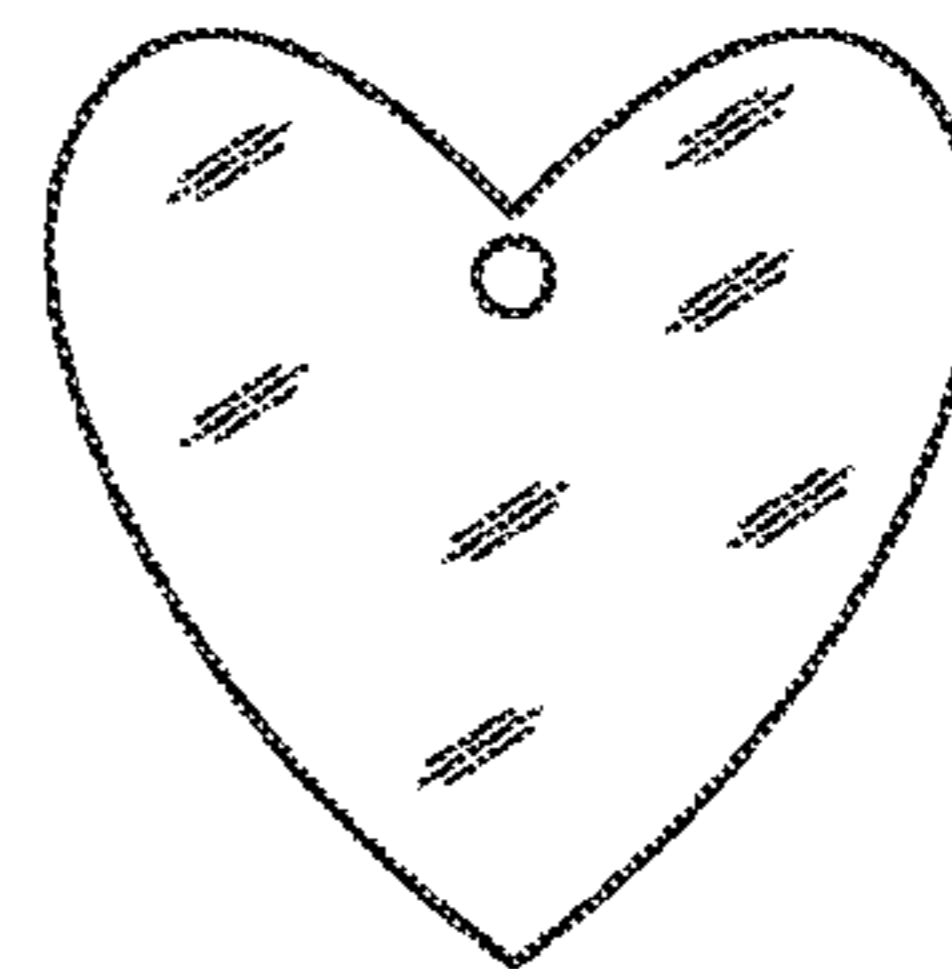

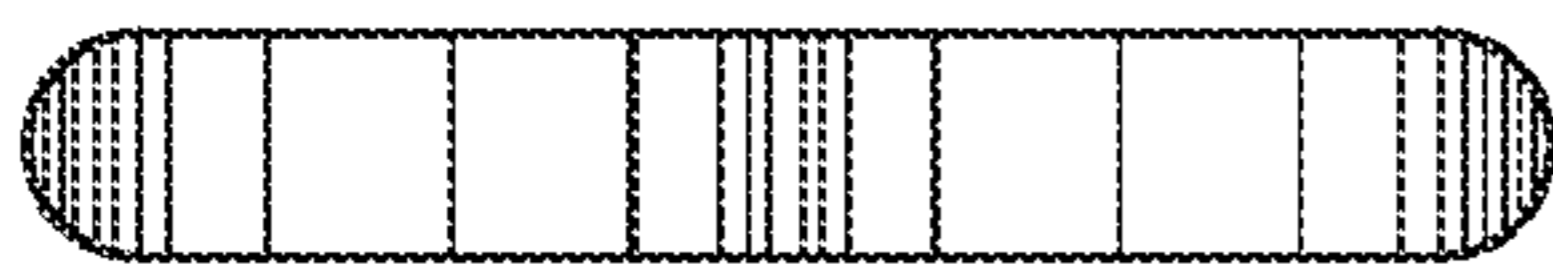

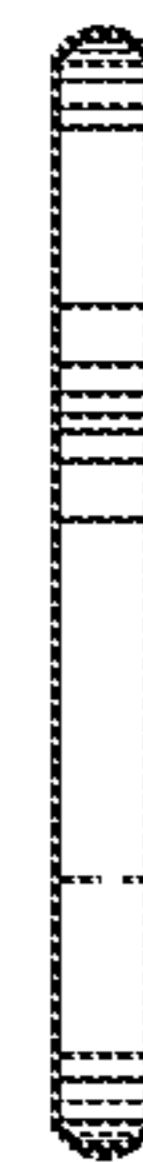
