FIG. 1 is a perspective view of a pedal cover for a truck showing my new design;

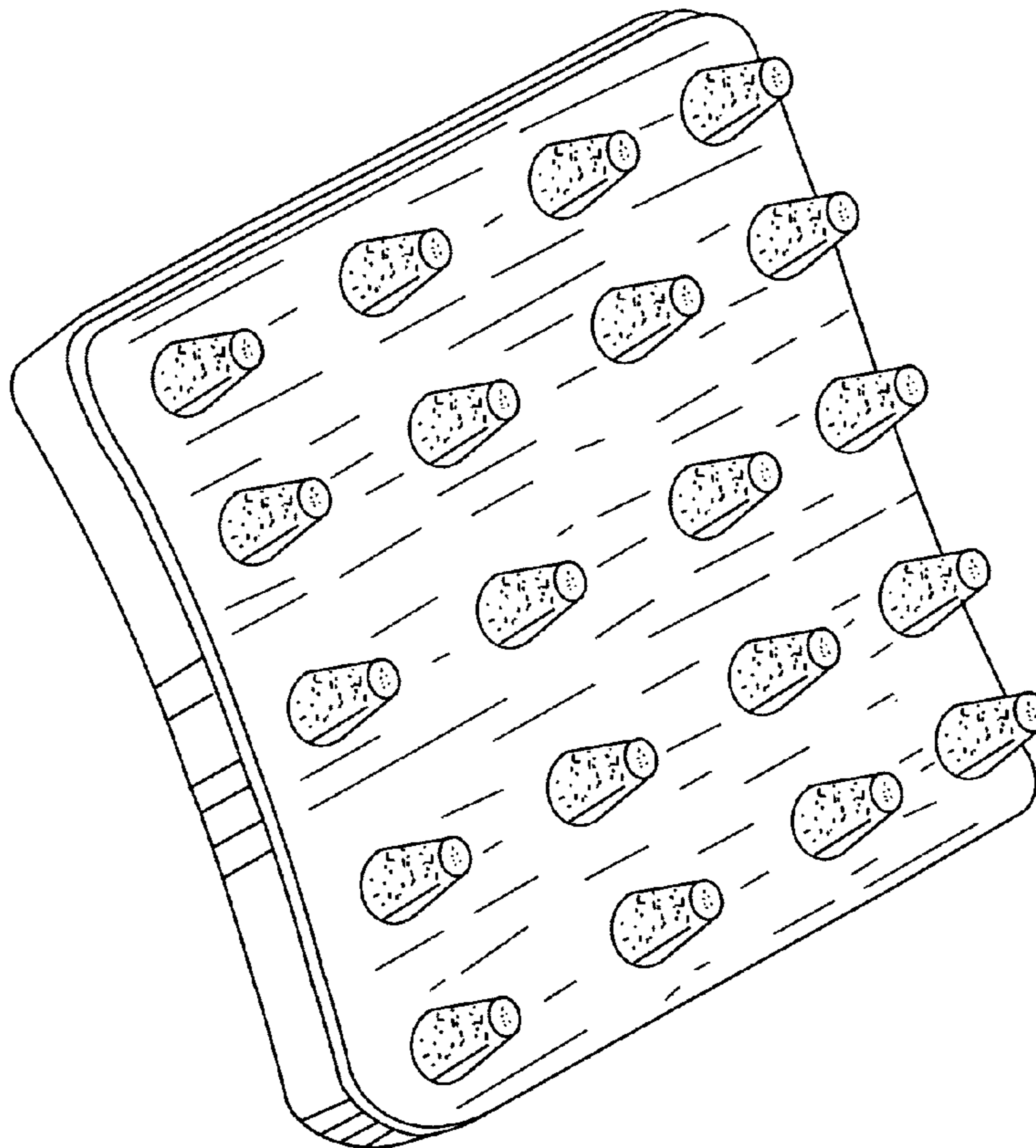
FIG. 2 is a top perspective view thereof, shown in a reduced scale;

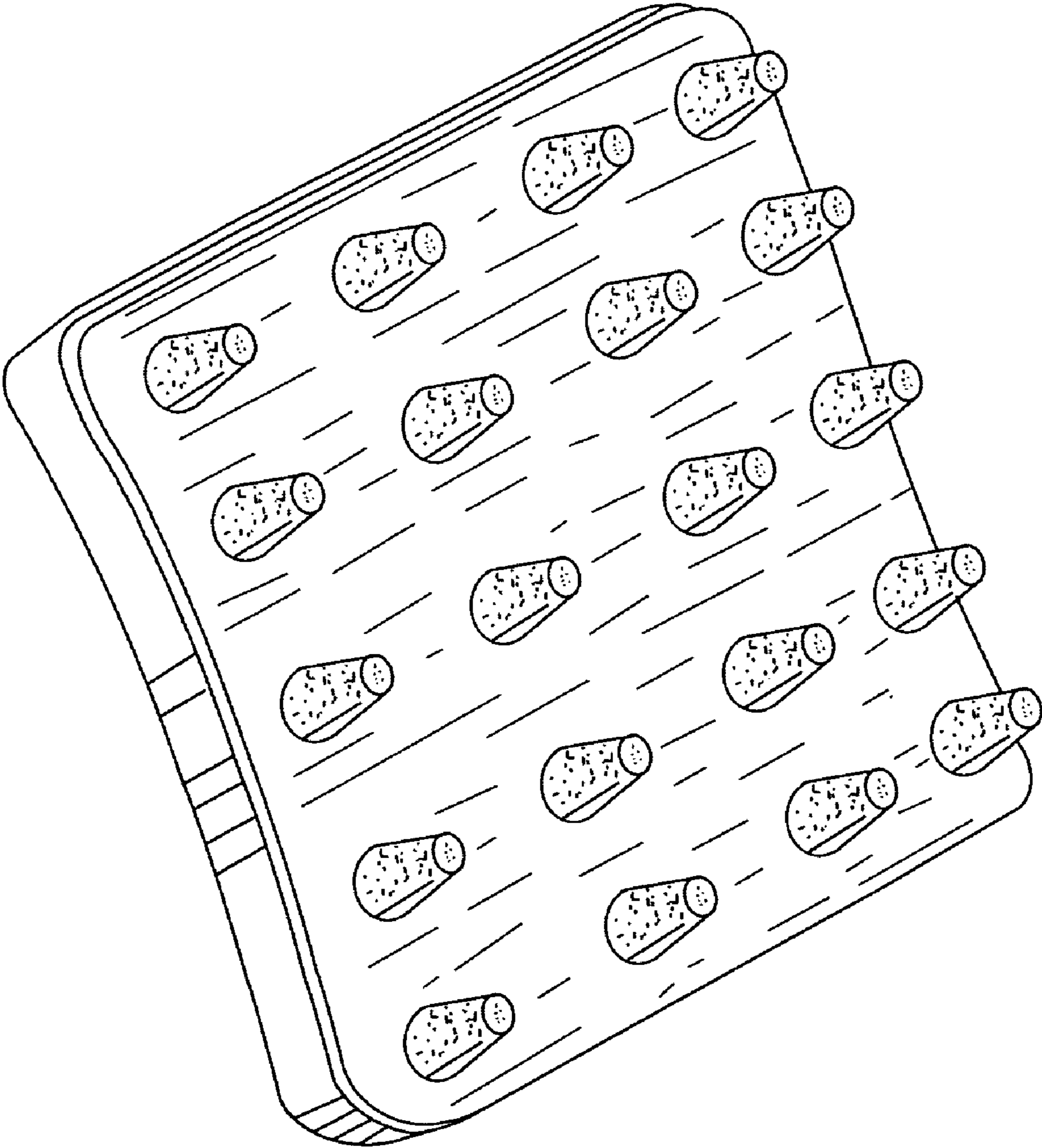

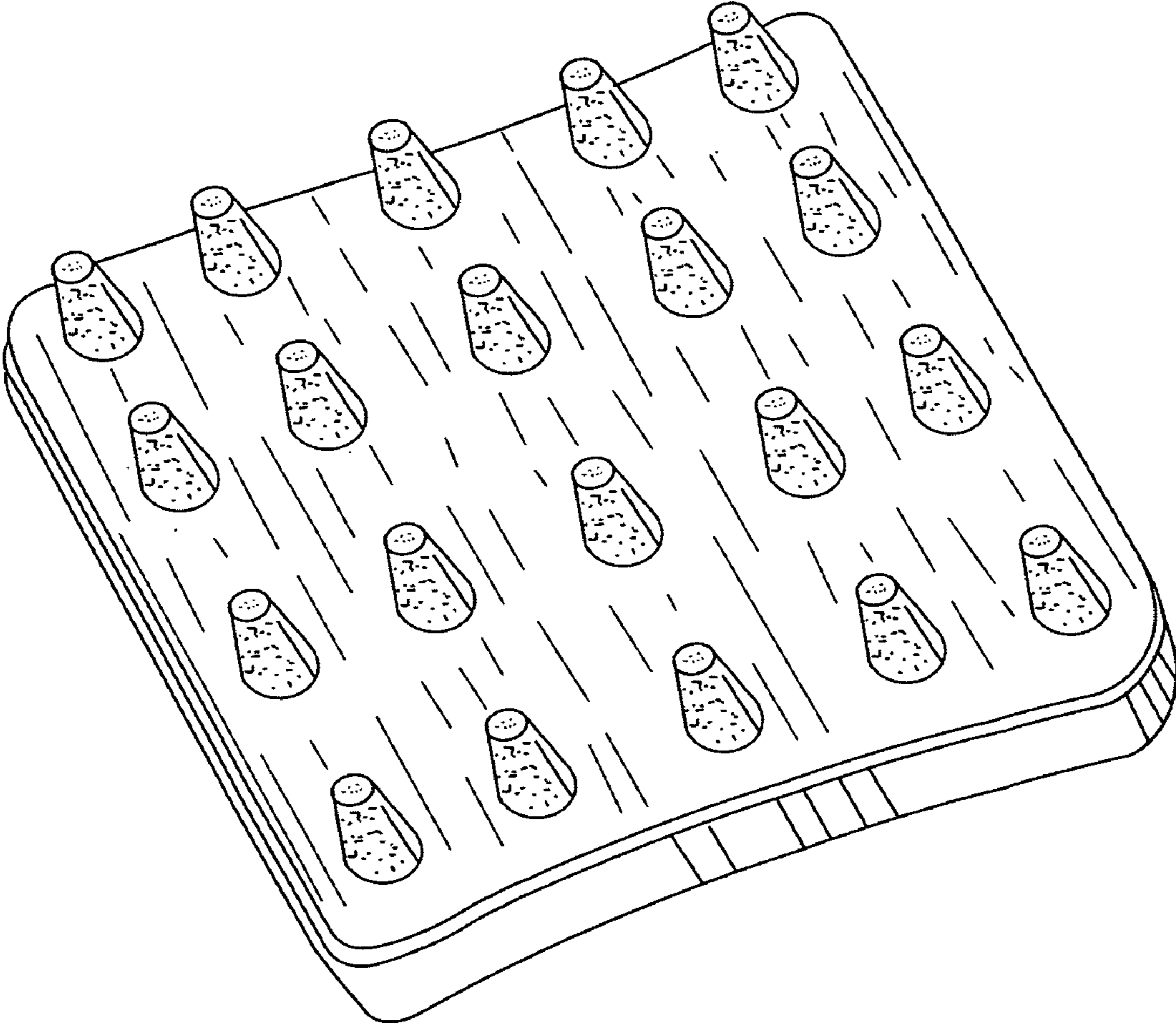

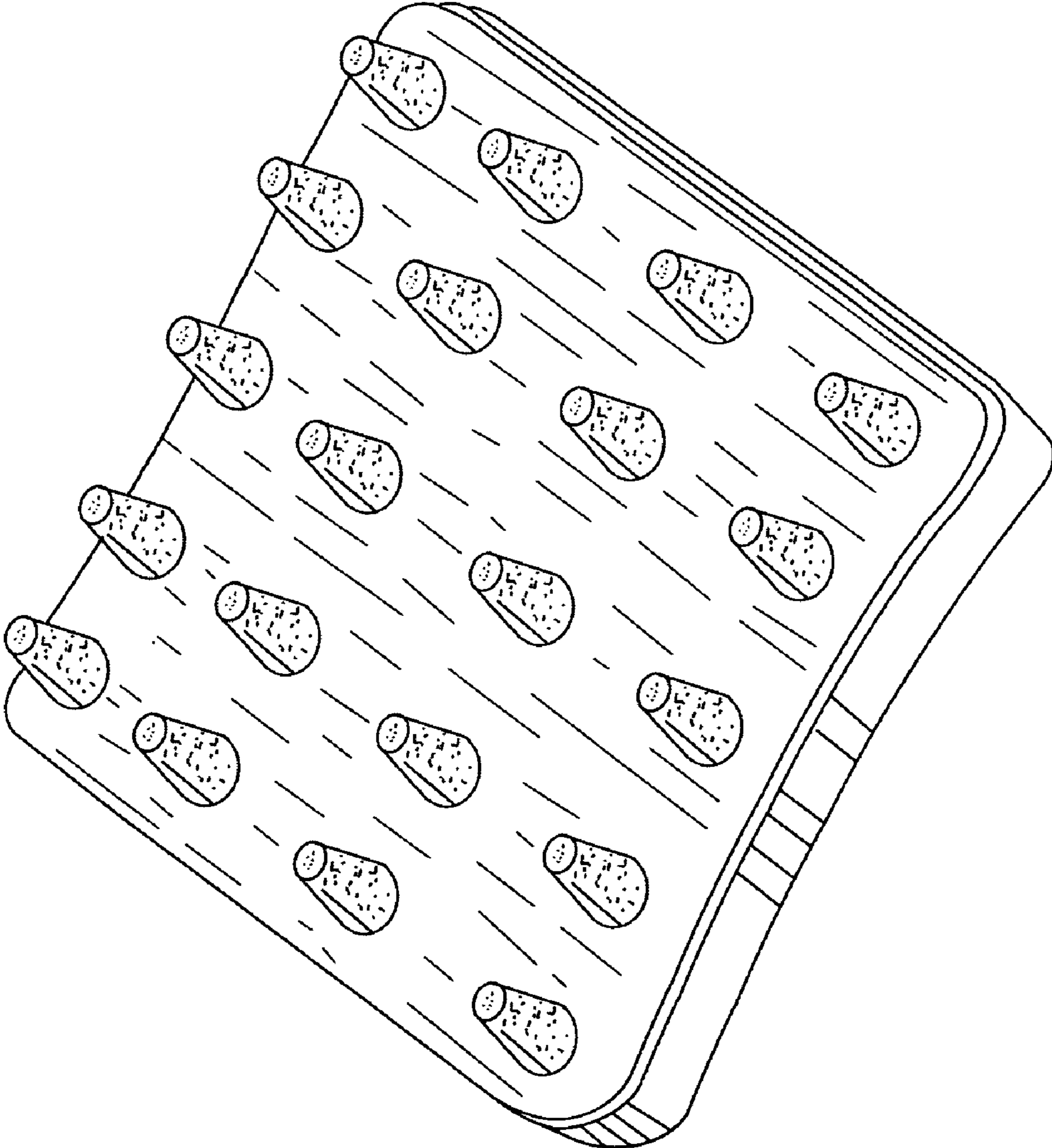

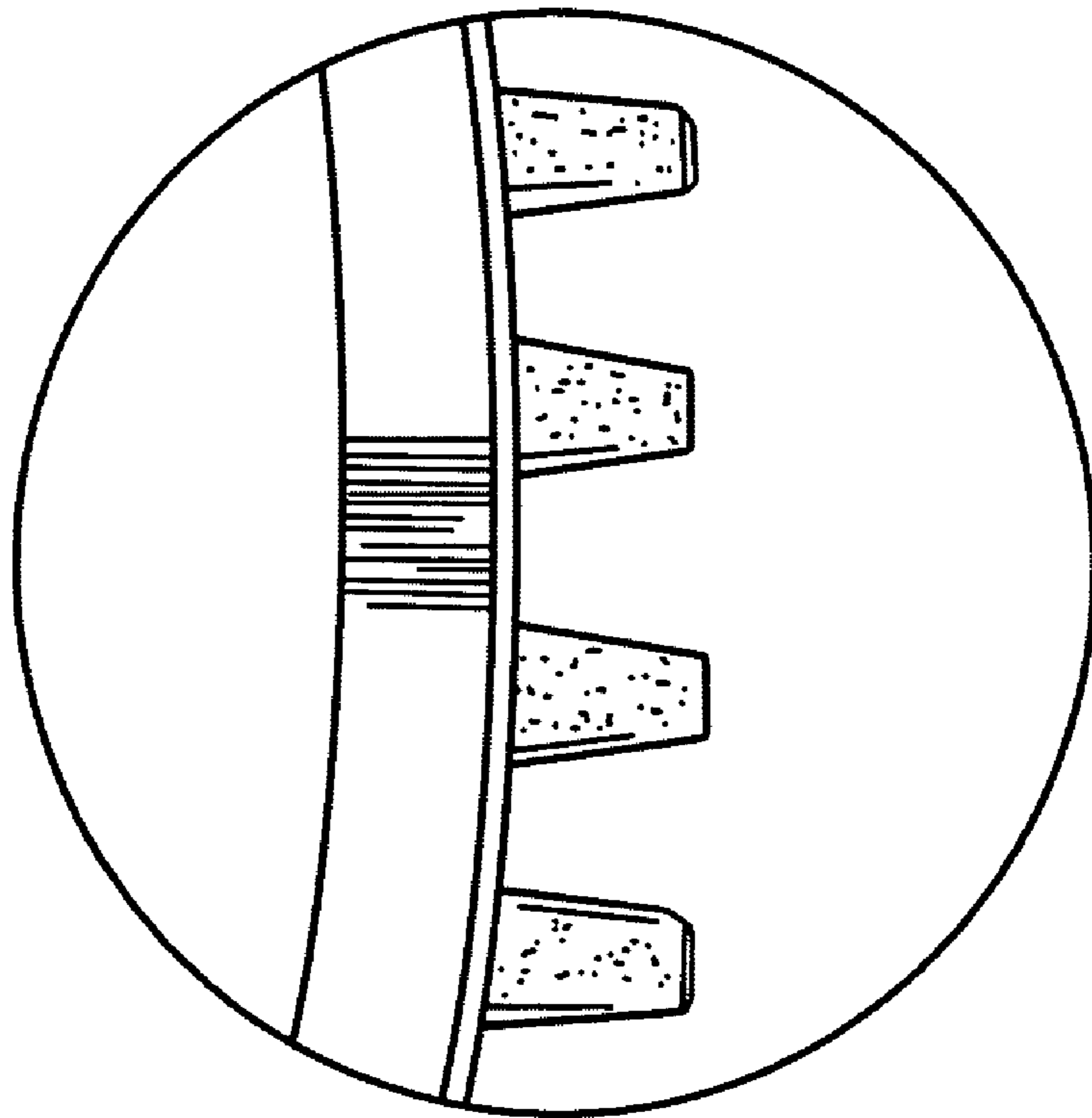

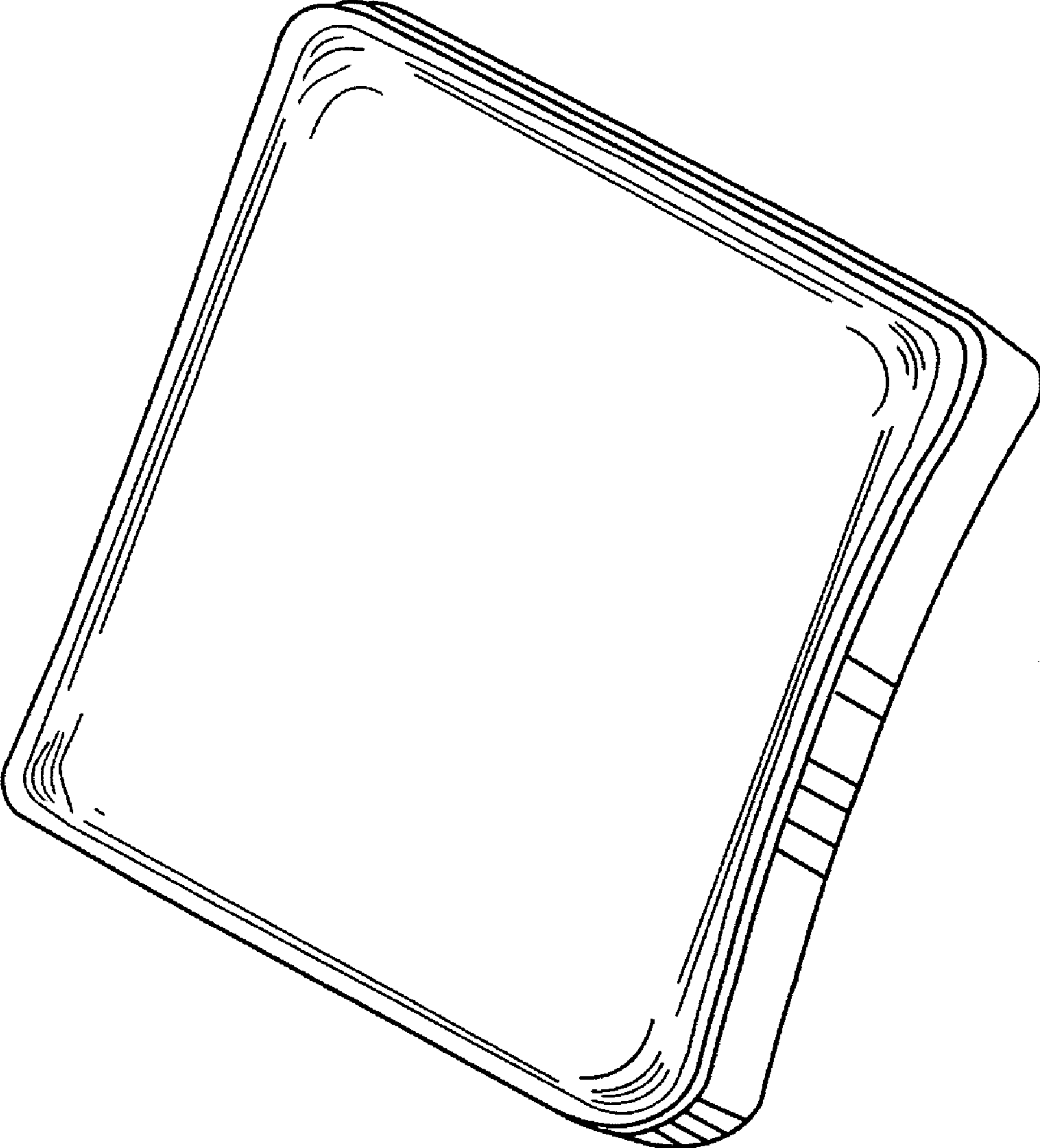
