(57) **CLAIM**

The ornamental design for an exterior vehicle mirror assembly, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the exterior vehicle mirror assembly design;

FIG. 2 is a rear perspective view of the exterior vehicle mirror assembly design;

FIG. 3 is a front elevation view of the exterior vehicle mirror assembly design;

FIG. 4 is a rear elevation view of the exterior vehicle mirror assembly design;

FIG. 5 is a right side elevation view of the exterior vehicle mirror assembly design;

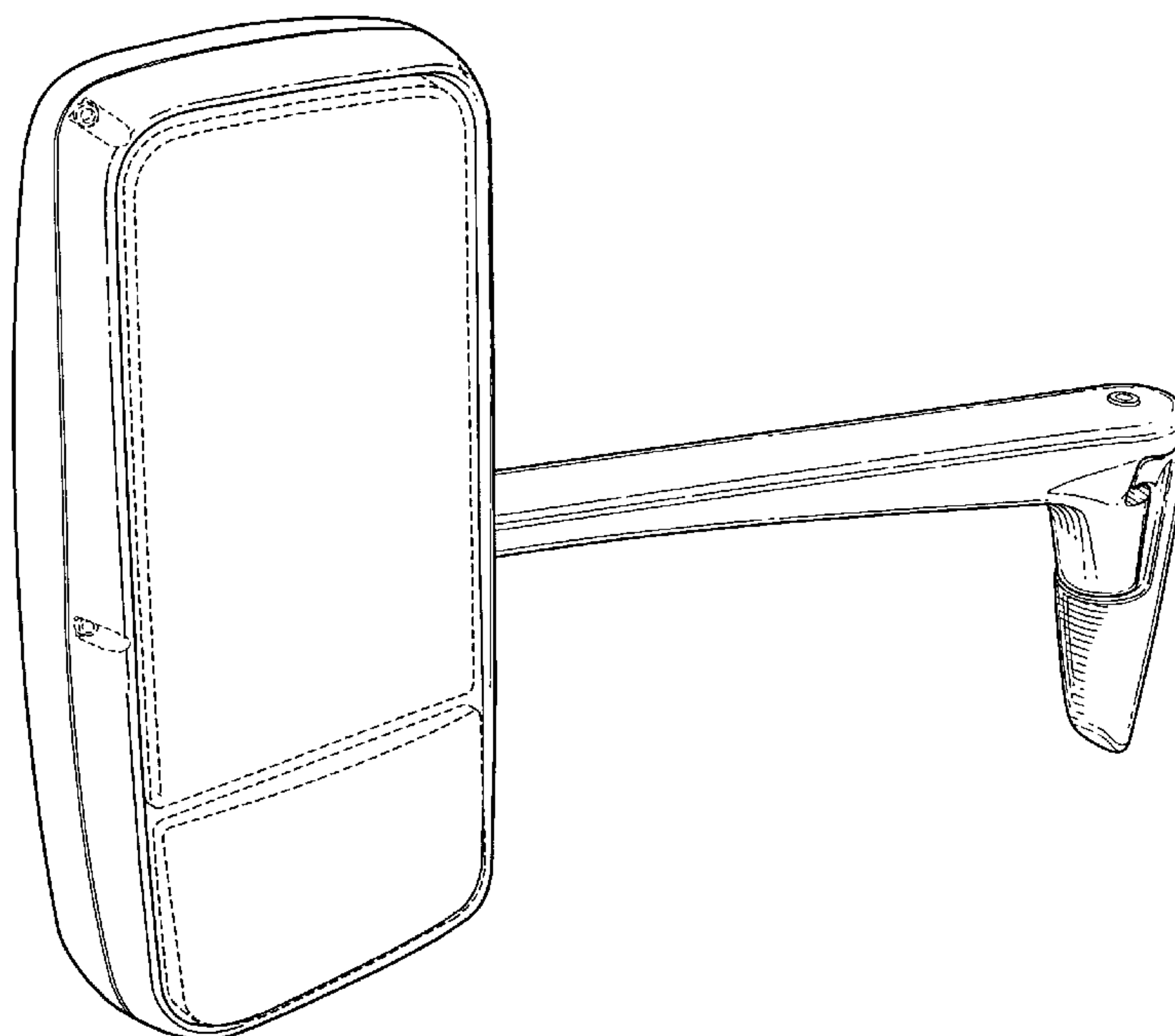
FIG. 6 is a left side elevation view of the exterior vehicle mirror assembly design;

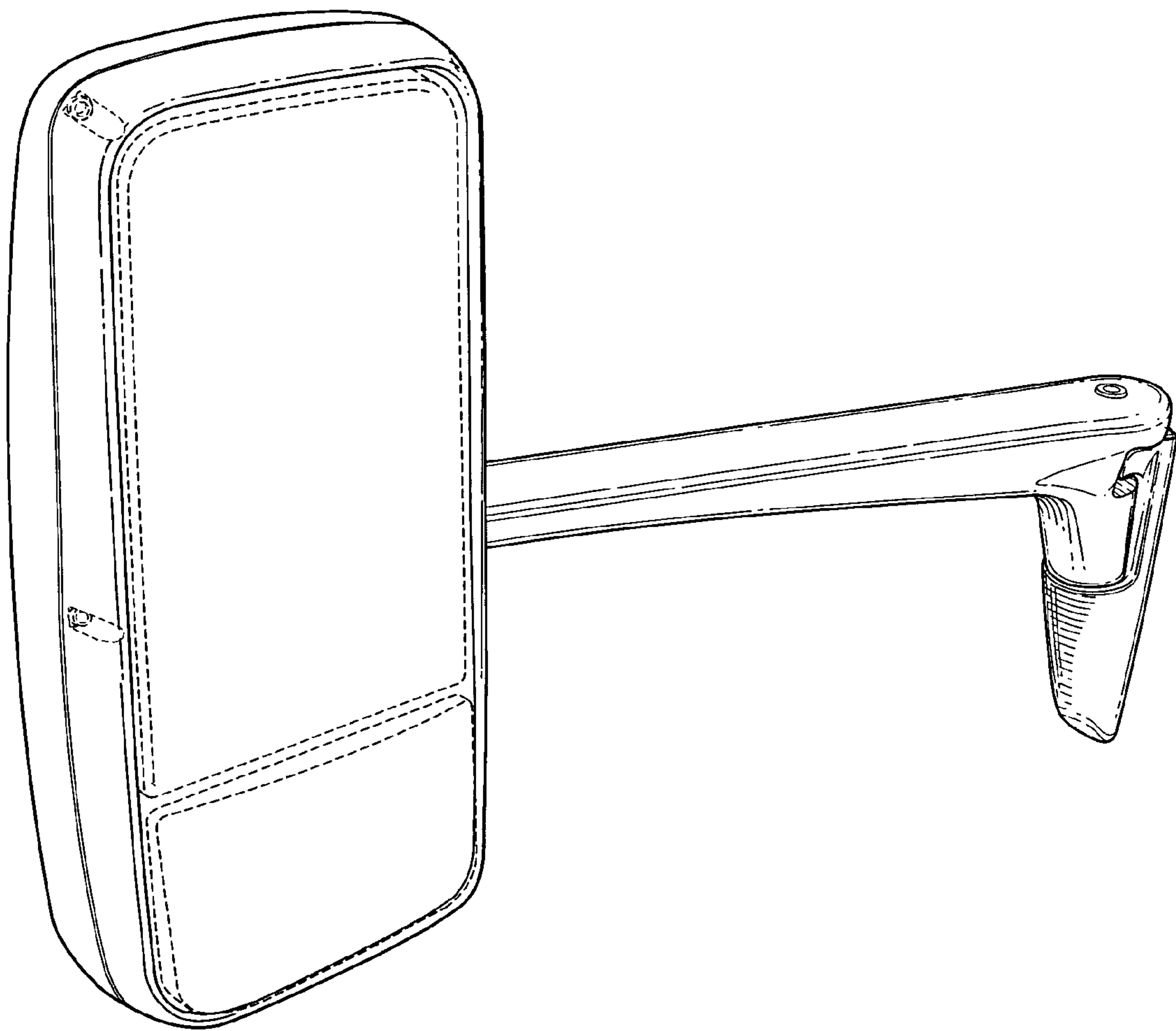

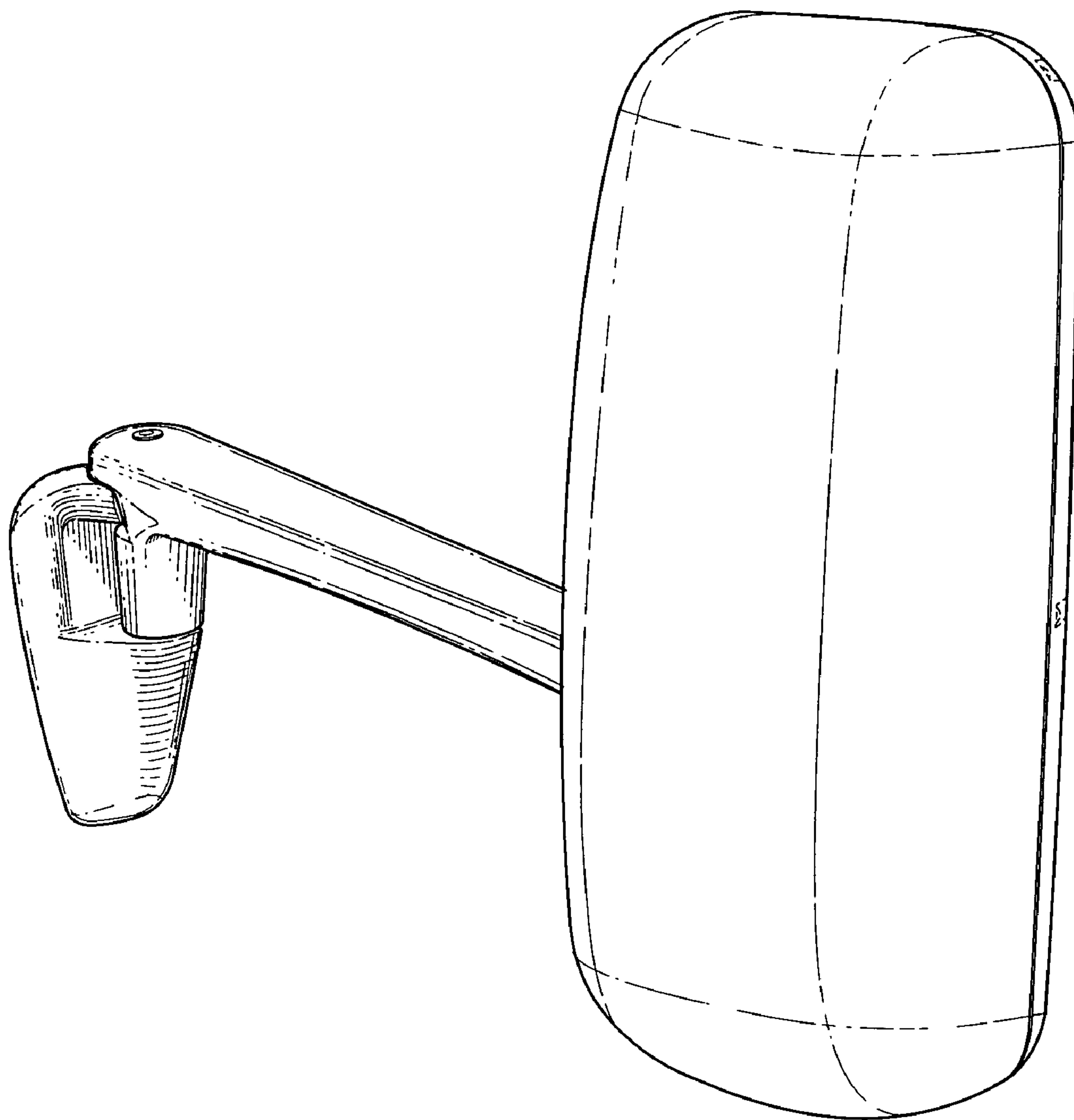

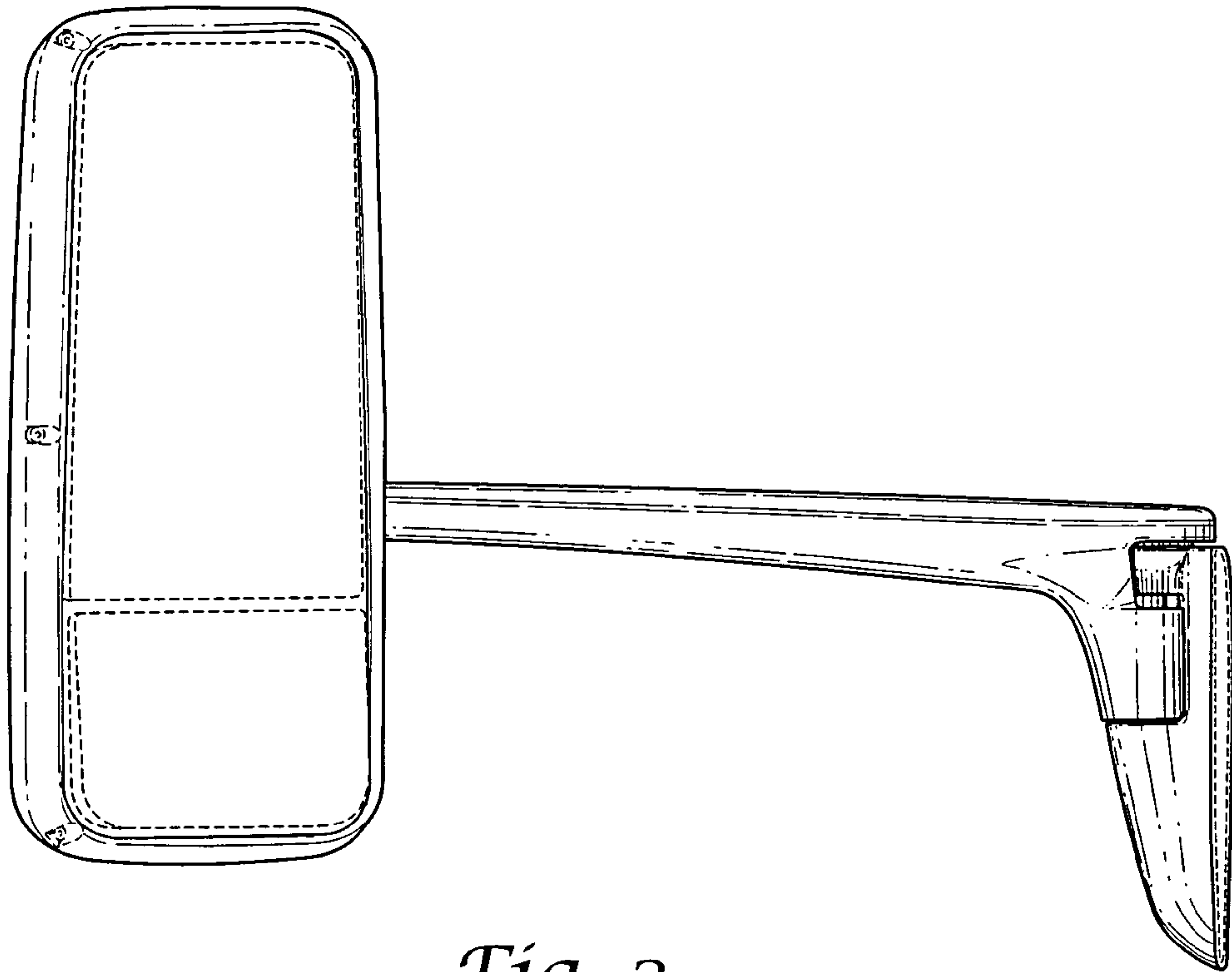

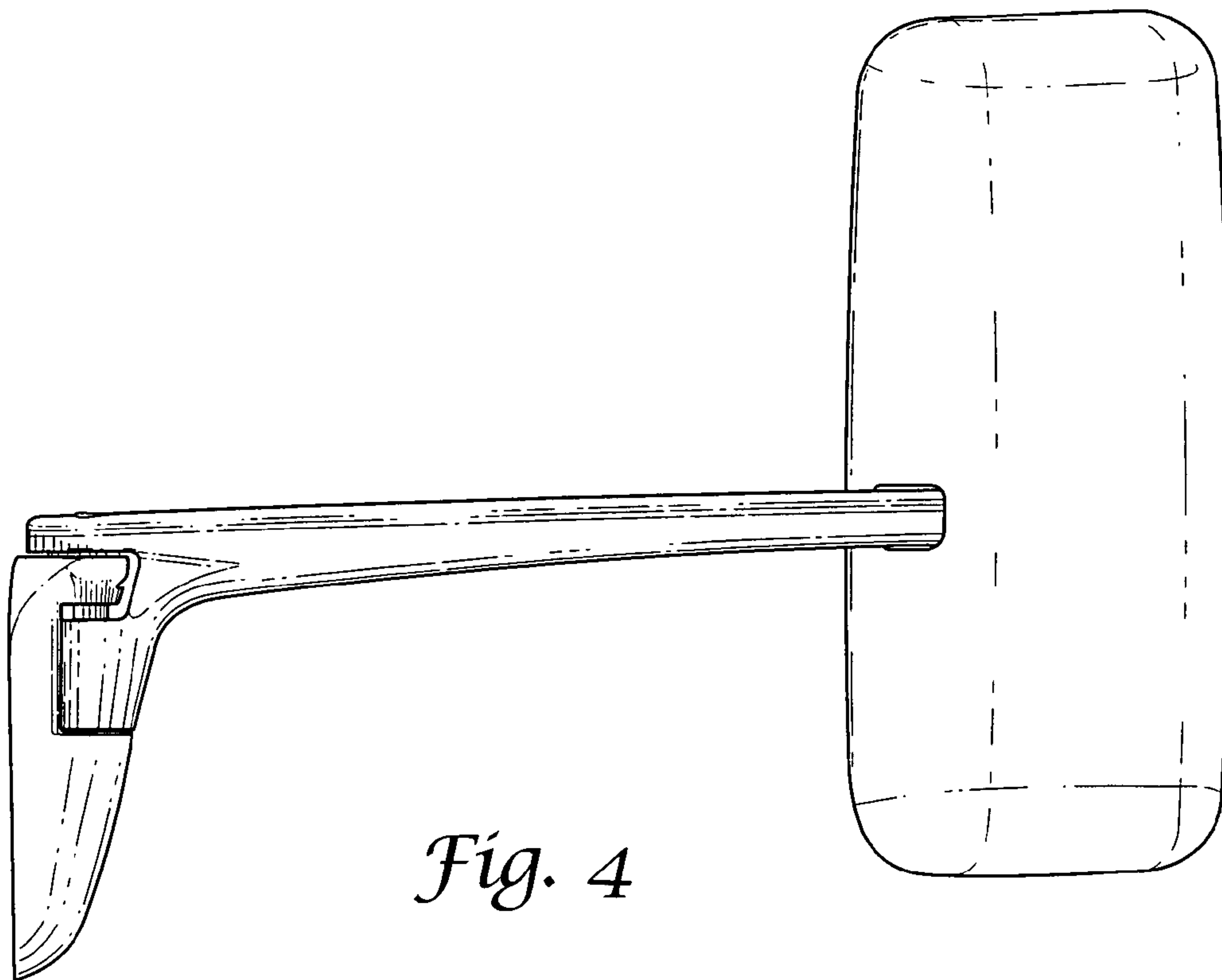

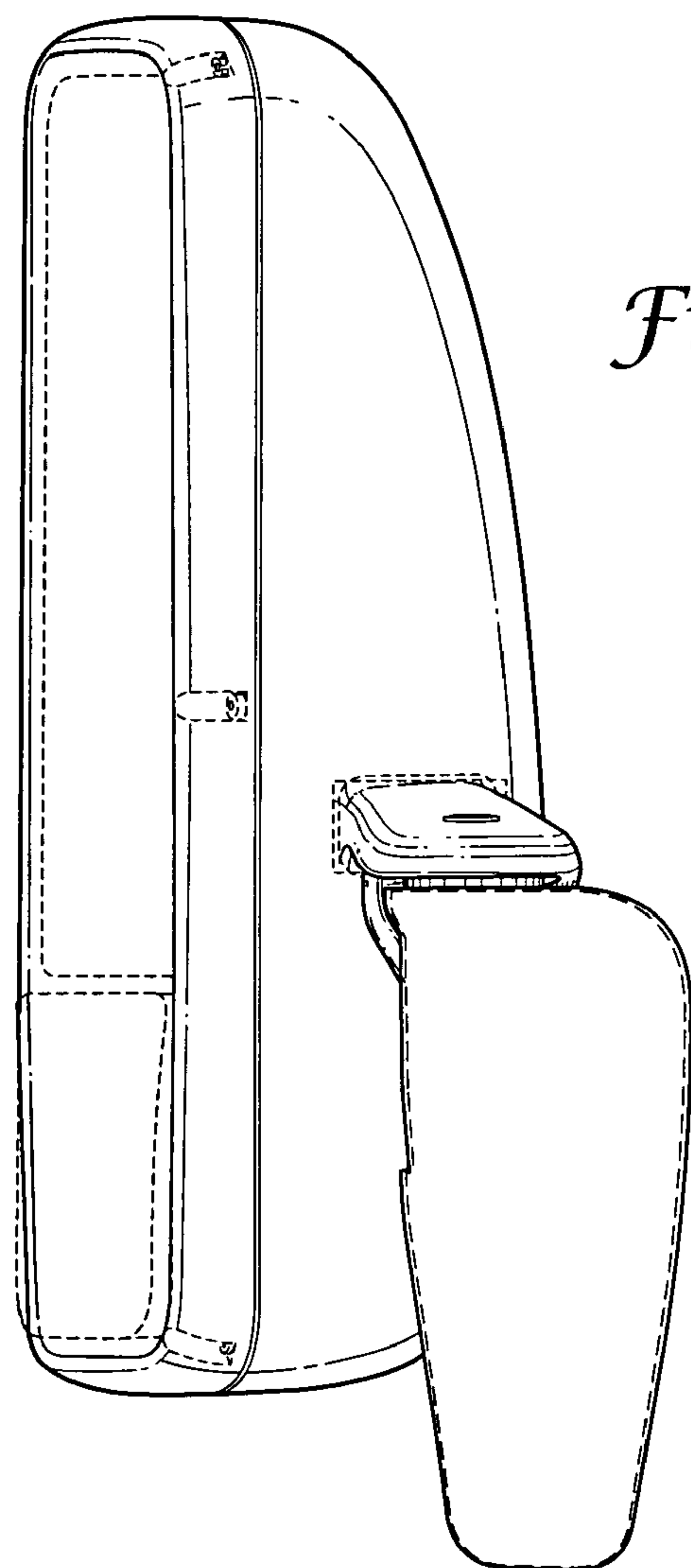

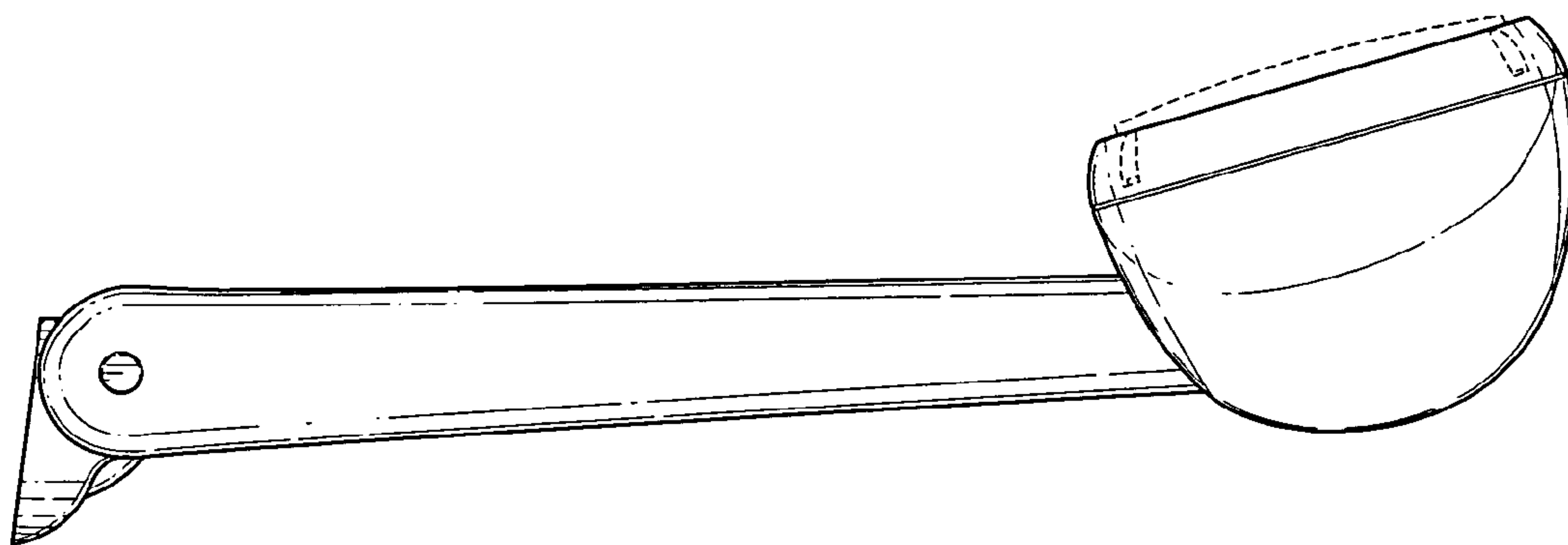
