assembly design;

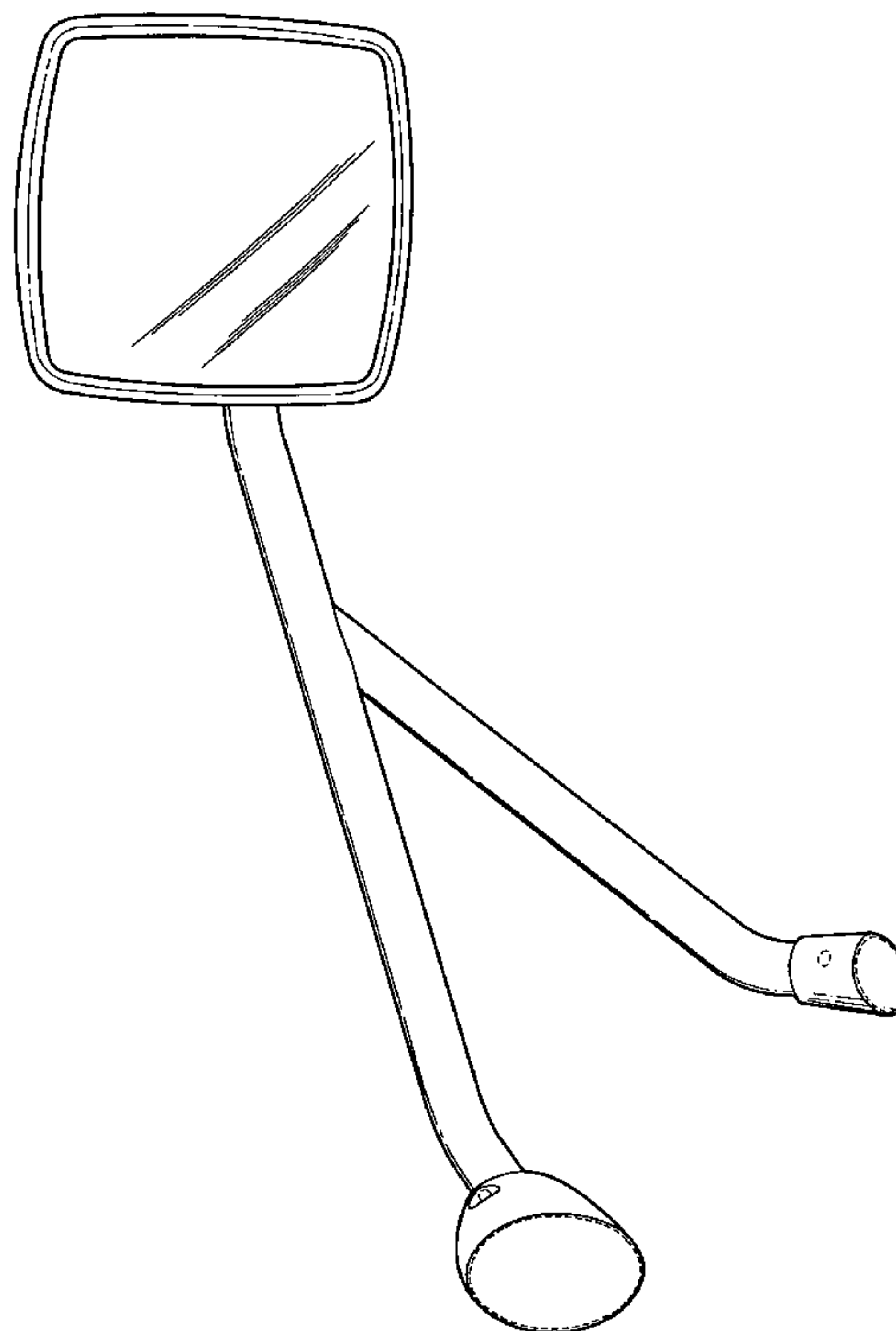
FIG. 6 is a right side elevation view of the vehicle fender  
mirror assembly design;

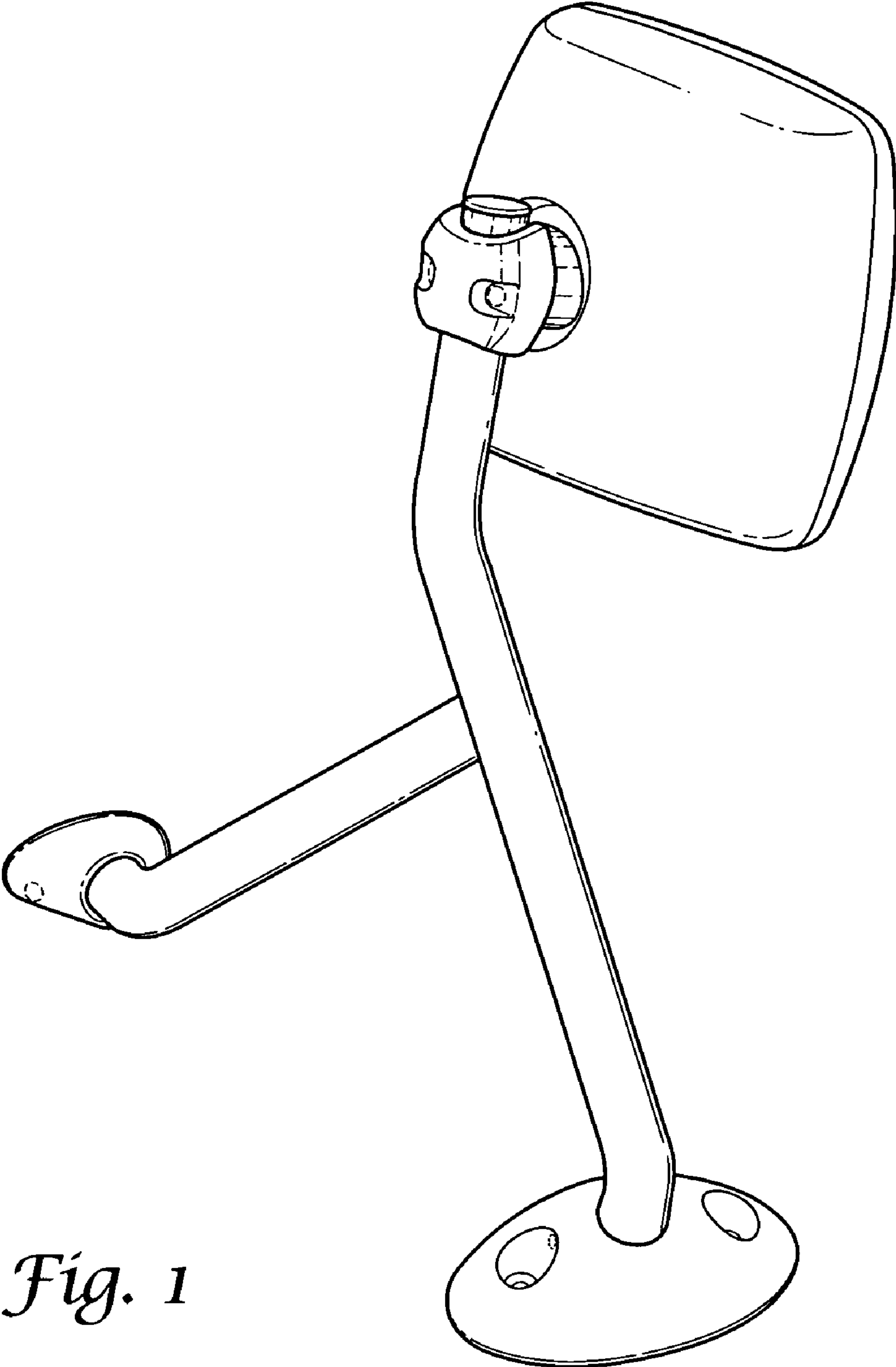
FIG. 7 is a top plan view of the vehicle fender mirror assembly

assembly design.

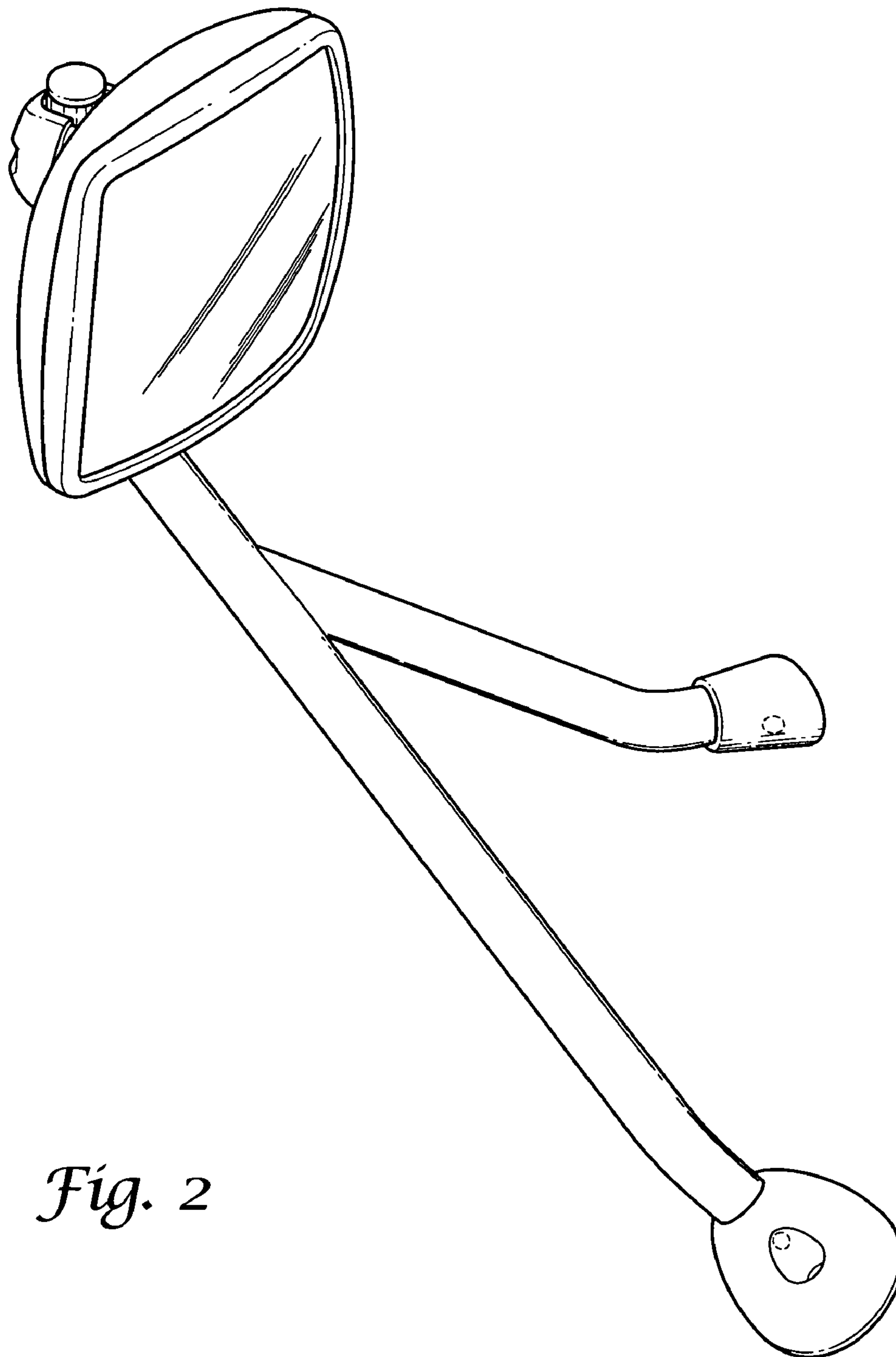
In the drawings the broken lines showing the screws holes and

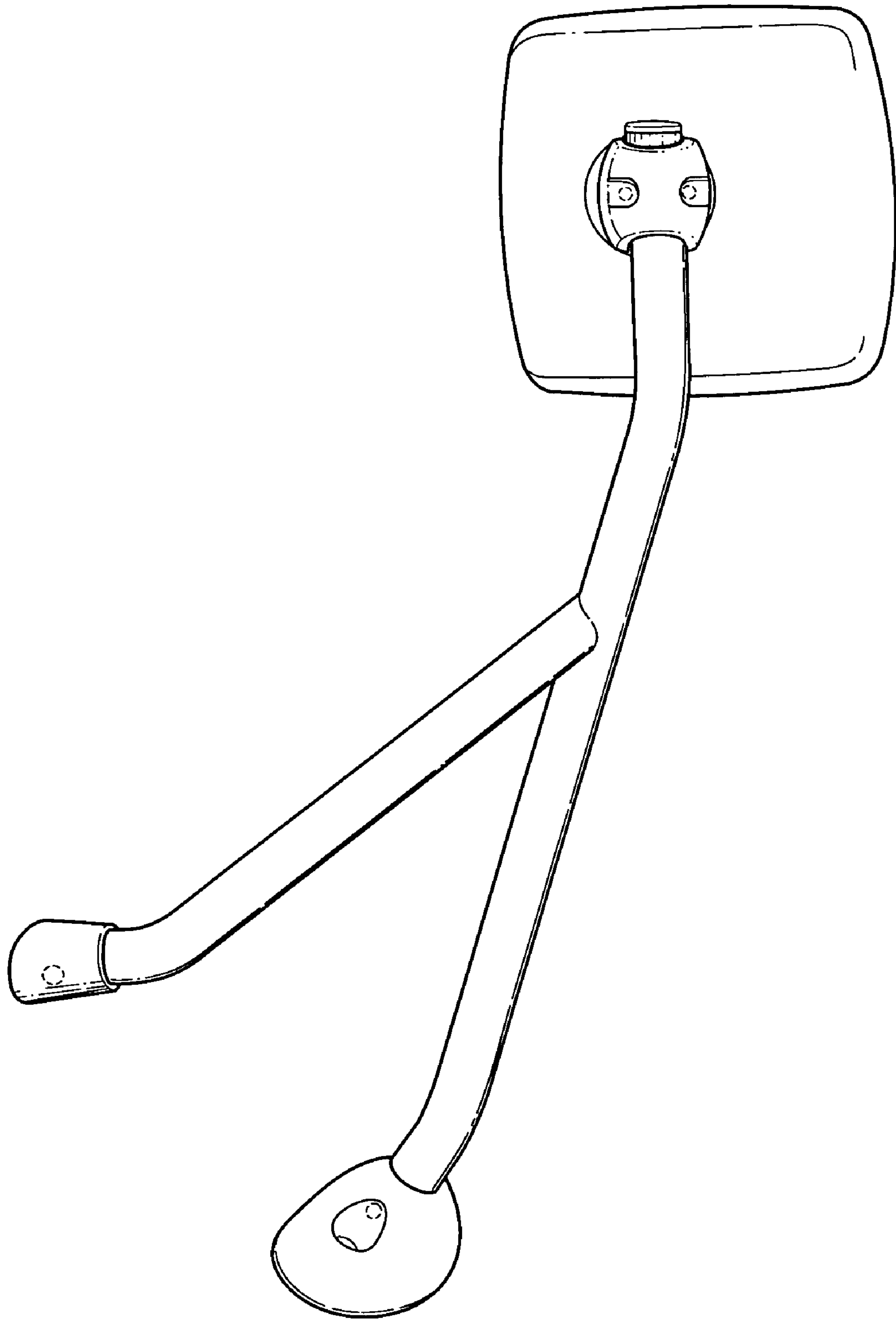




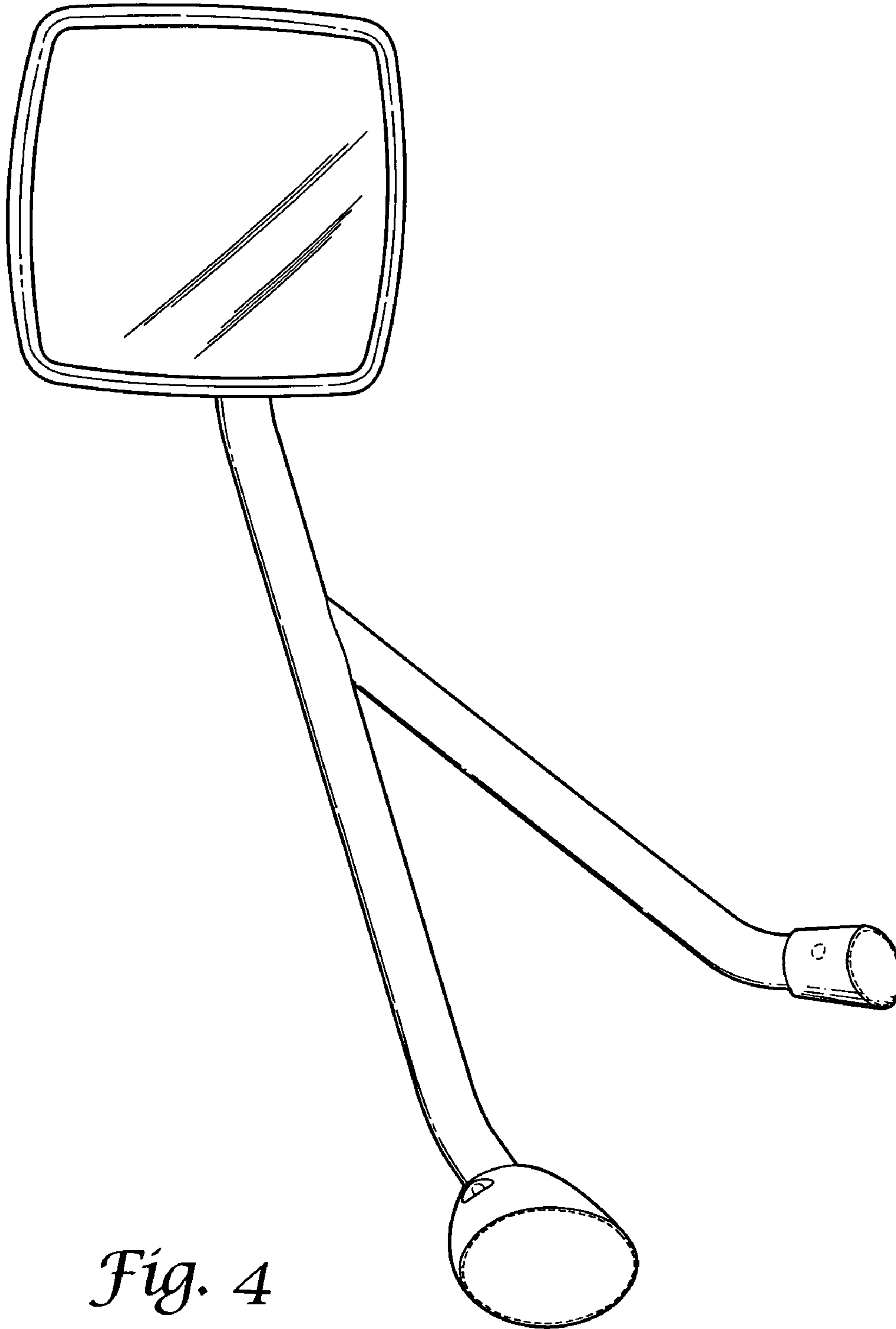

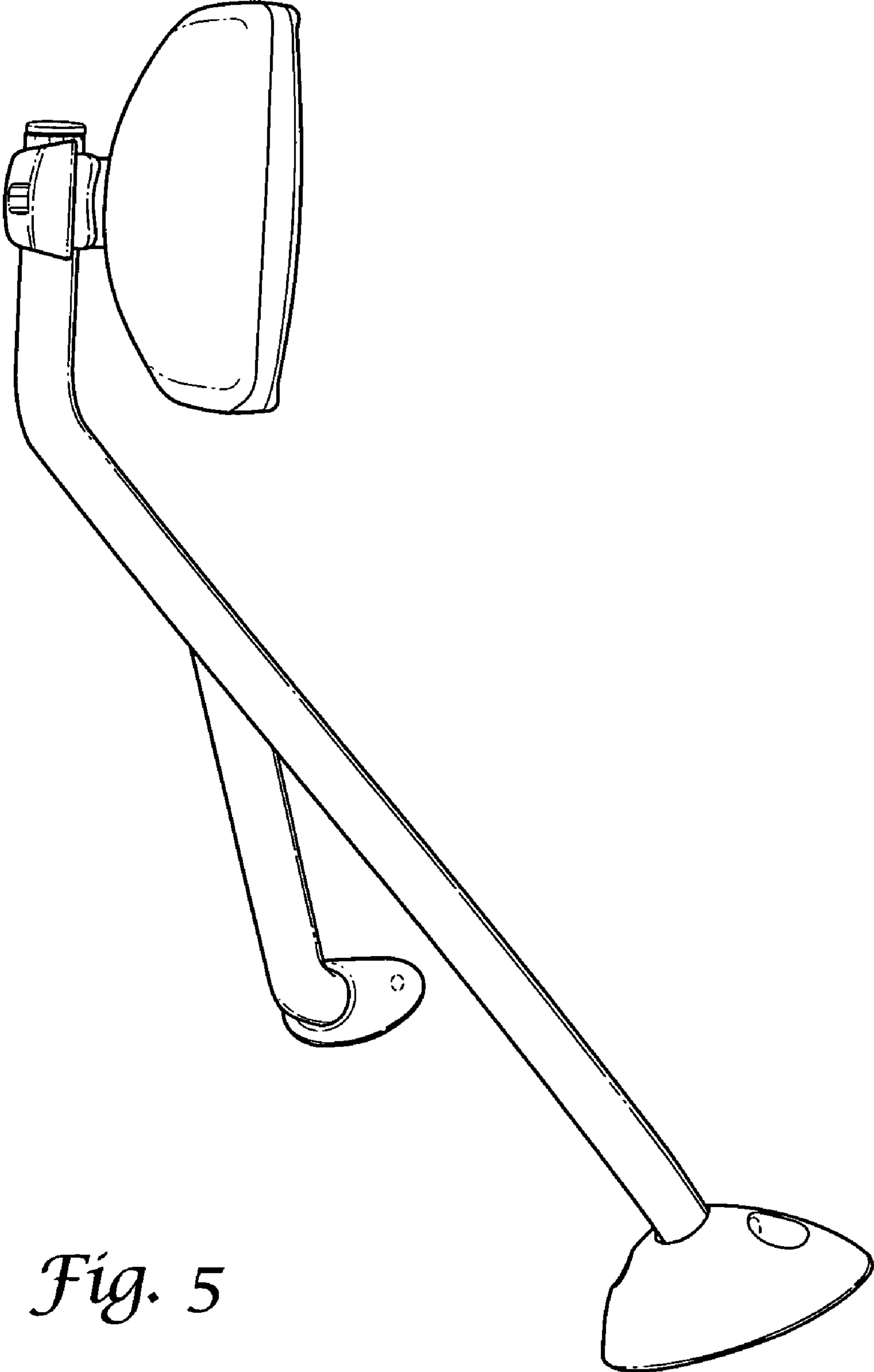

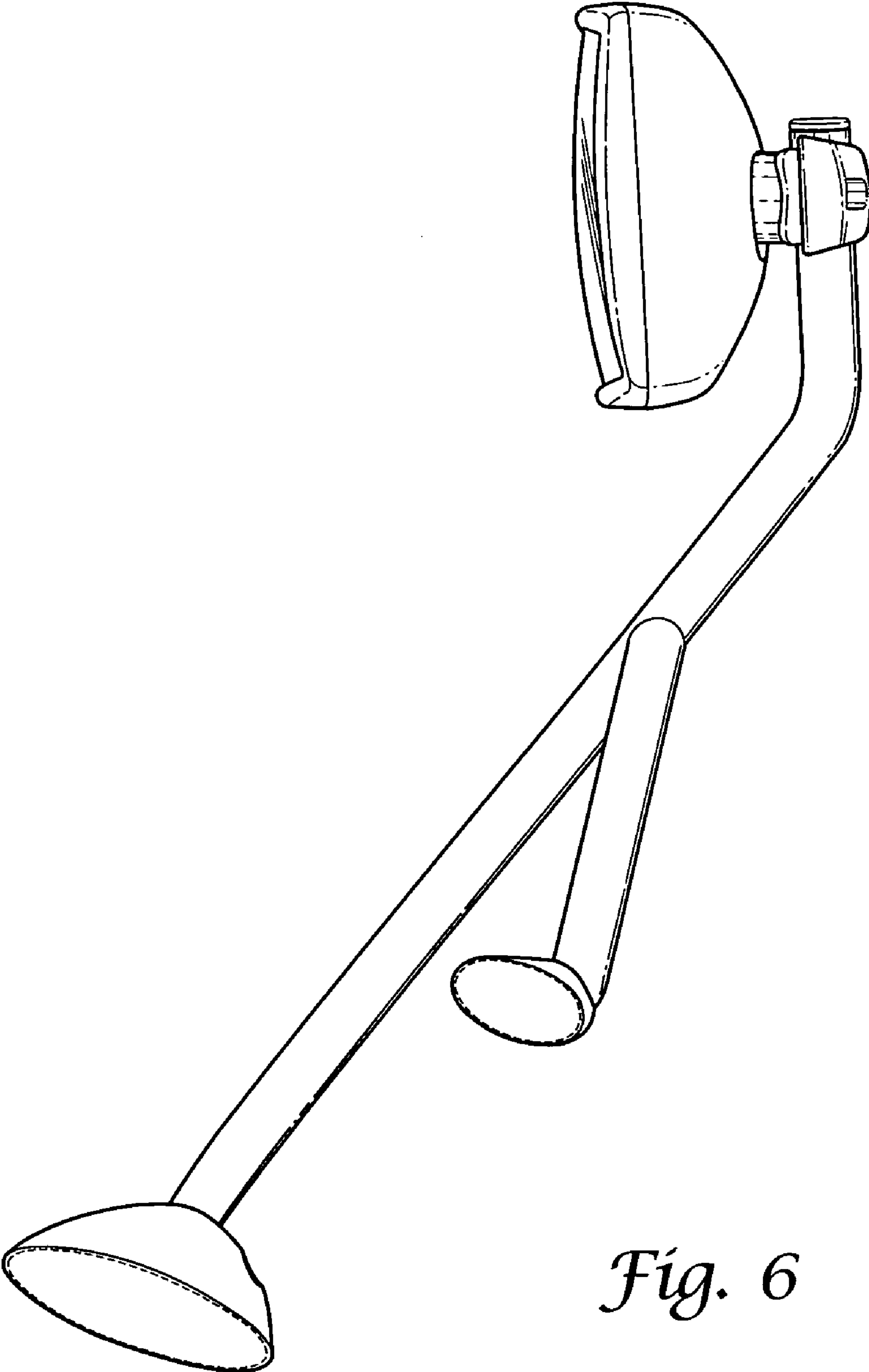

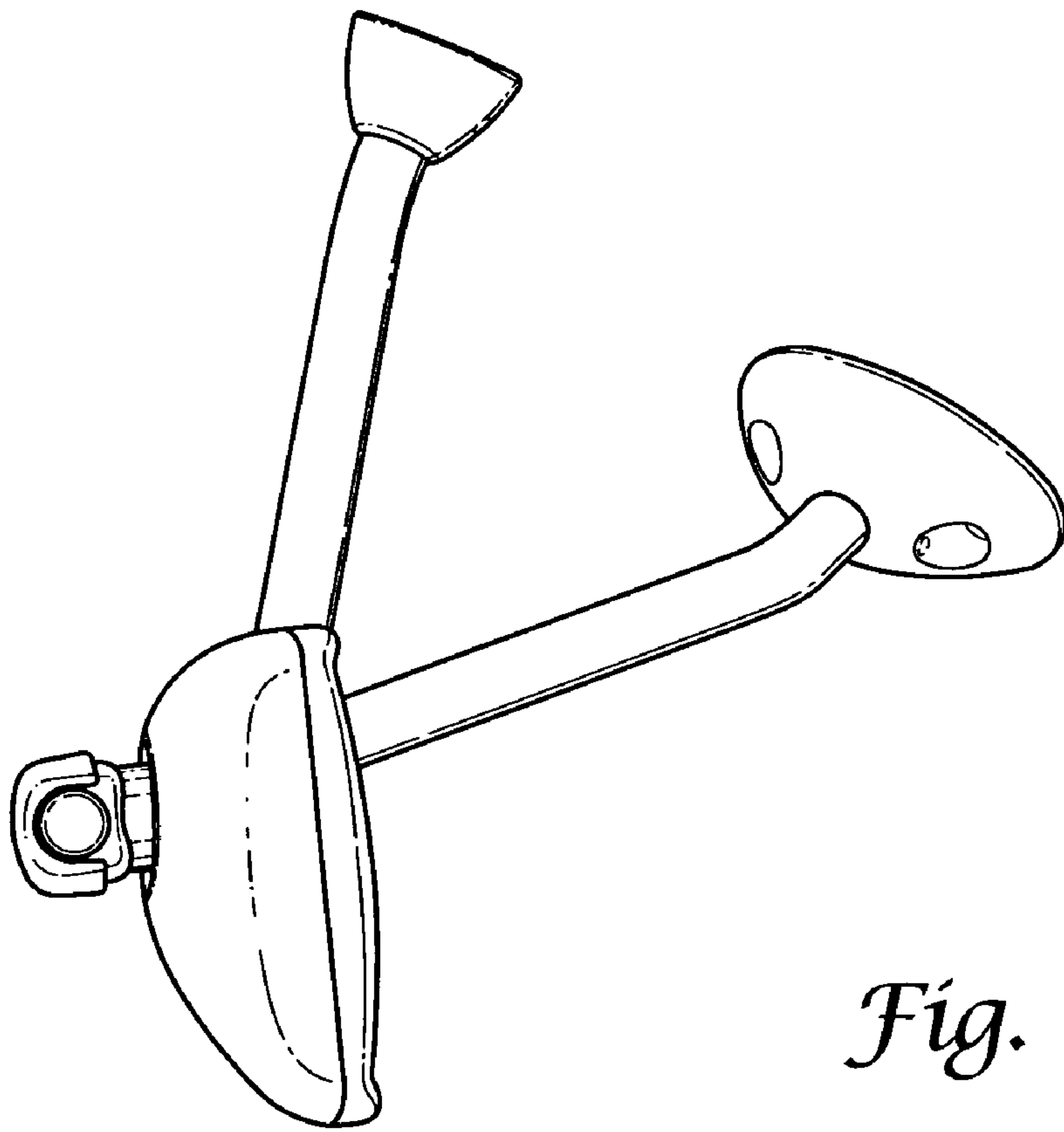

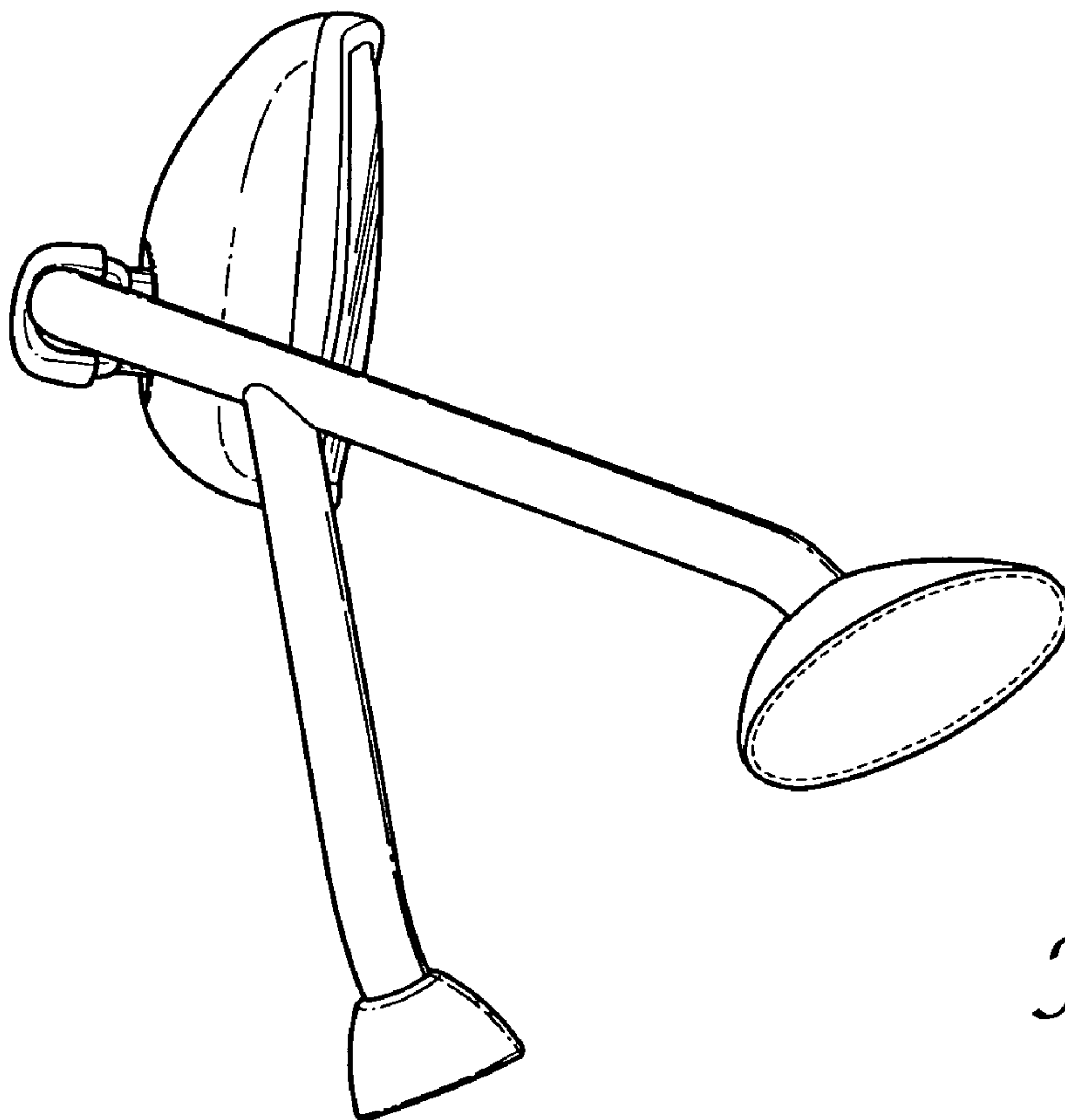
