DESCRIPTION

FIG. 1 is a top, front perspective view of the battery holder of the present invention;

FIG. 2 is a front view of the battery holder of FIG. 1;

FIG. 3 is a rear view of the battery holder of FIG. 2;

FIG. 4 is a top view of the battery holder of FIG. 2;

FIG. 5 is a bottom view of the battery holder of FIG. 2;

FIG. 6 is a right side view of the battery holder of FIG. 2; and,

FIG. 7 is a left side view of the battery holder of FIG. 2.

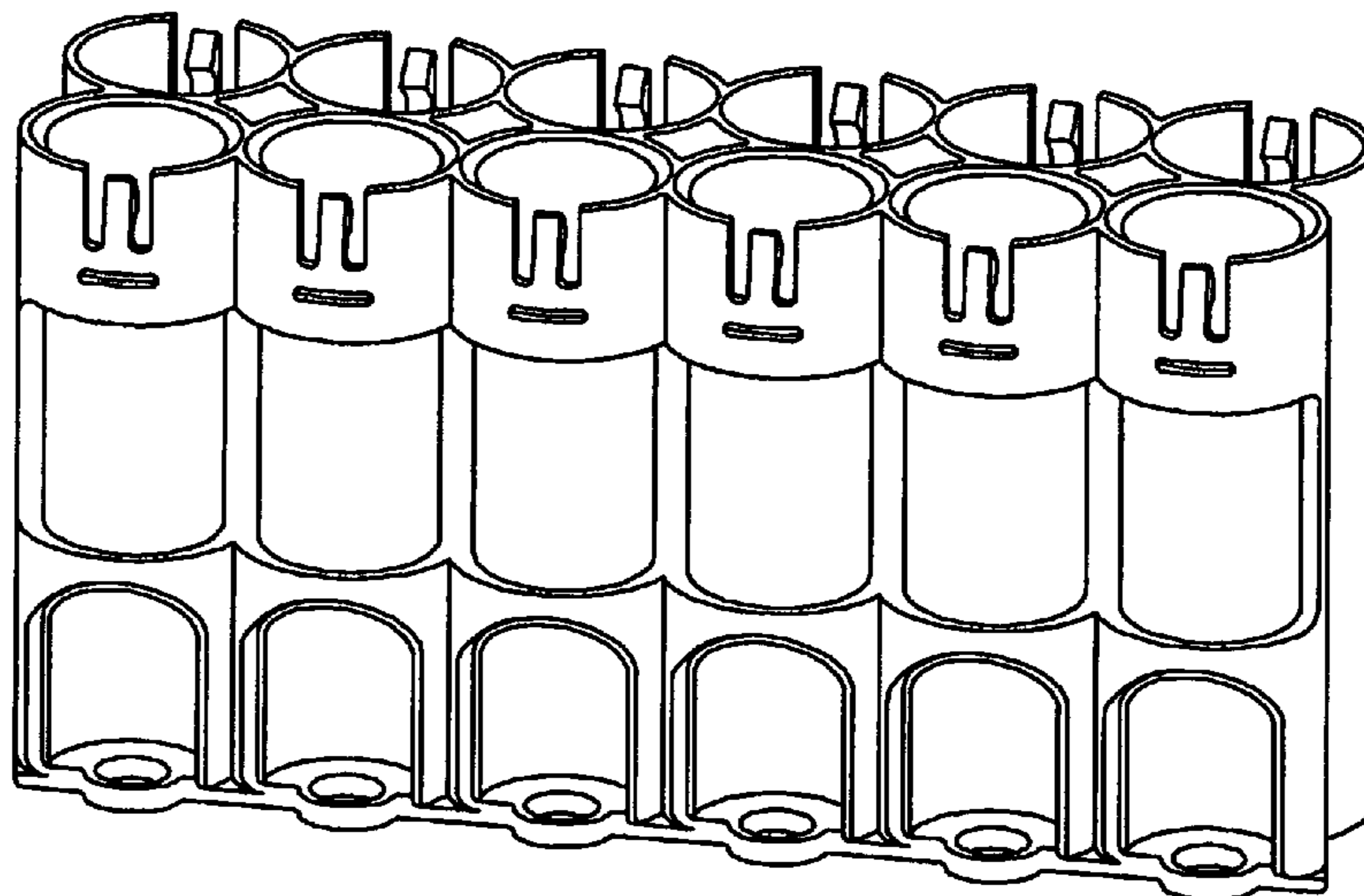

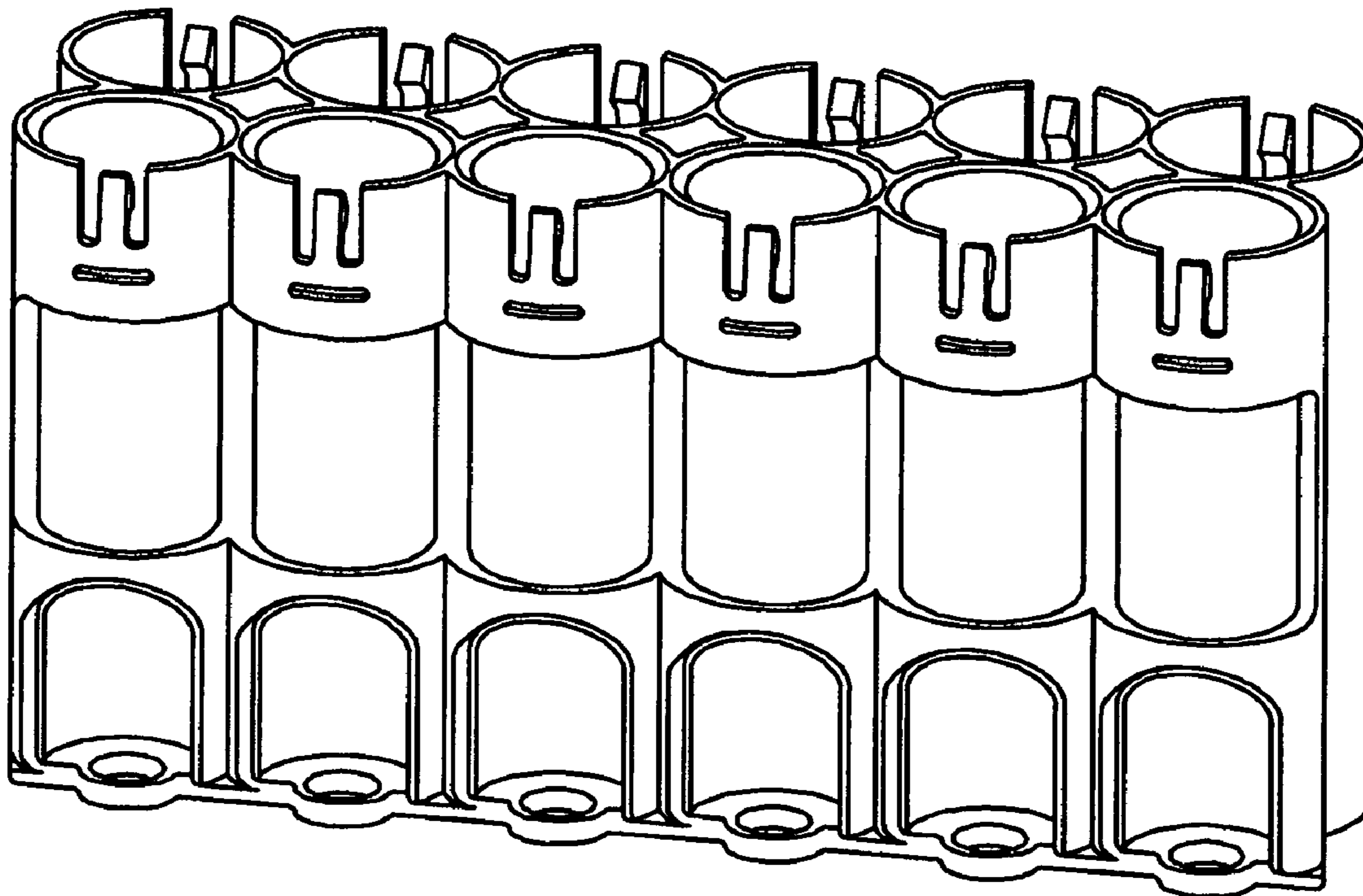

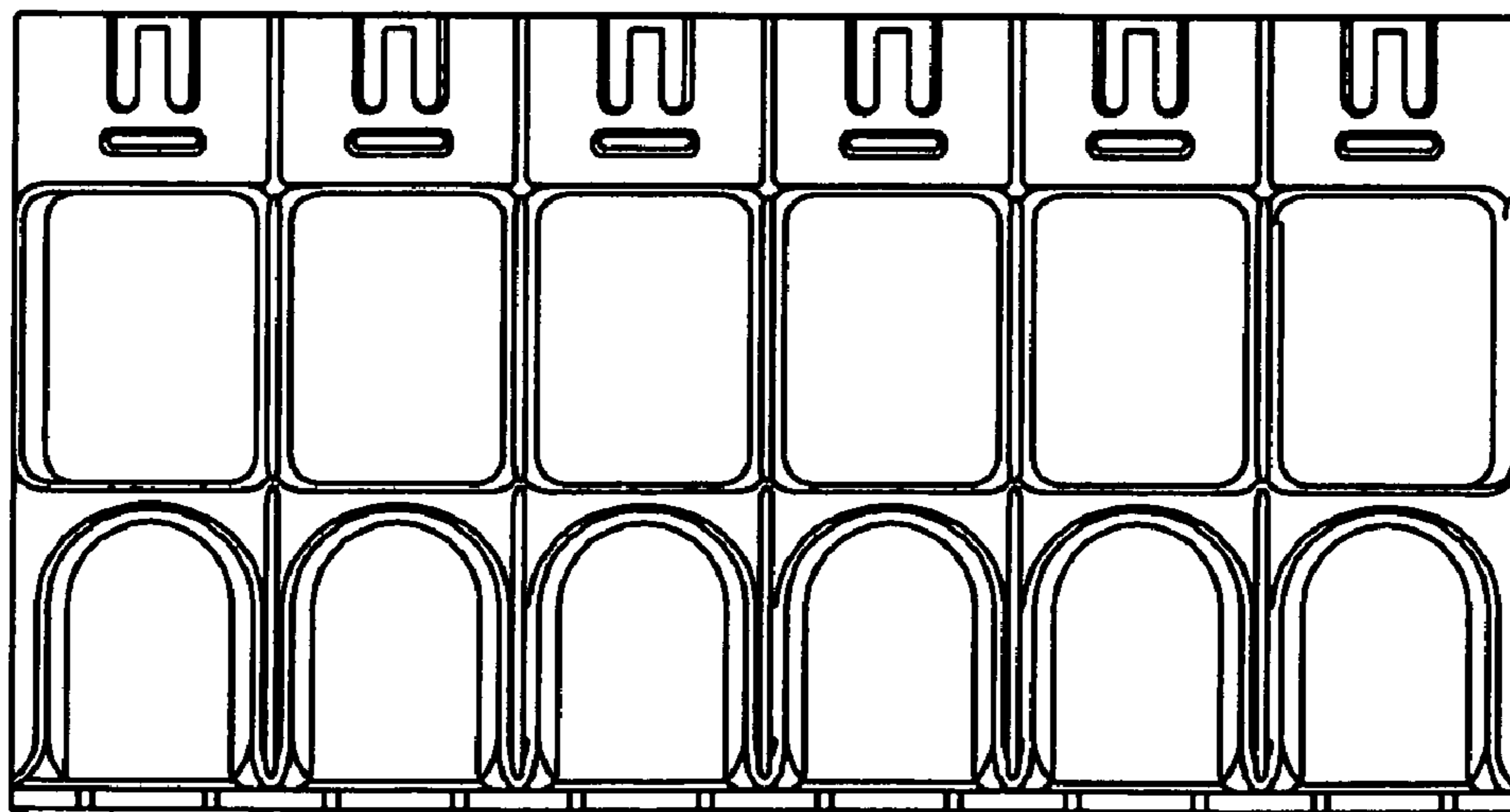

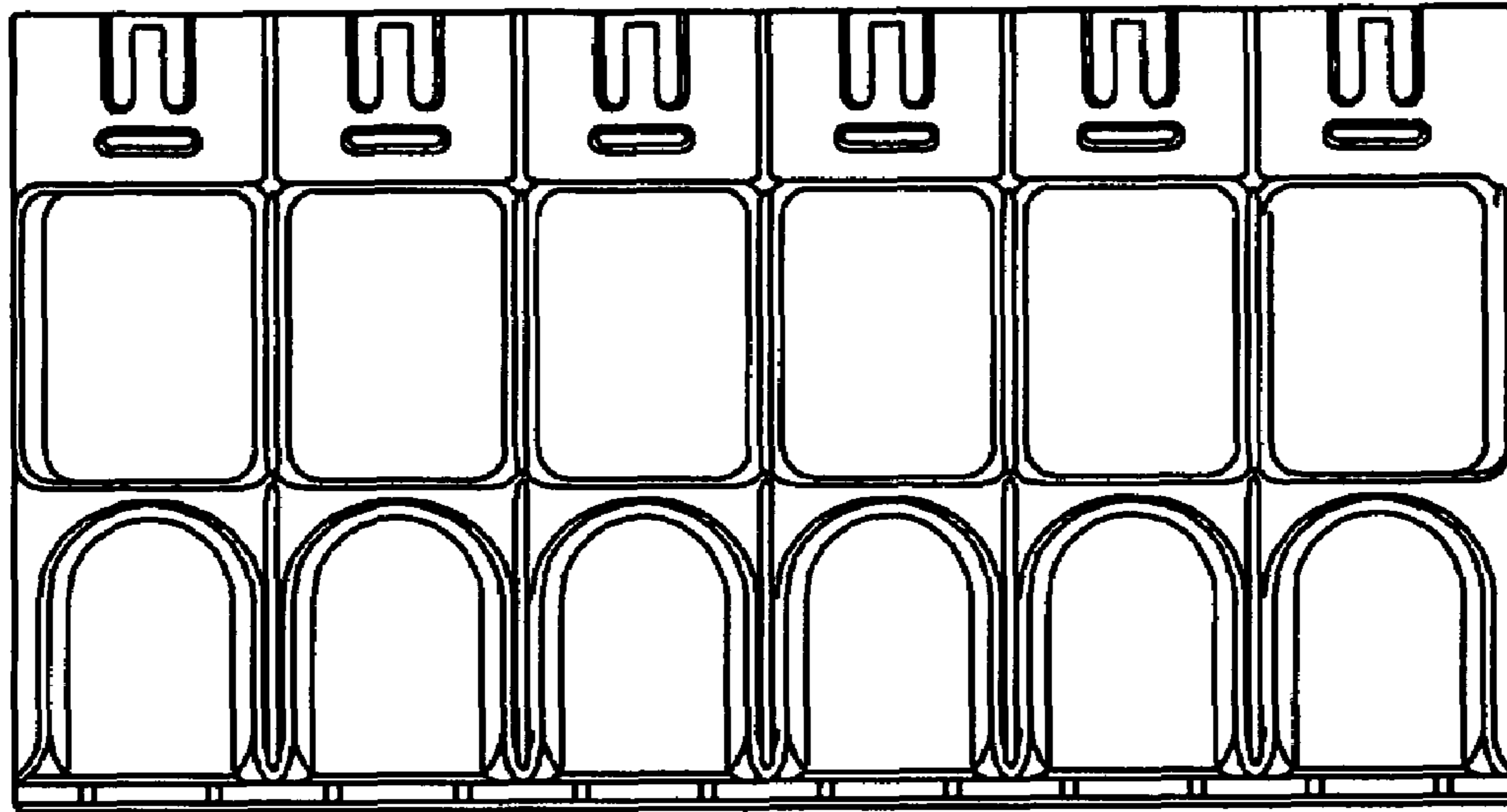

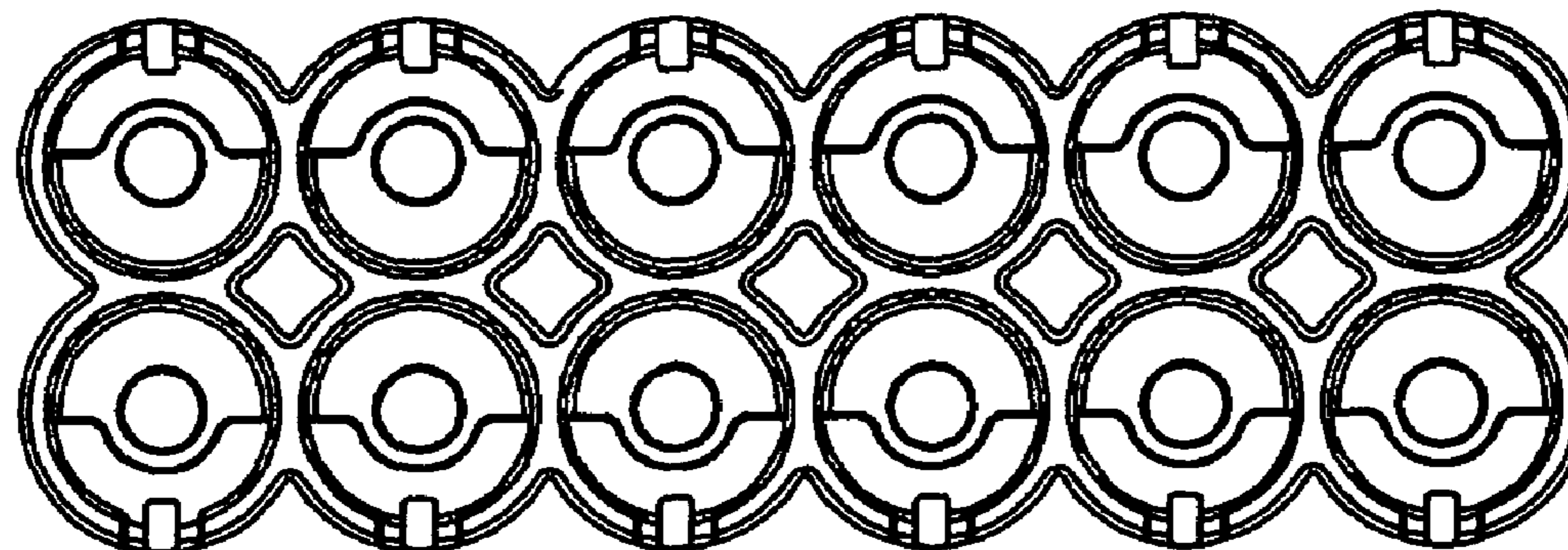

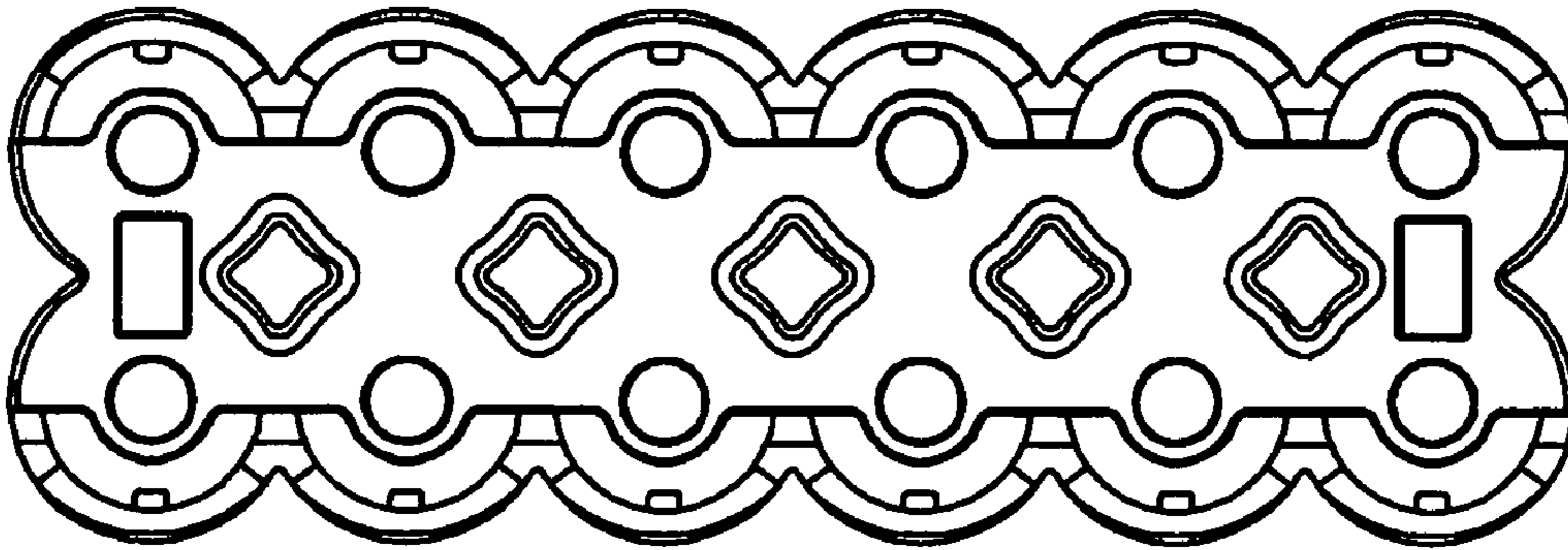

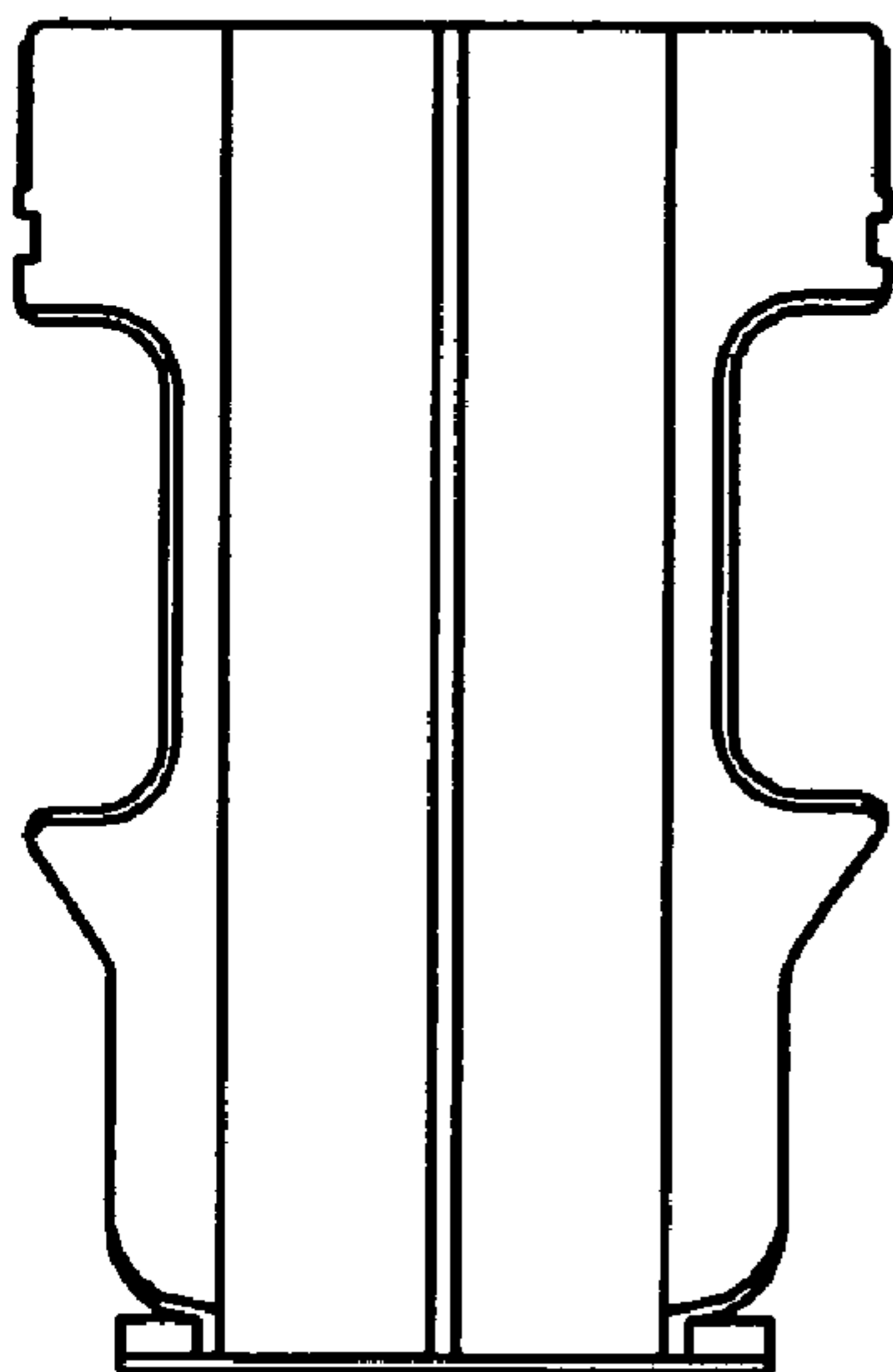
