I claim the ornamental design for a telephone base unit, as shown and described.

DESCRIPTION

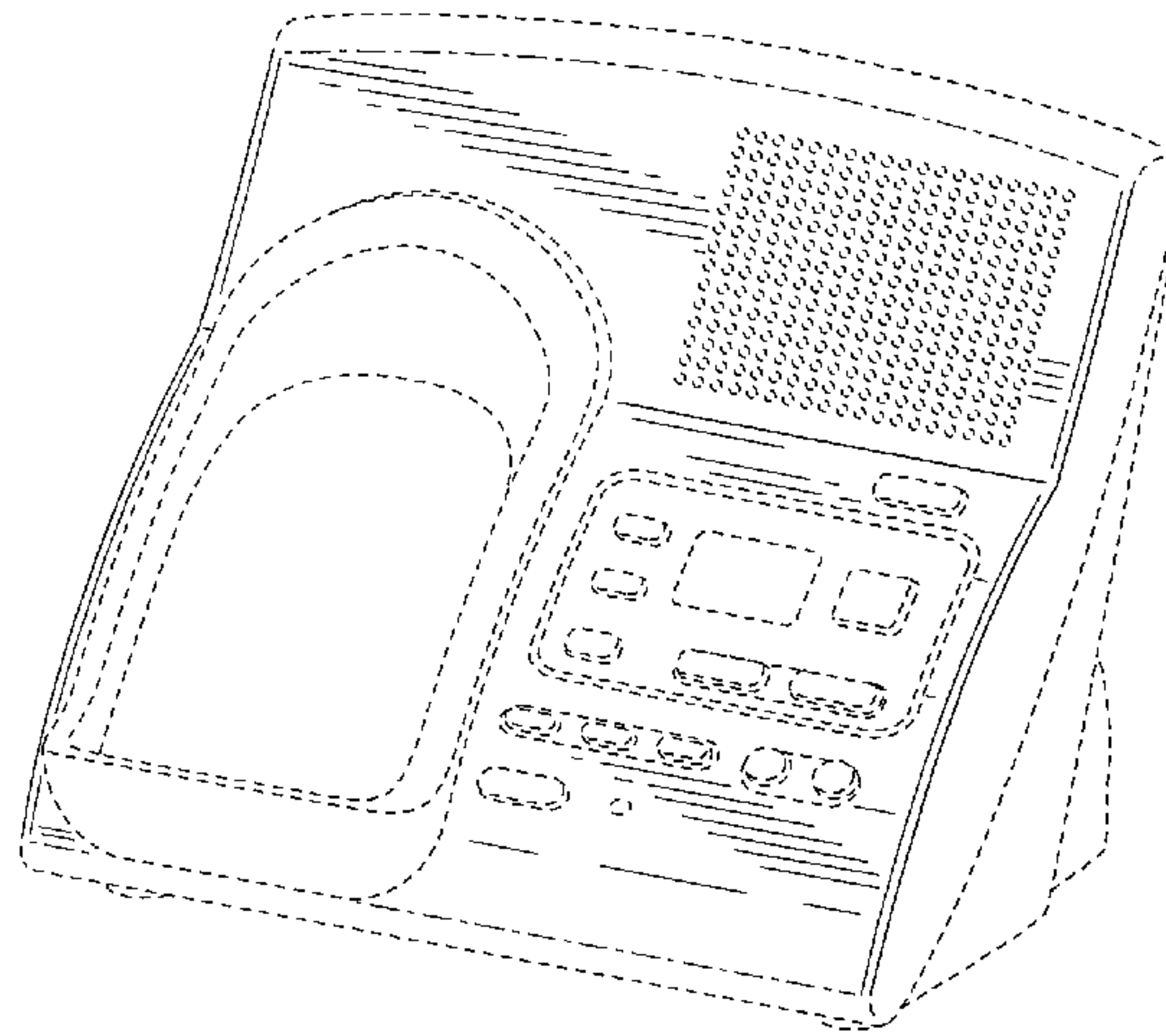

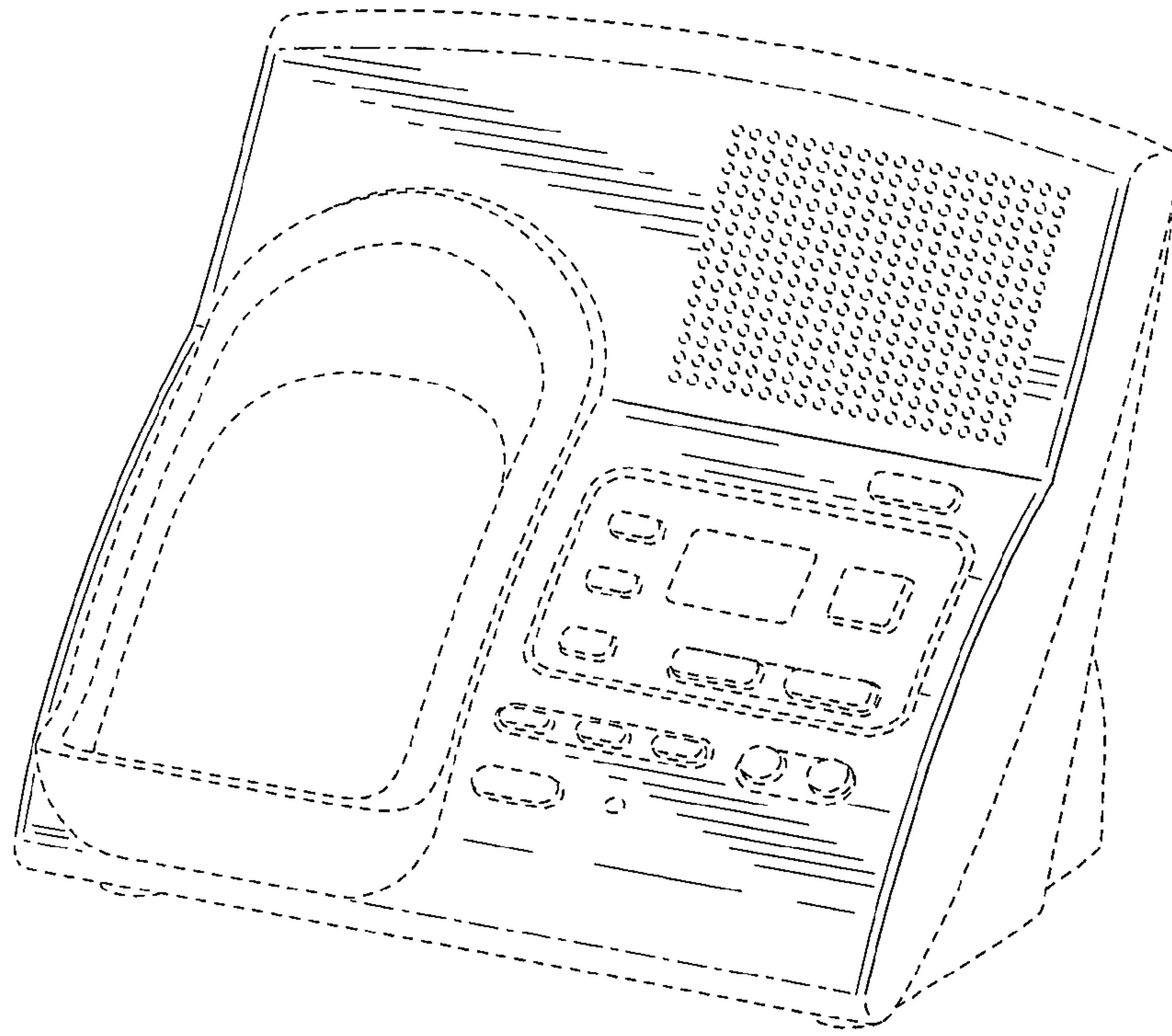

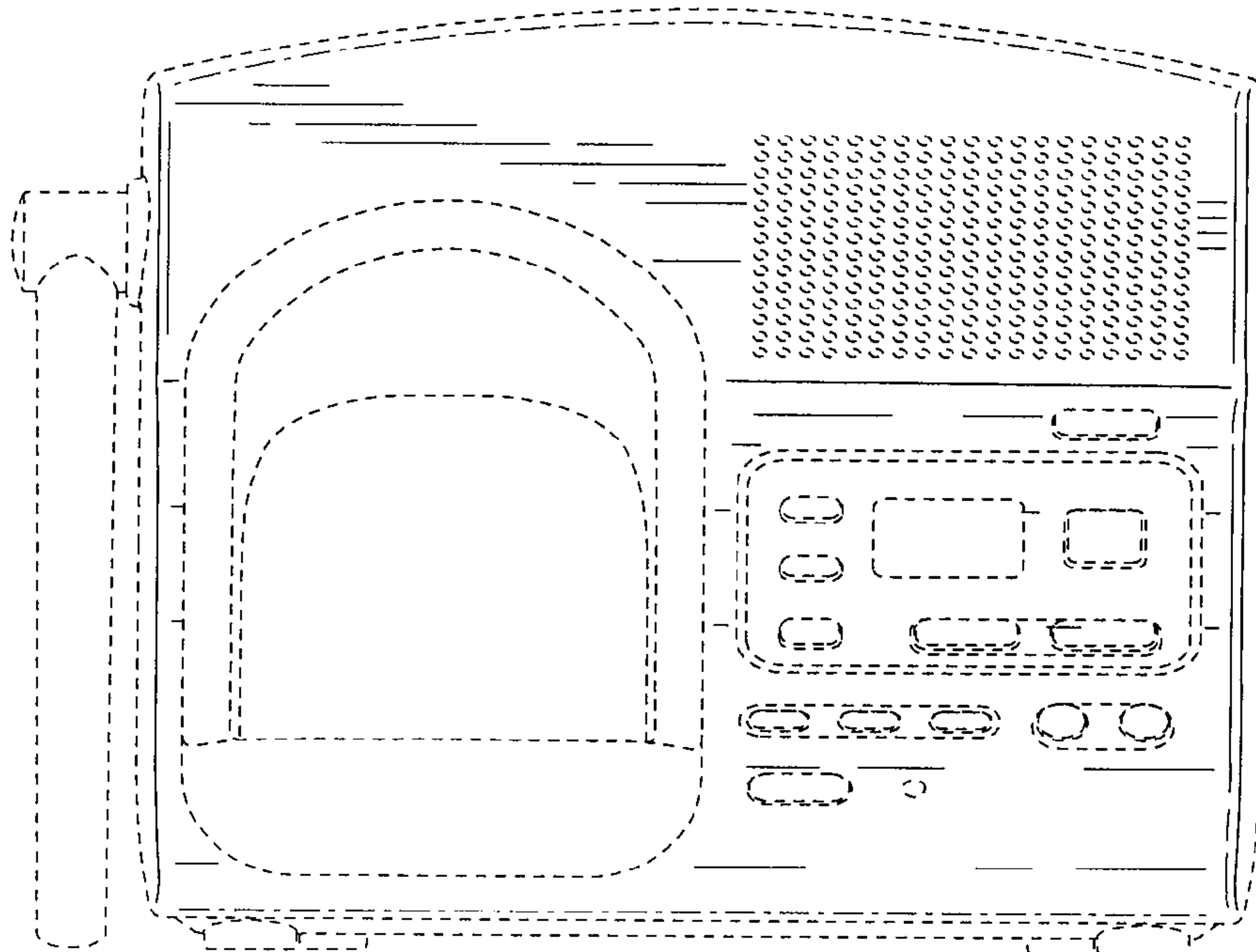

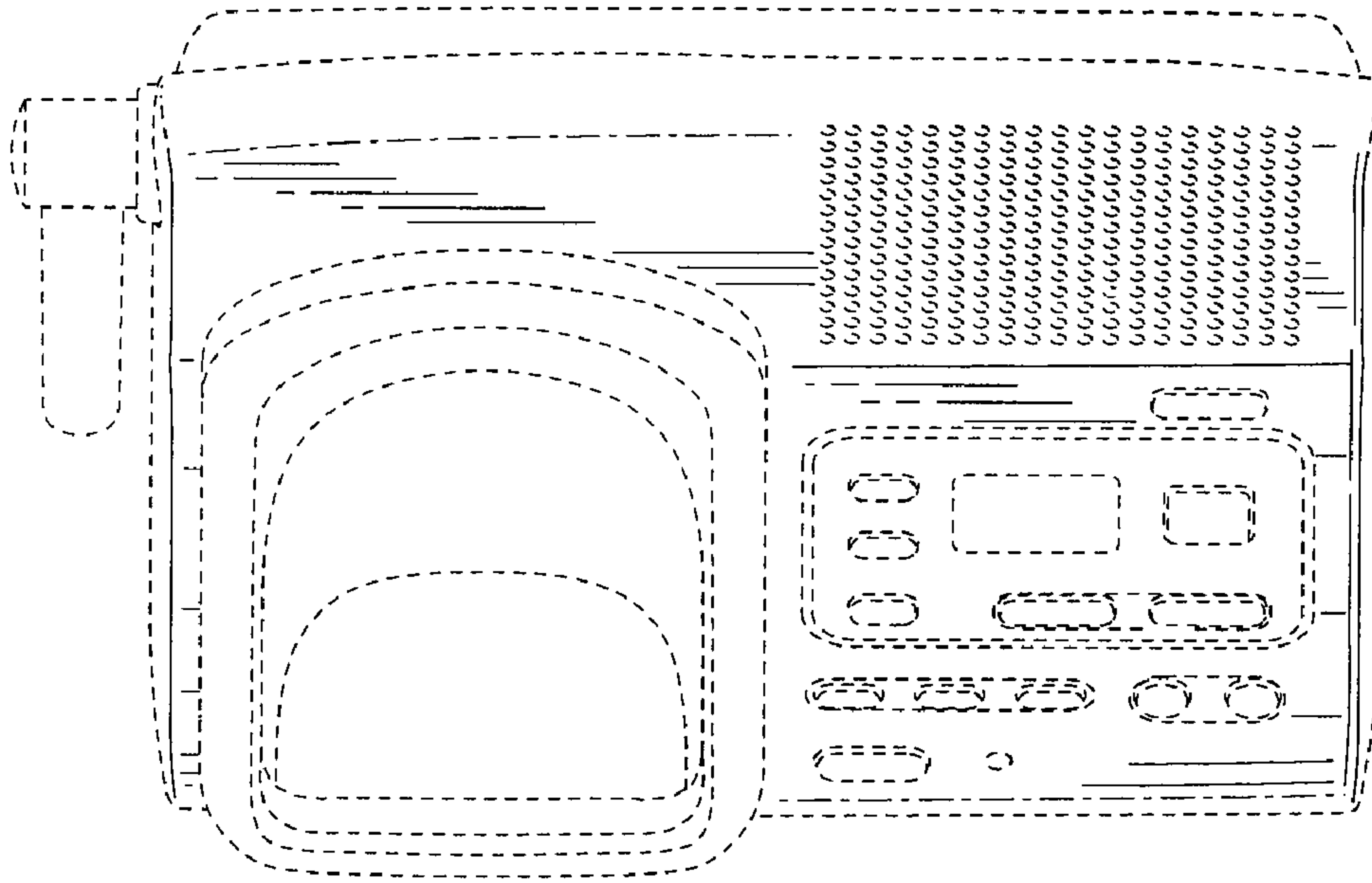

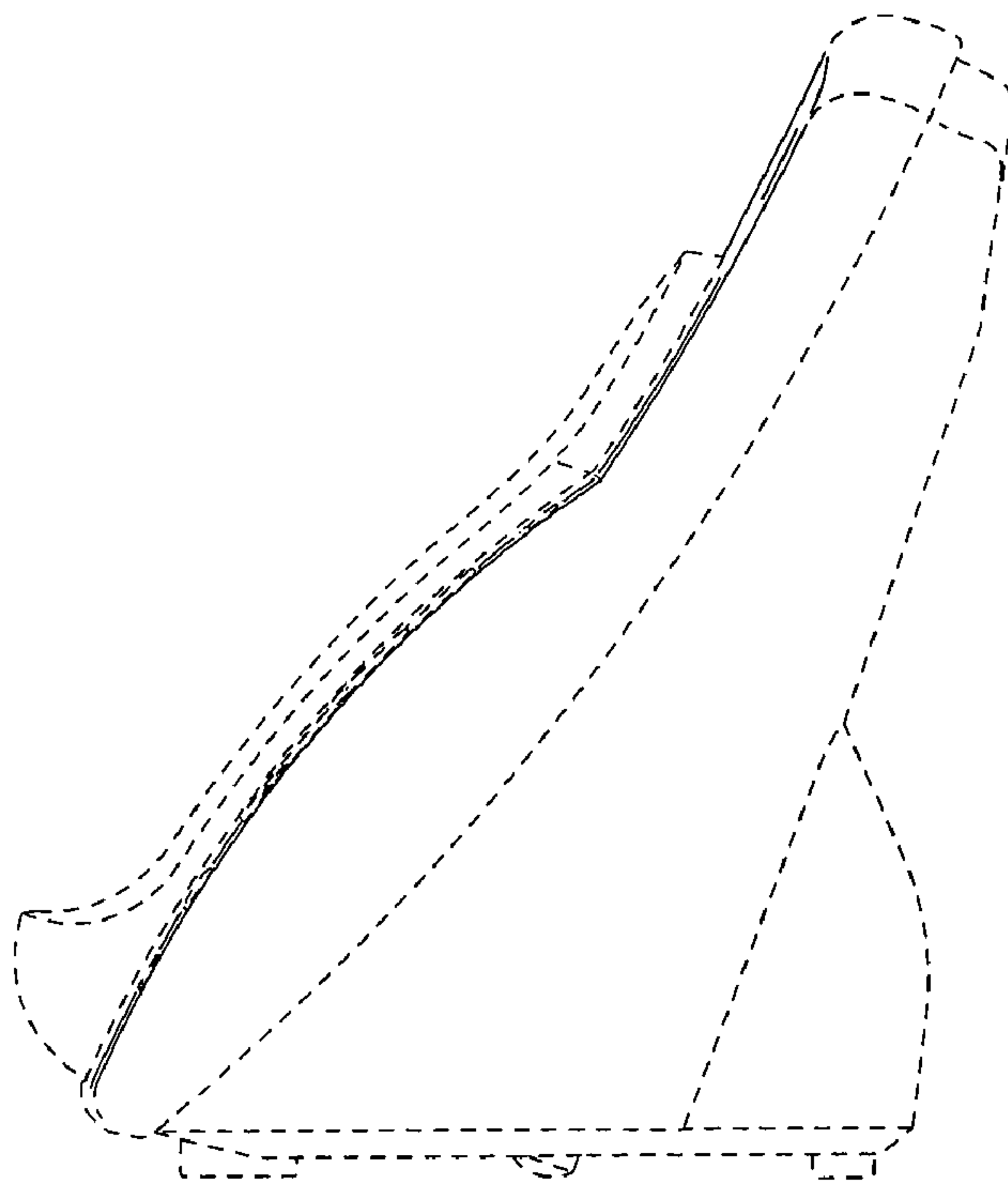

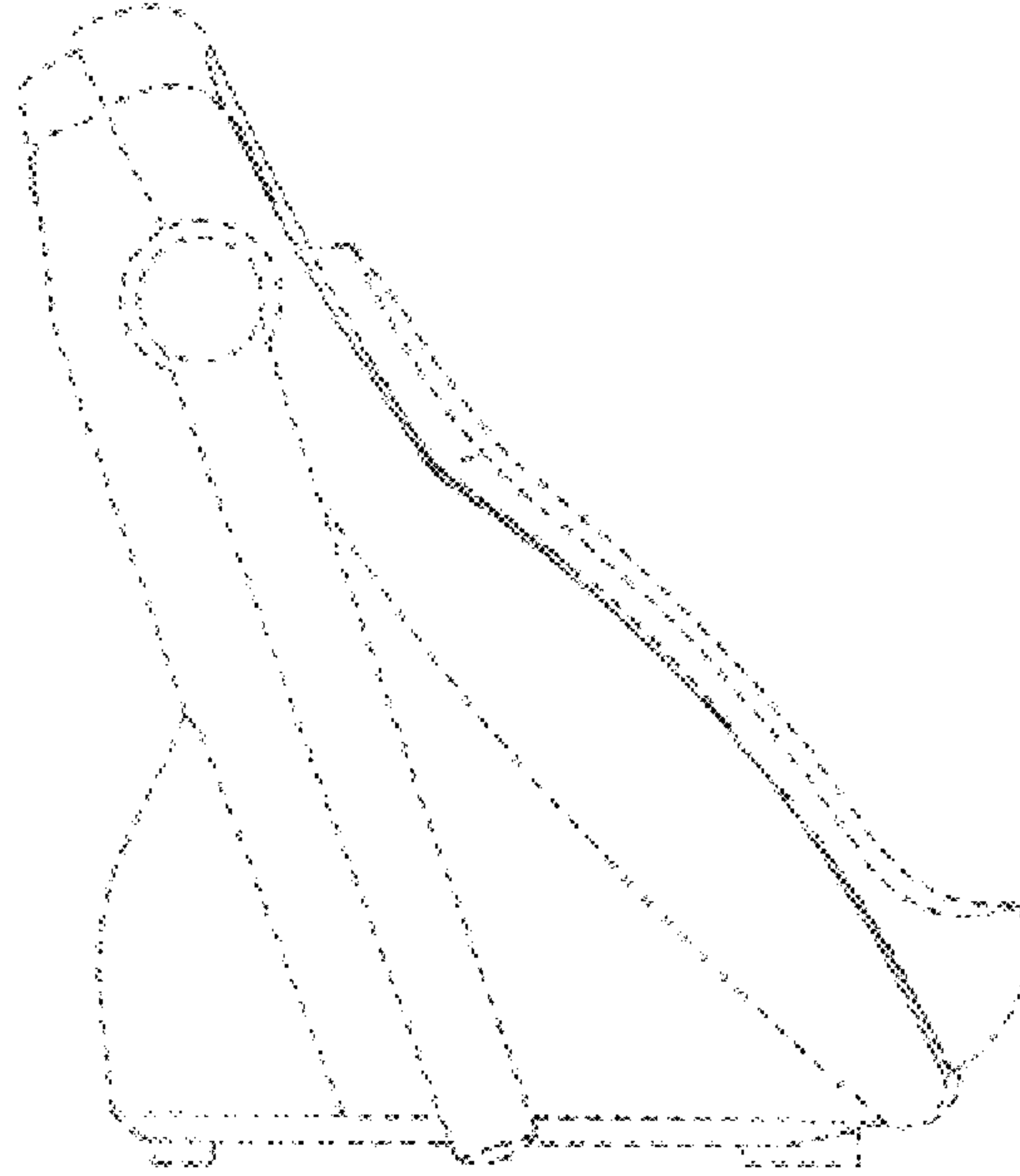

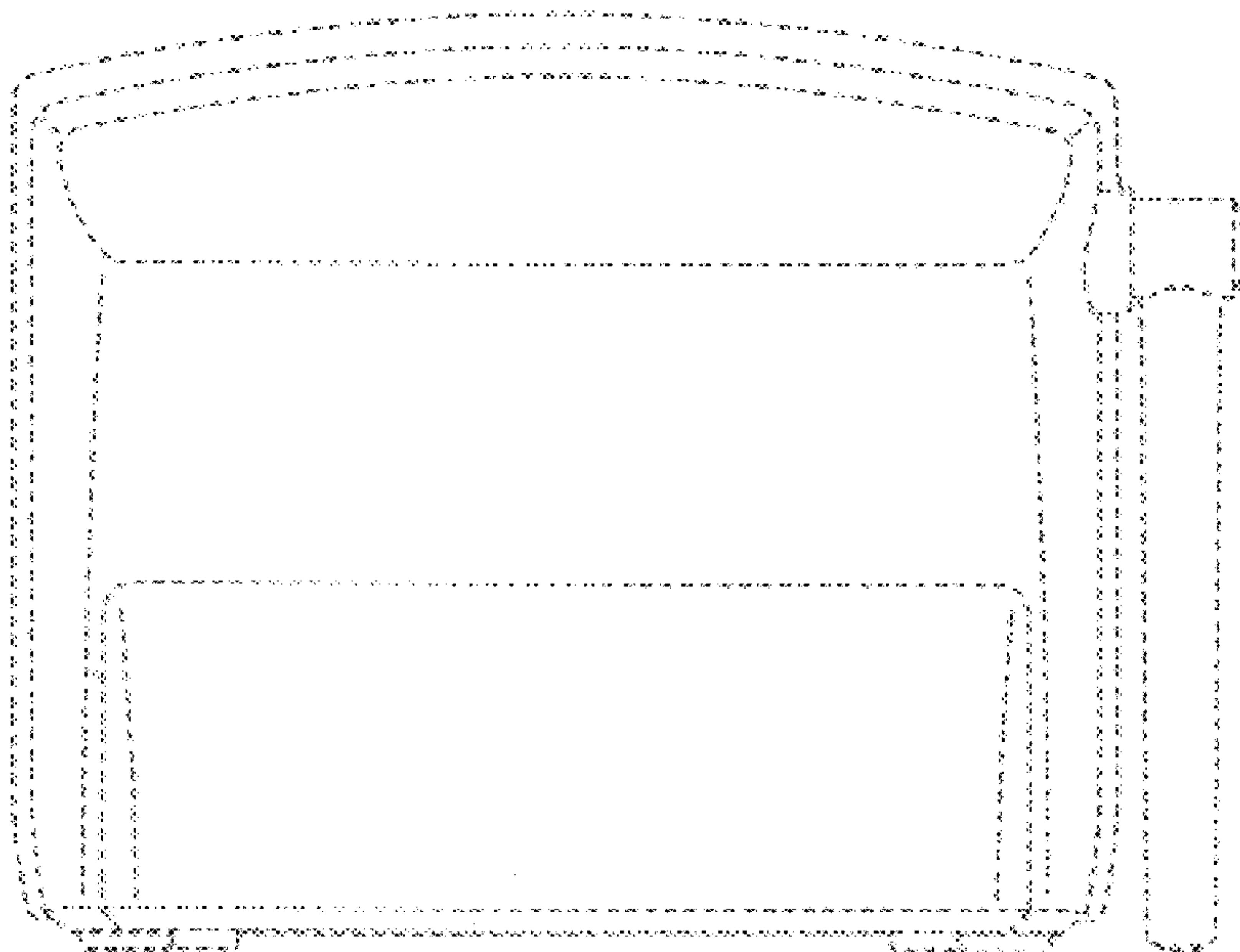

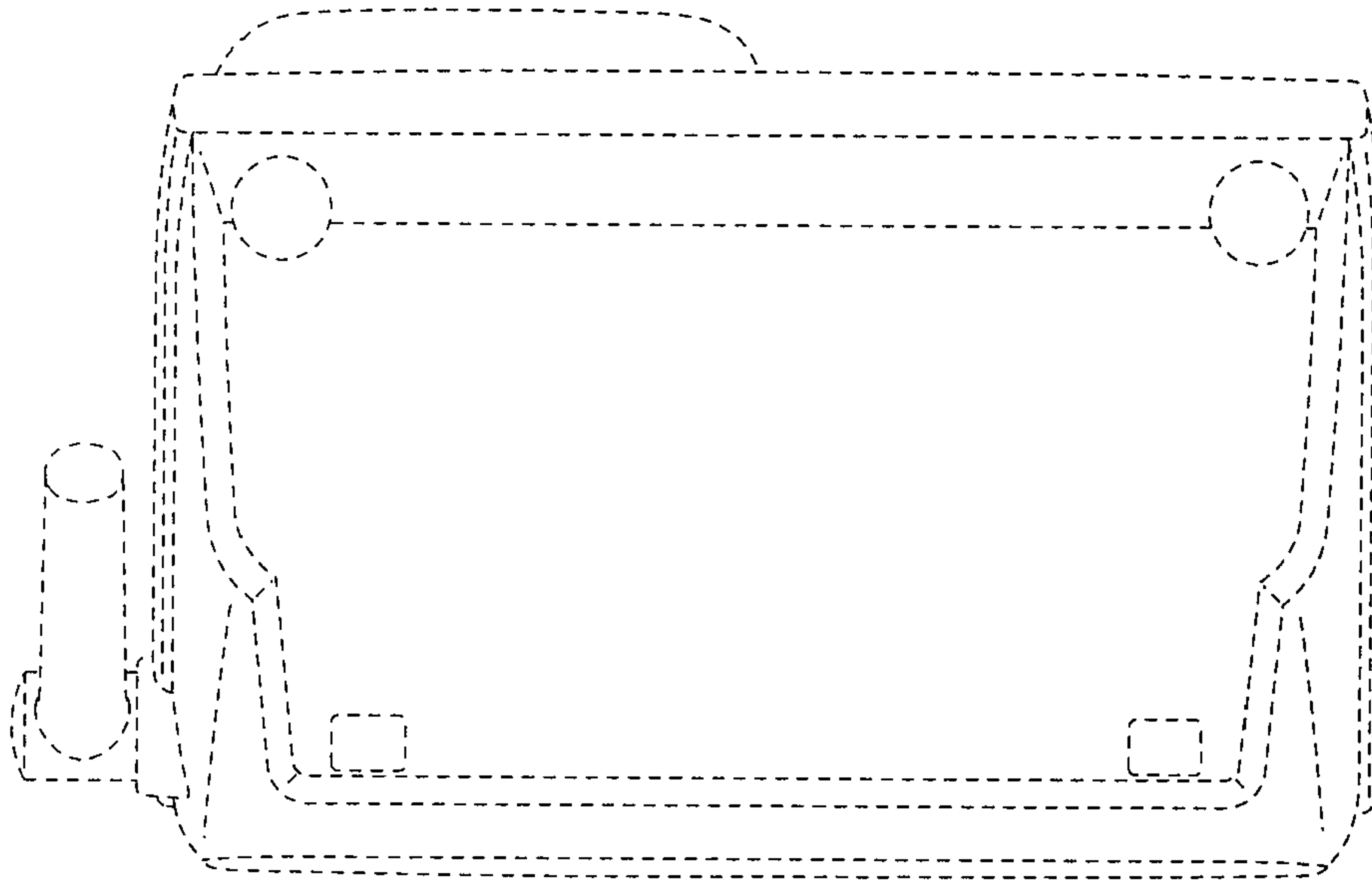

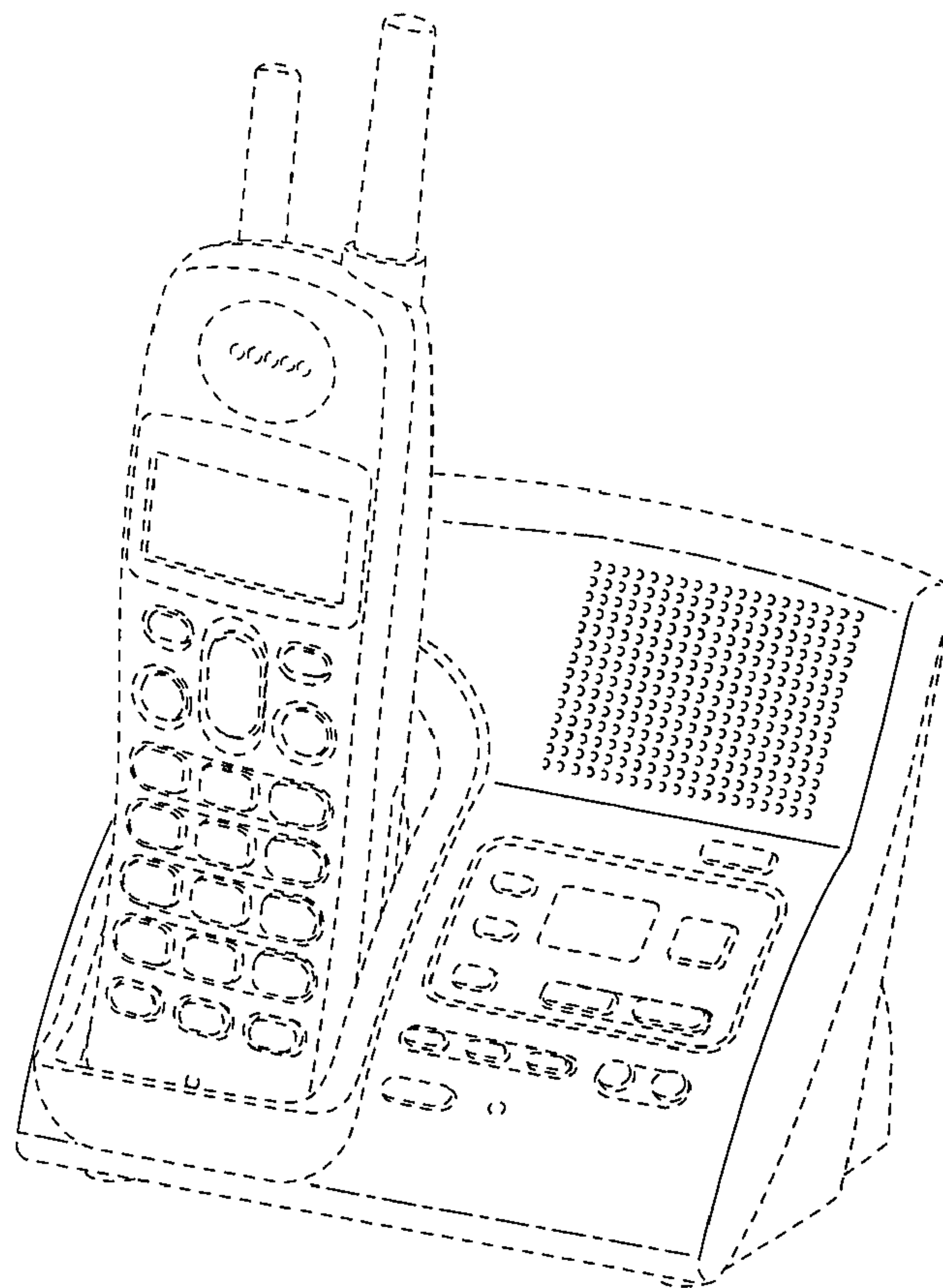

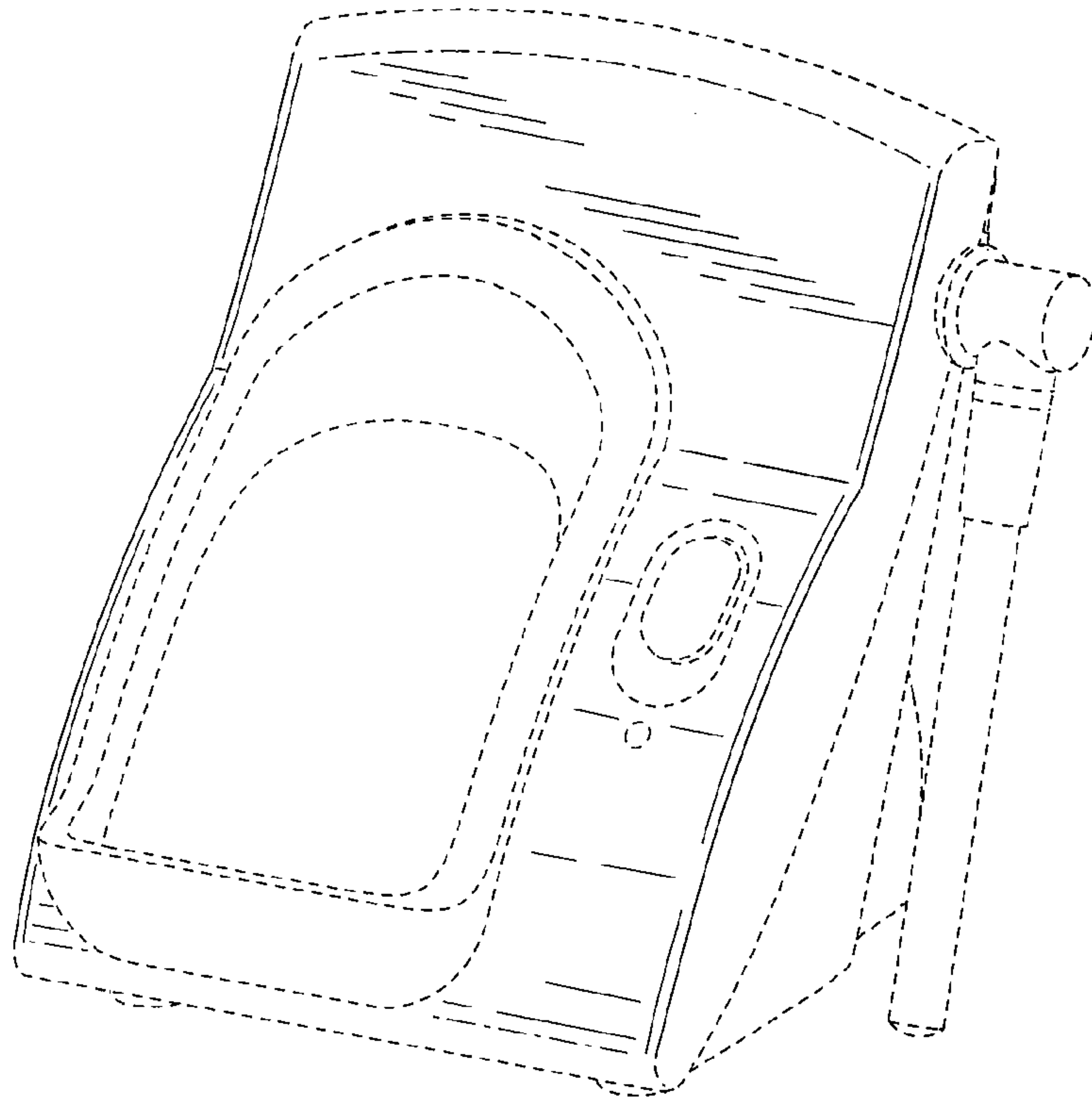

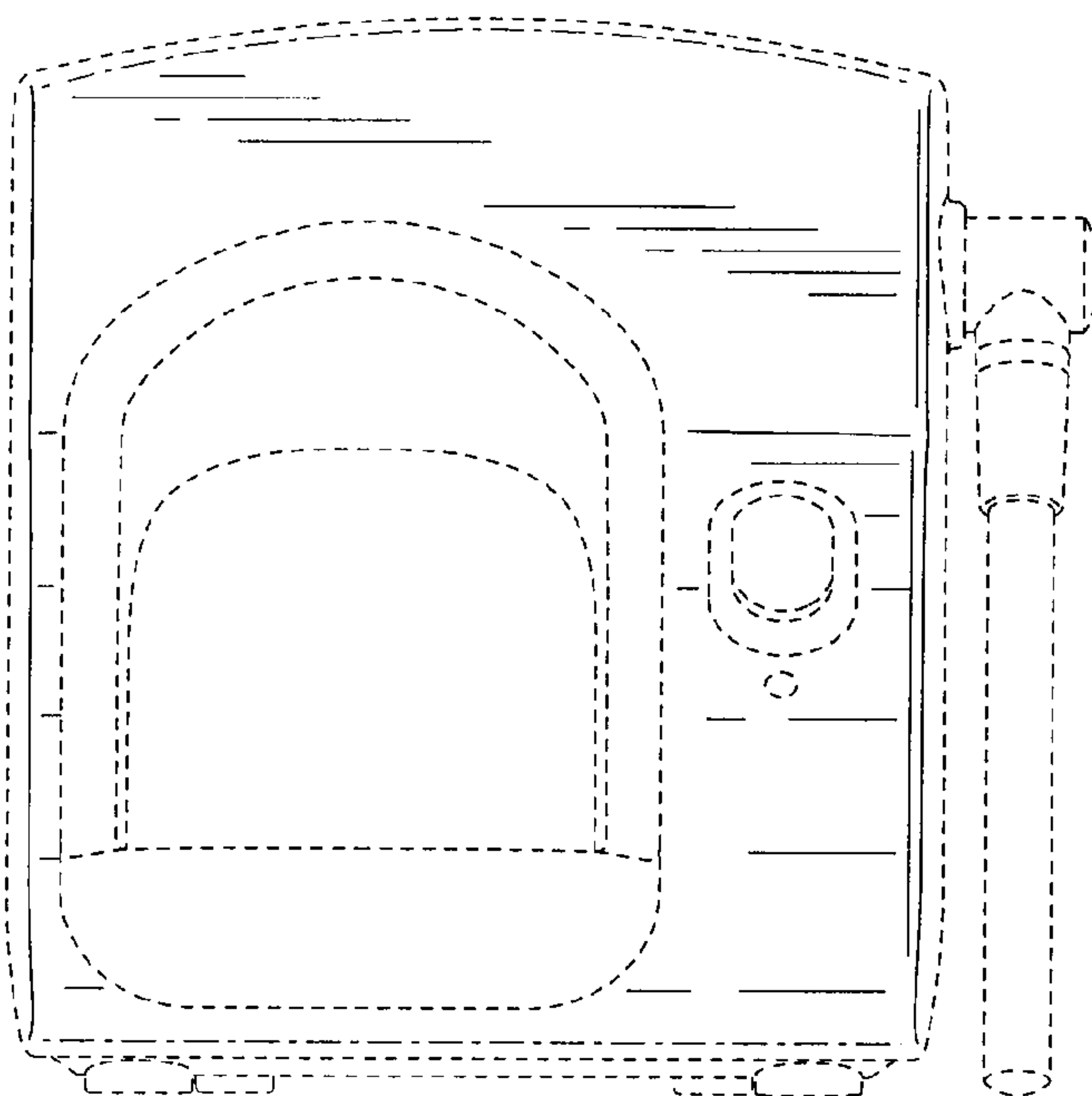

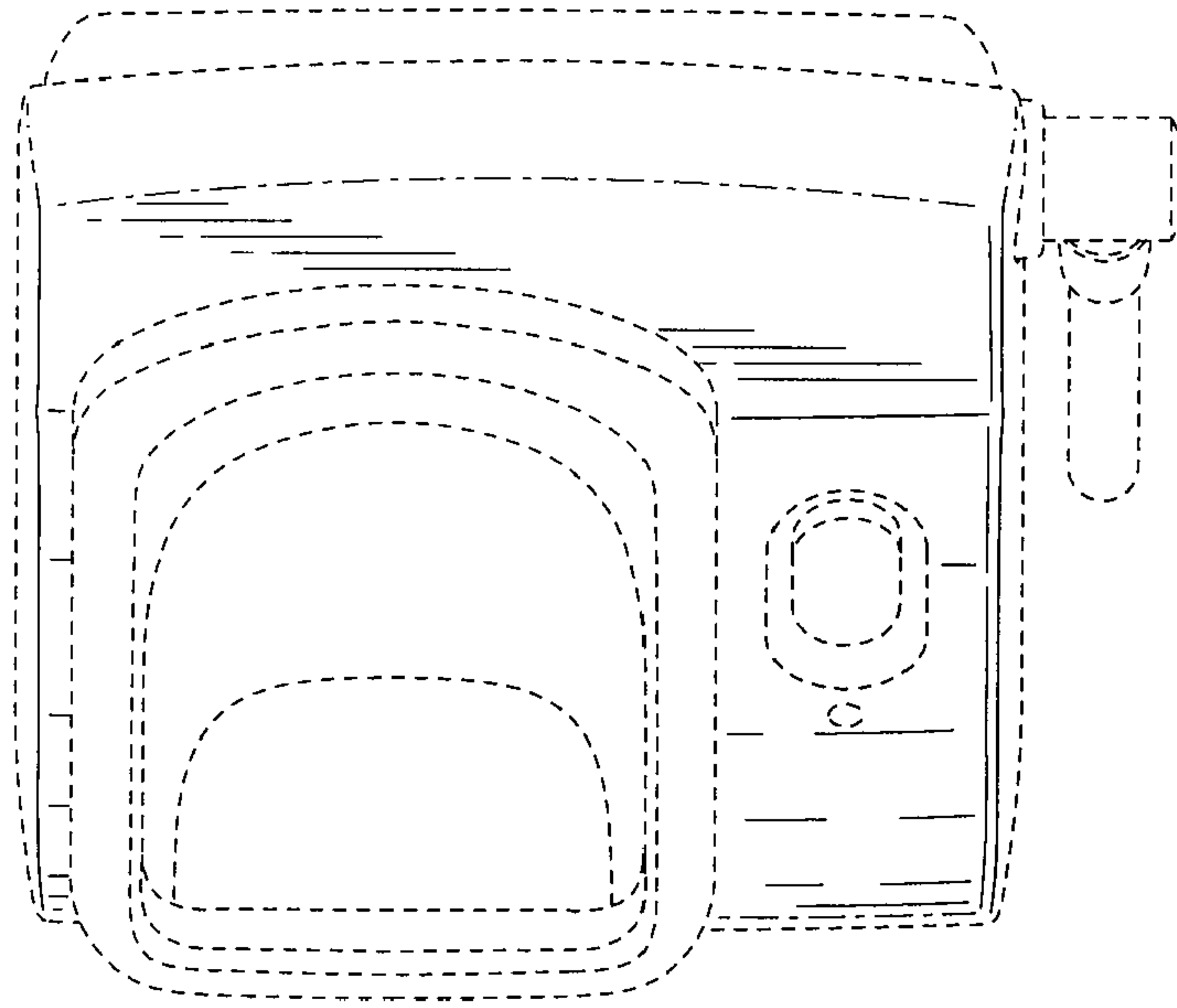

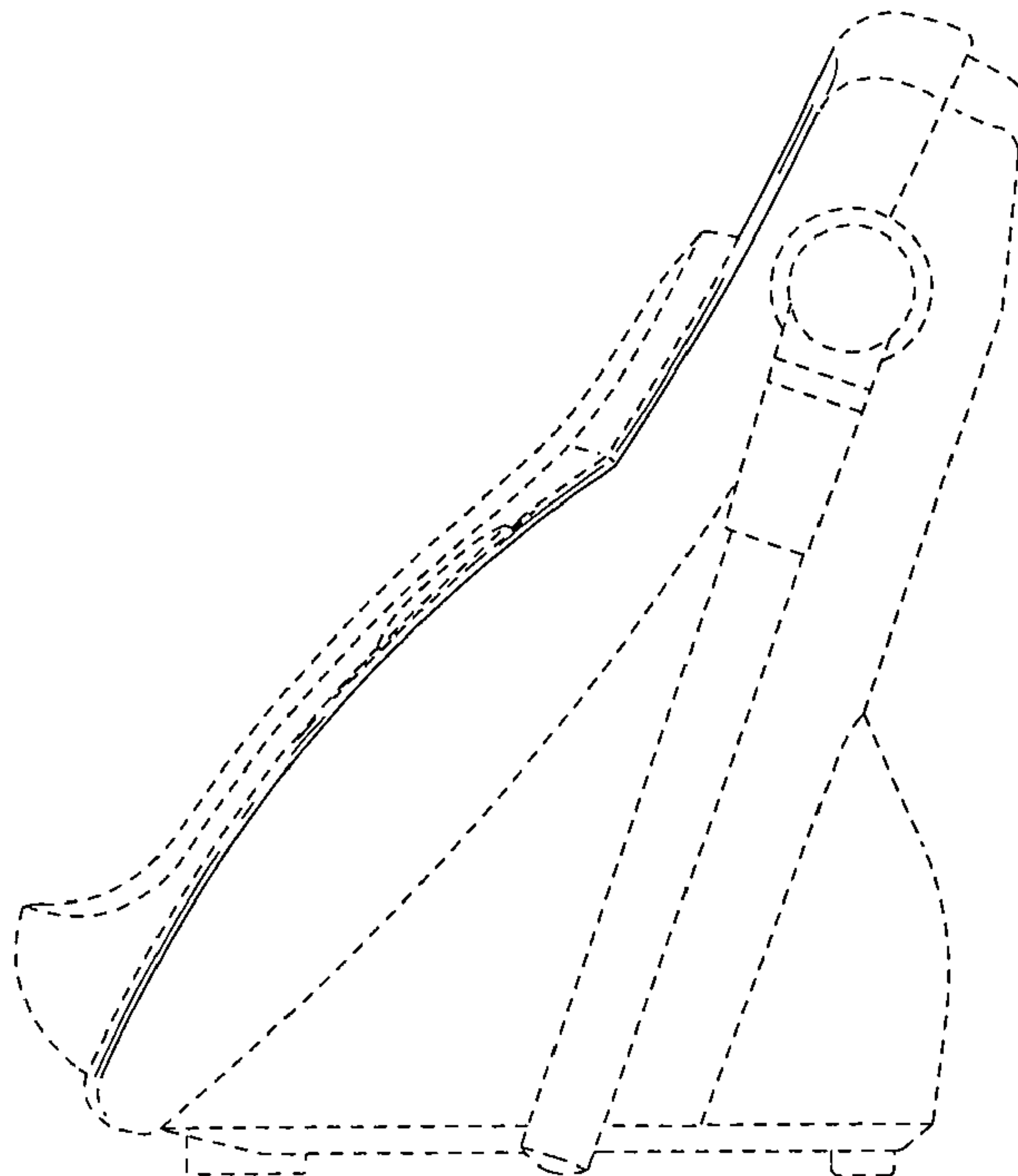

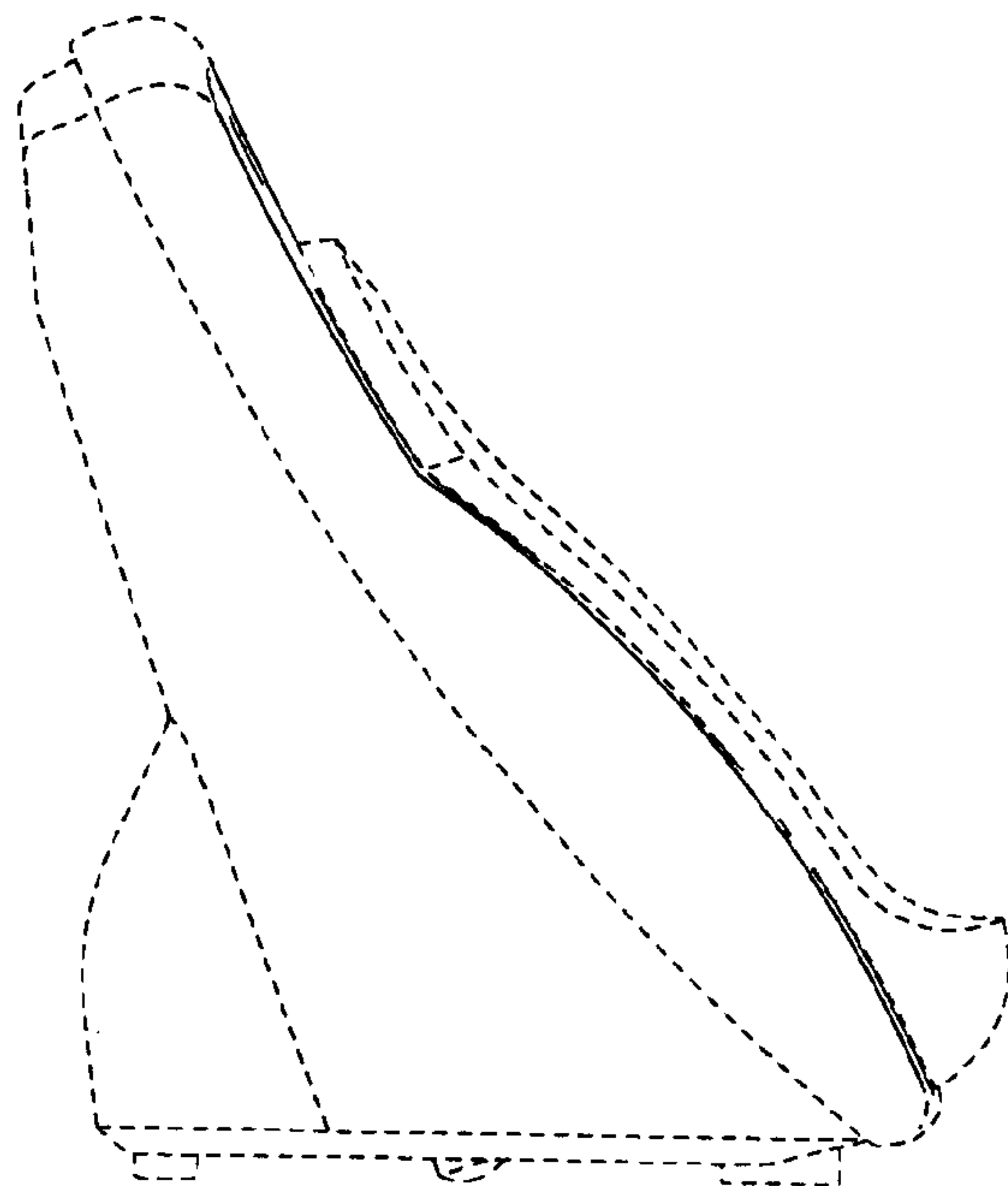

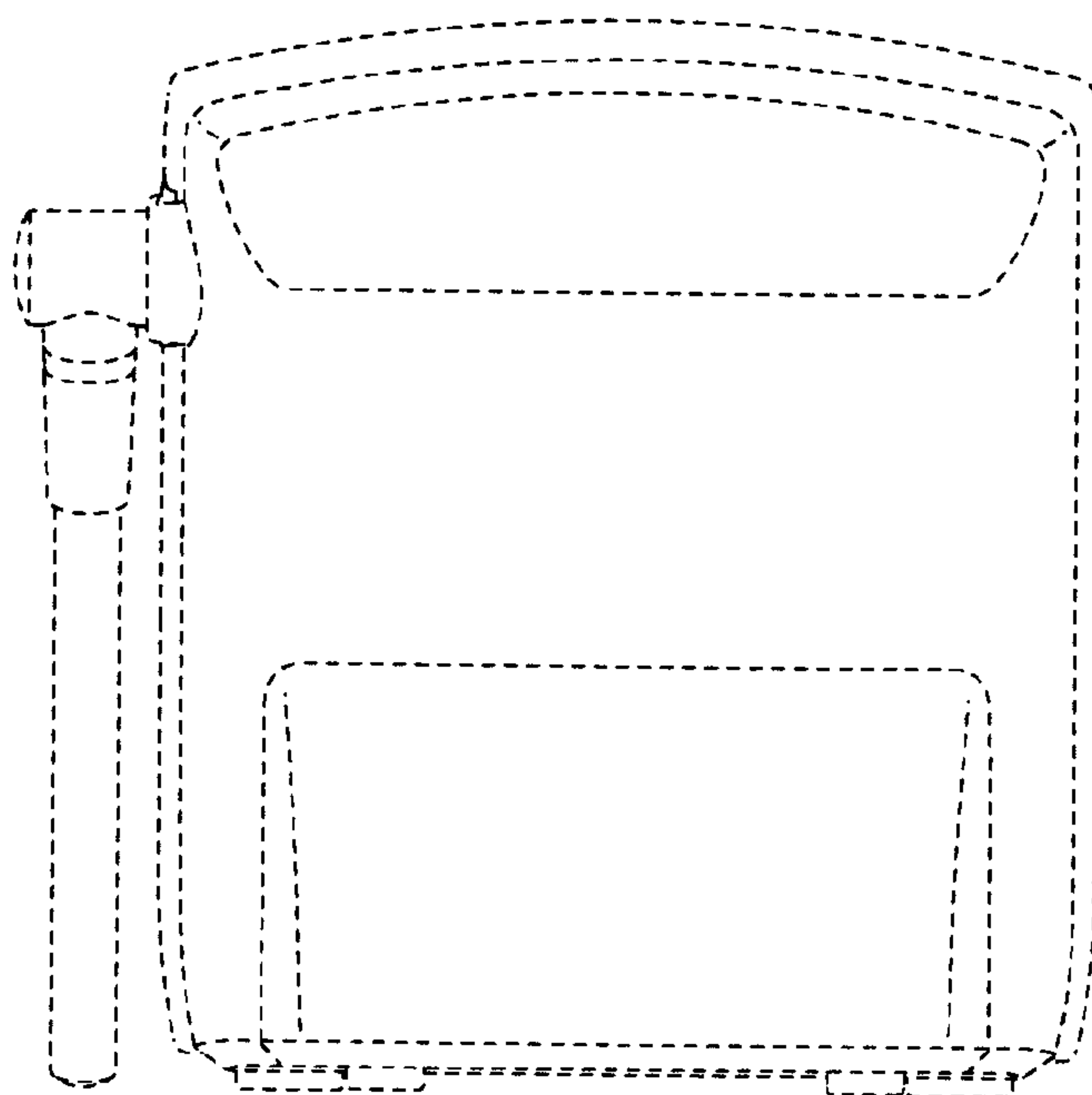

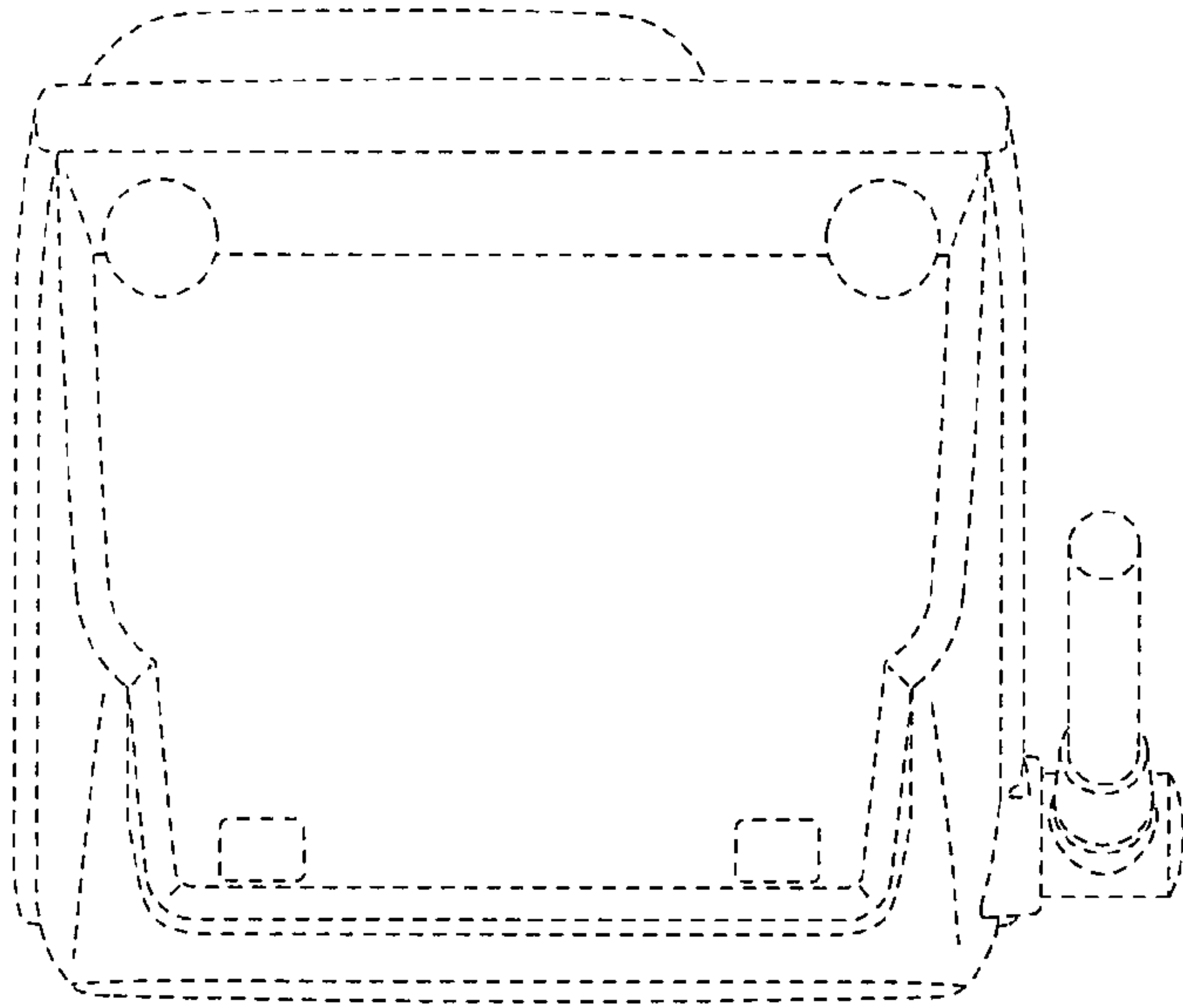

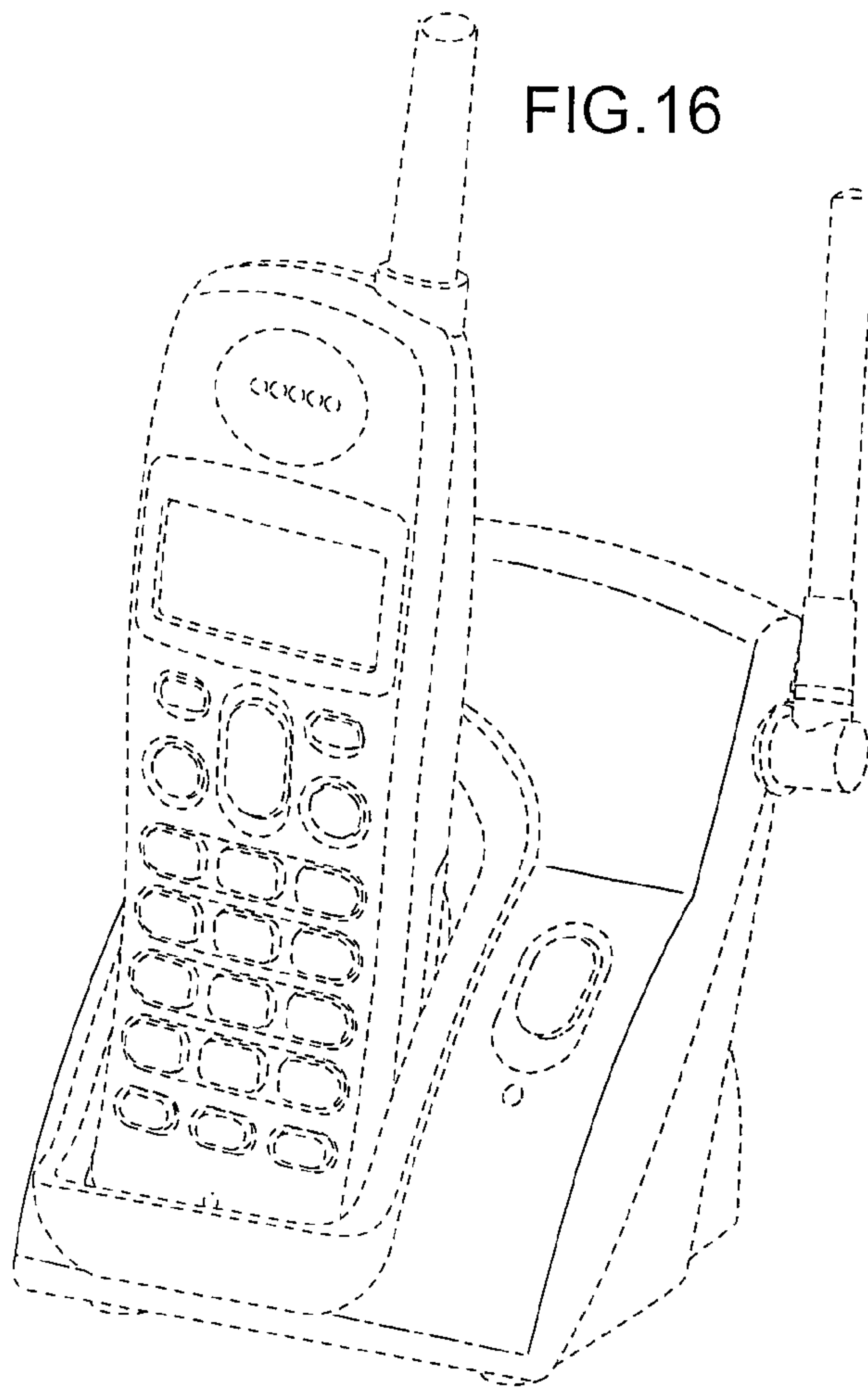

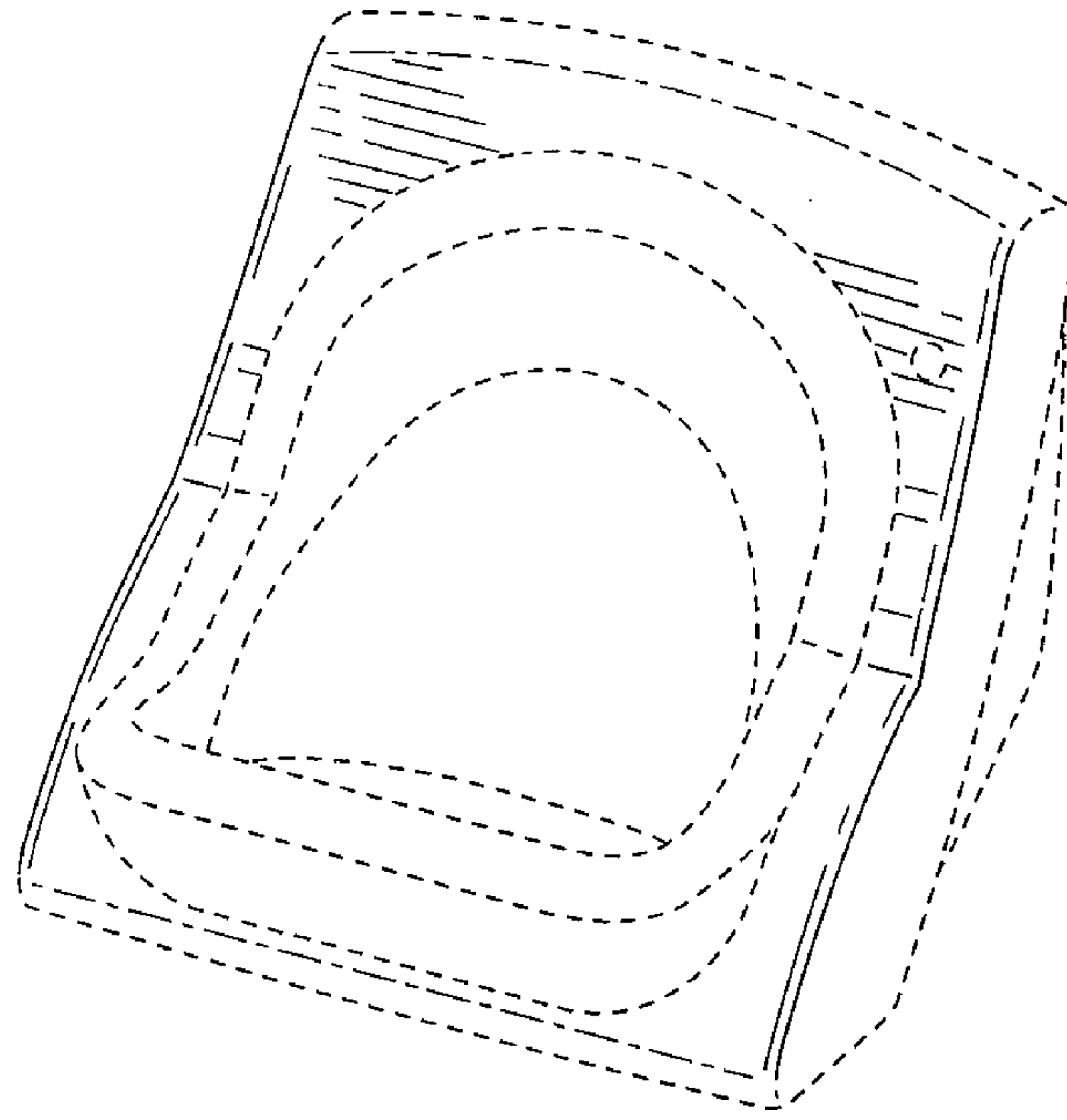

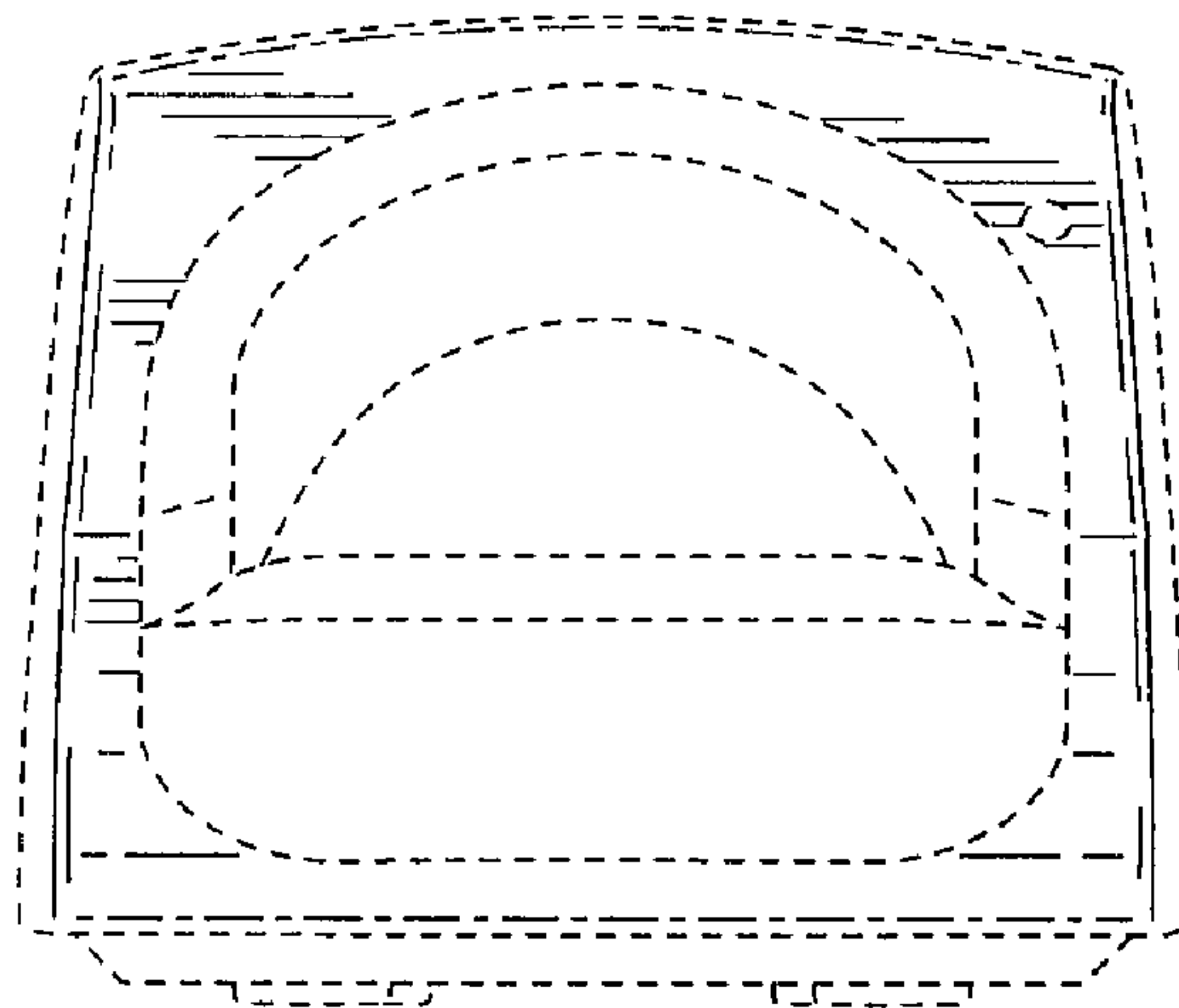

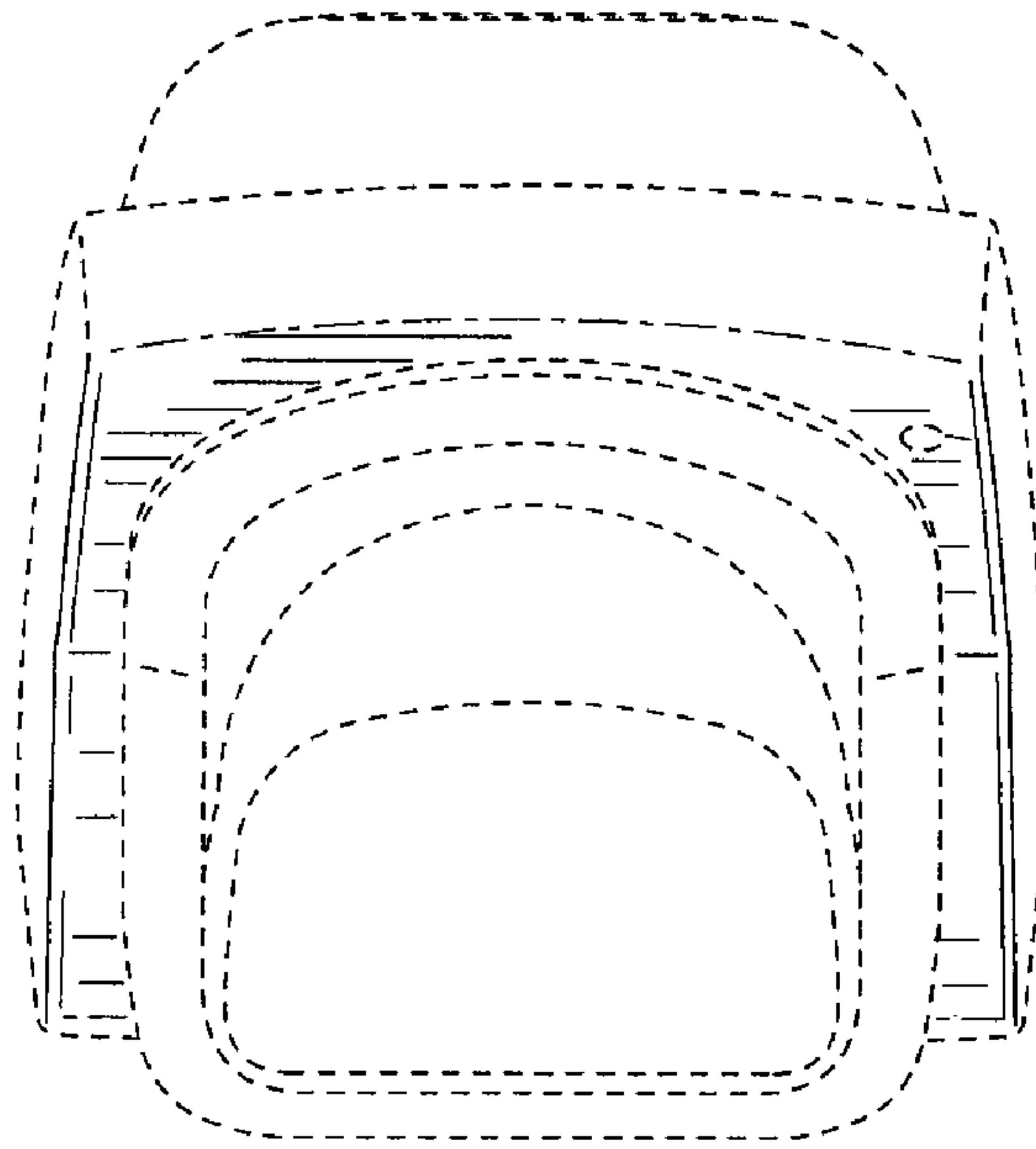

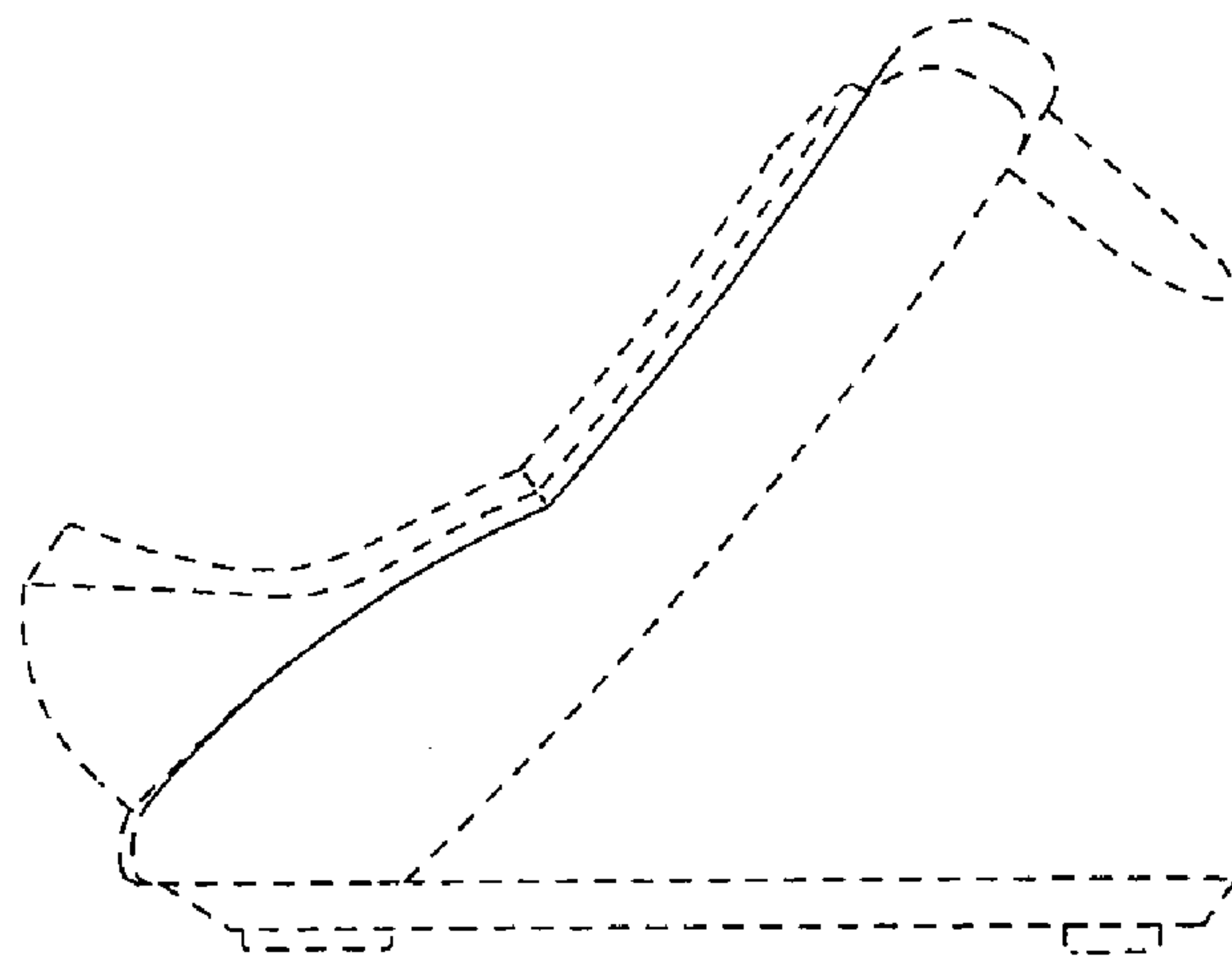

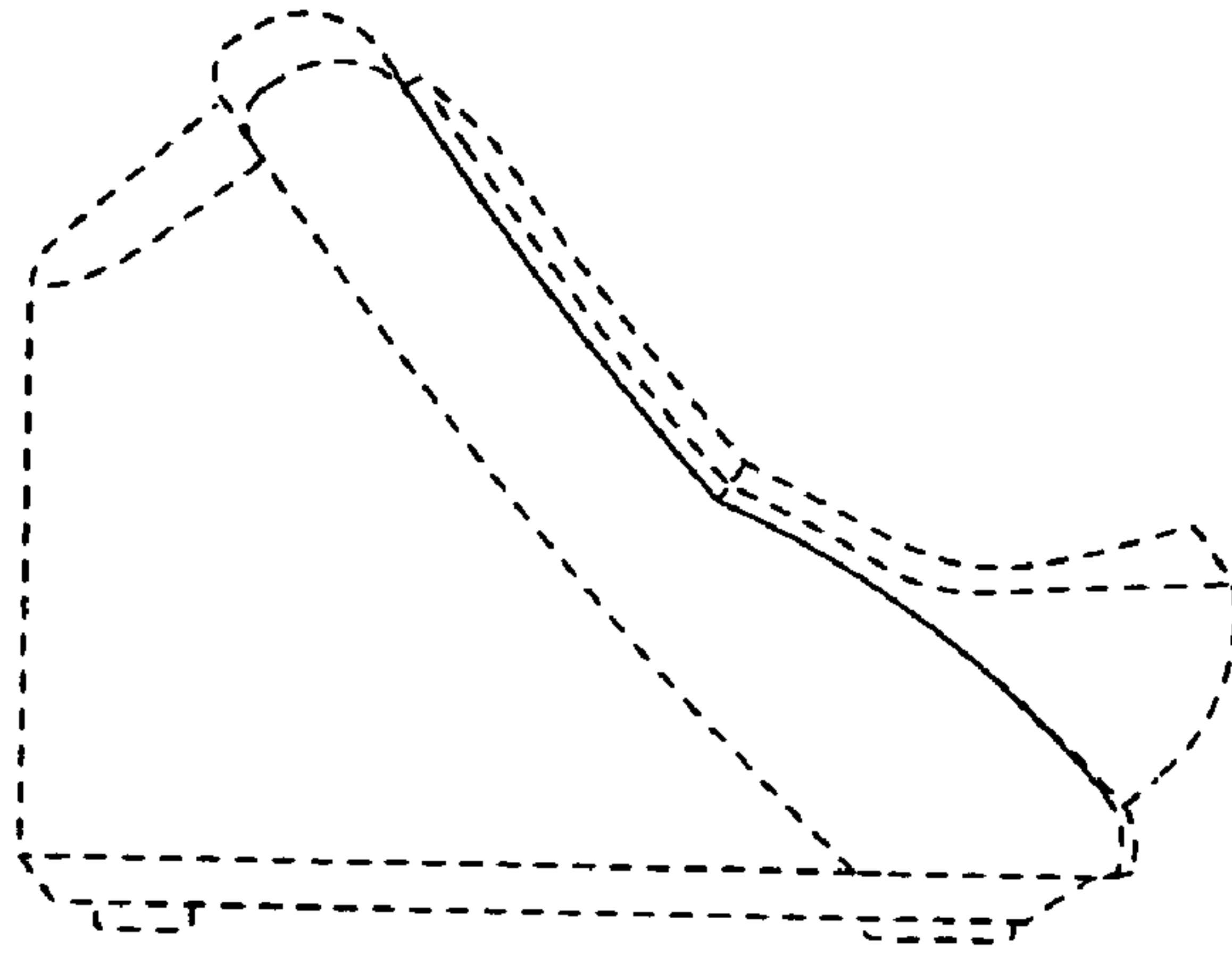

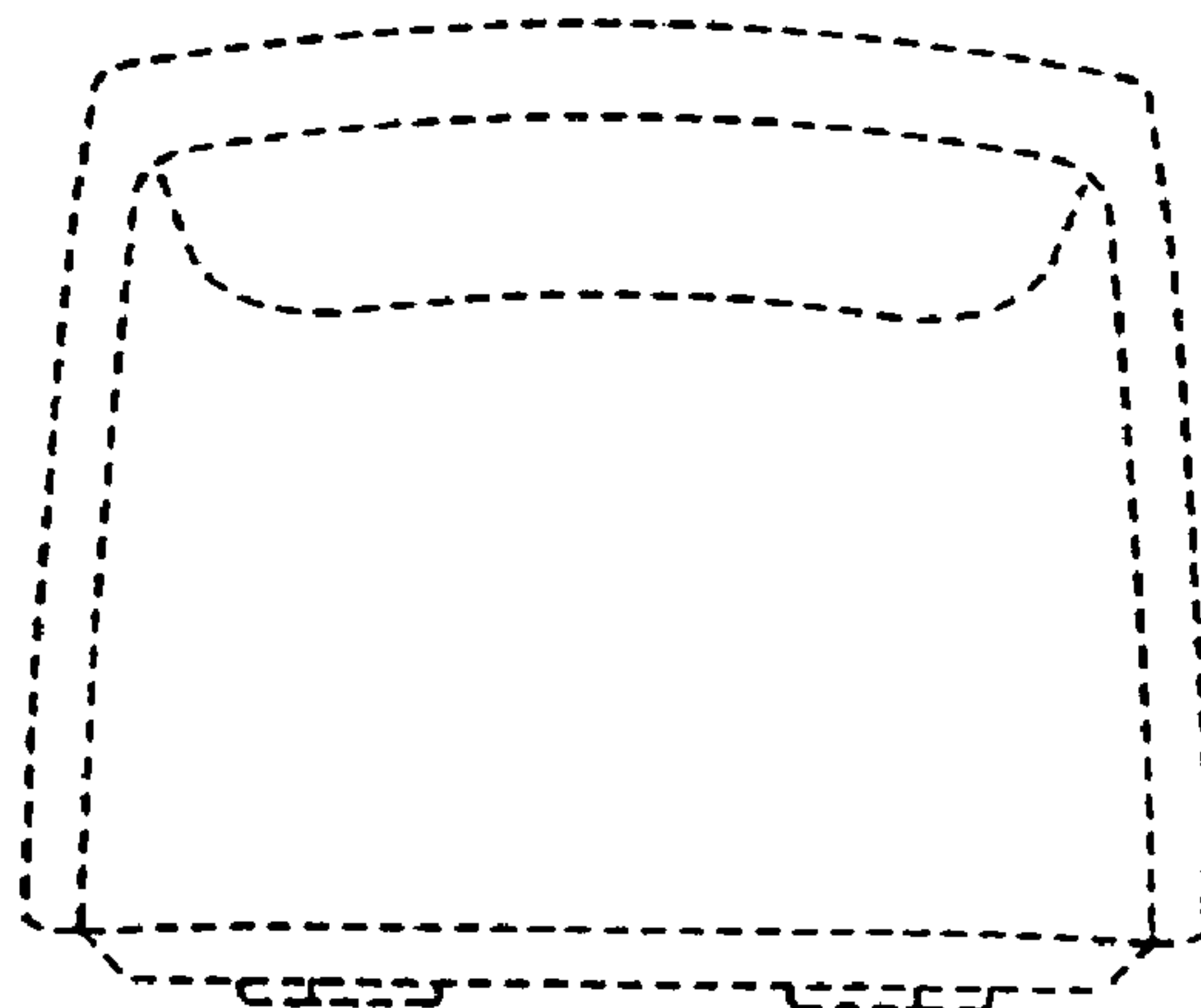

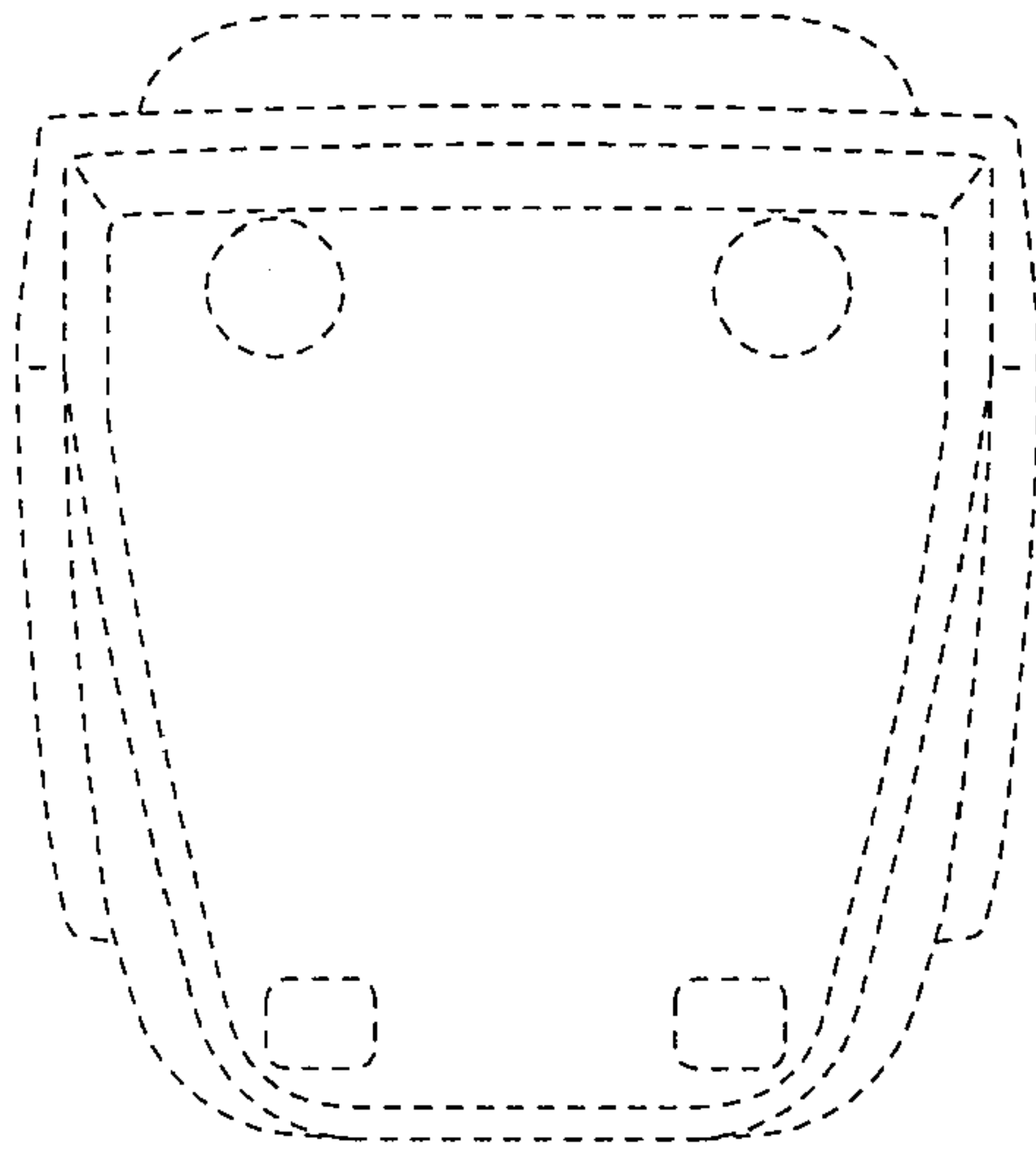
