I claim, the ornamental design for the combined electronic business card and stylus, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the combined electronic business card and stylus showing my new design;

FIG. 2 is a rear elevational view of the electronic business card thereof;

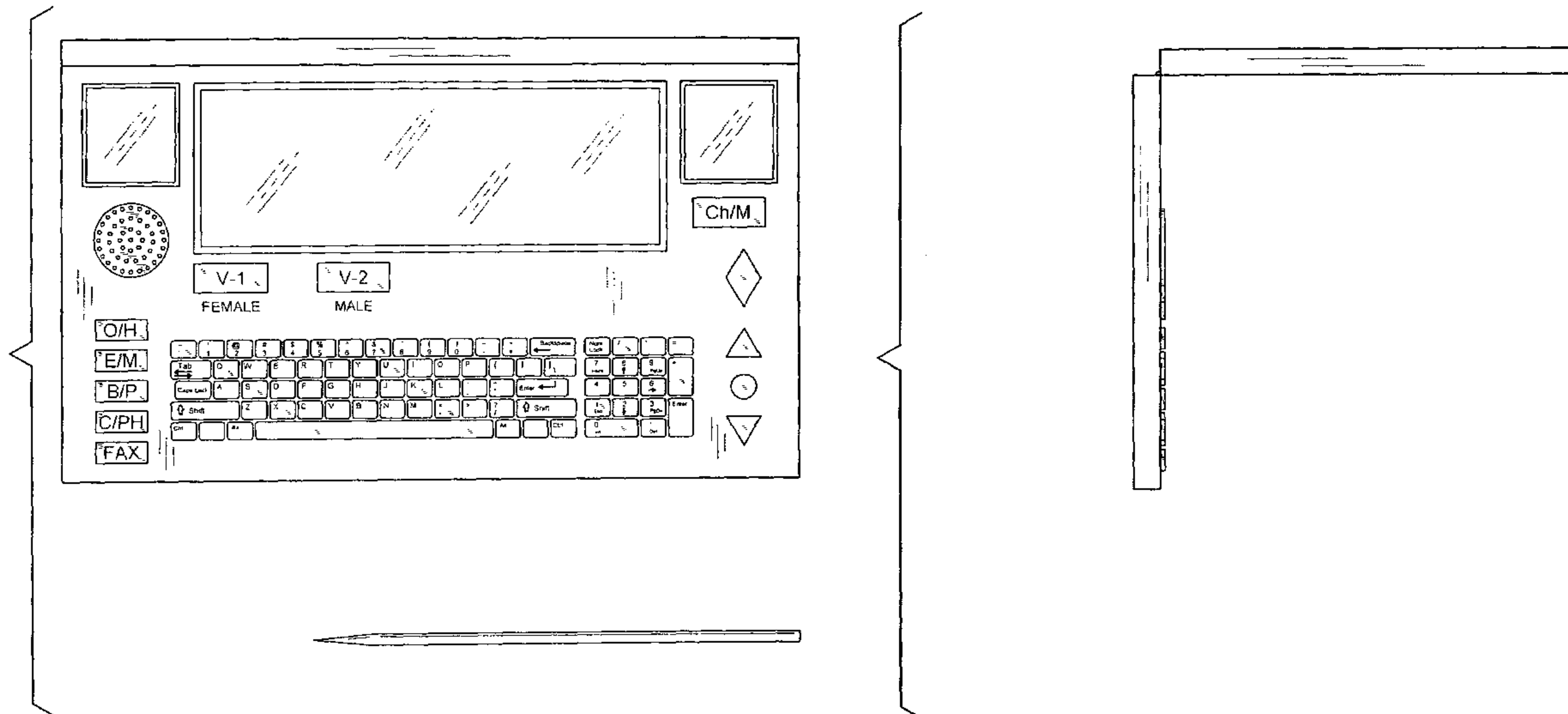
FIG. 3 is a left-side elevational view of the electronic business card thereof;

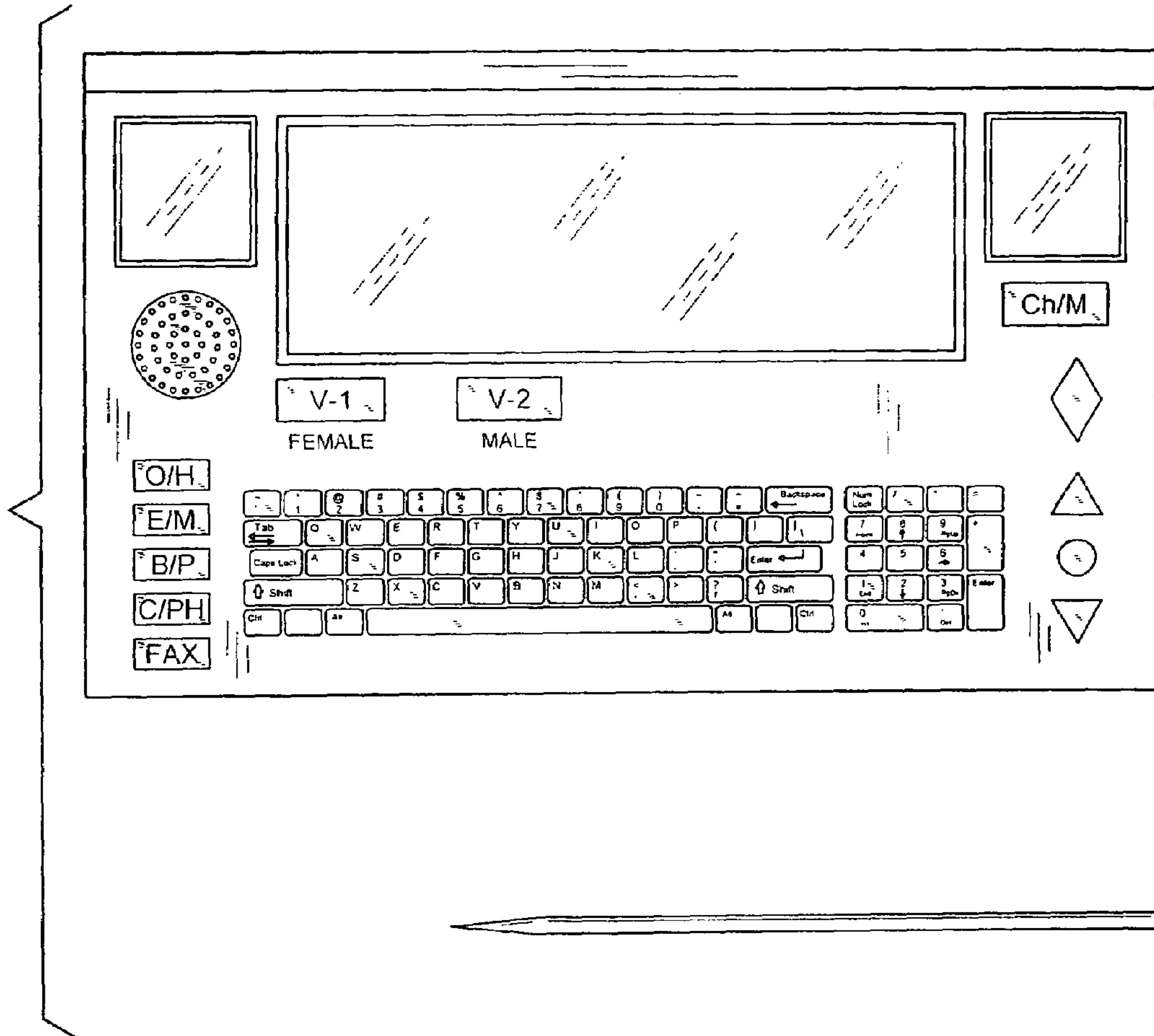

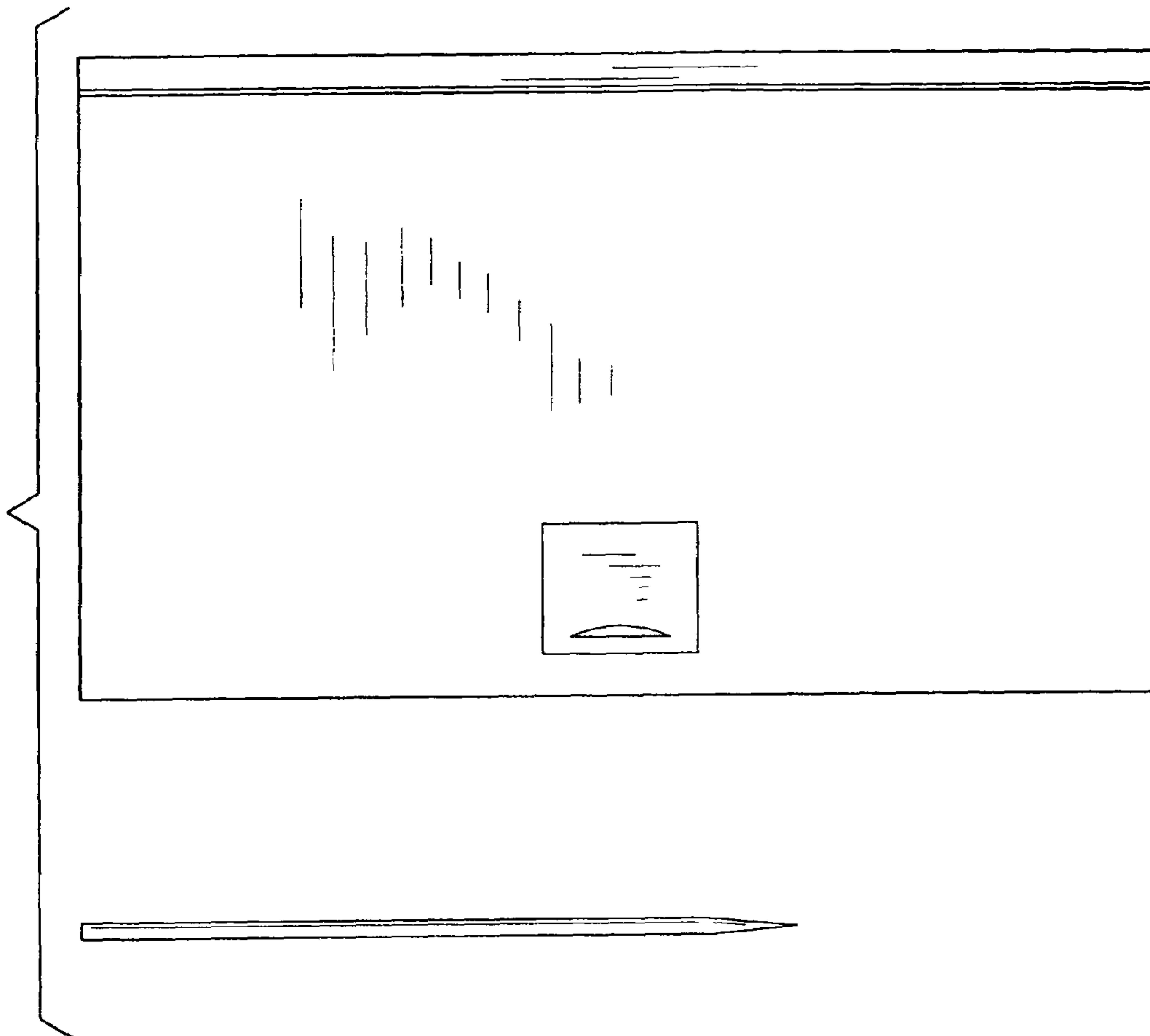

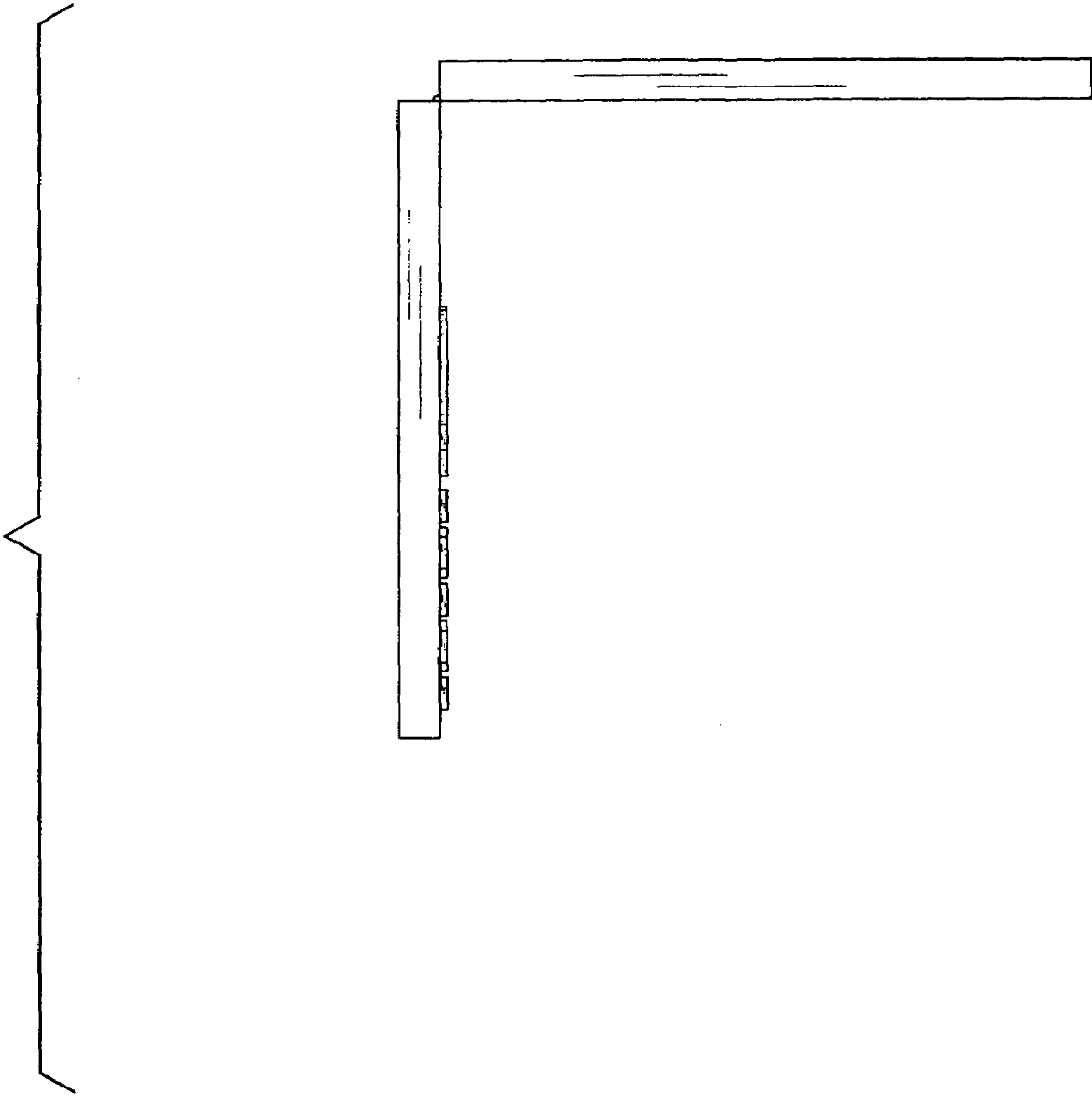

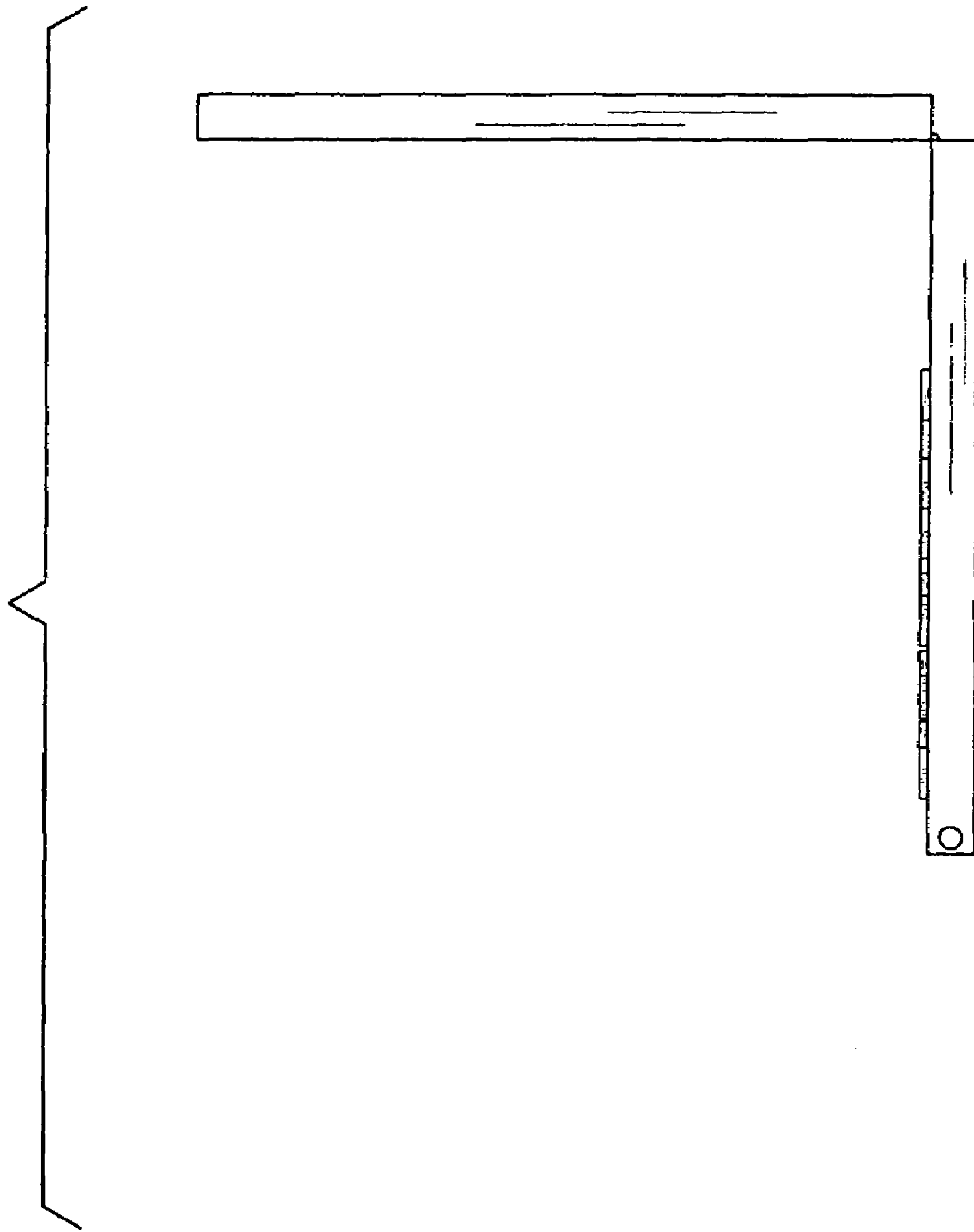

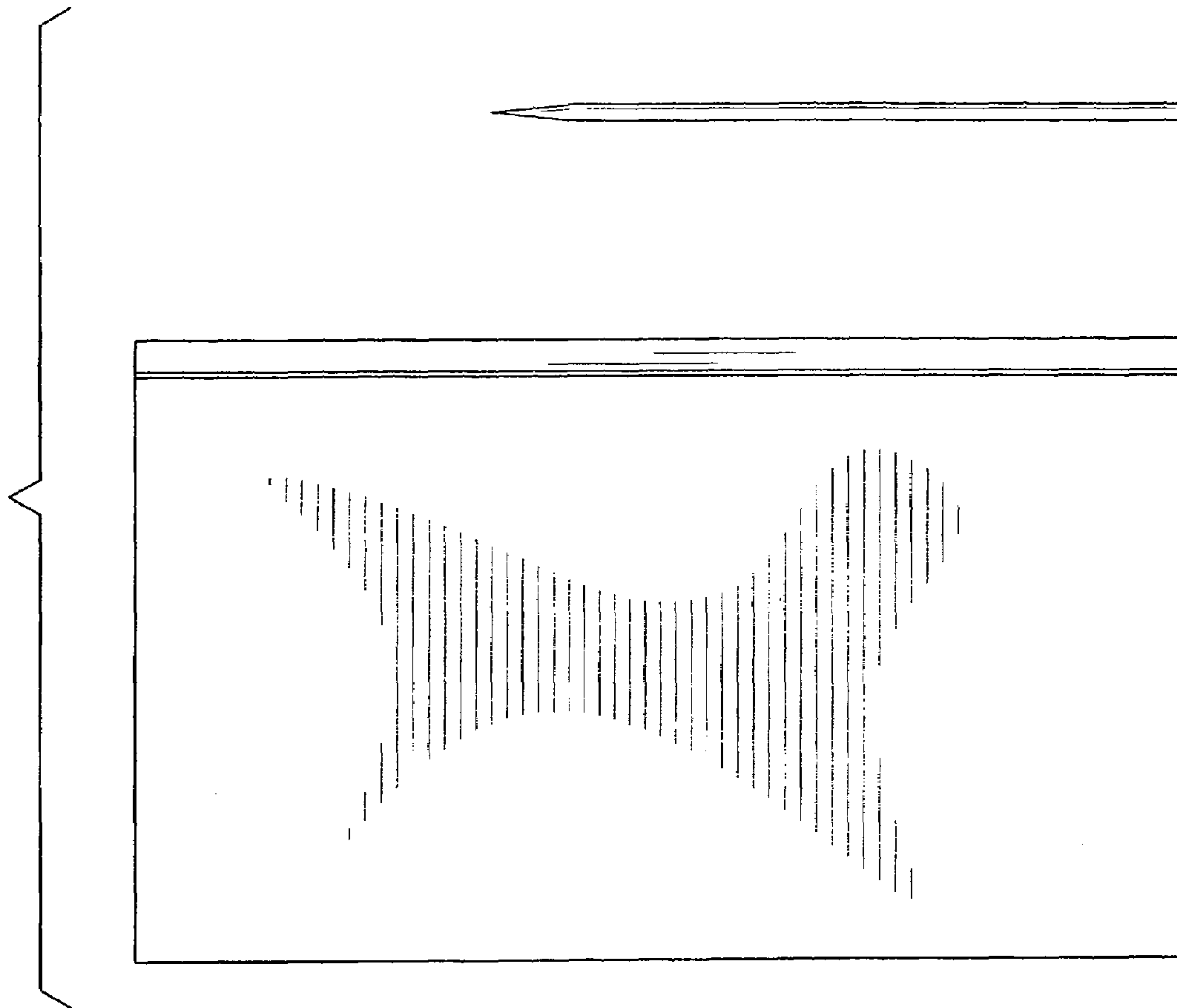

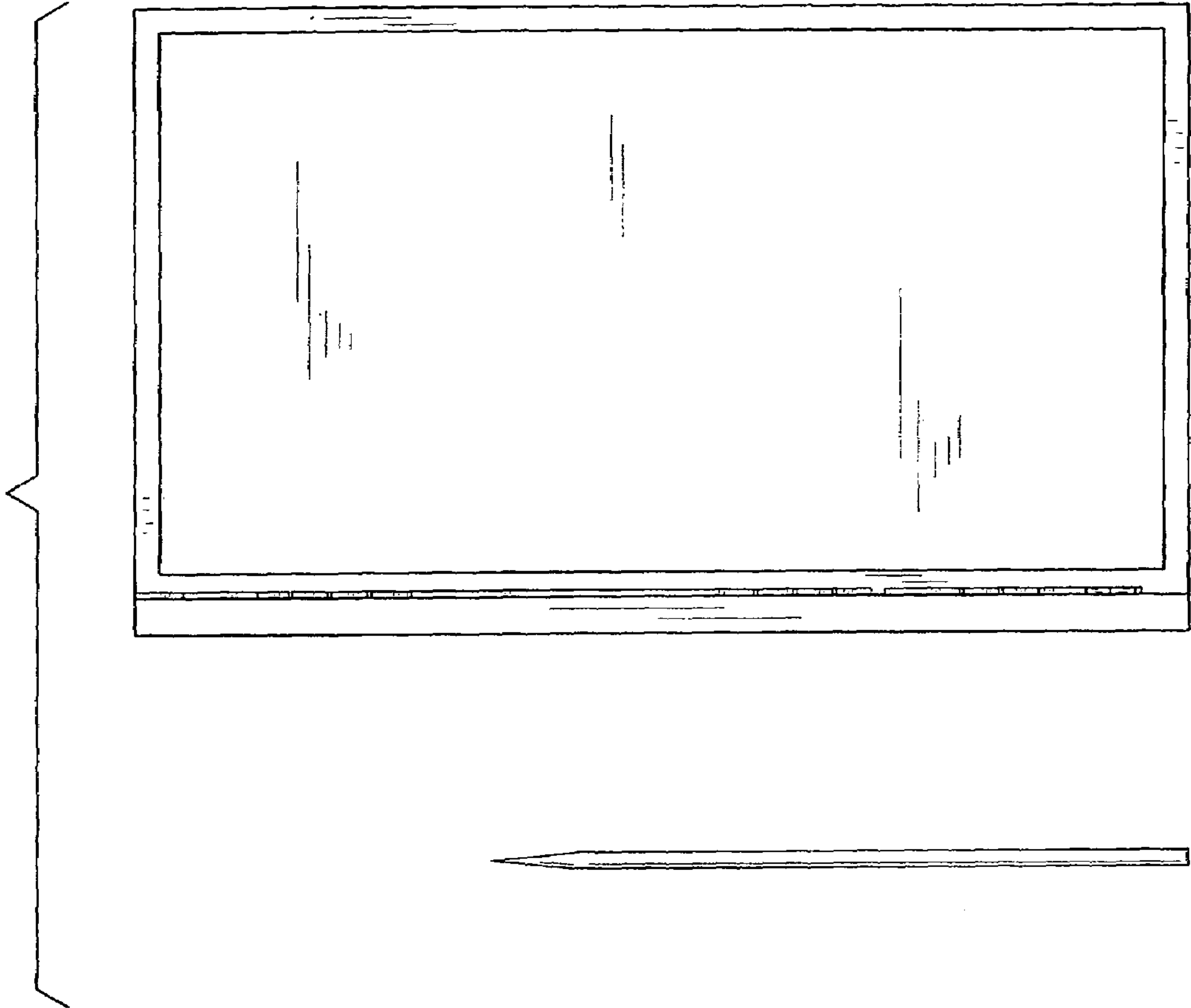
