FIG. 9 is a front view of FIG. 8.

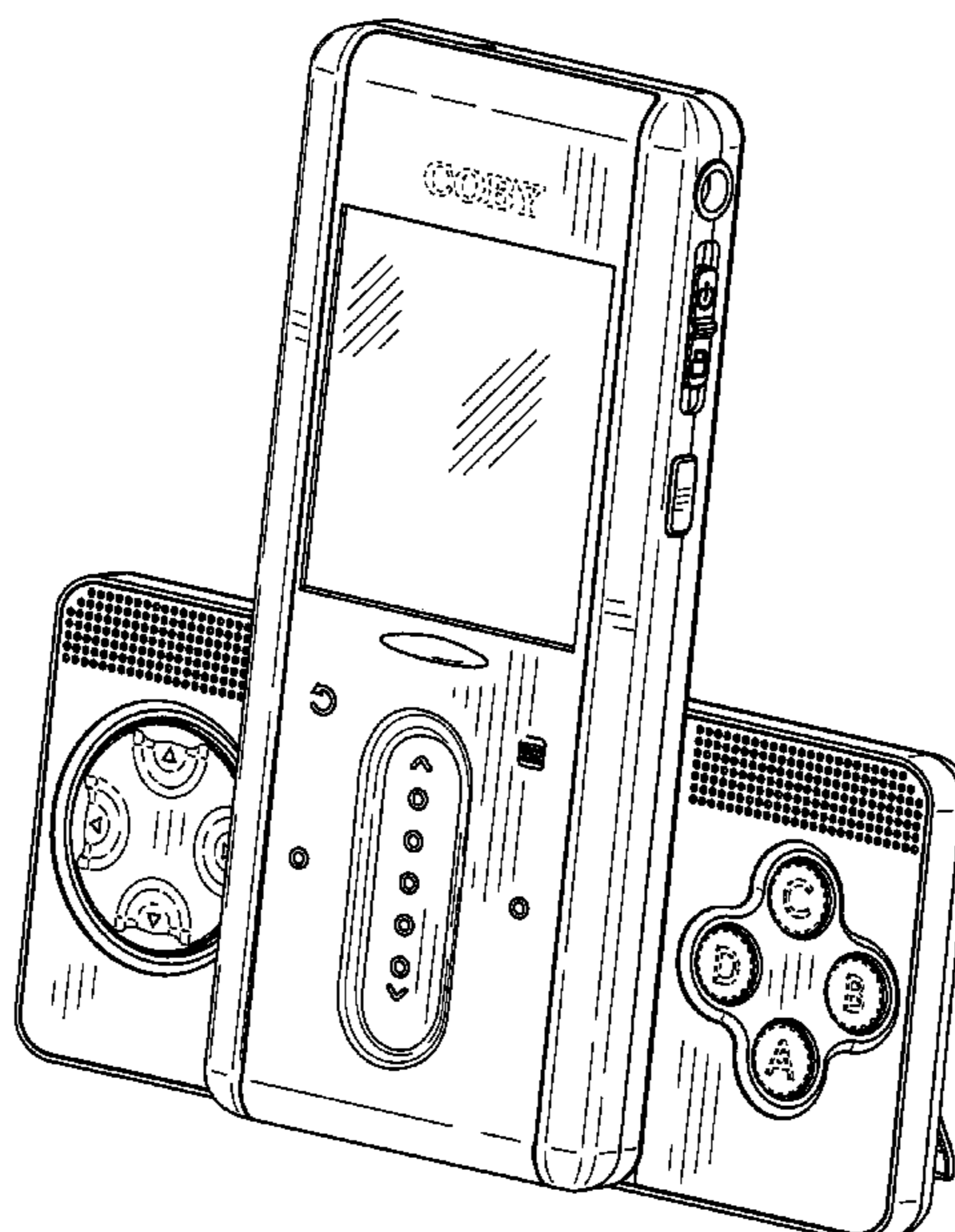

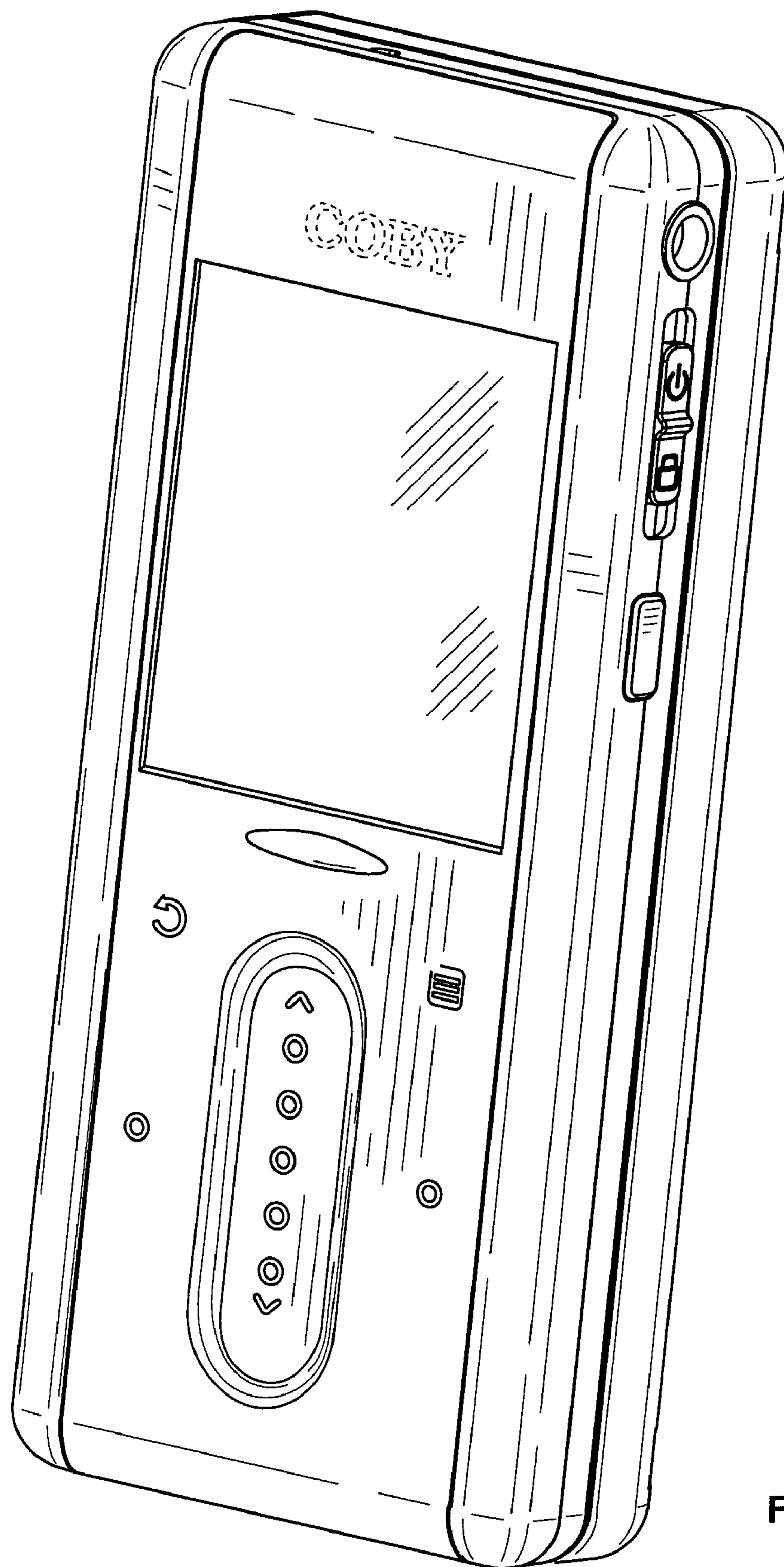

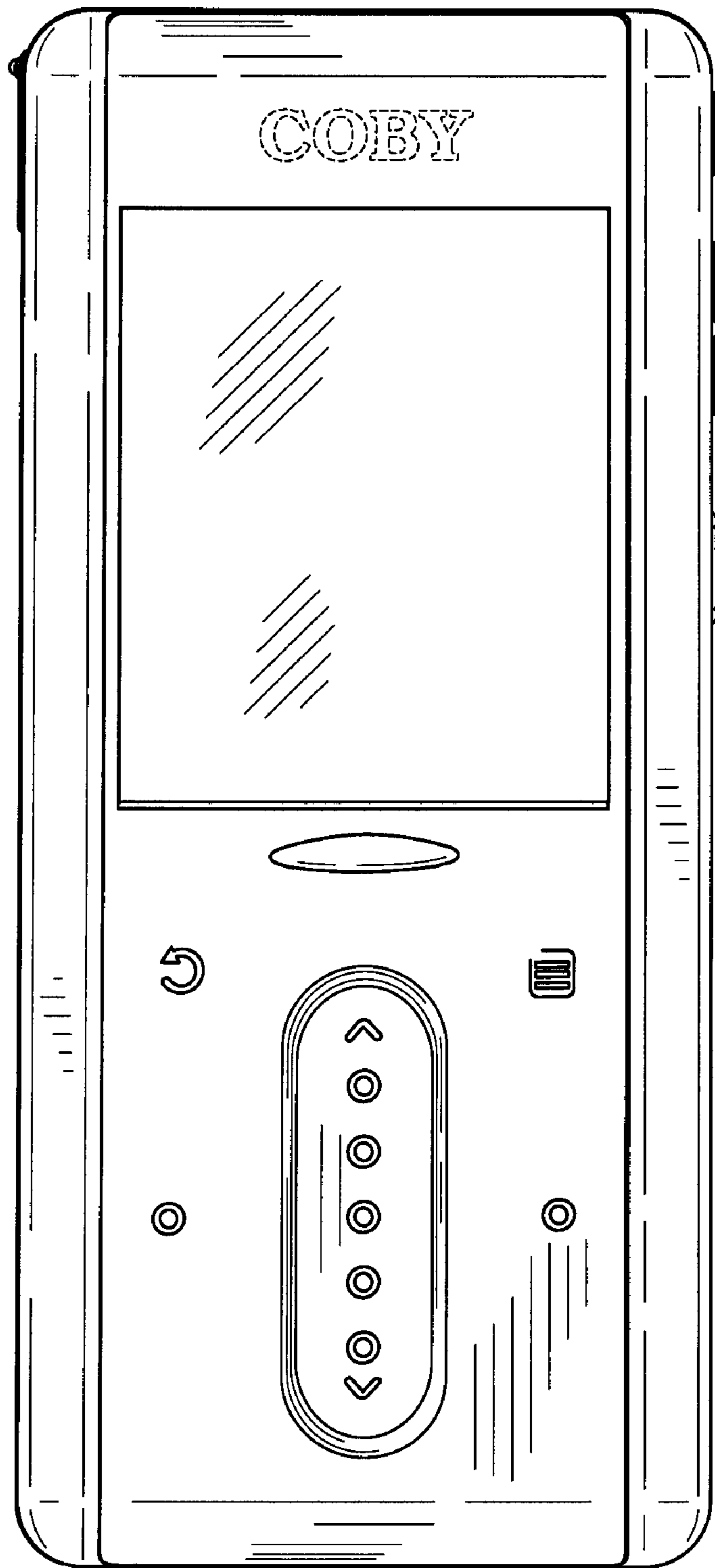

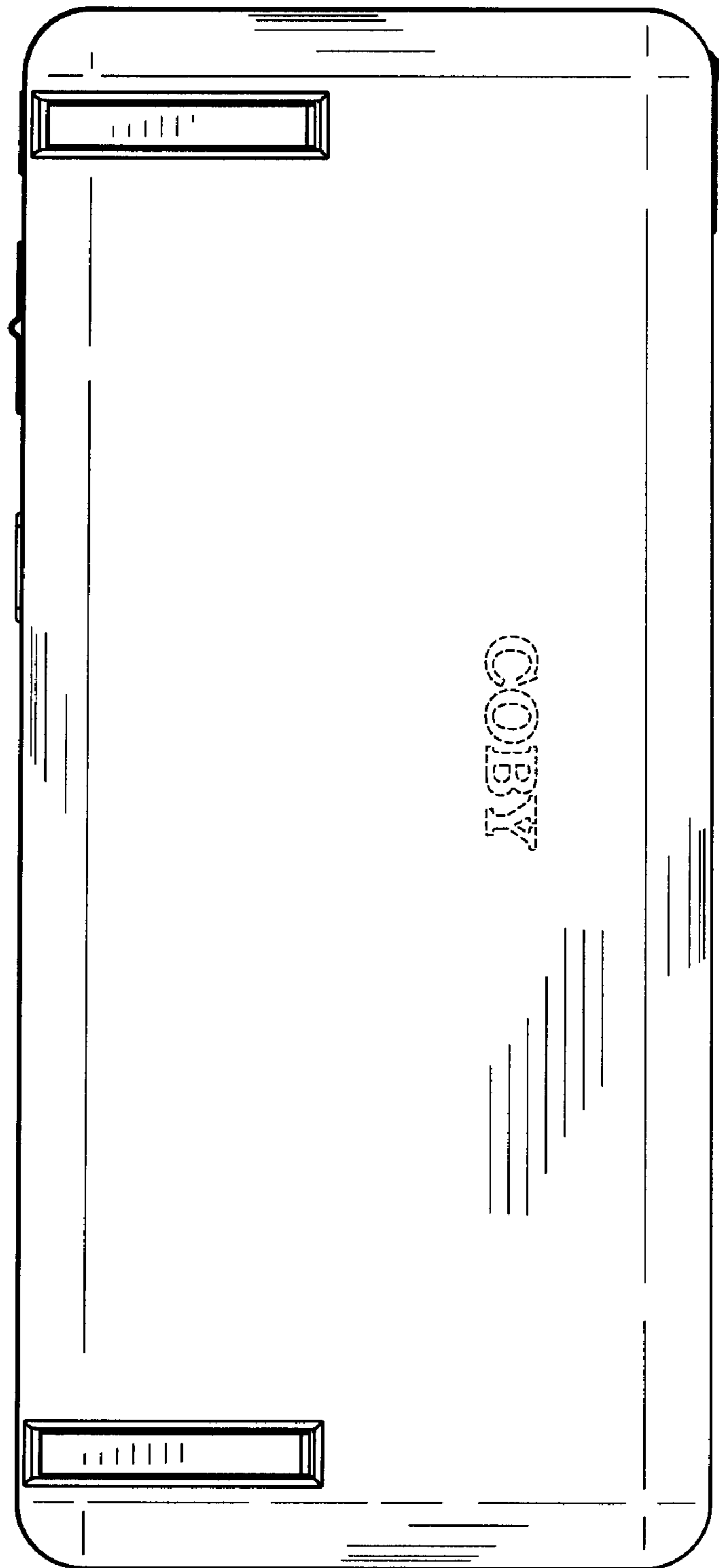

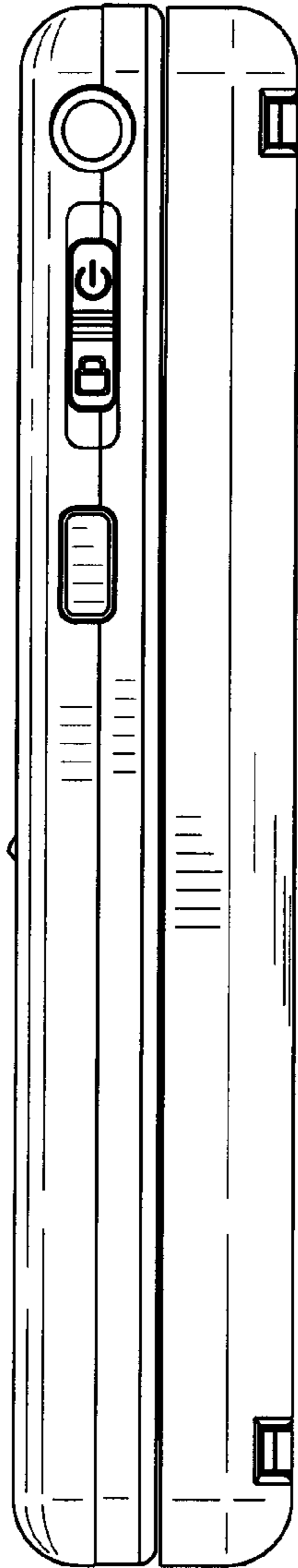

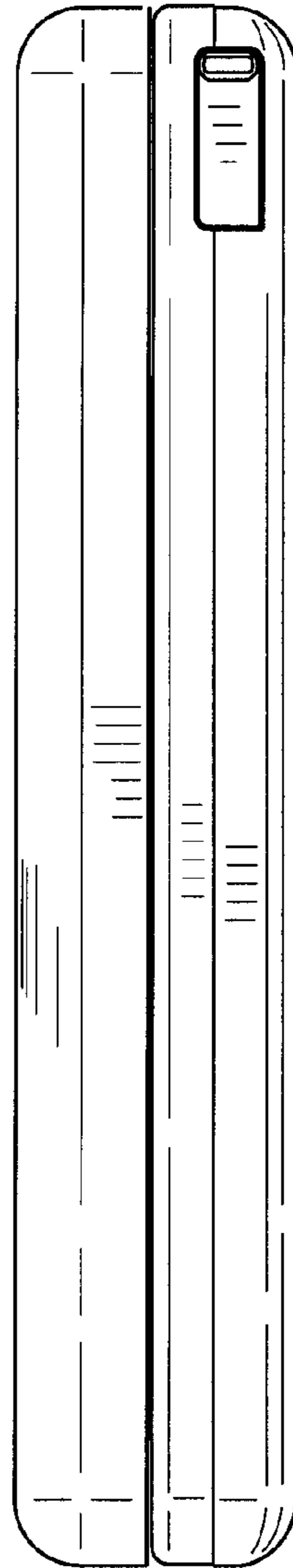

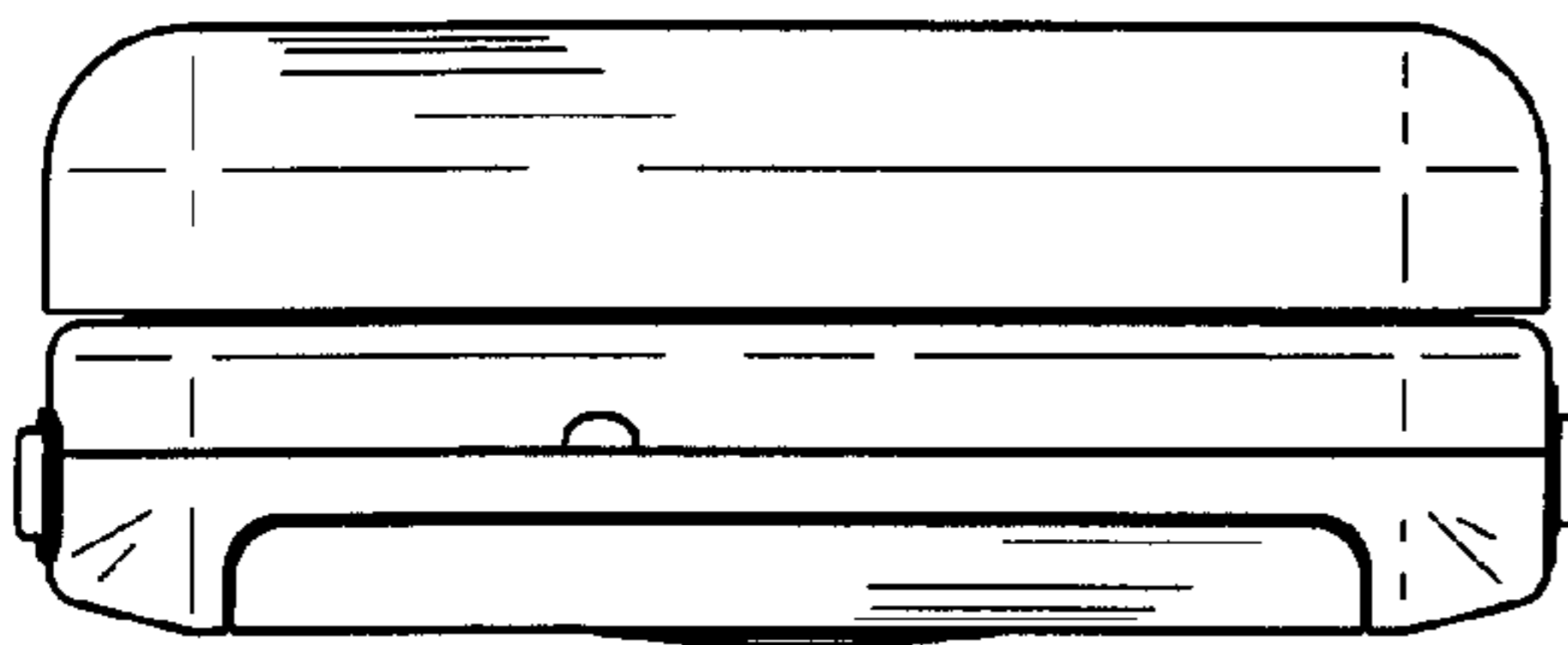

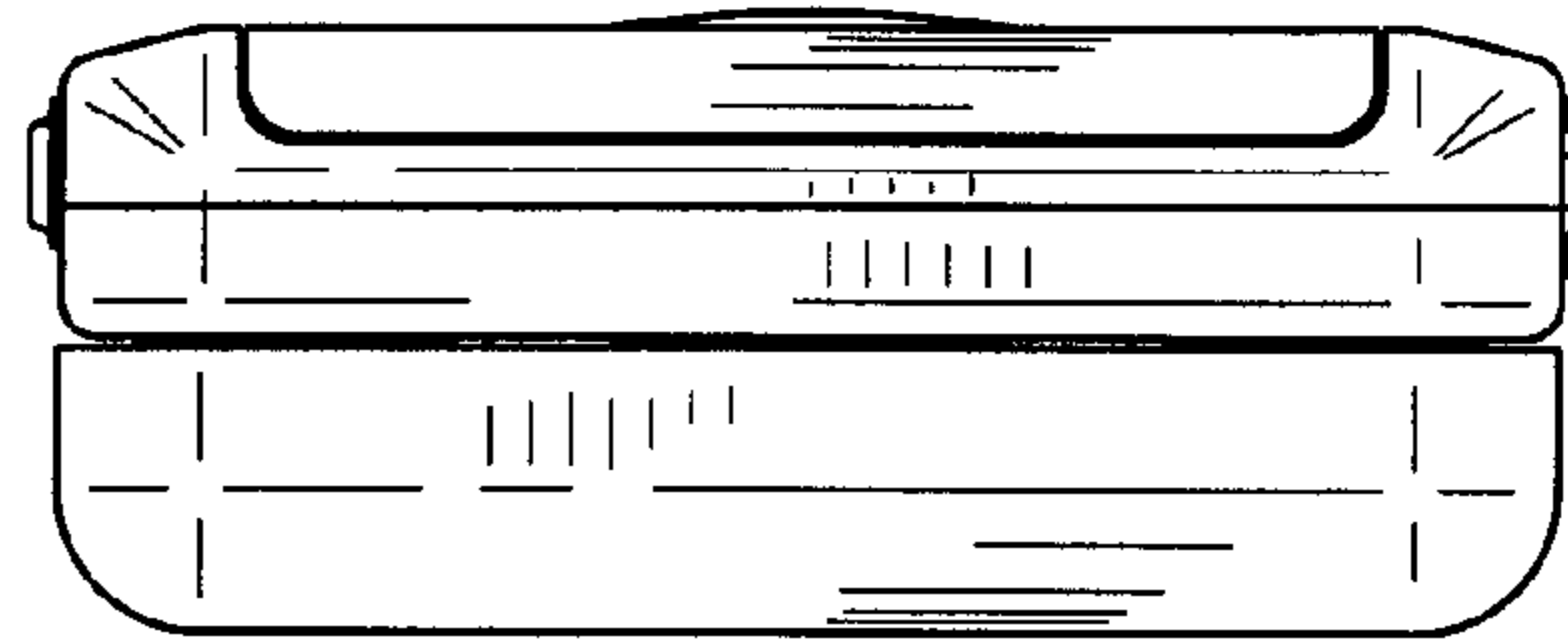

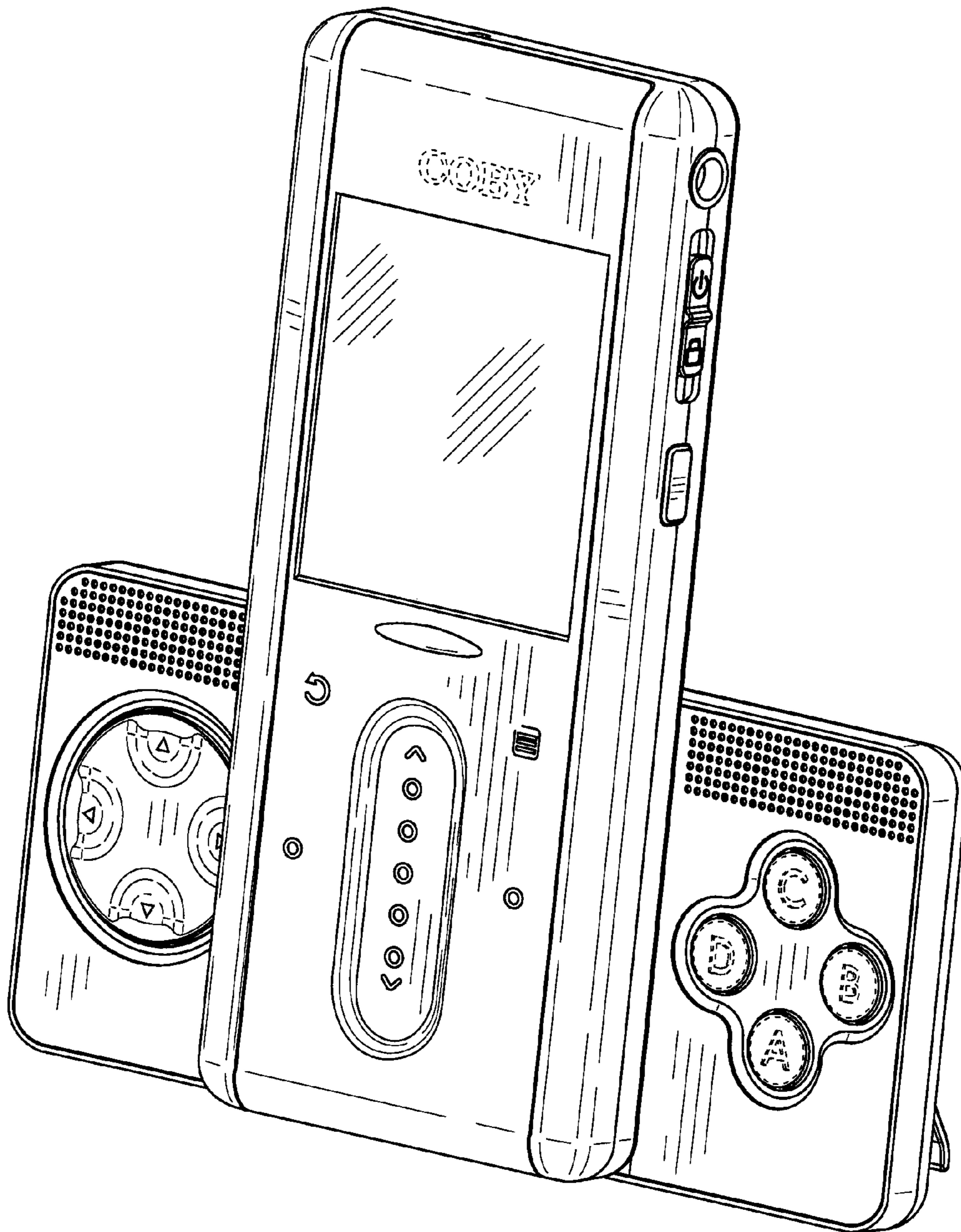

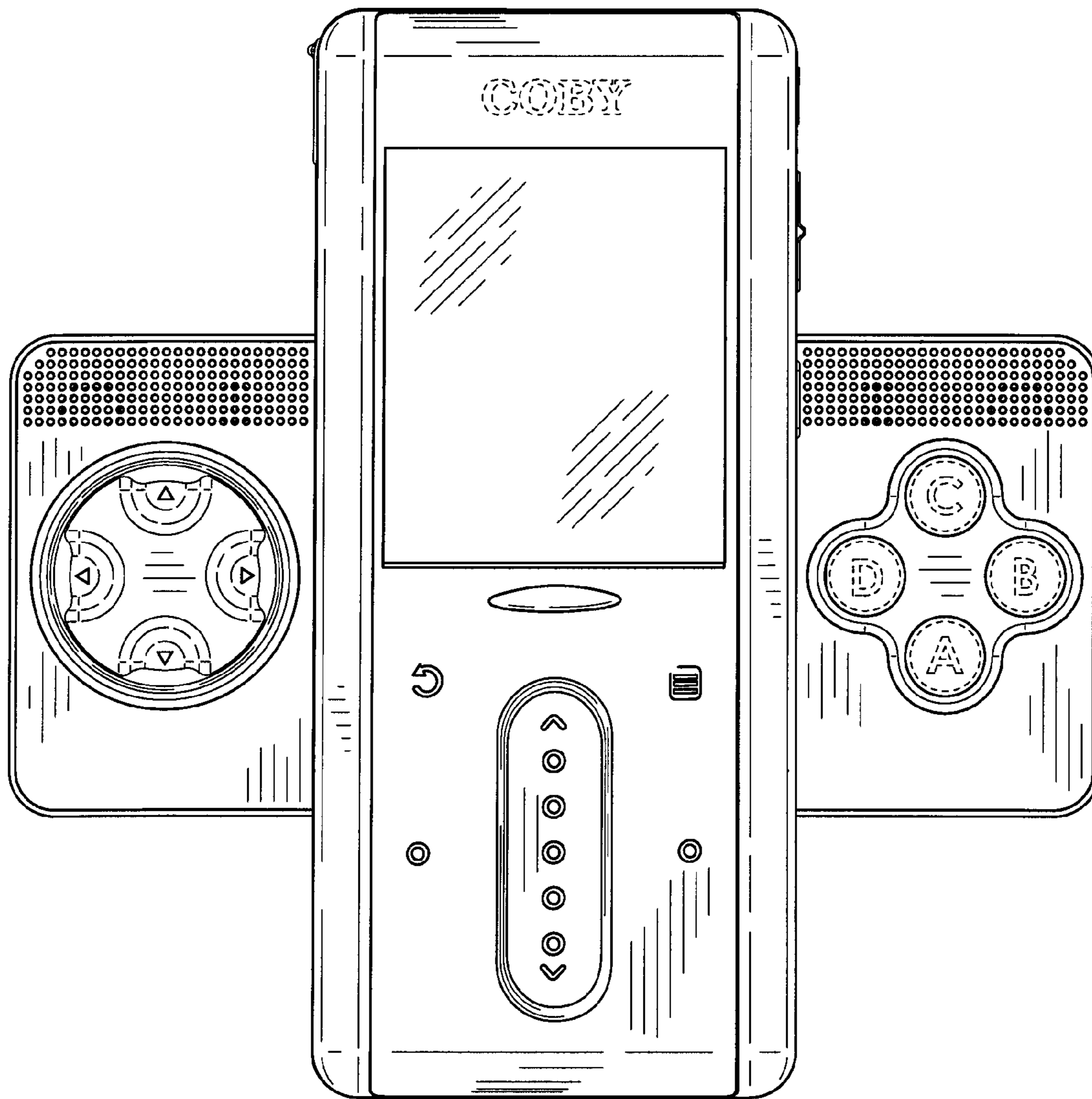
