(57) **CLAIM**

The ornamental design for a backhoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a right rear perspective view of the backhoe showing our new design. The part of the photograph shown in coarse dot pattern and outlined in dashed lines illustrates a portion of the backhoe that forms no part of the claimed design;

FIG. 2 is a left rear perspective view thereof. The part of the photograph shown in coarse dot pattern and outlined in dashed lines illustrates a portion of the backhoe that forms no part of the claimed design;

FIG. 3 is a front view thereof. The part of the photograph shown in coarse dot pattern and outlined in dashed lines illustrates a portion of the backhoe that forms no part of the claimed design;

FIG. 4 is a top plan view thereof. The part of the photograph shown in coarse dot pattern and outlined in dashed lines illustrates a portion of the backhoe that forms no part of the claimed design;

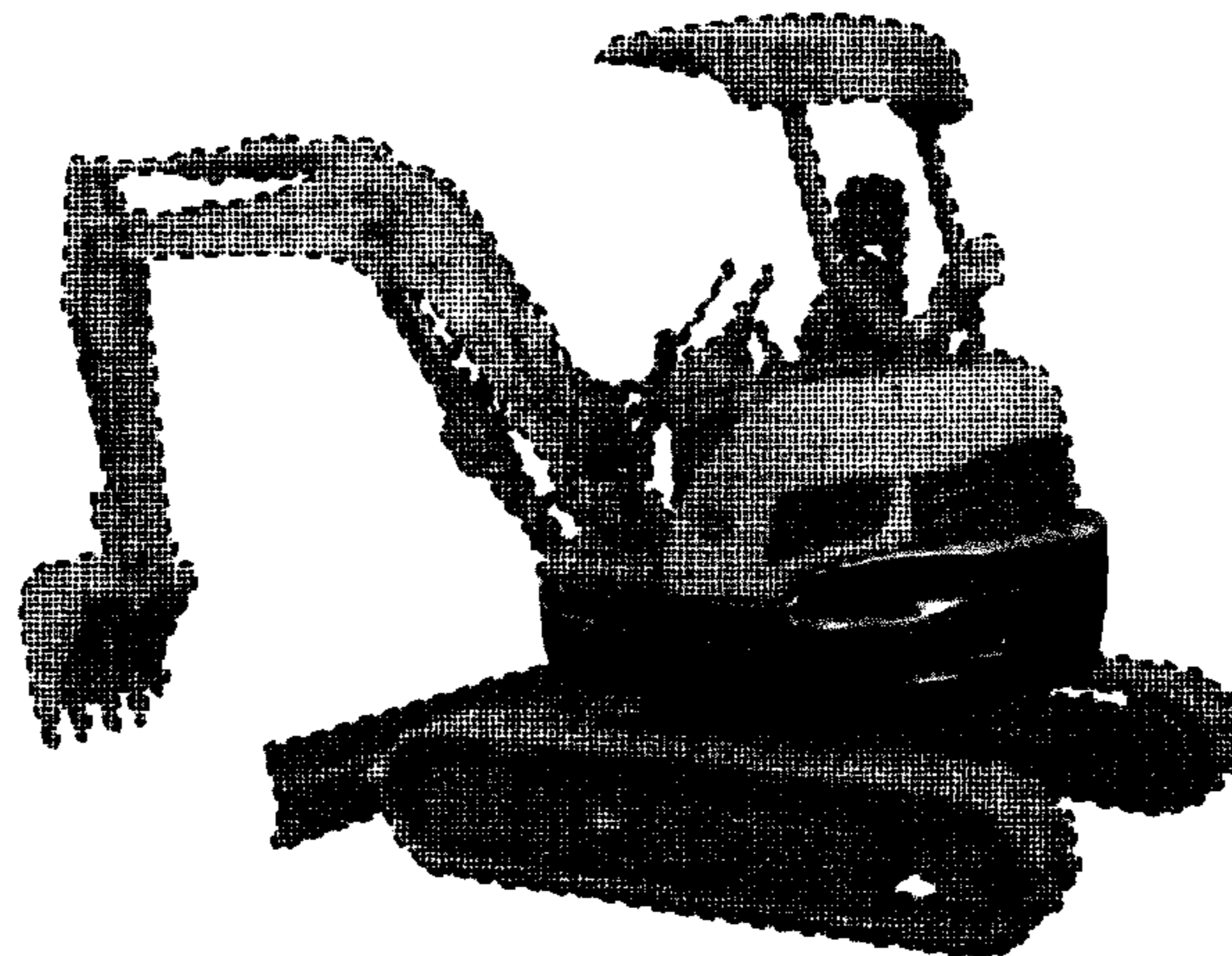
FIG. 5 is a rear view thereof;

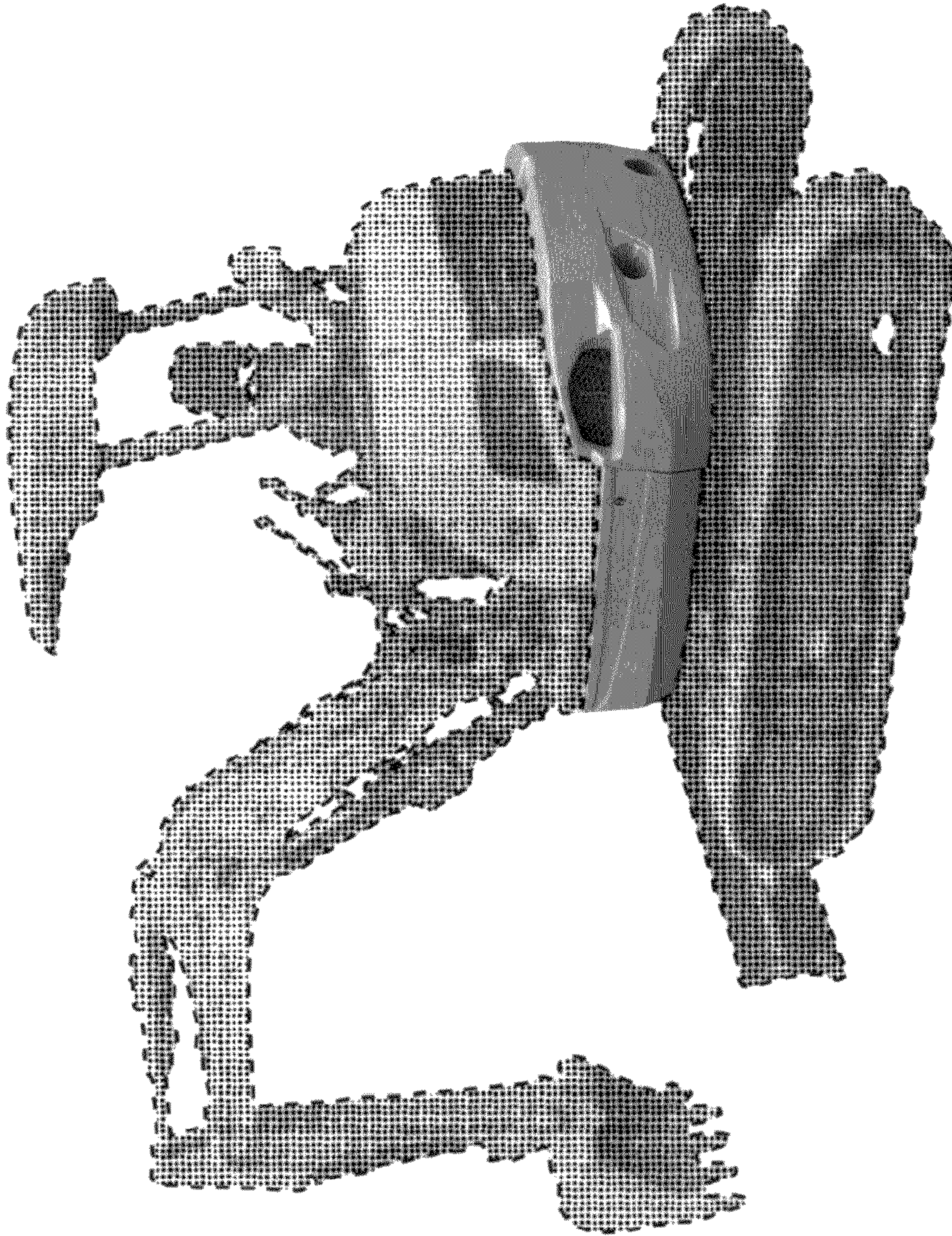

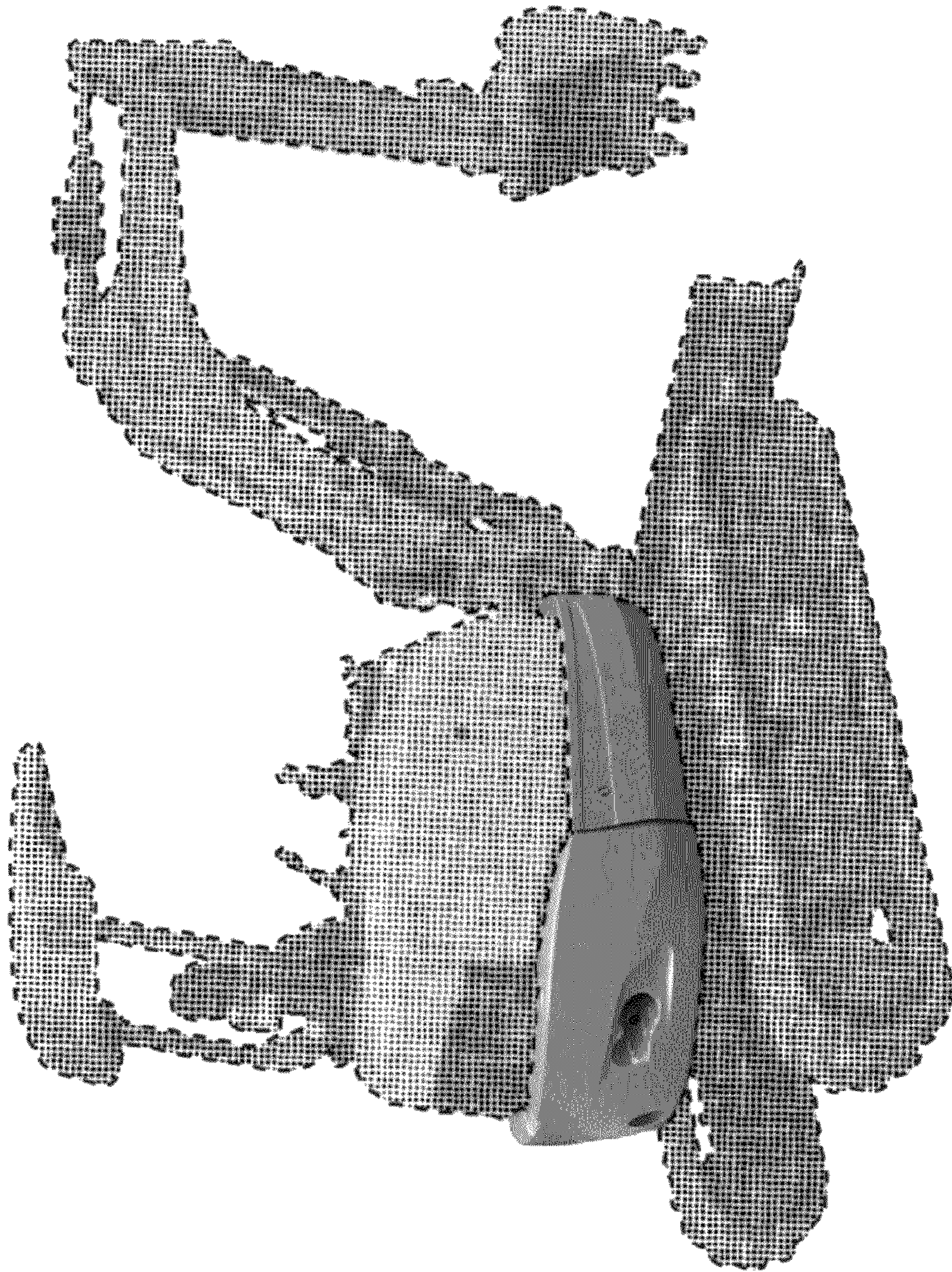

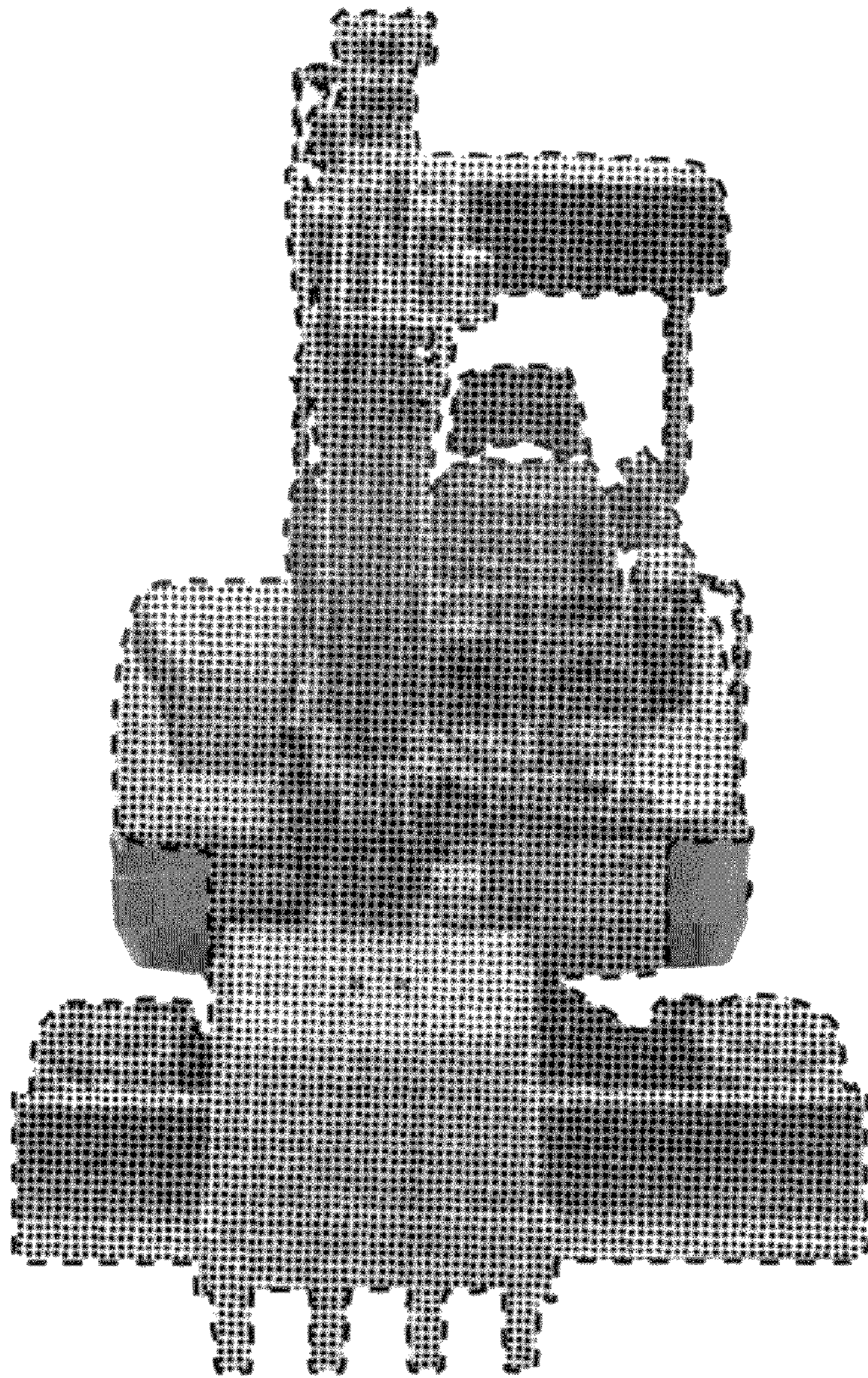

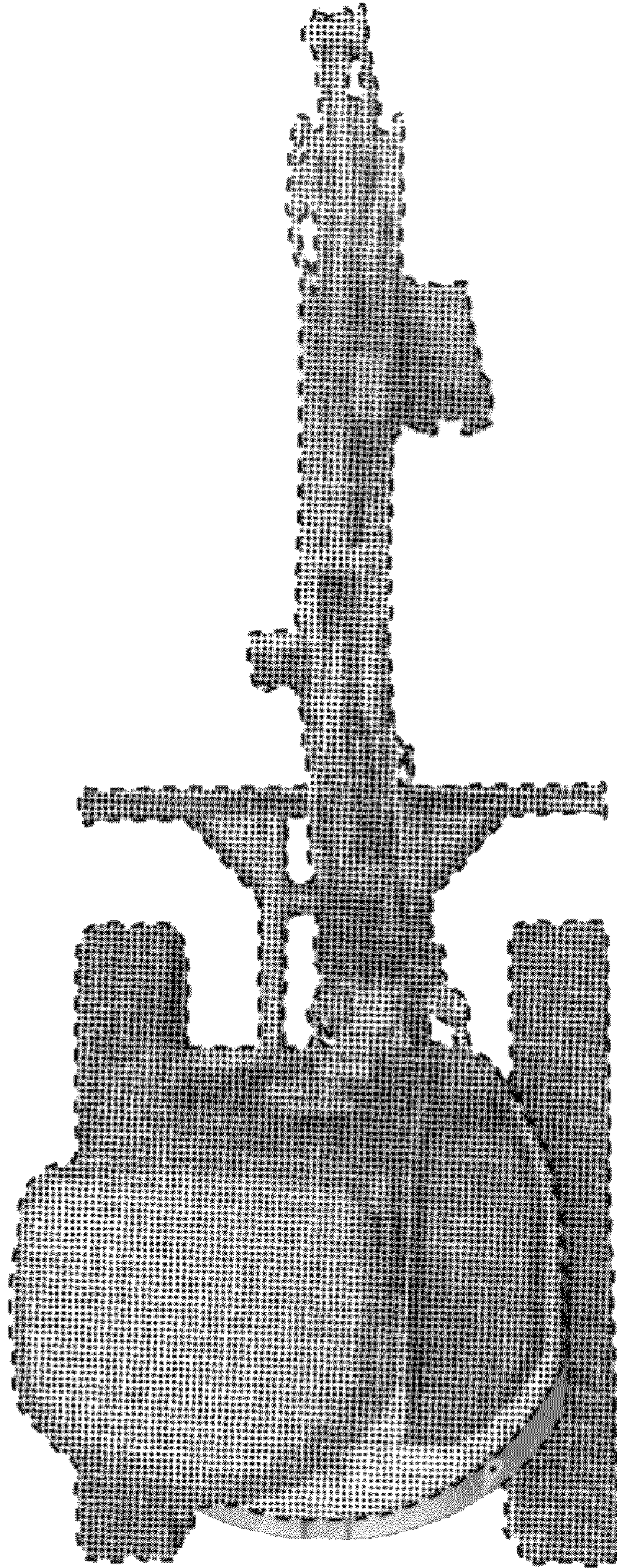

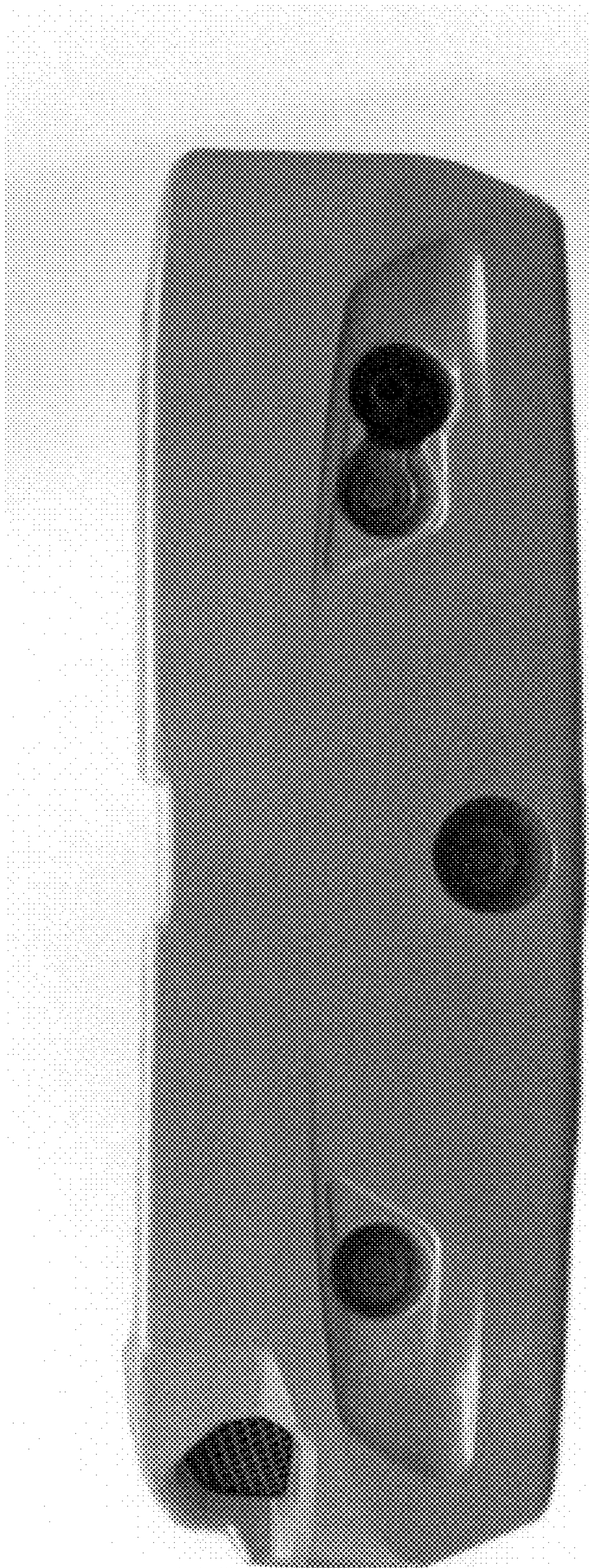

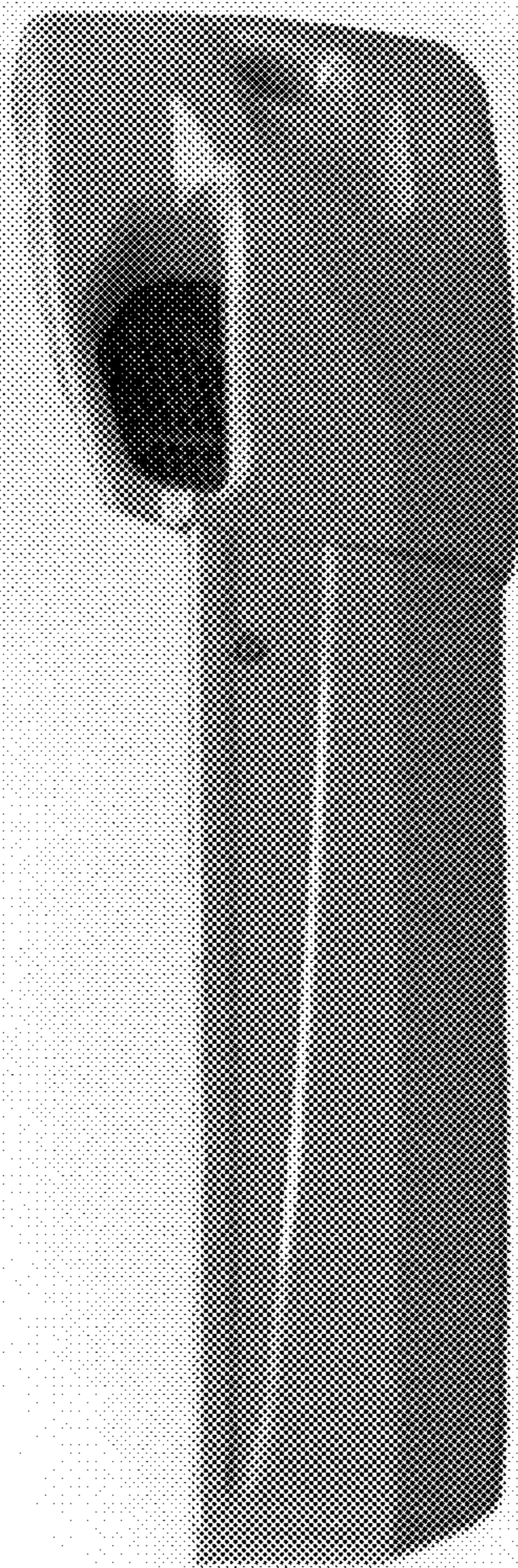

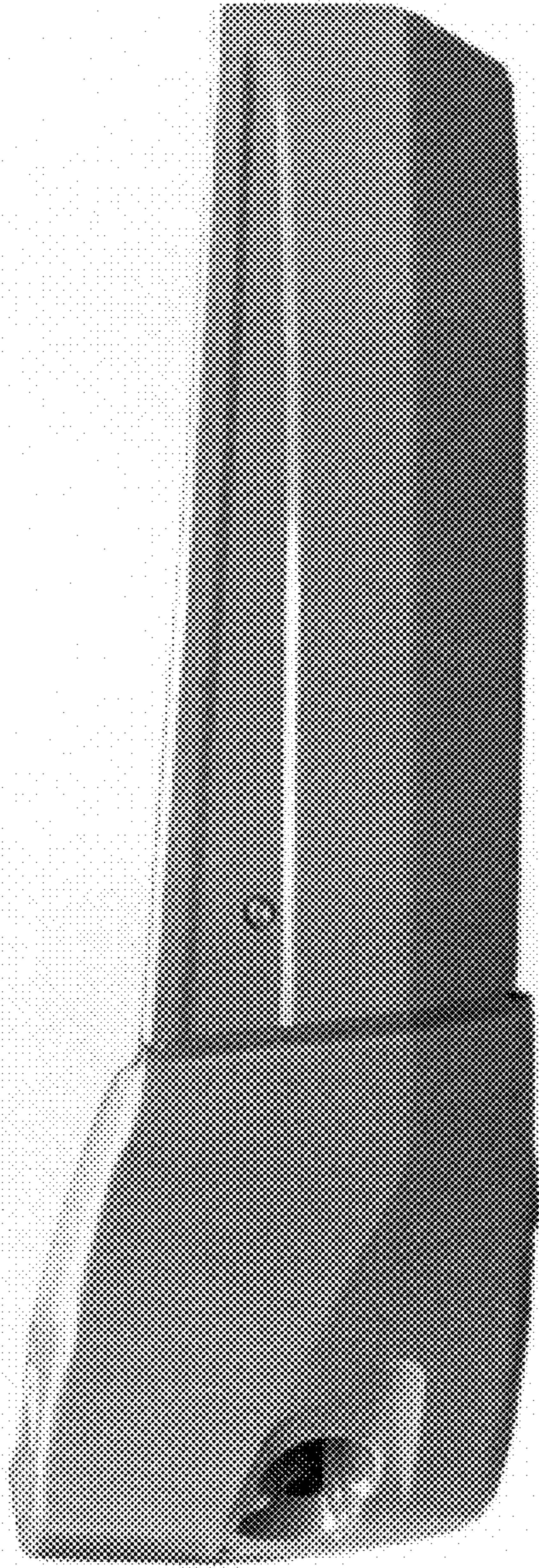
