The ornamental design for a pen, as shown and described.

DESCRIPTION

FIG. 1 is an upper front right perspective view of a pen showing my new design;

FIG. 2 is an upper rear right perspective view of the pen shown in FIG. 1 with the pen cap removed and placed on the opposite end of the pen;

FIG. 3 is an exploded lower front right perspective view of the pen shown in FIG. 1;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a top plan view thereof;

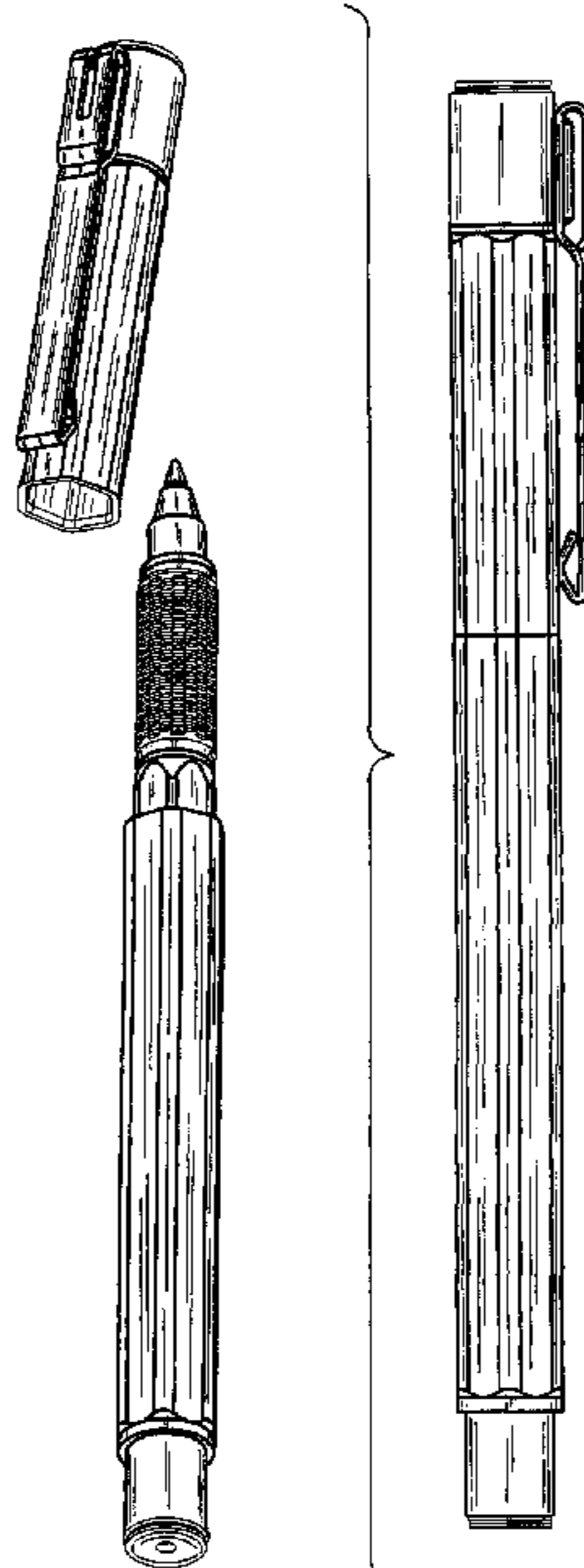
FIG. 6 is a left side elevation view thereof;

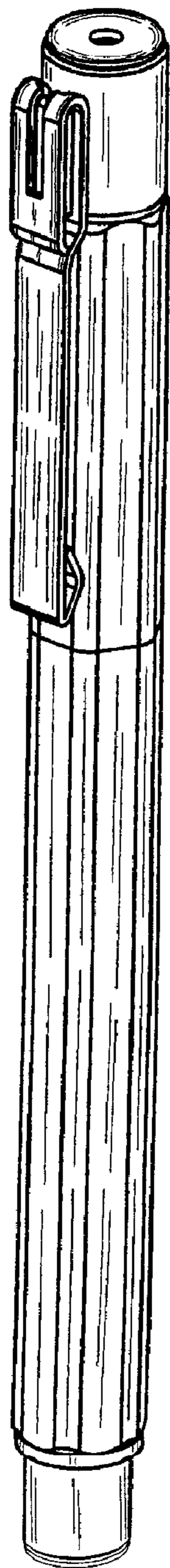

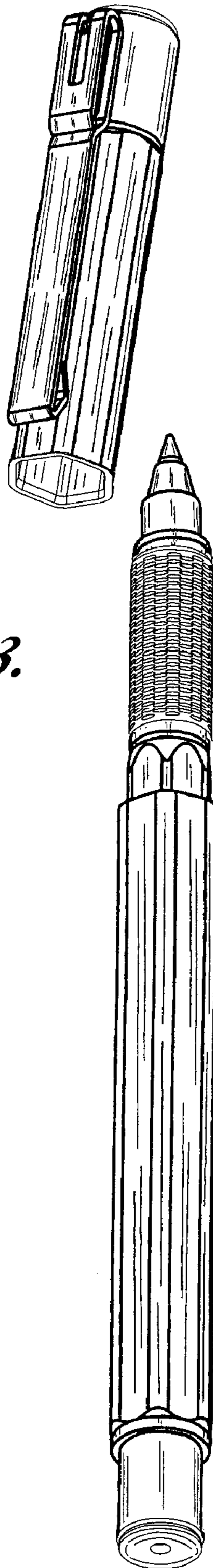

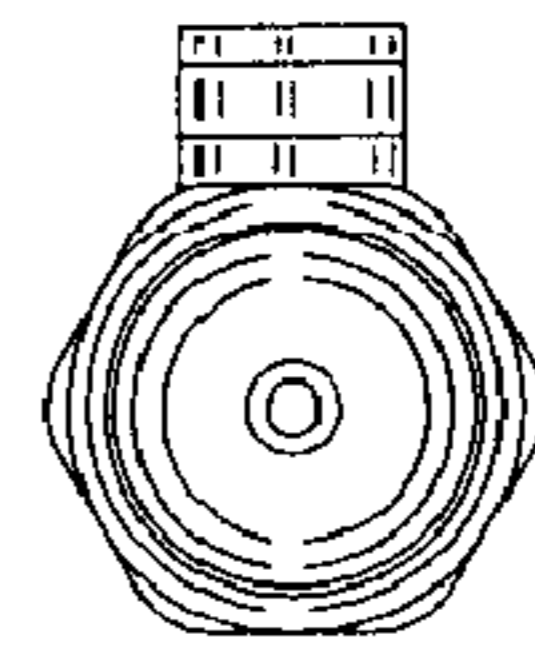

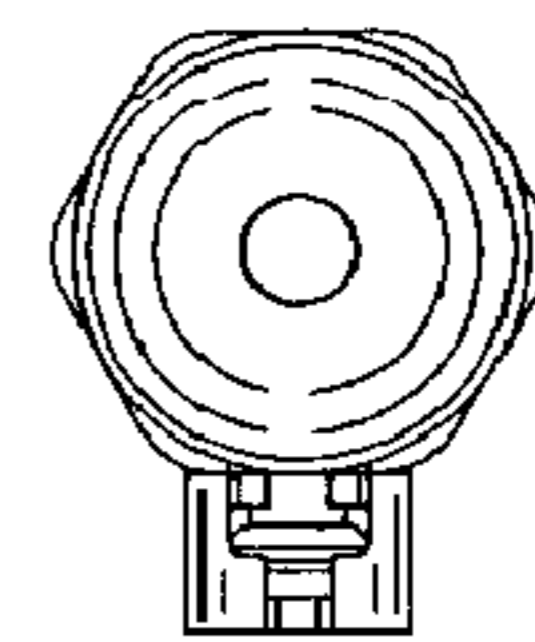

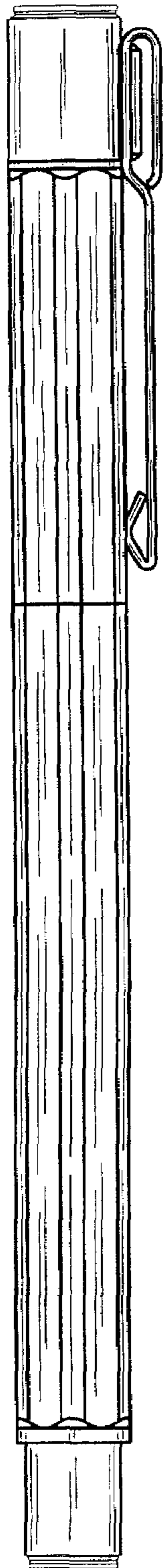

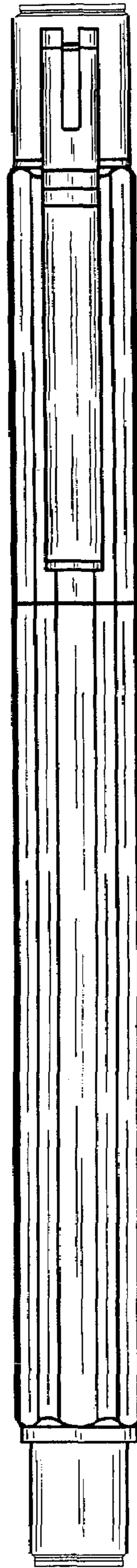

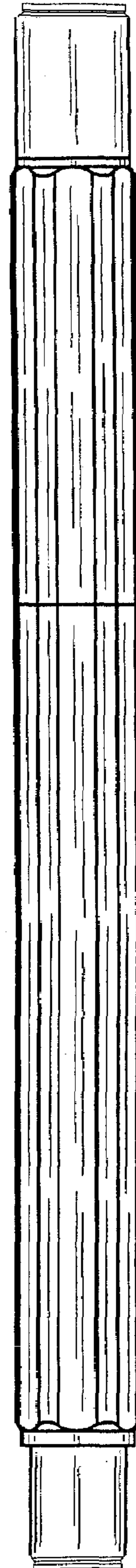
