(57) **CLAIM**

The ornamental design for a urine collection device for a male, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of my urine collection device for a male.

FIG. 2 is an enlarged perspective view of an end portion of my device; and,

FIG. 3 is a side view of FIG. 2.

The broken line showing of the bag portion and hose is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

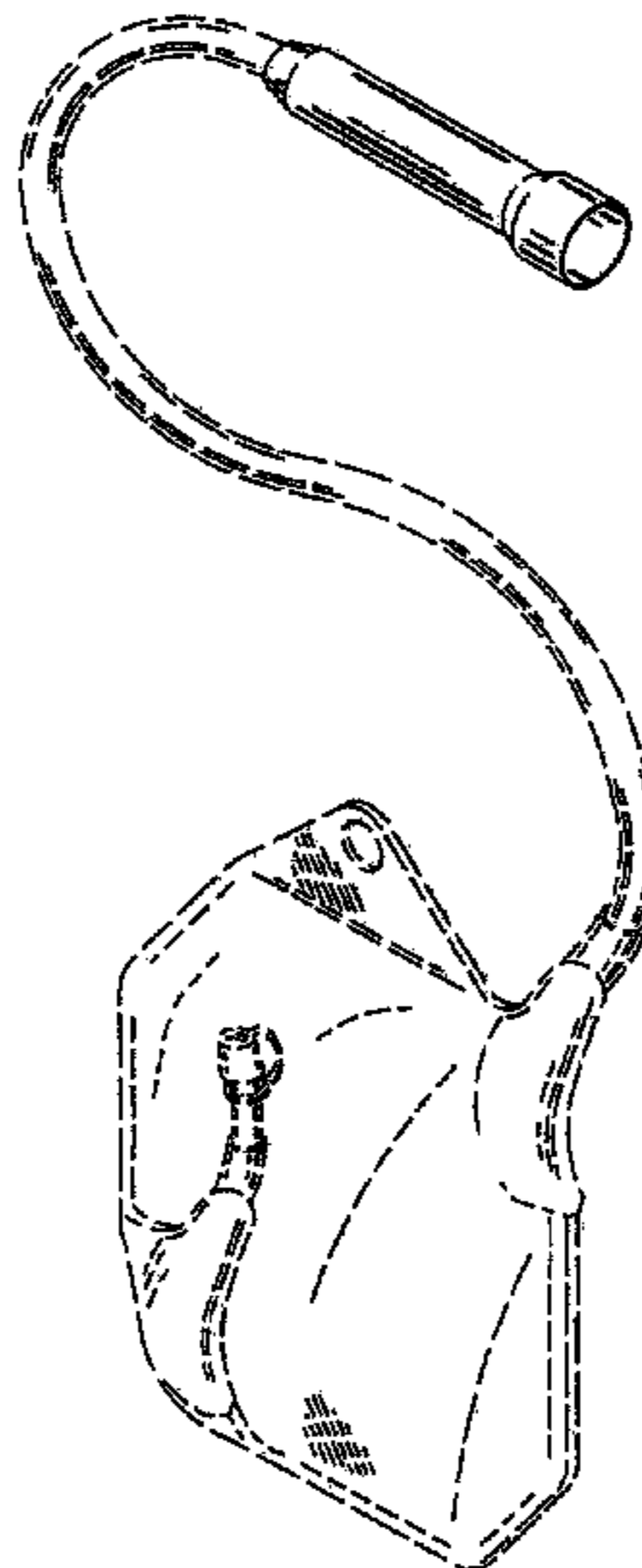

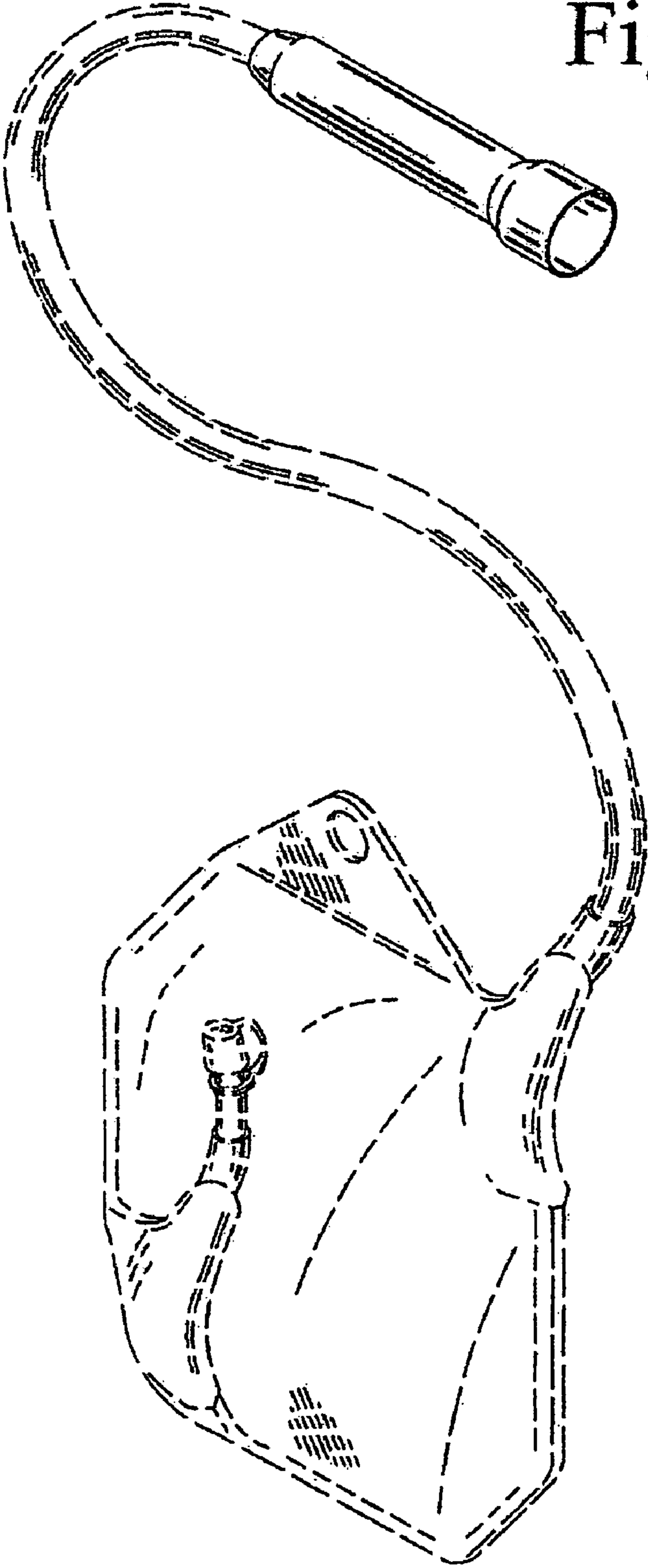

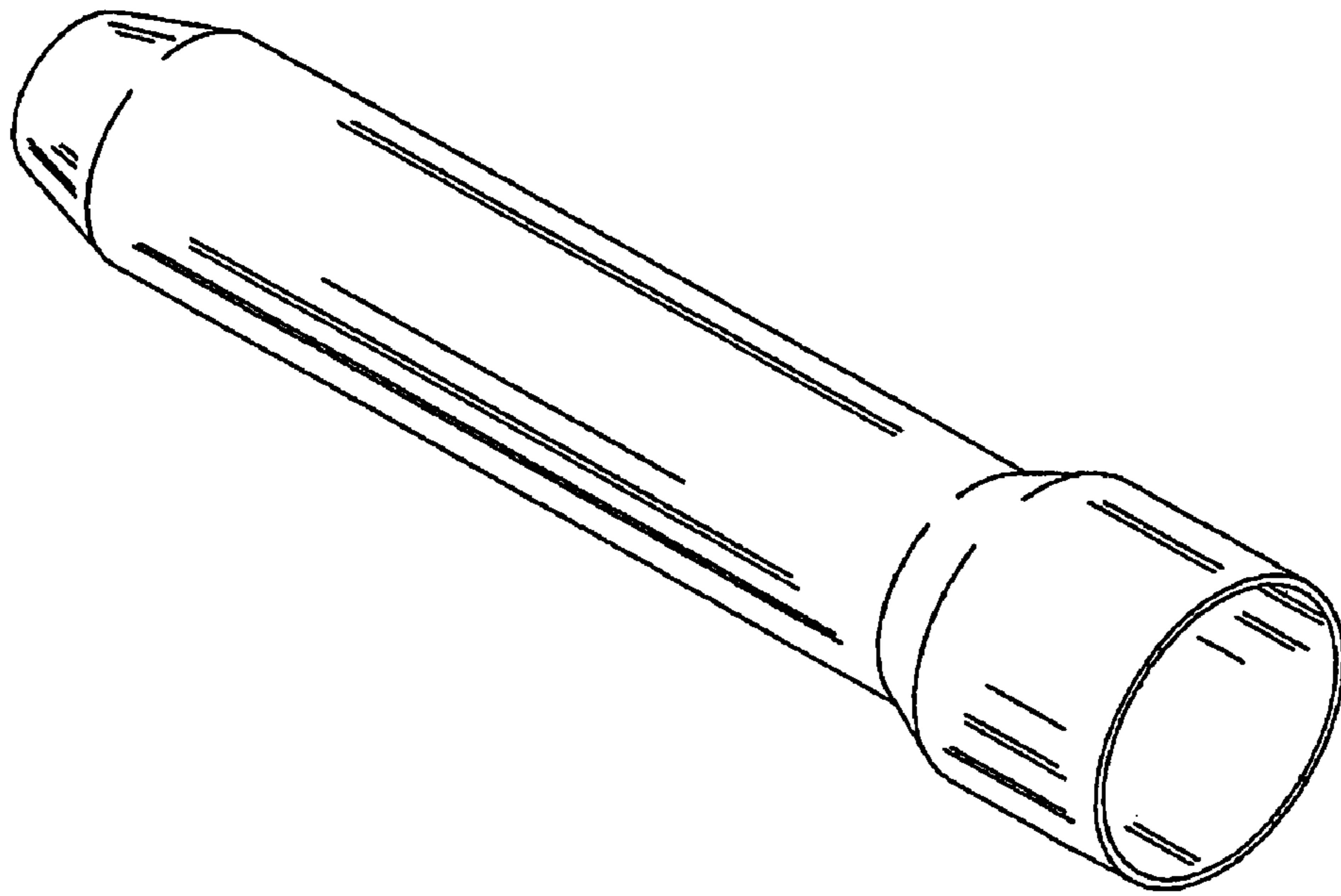
