The ornamental design for sanitary foot protection, as shown and described.

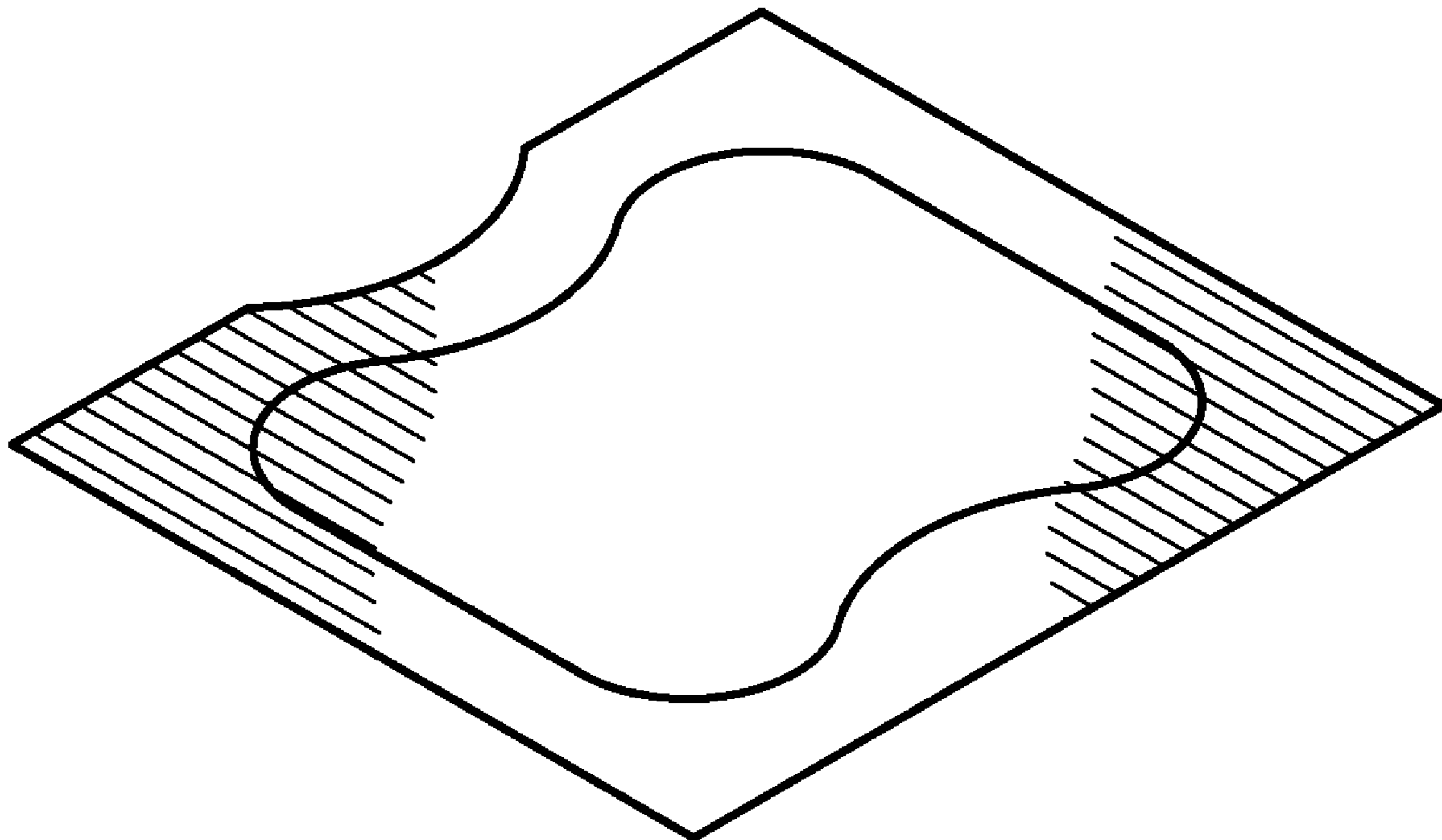
DESCRIPTION

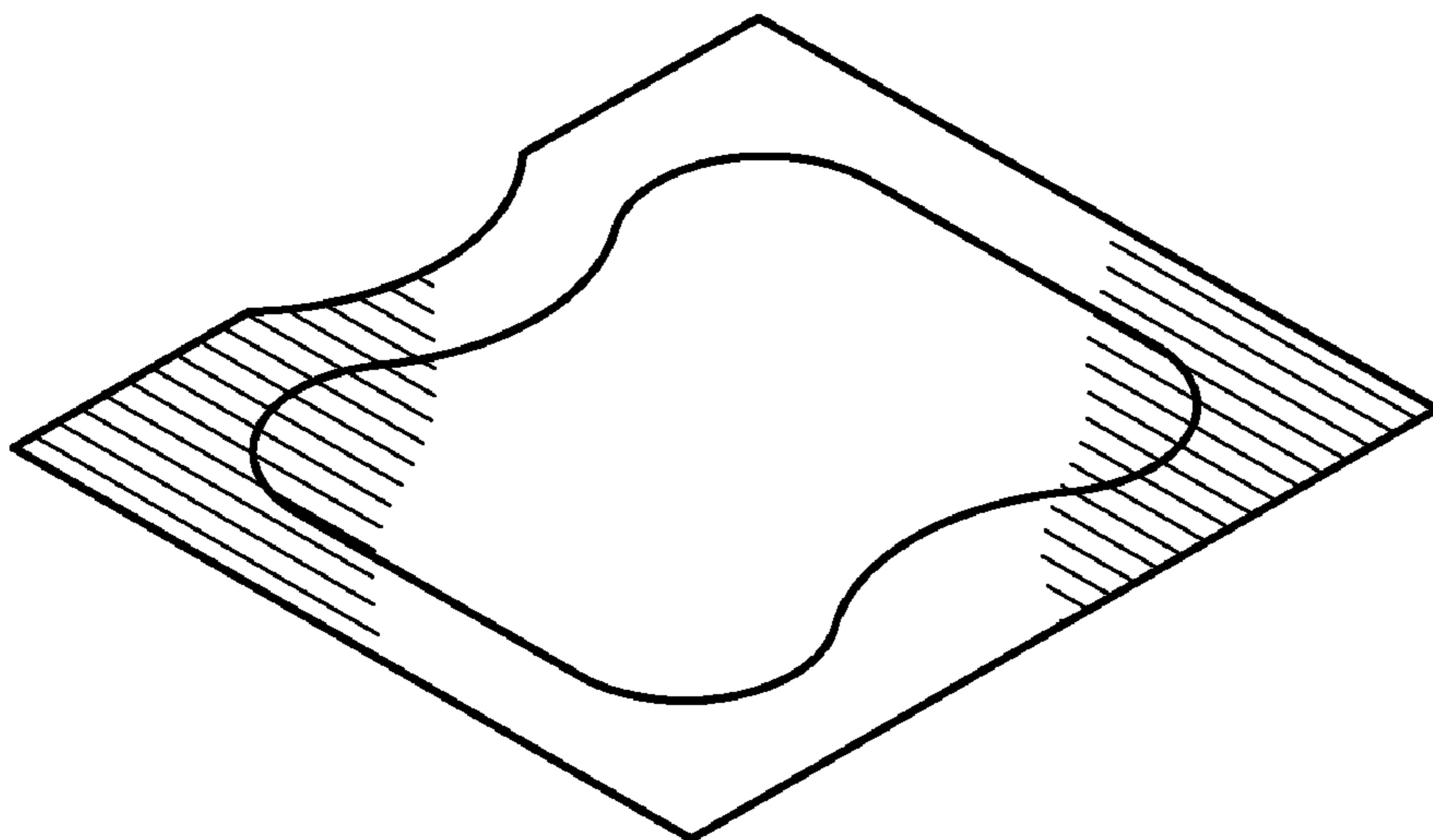

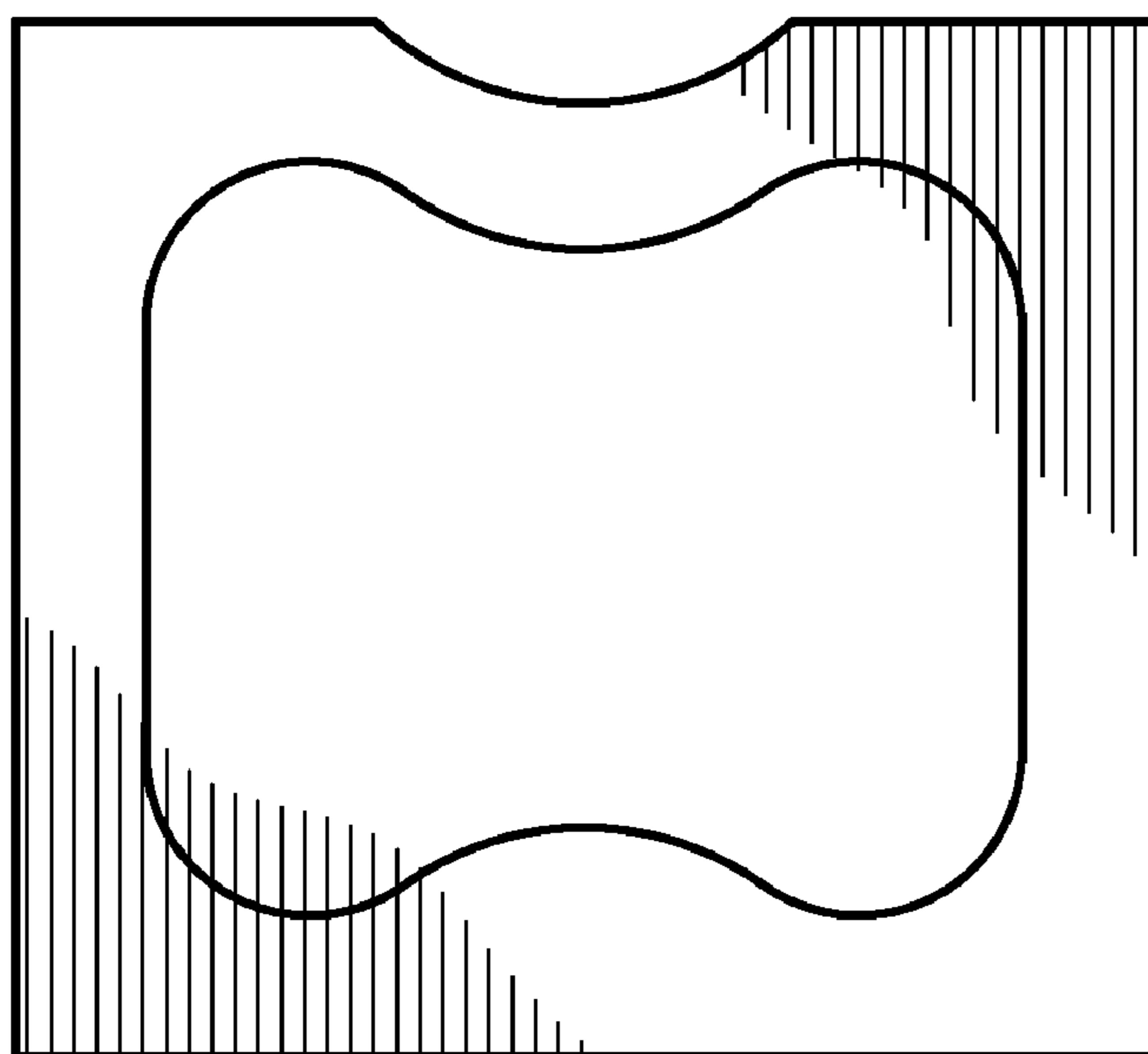
