FIG. 4 is a bottom plan view thereof;

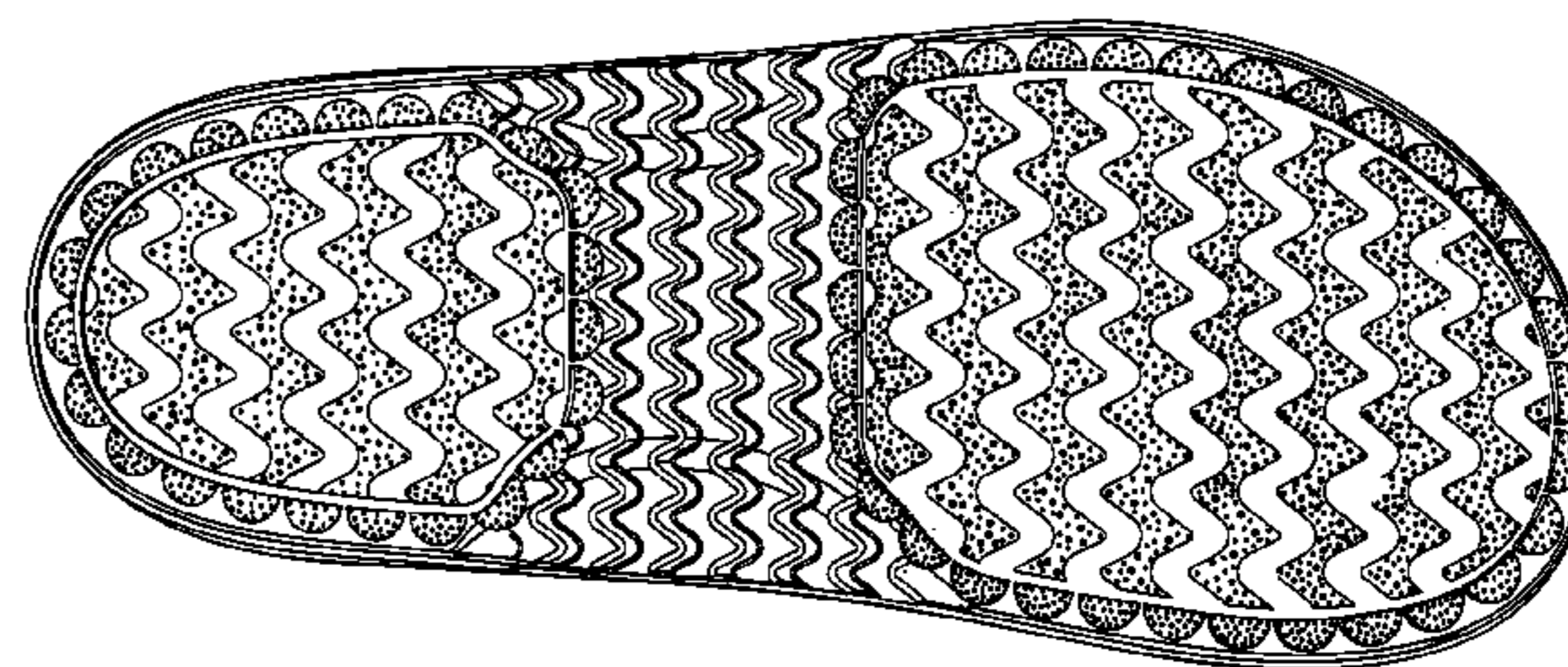
FIG. 5 is front elevation view thereof;

FIG. 7 is a right side elevation view thereof; and,

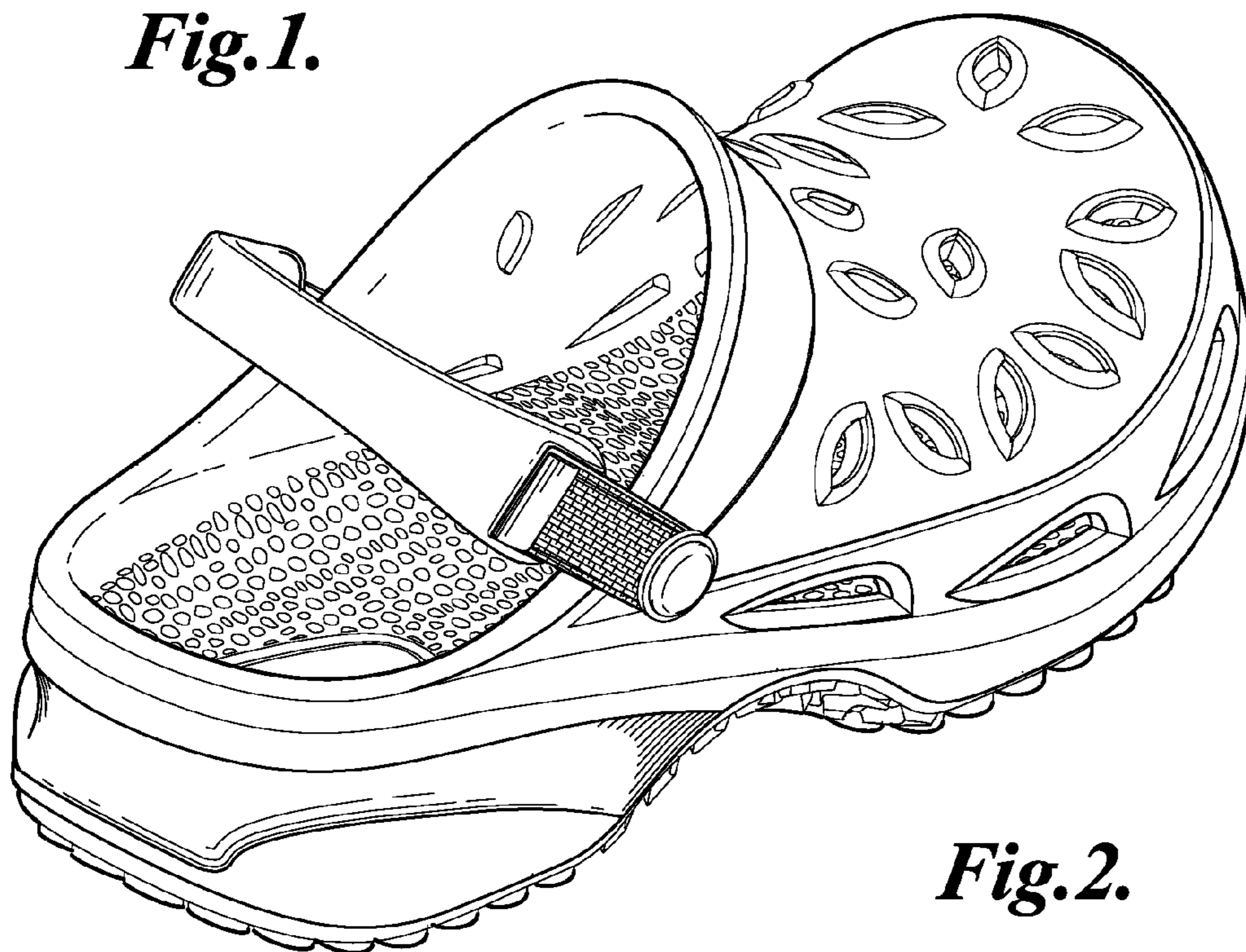
FIG. 8 is a left side elevation view thereof.

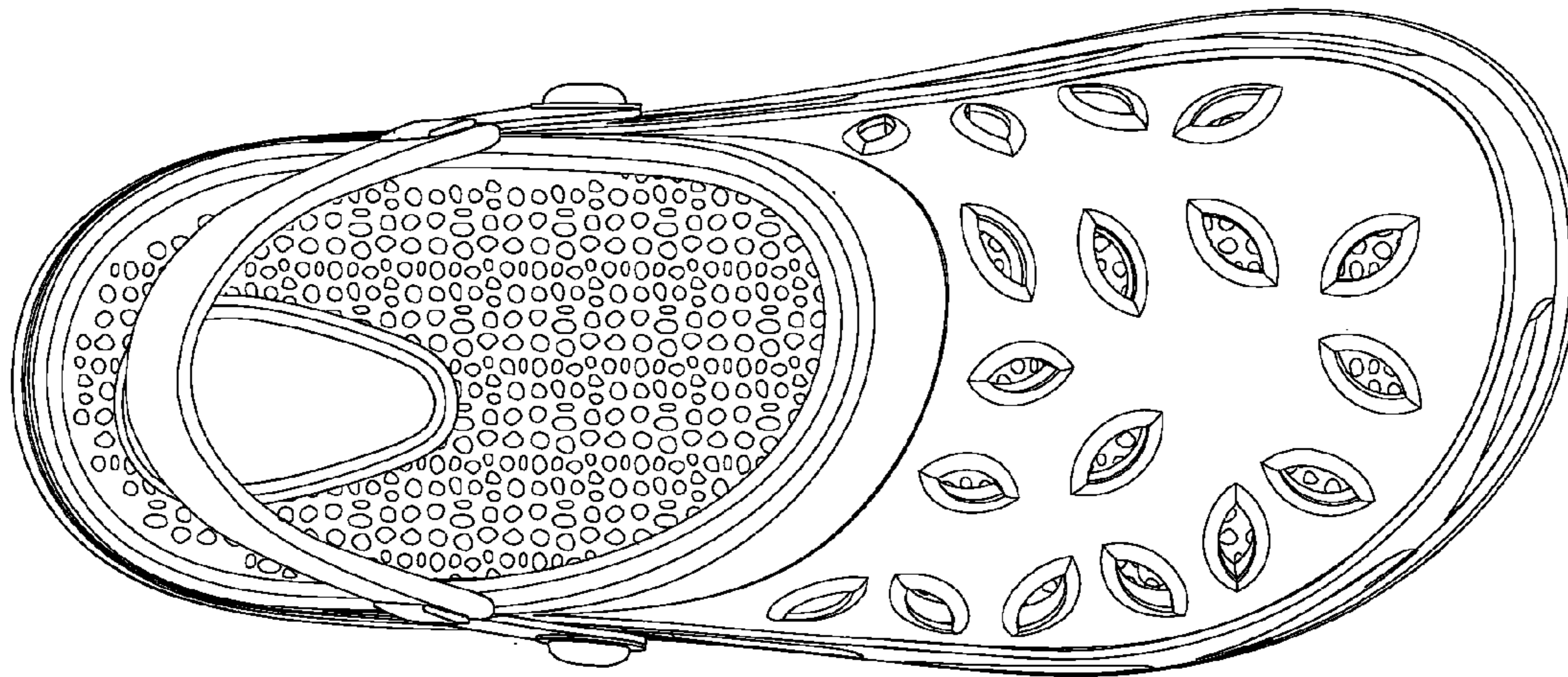




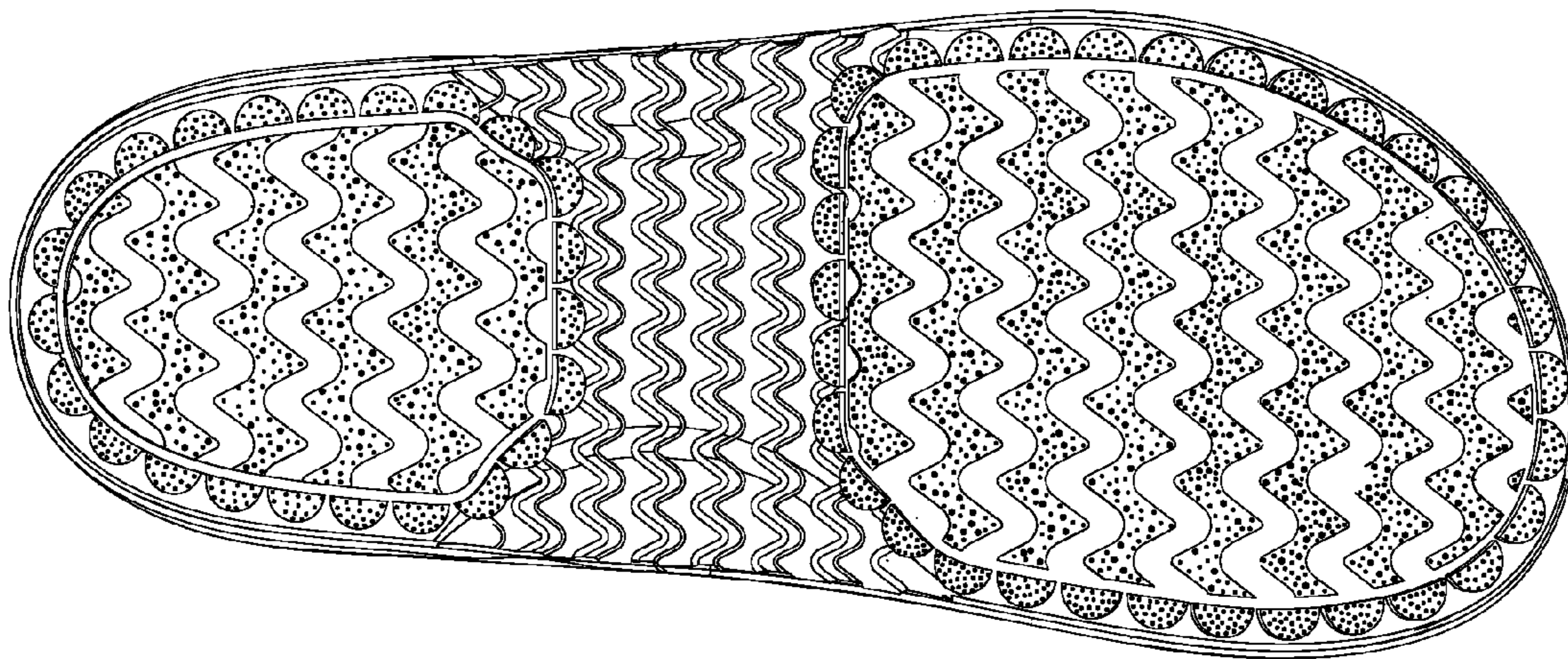

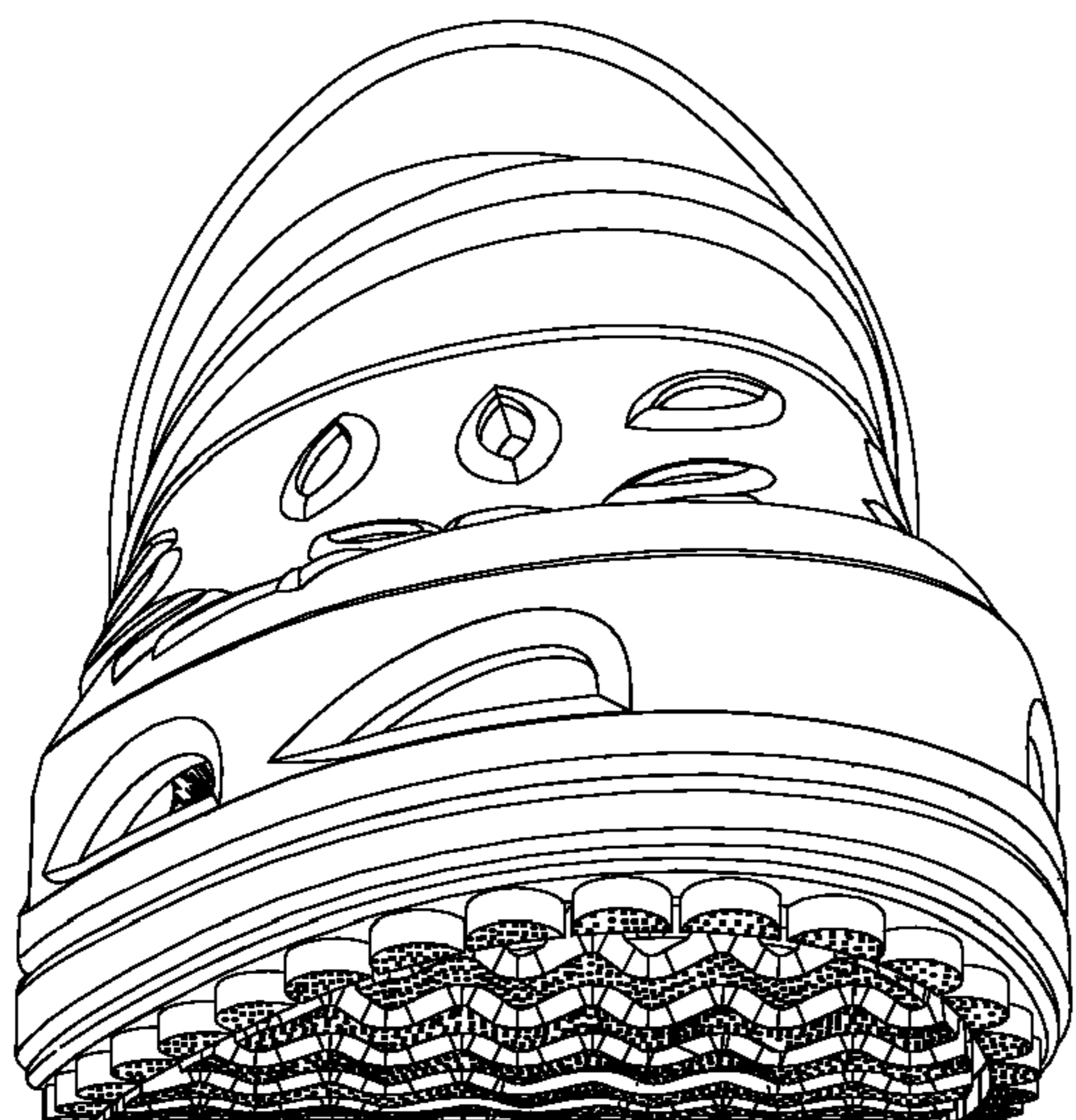

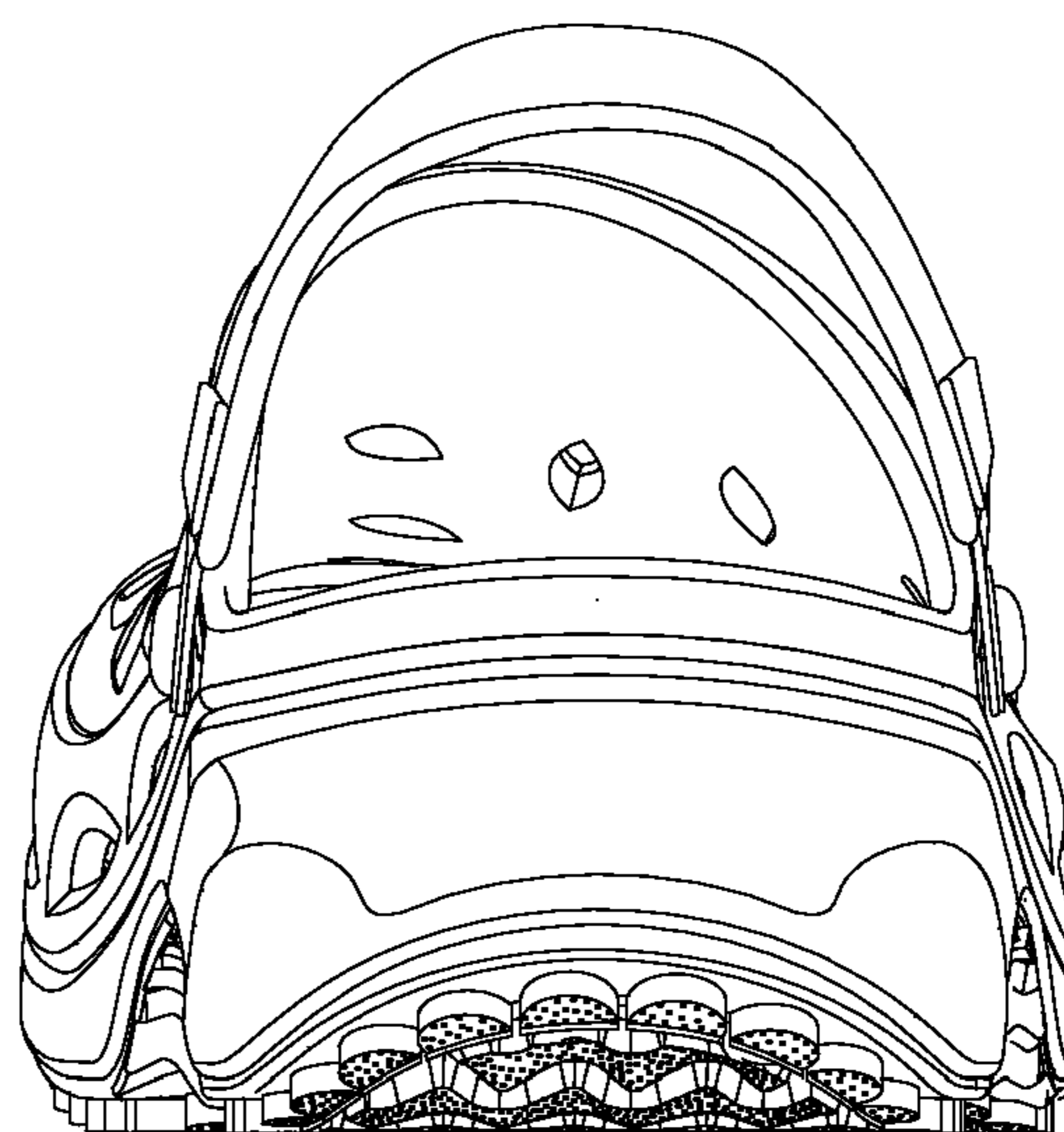

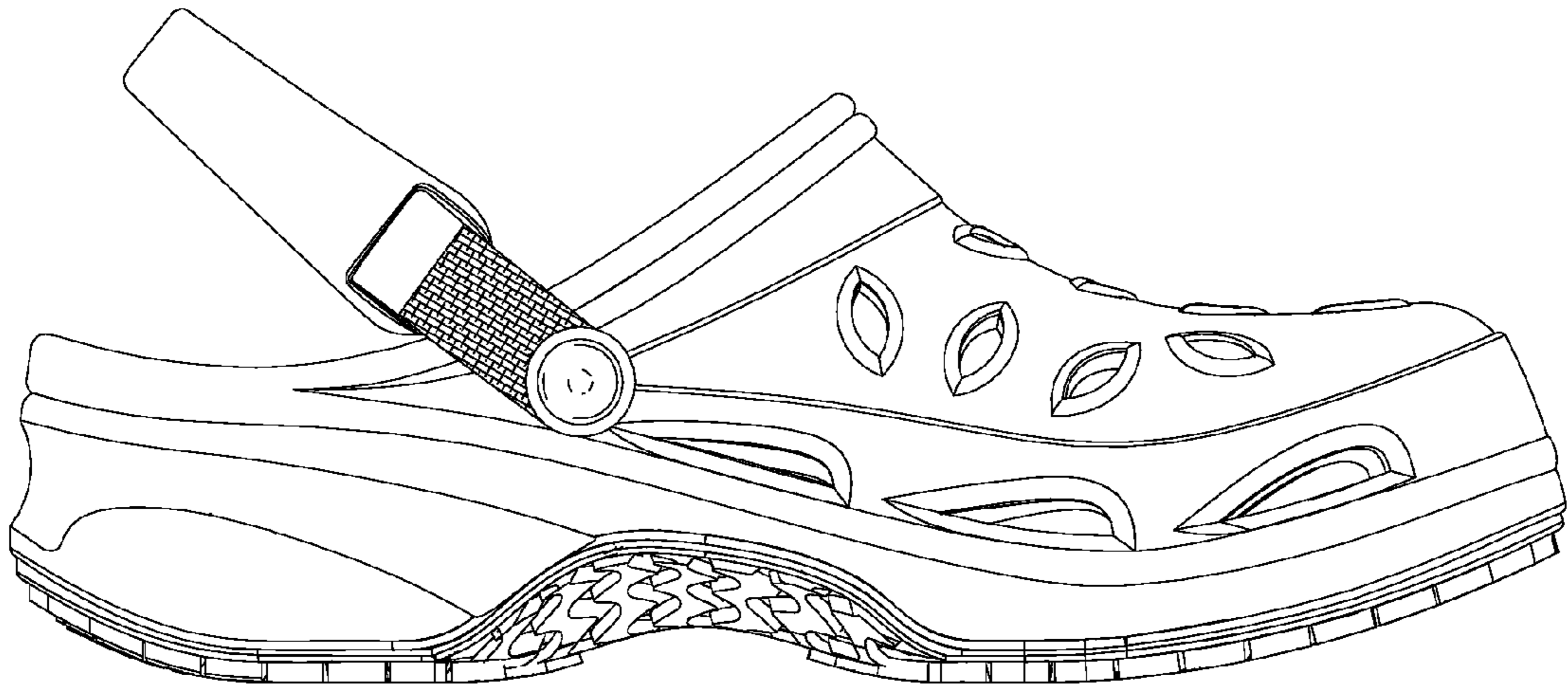

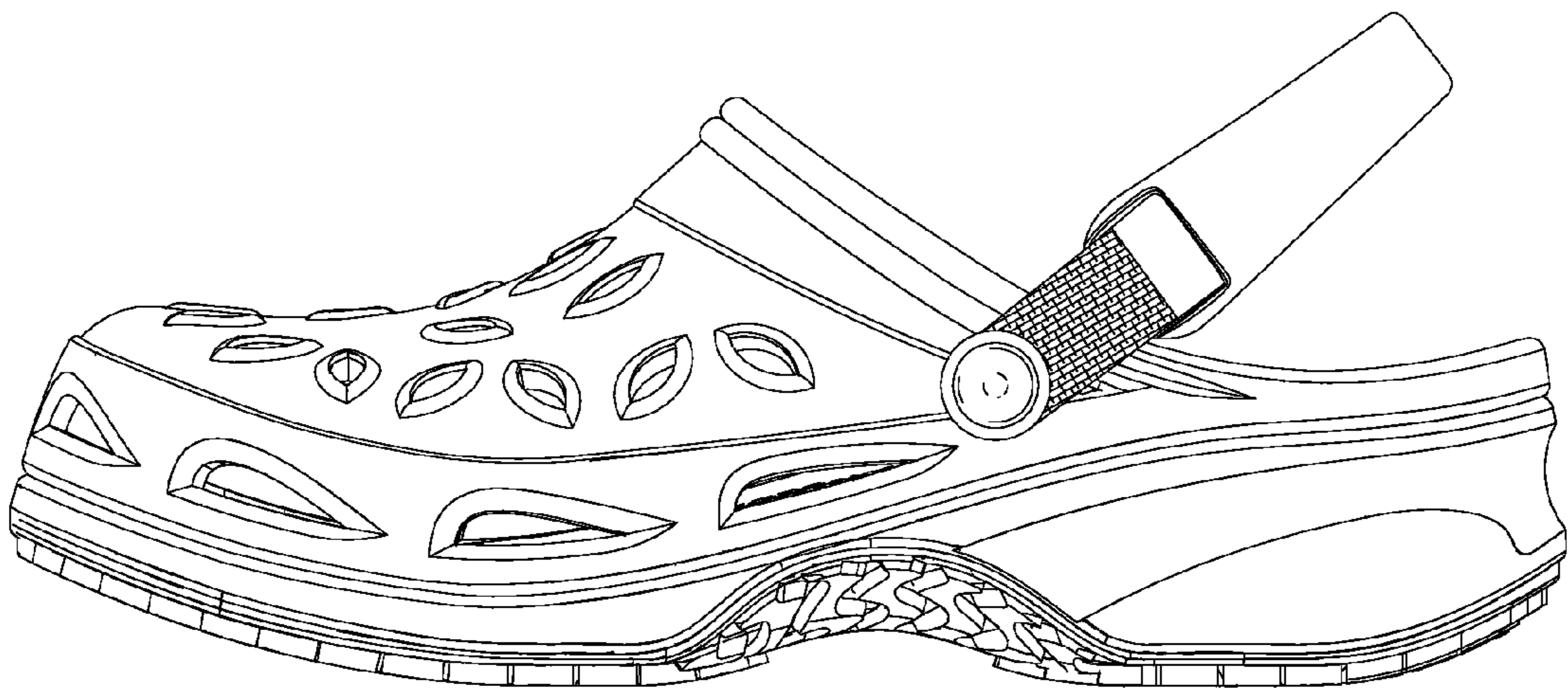
