(57) **CLAIM**

We claim the ornamental design for a pair of heels for shoe outsoles, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom rear perspective view of the left component of a pair of heels for shoe outsoles showing our new design; the broken lines shown throughout the views illustrate the portions of the design that form no part of the claim;

FIG. 2 is a bottom front perspective view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

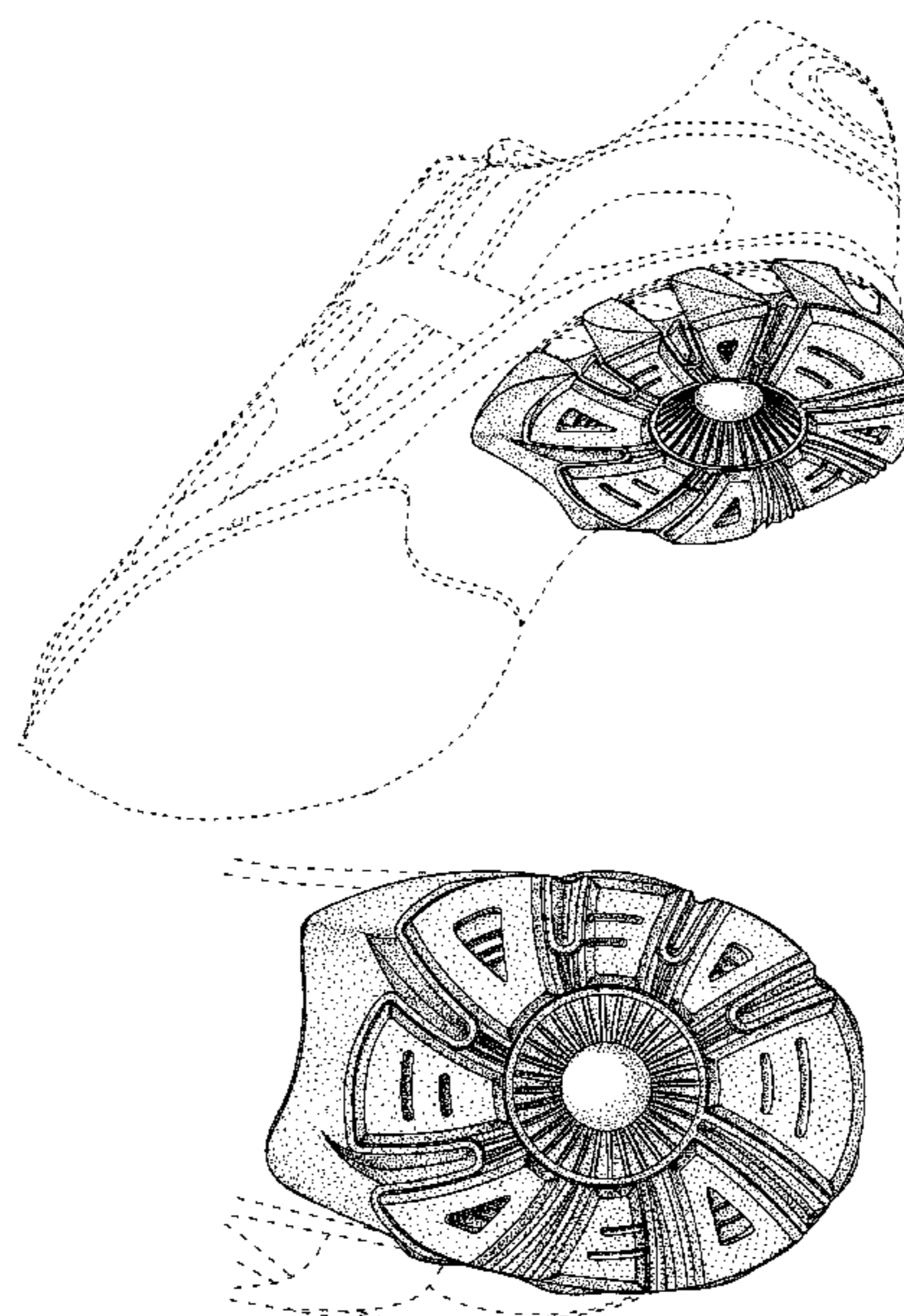
FIG. 7 is a rear elevational view thereof;

FIG. 8 is an enlarged bottom plan view thereof; and,

FIG. 9 is an enlarged bottom perspective view thereof.

The right component of the pair of heels is a mirror image.

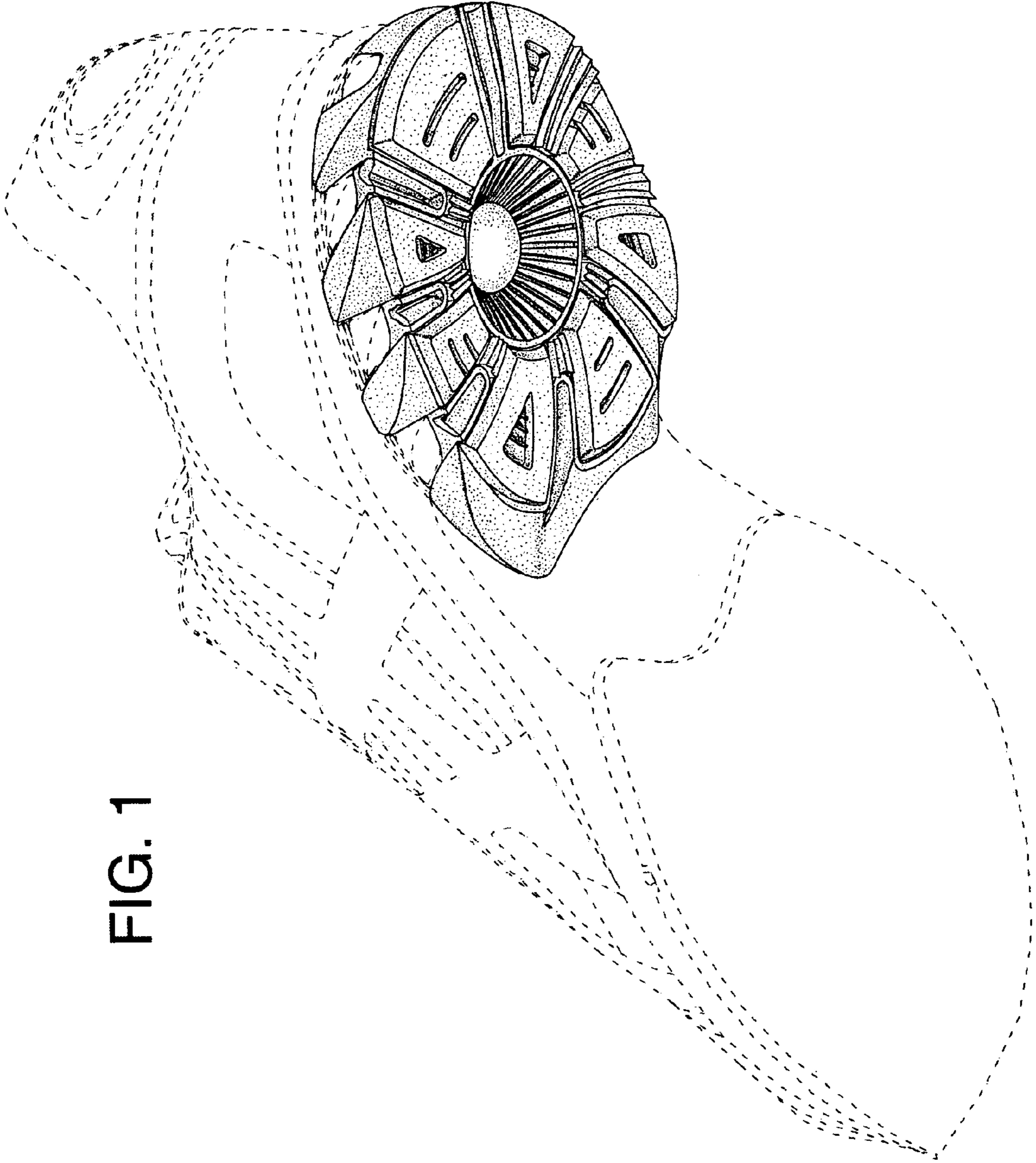

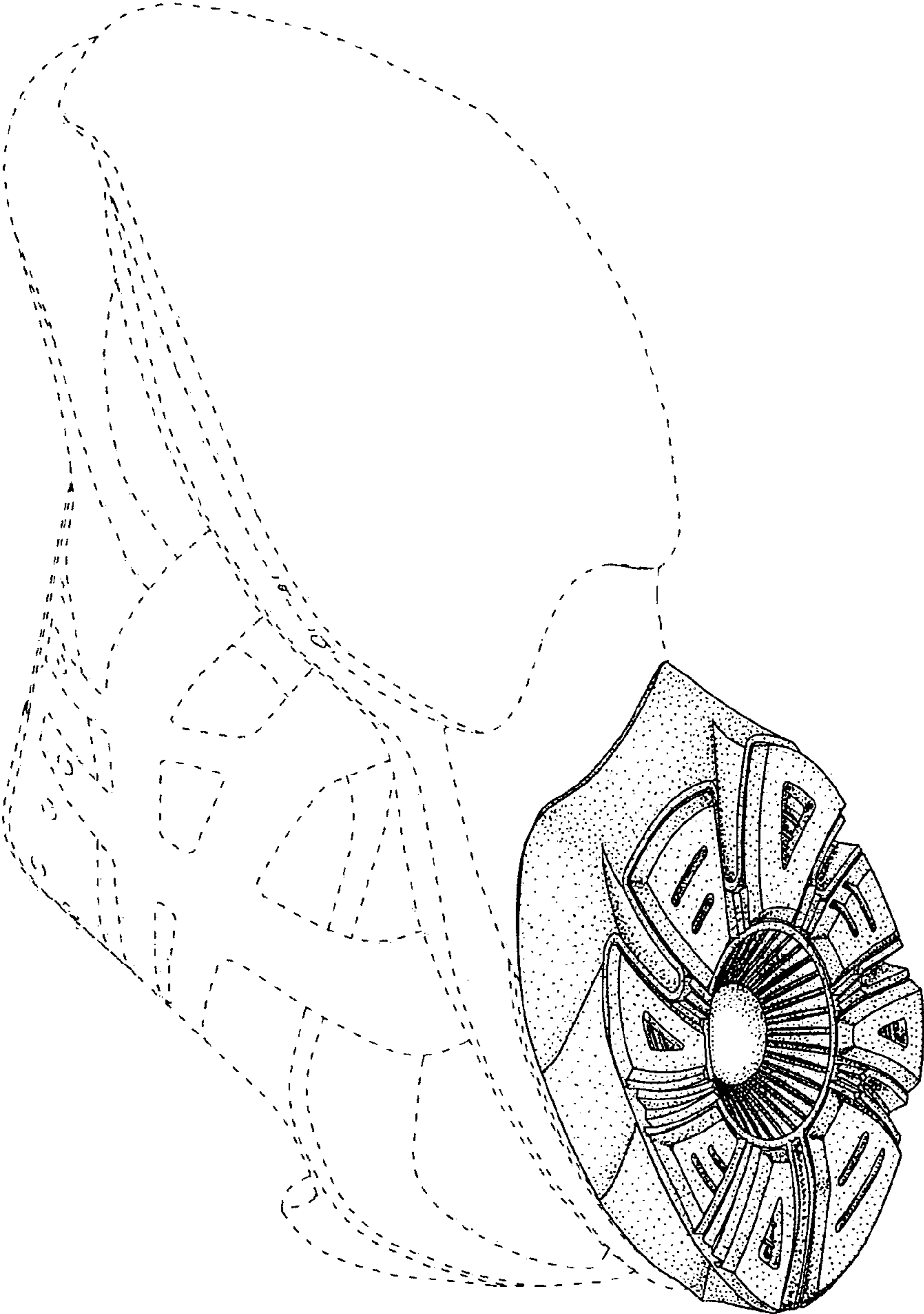

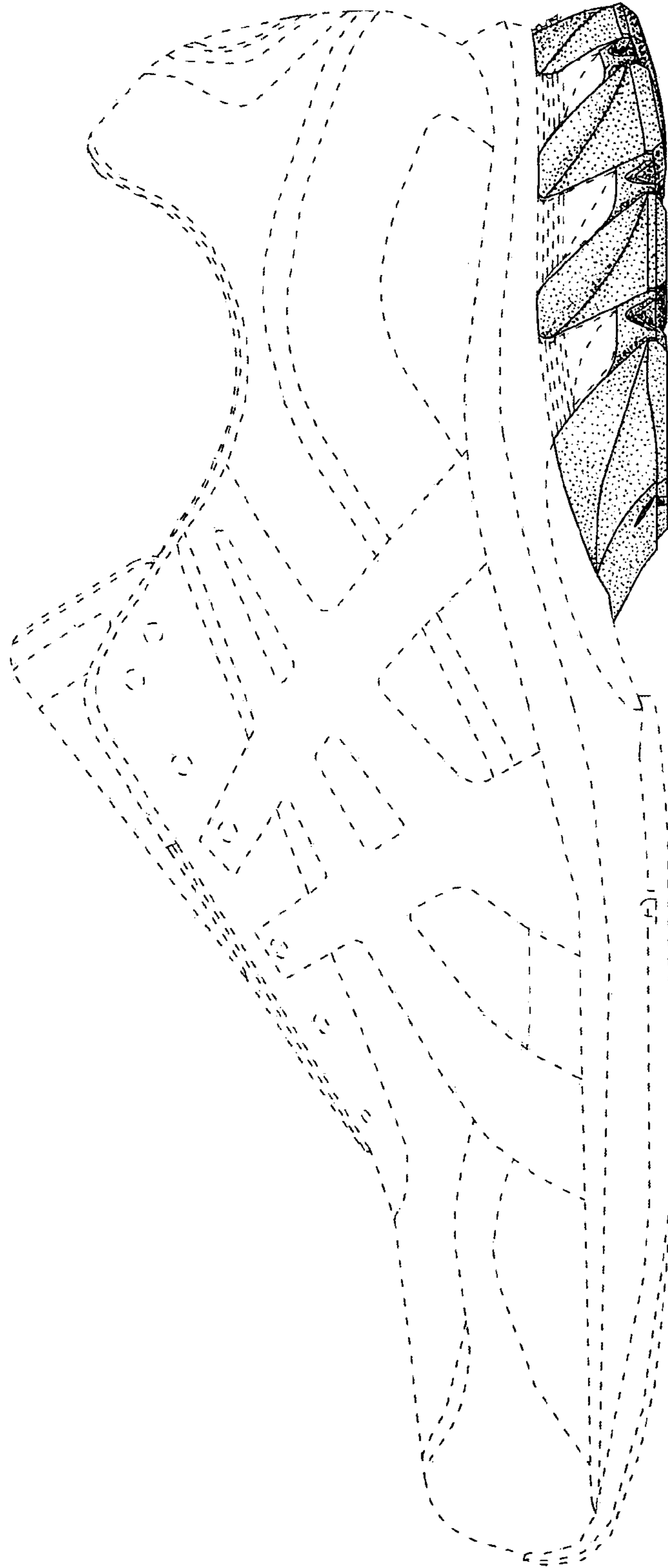

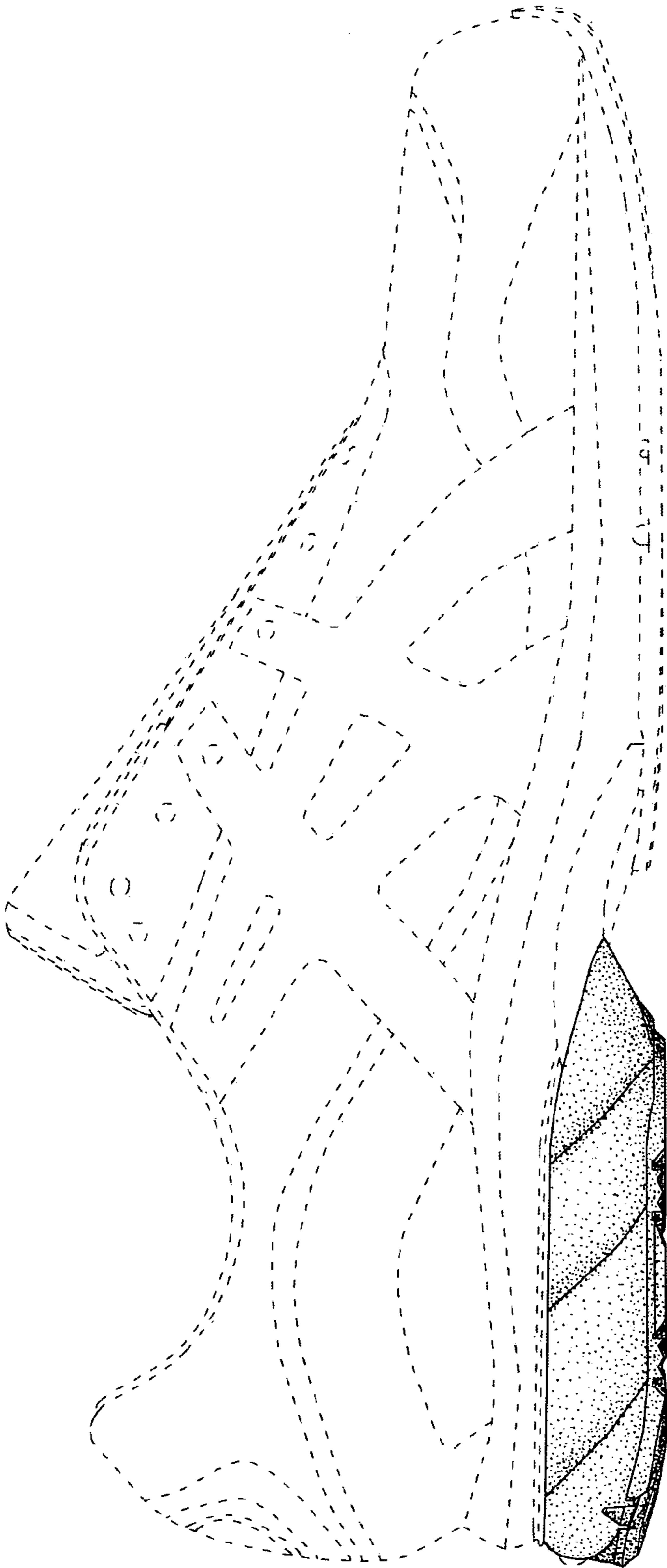

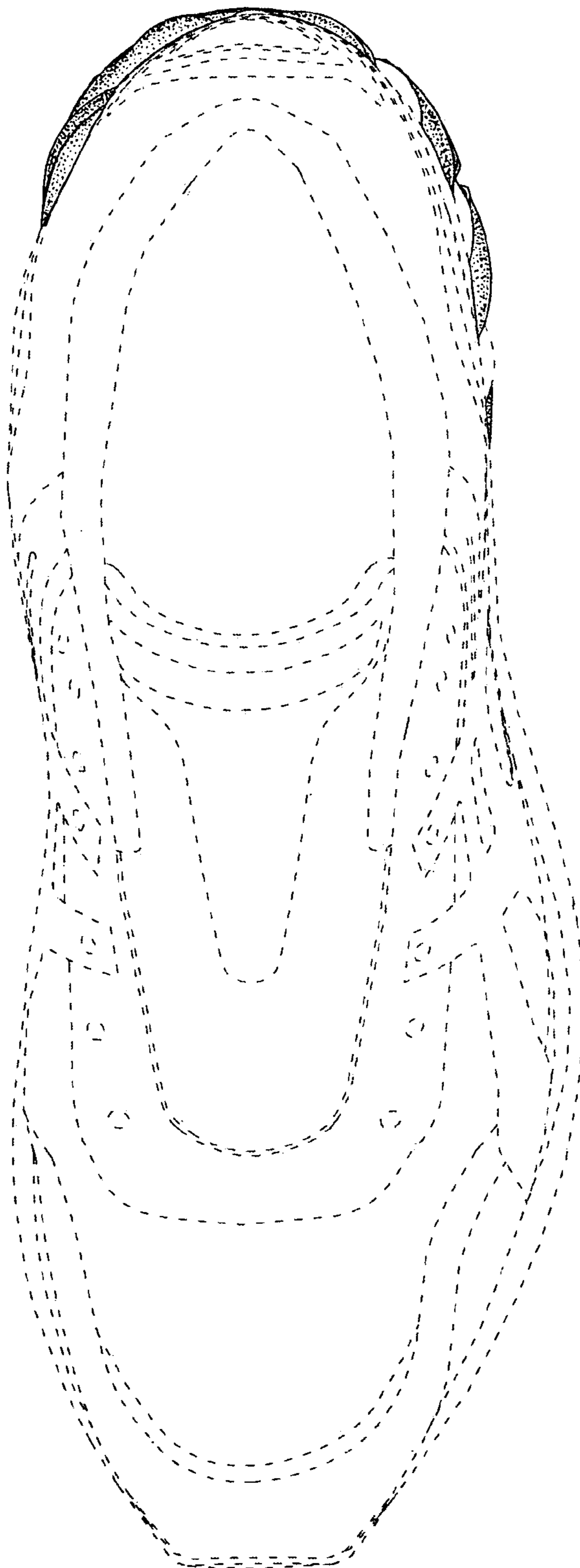

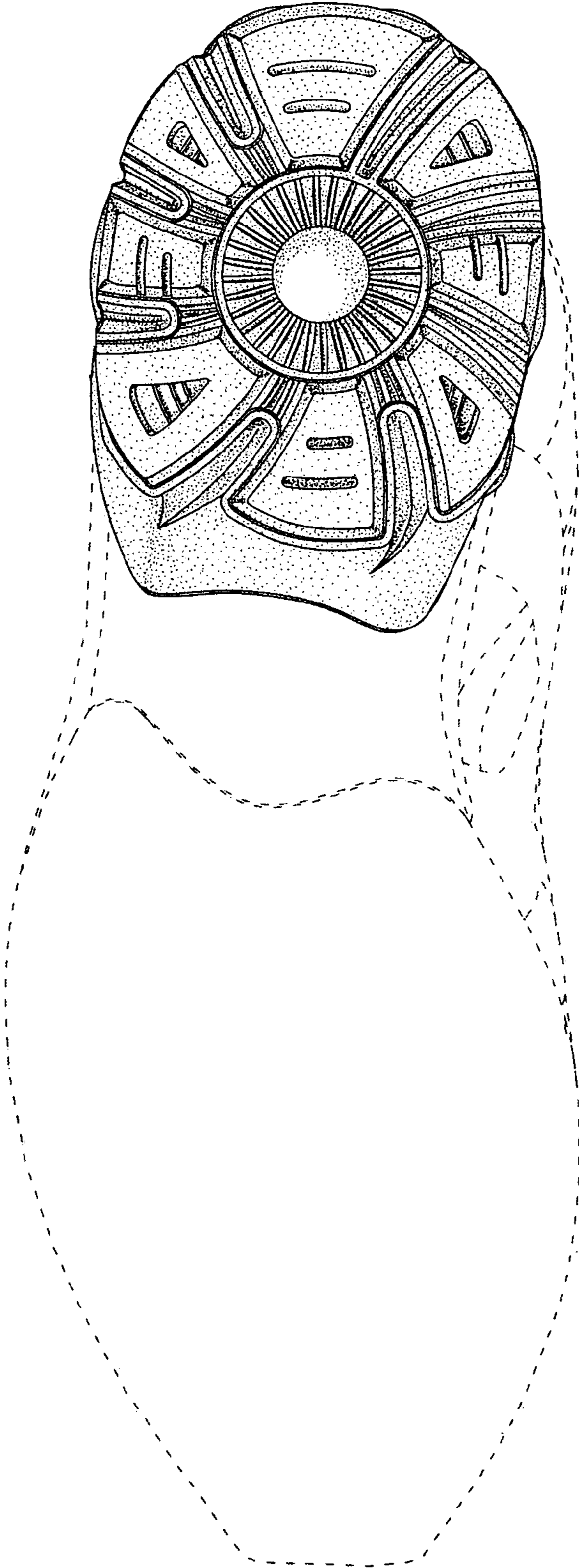

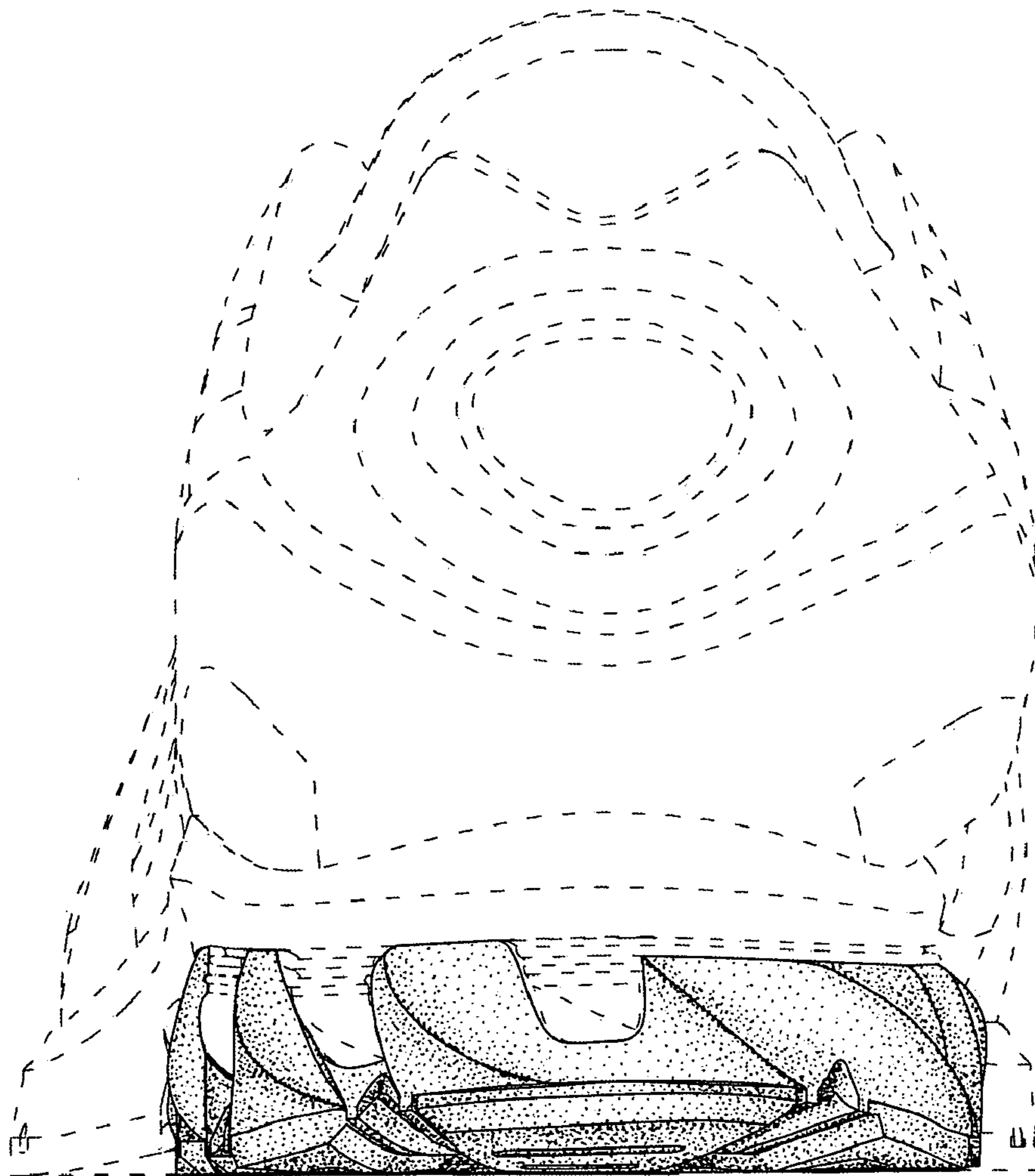

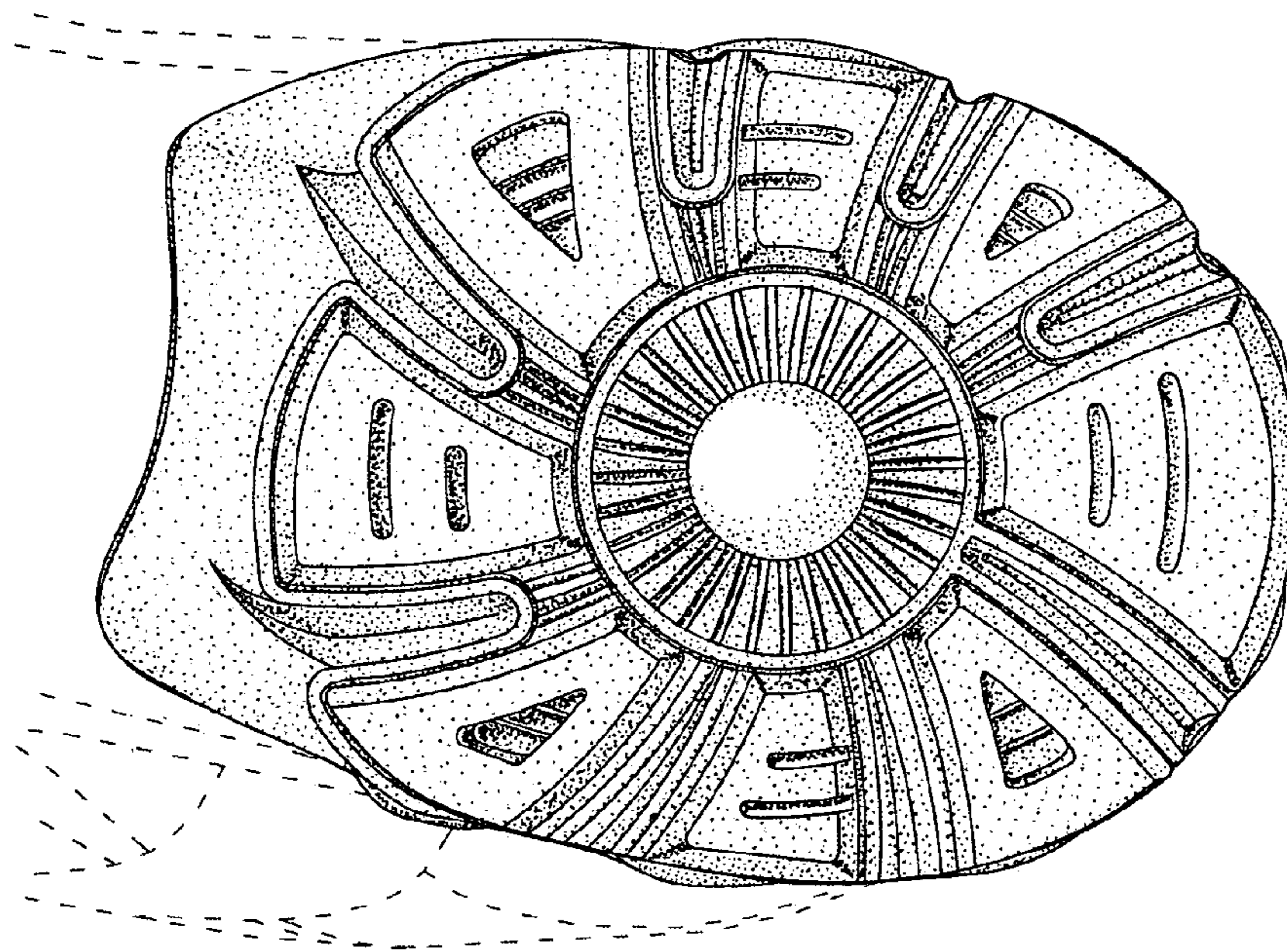
