FIG. 3 is a side view of the chair of FIG. 1;

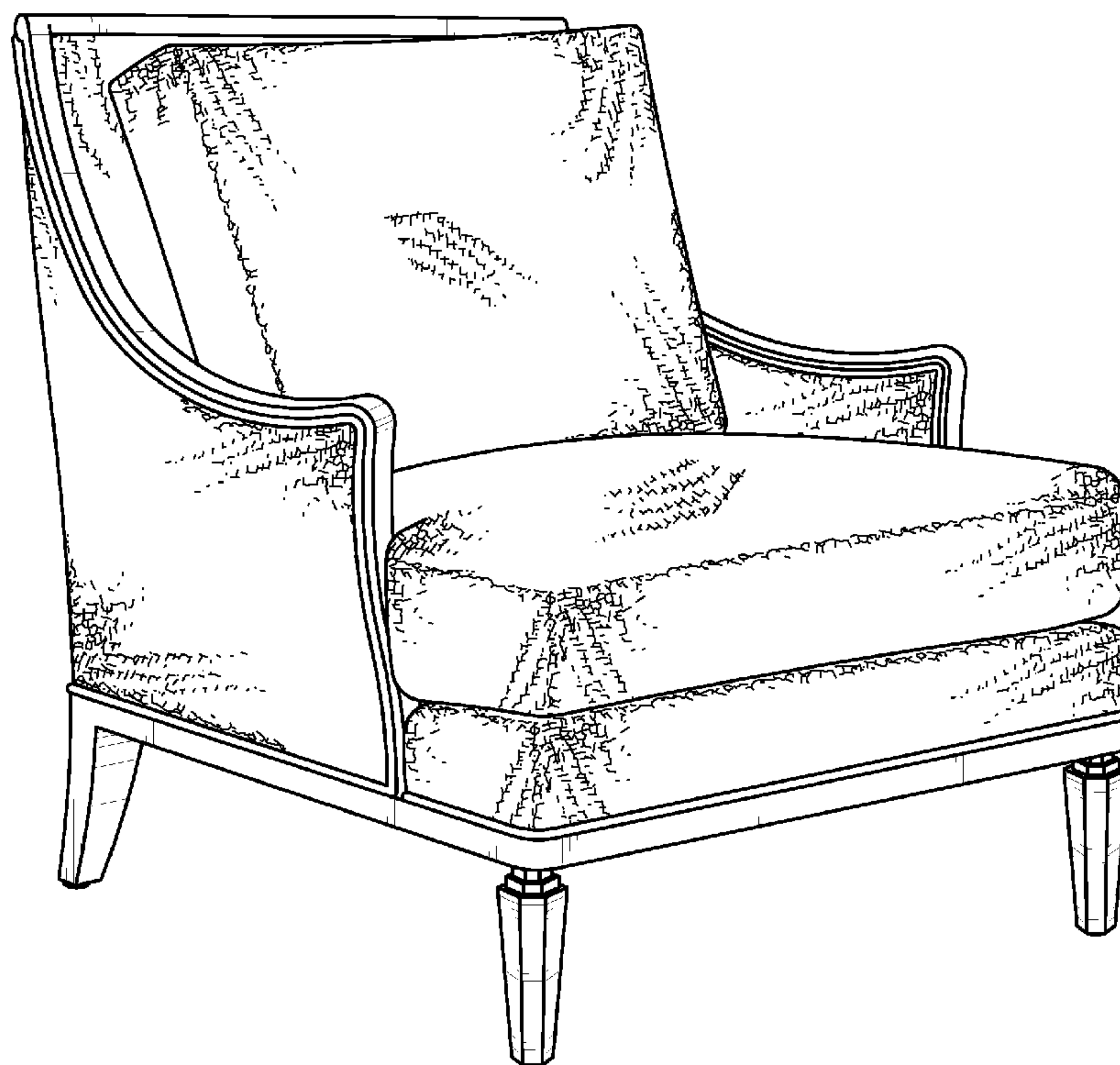
FIG. 4 is a top view of the chair of FIG. 1;

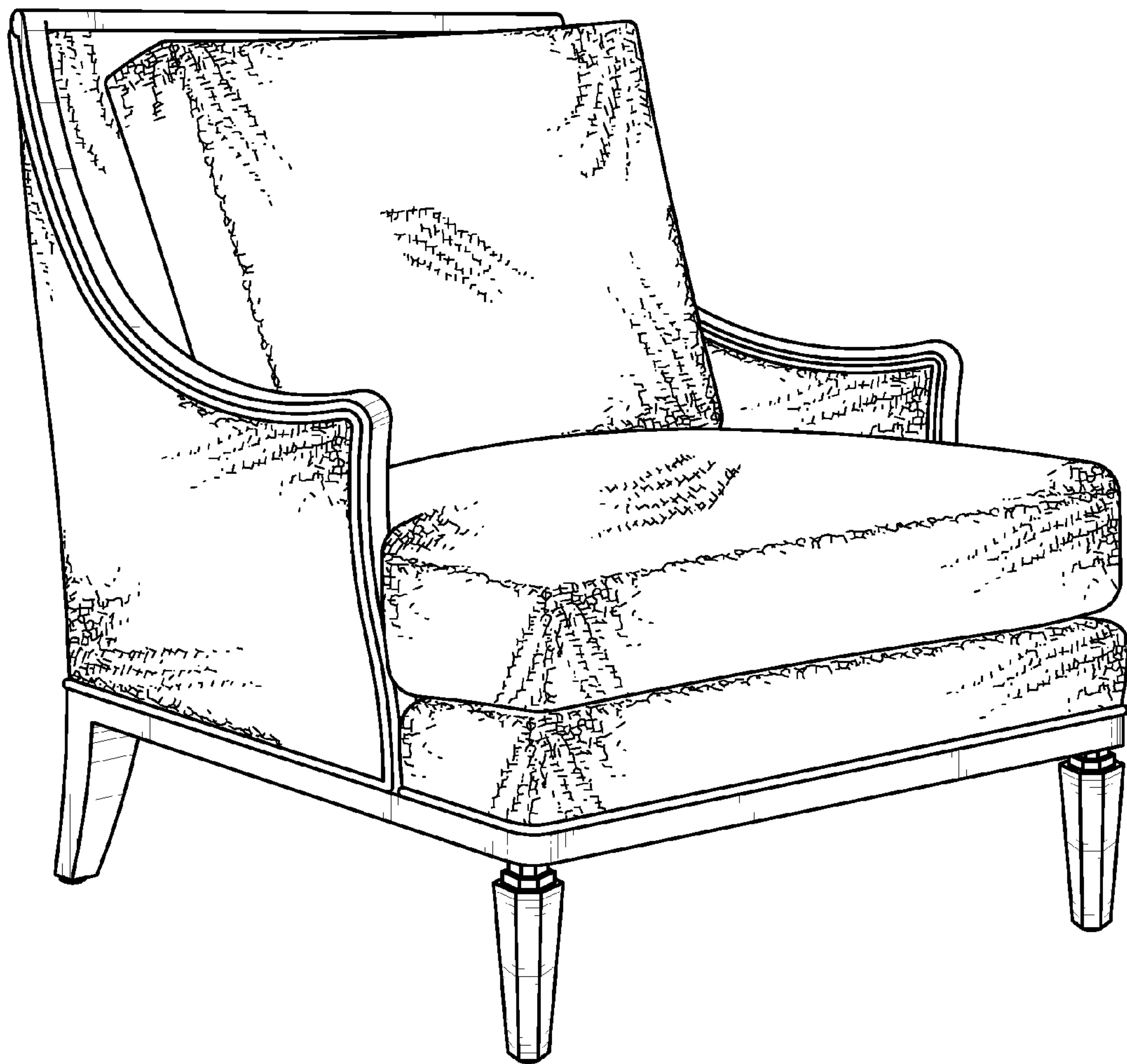

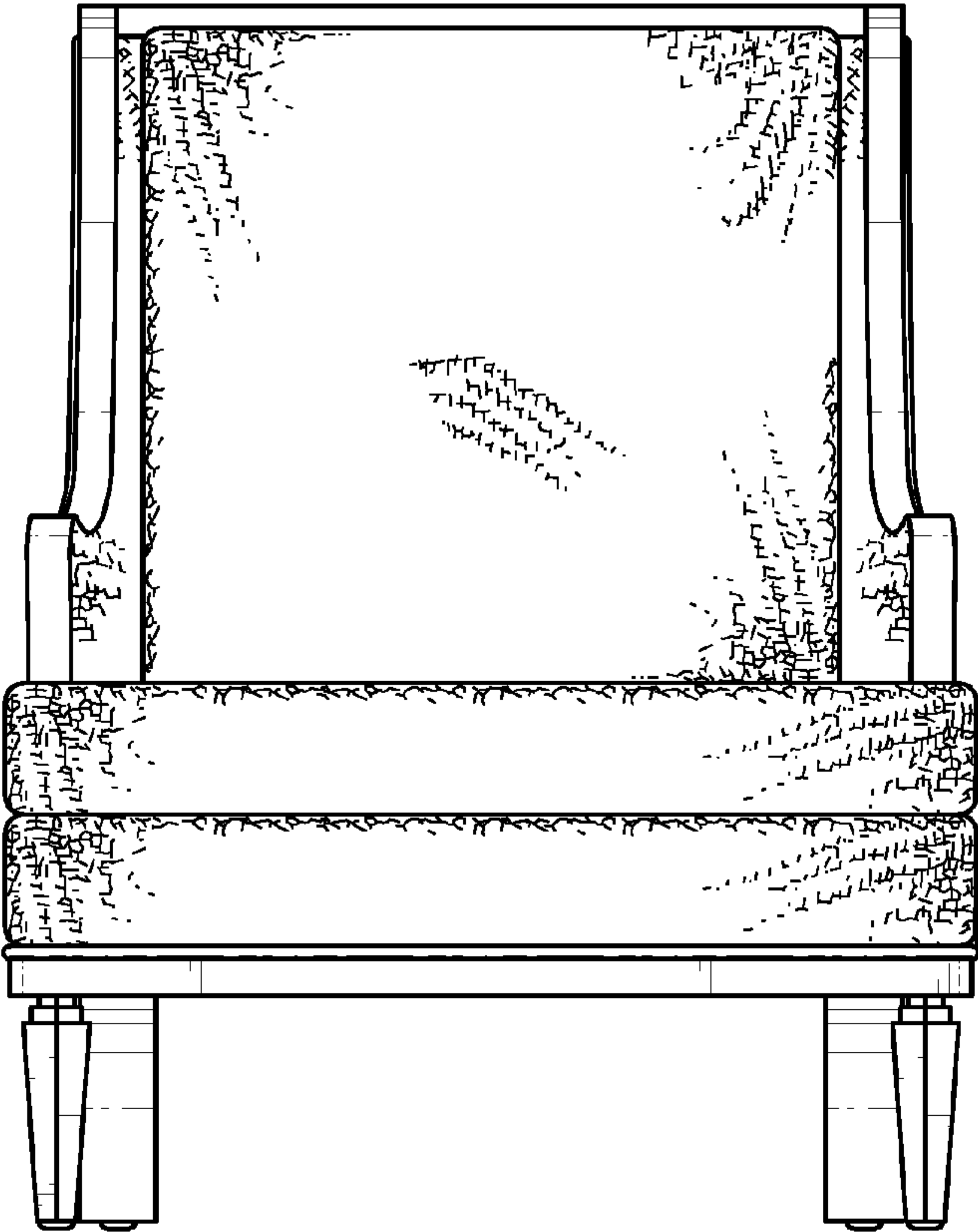

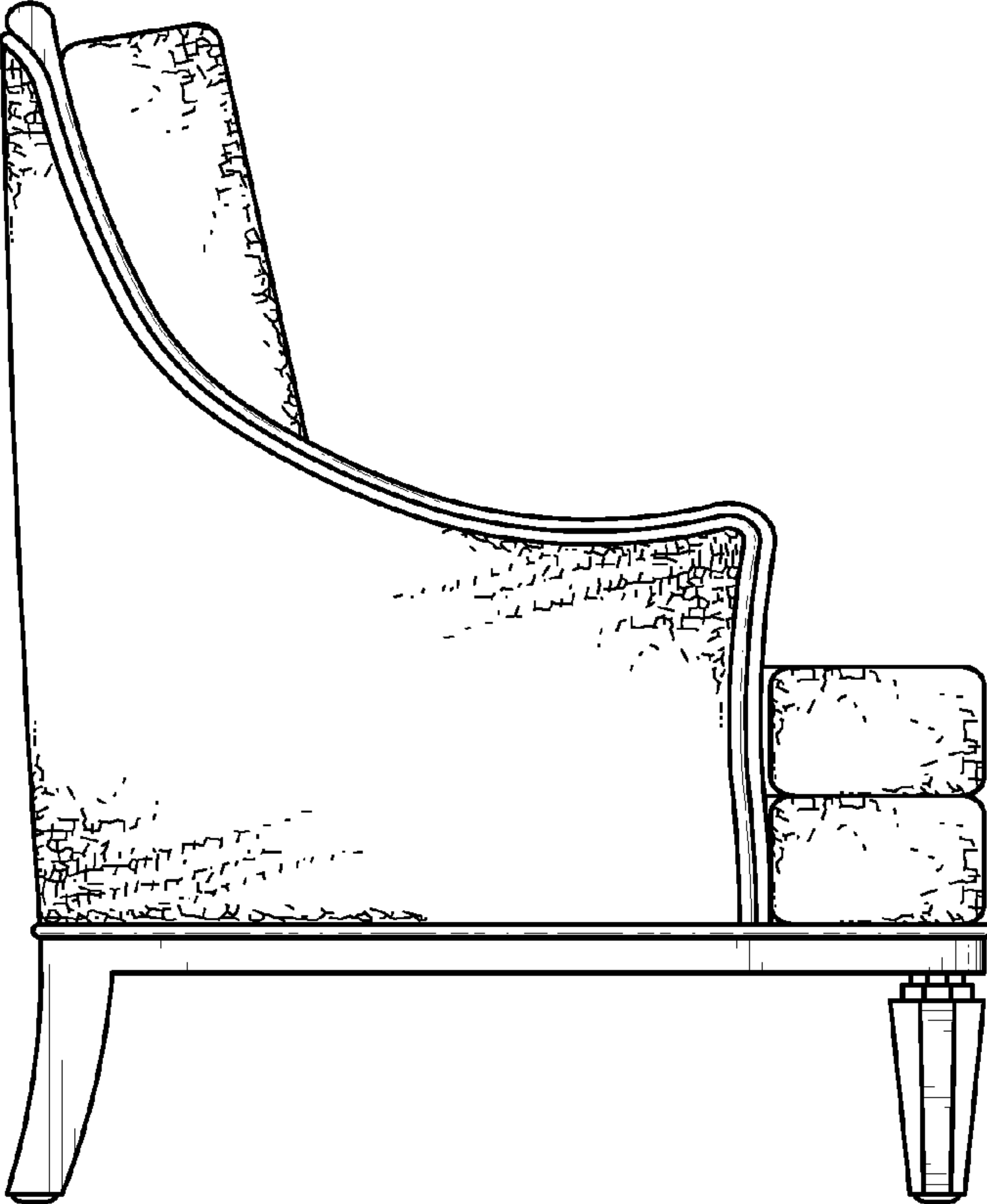

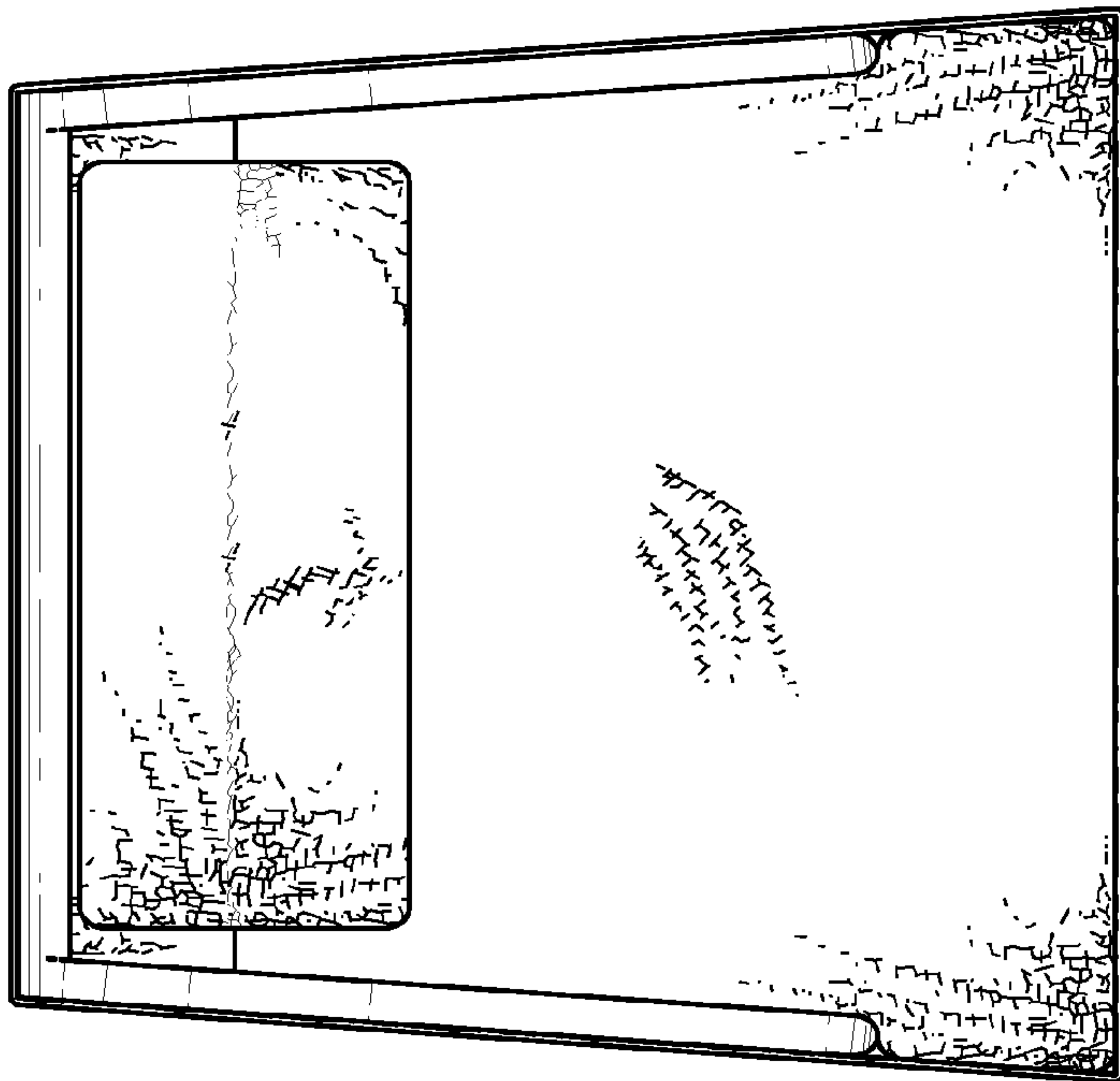
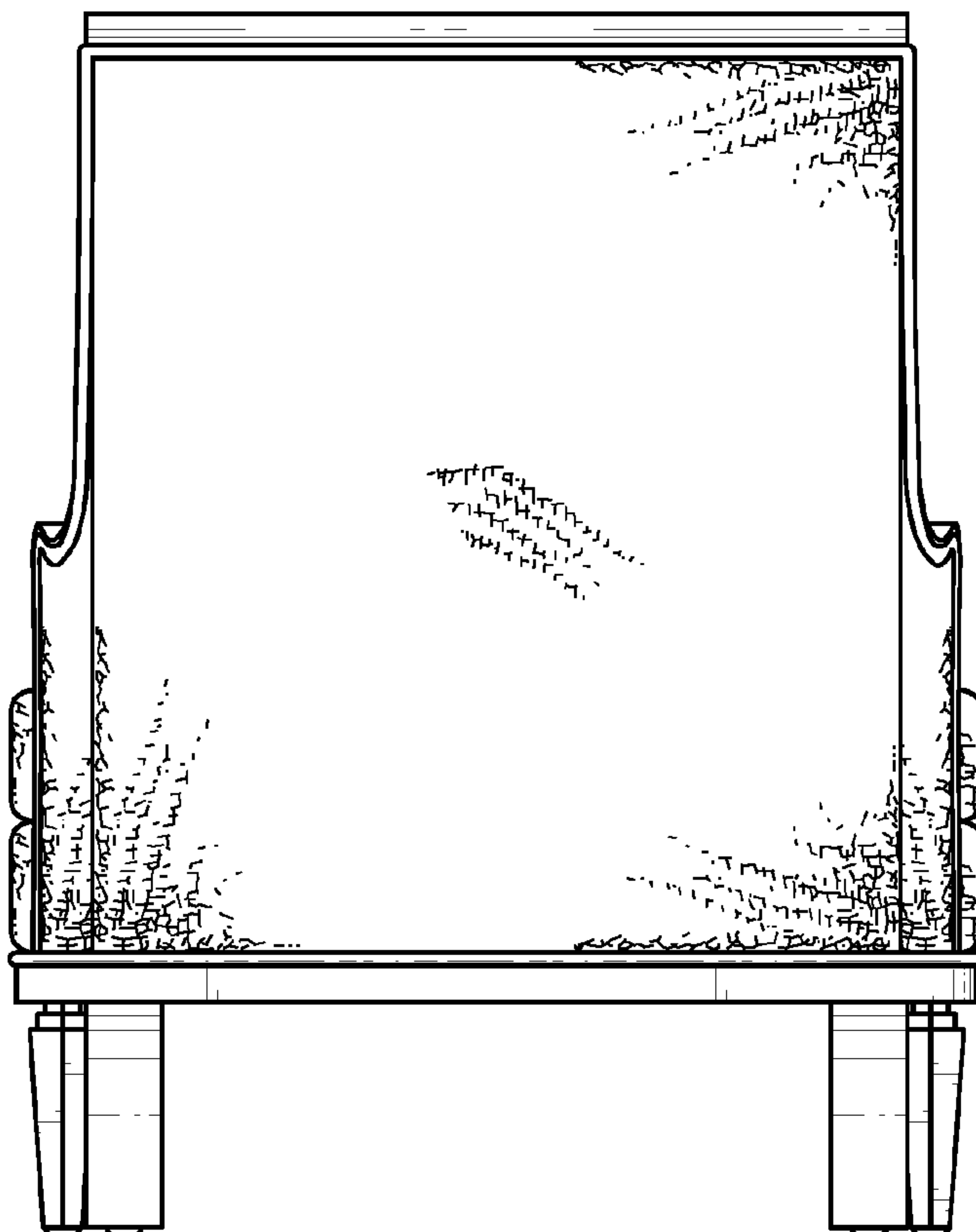

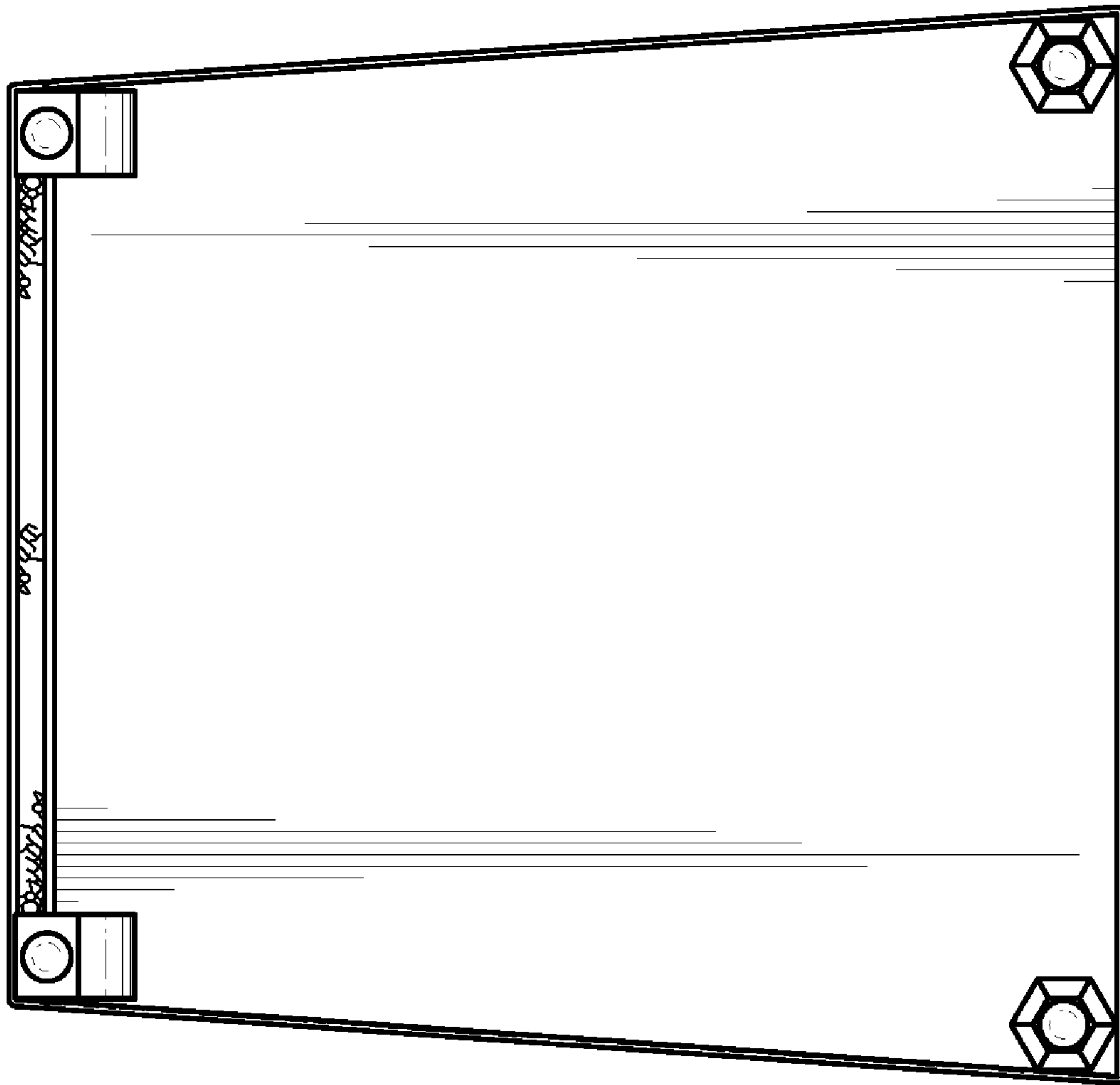
