DESCRIPTION

FIG. 1 is a perspective view of a pan handle, showing my new design from the top and left side;

FIG. 2 is a front elevational view thereof;

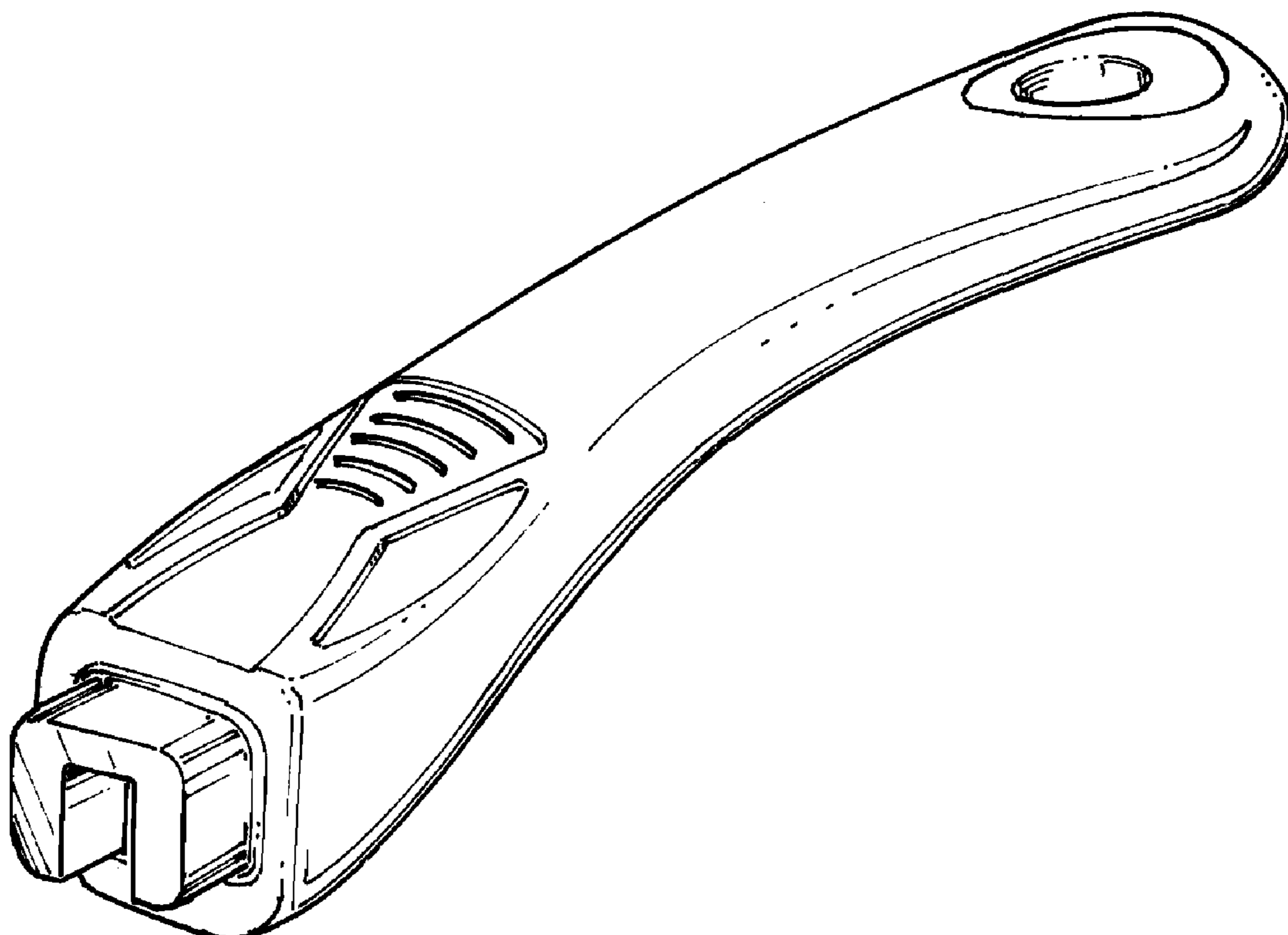
FIG. 3 is a rear elevational view thereof;

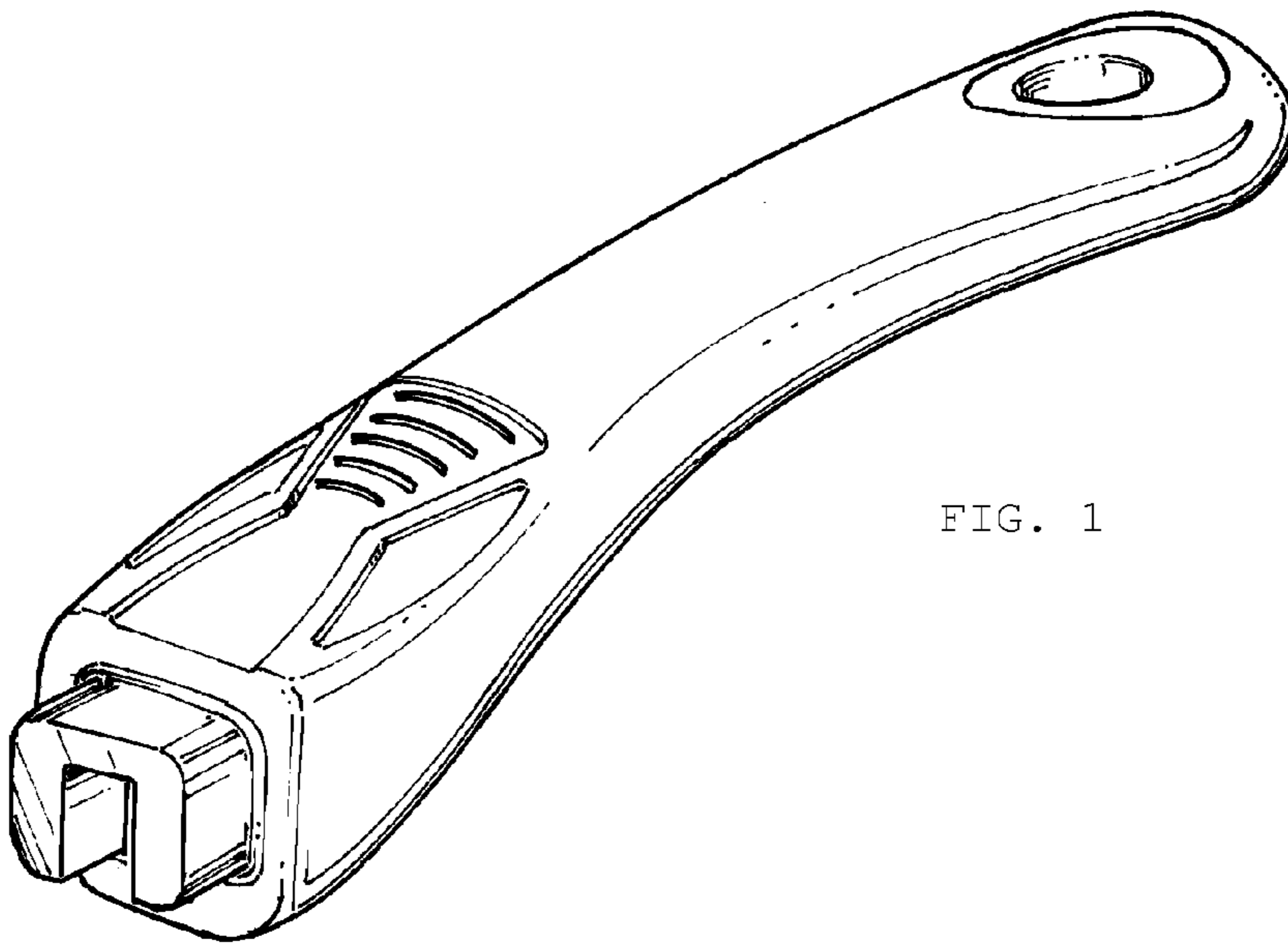

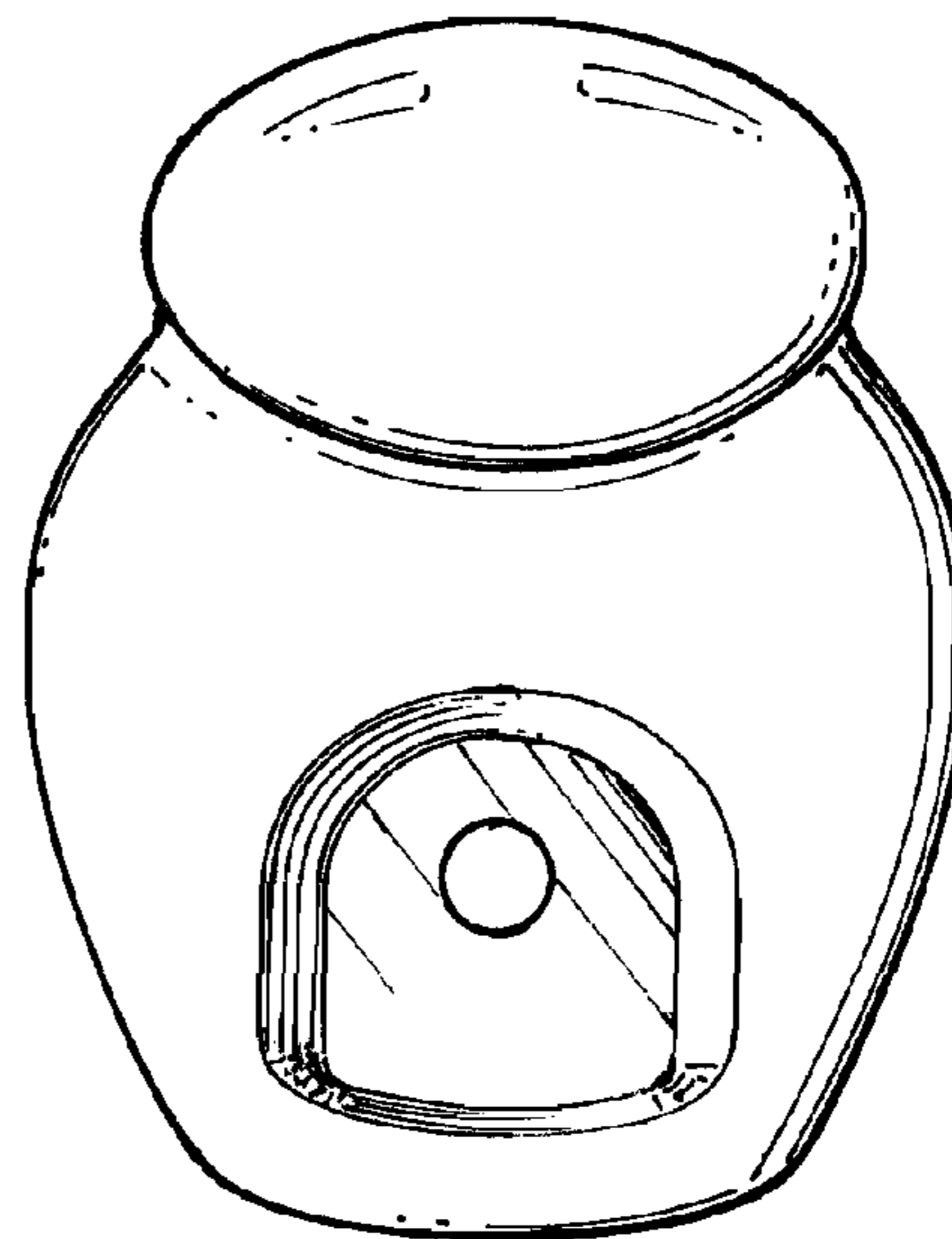

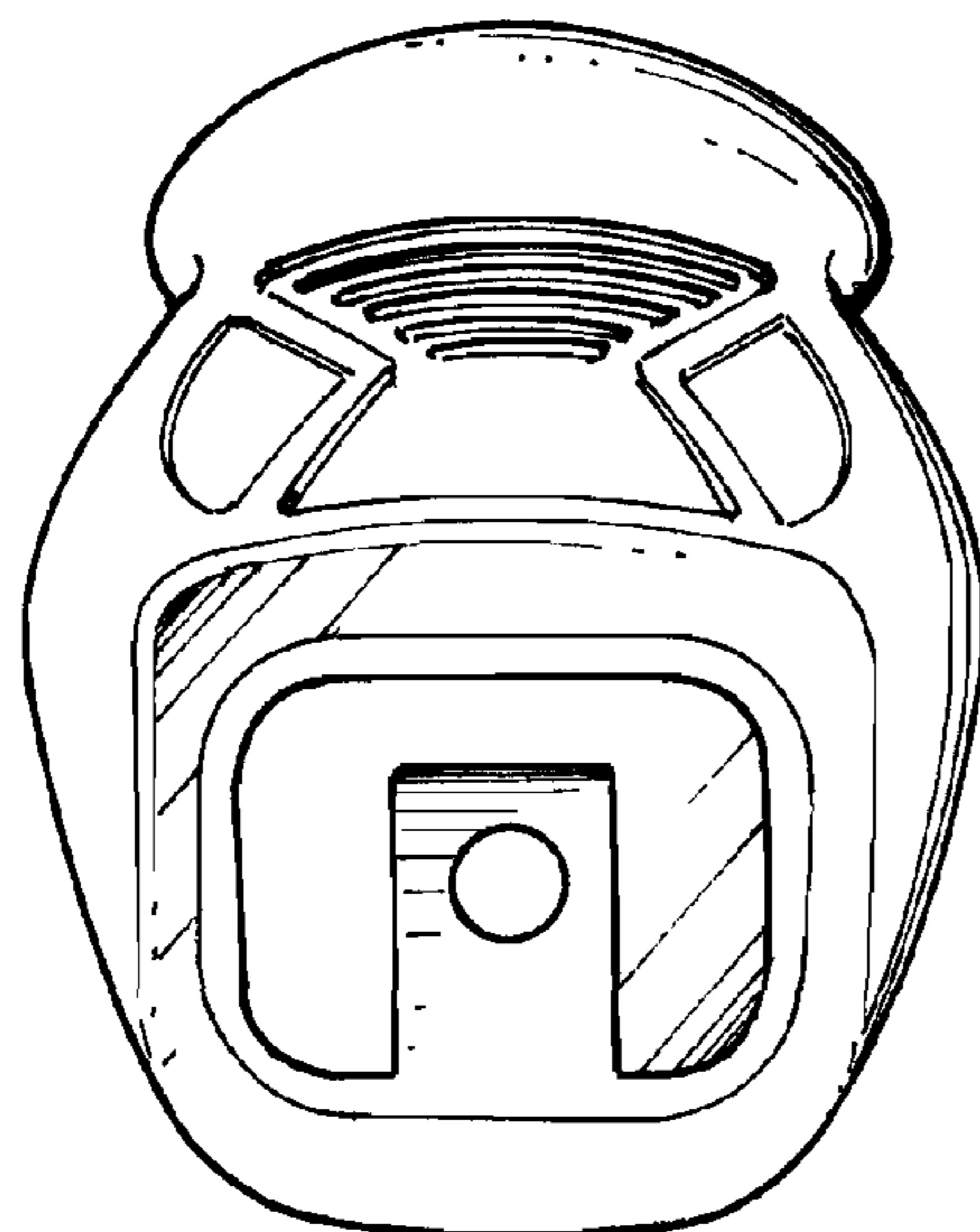

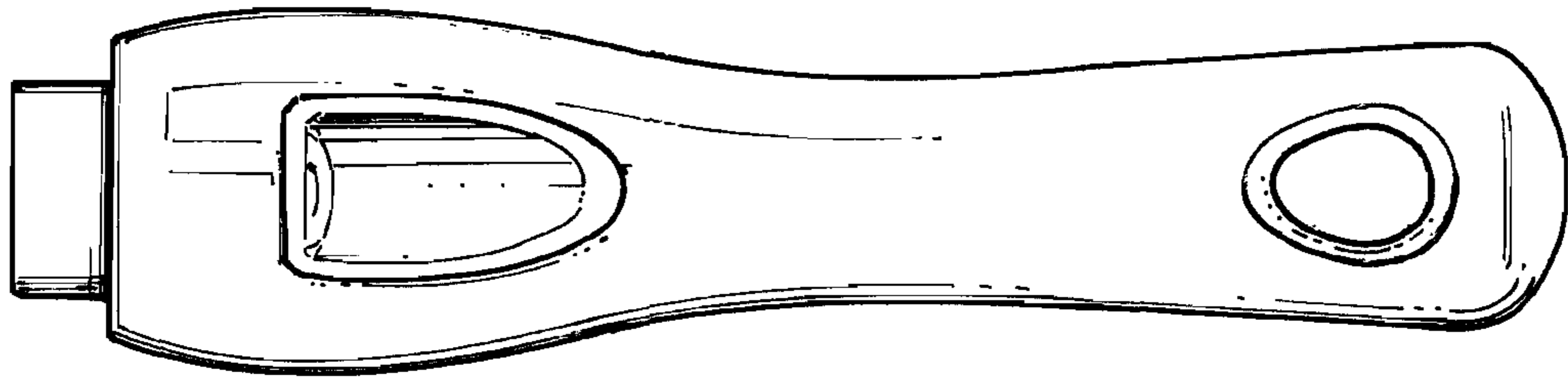

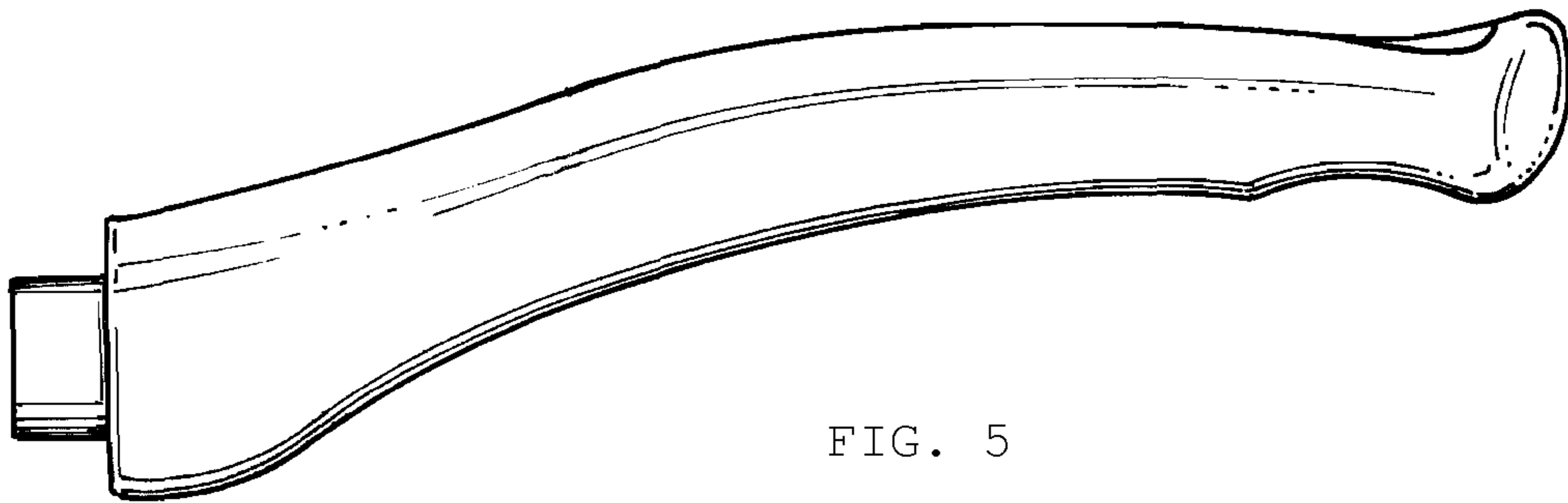

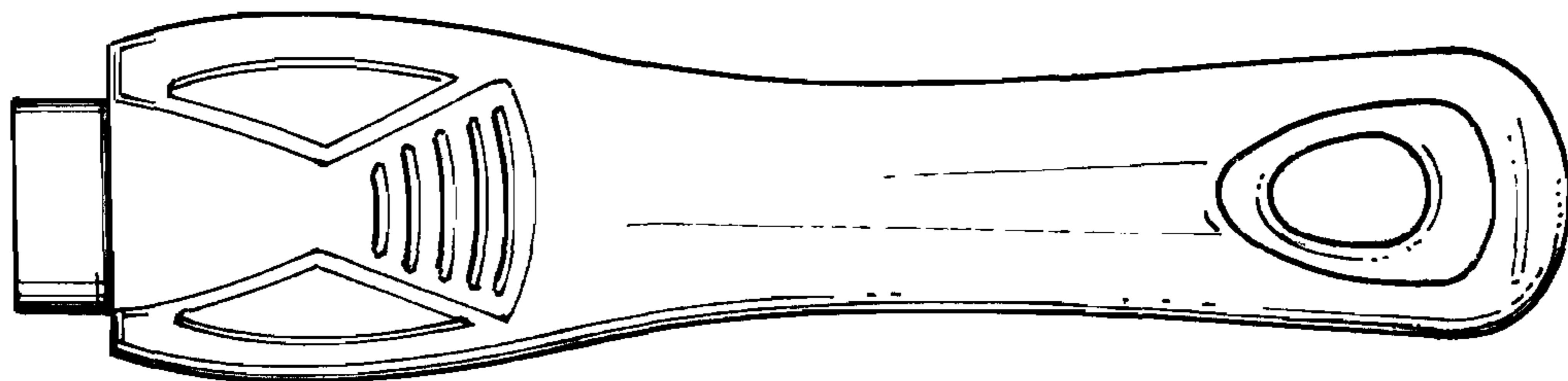
