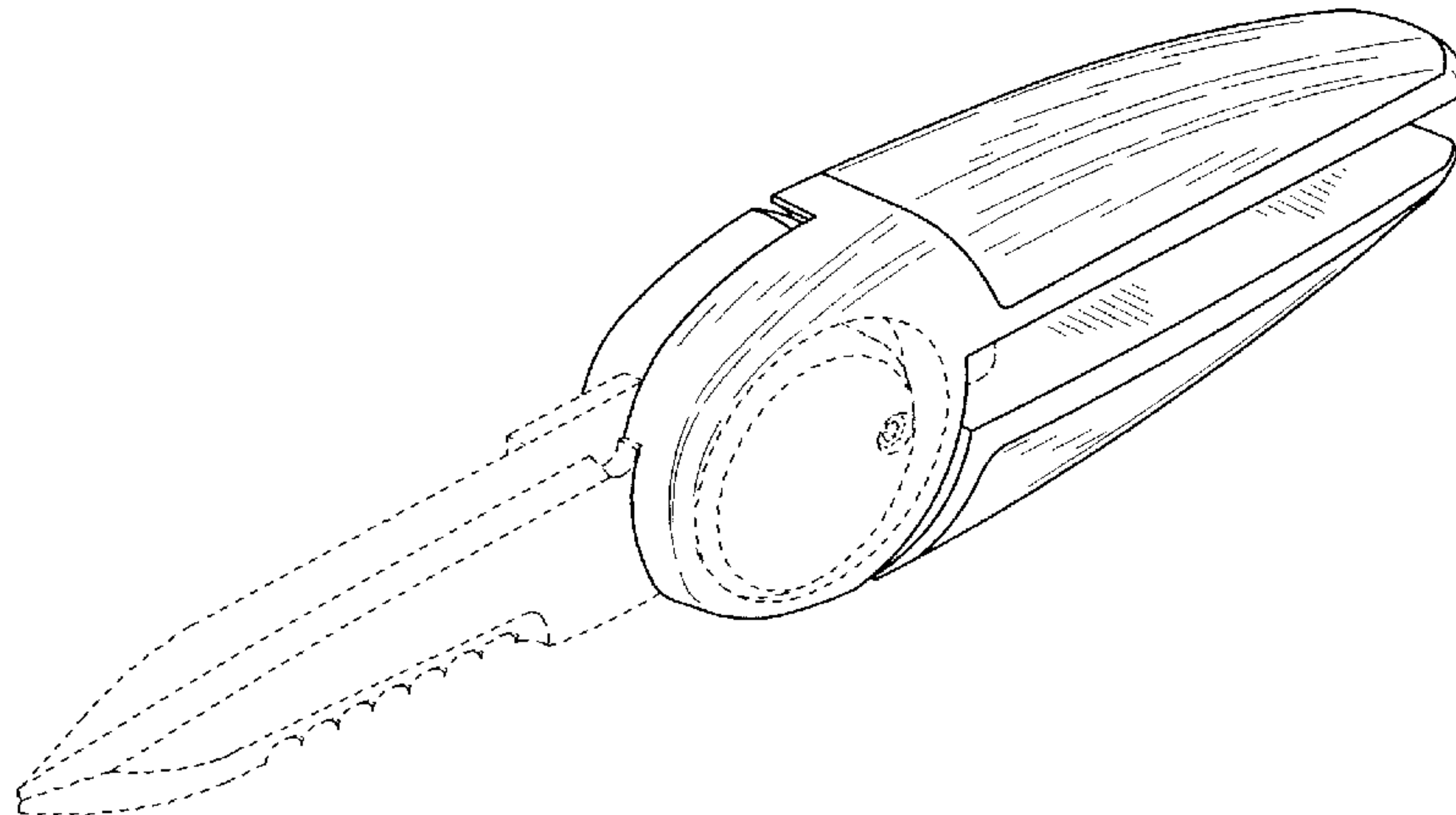
We claim the ornamental design for a handle for a hand tool, as shown and described.

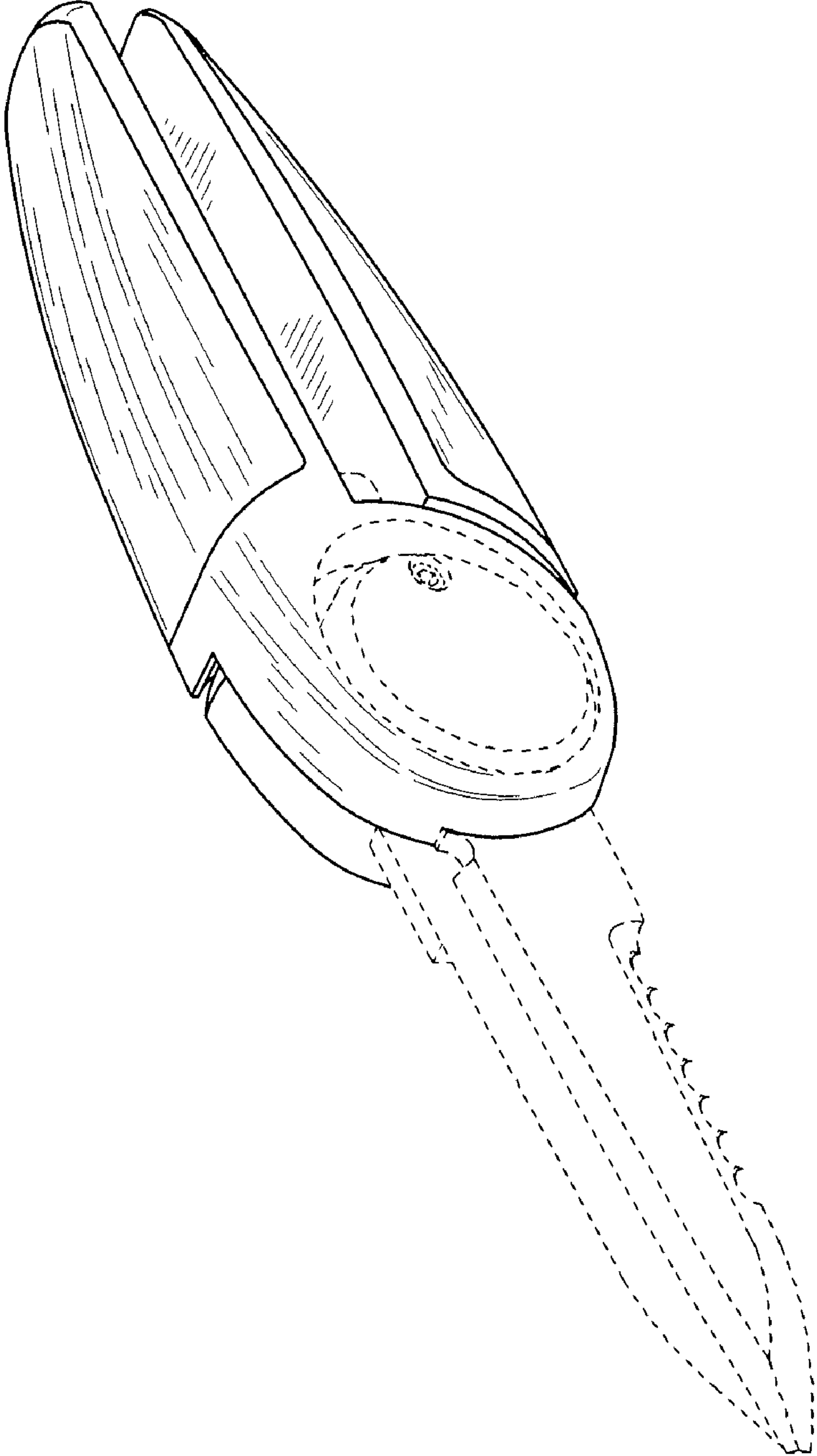

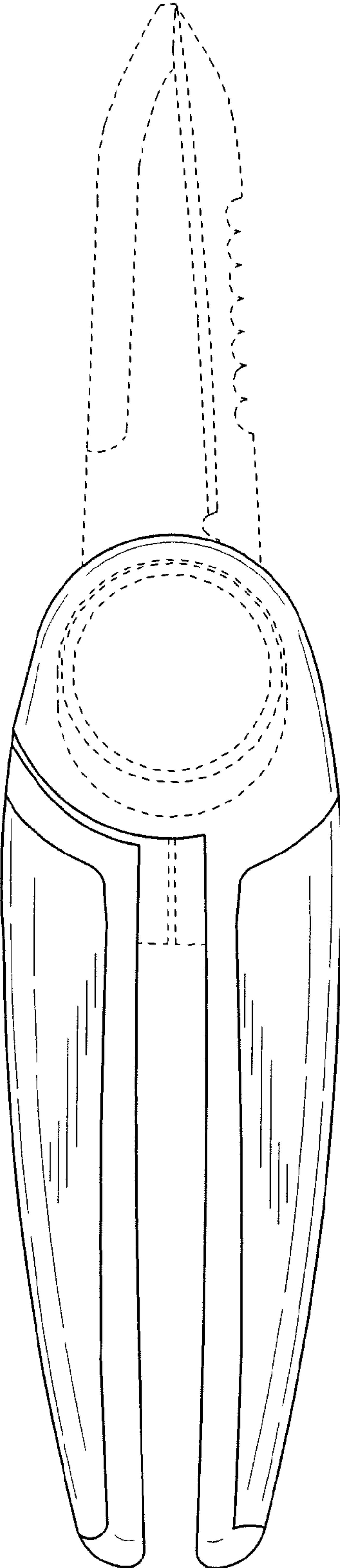

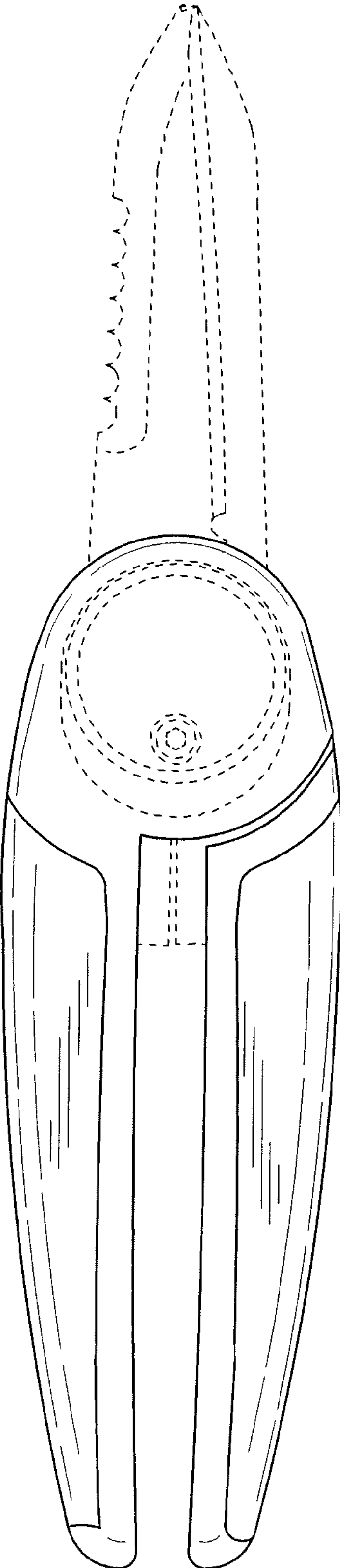

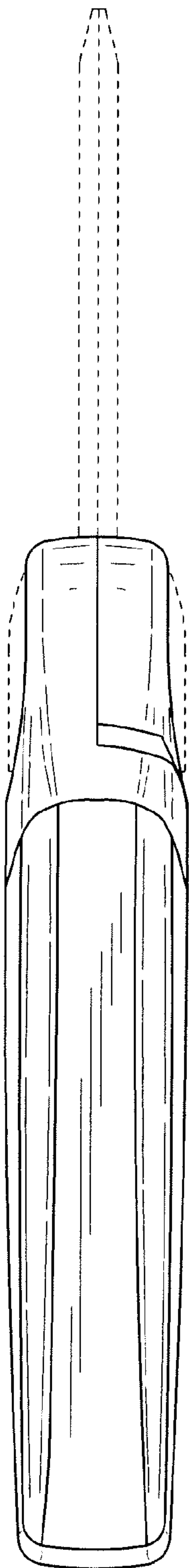

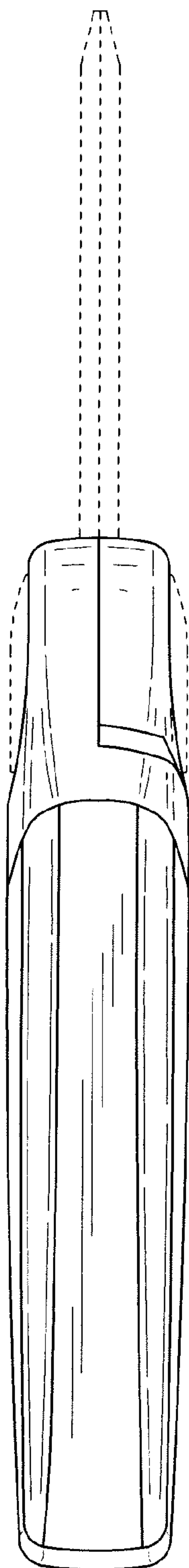

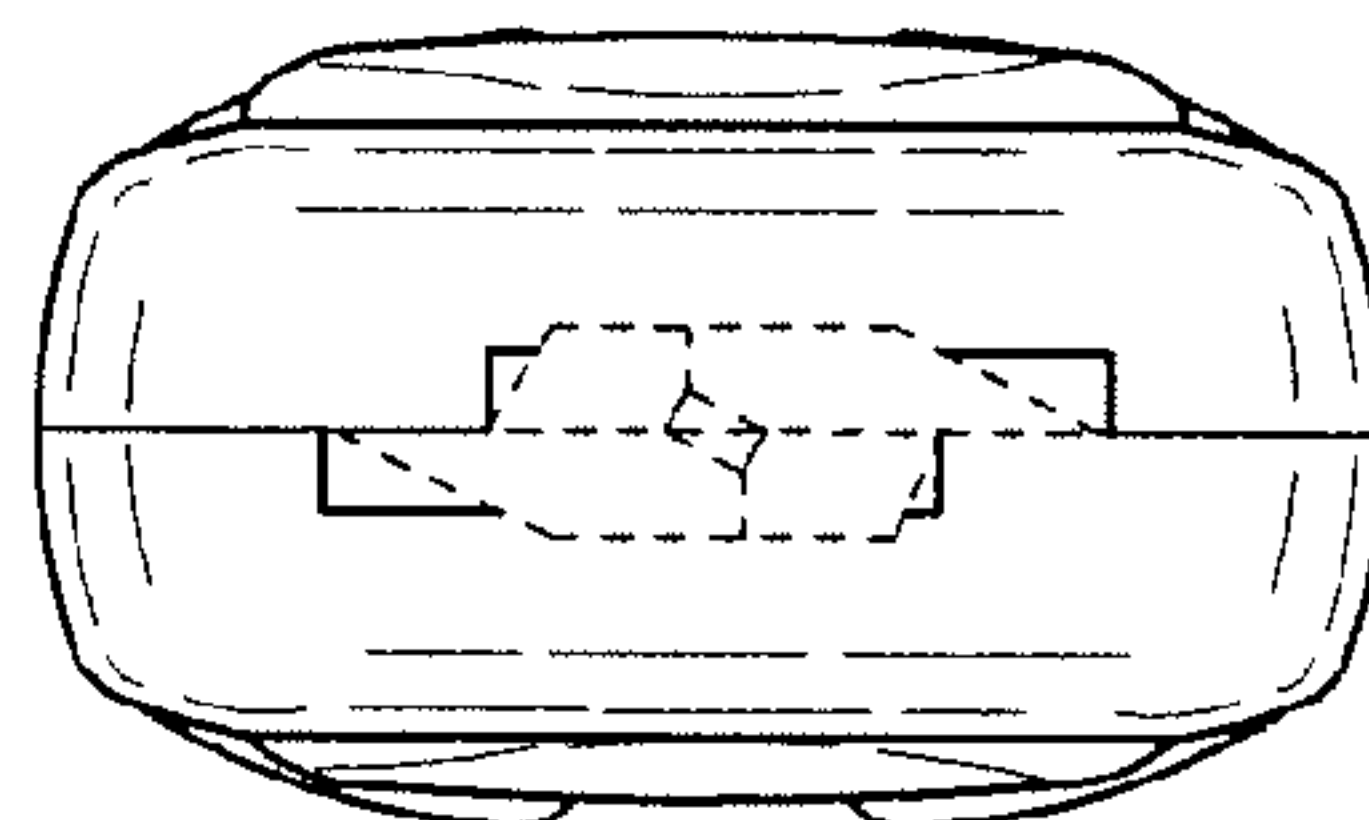
