(57) **CLAIM**

The ornamental design for an electric connector, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of an electric connector, showing our new design;

FIG. 2 is a bottom, rear and right side perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof; and,

FIG. 7 is a top plan view thereof, a bottom plan view being a mirror image of the top plan view.

The broken line showing on the drawing disclosure is for illustrative purposes only and forms no part of the claimed design. The lines consisting of long lines and dots indicate conceptual border lines between the claimed portions and the disclaimed portion.

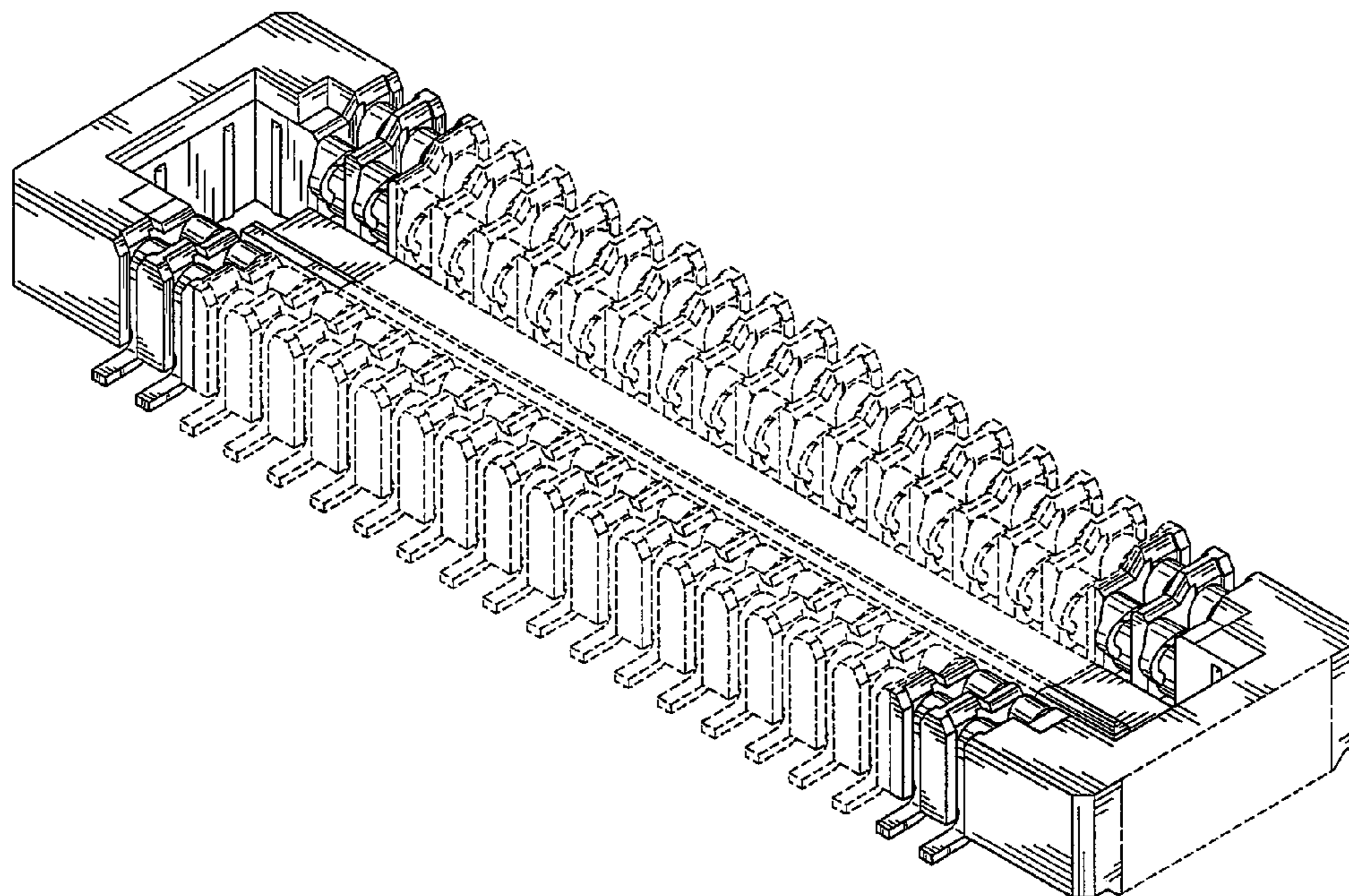

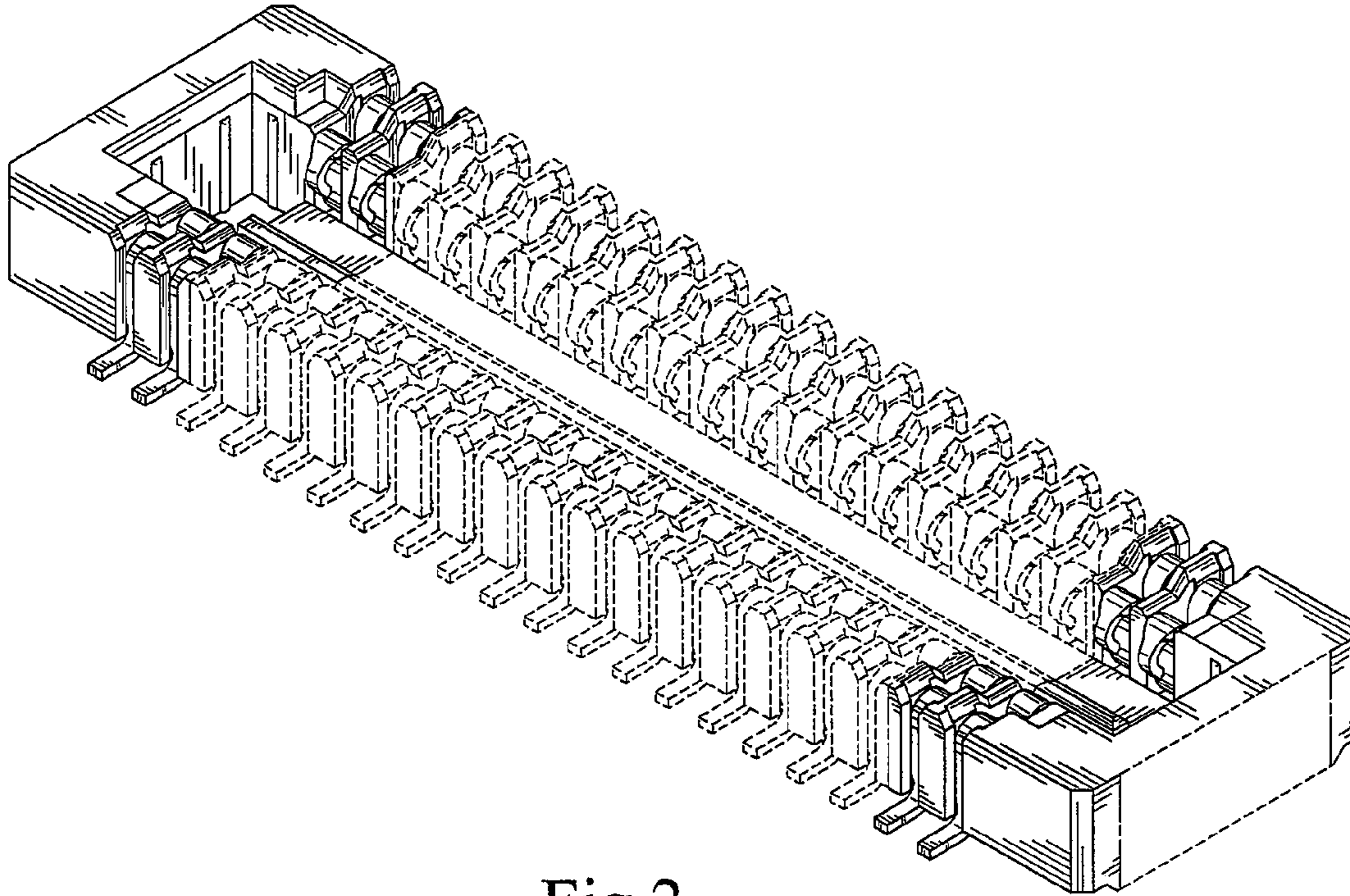

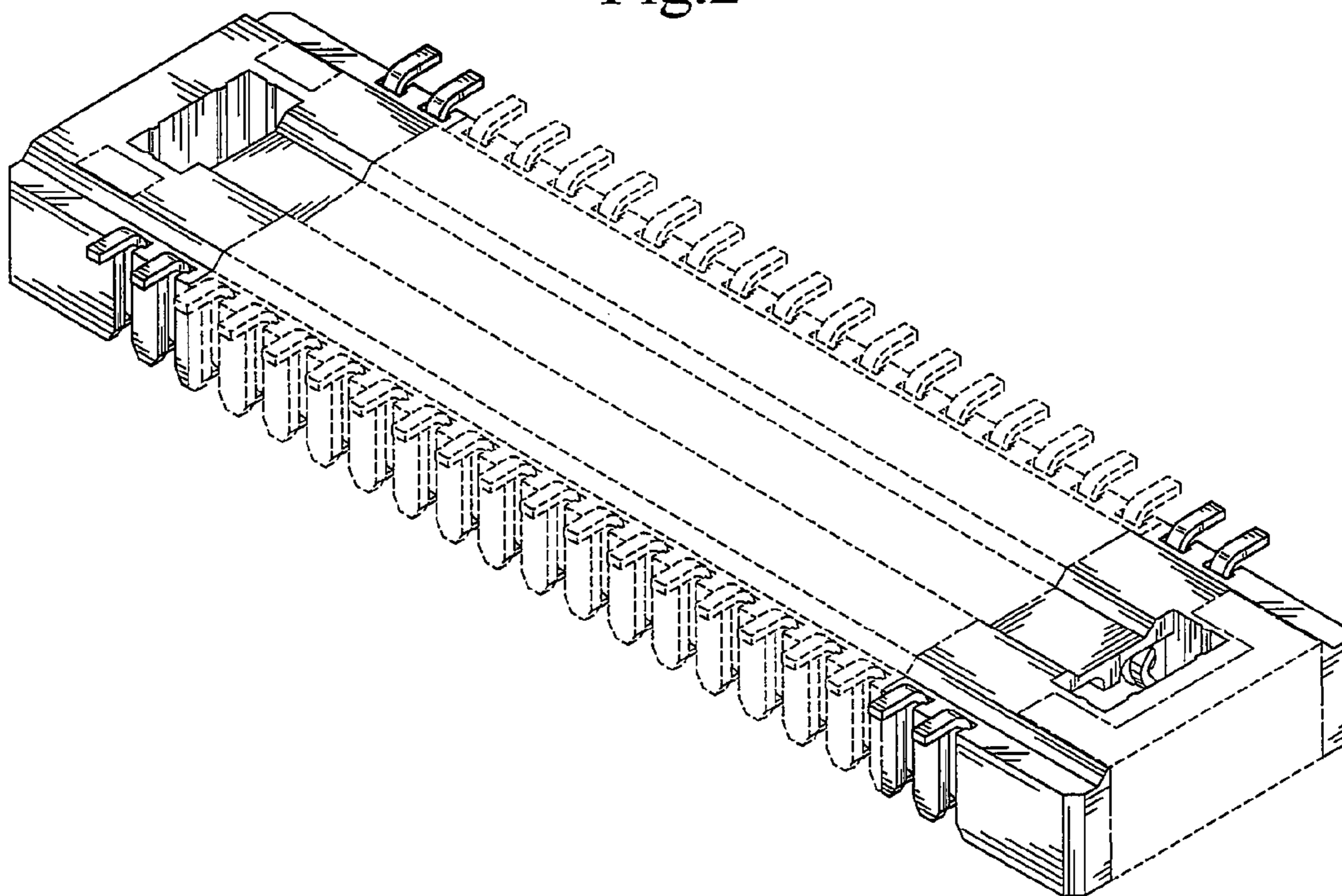

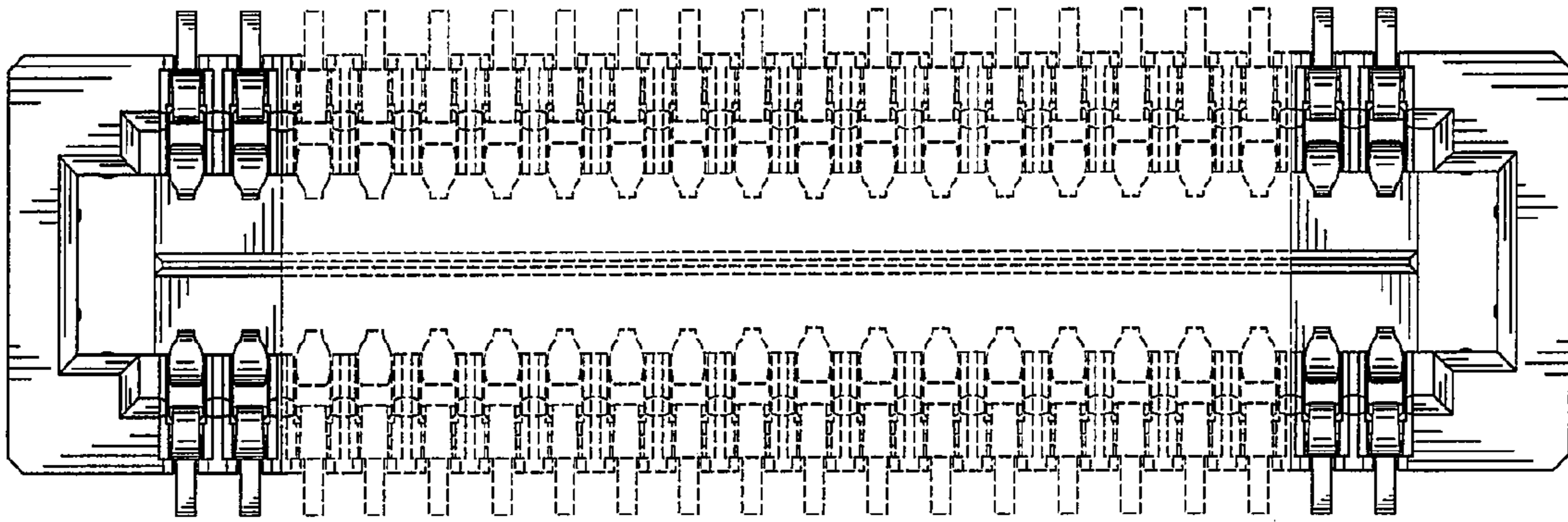

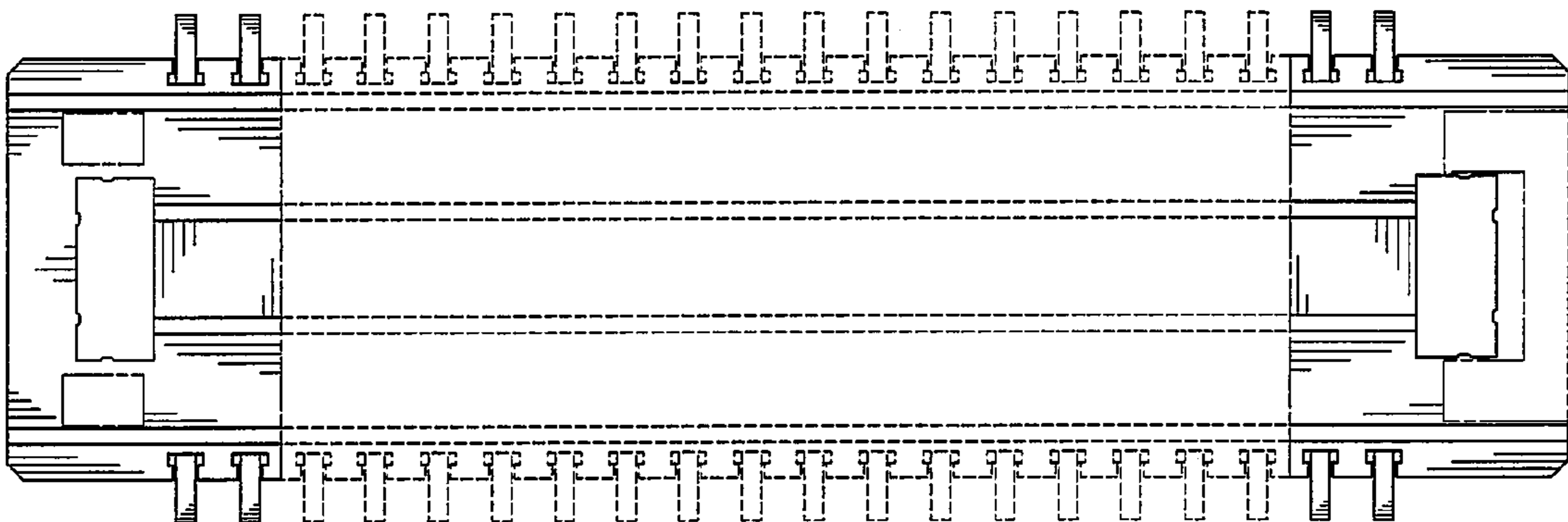

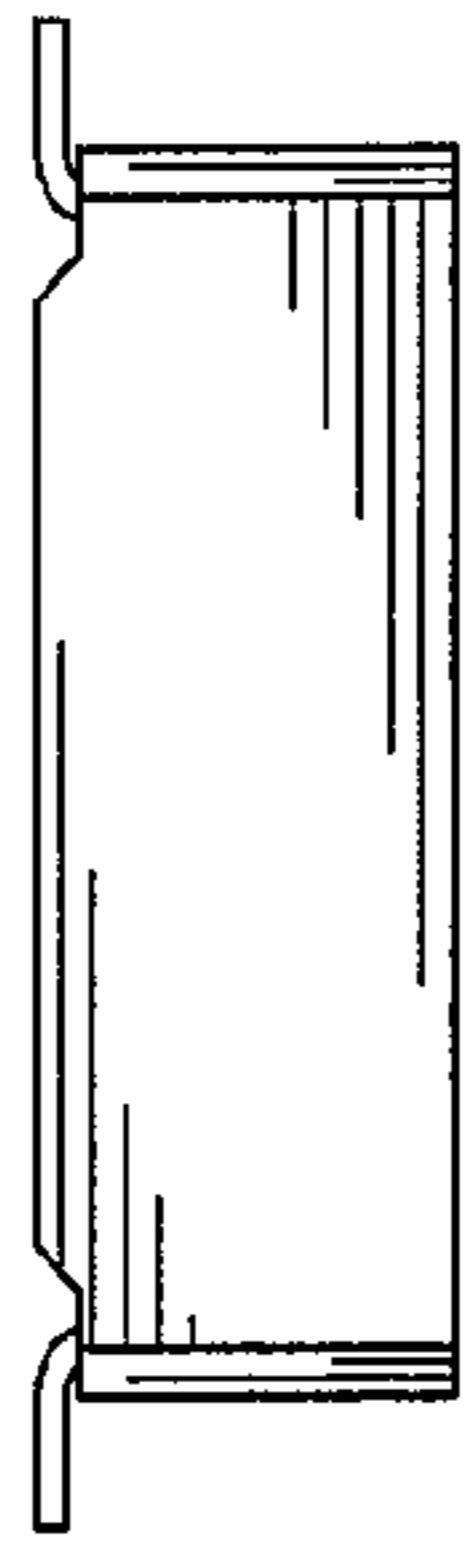
