FIG. 8 is an enlargement of the image area shown in FIG. 2.

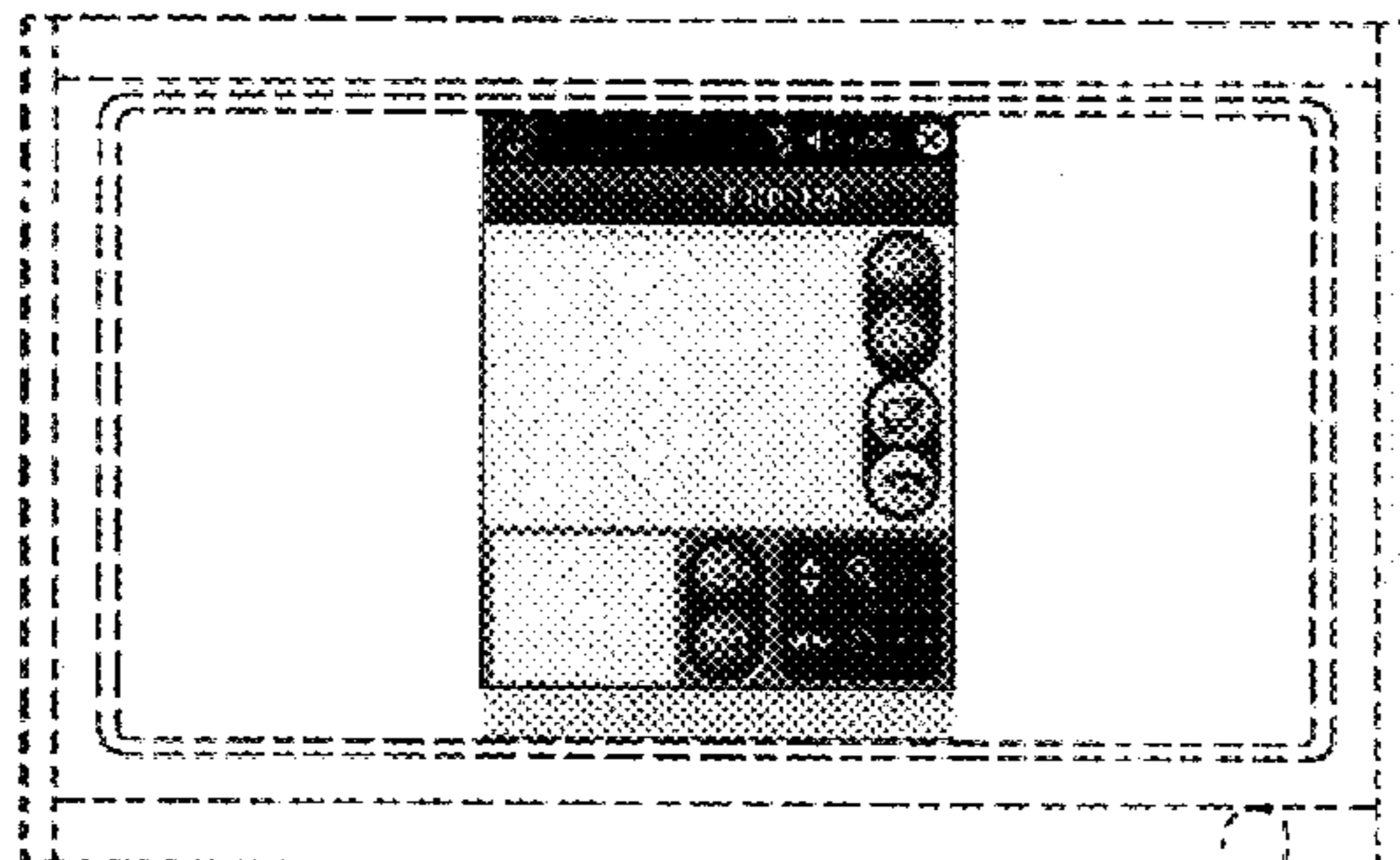
The broken line showing of a personal digital assistant is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

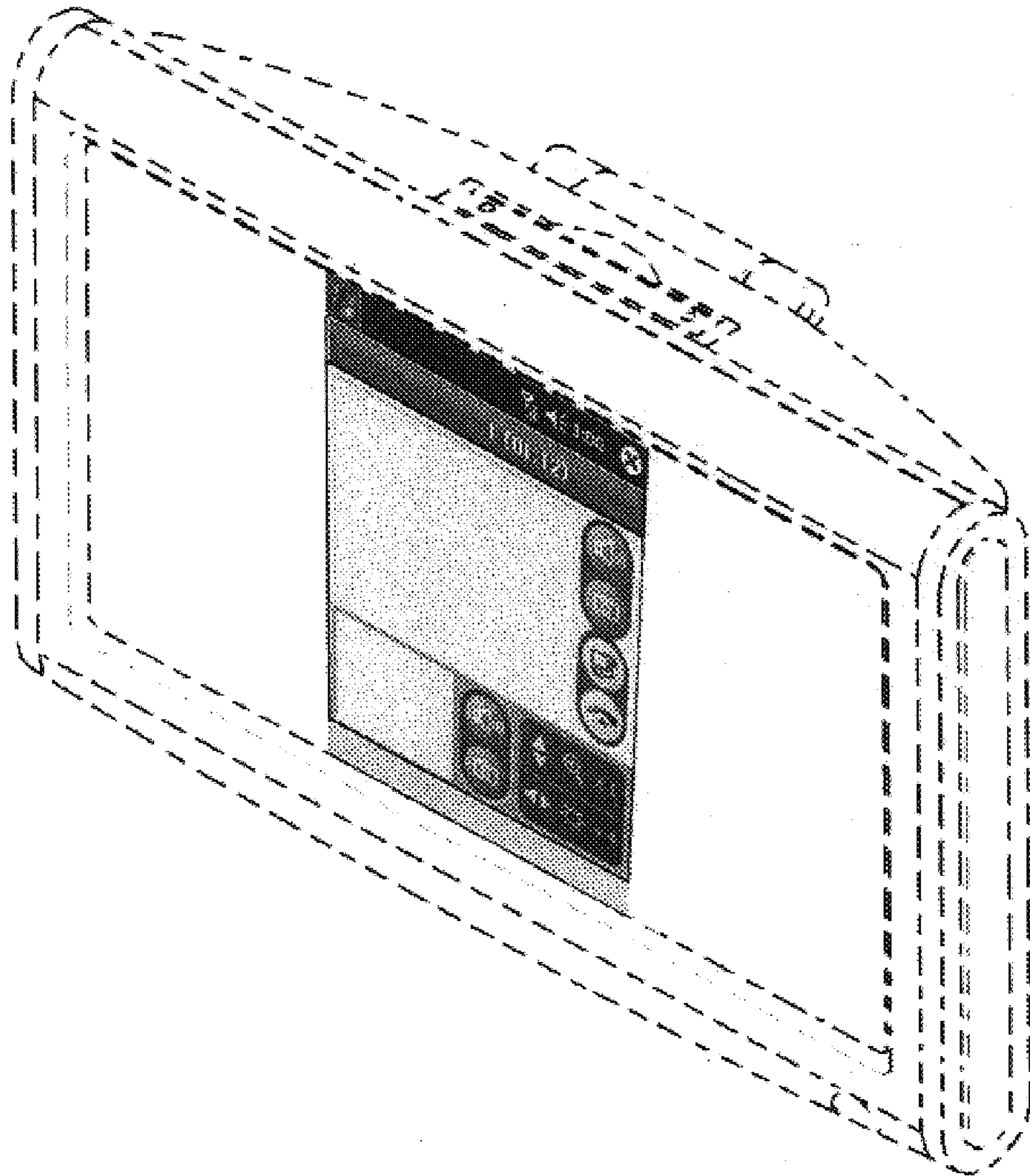

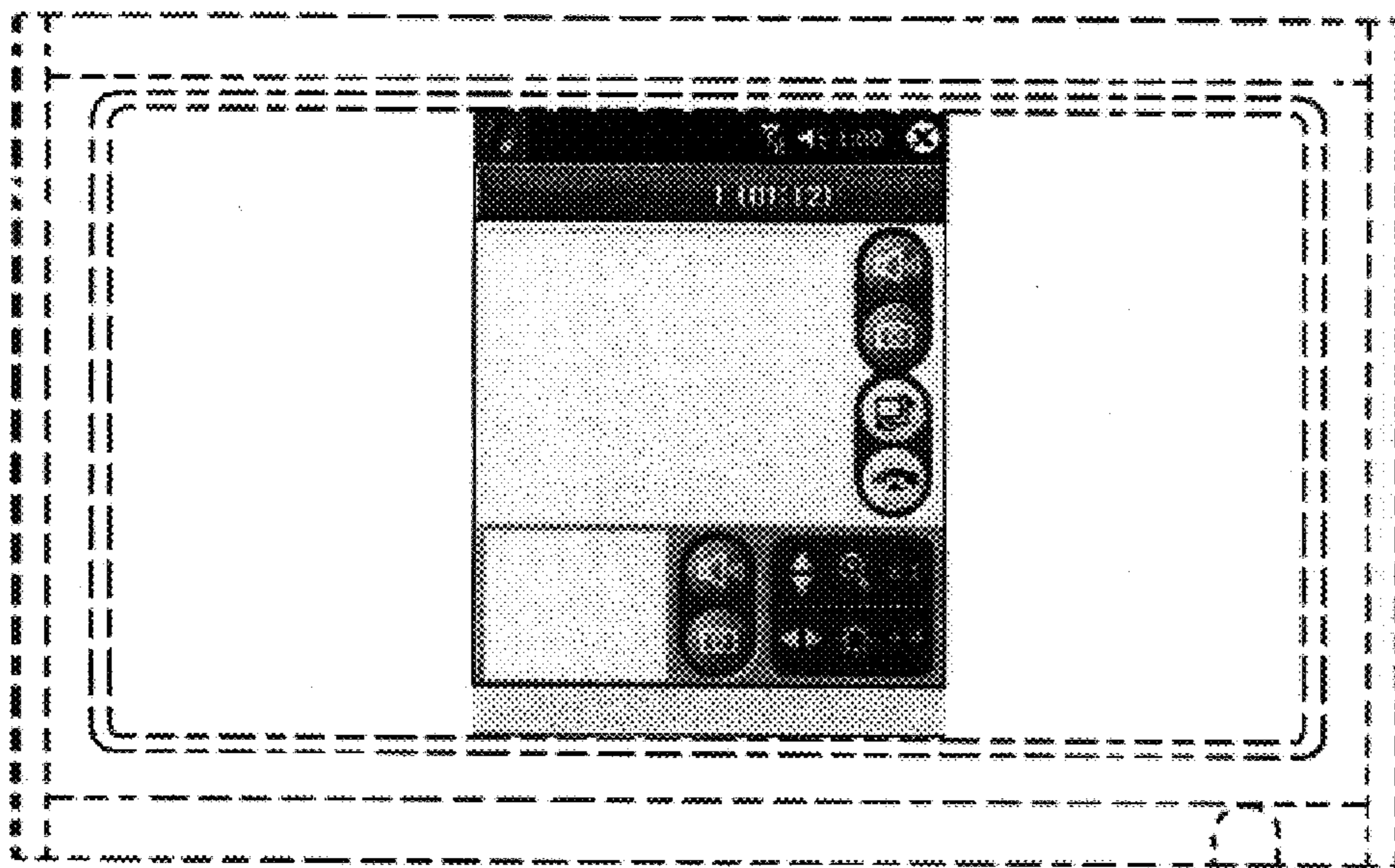

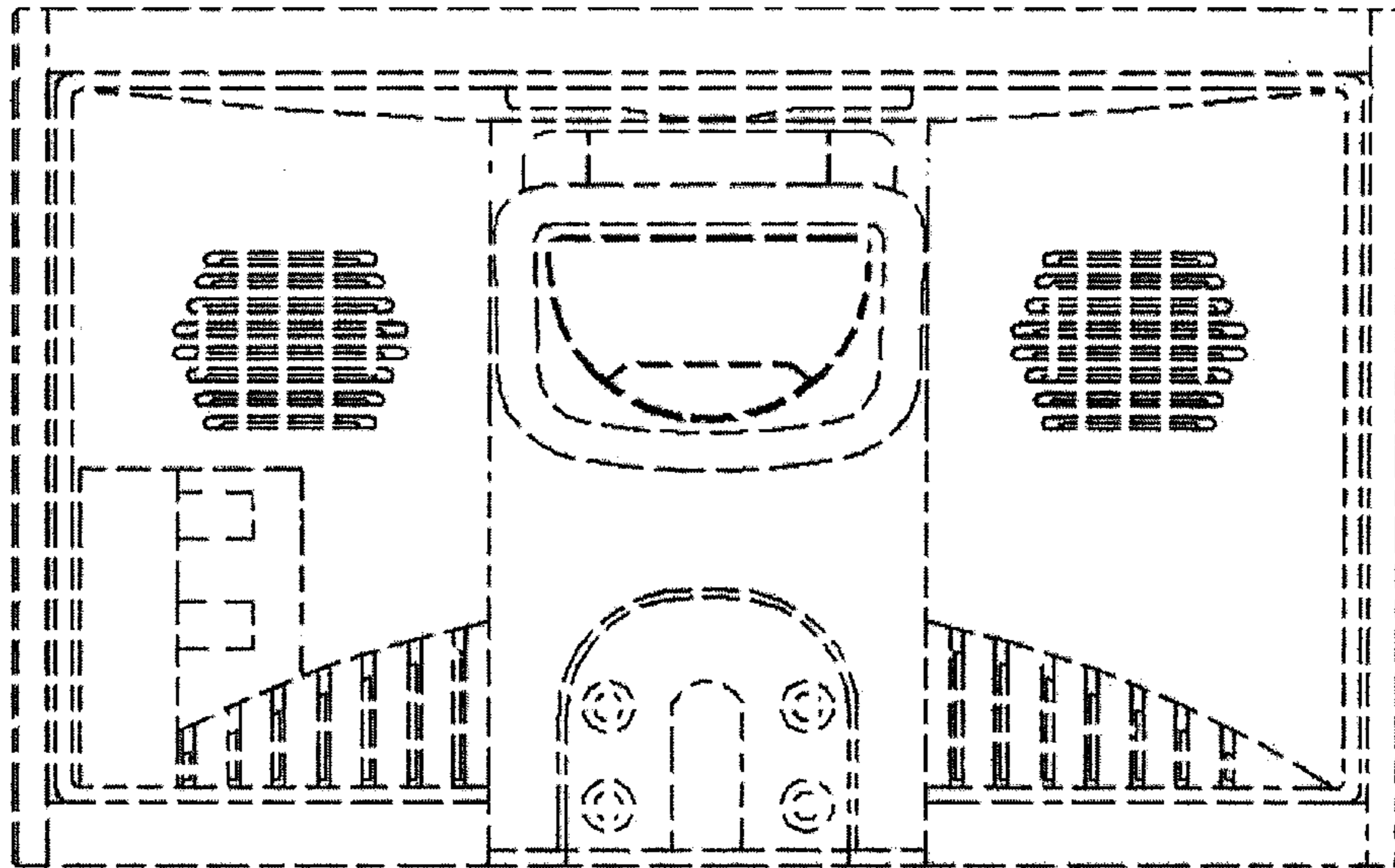

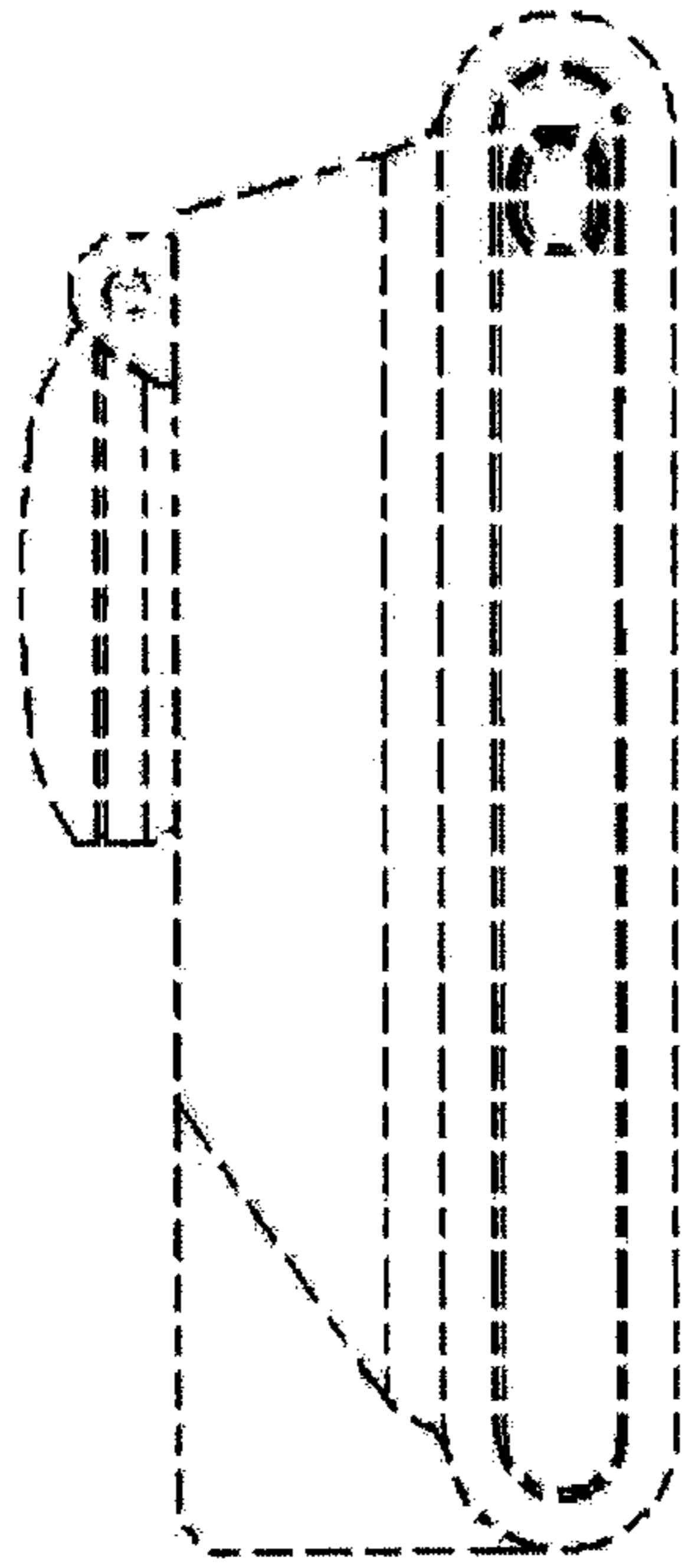

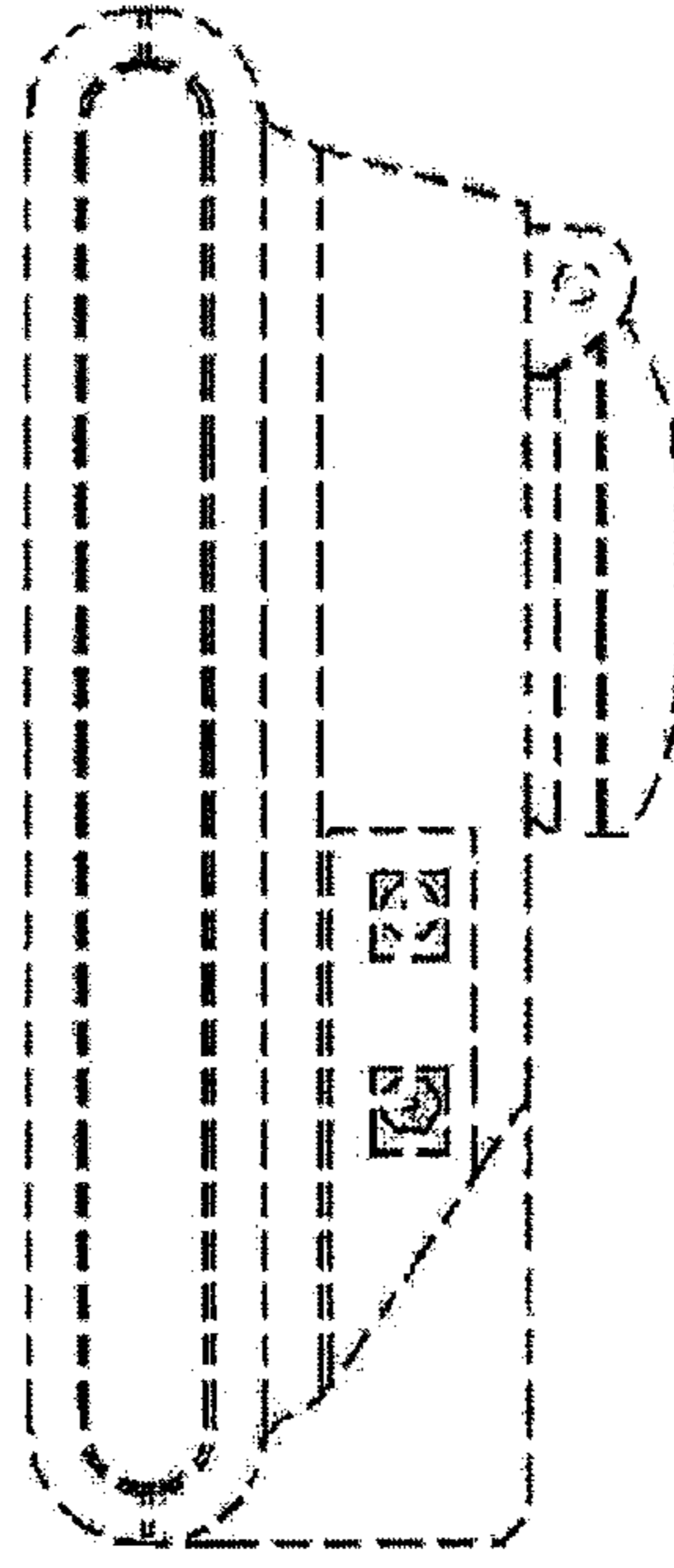

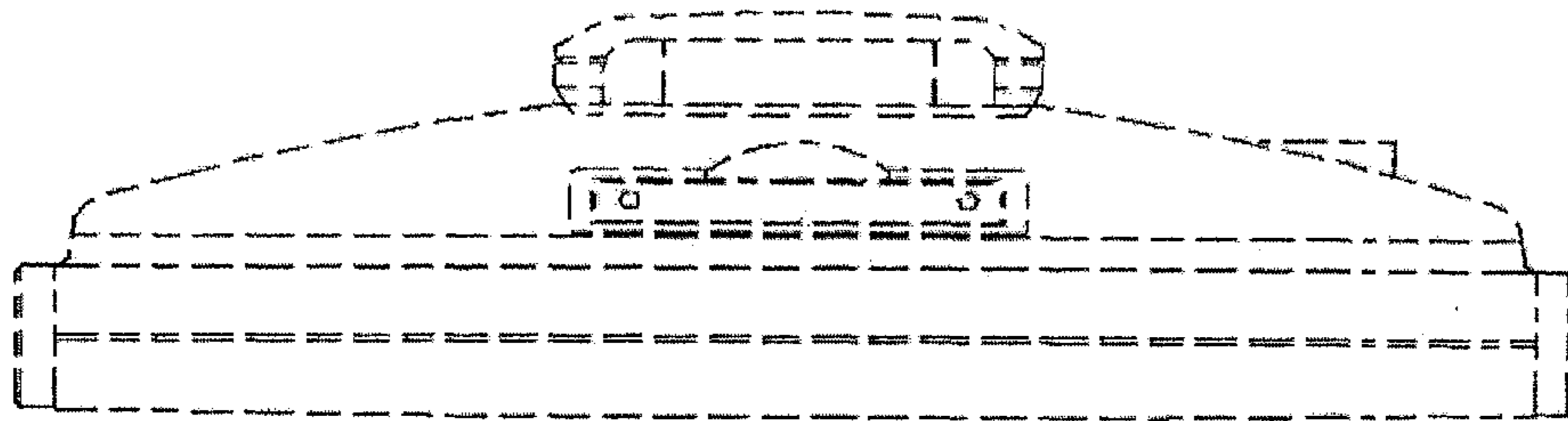

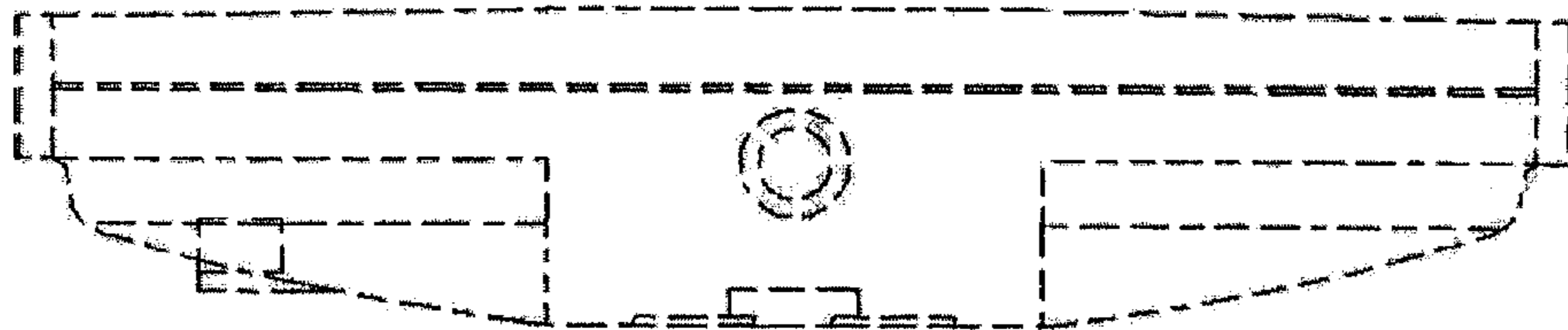

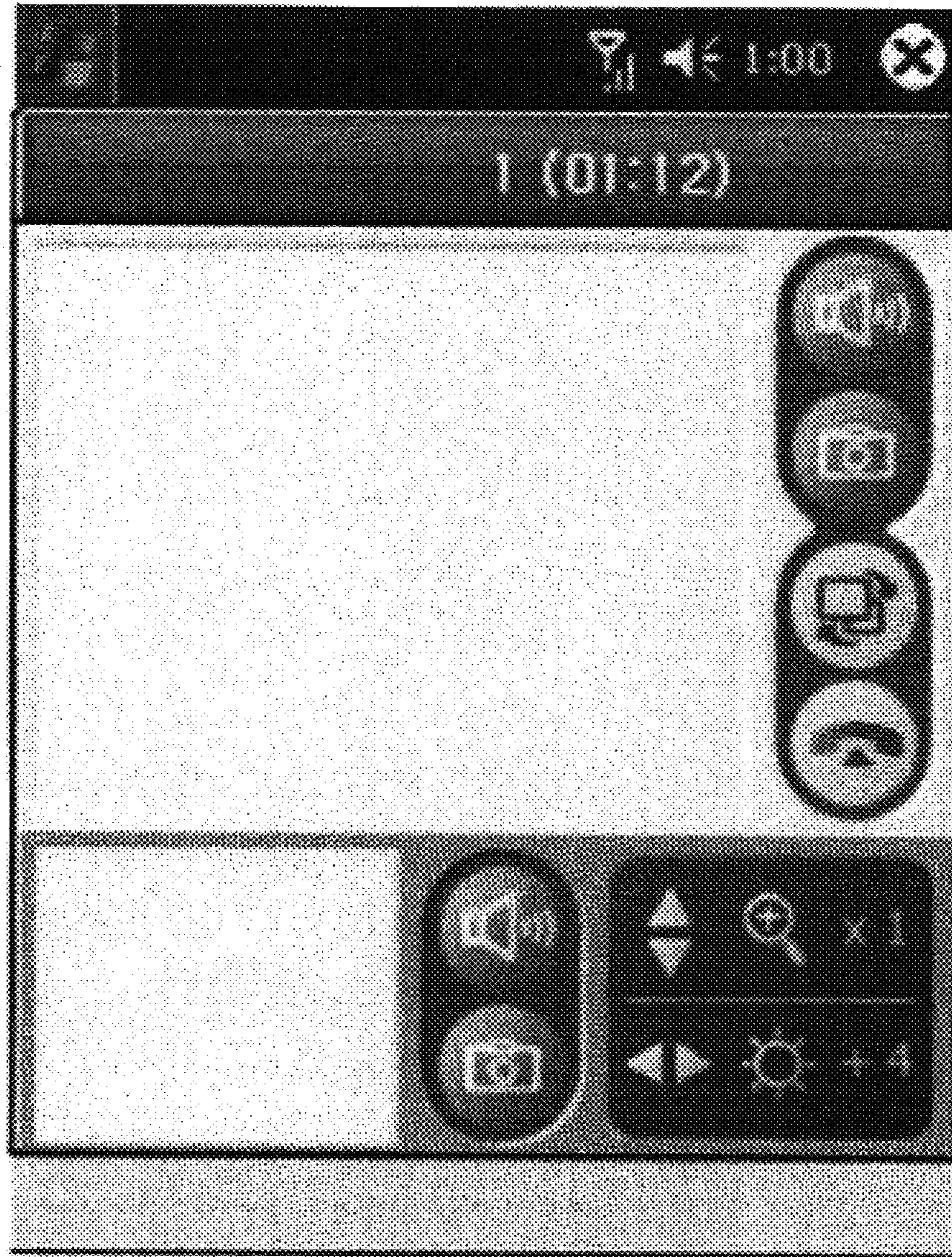
