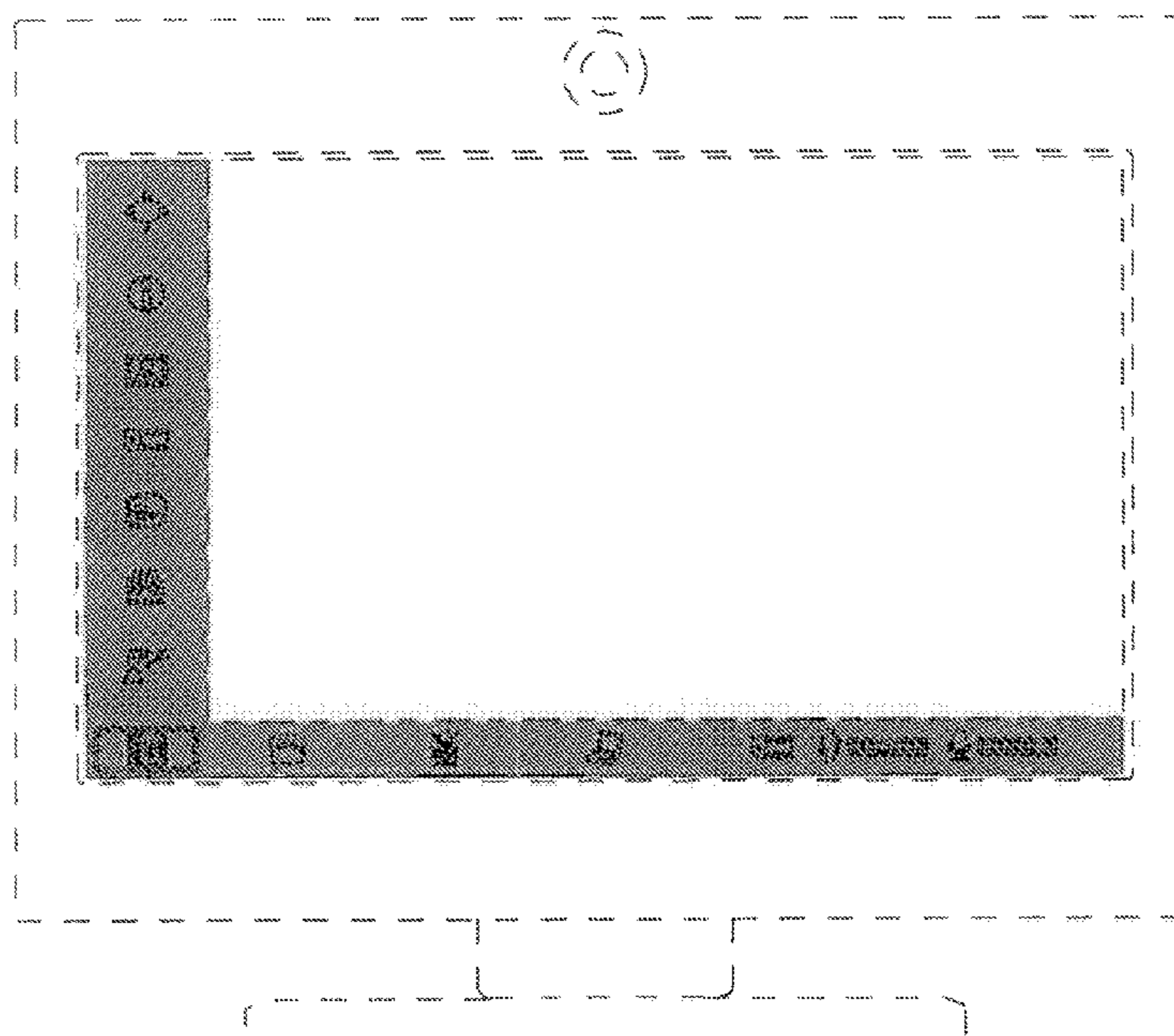
The ornamental design for an image for display panel or screen, as shown and described.

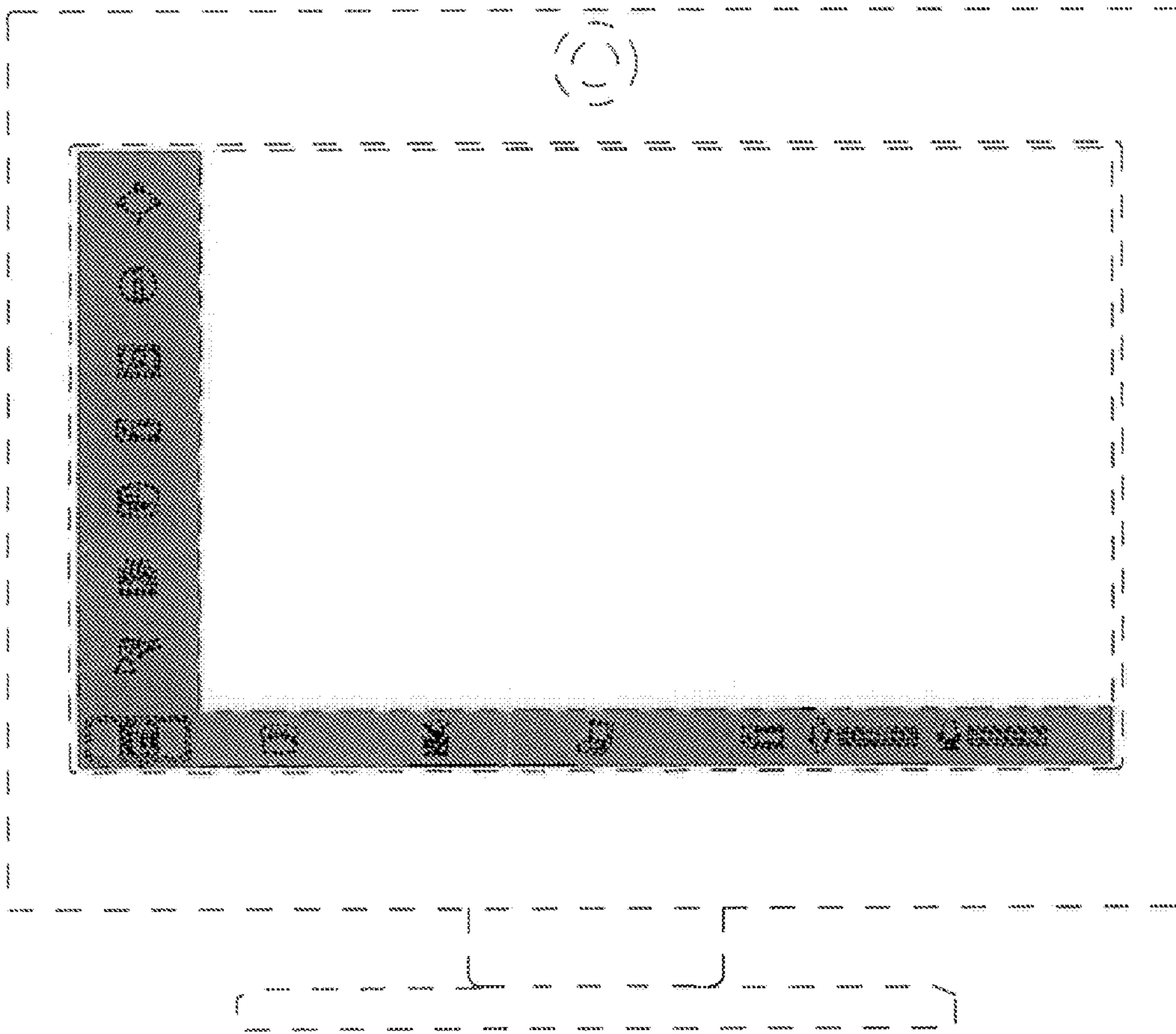
DESCRIPTION
