DESCRIPTION

- FIG. 1 is a lower front left perspective view of a mechanical pencil showing my new design;
- FIG. 2 is a left side elevation view thereof;

- FIG. 4 is a front elevation view thereof;
- FIG. 5 is a right side elevation view thereof;
- FIG. 6 is a bottom plan view thereof; and,

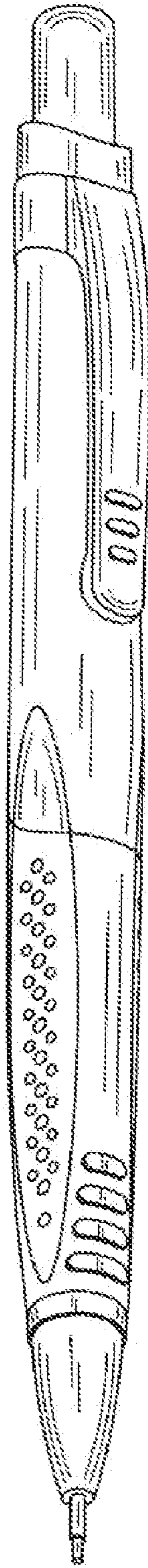

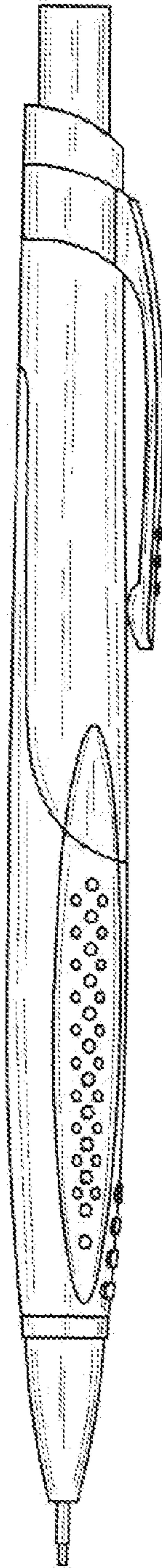

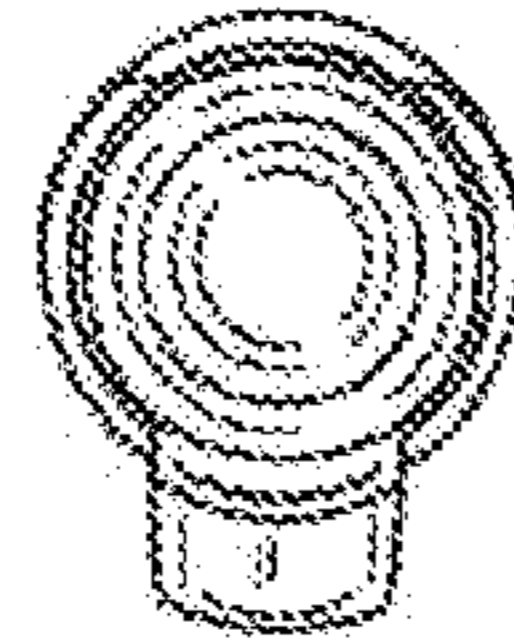

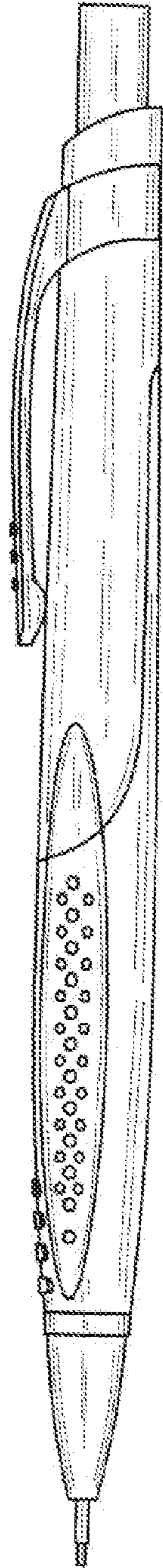

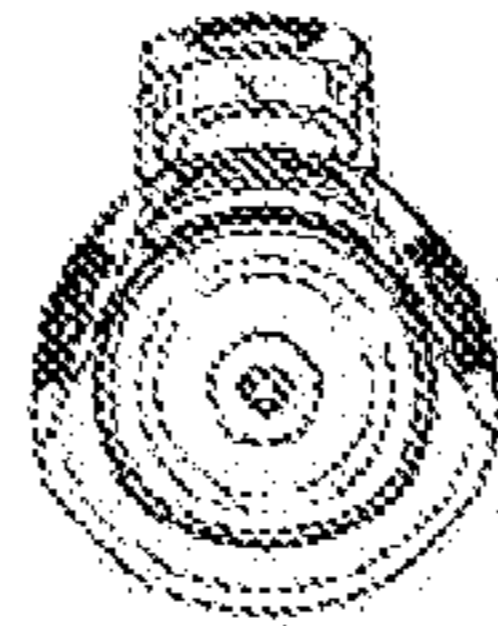
