(57) **CLAIM**

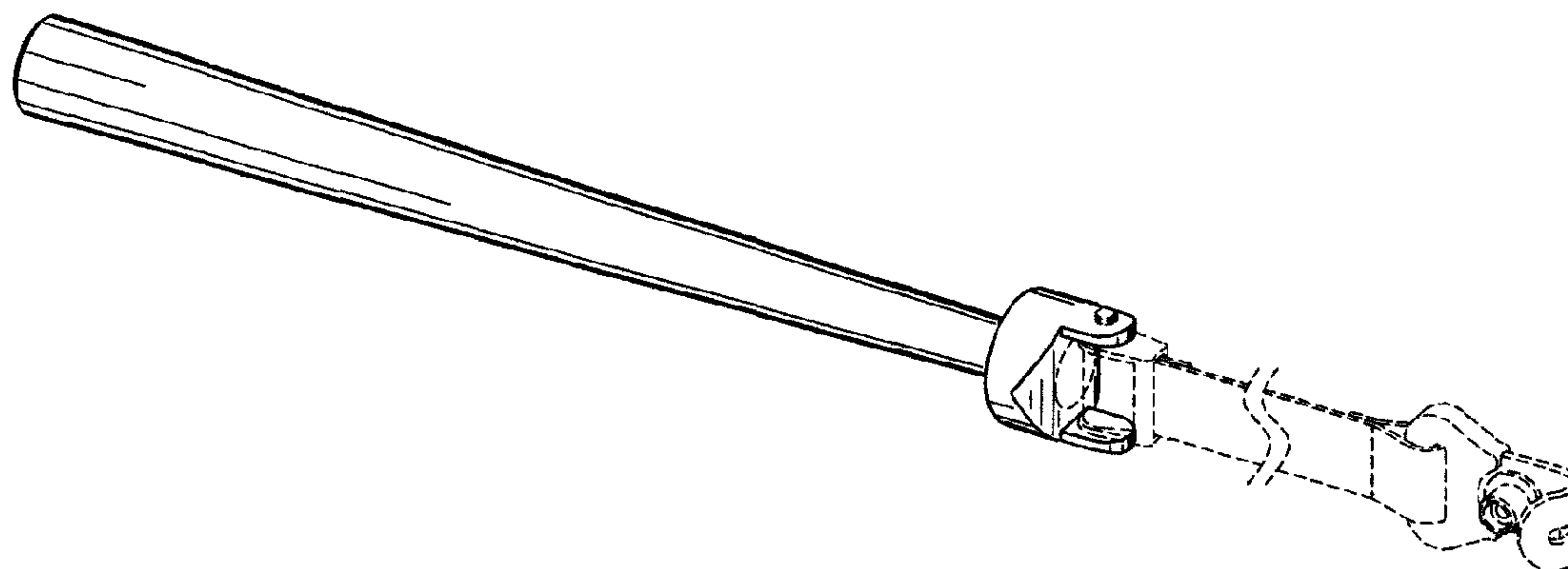
The ornamental design for a golf club style functional training handle for exercise machines, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf club style functional training handle for exercise machines showing my new design in a representative operating environment.
FIG. 2 is a front isometric view showing my new design in isolation;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a back elevational view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a right side elevation view thereof.

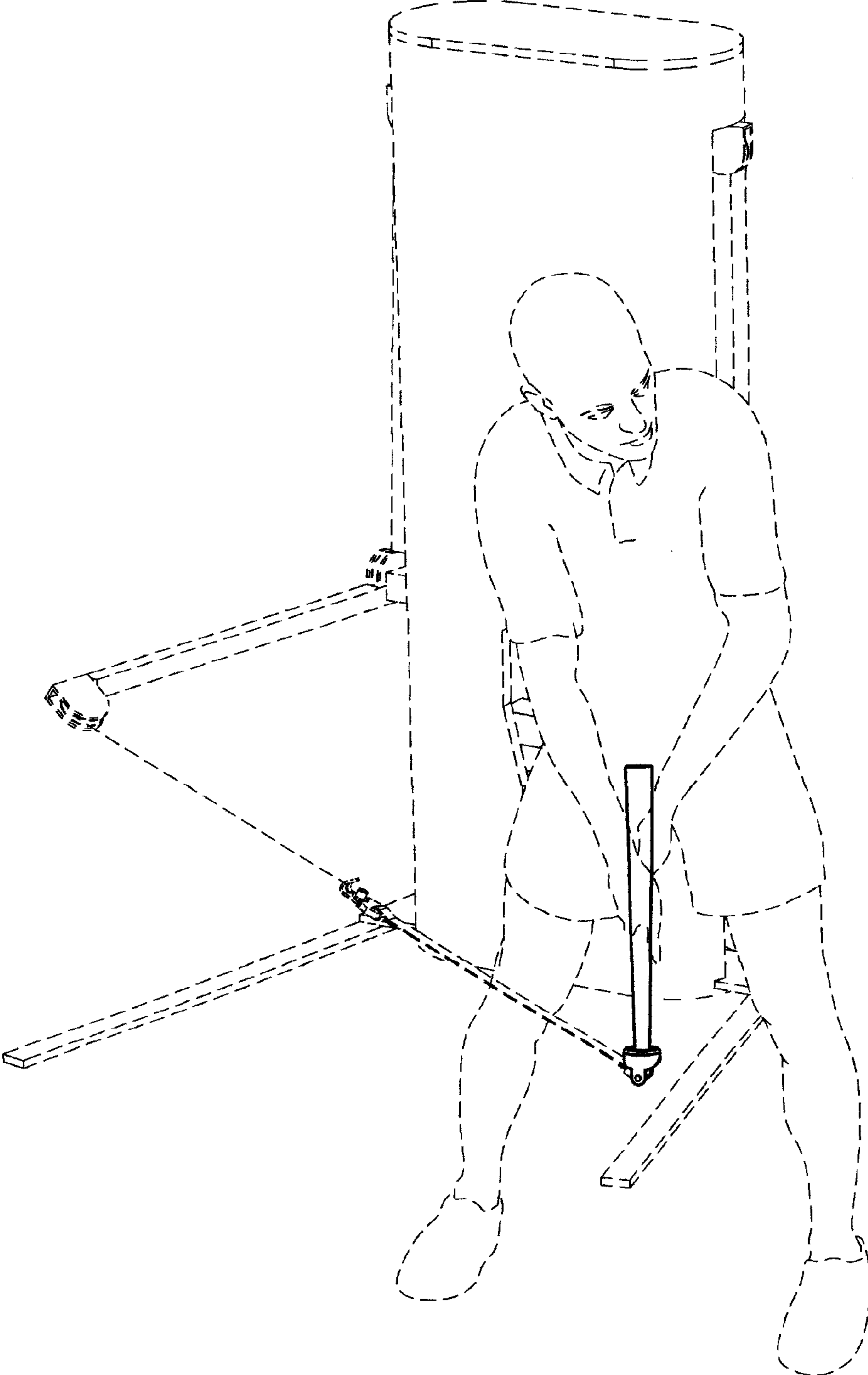

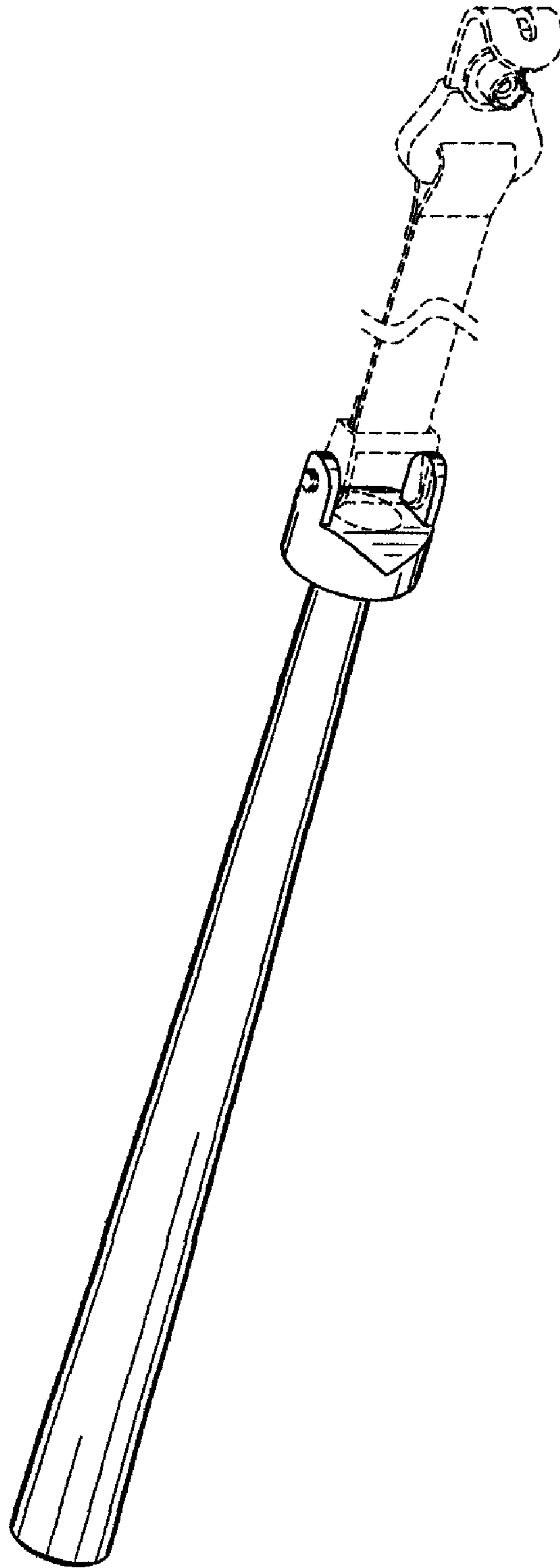

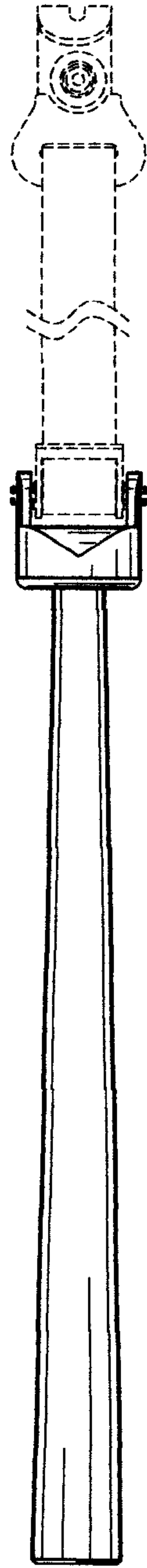

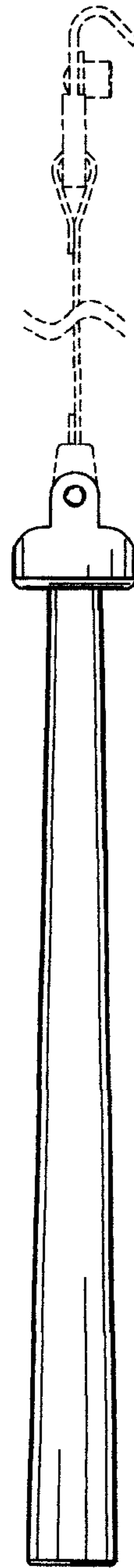

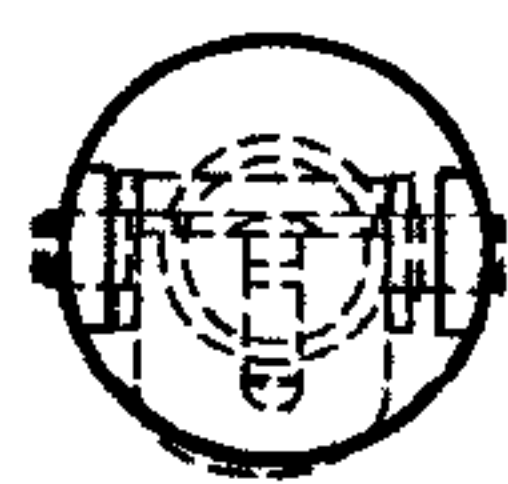

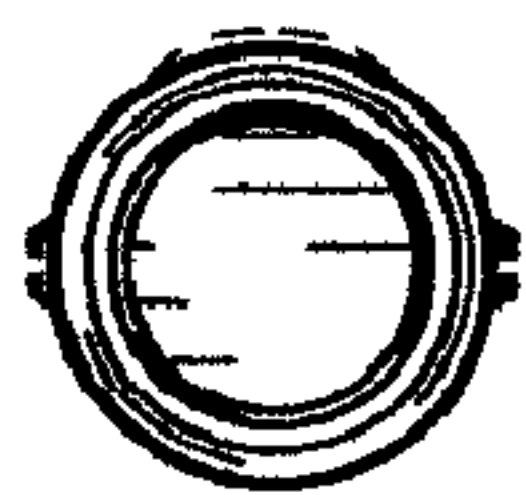

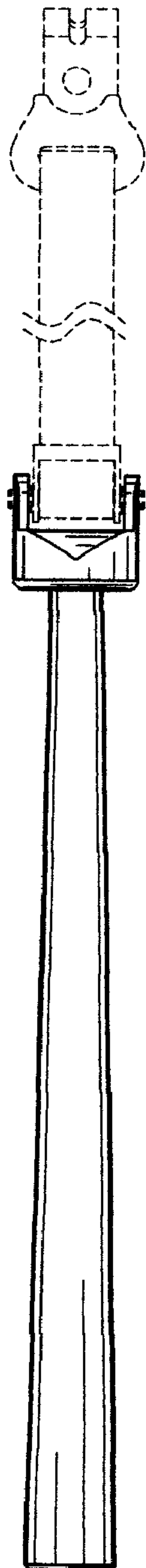

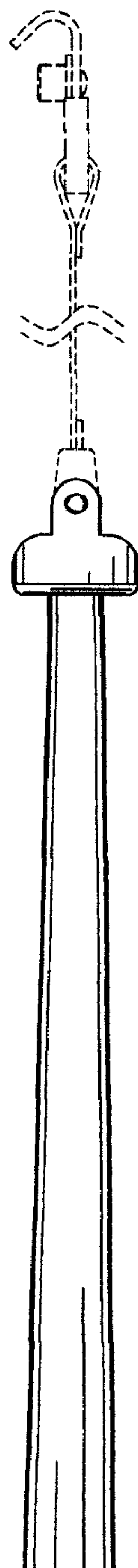
