thereof.

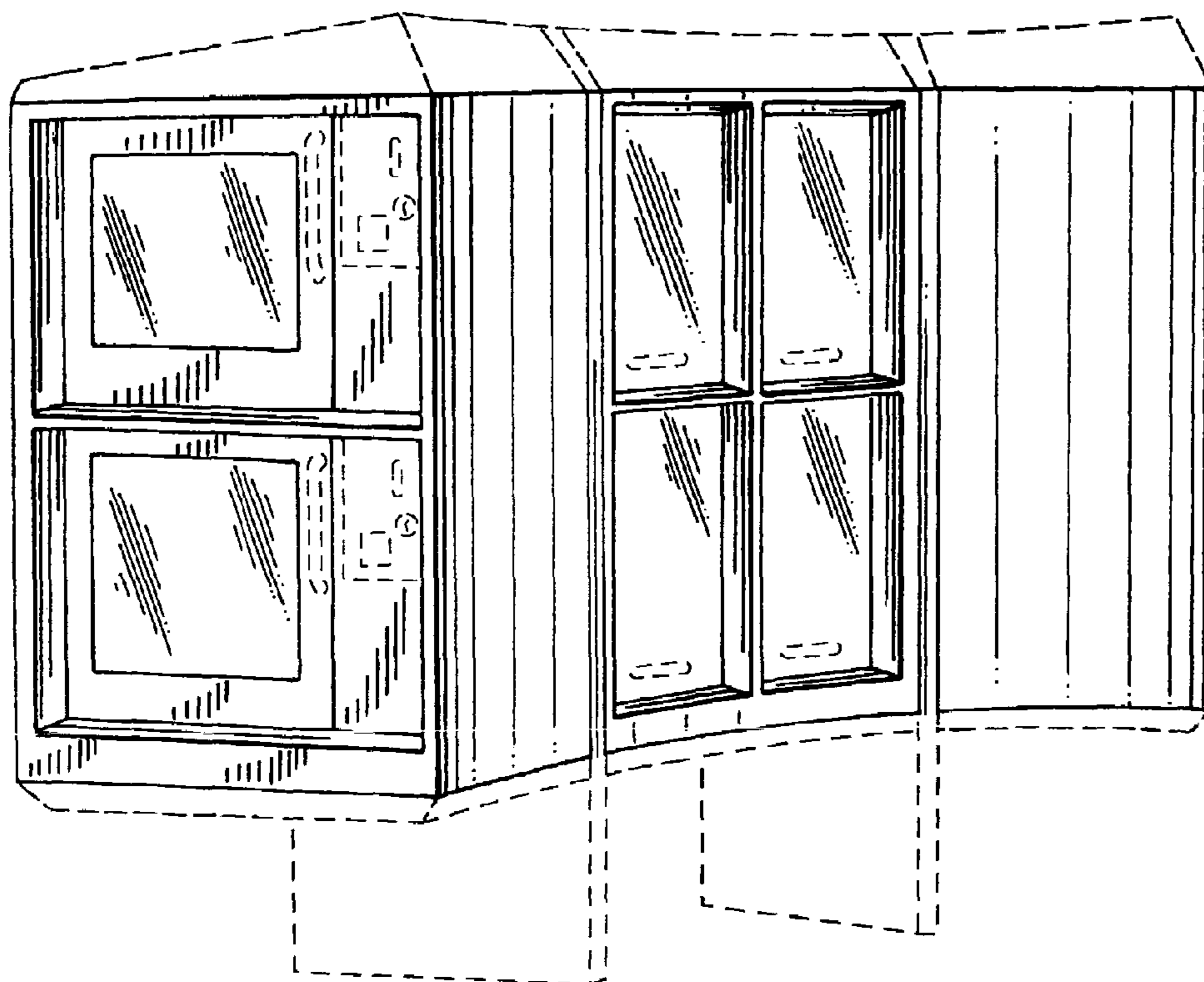
The broken line showing of the roof, base, legs, and panel

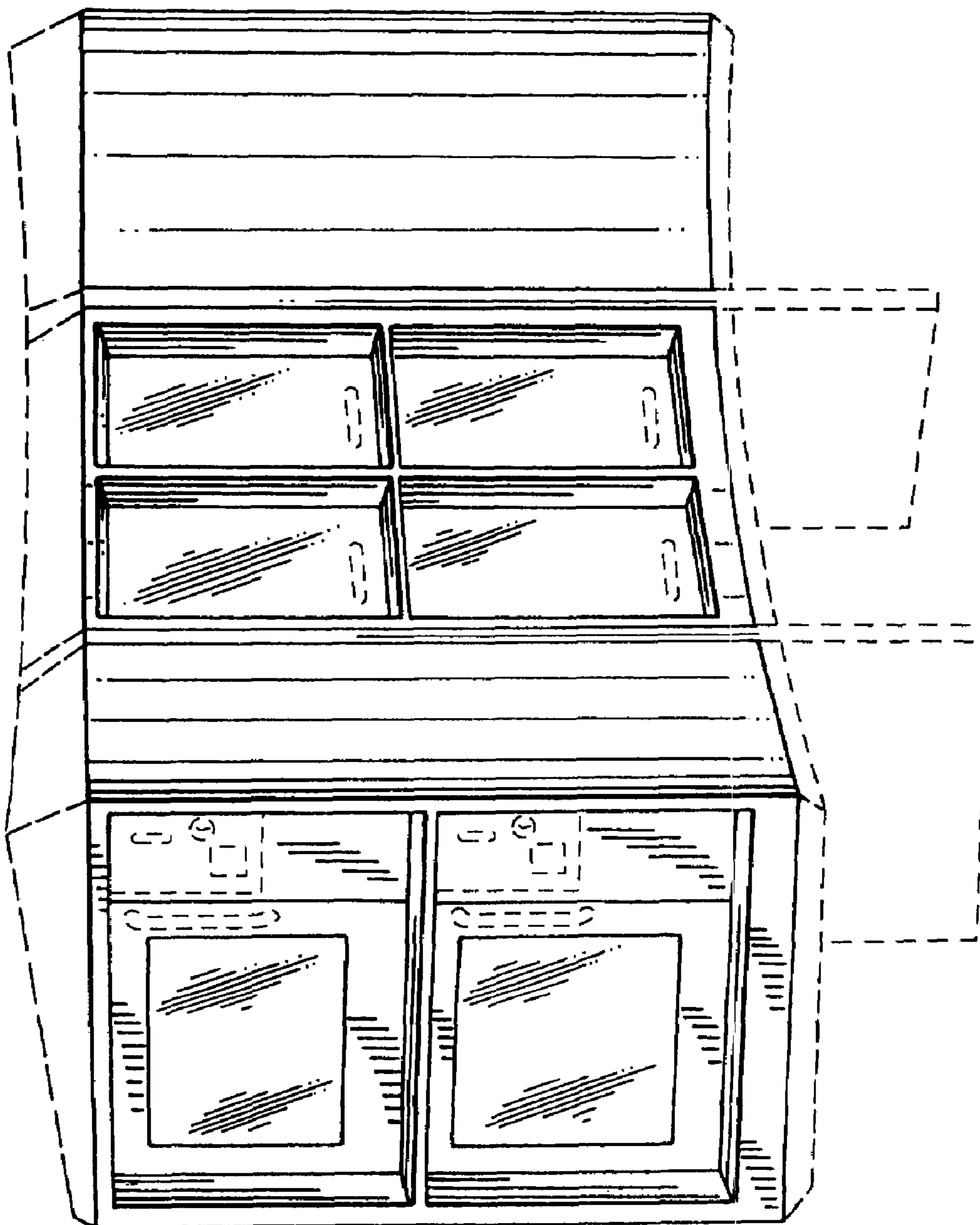

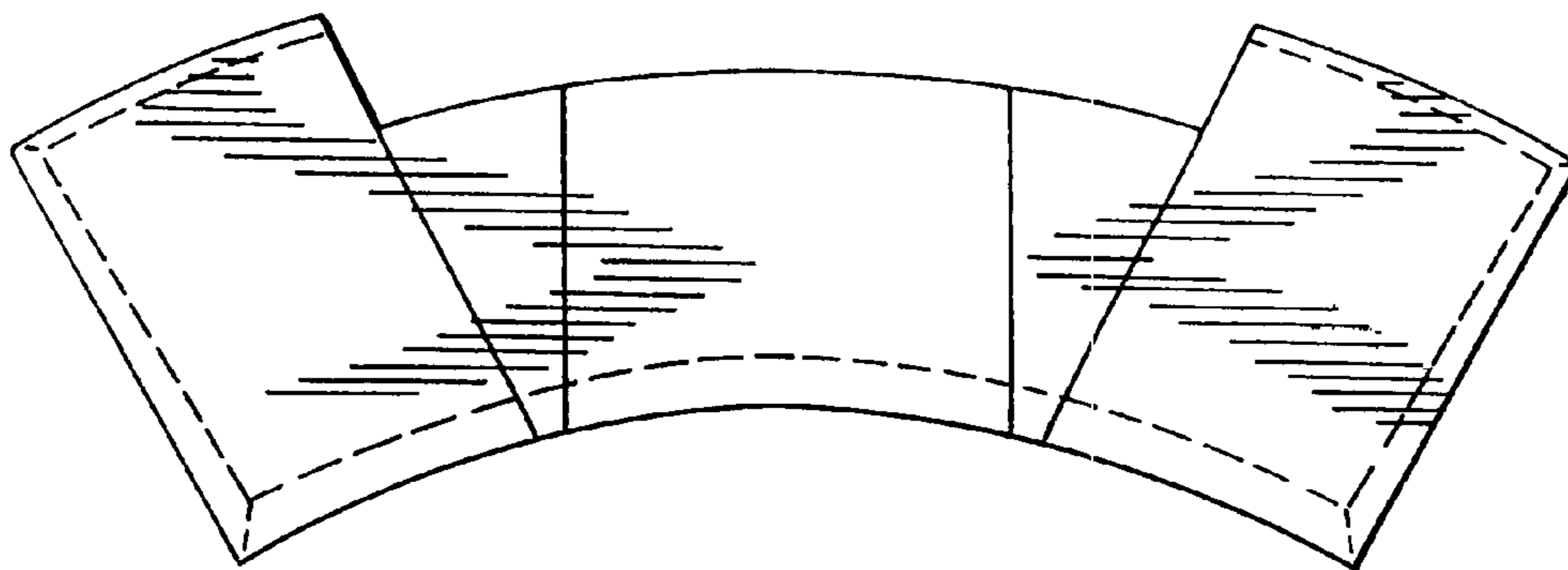

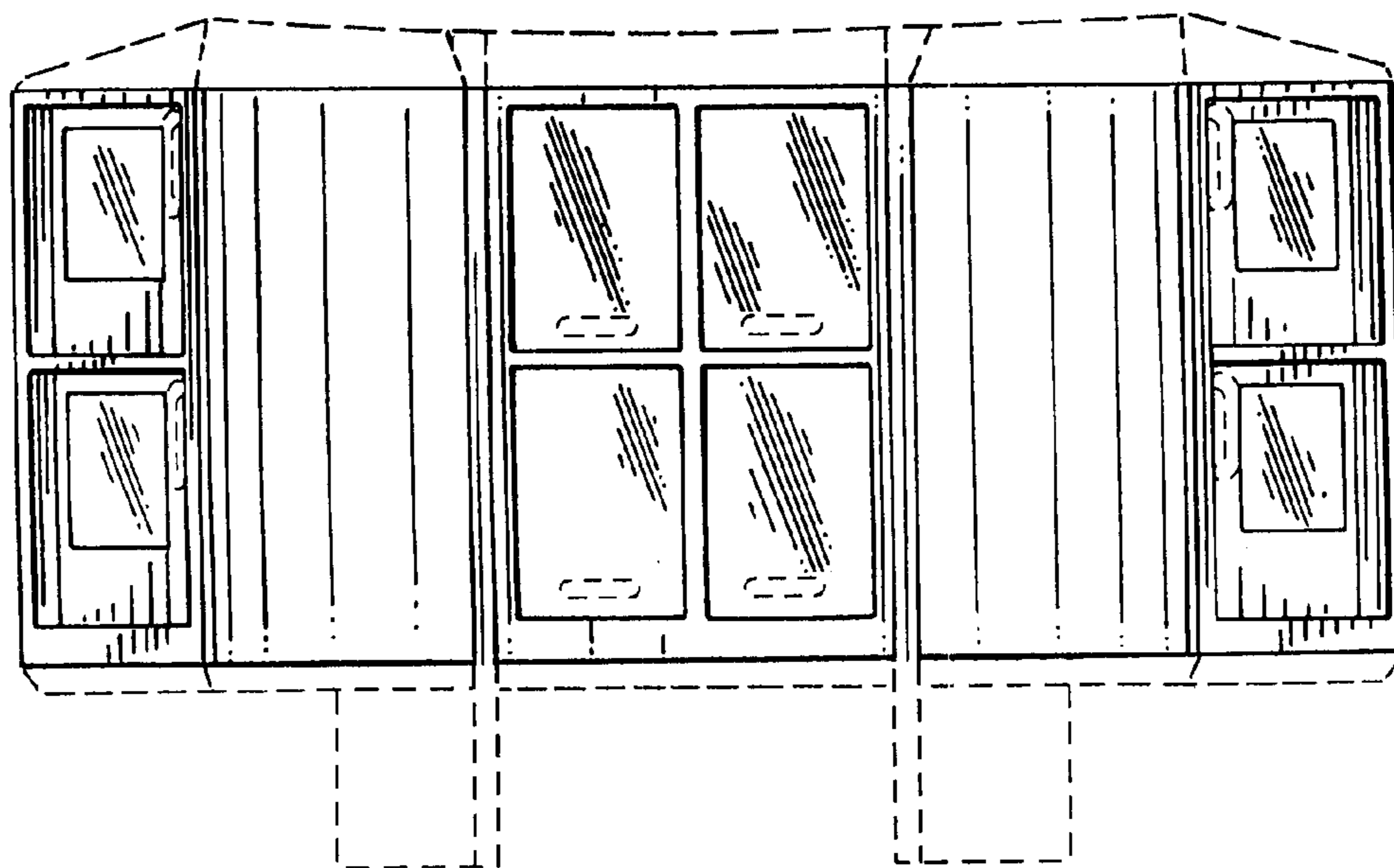

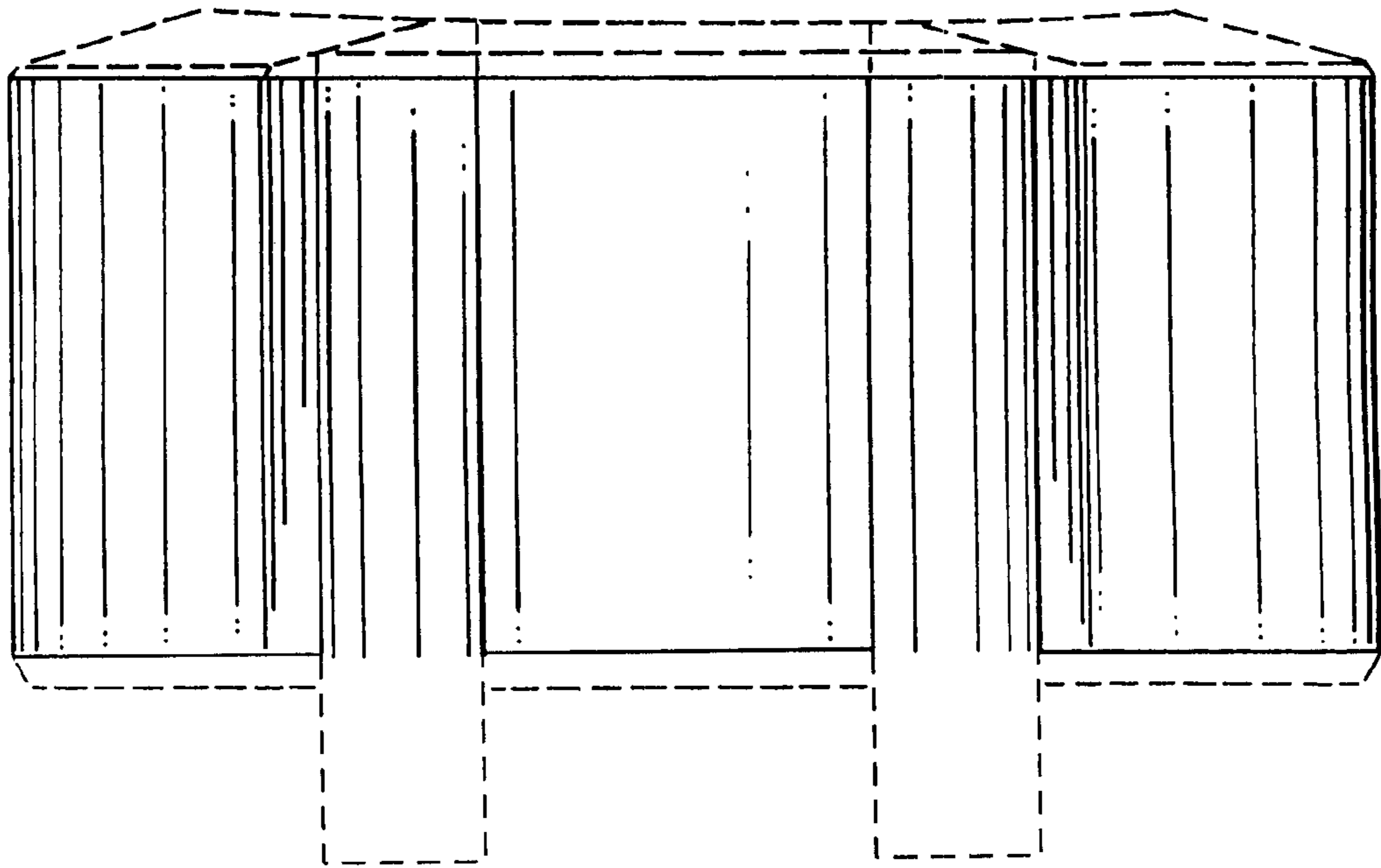

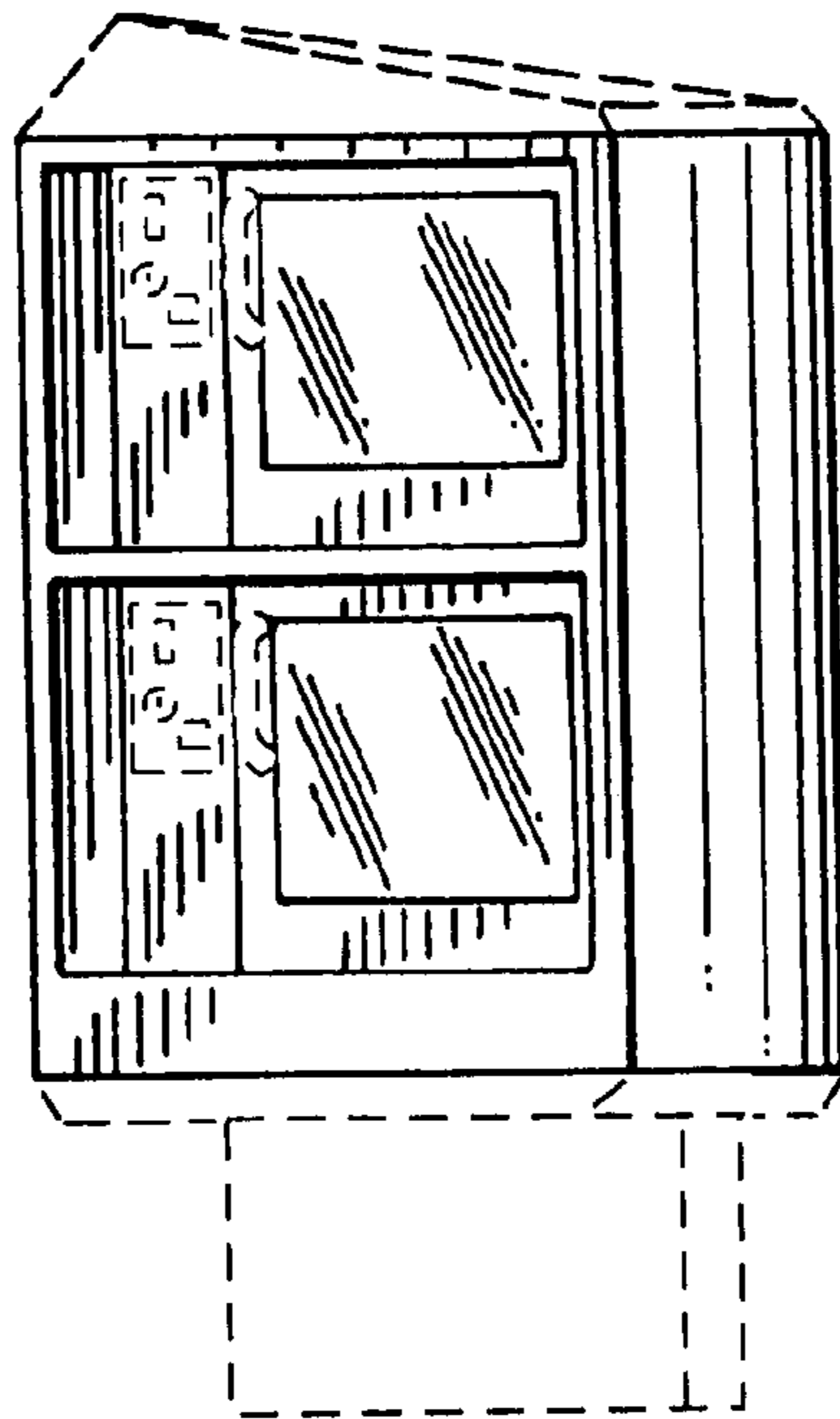
