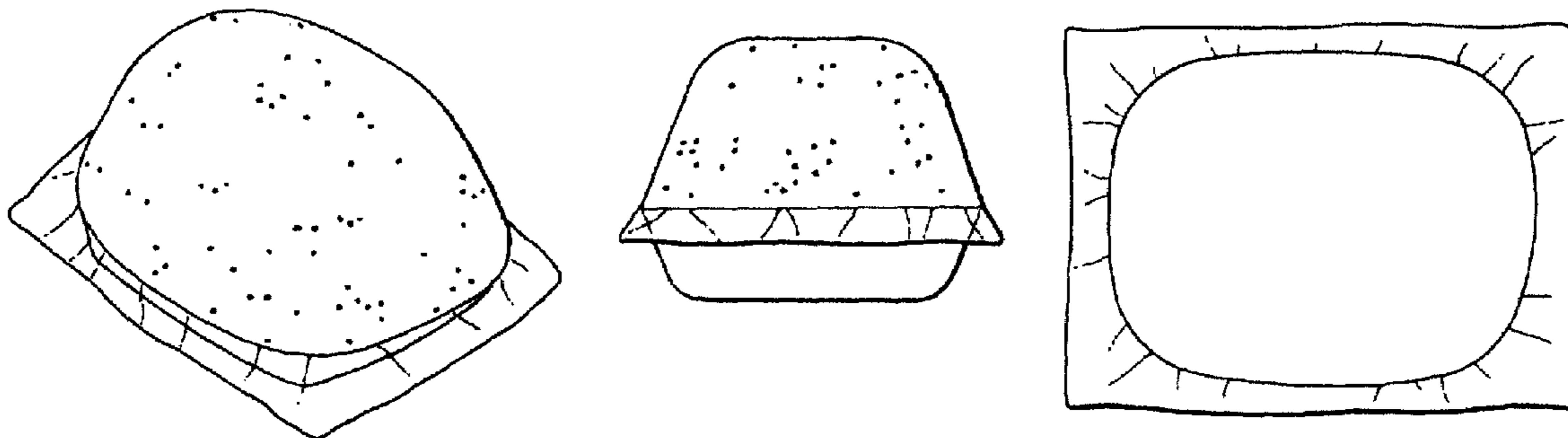
FIG. 5 is a perspective view taken from the top of an alternative embodiment of a capsule;

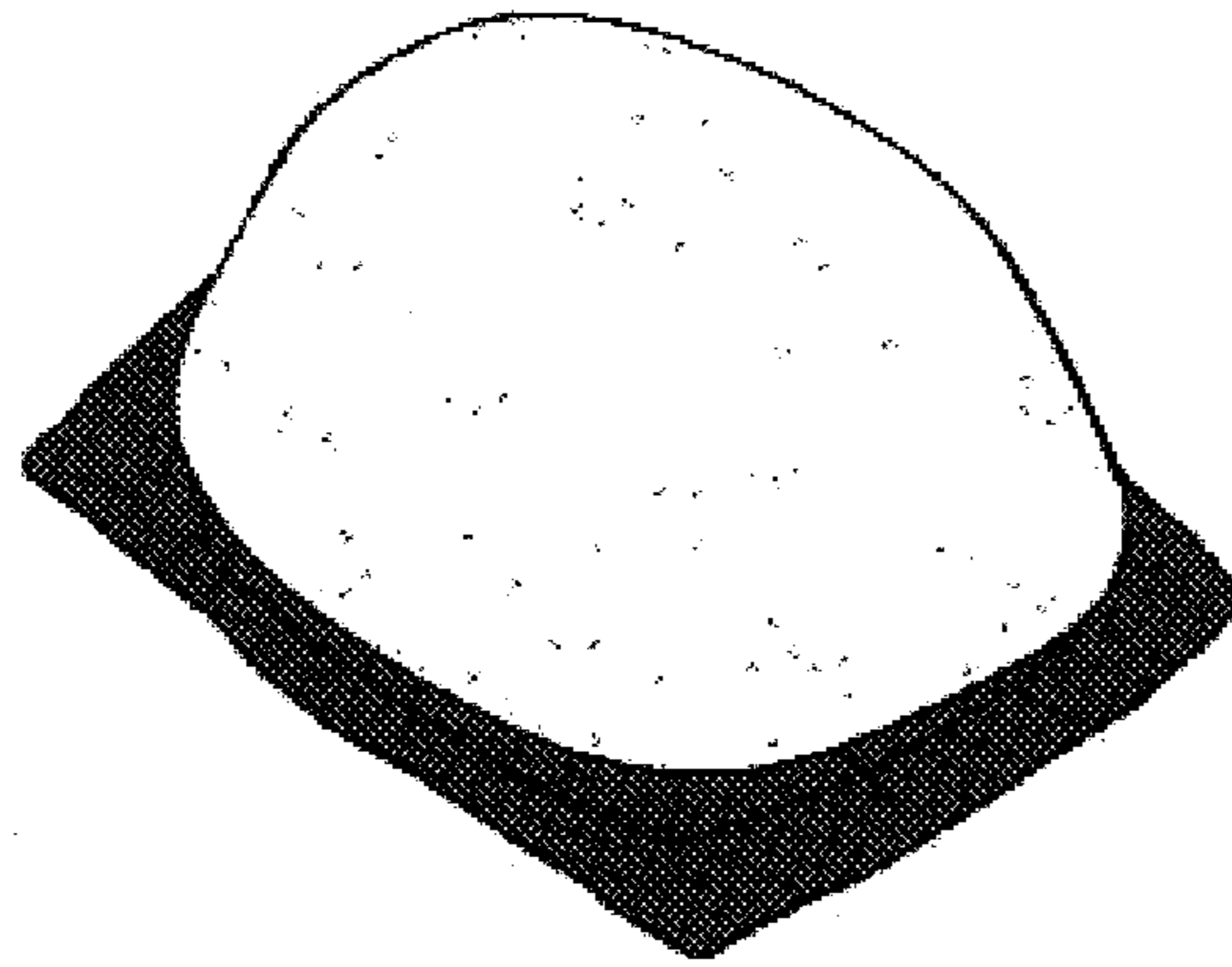

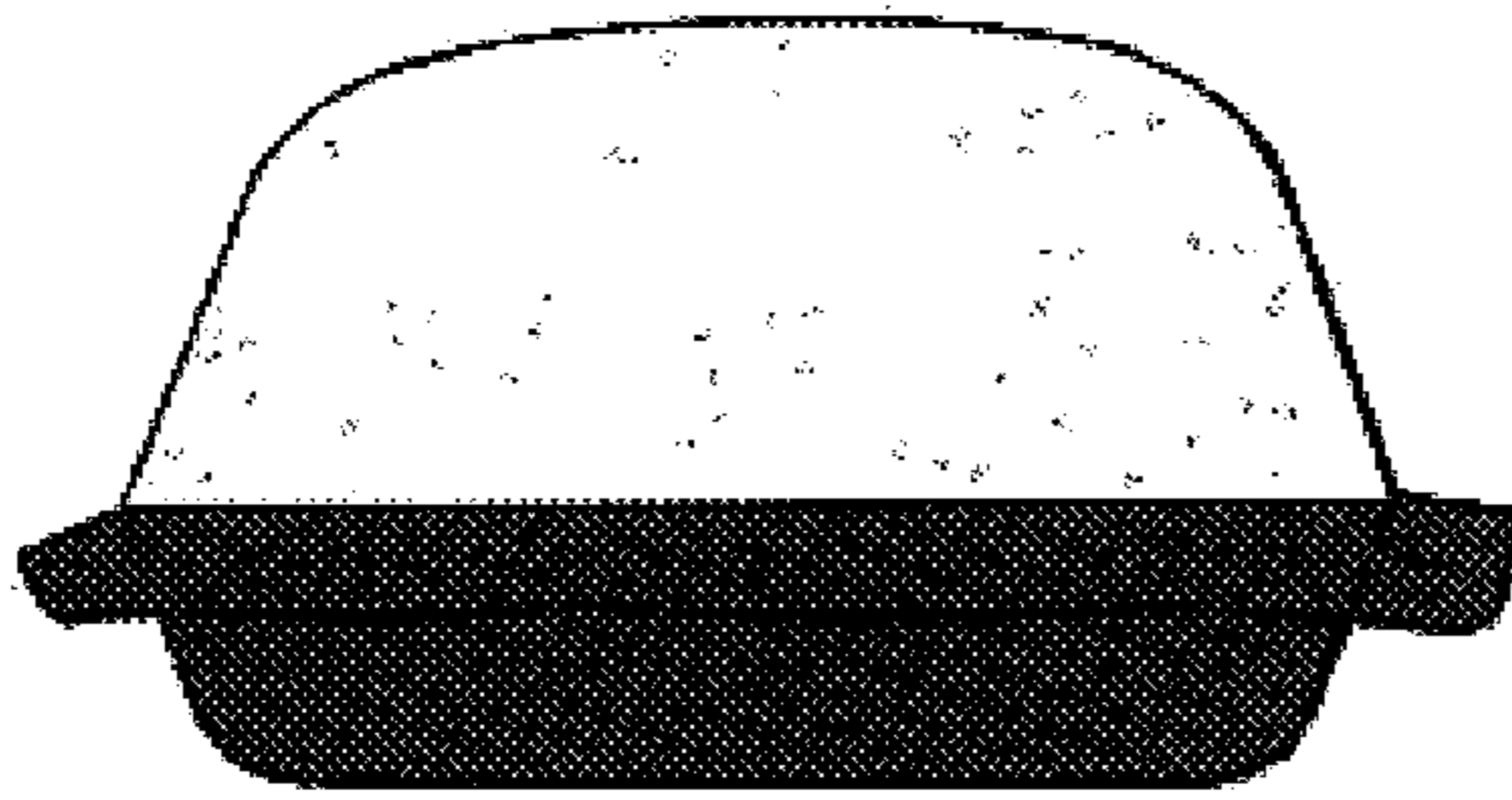

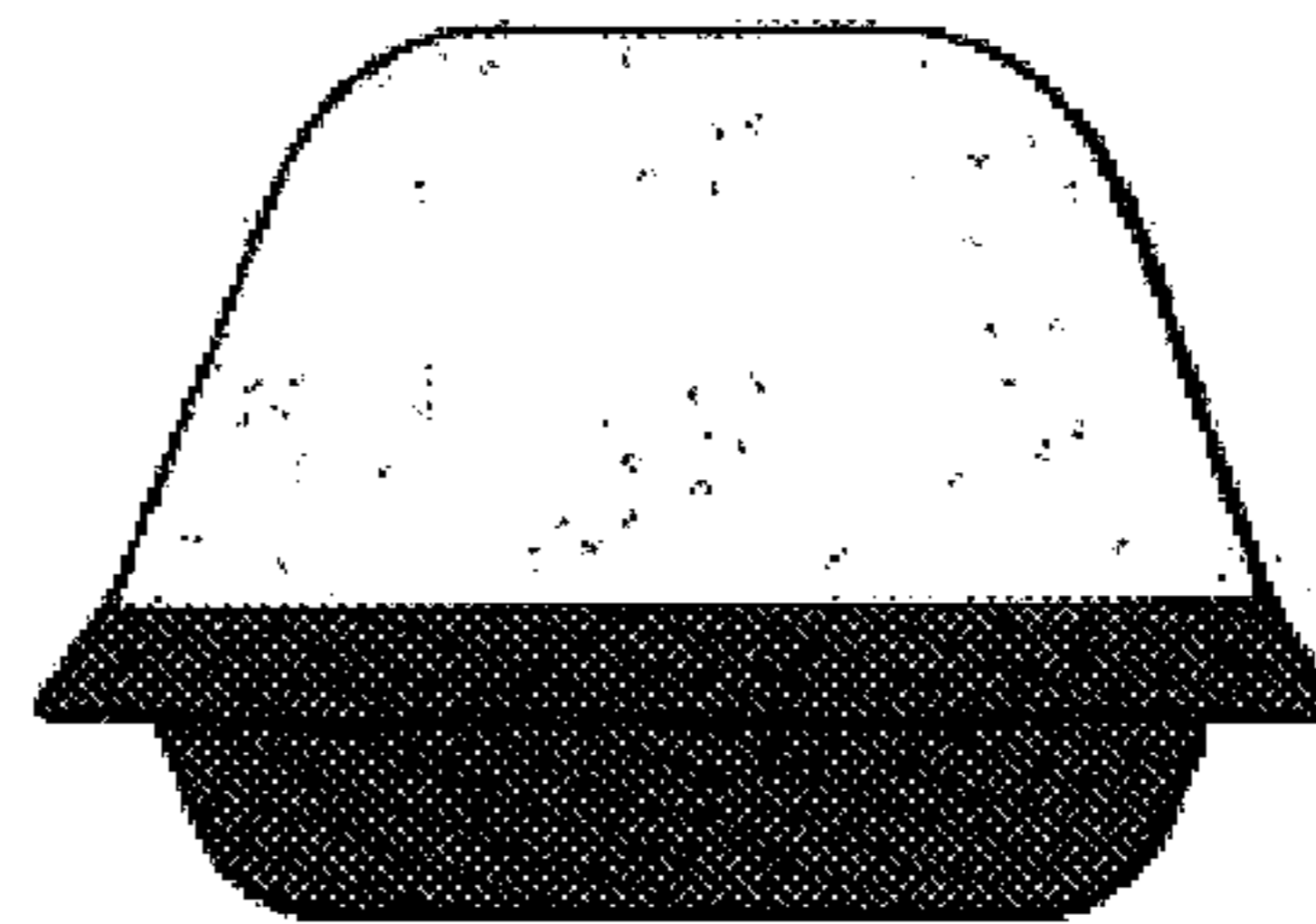

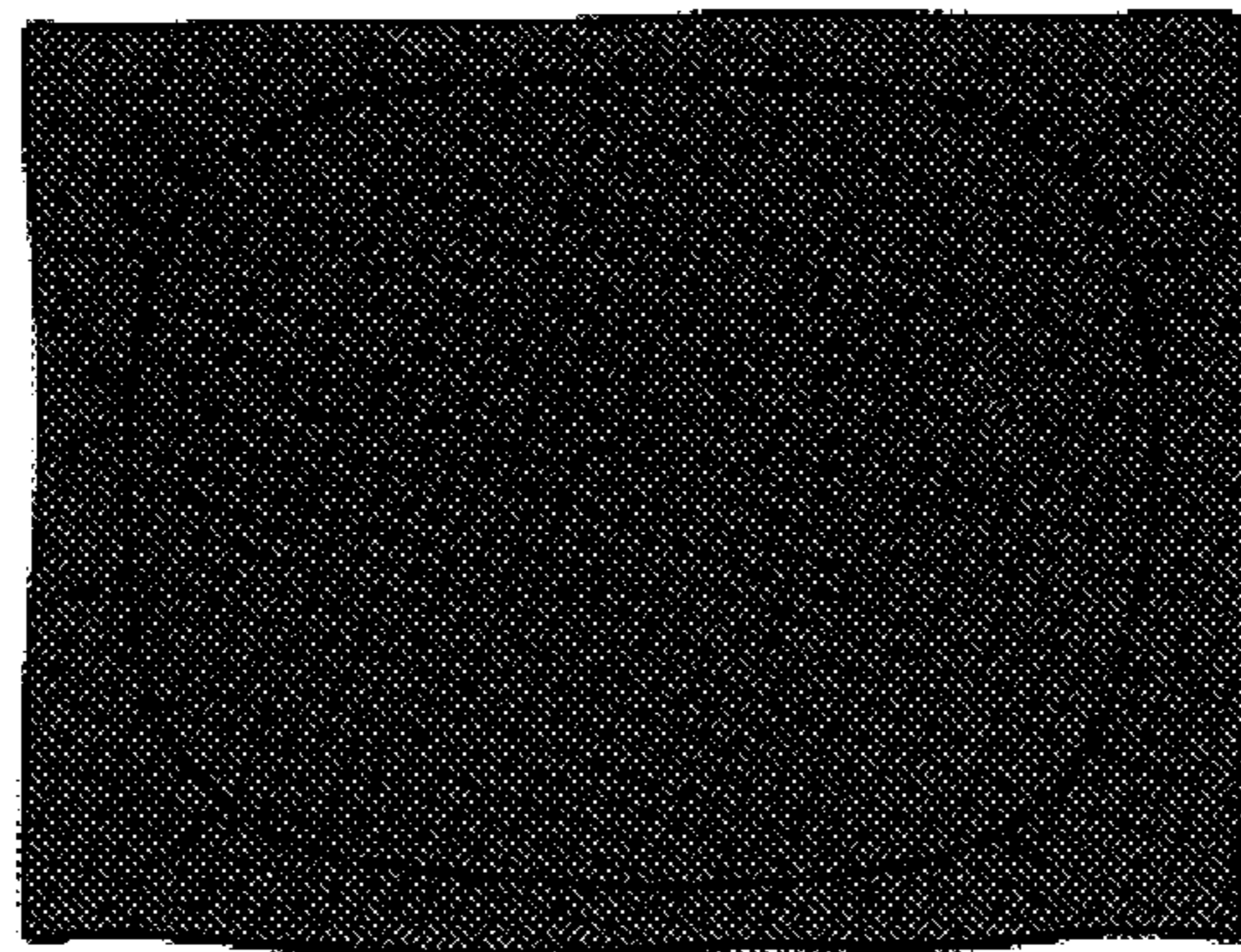

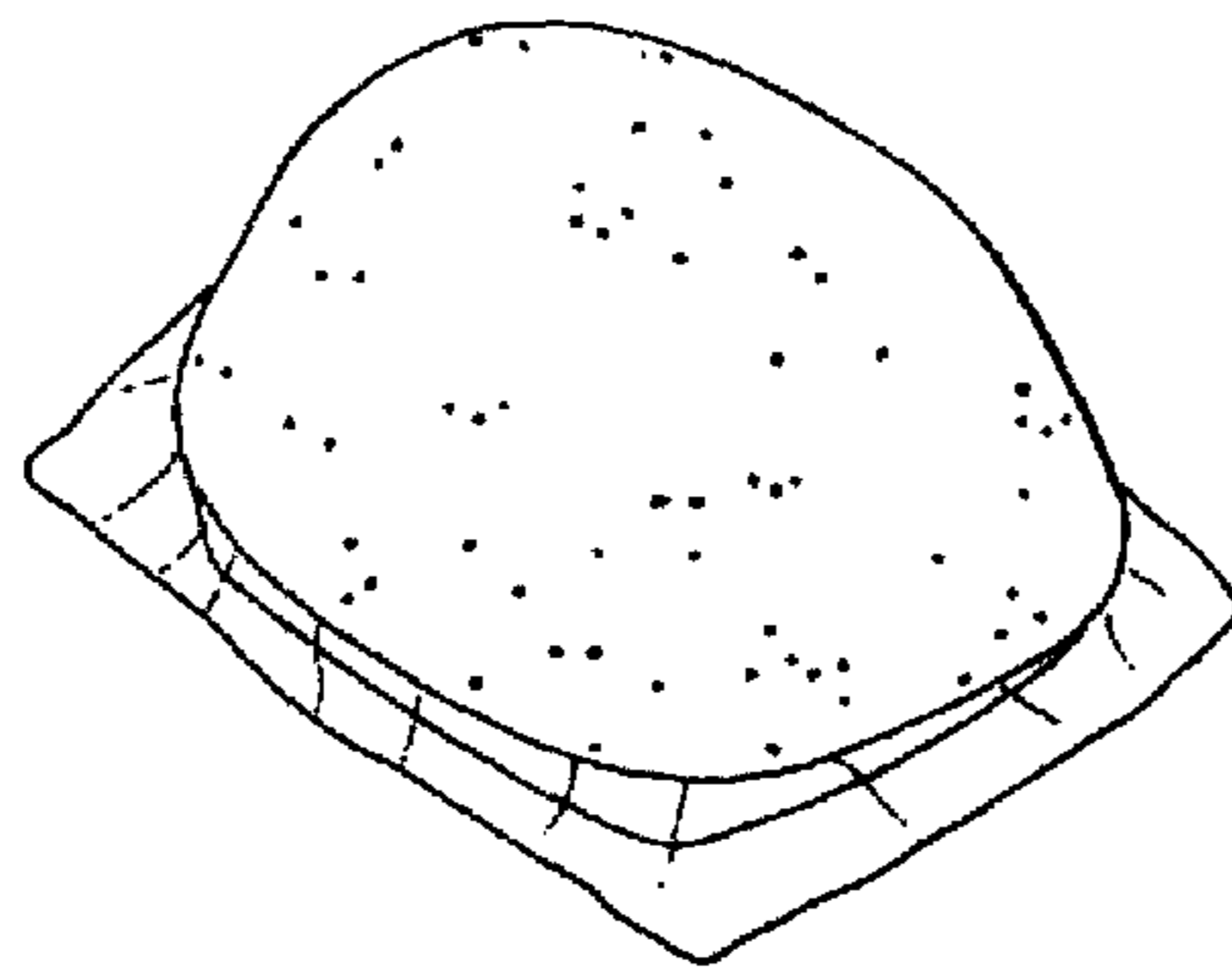

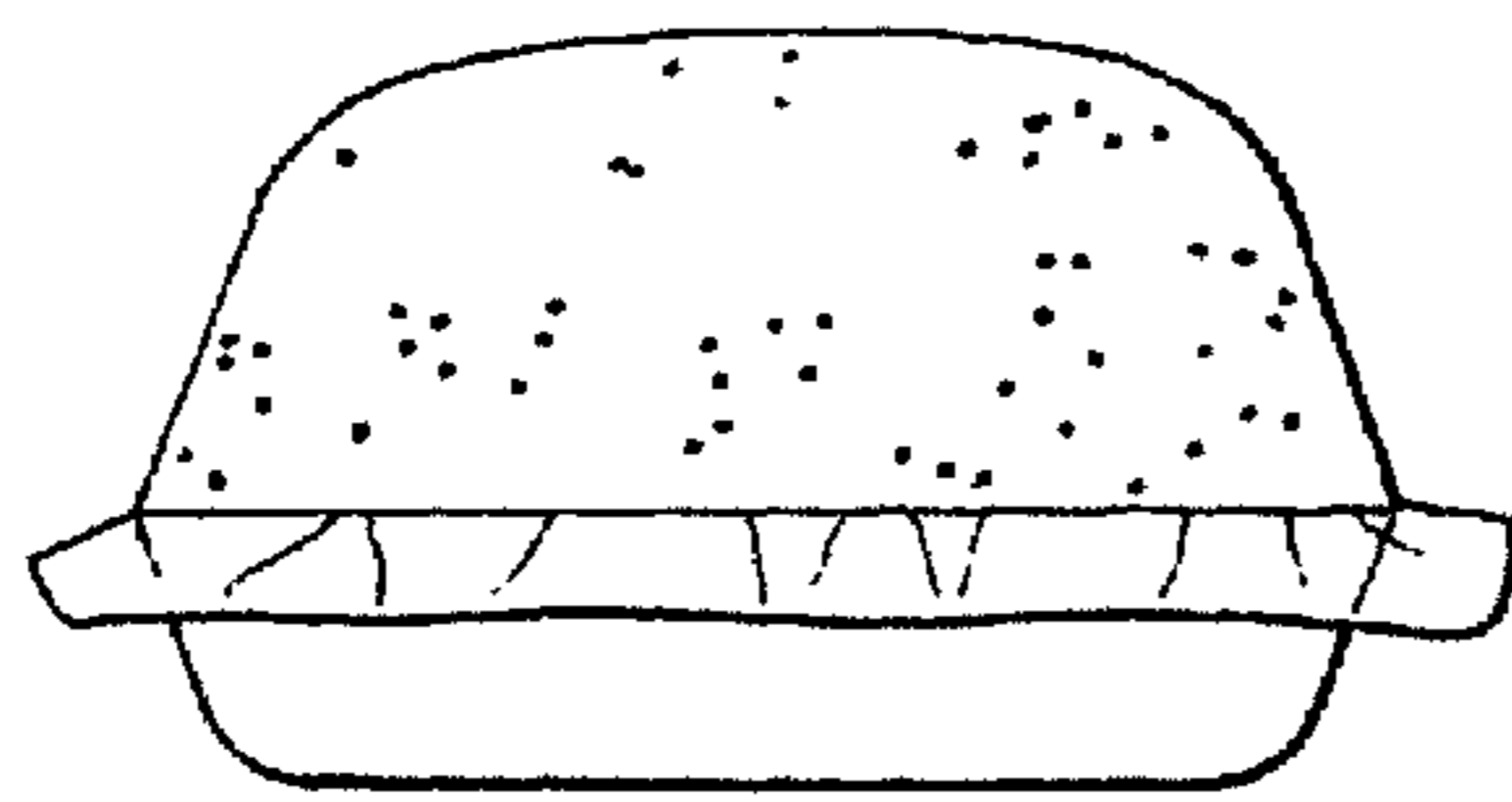

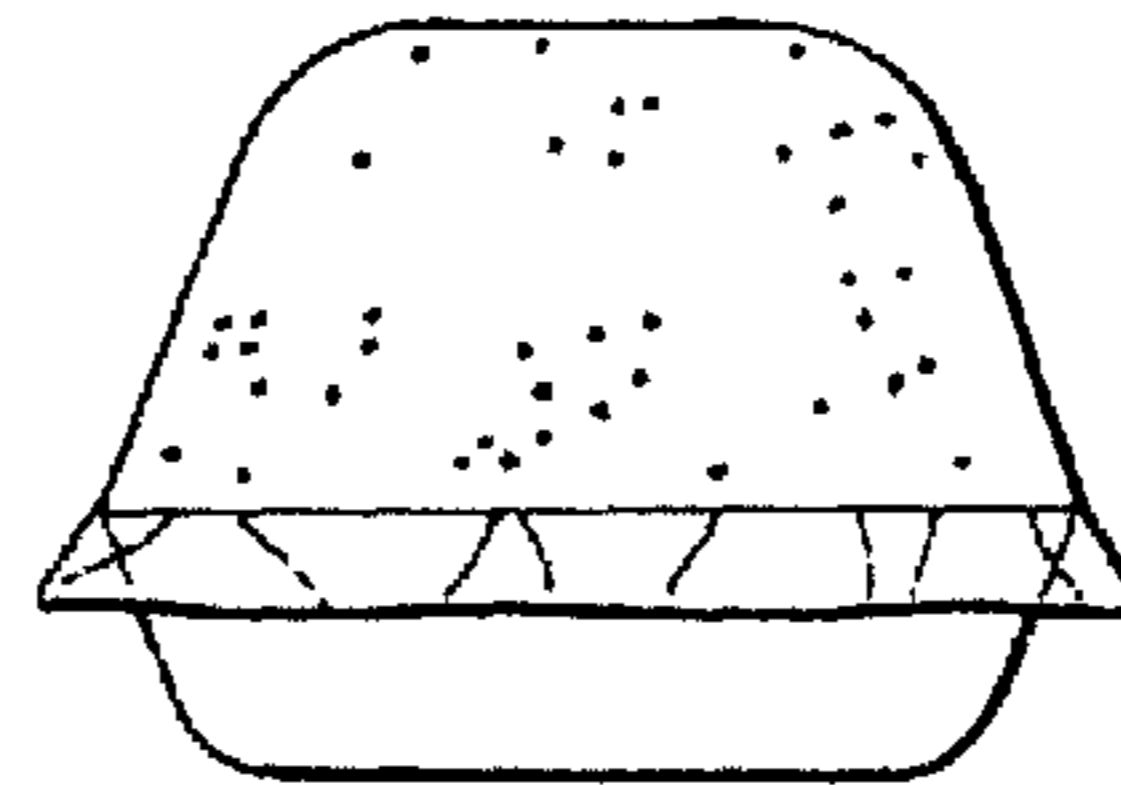

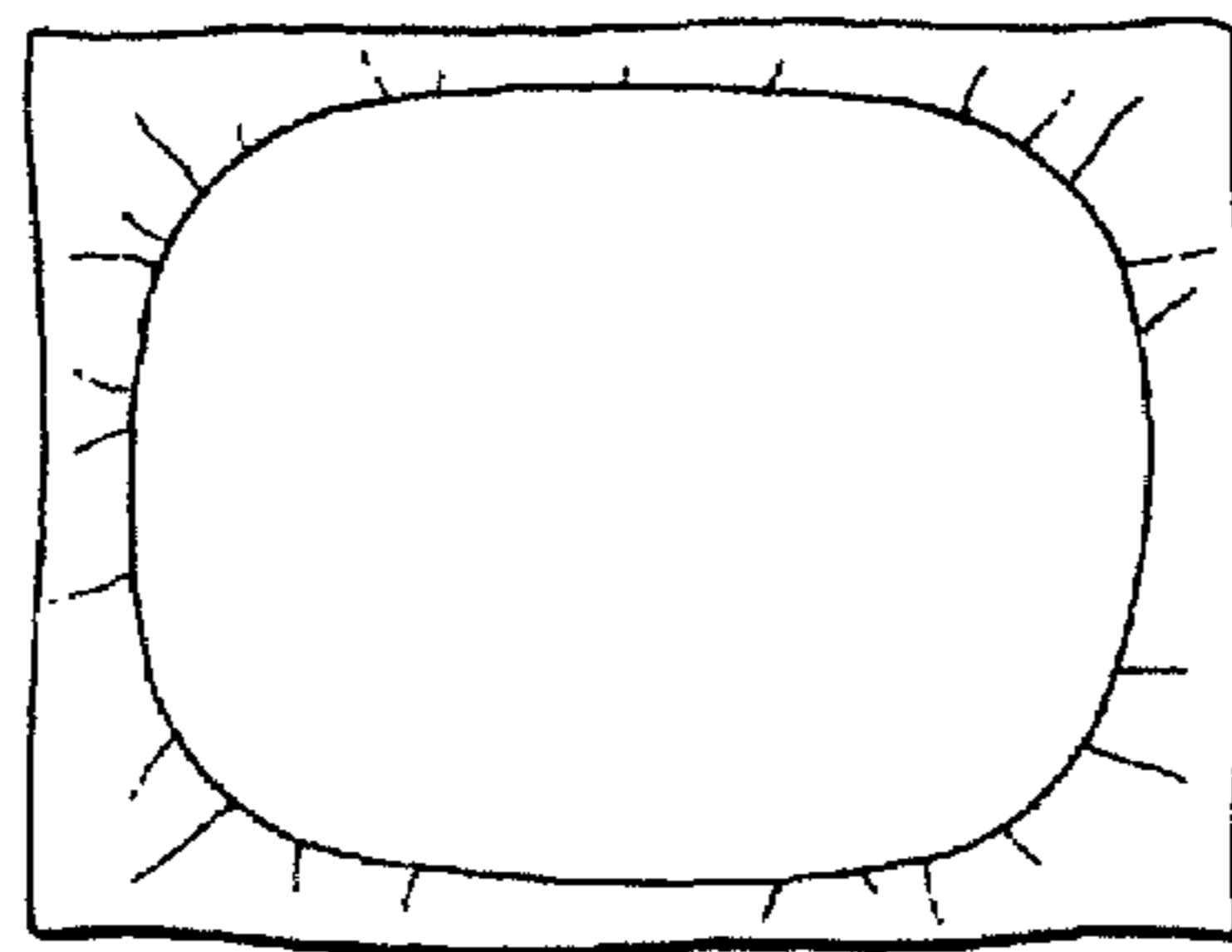
