(57) **CLAIM**

The ornamental design for a dress dog collar, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dress dog collar shown in position around a dog's neck, with the neck strap portion folded downward;

FIG. 2 is a right side elevational view of the dress dog collar in an unfolded, flat configuration;

FIG. 3 is a bottom plan view of the dress collar shown in FIG. 2;

FIG. 4 is a top plan view of the dress collar shown in FIG. 2;

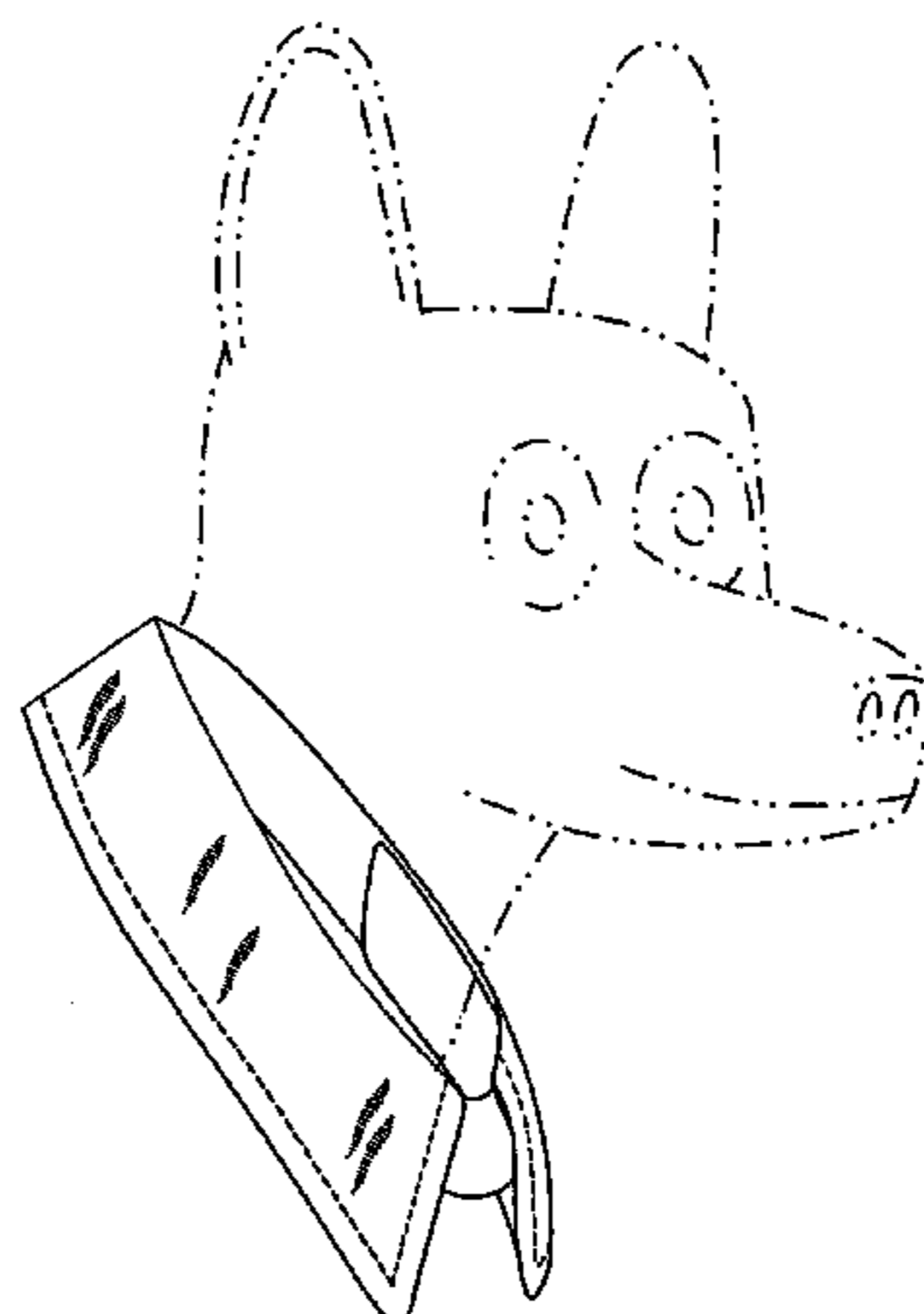
FIG. 5 is a front elevational view of the dress collar shown in FIG. 2;

FIG. 6 is a rear elevational view of the dress collar shown in FIG. 2; and,

FIG. 7 is a left side elevational view of the dress dog collar in an unfolded, flat configuration.

The broken line showing of a dog's head in FIG. 1 is for illustrative purposes only and forms no part of the claimed design. The dashed lines on the dress dog collar represent stitching and form part of the claimed design.

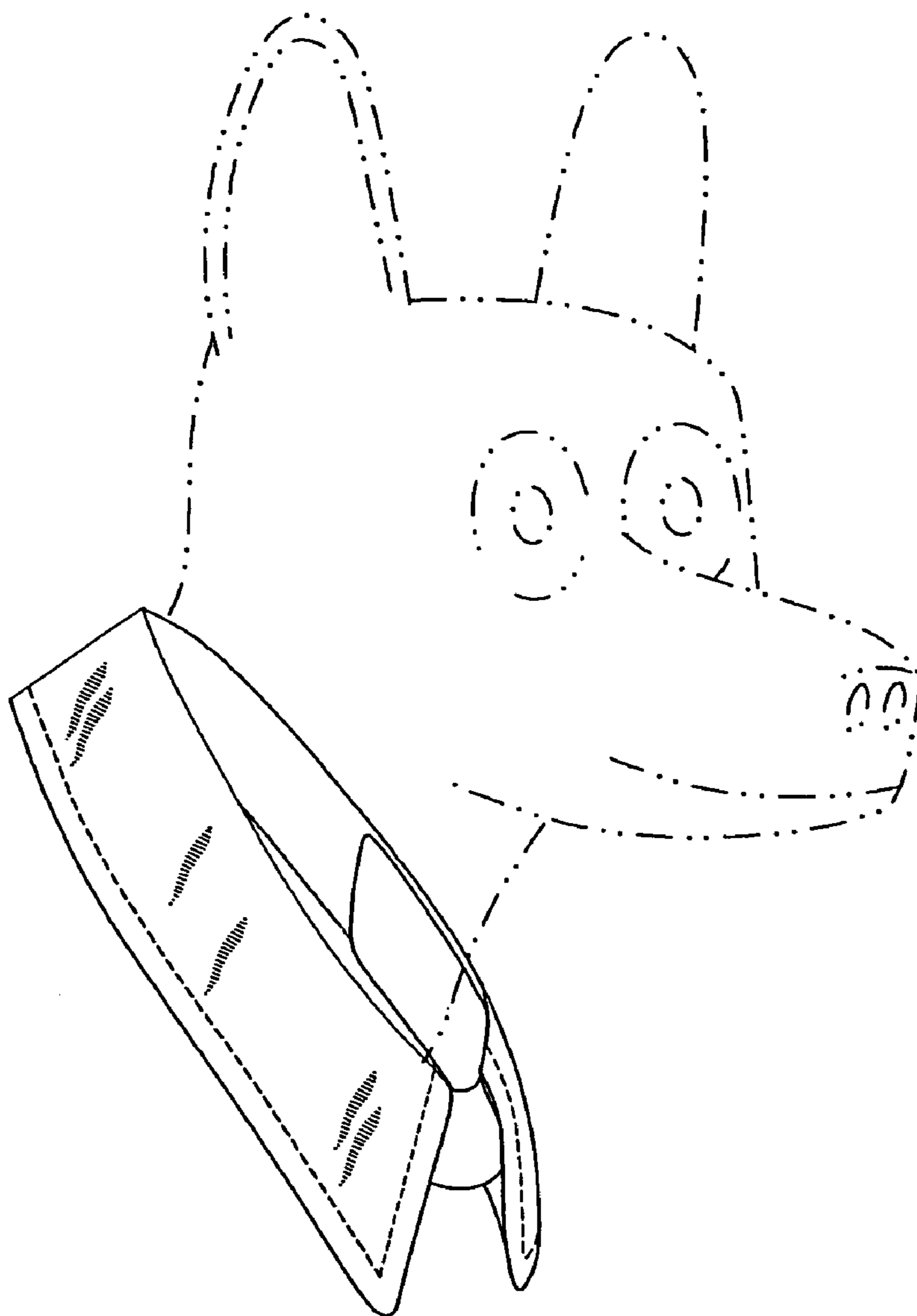
