DESCRIPTION

FIG. 1 is a top, right side, rear perspective view of a creeper showing our new design;

FIG. 2 is a top plan view thereof;

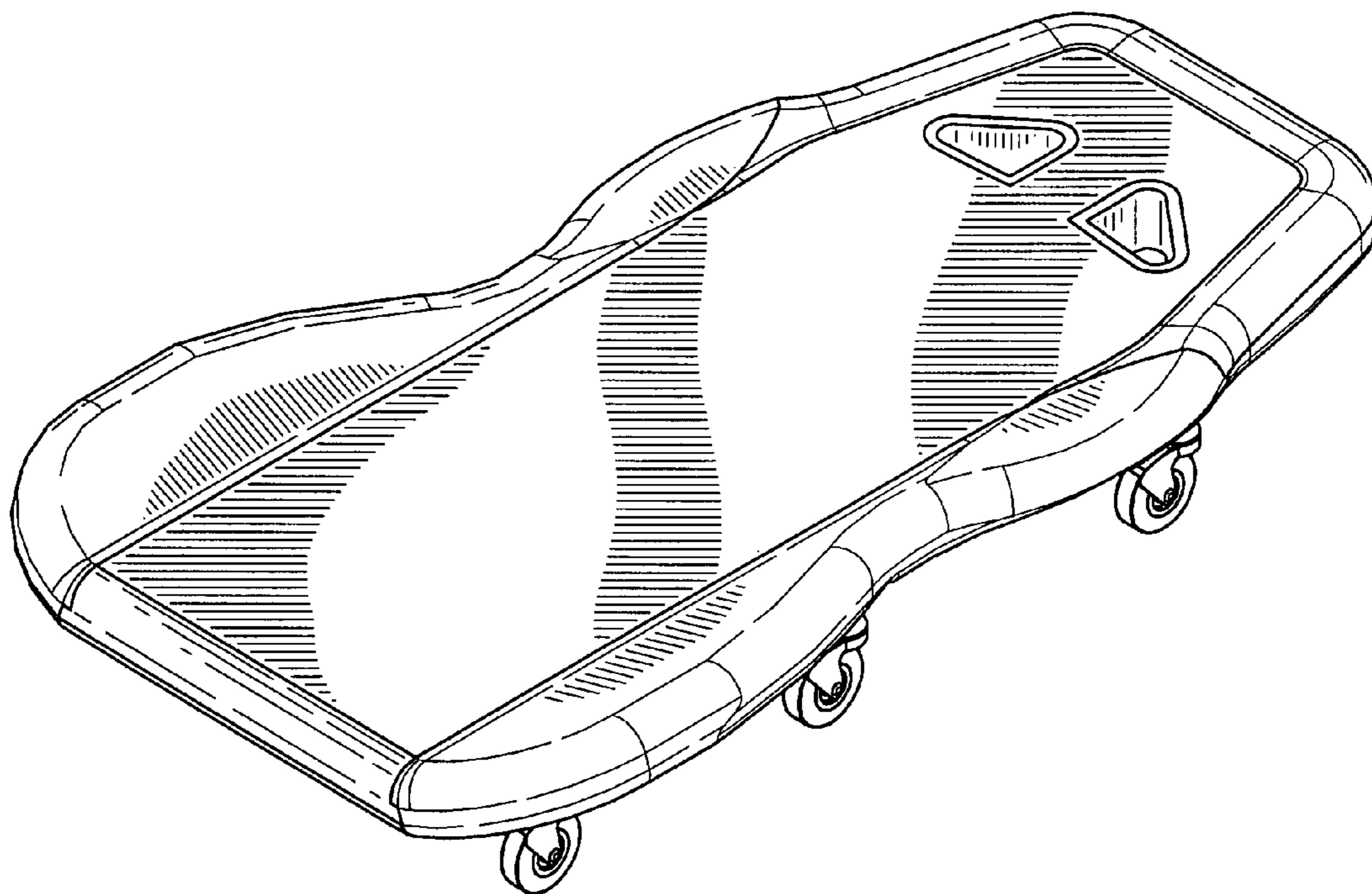
FIG. 3 is a right side elevational view thereof, the left side being a mirror image of FIG. 3;

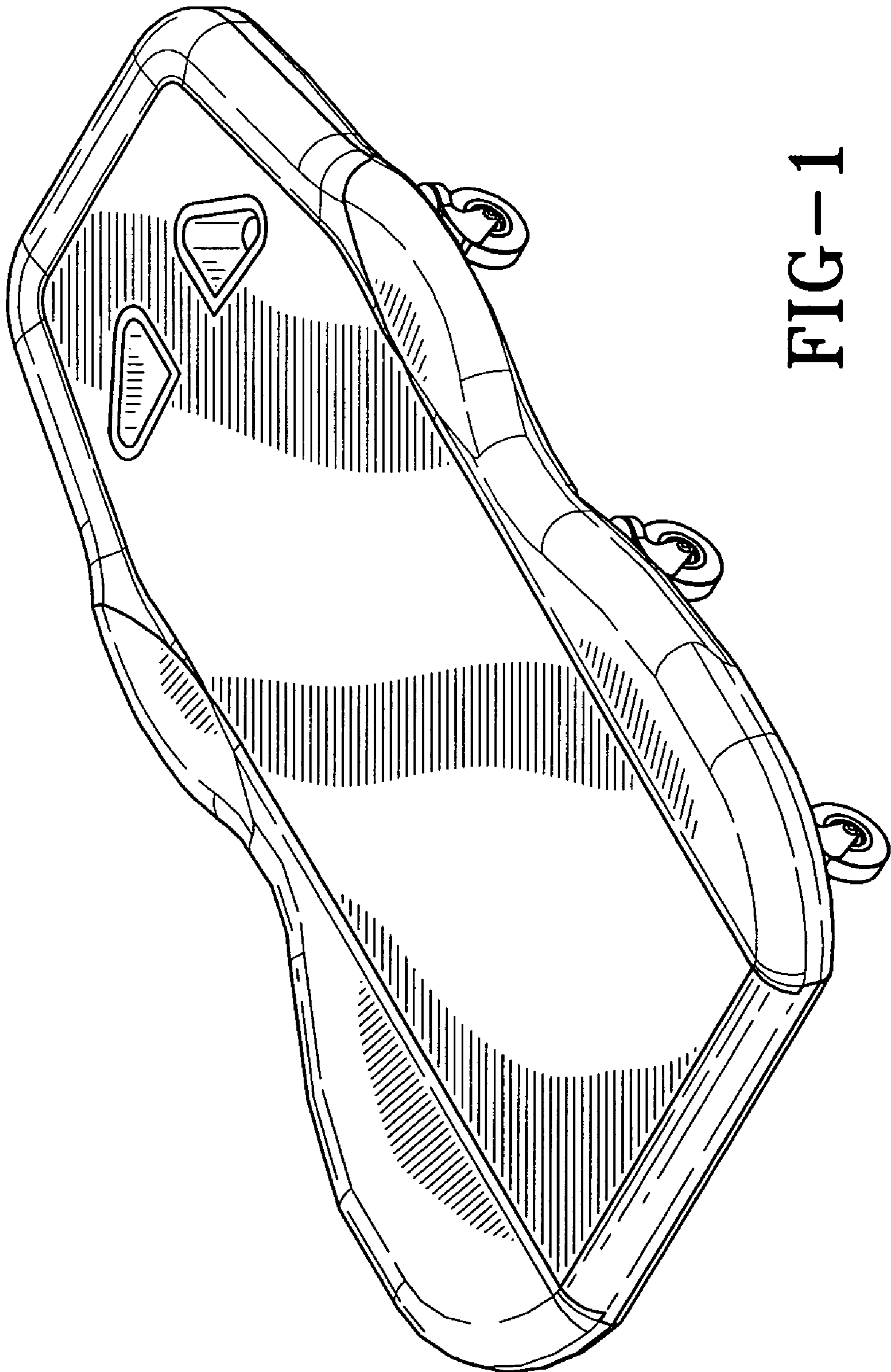

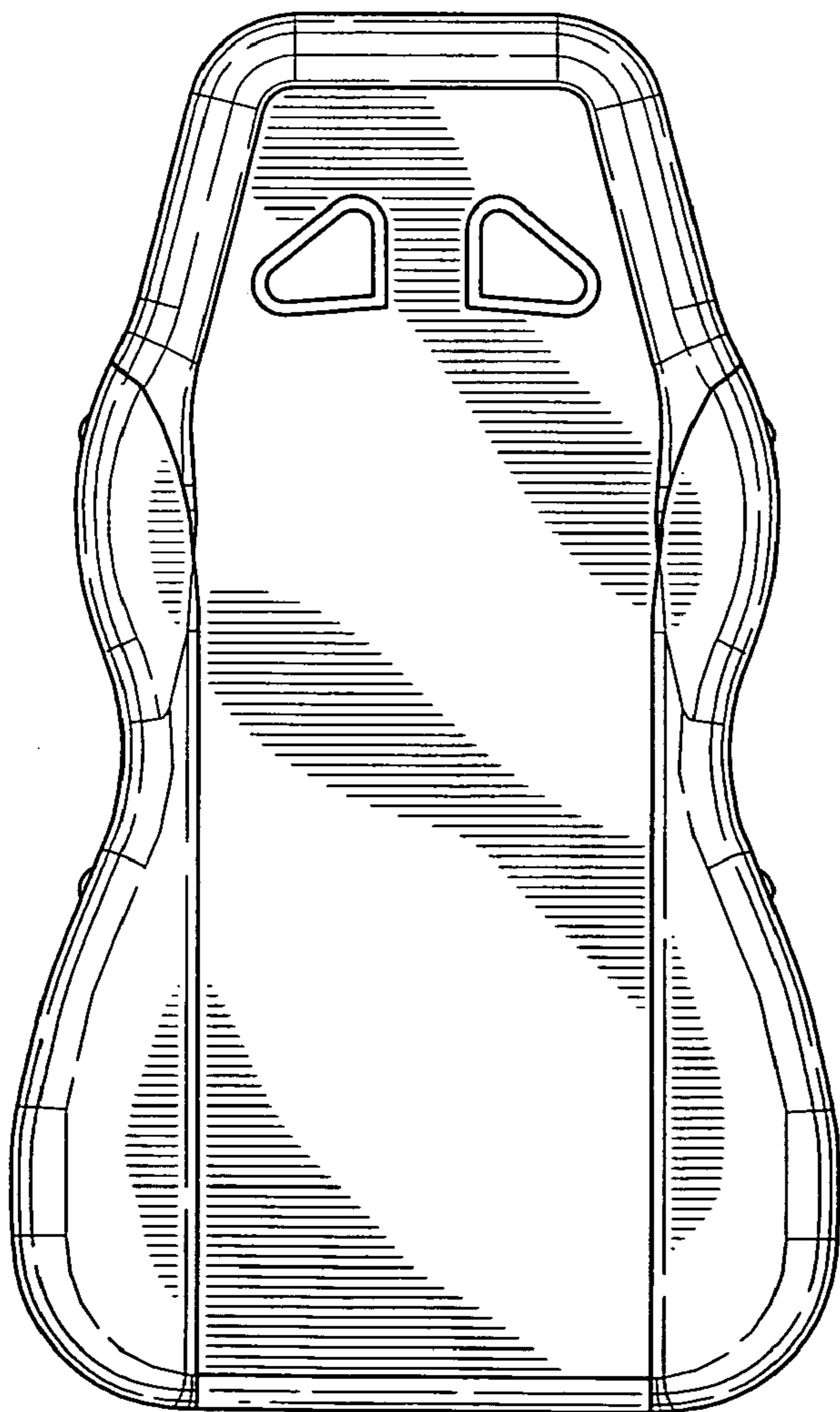

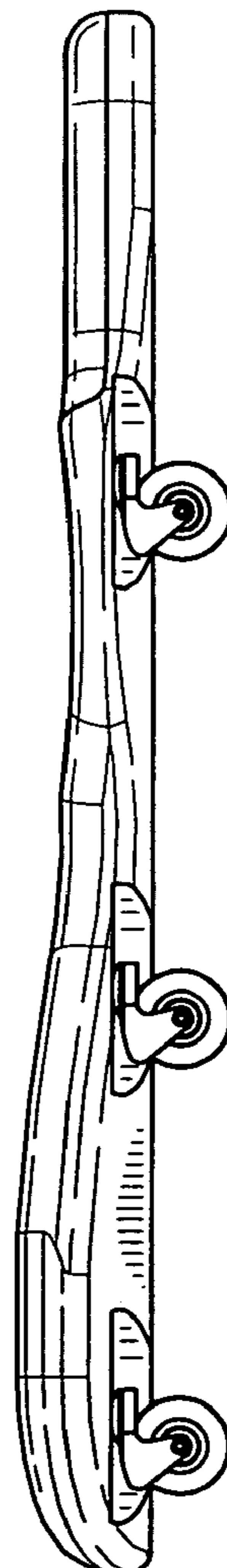

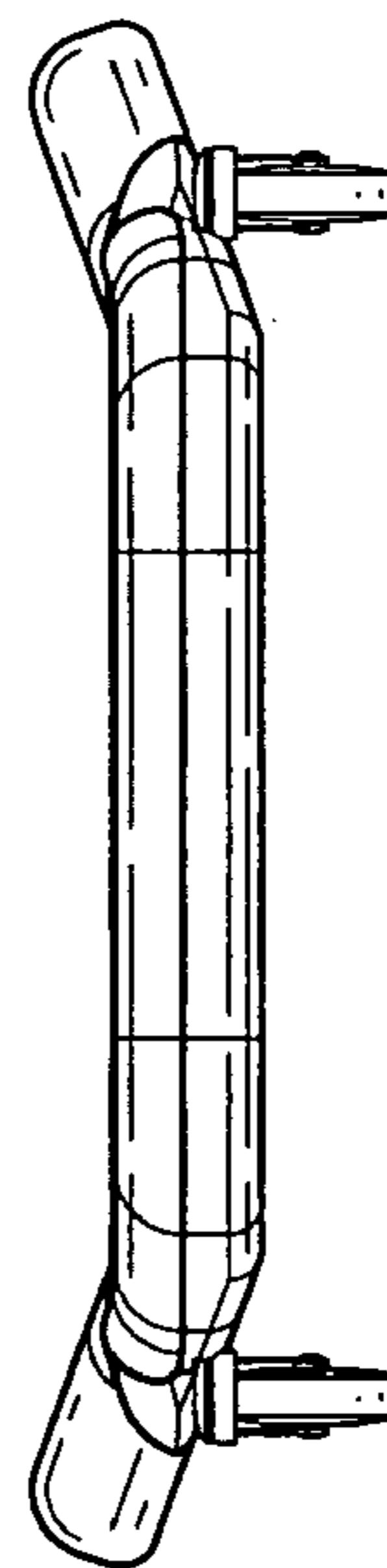

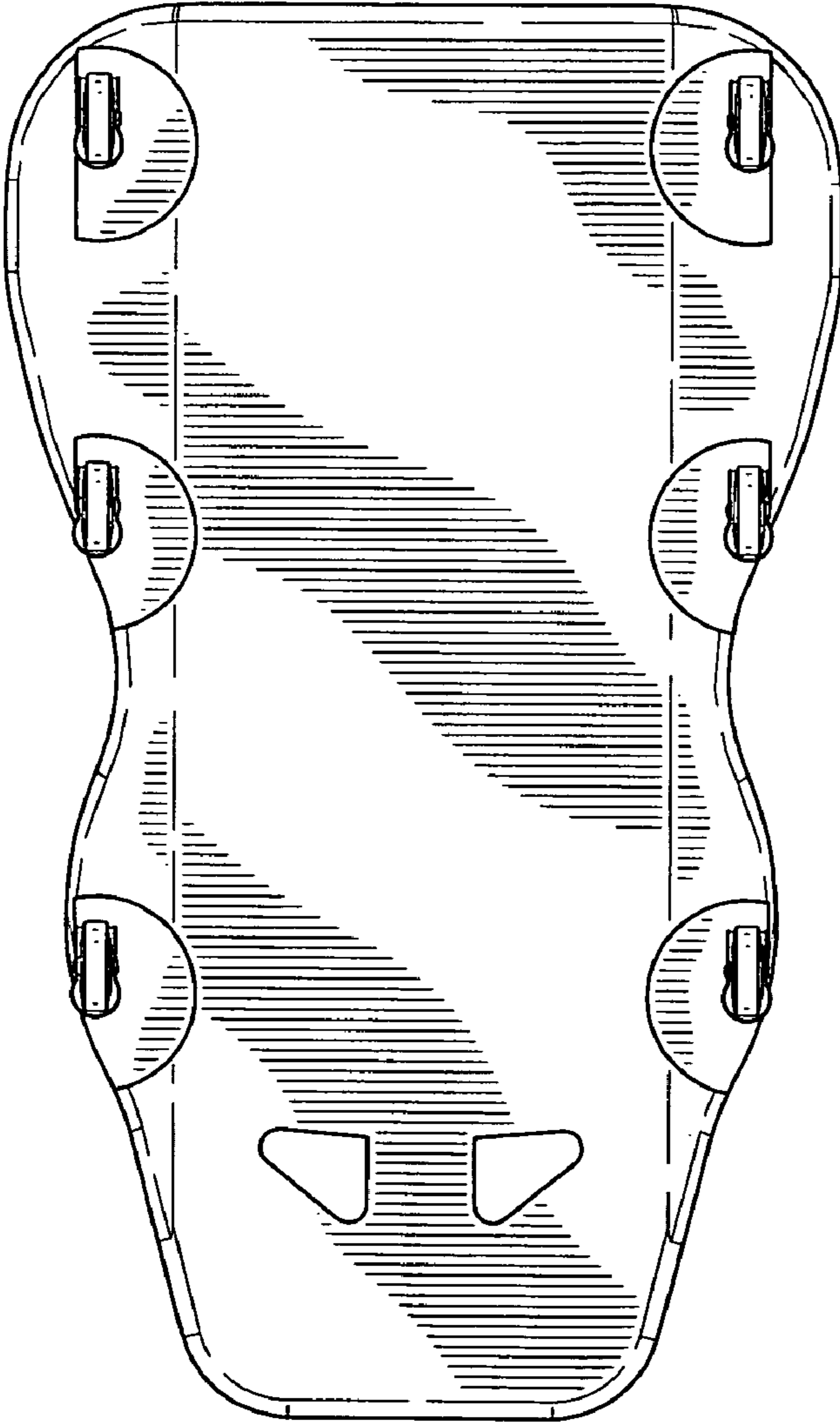

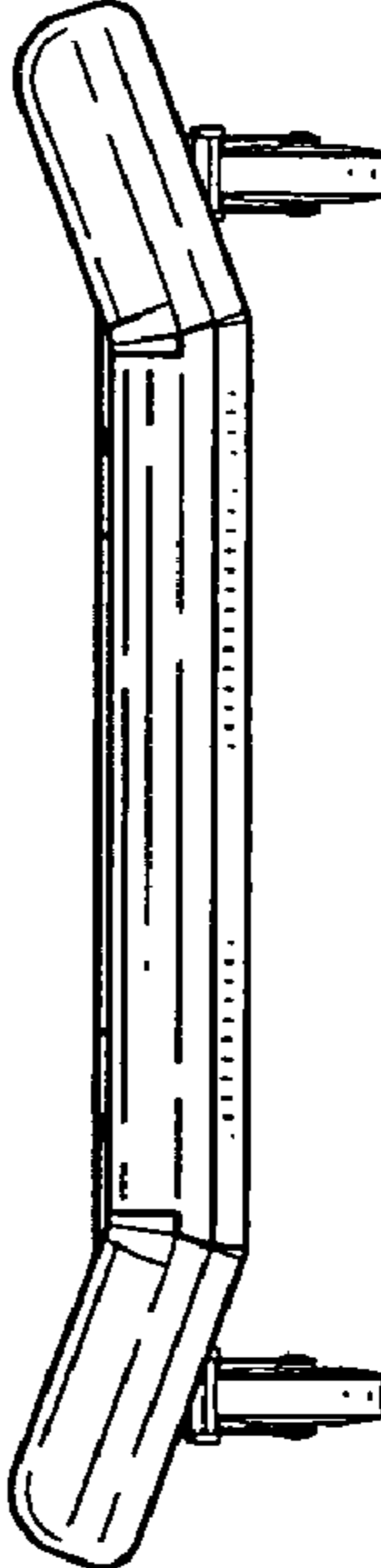
