FIG. 2 is a rear elevation view thereof;

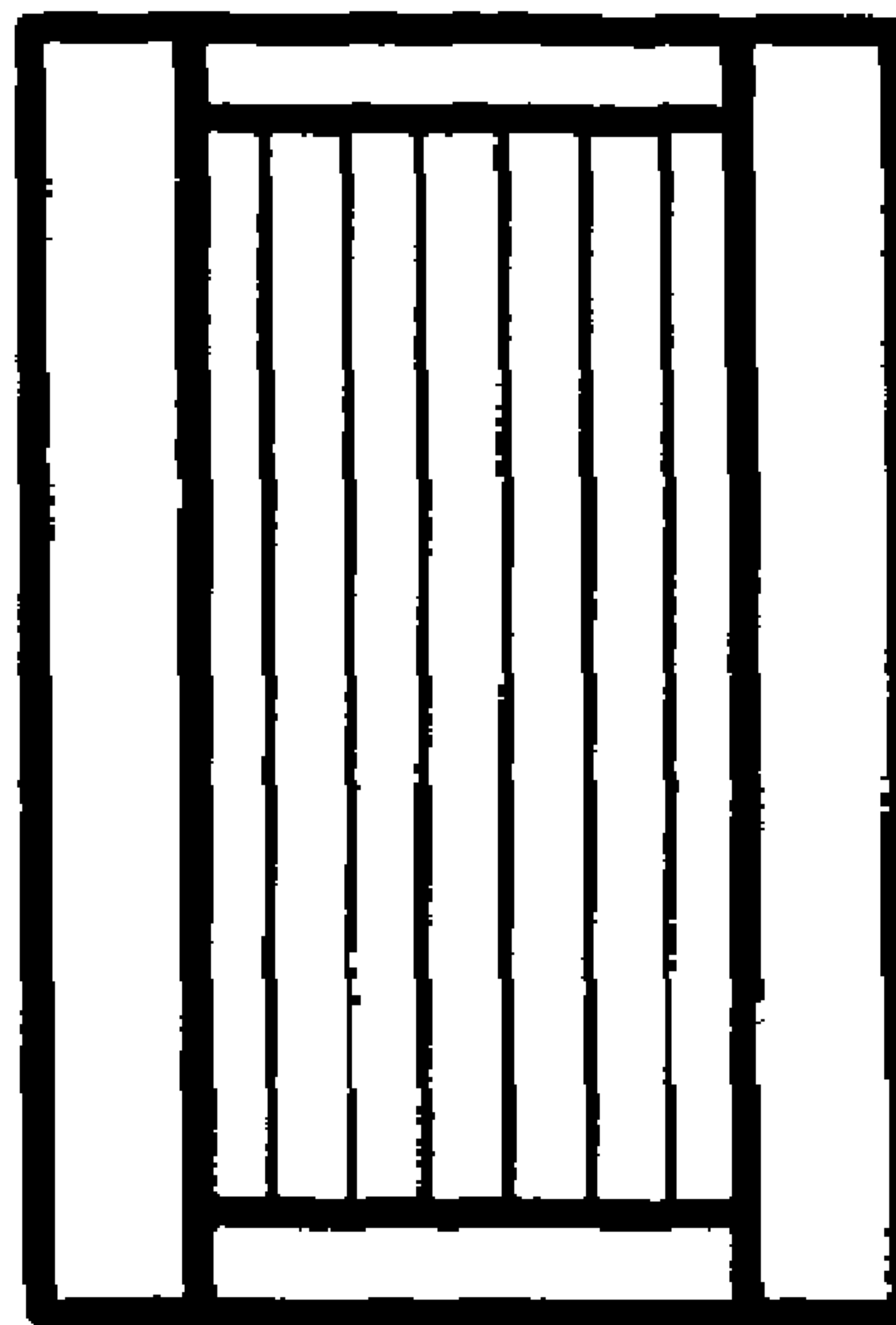
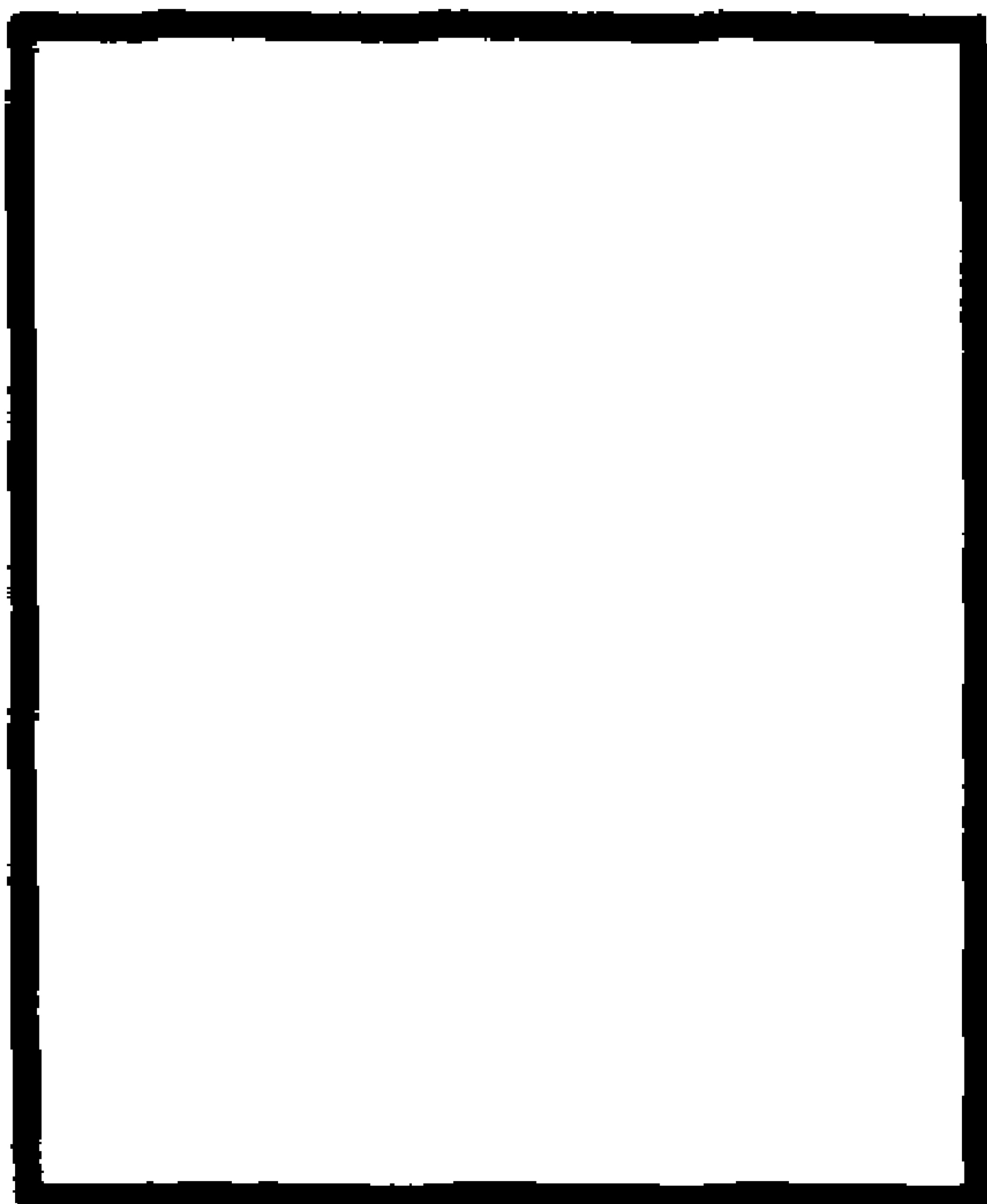
FIG. 3 is a right side elevation view thereof;

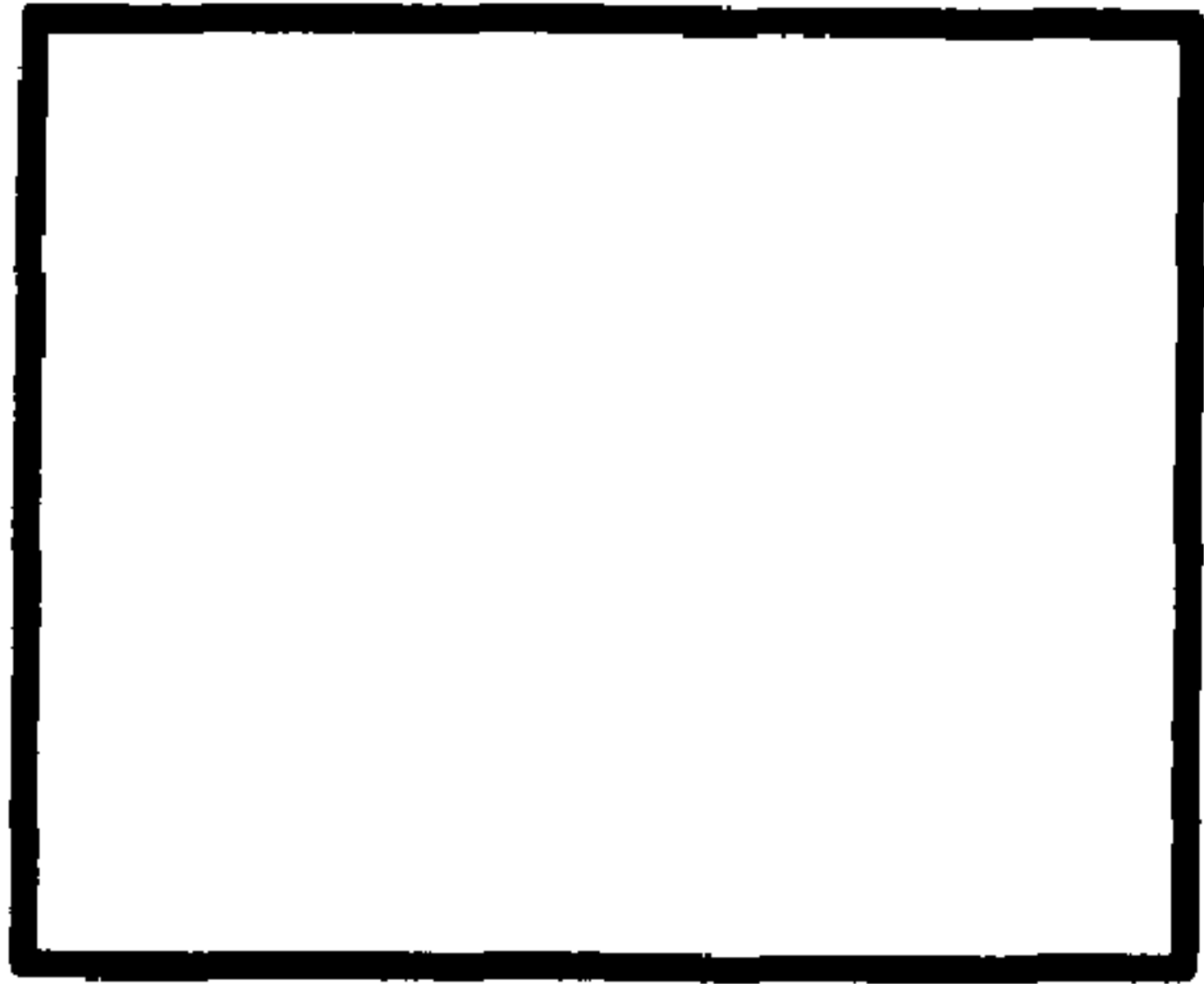

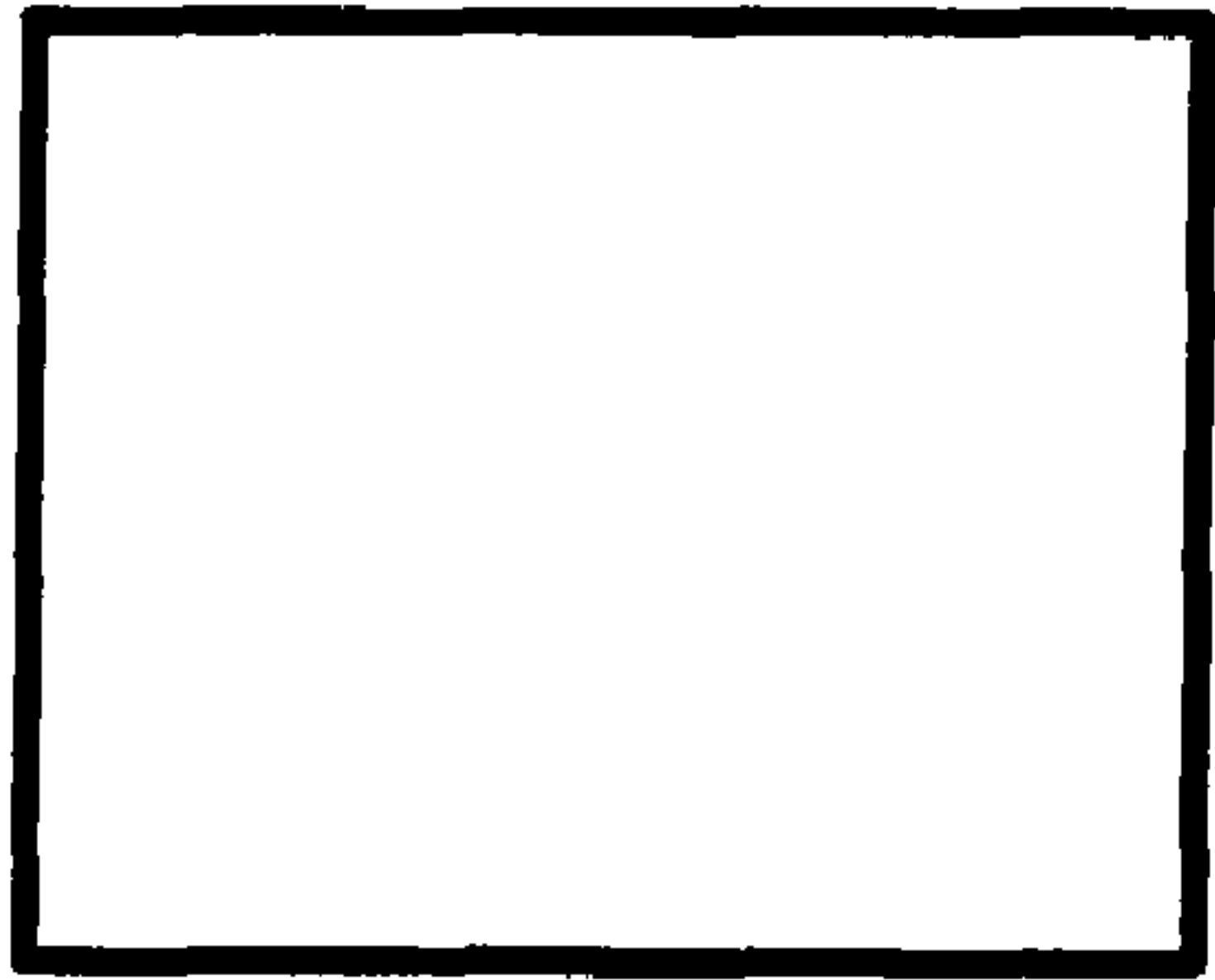

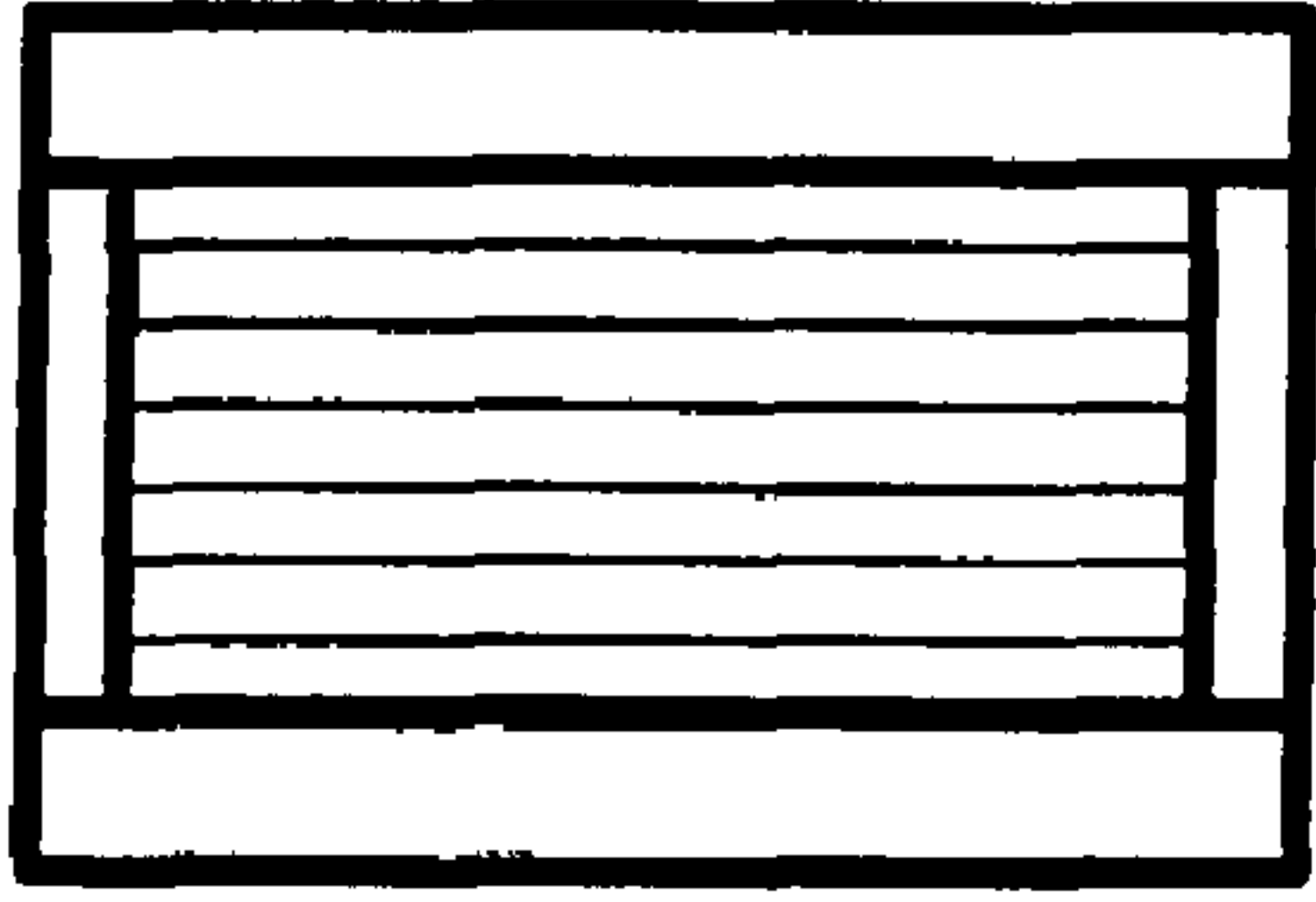

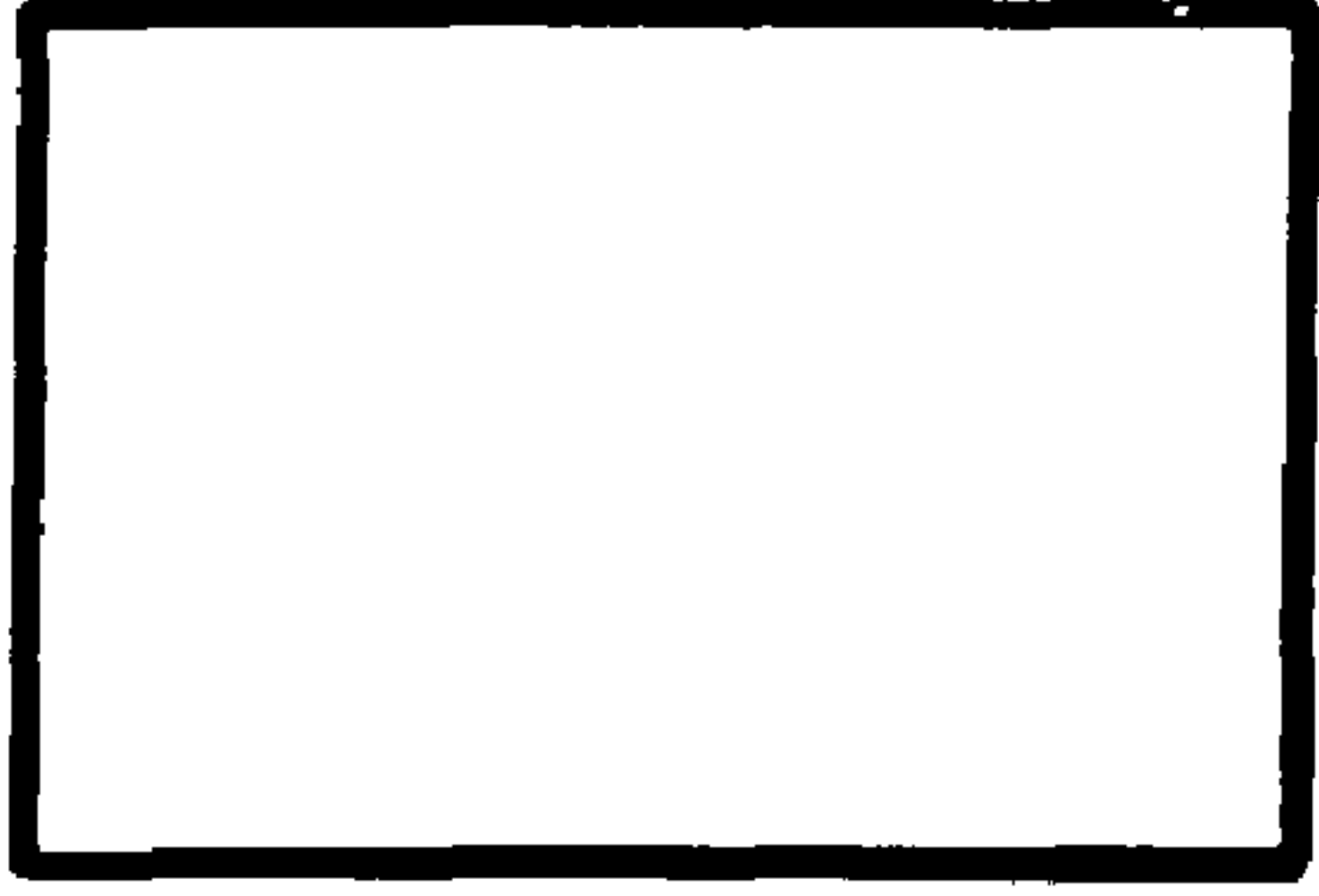

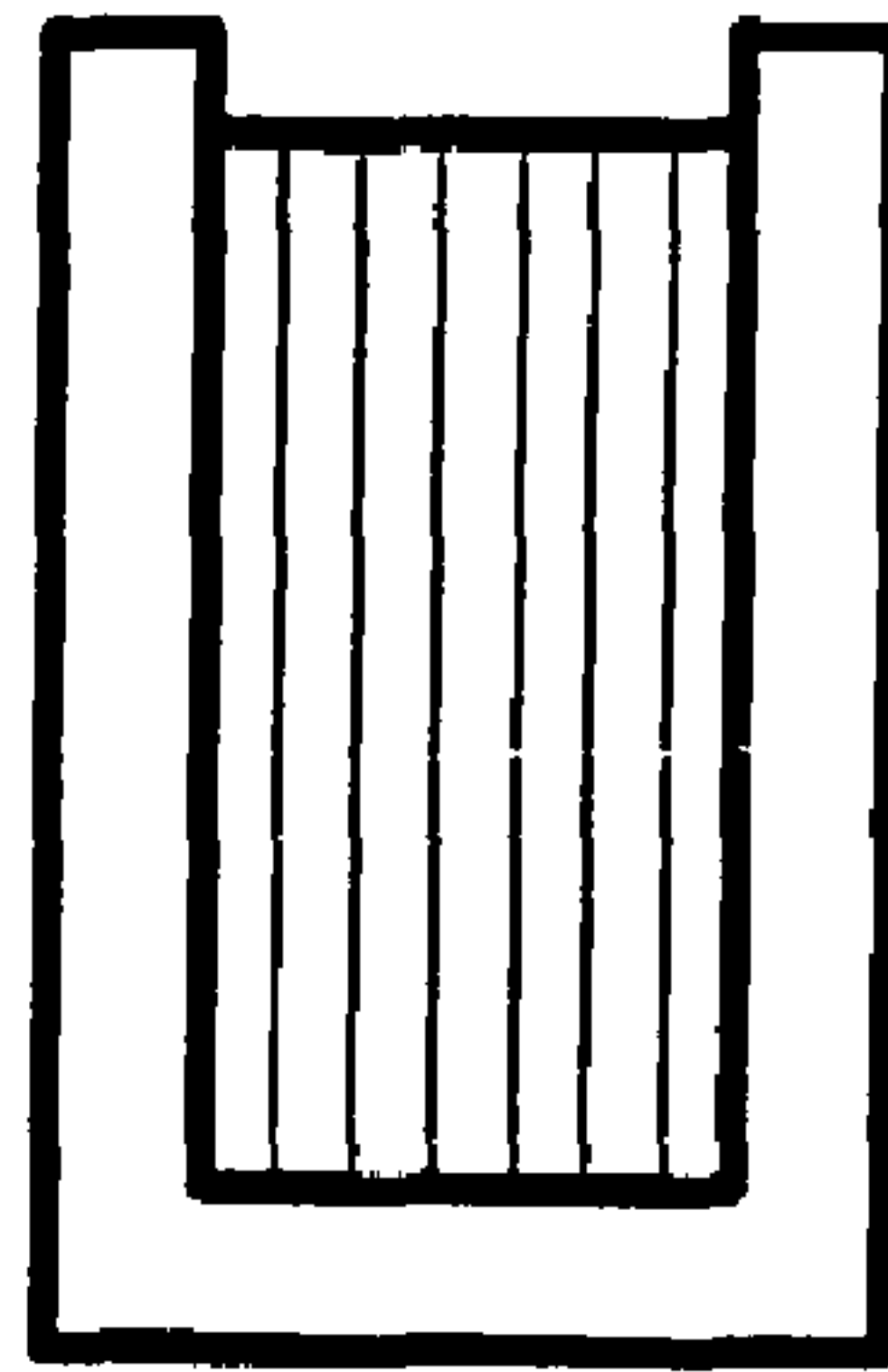

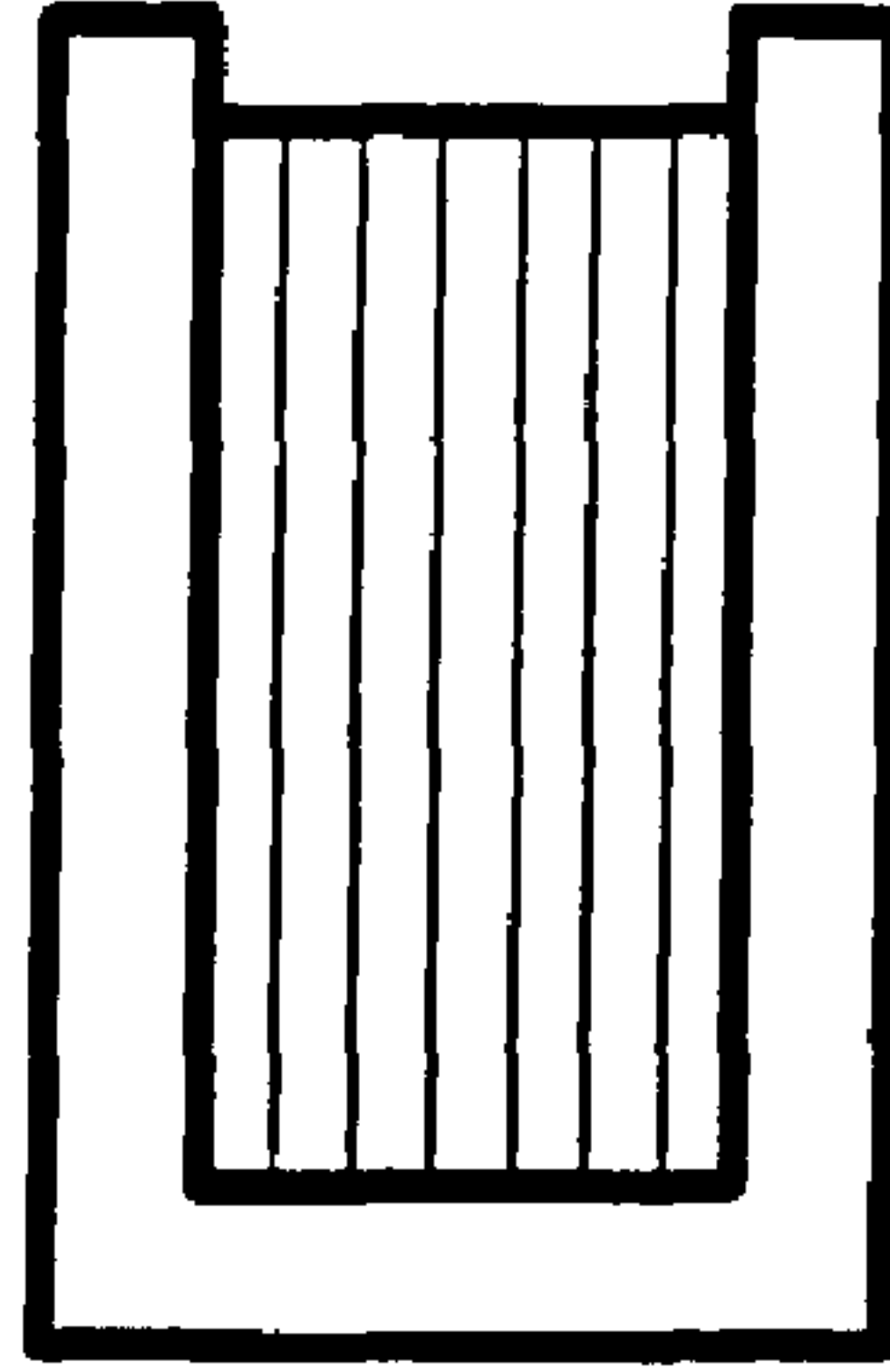
