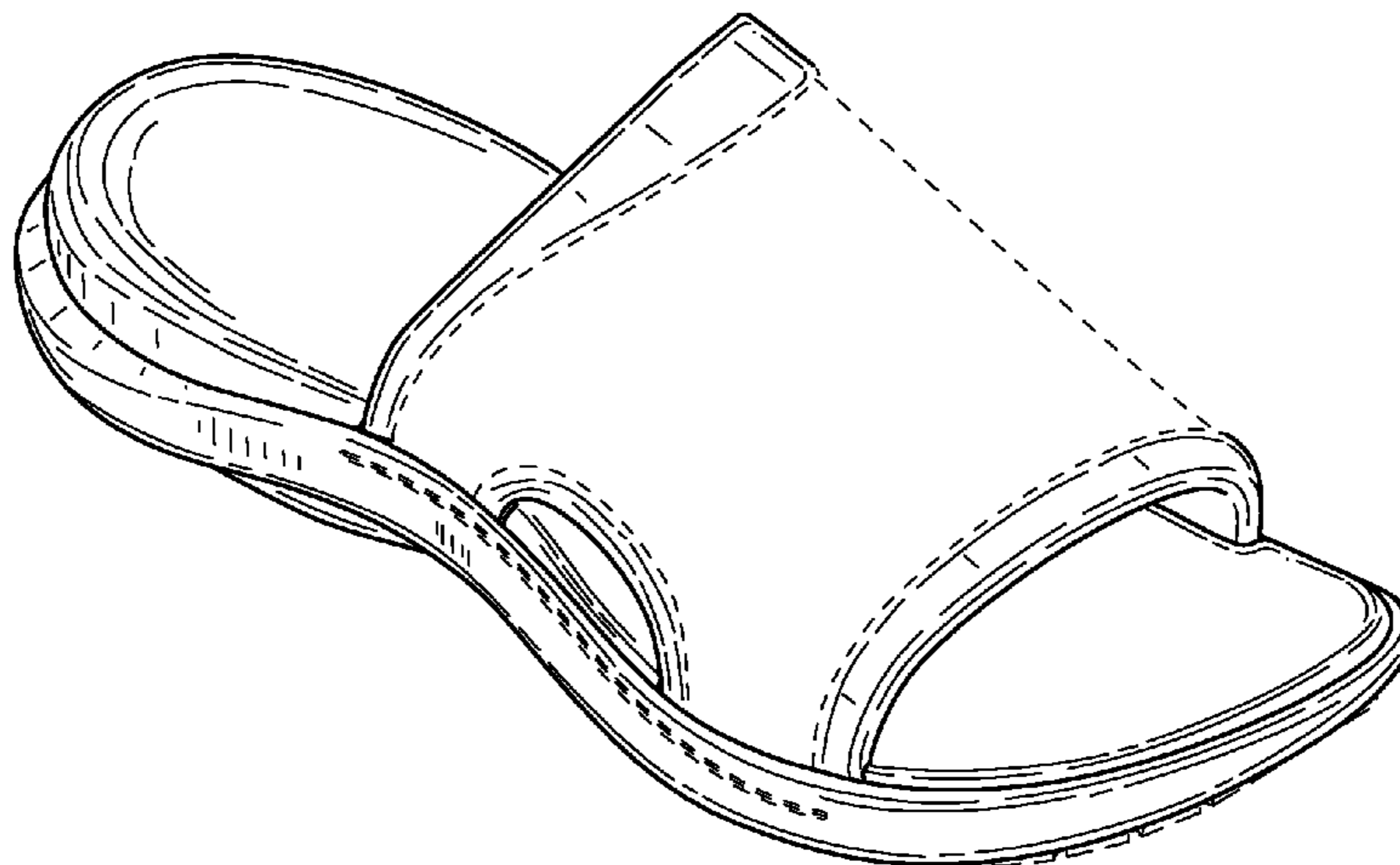
The ornamental design for footwear, as shown and described.

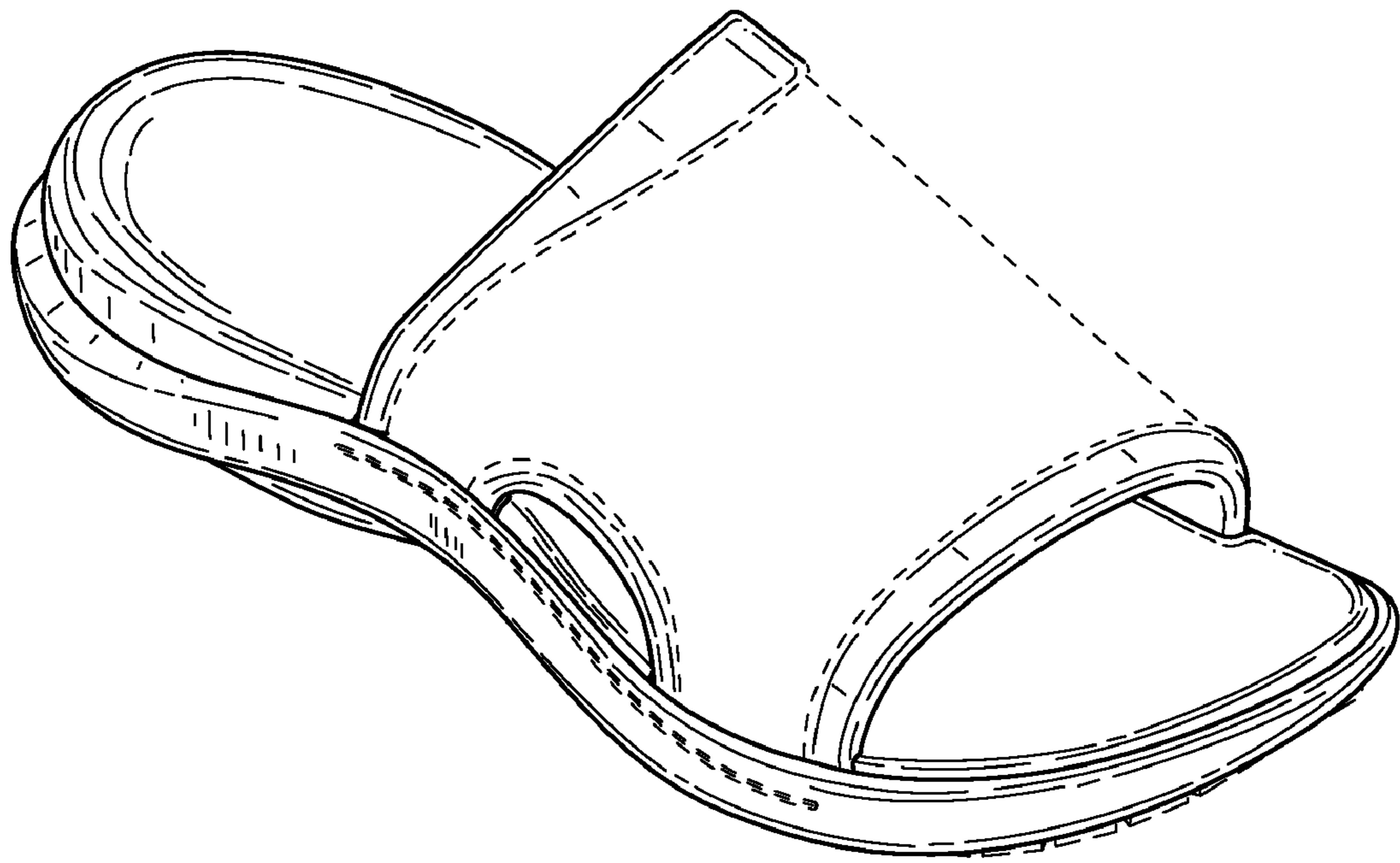

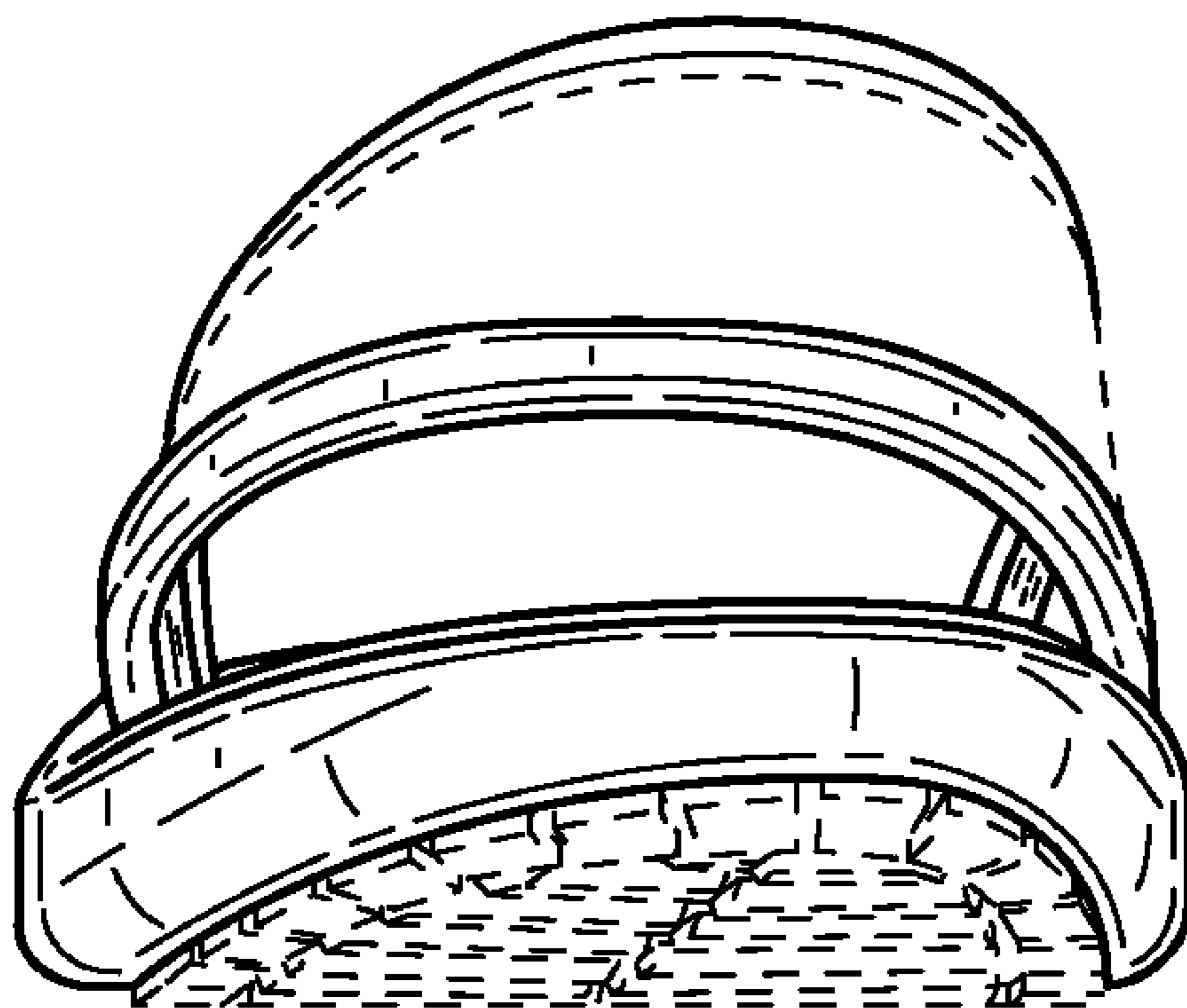

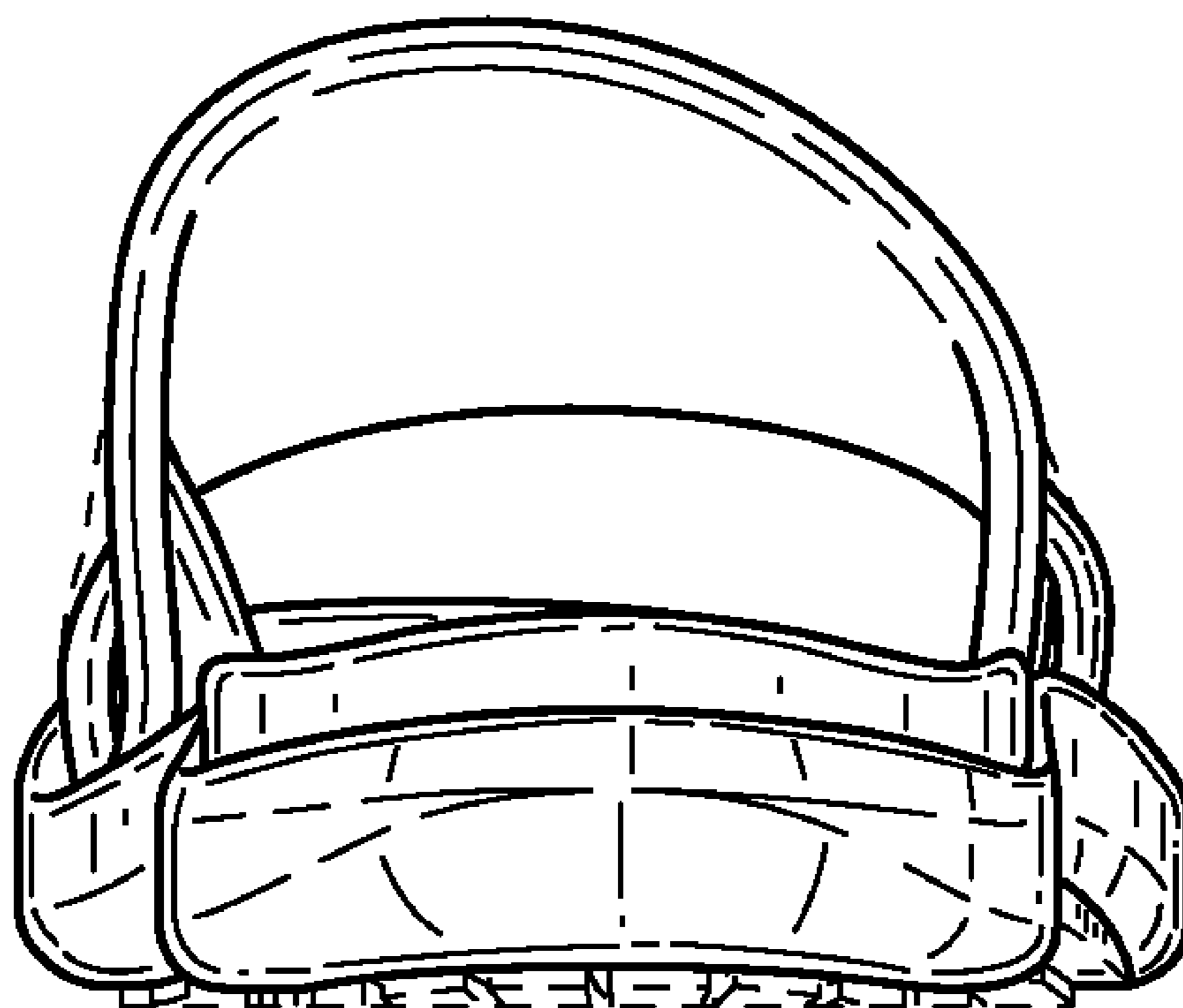

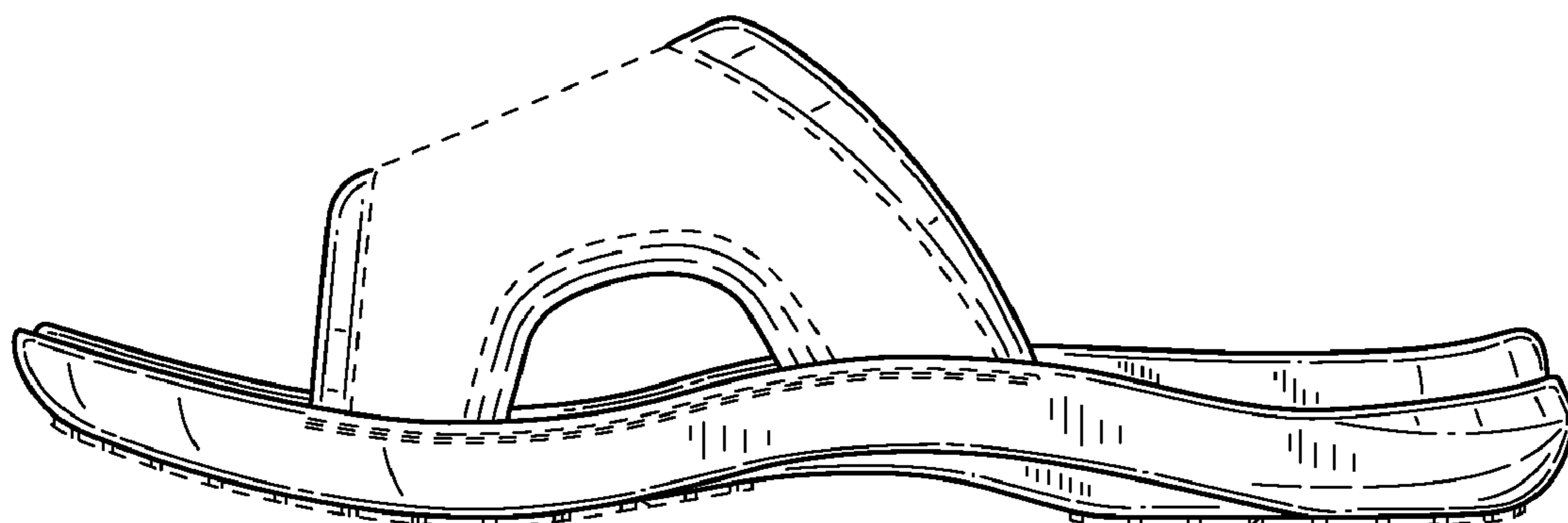

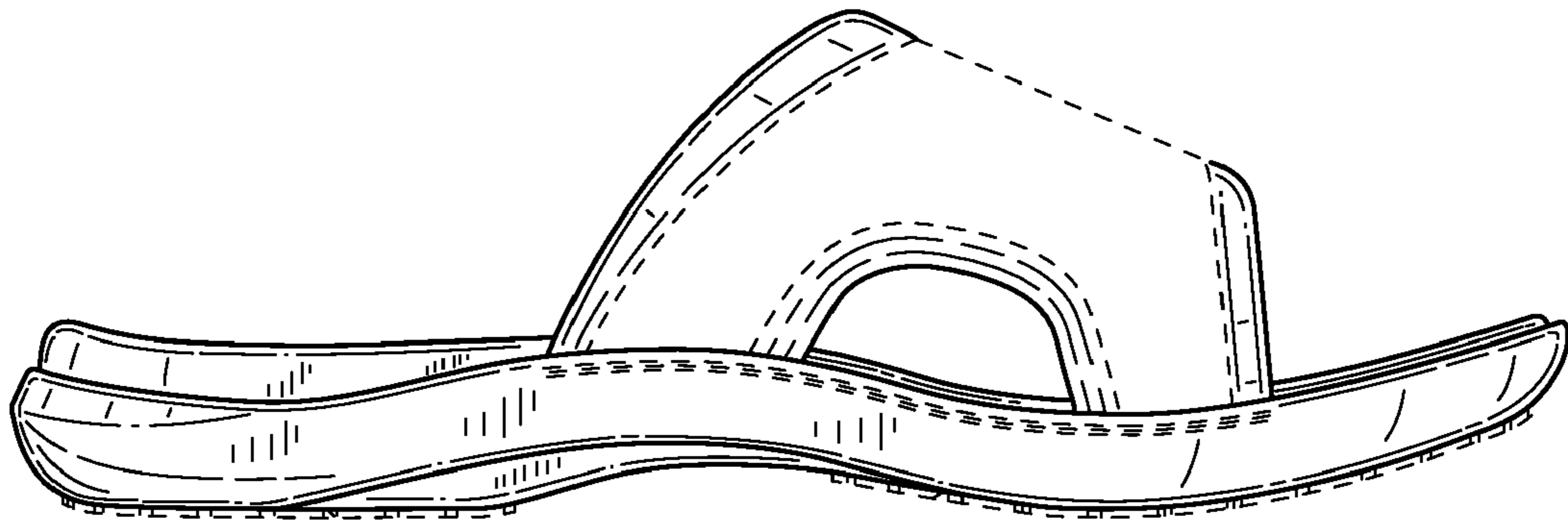

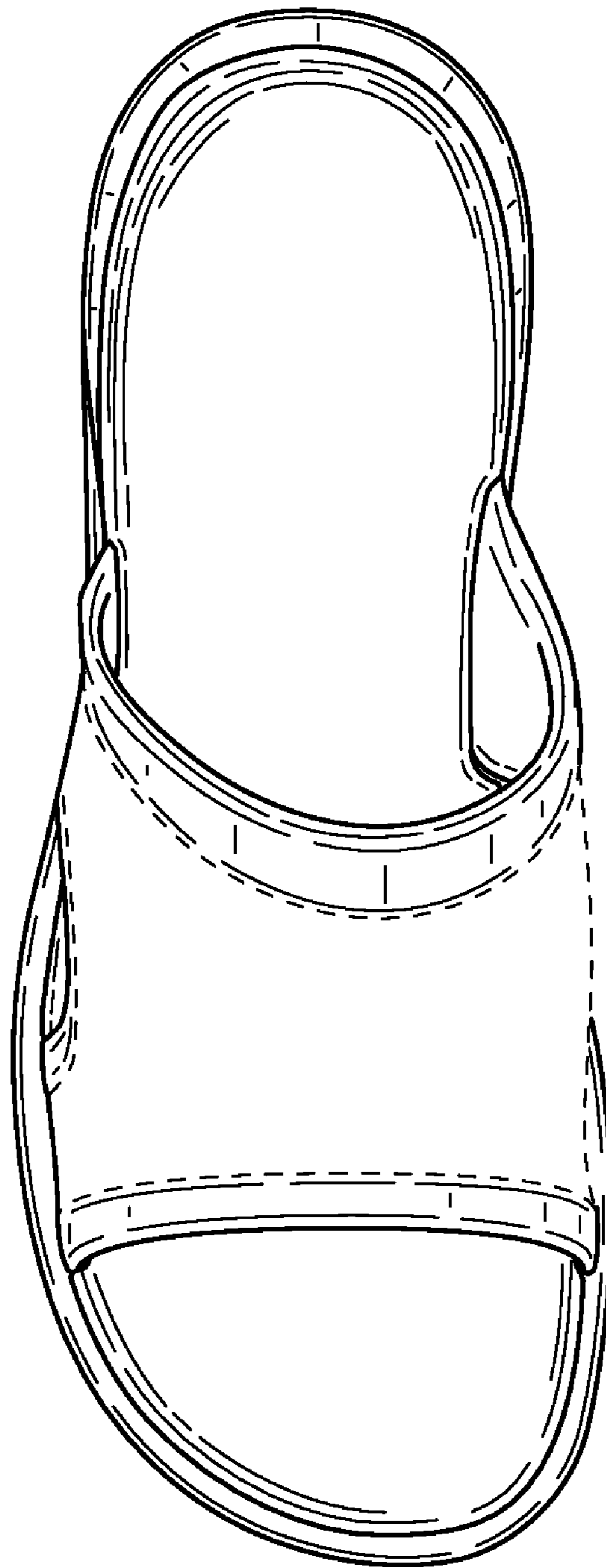

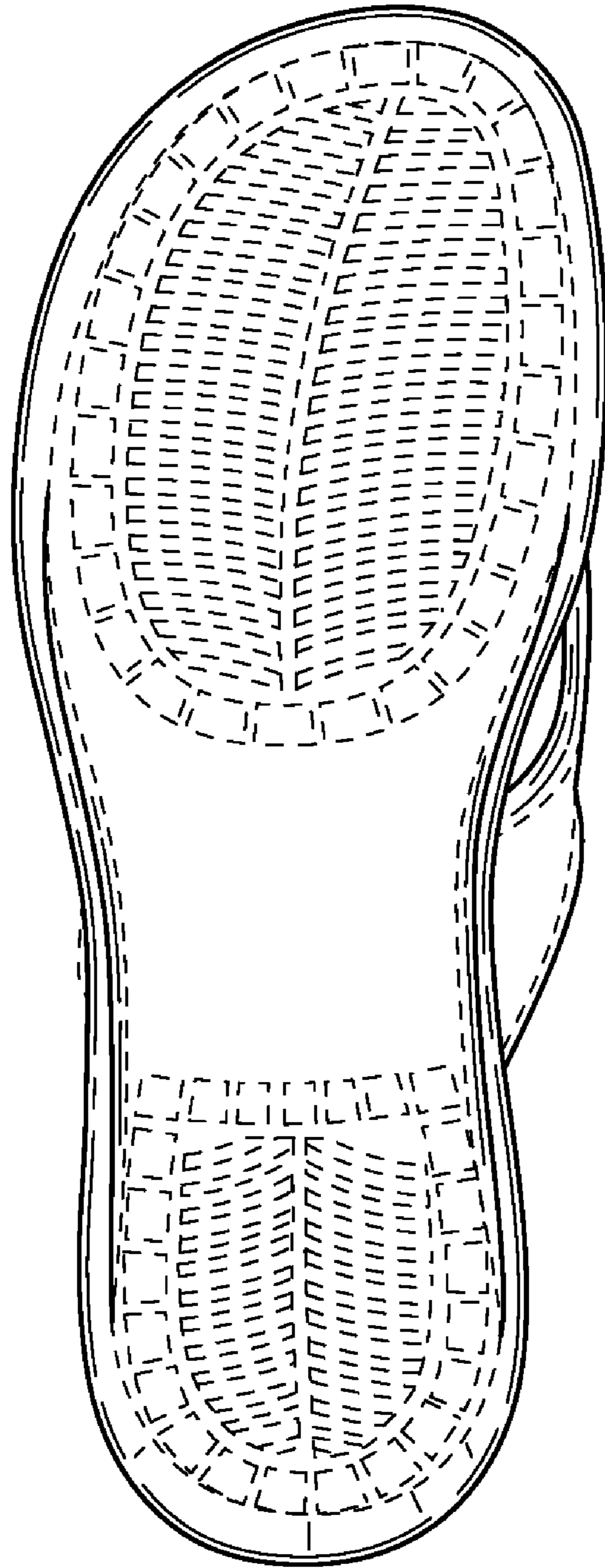
